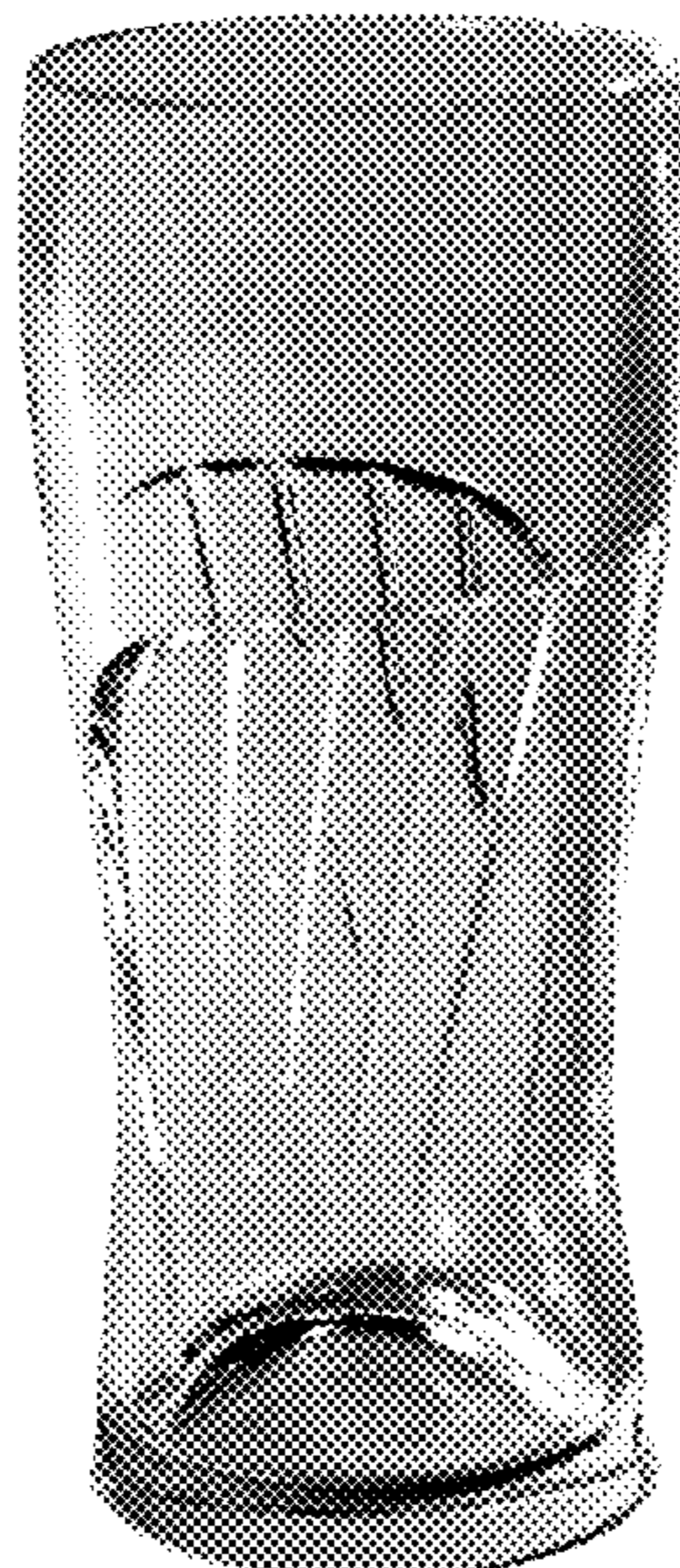
(57) **CLAIM**
The ornamental design for a drinking glass, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front isometric view of a drinking glass.
FIG. 2 is a front elevation view of the drinking glass of FIG. 1, to which the rear elevation view is identical.
FIG. 3 is a top plan view of the drinking glass of FIG. 1; and,
FIG. 4 is a bottom, front isometric view of the drinking glass of FIG. 1.
