FIG. 7 is a bottom view of the sleeve for a drink container of FIG. 1.

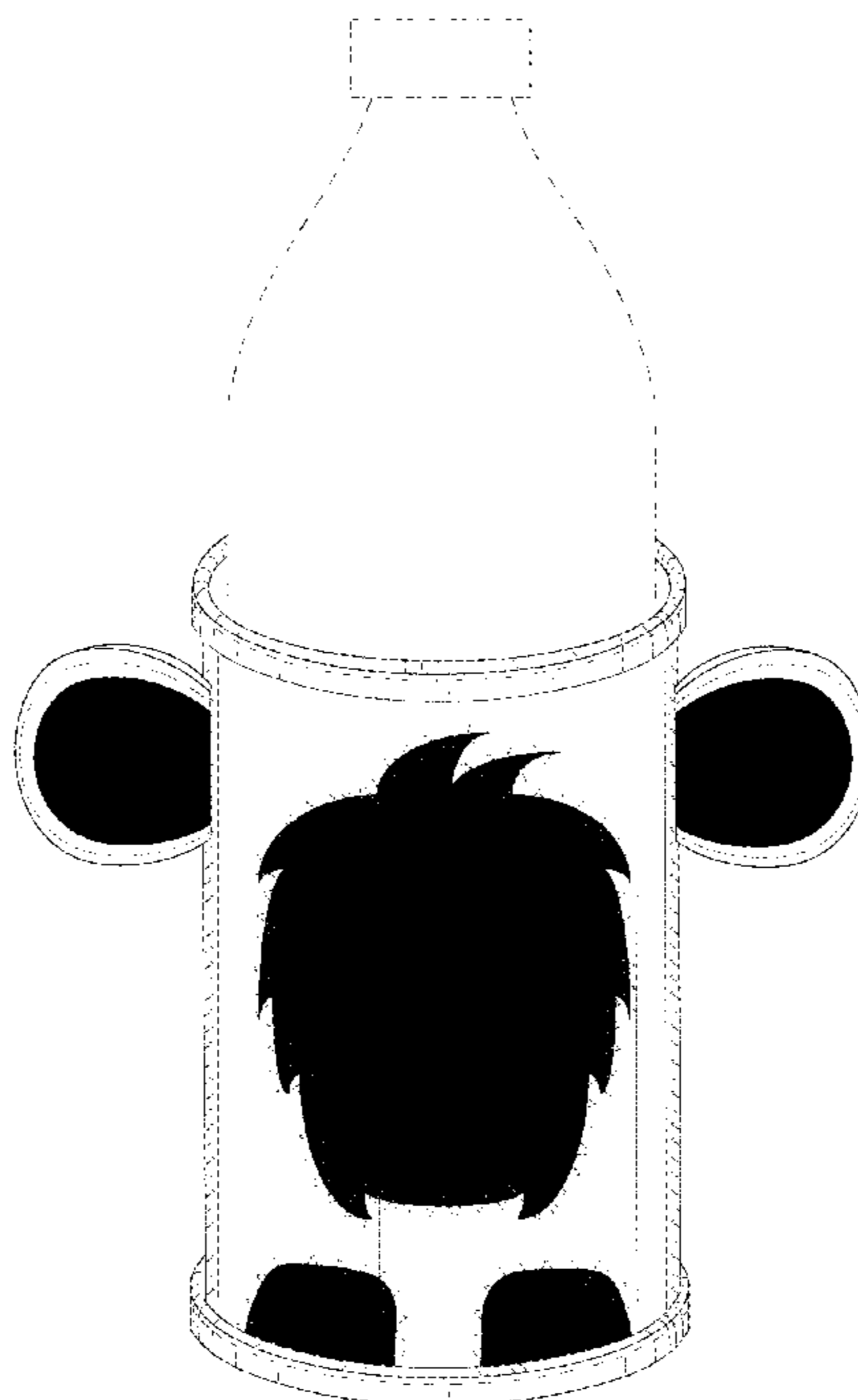
The portion of the sleeve for a drink container shown in broken lines are environmental only and form no part of the claimed design. The showing of solid black shading in the drawing views represents color contrast.

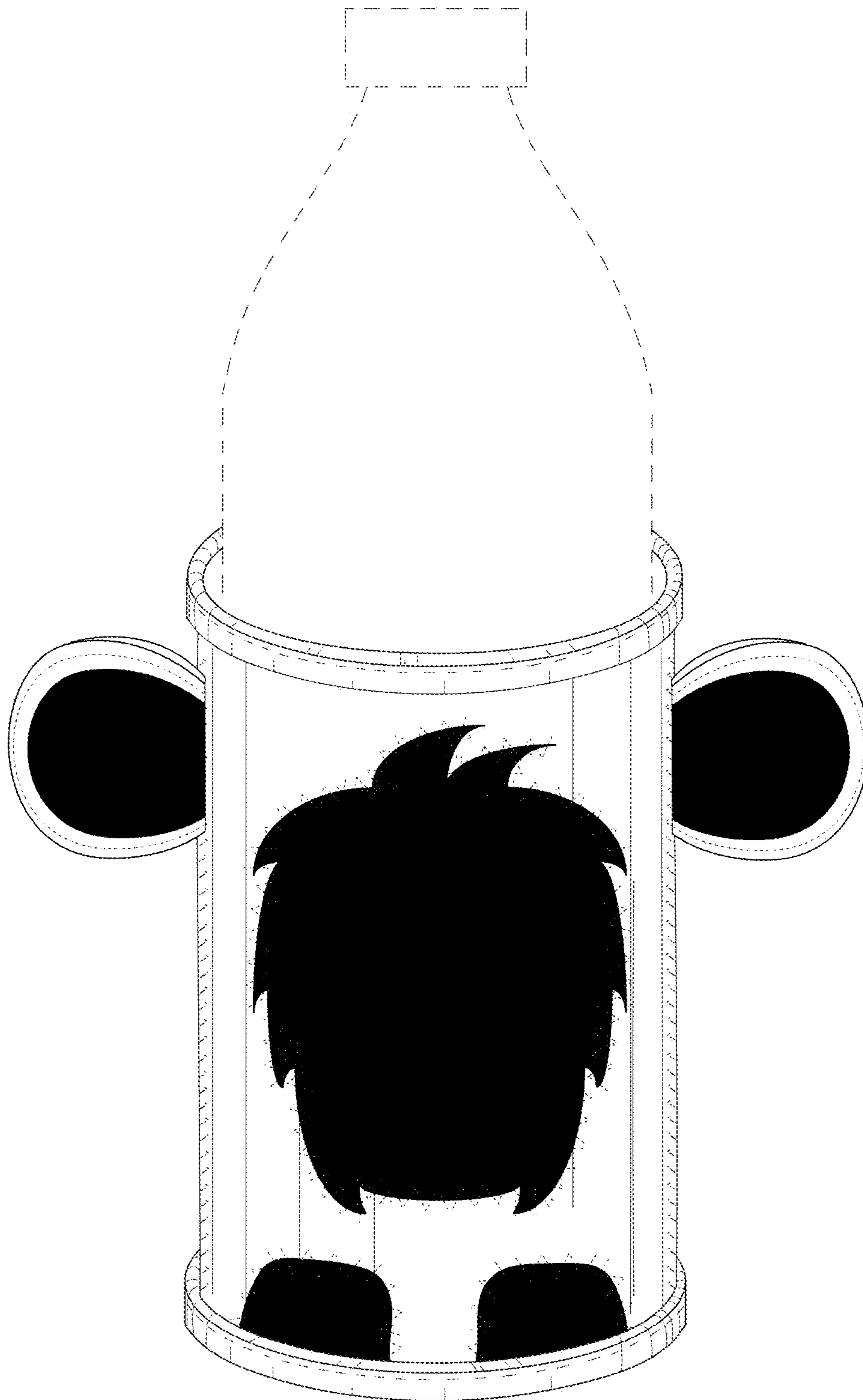

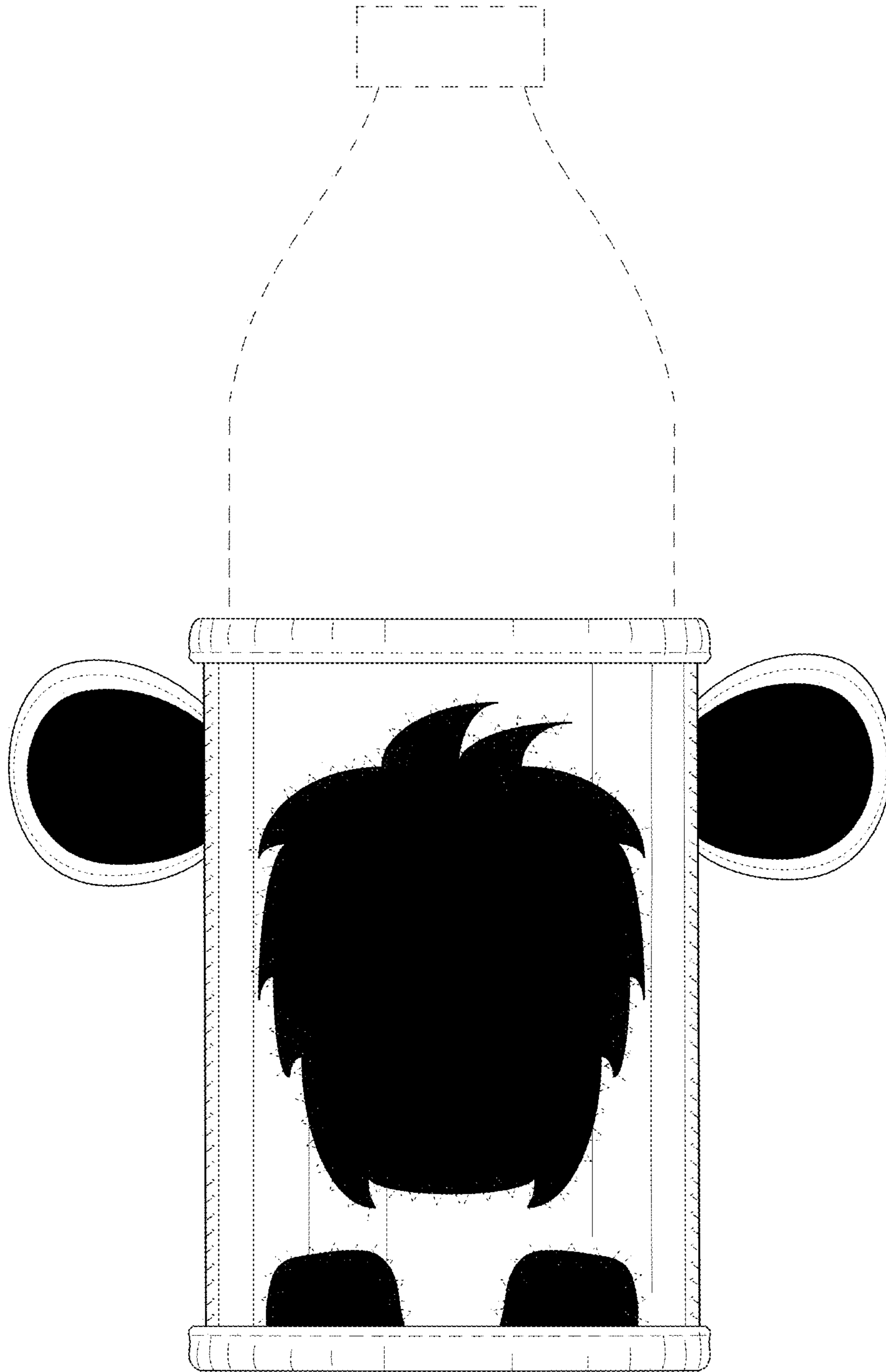

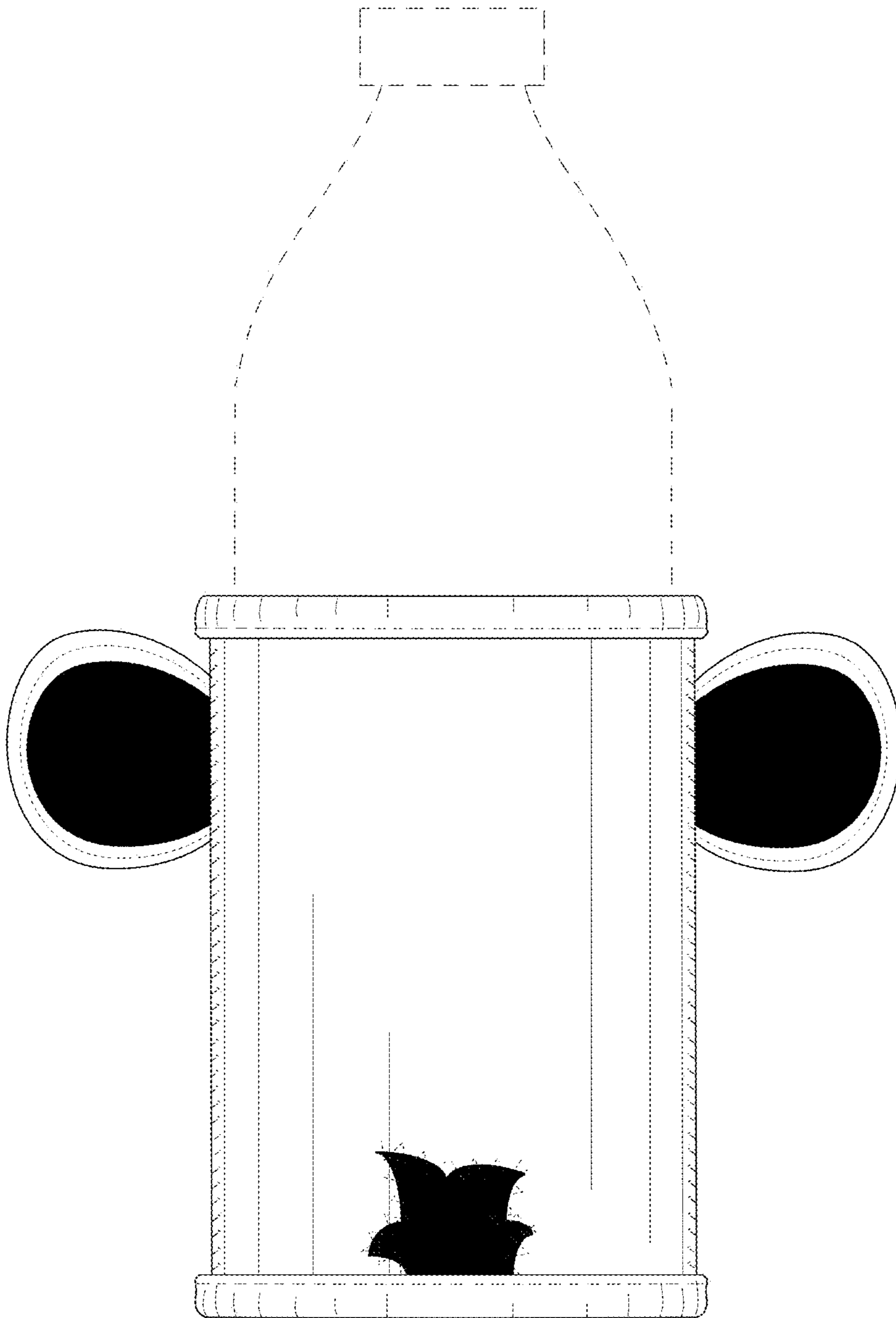

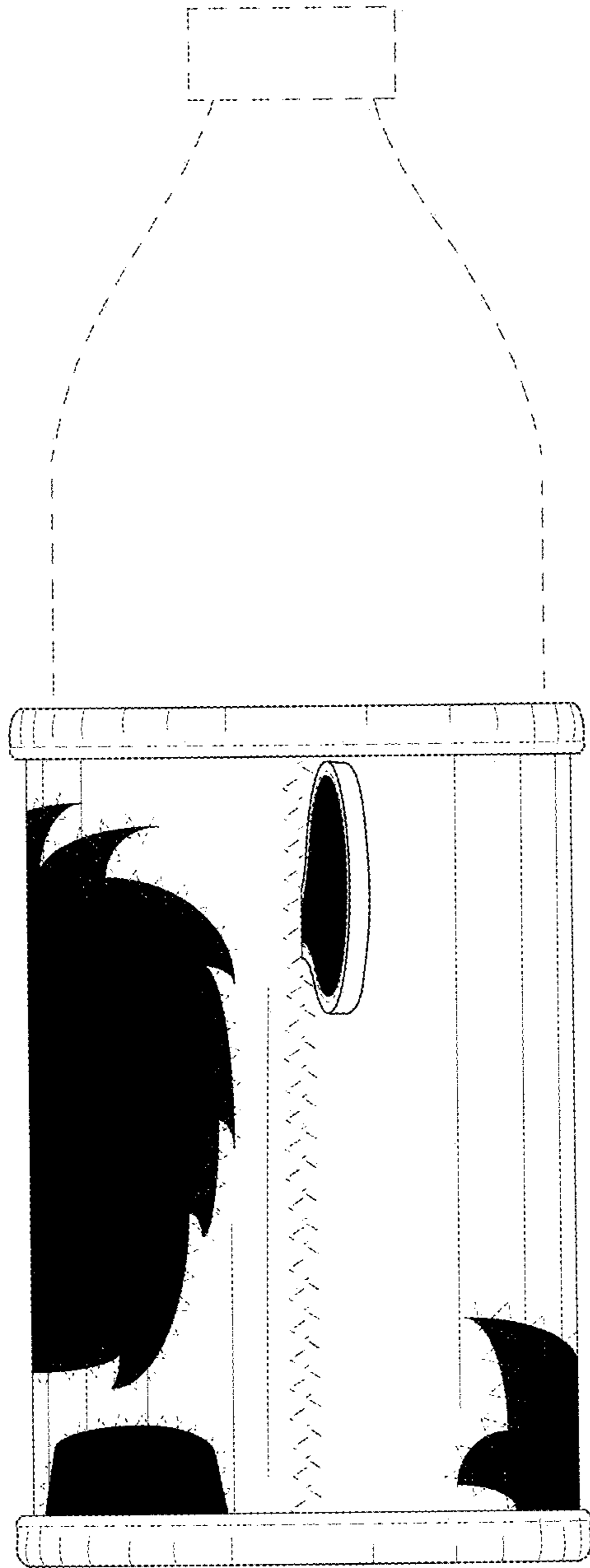

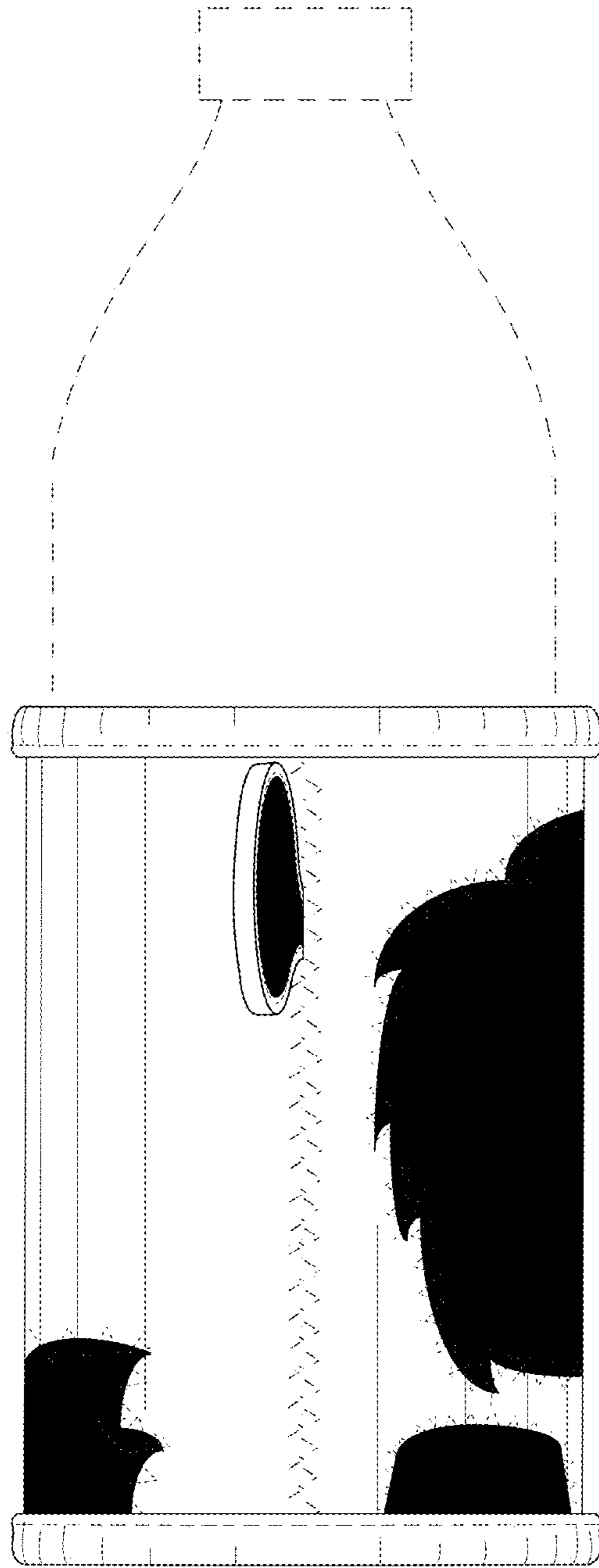

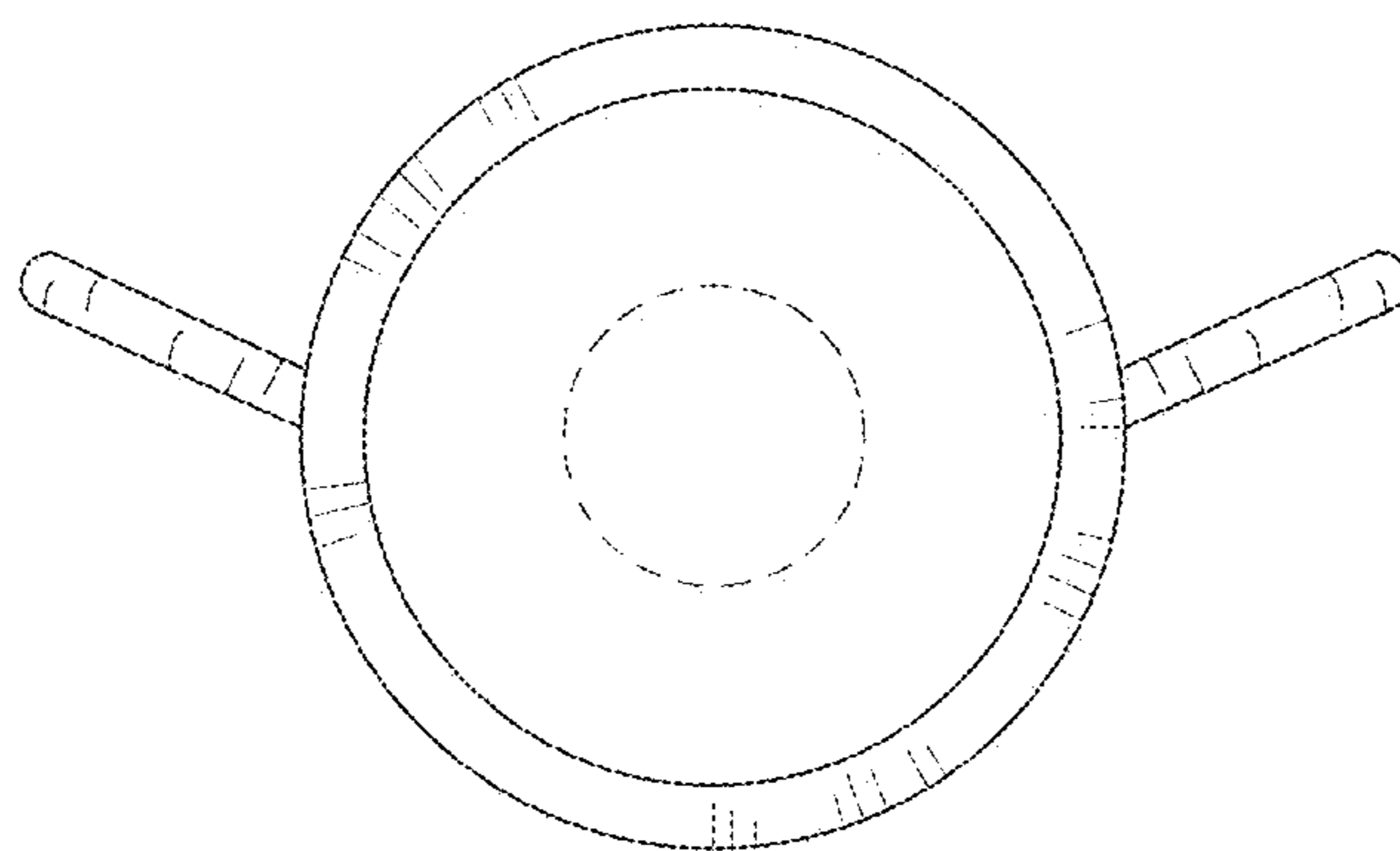

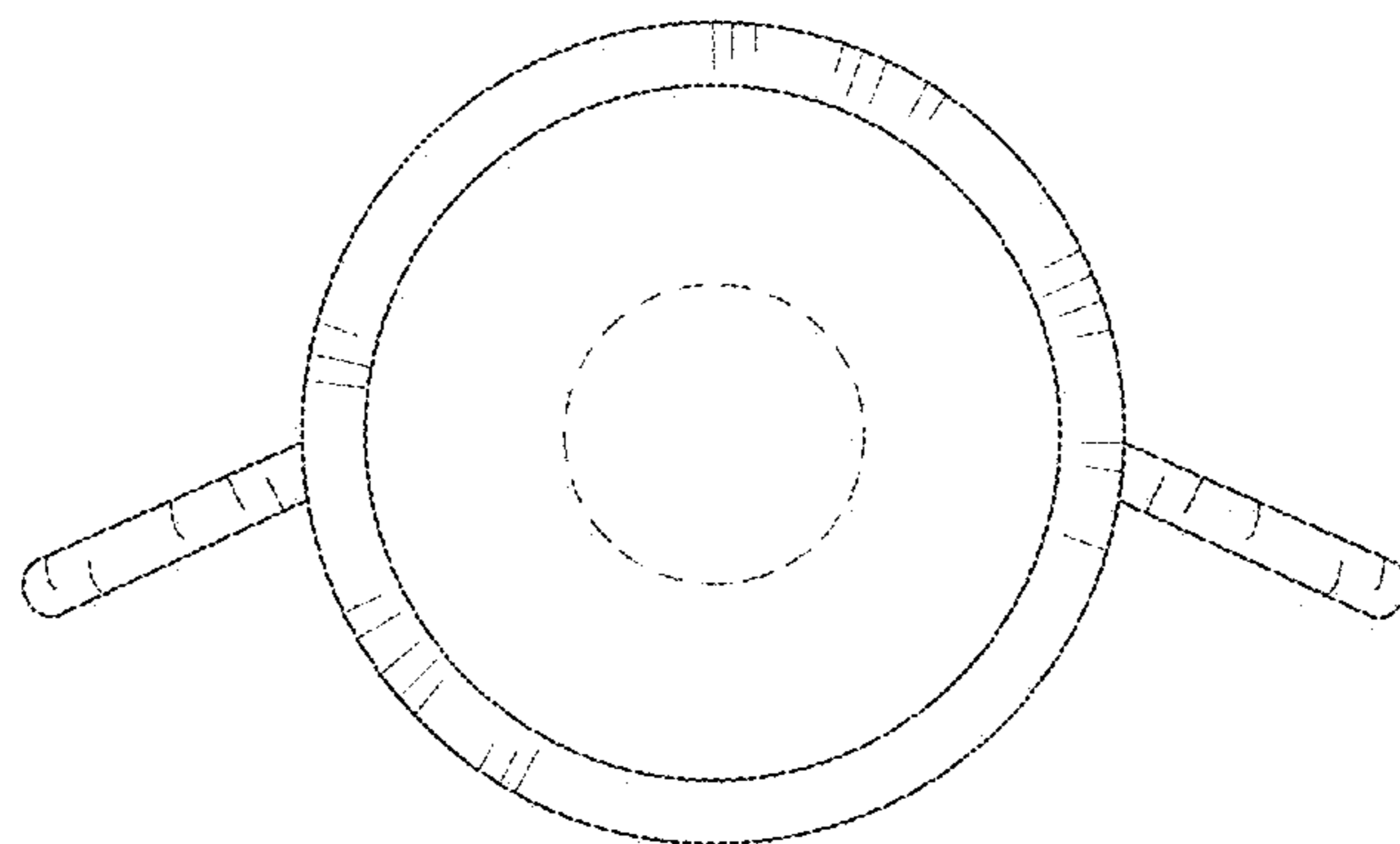
