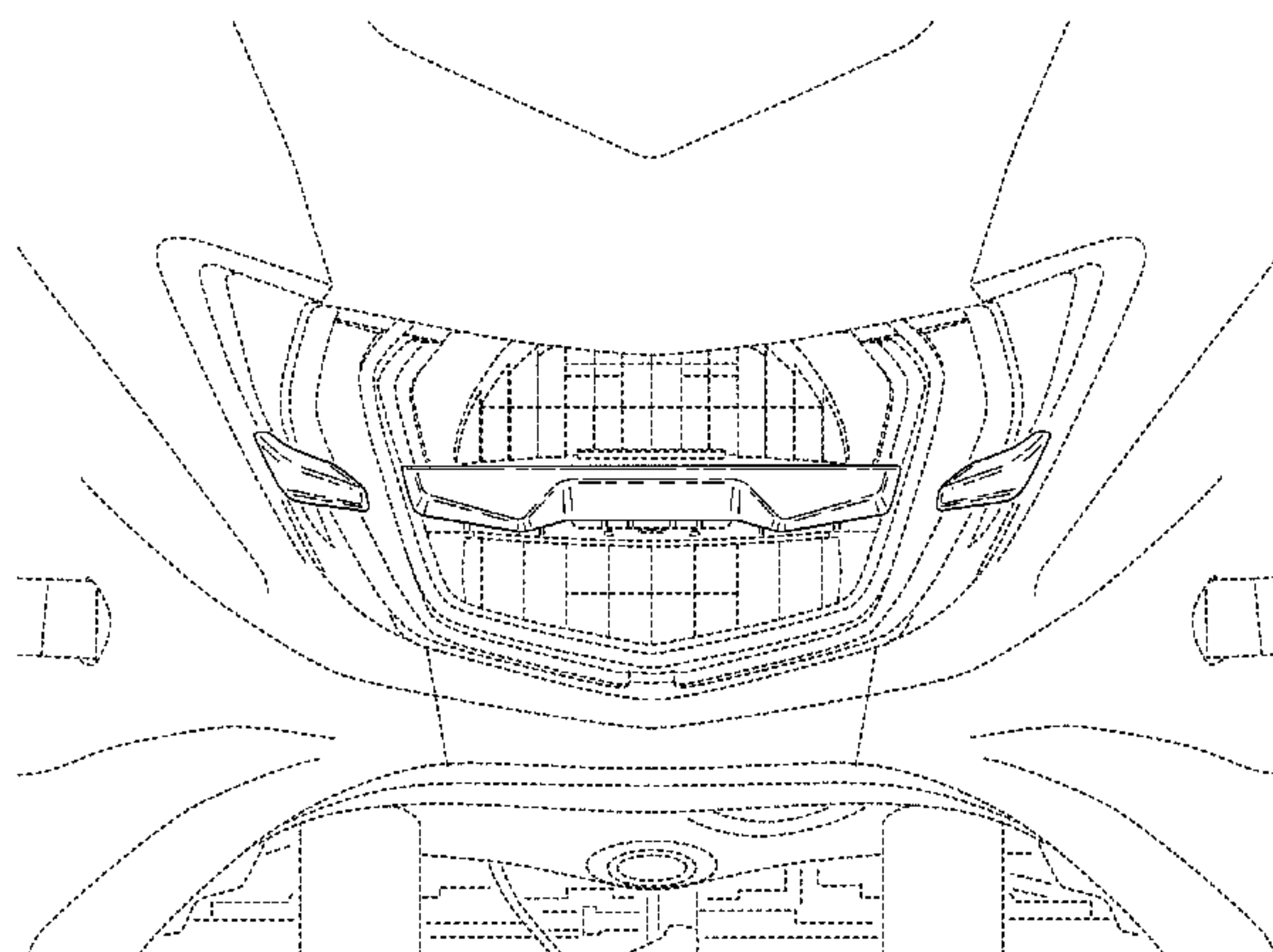
(57) **CLAIM**

The ornamental design for a motorcycle headlight guard, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right side perspective view of a motorcycle headlight guard showing our new design;  
FIG. 2 is a front left side perspective view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a front elevational view thereof,  
FIG. 5 is an enlarged partial front view thereof;  
FIG. 6 is an enlarged partial right side perspective view;  
FIG. 7 is a left side elevational view thereof;  
FIG. 8 is a rear view thereof; and,  
FIG. 9 is a top plan view thereof.

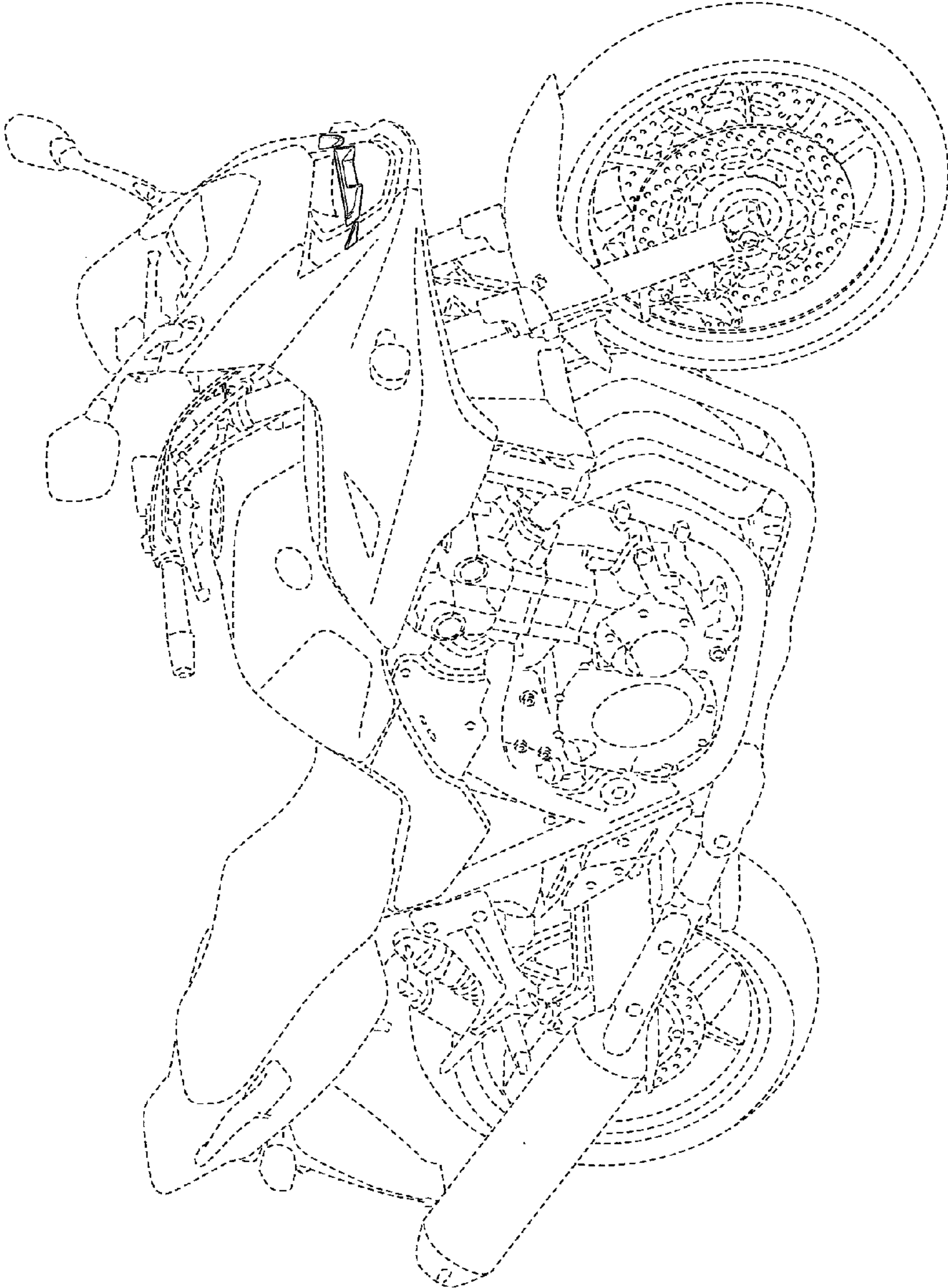

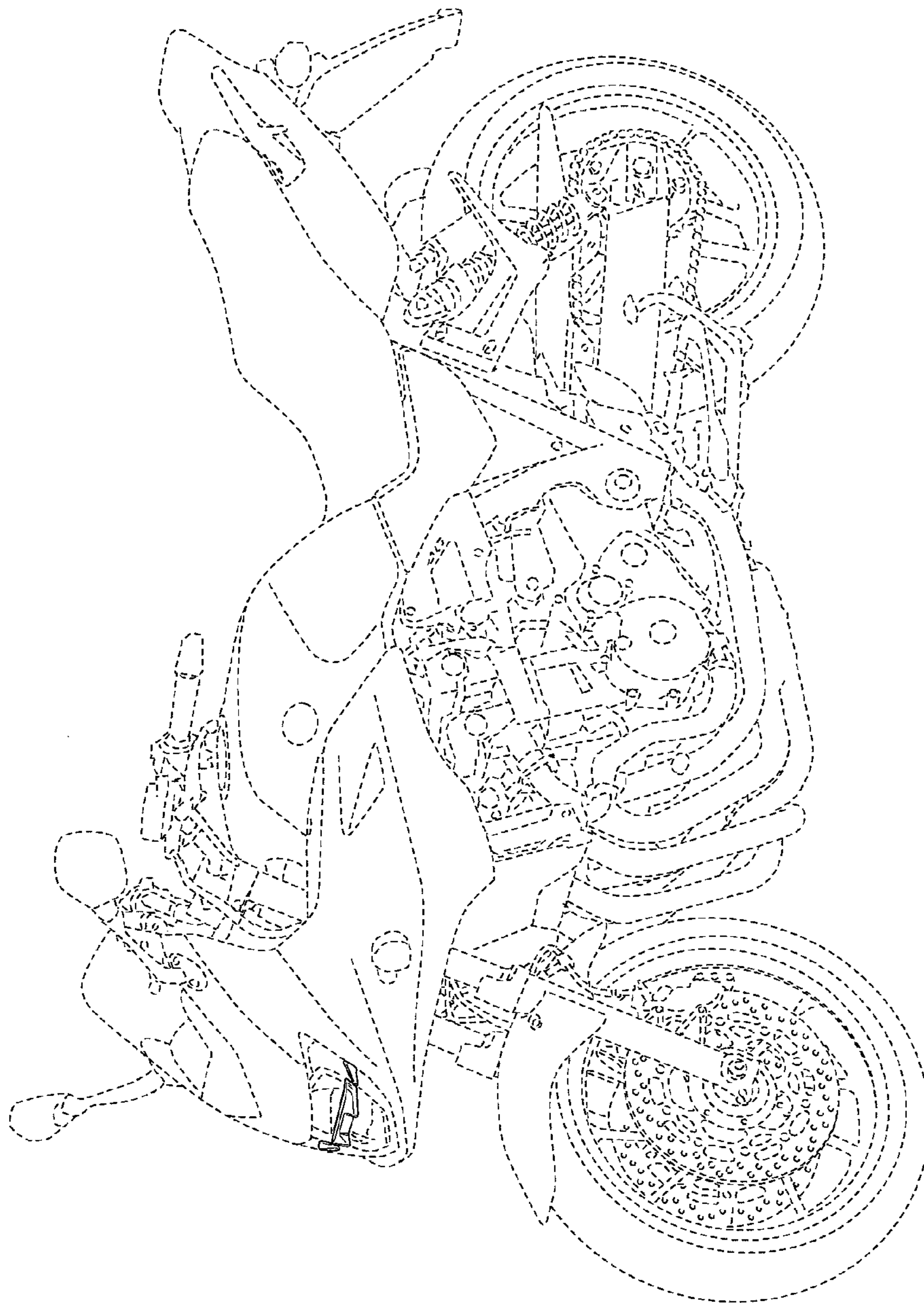

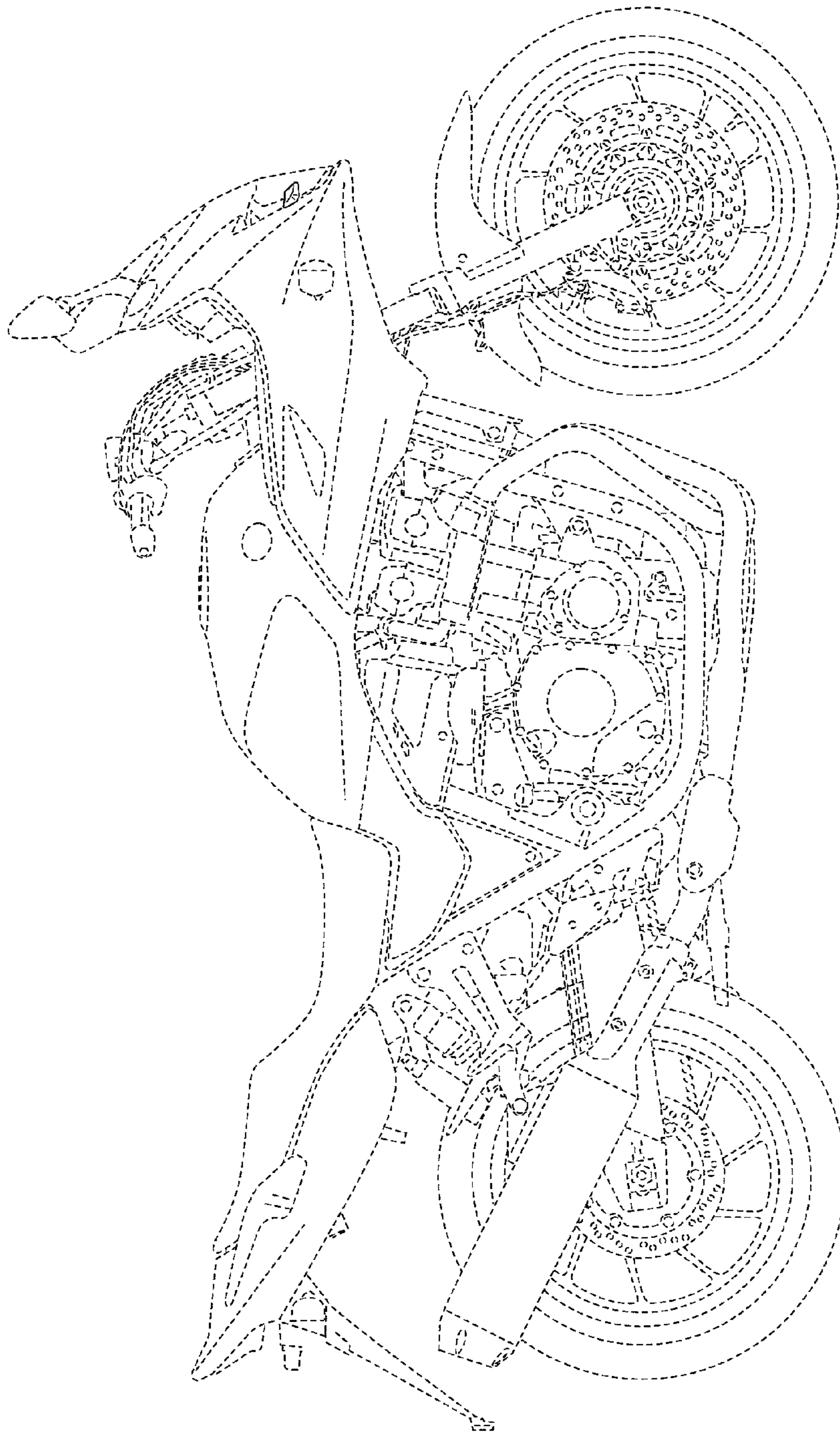

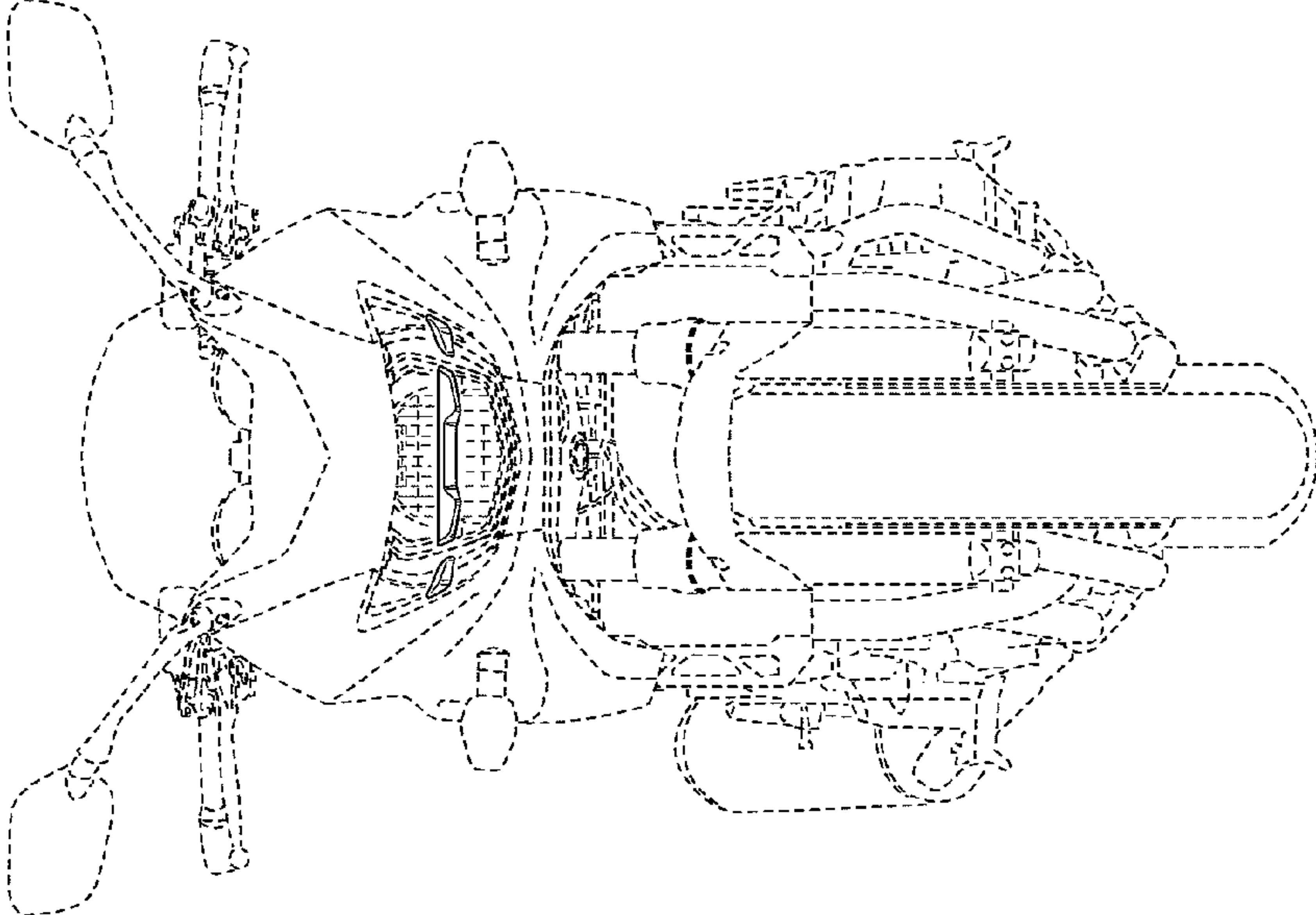

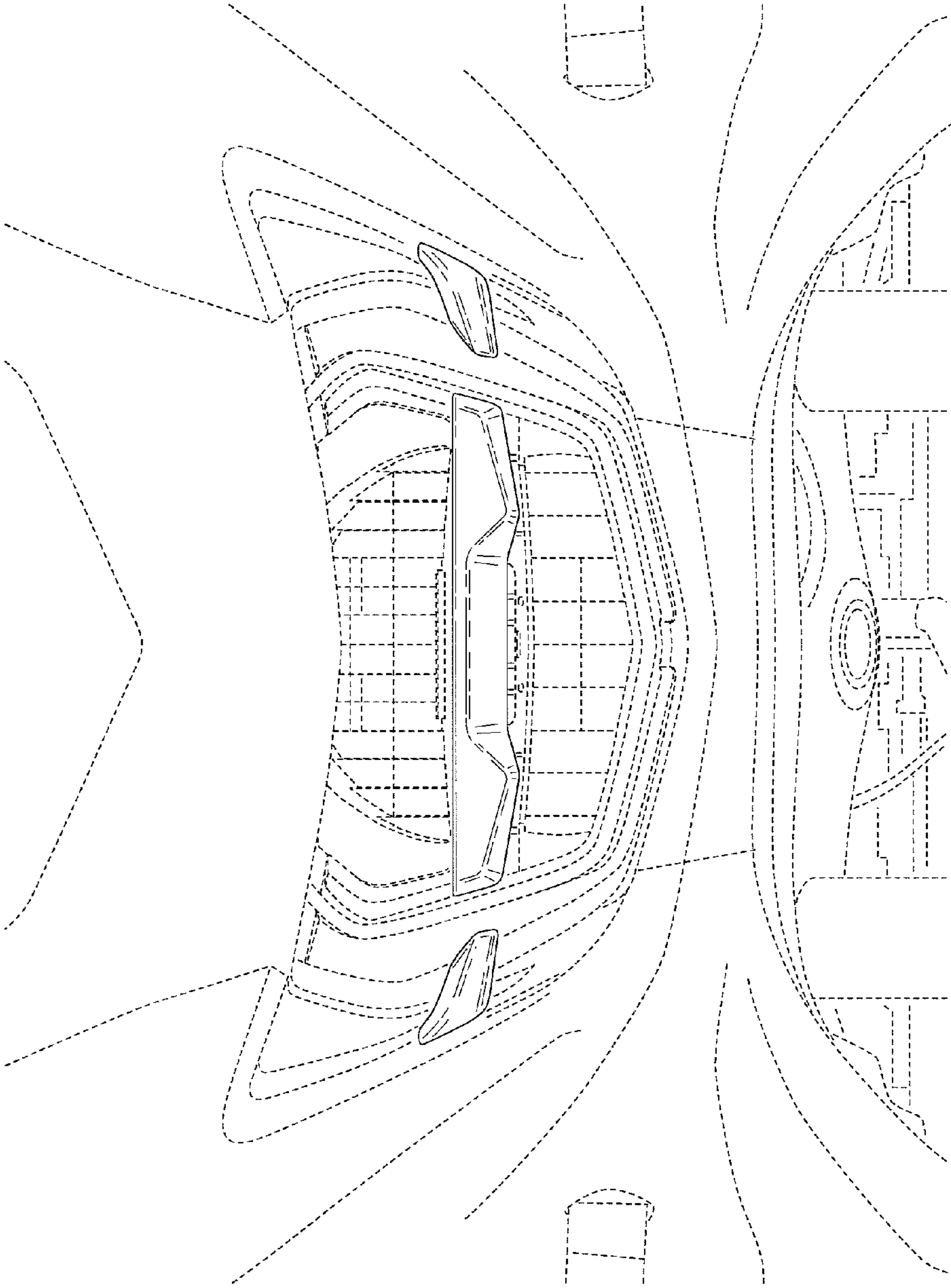

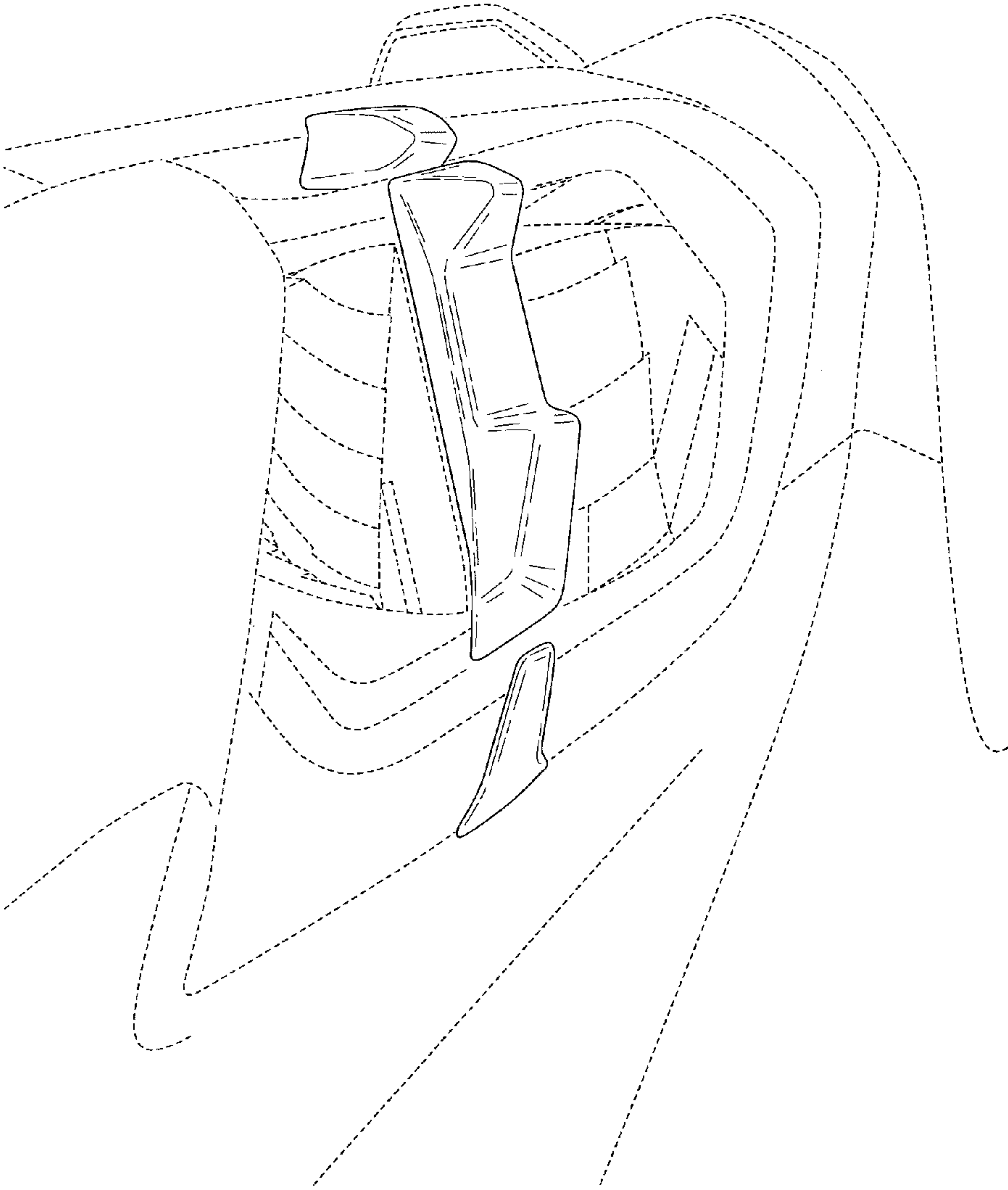

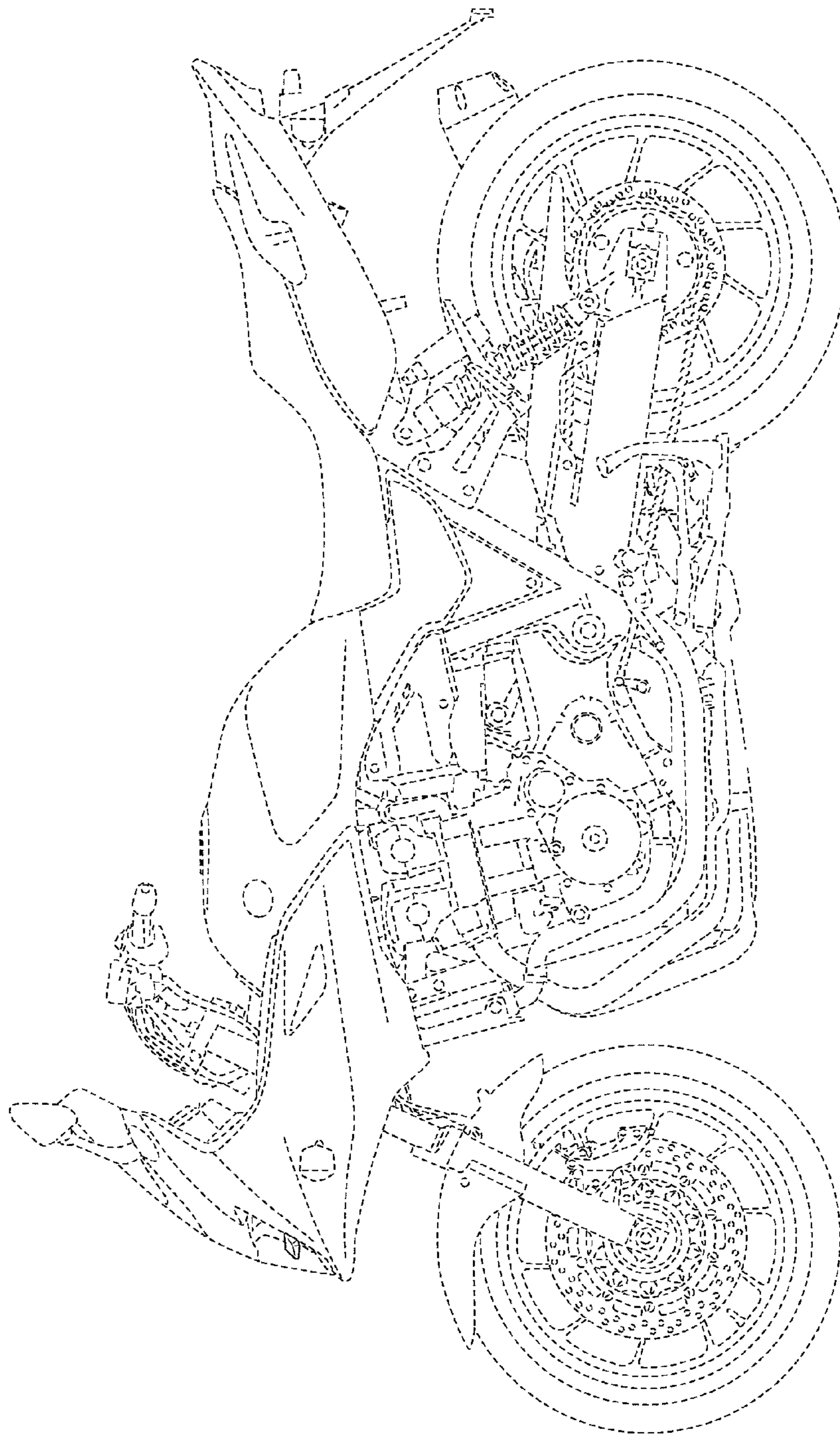

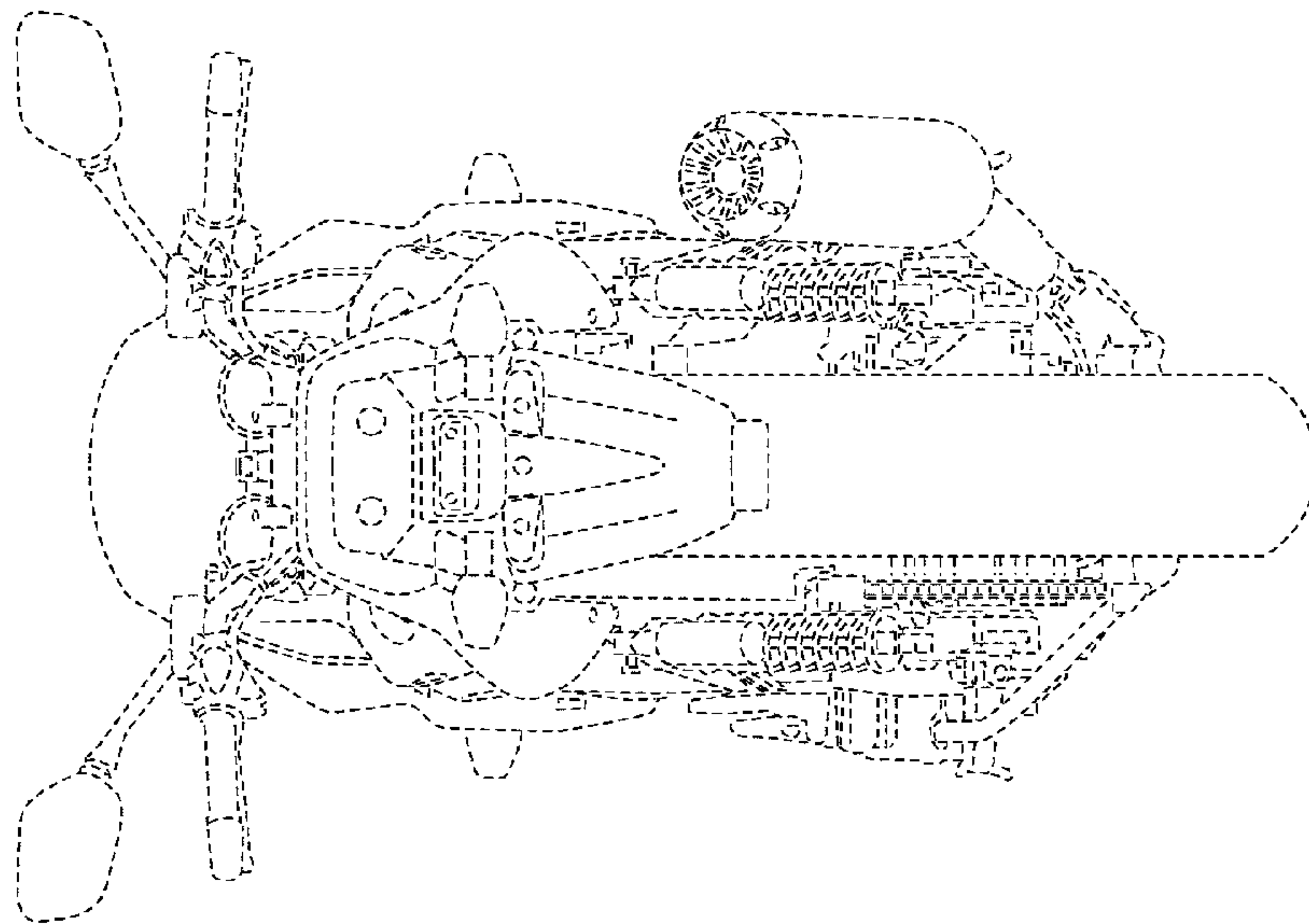

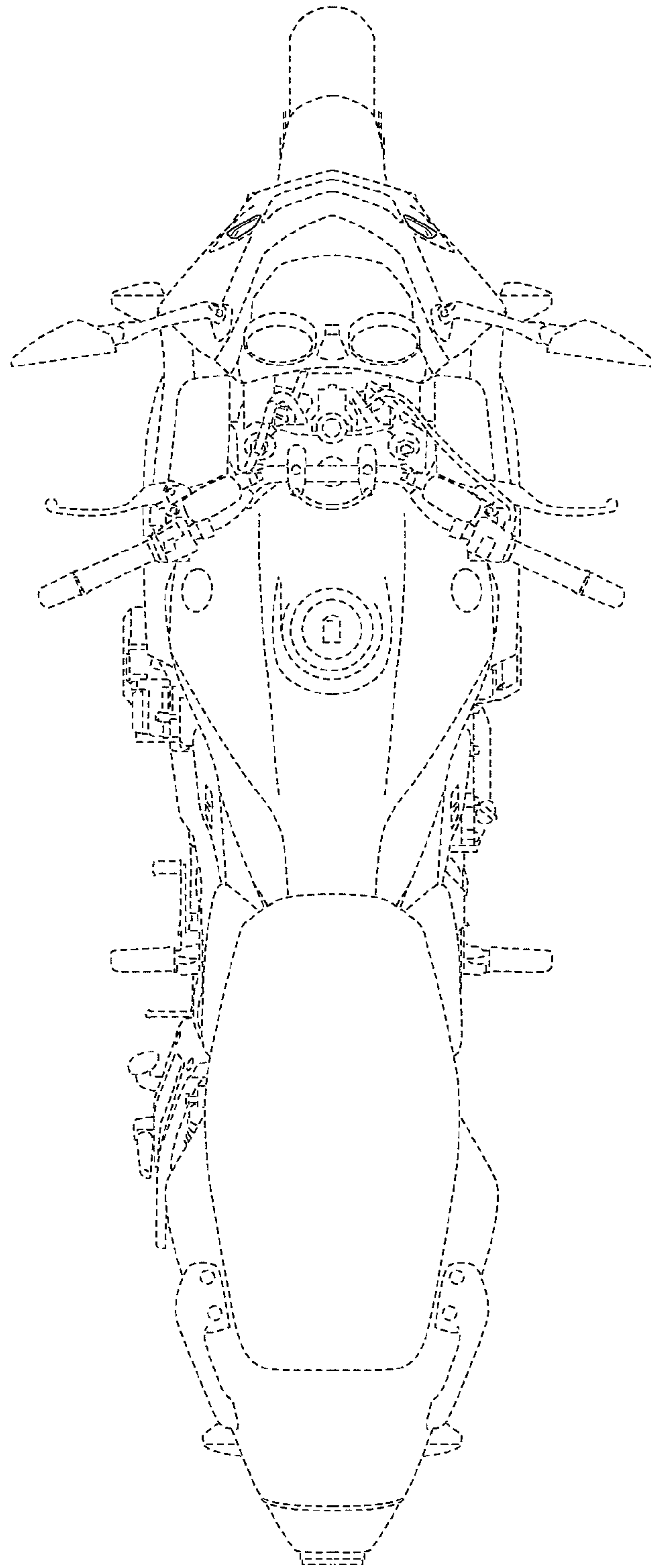
