DESCRIPTION

FIG. 1 is a perspective view of a television receiver showing our new design;

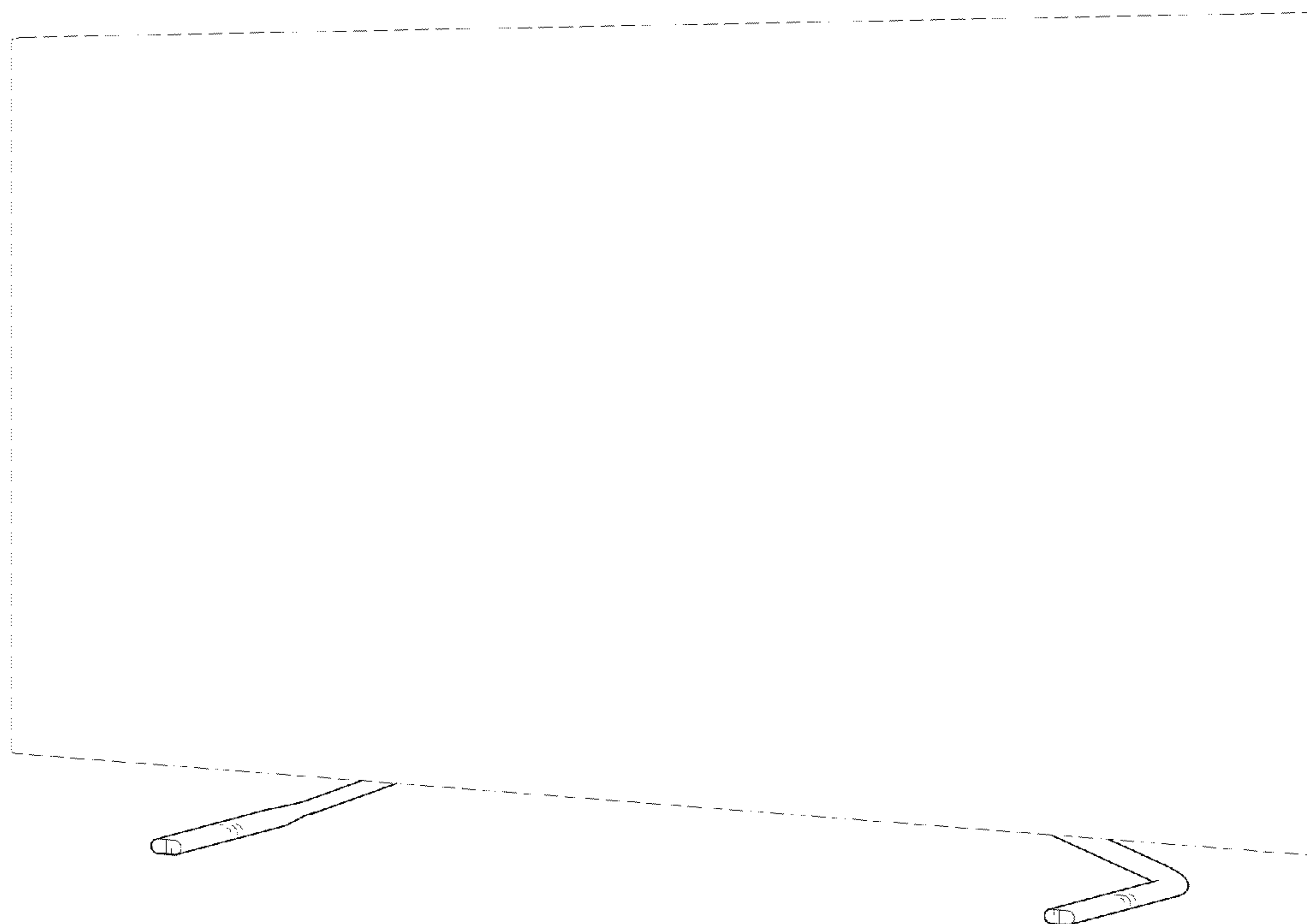

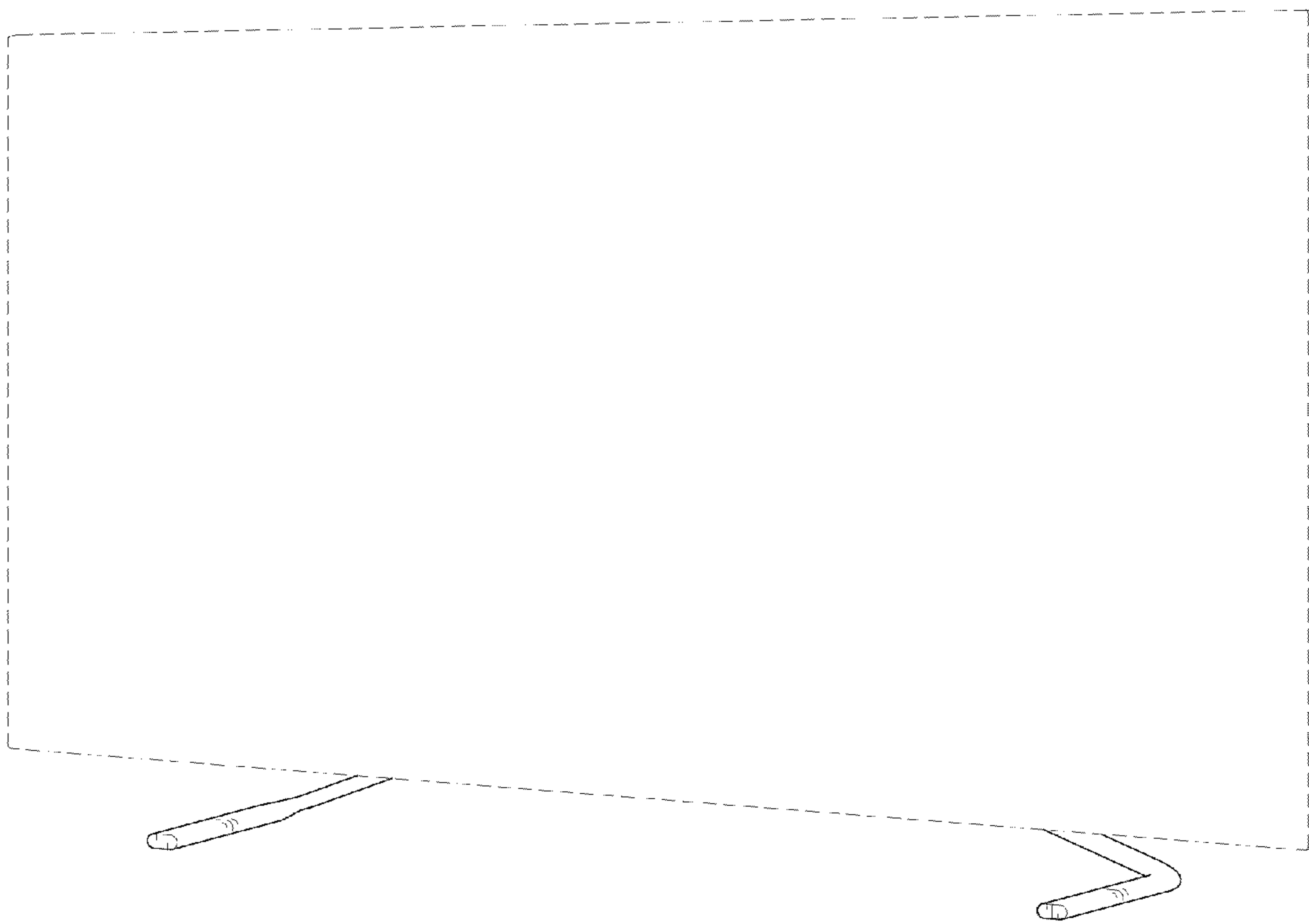

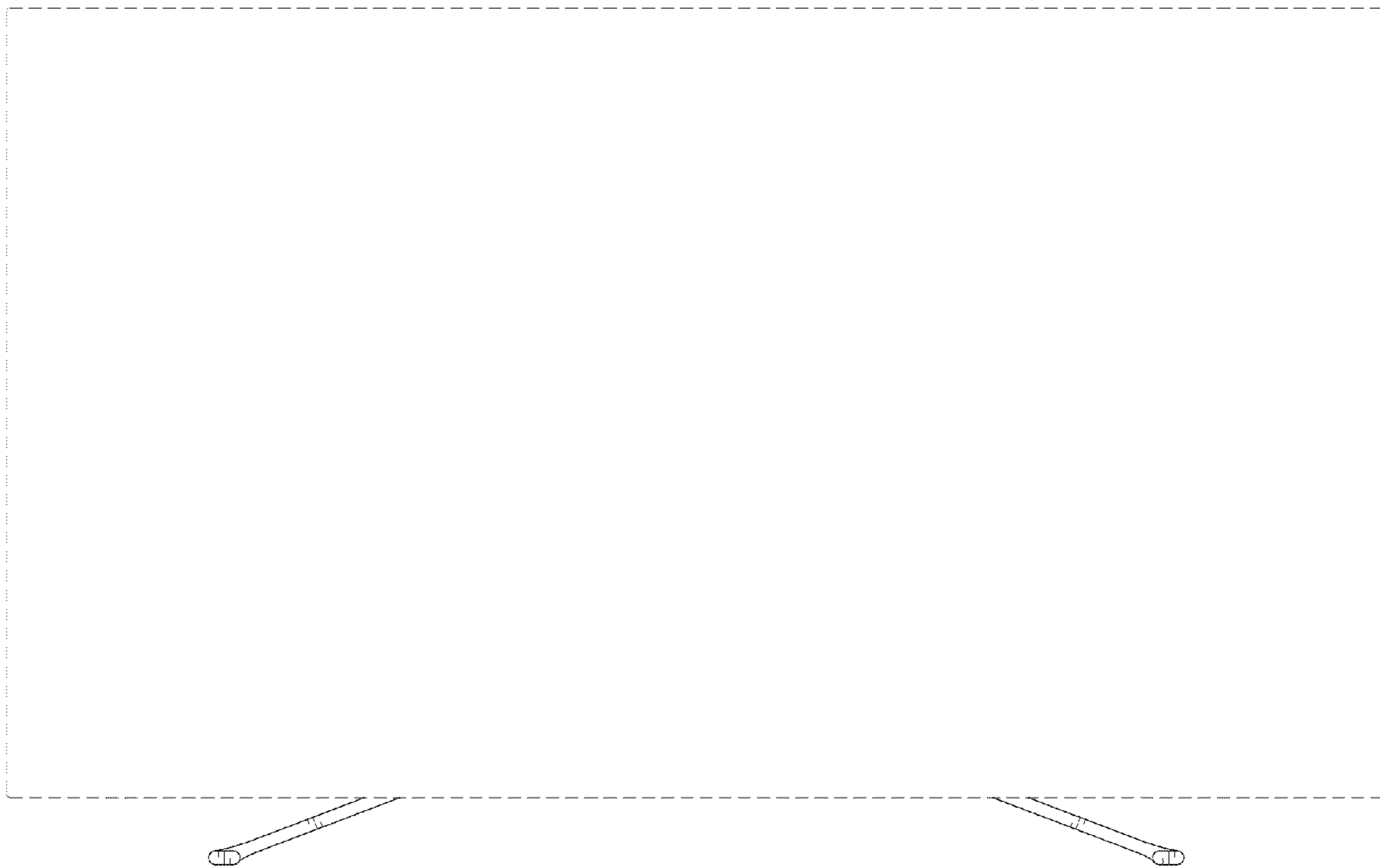

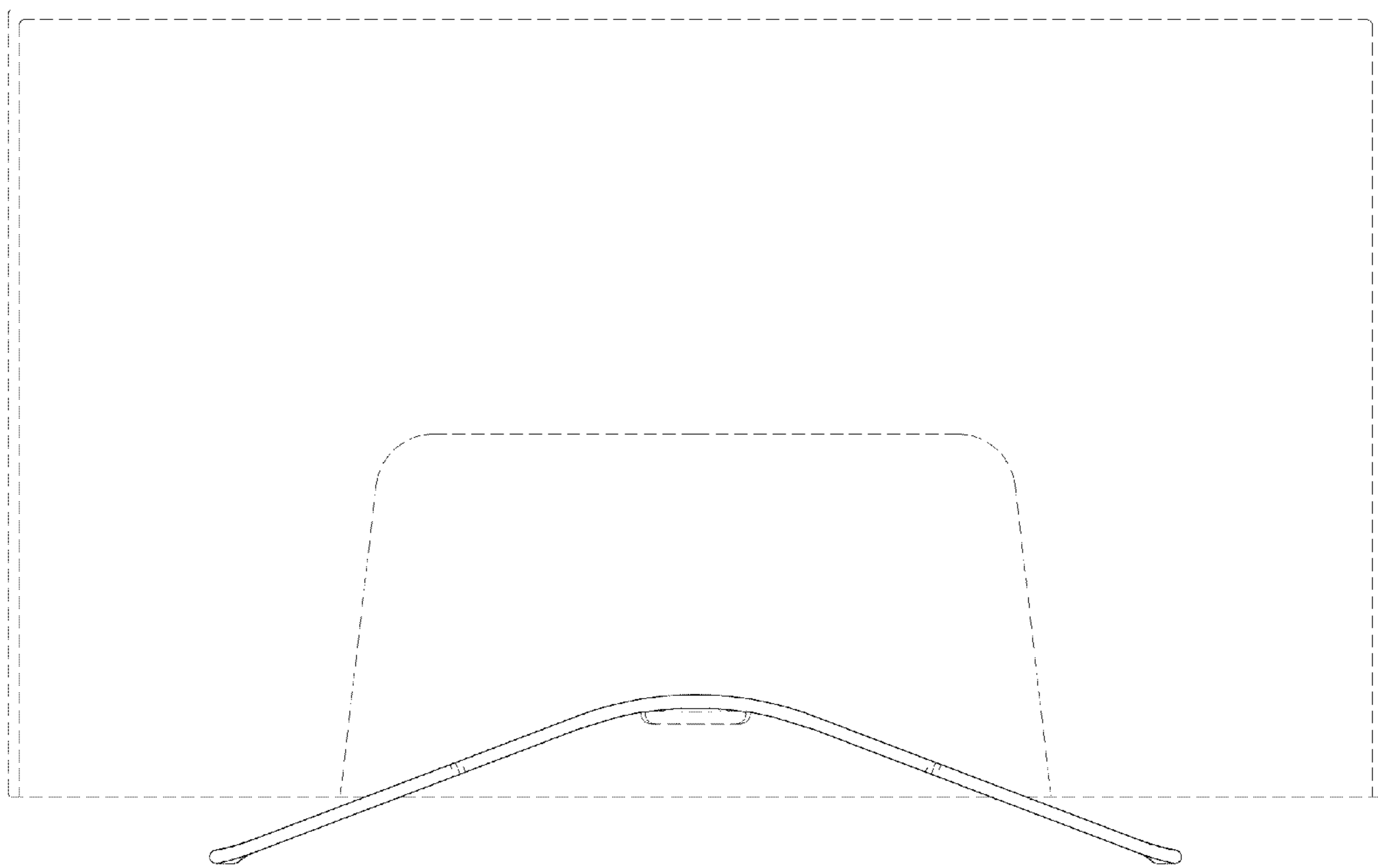

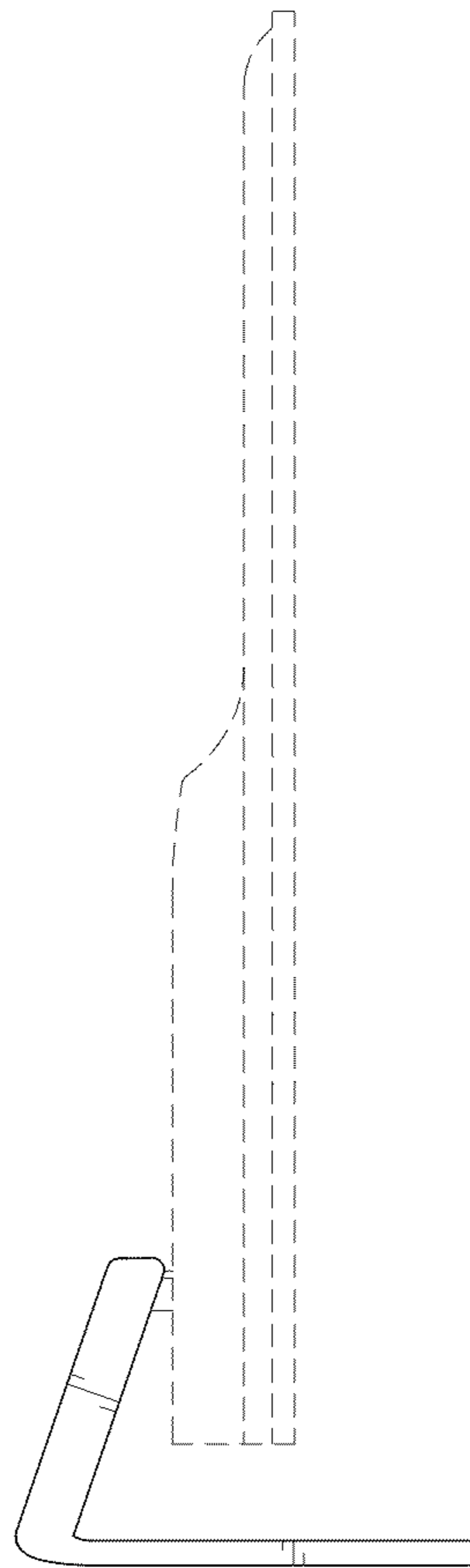

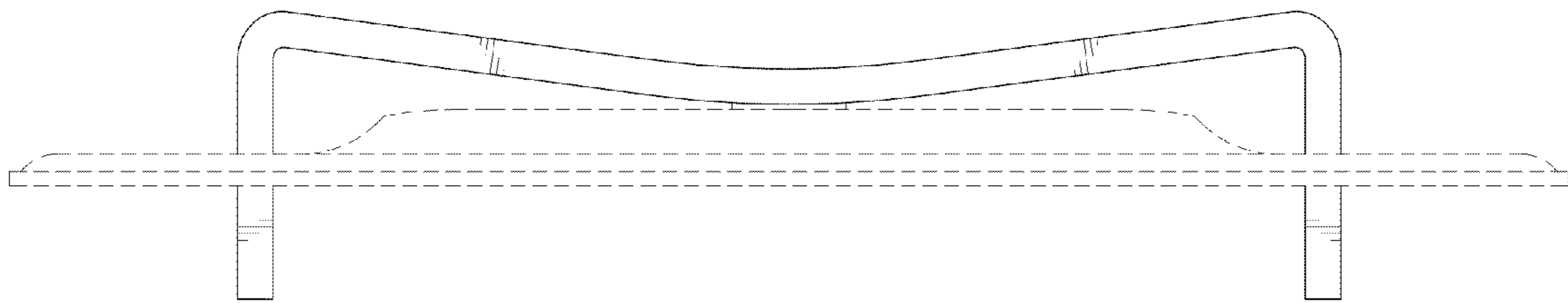

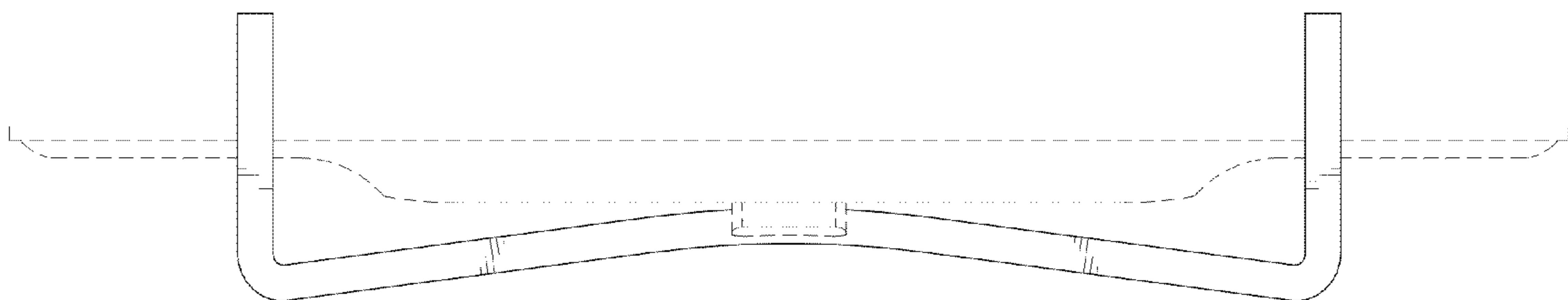
