icon, as shown and described.

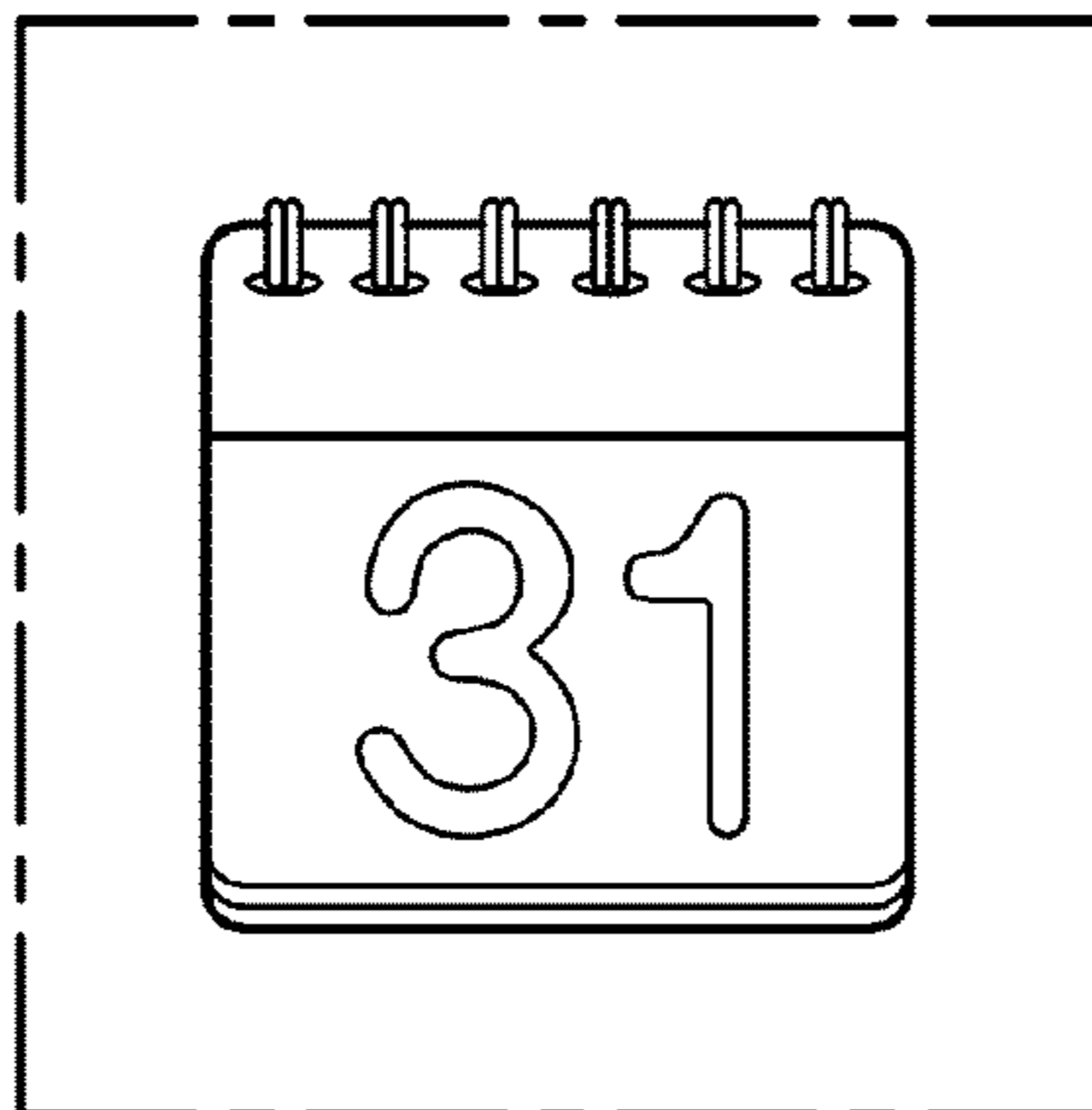
**DESCRIPTION**

FIG. 1 is a front view of a portion of a display screen with icon  
showing our new design; and,

FIG. 2 is a front view of the portion of a display screen with  
icon of FIG. 1, in which a mobile terminal in broken lines is  
provided to illustrate an example environment.

The broken line drawing of the portion of a display screen in  
FIGS. 1 and 2, mobile terminal, and the symbols and other-  
wise images shown in broken lines in FIG. 2 are for illustra-

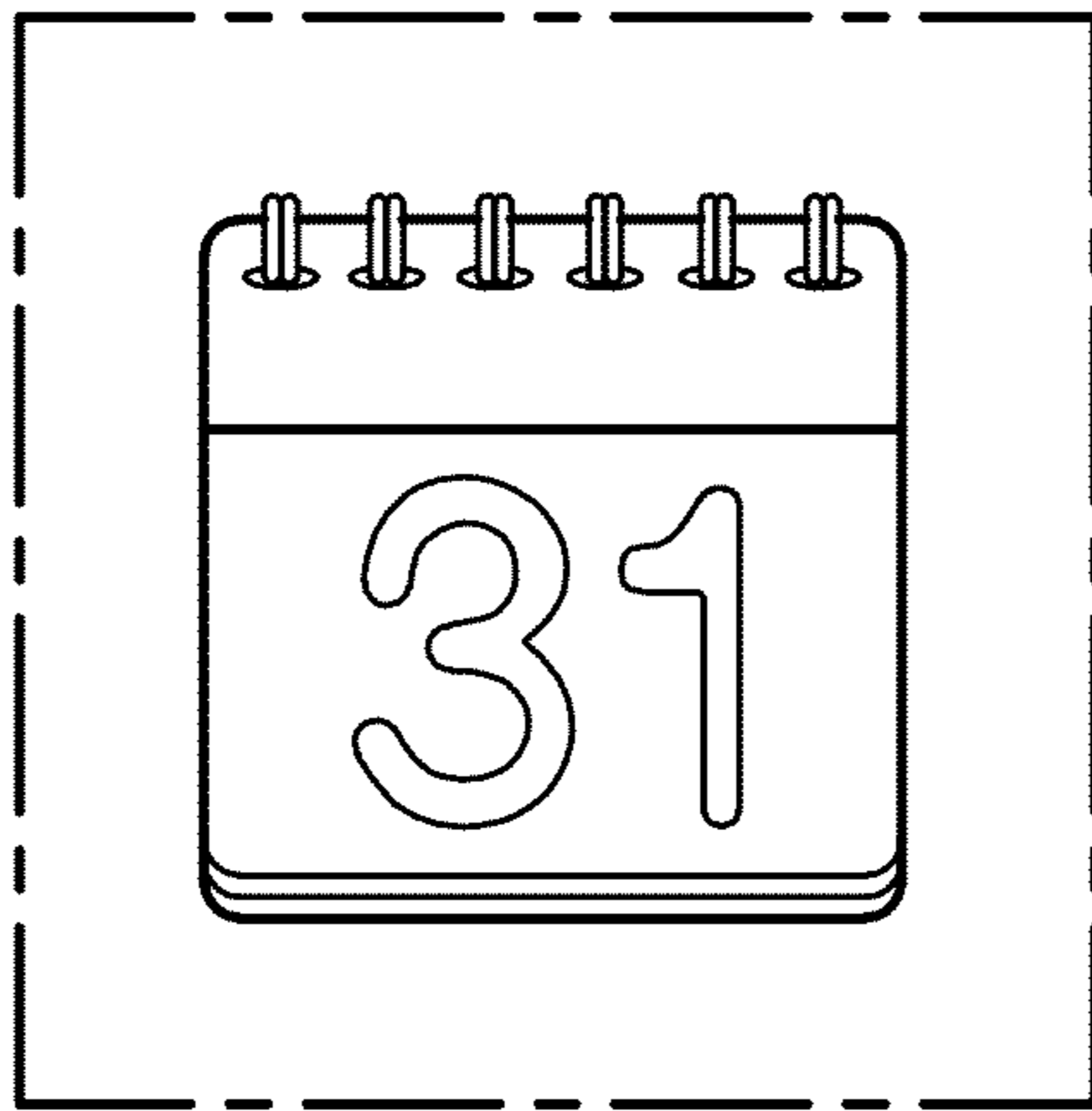
