I claim the ornamental design for the computer screen display, as shown and described.

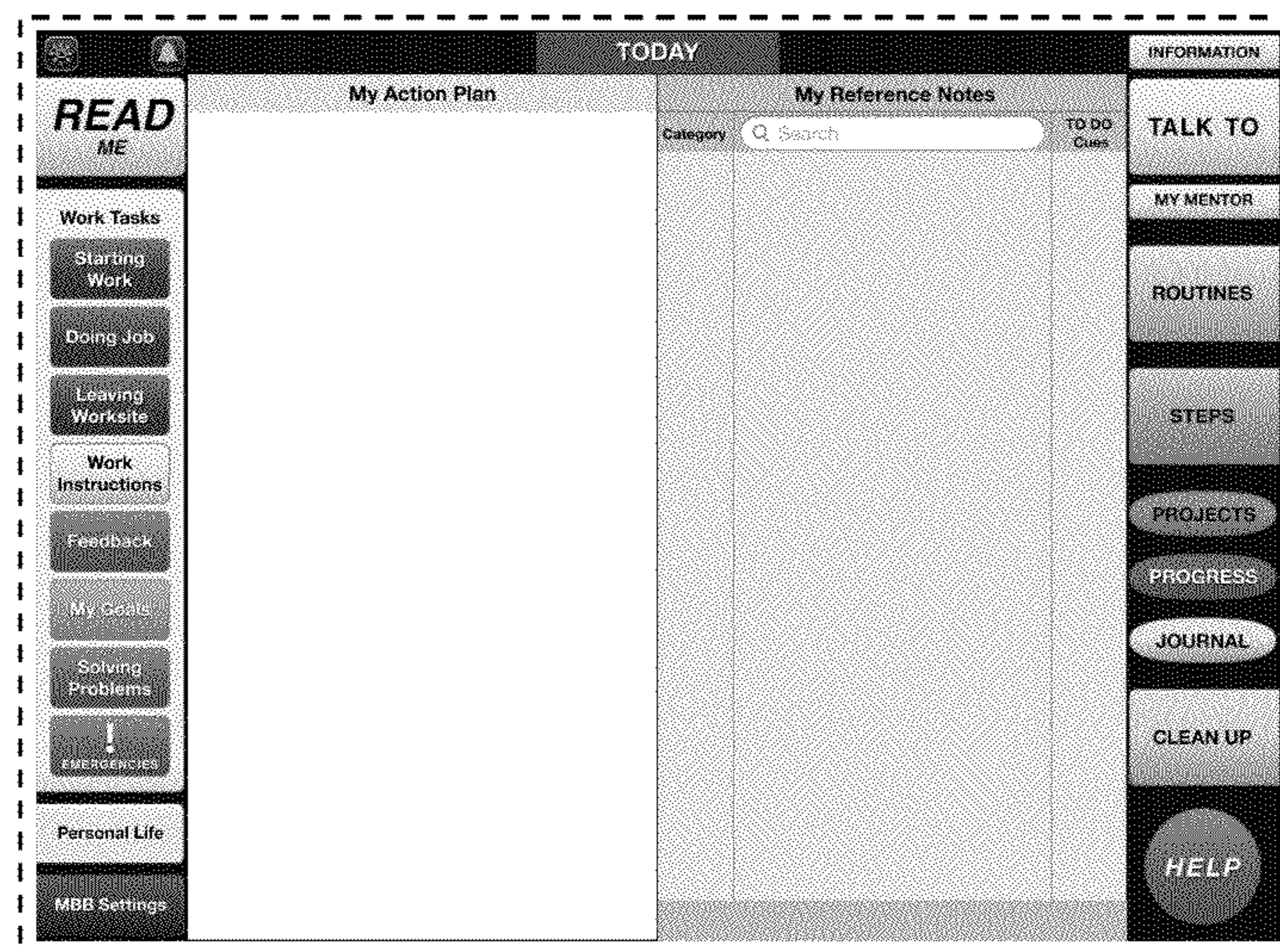
DESCRIPTION
