(57) **CLAIM**

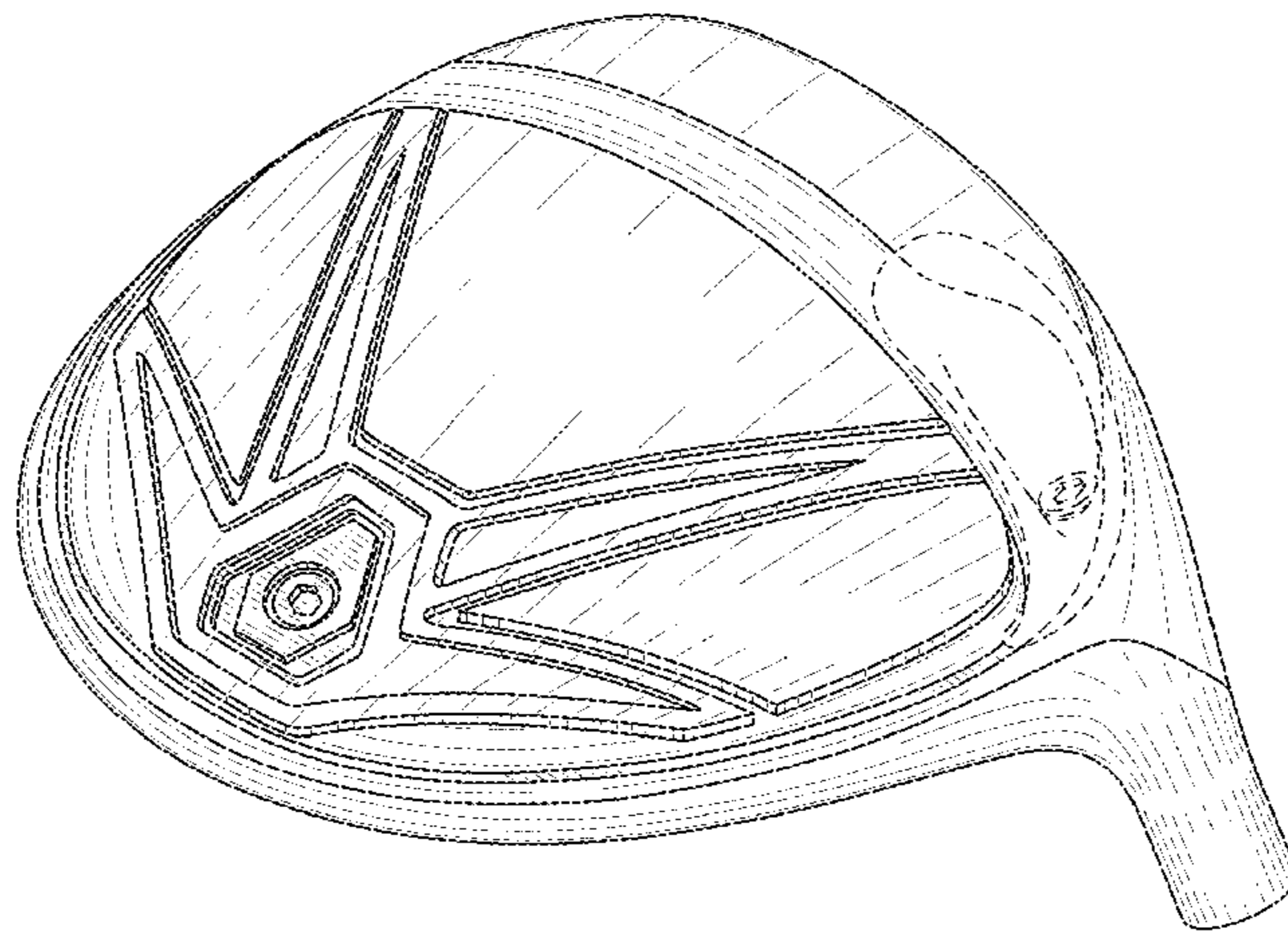
The ornamental design for a golf club head, as shown and described.

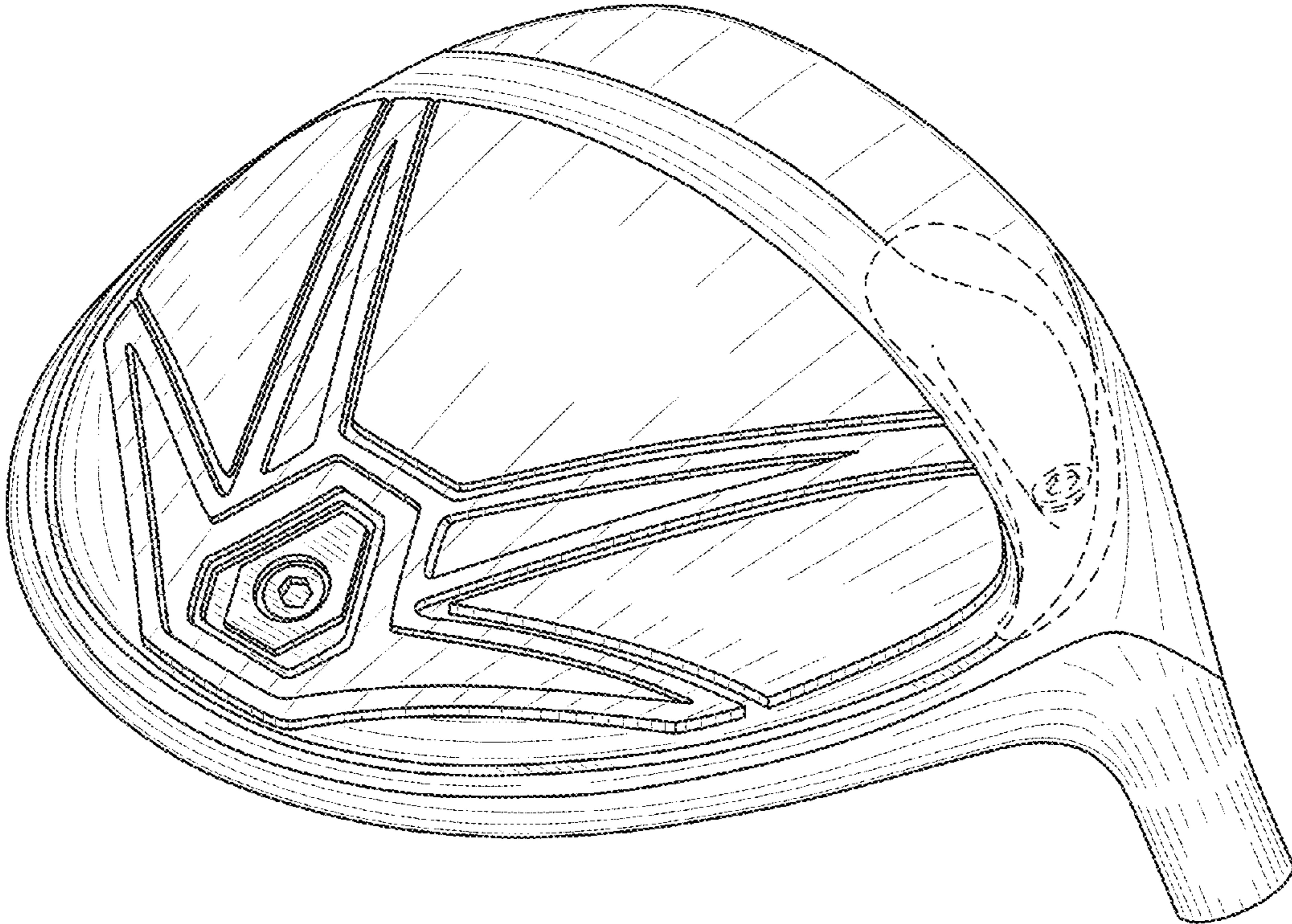

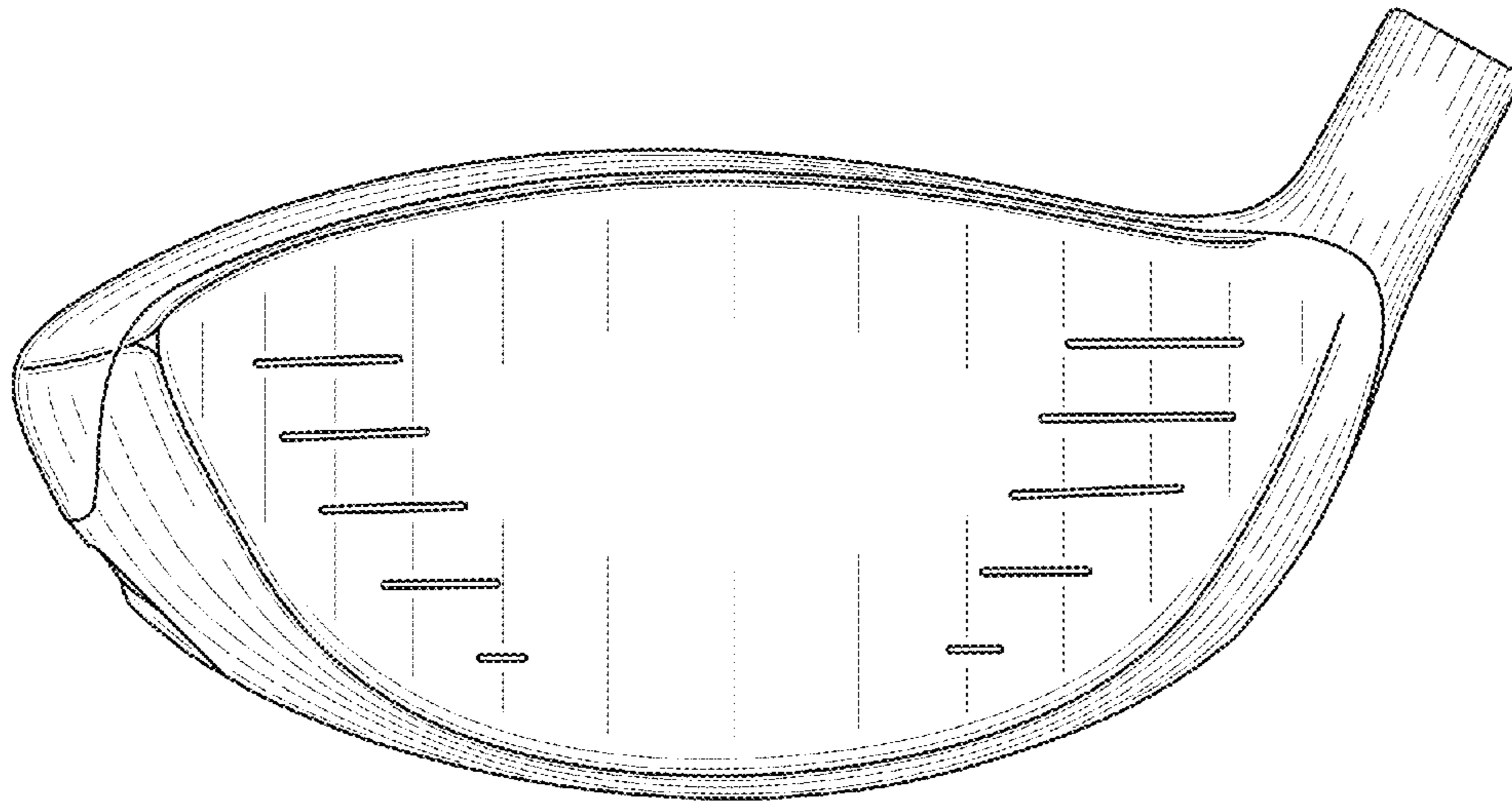

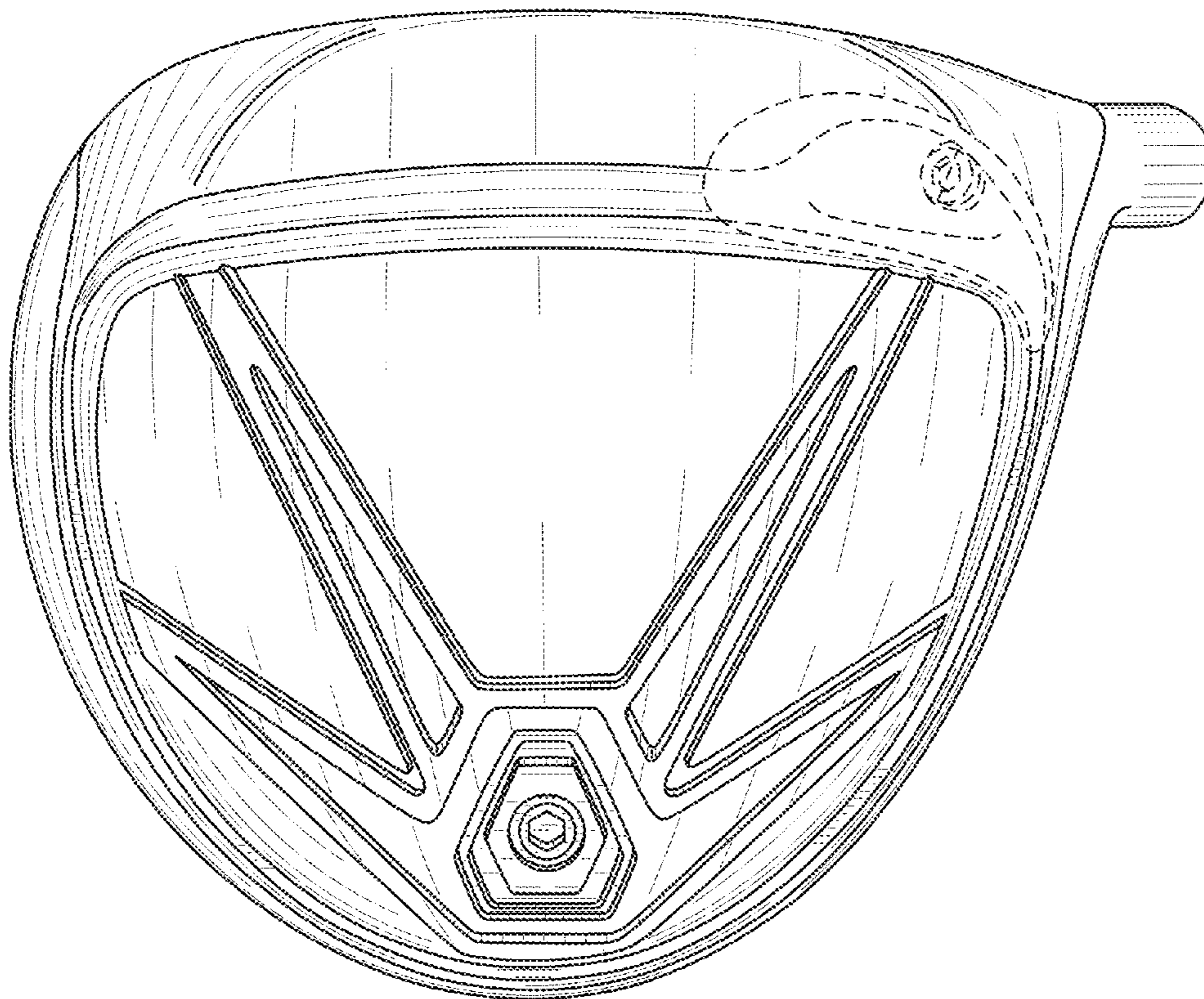

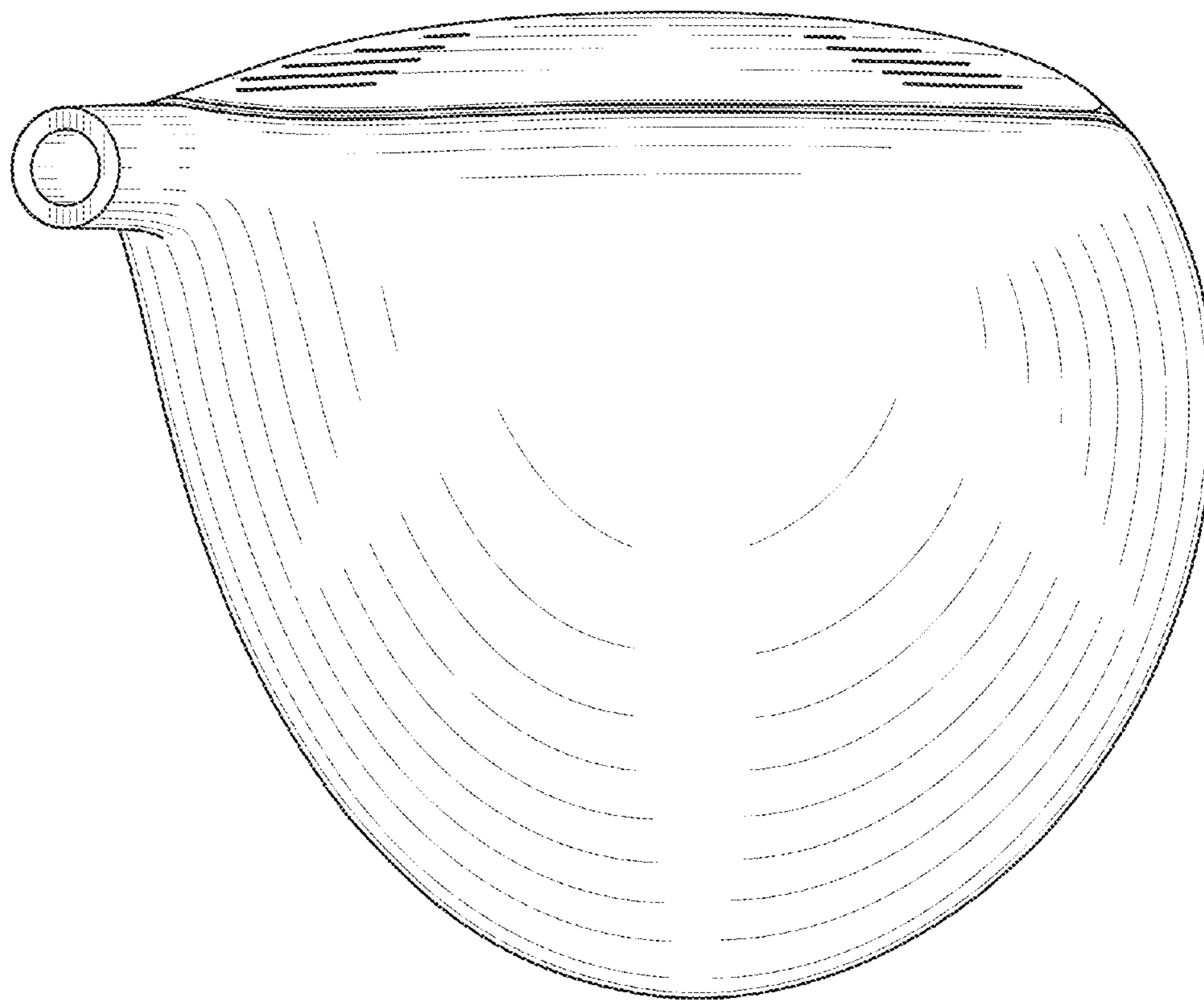

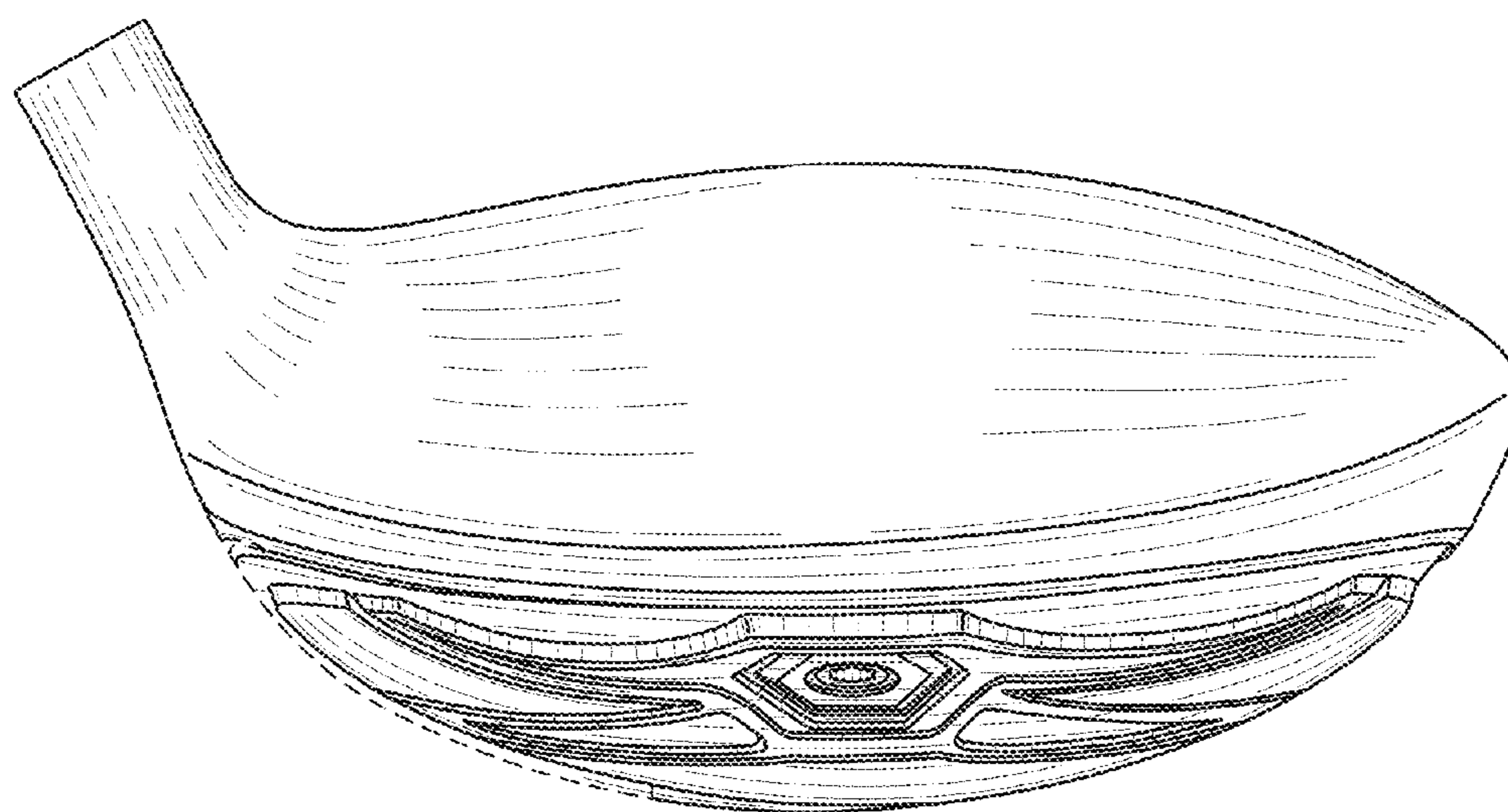

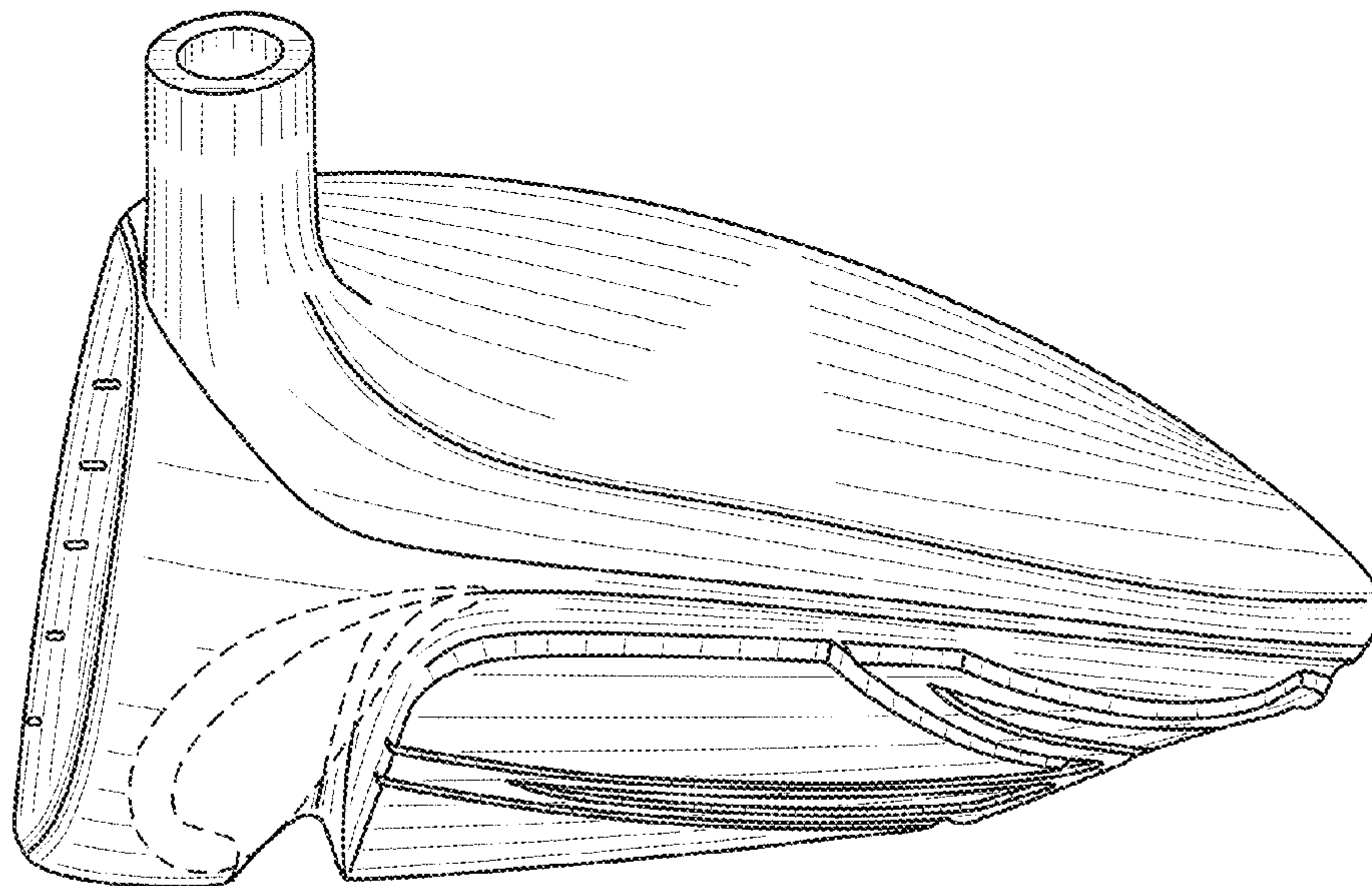

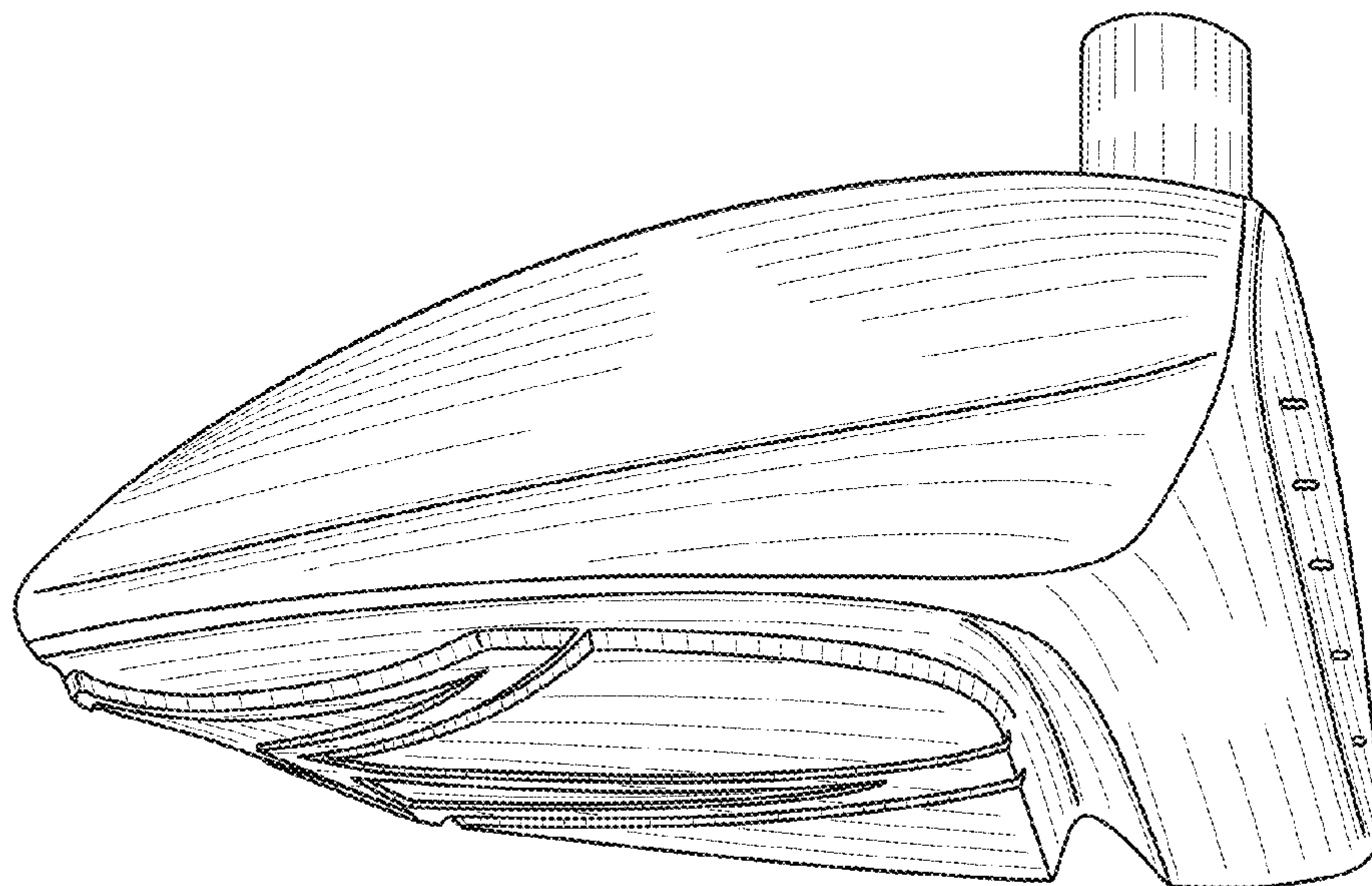
