DESCRIPTION

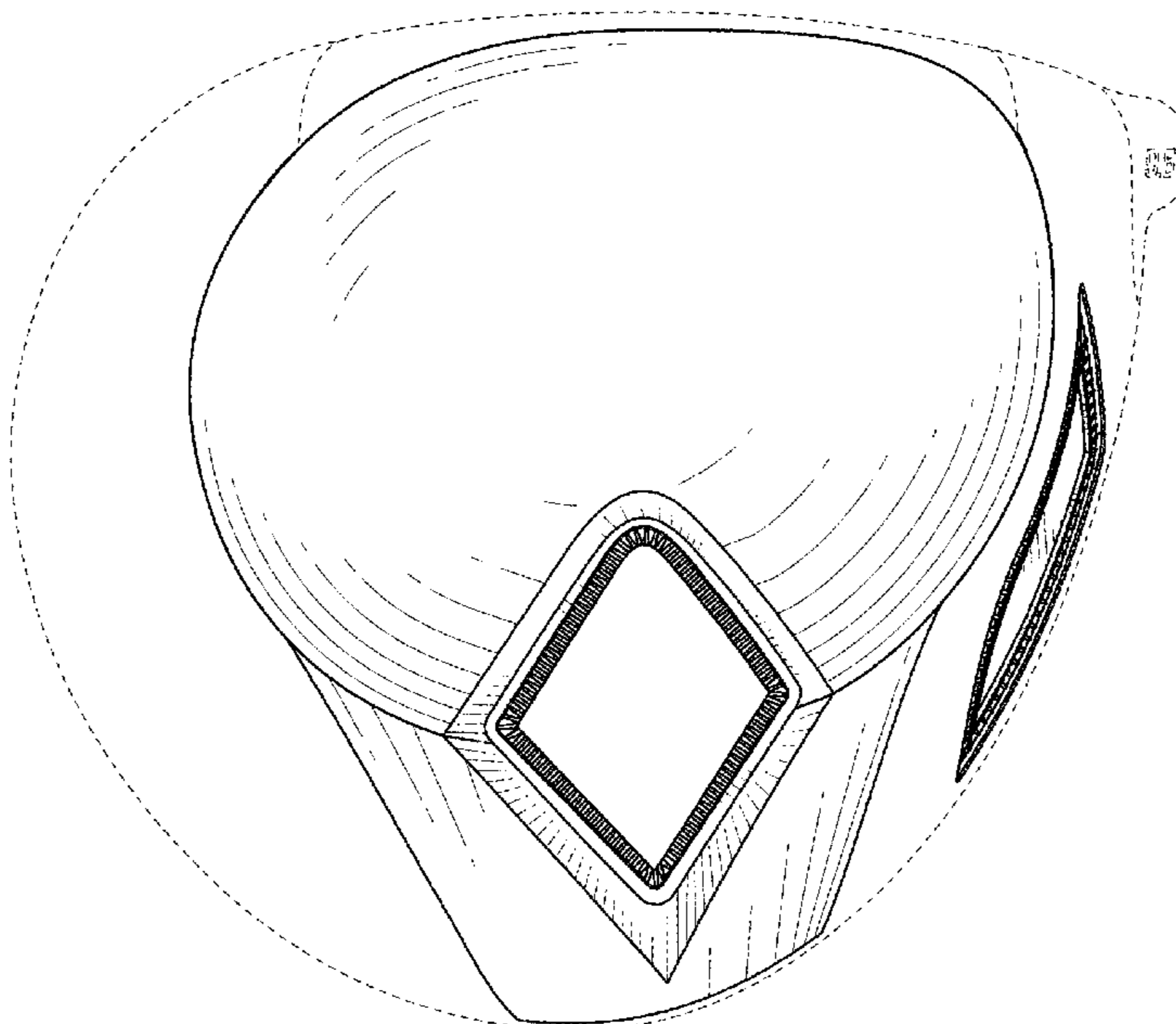
FIG. 1 is a perspective view of the golf club head herein;

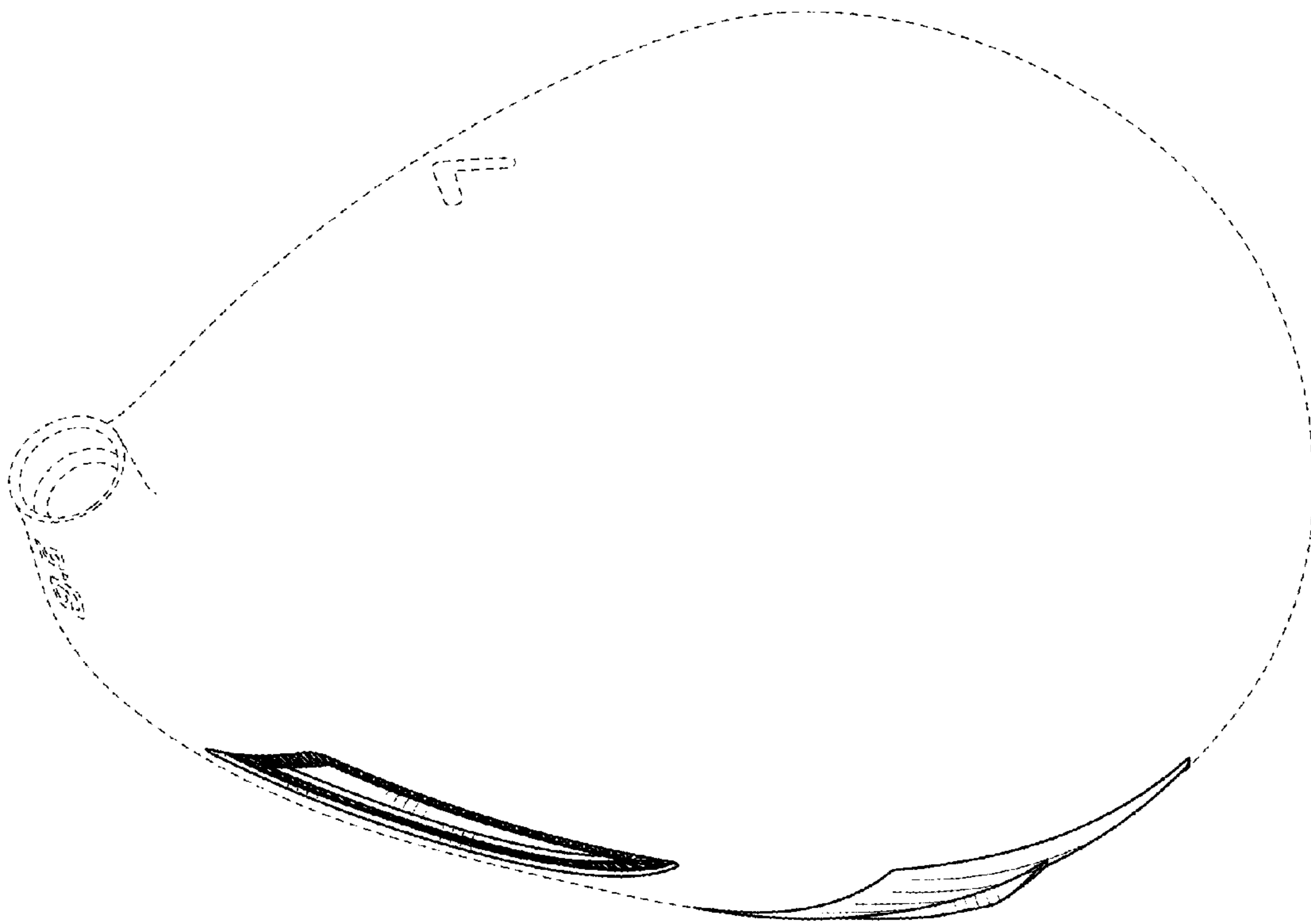

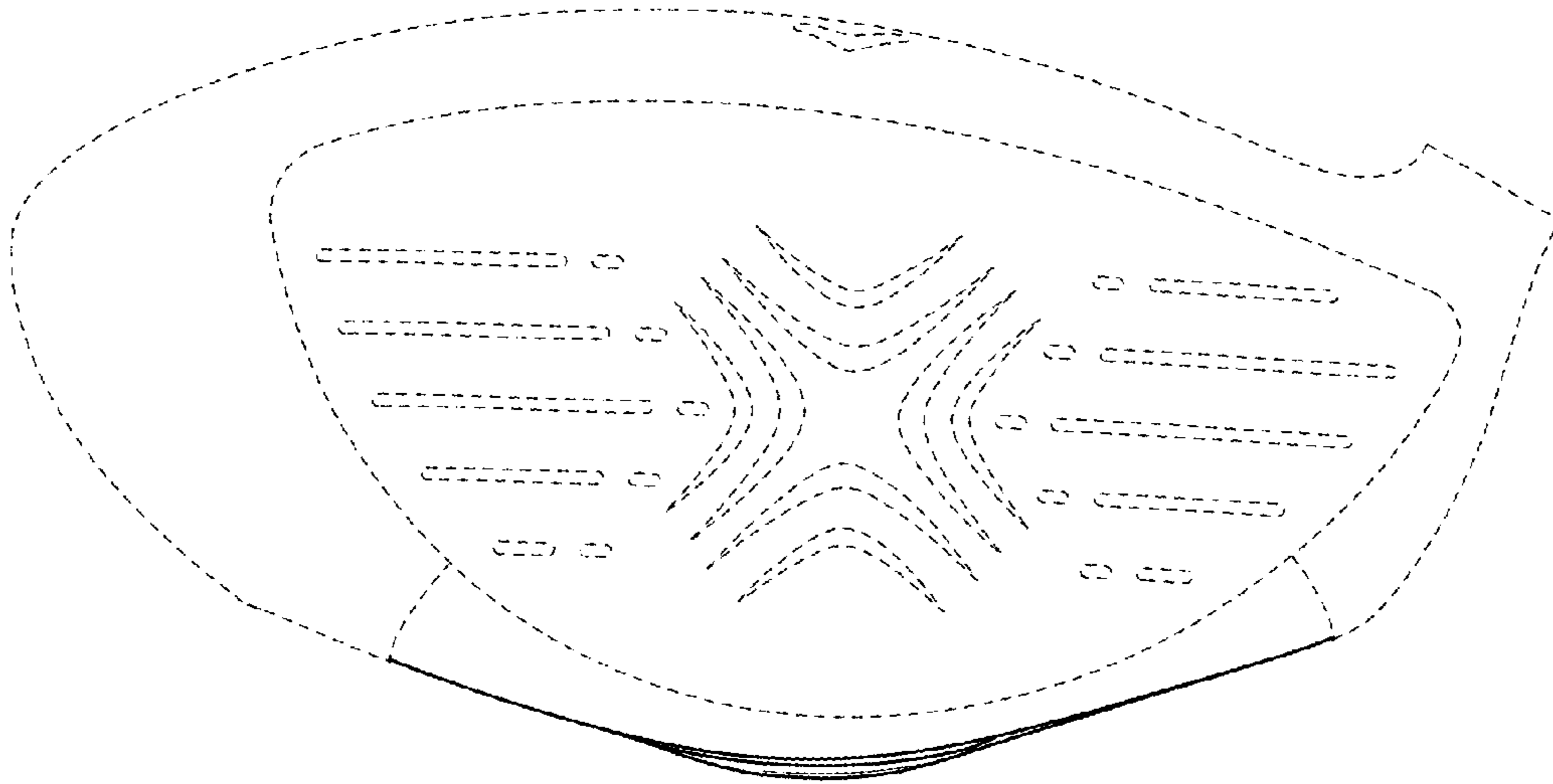

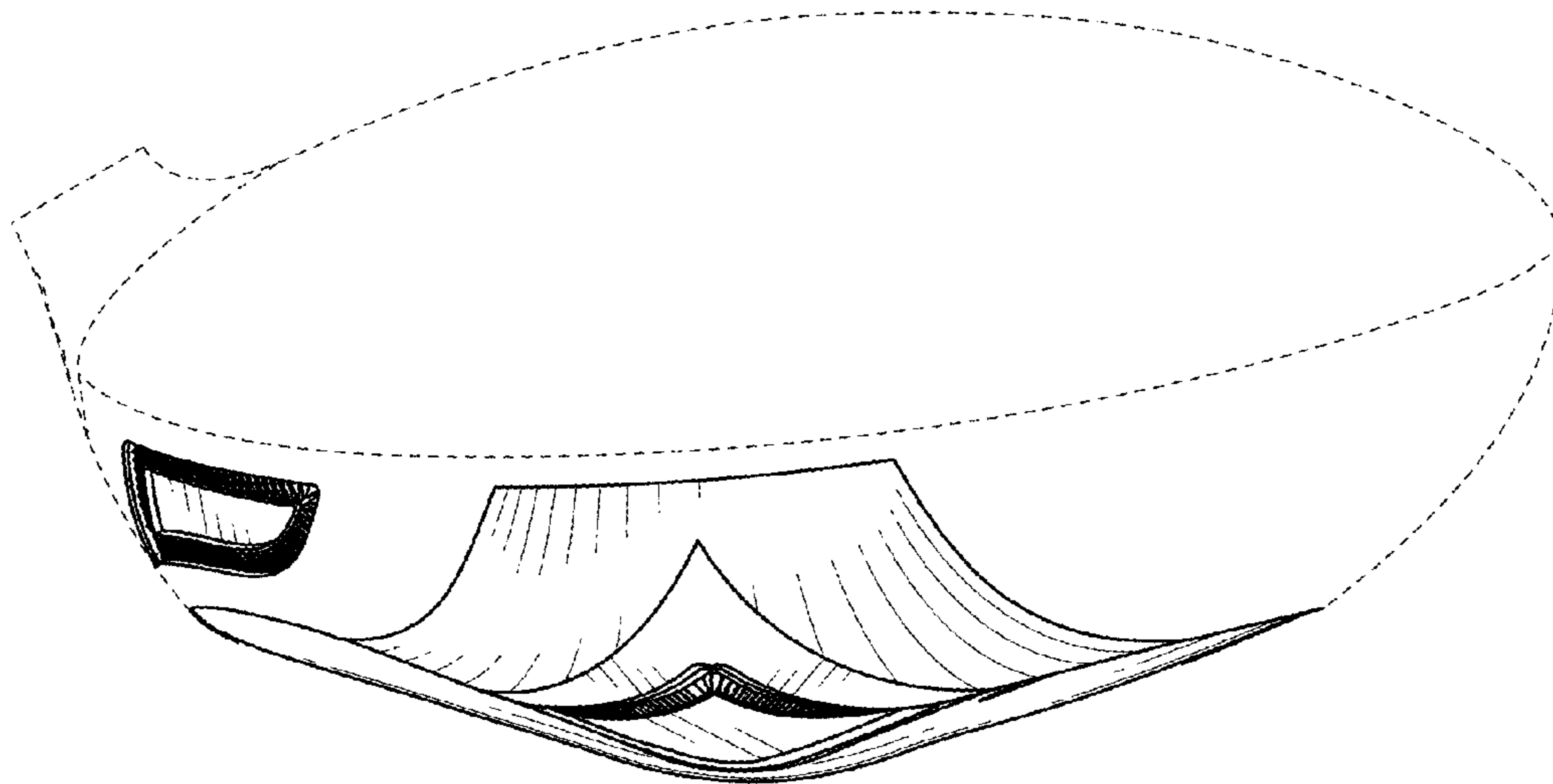

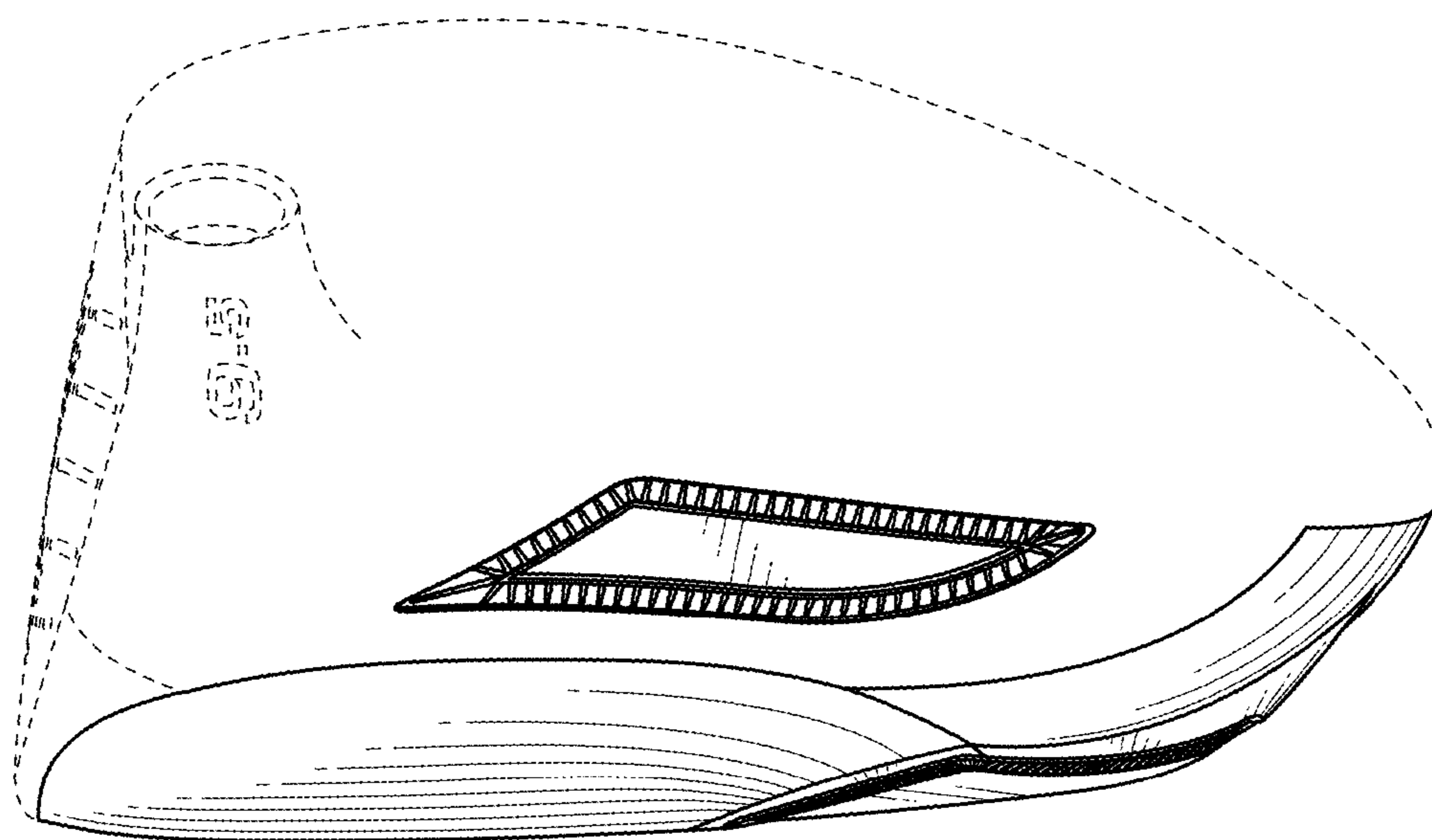

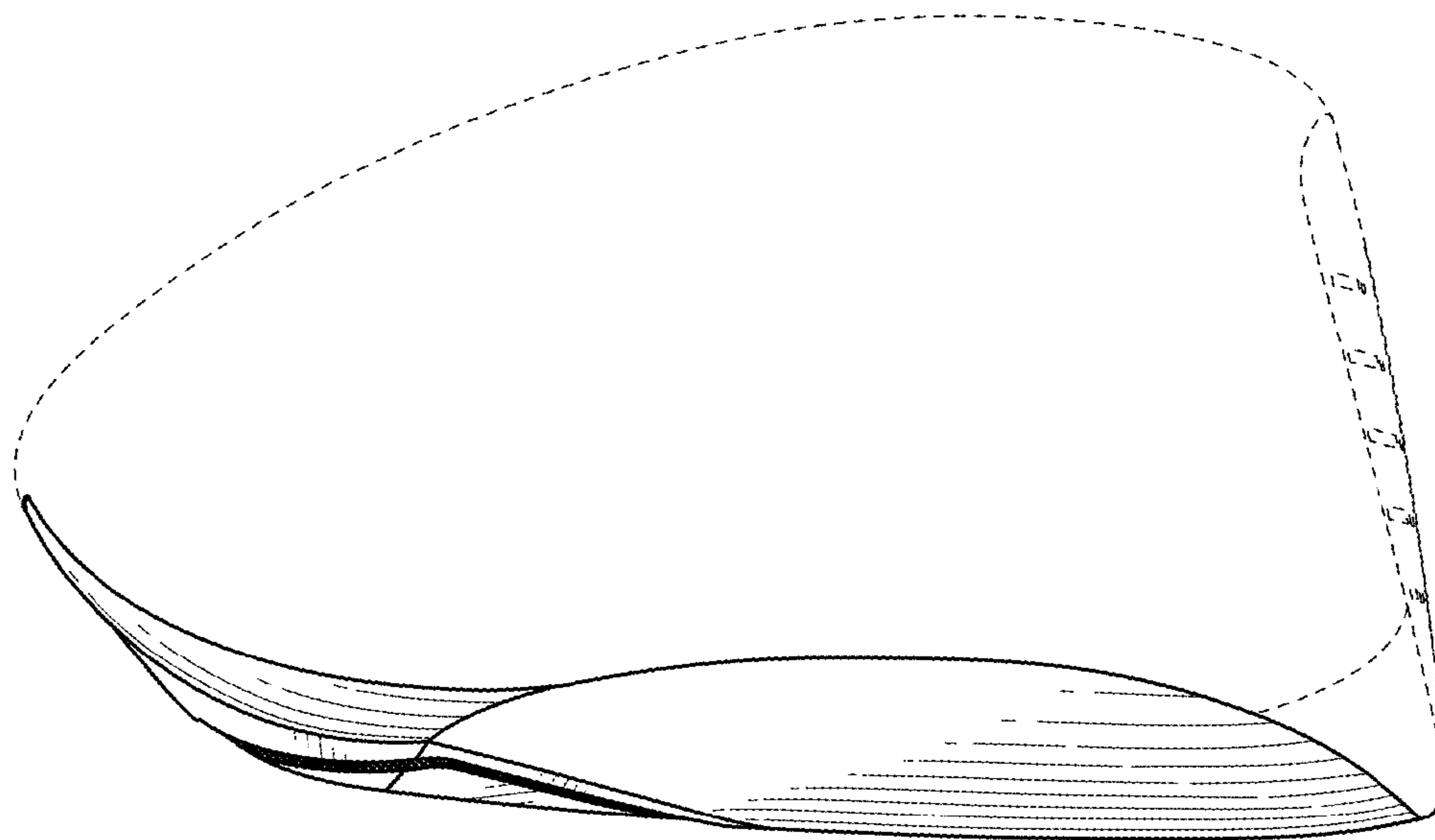

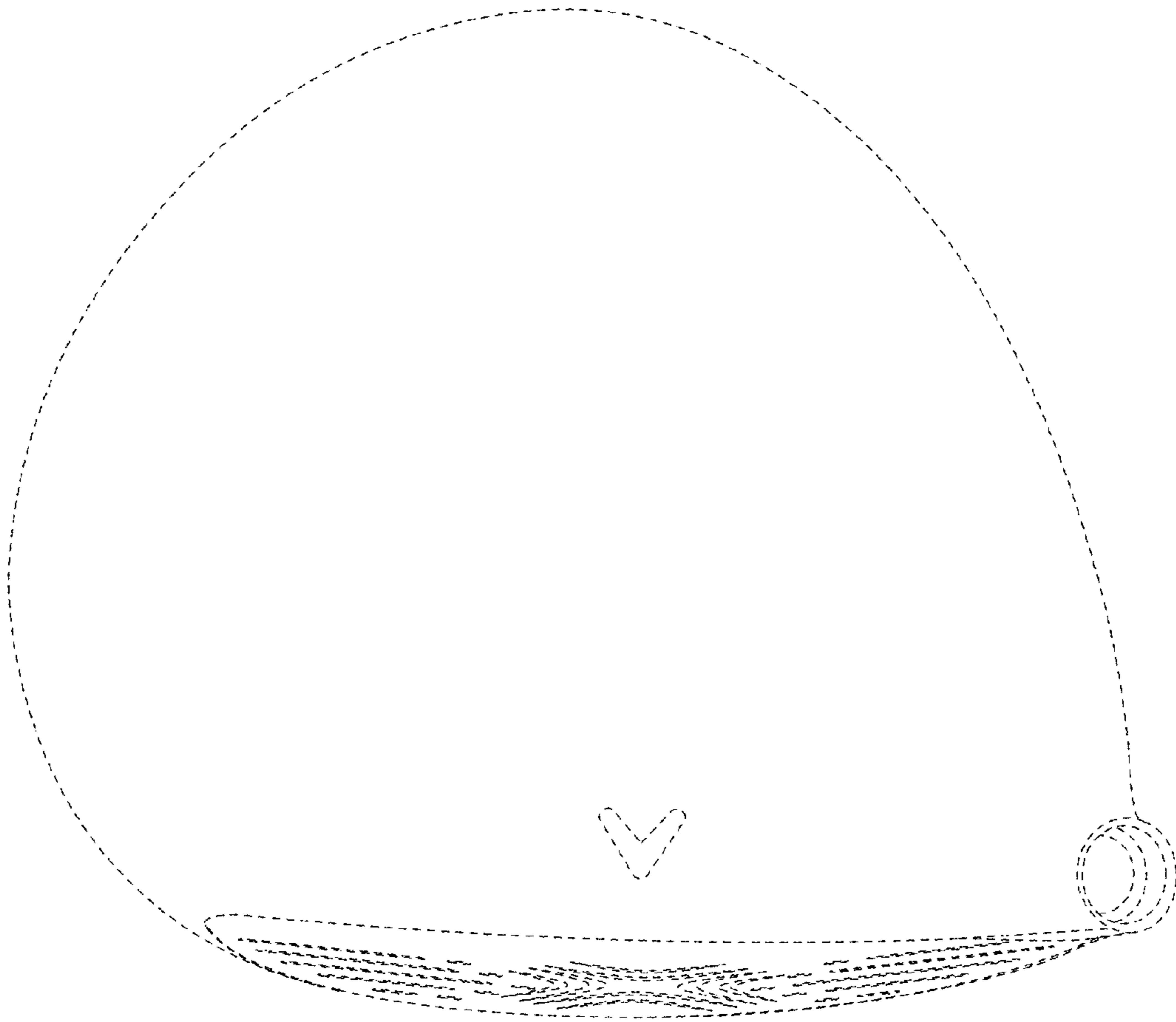

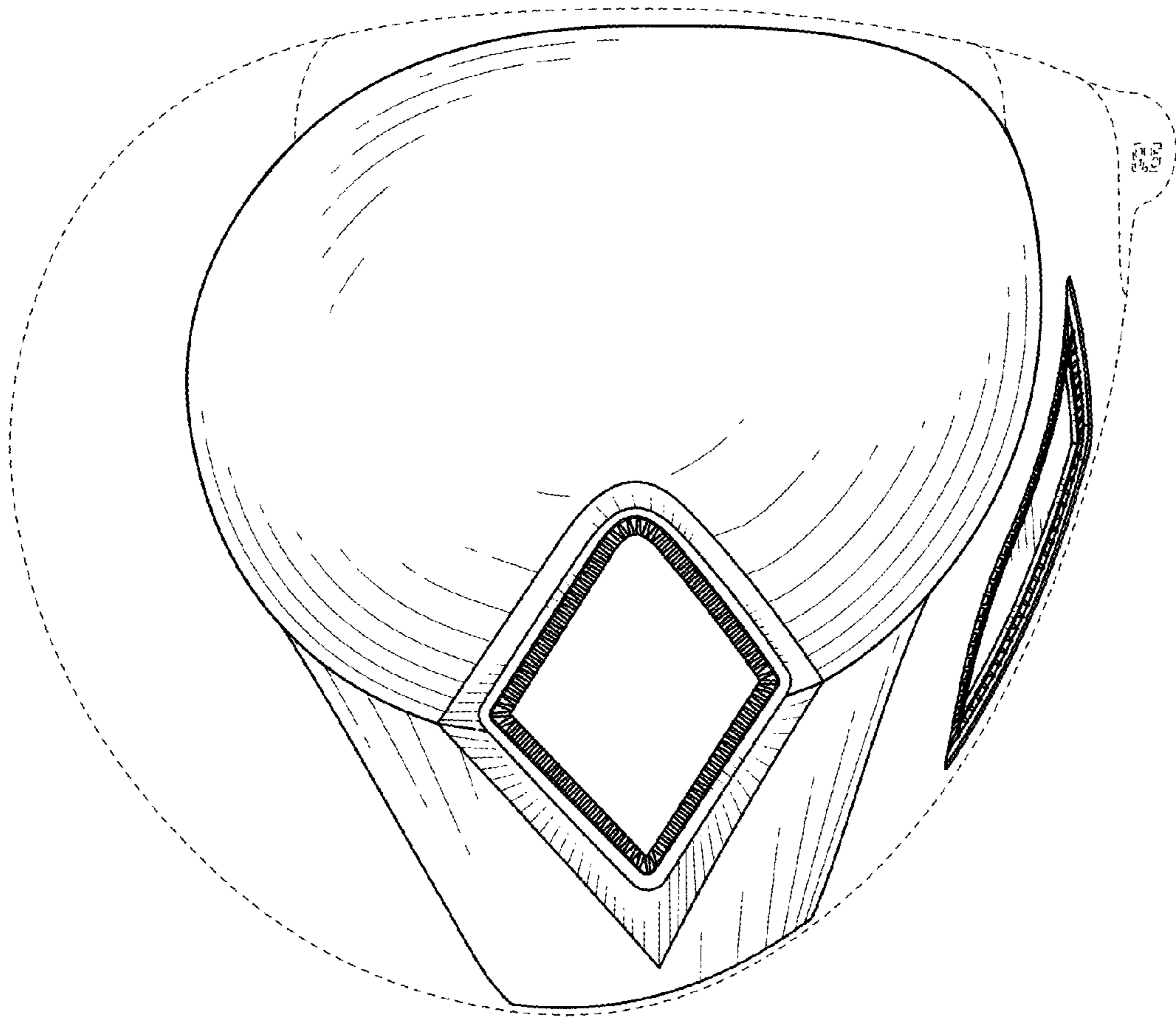
