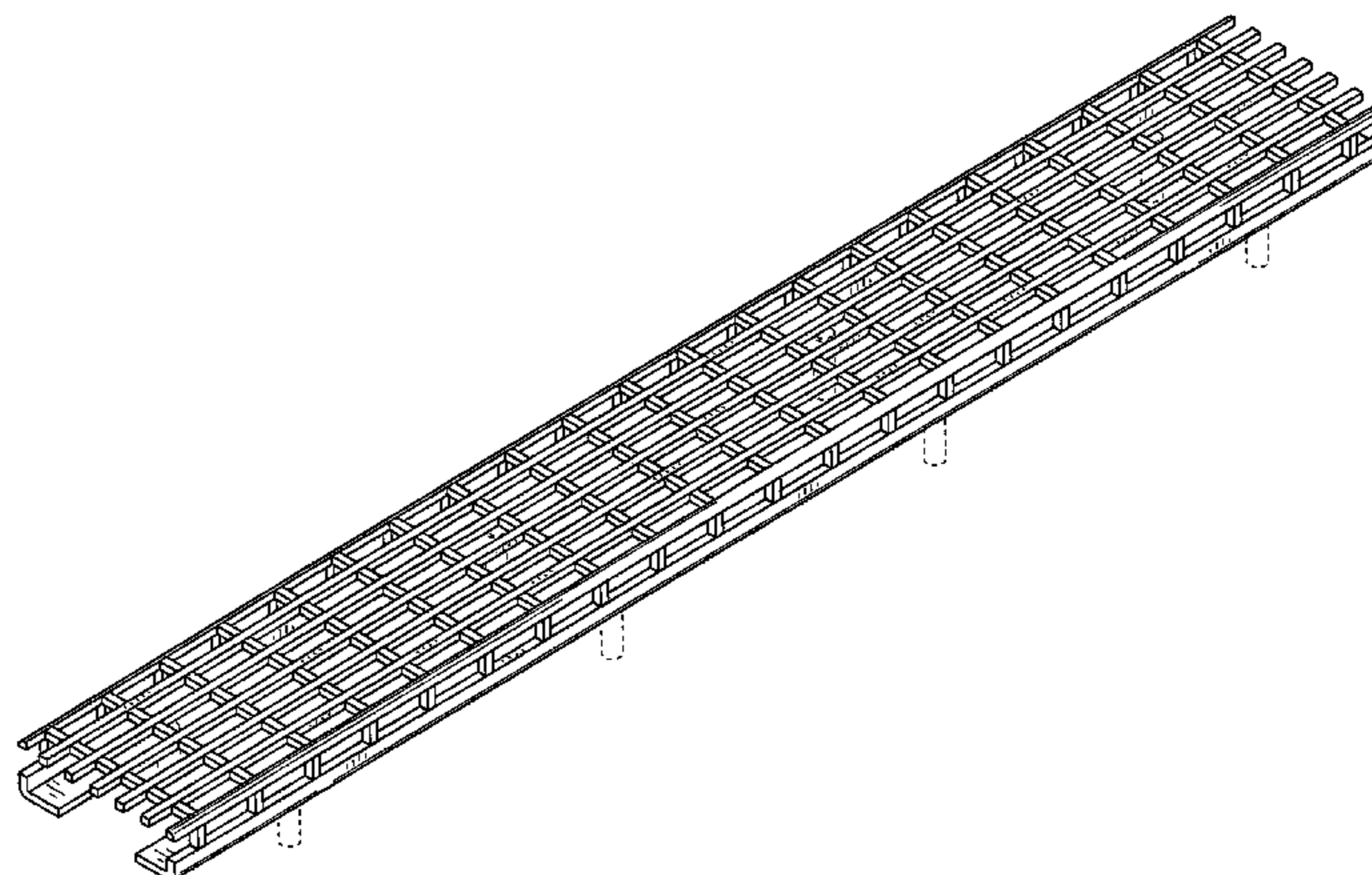
(57) **CLAIM**

What is claimed is an ornamental design for a grate for a channel drain, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an ornamental design for a grate for a channel drain;  
 FIG. 2 is a front view of the ornamental design for a grate for a channel drain shown in FIG. 1;  
 FIG. 3 is a back view of the ornamental design for a grate for a channel drain shown in FIG. 1;  
 FIG. 4 is a left view of the ornamental design for a grate for a channel drain shown in FIG. 1;  
 FIG. 5 is a right view of the ornamental design for a grate for a channel drain shown in FIG. 1;  
 FIG. 6 is a top view of the ornamental design for a grate for a channel drain shown in FIG. 1; and,  
 FIG. 7 is a bottom view of the ornamental design for a grate for a channel drain shown in FIG. 1.

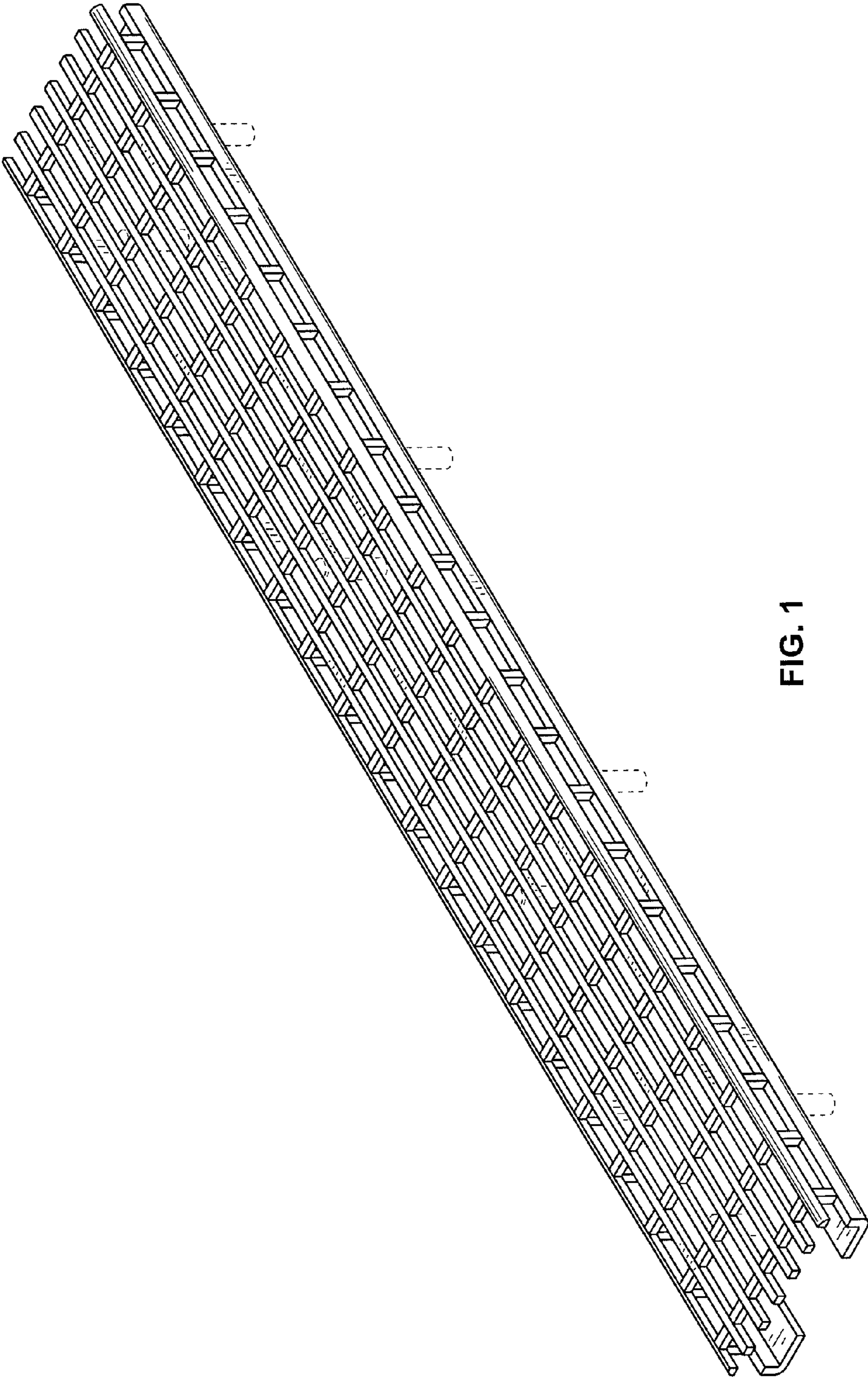

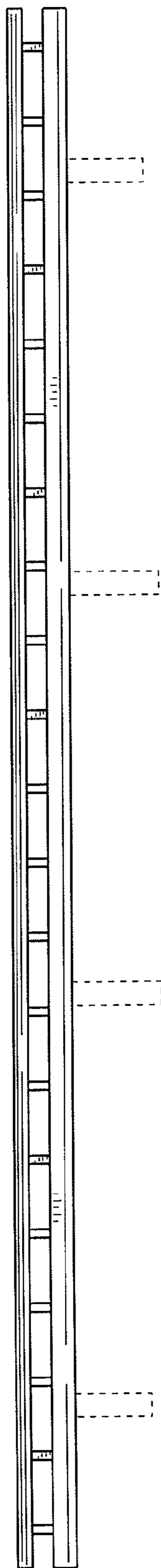

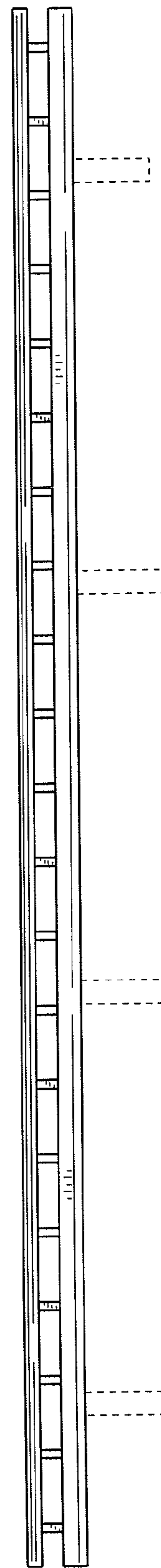

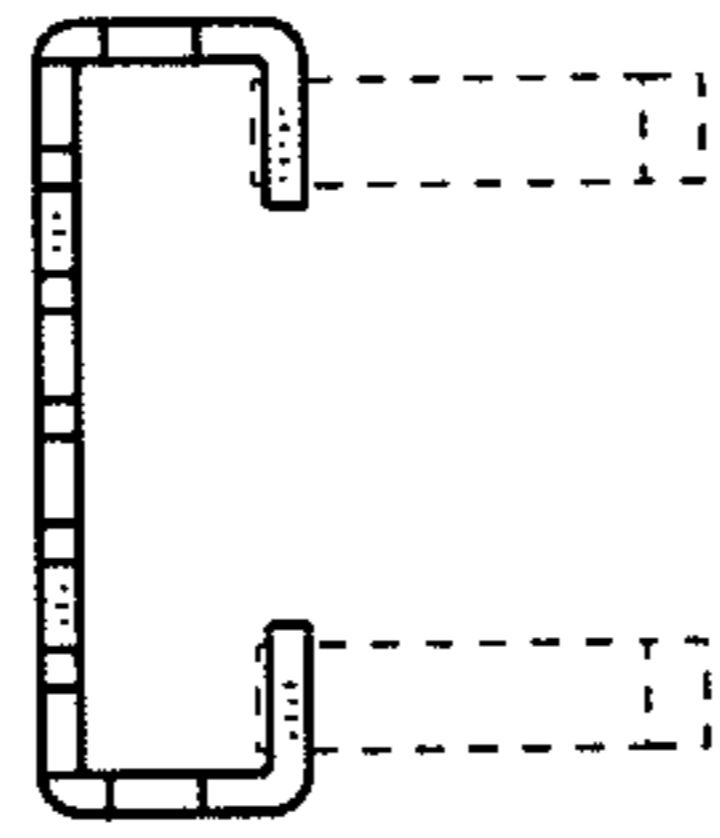

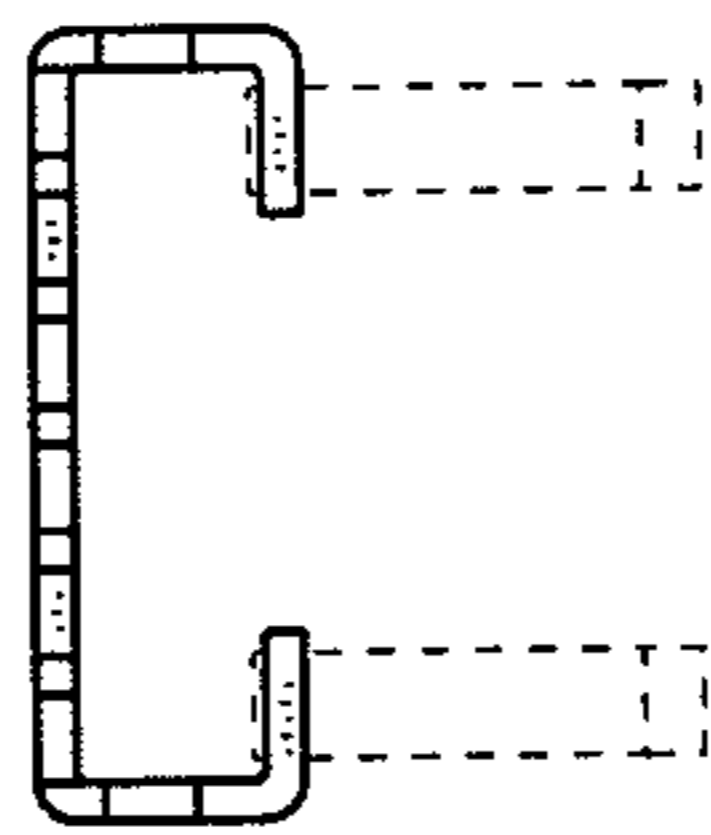

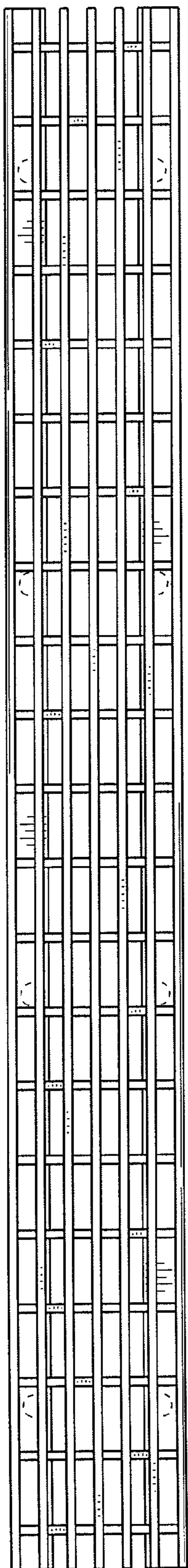

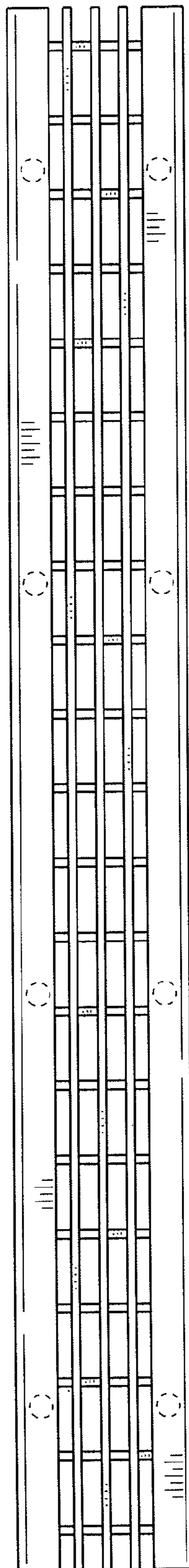
