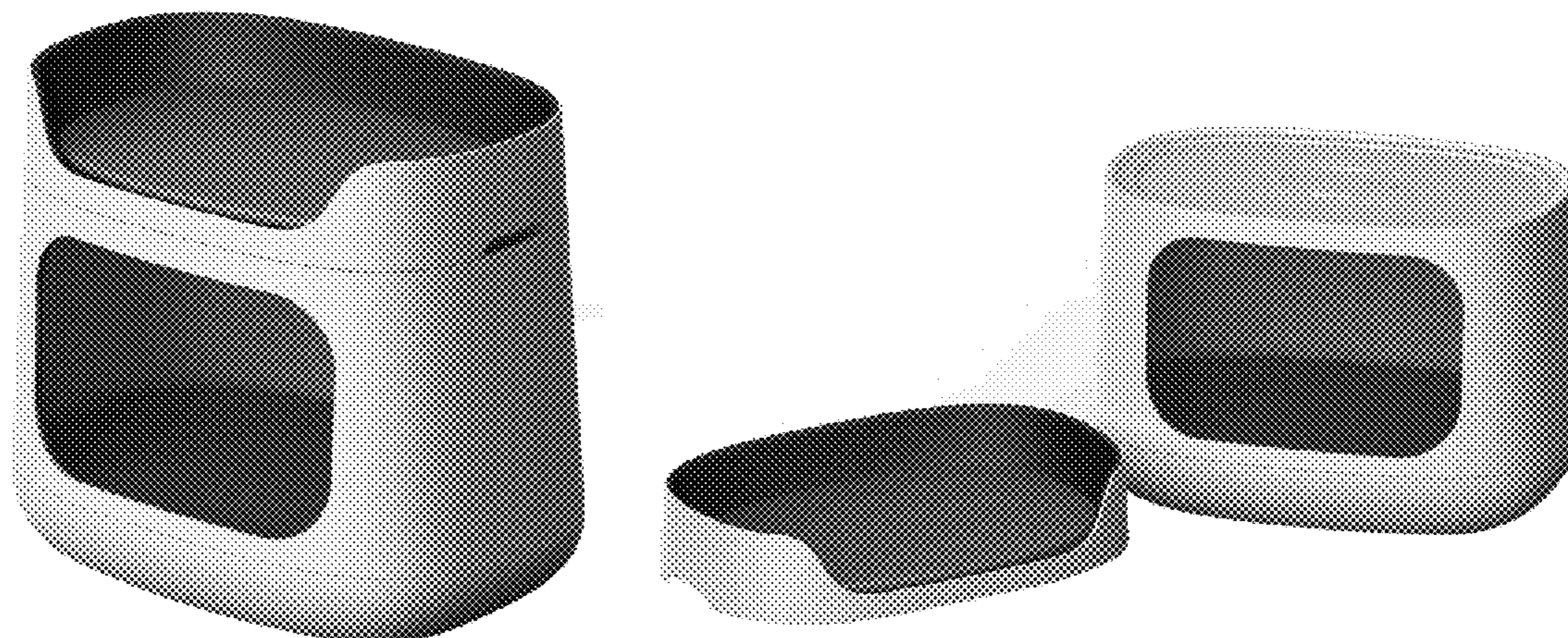
(57) **CLAIM**

The ornamental design for a bunk bed, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a bunk bed at an assembled position,

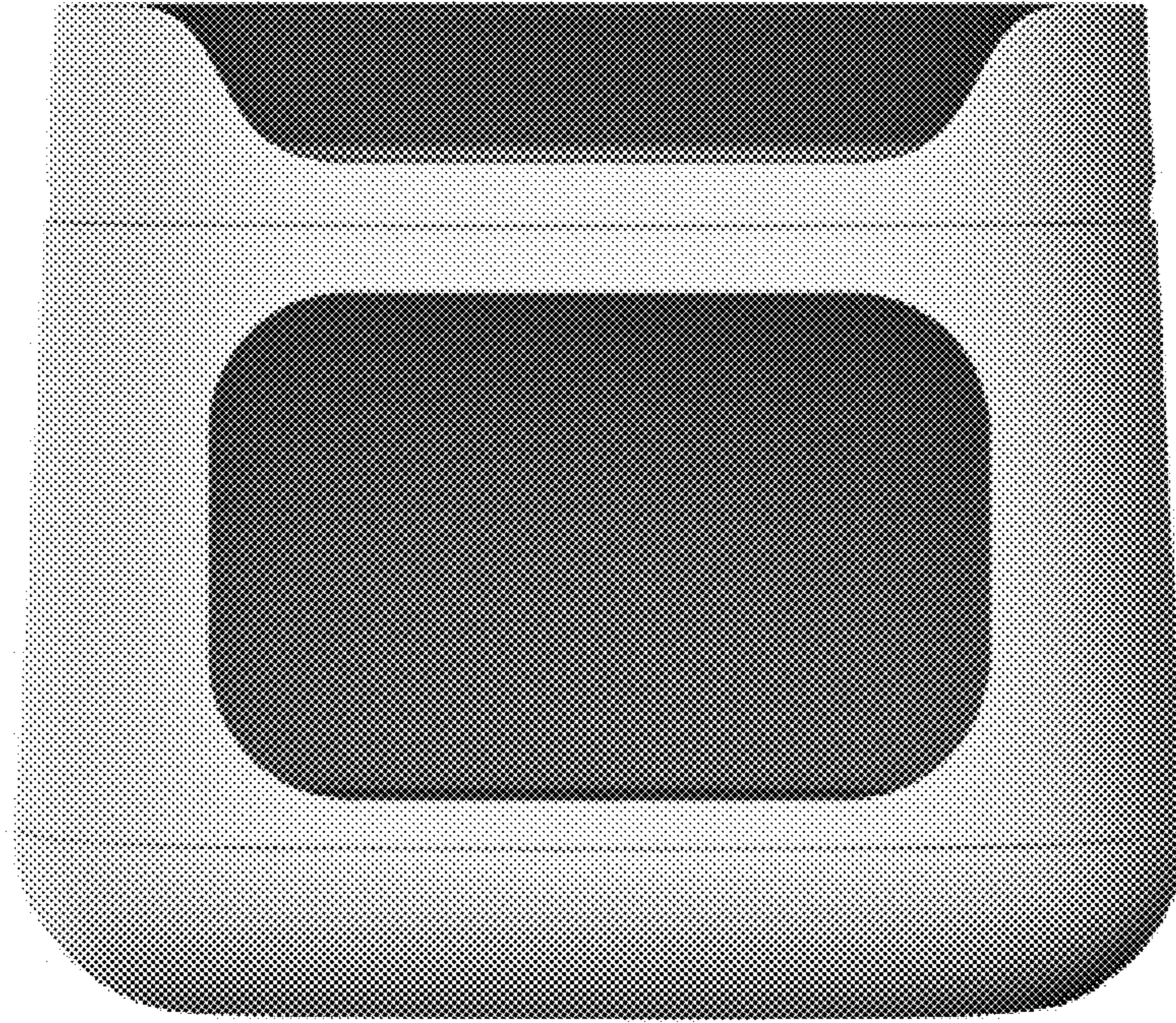

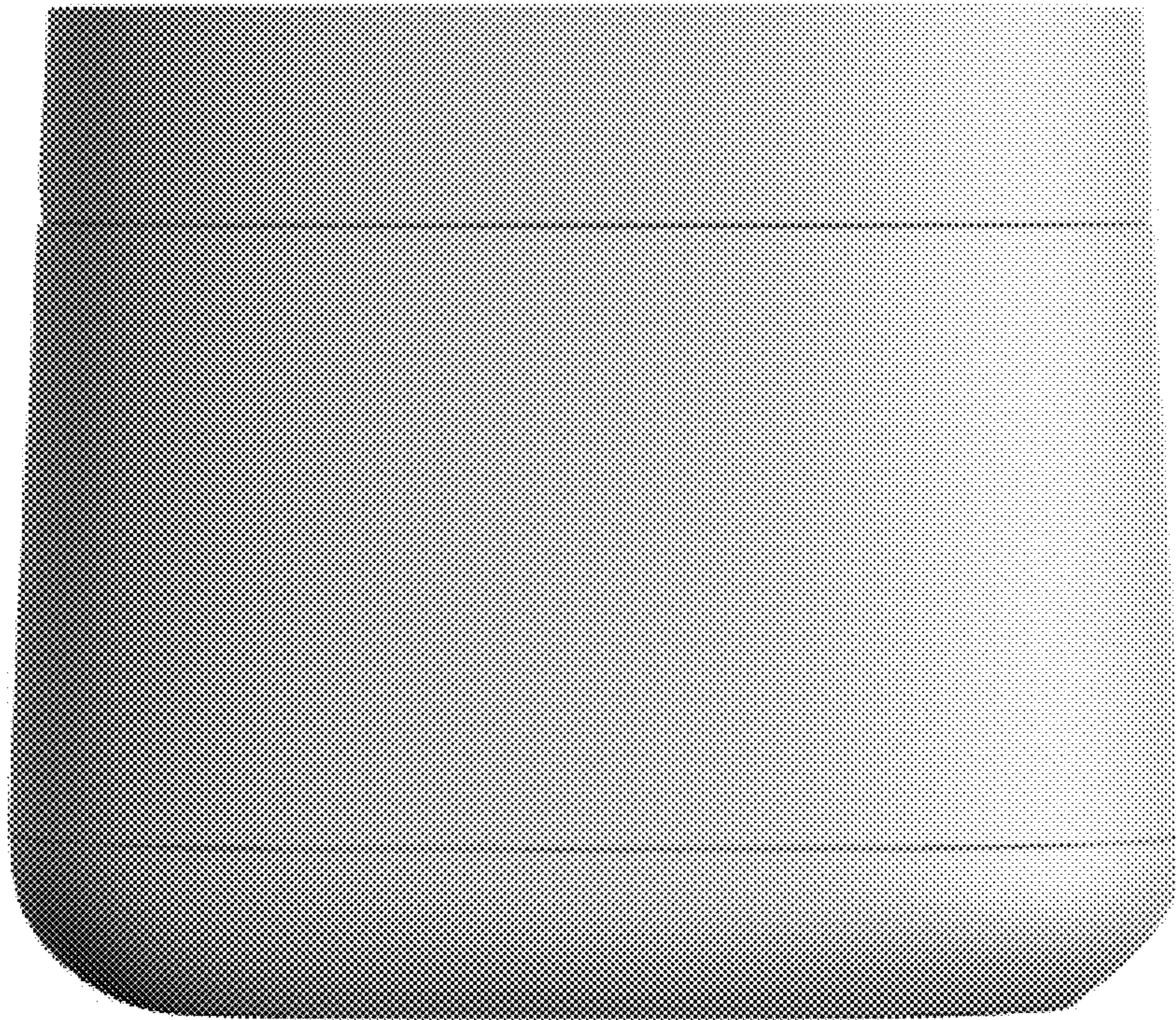

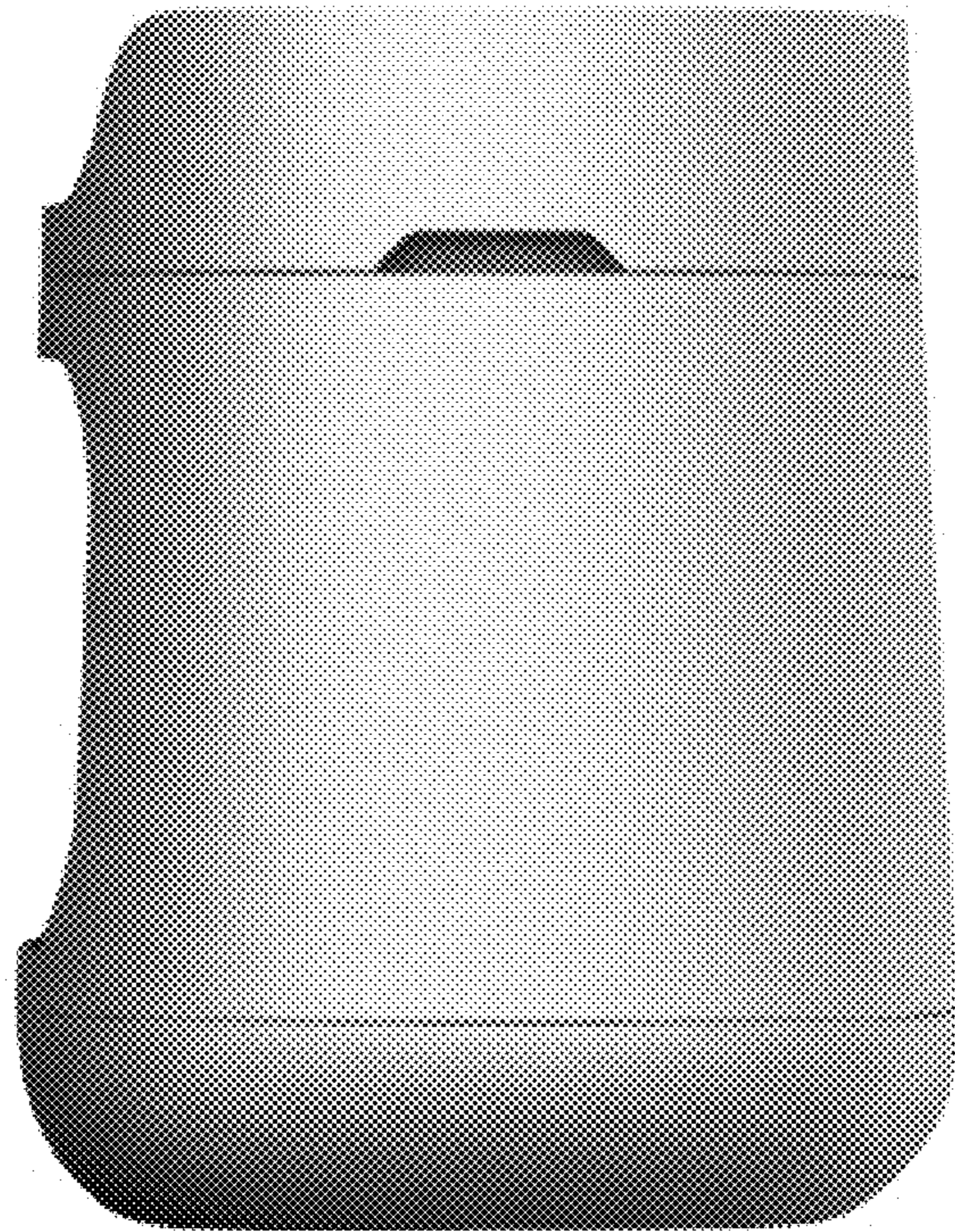

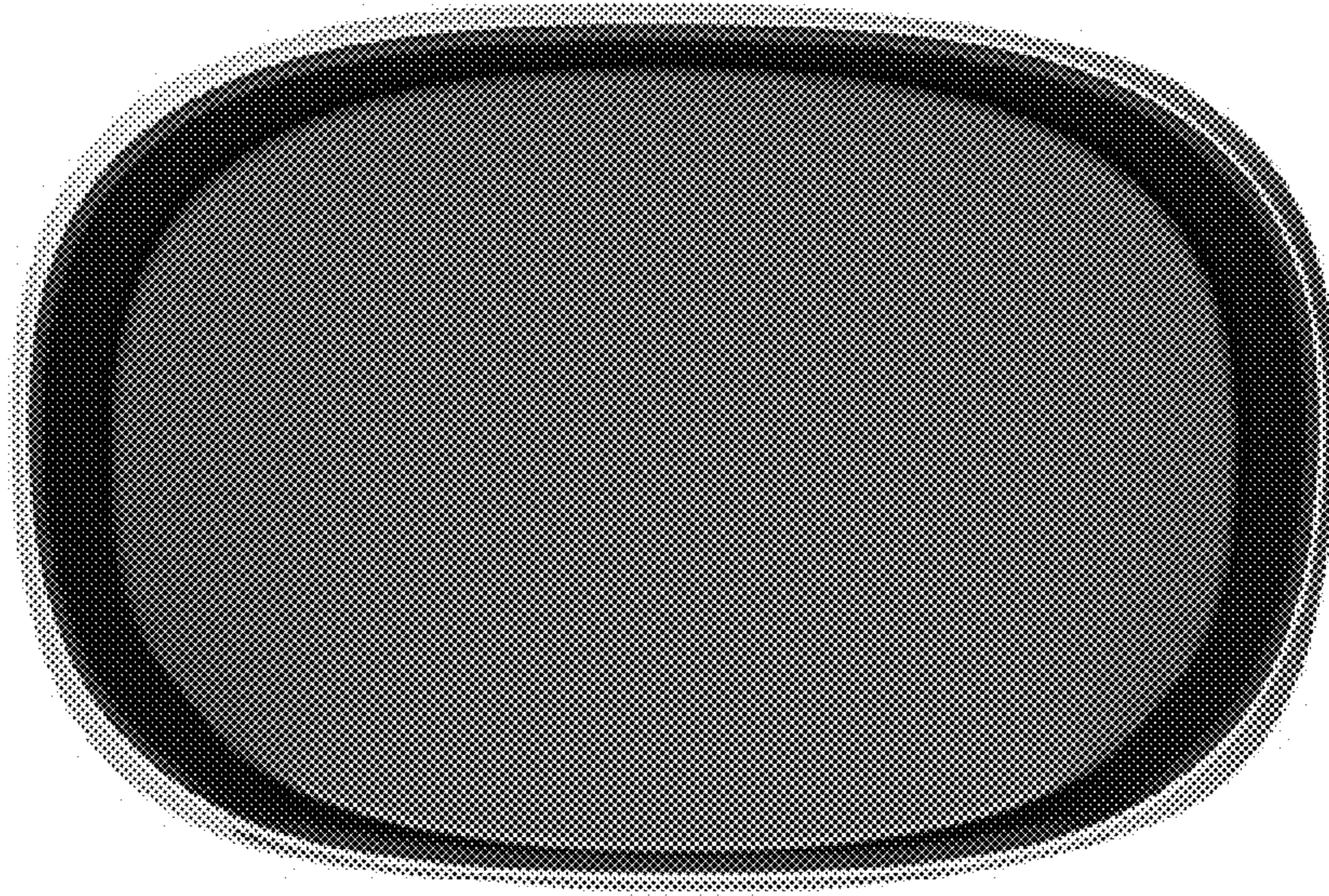

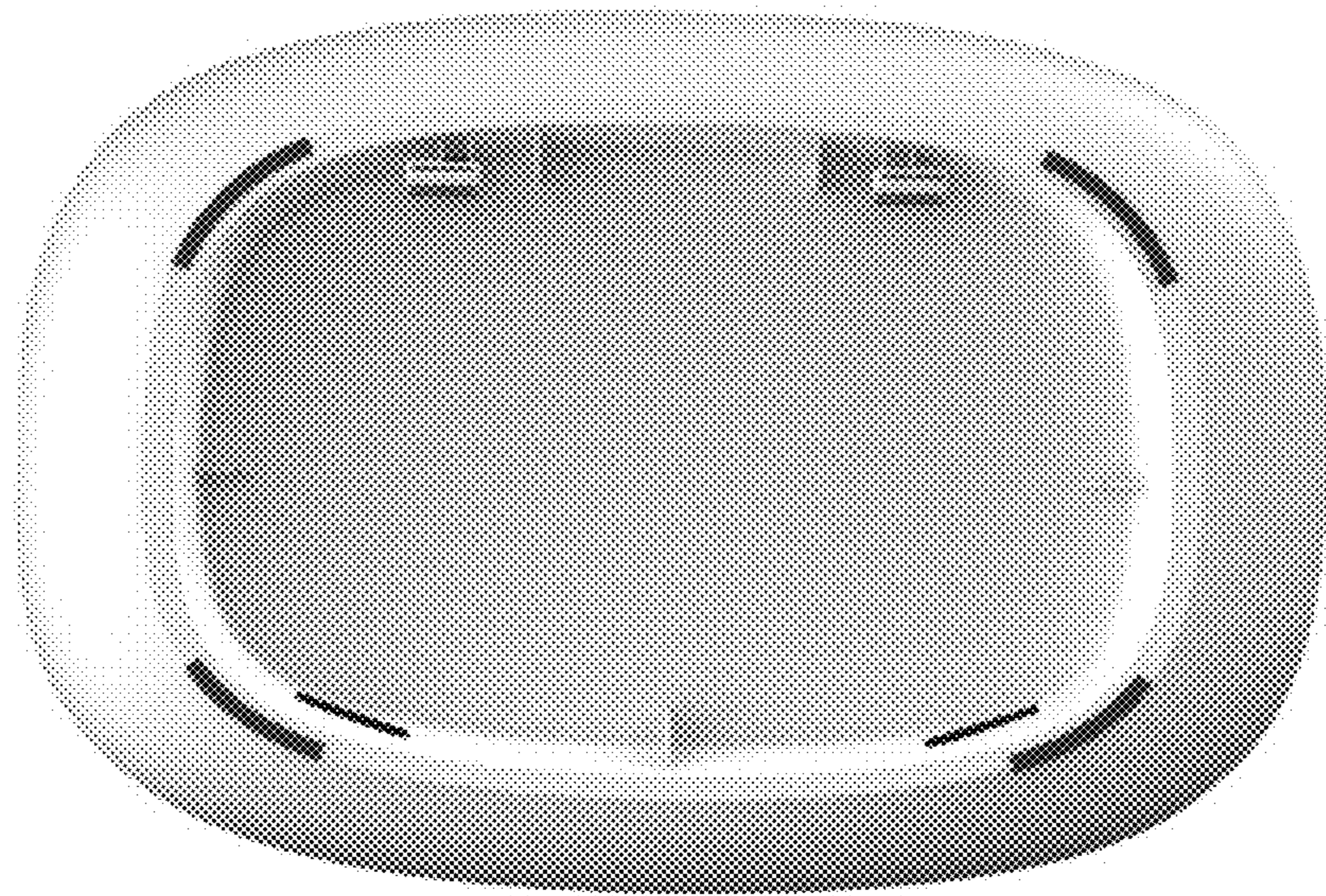

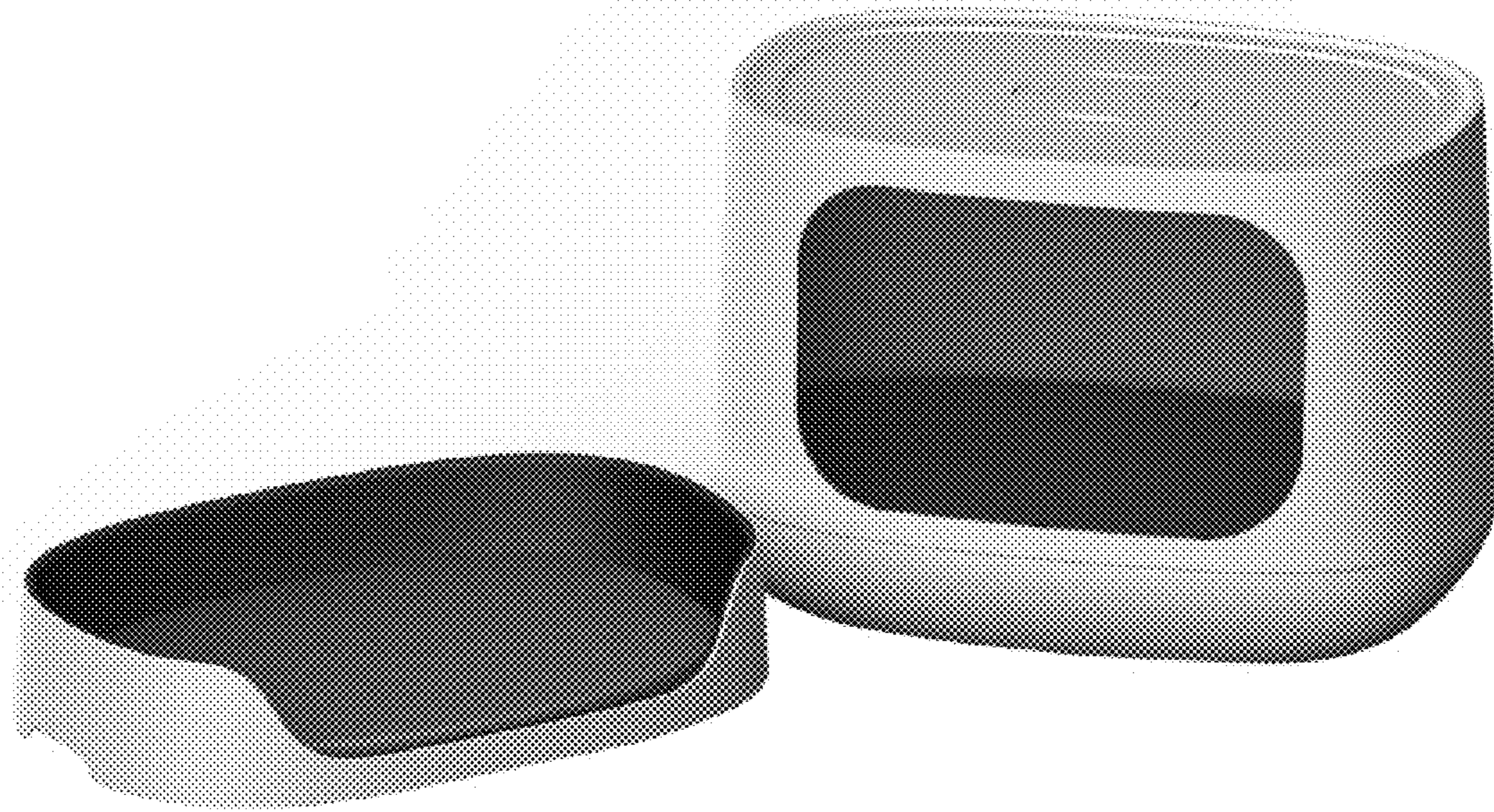

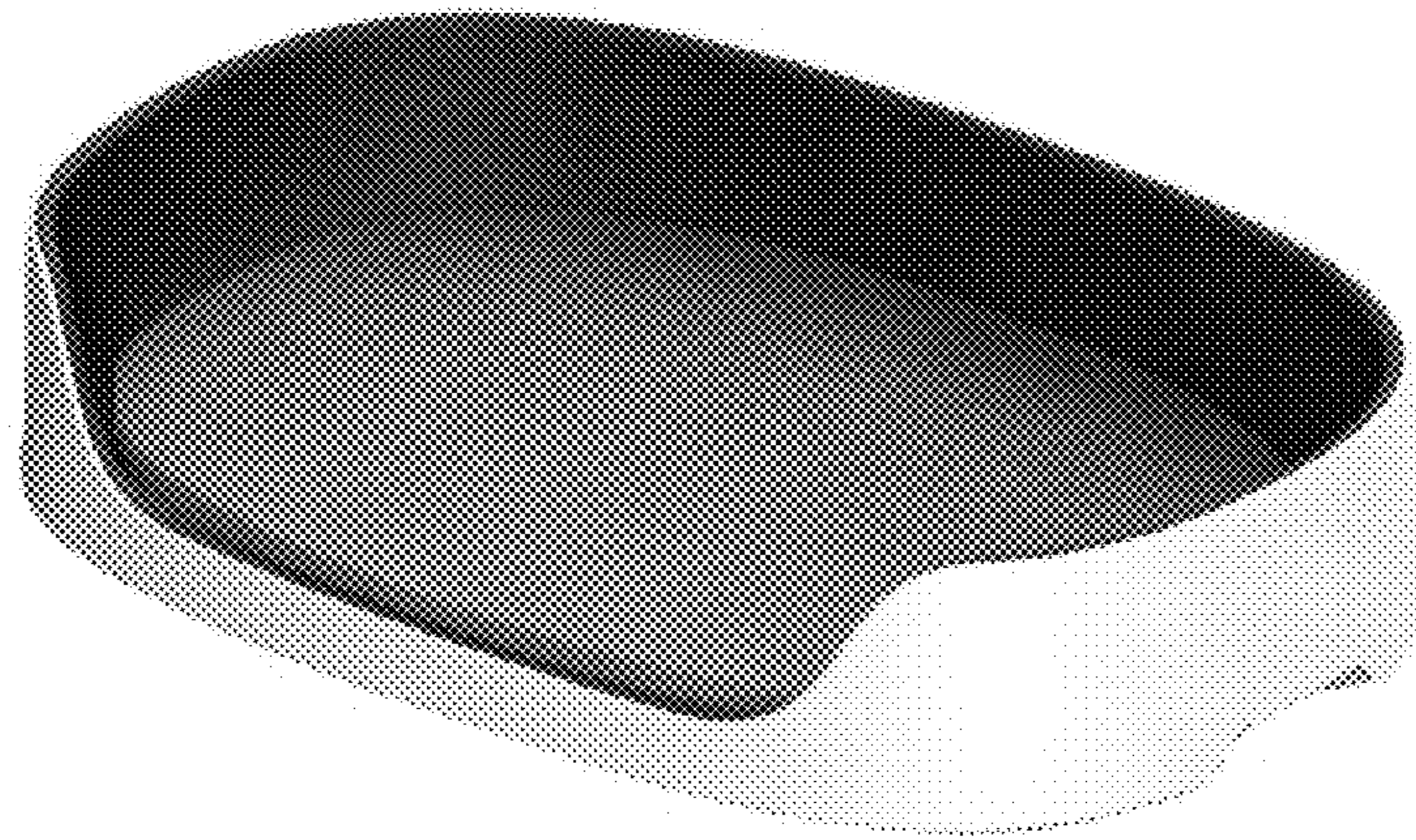

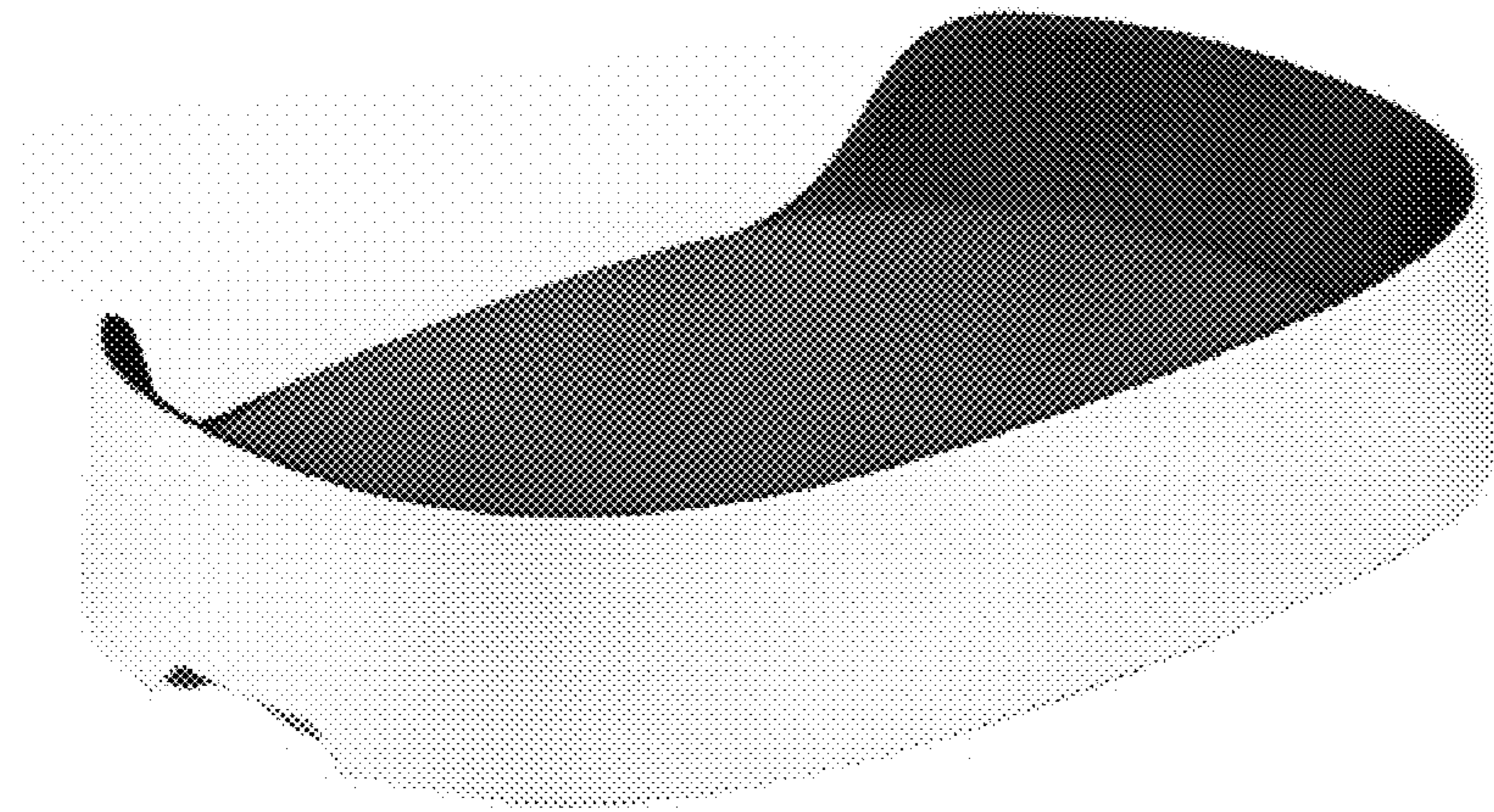

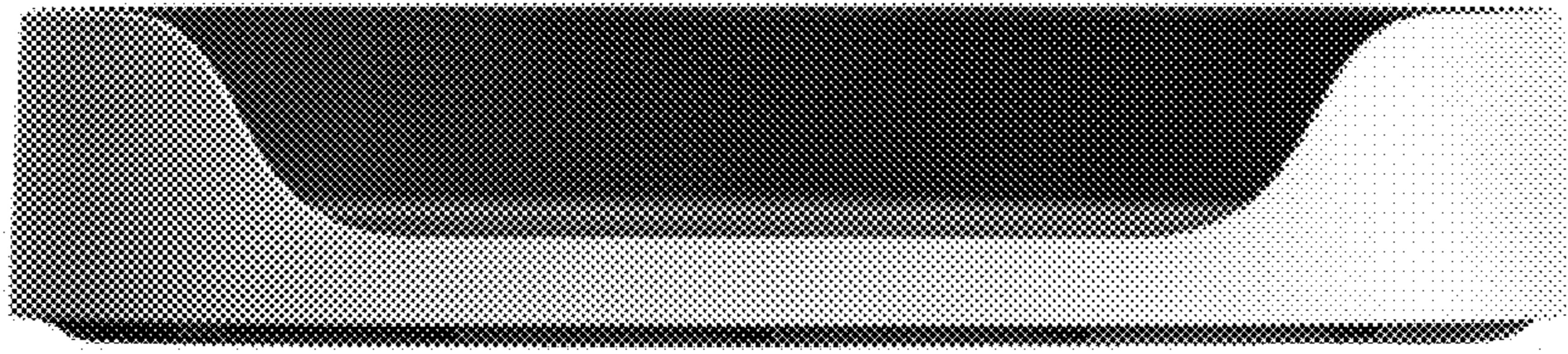
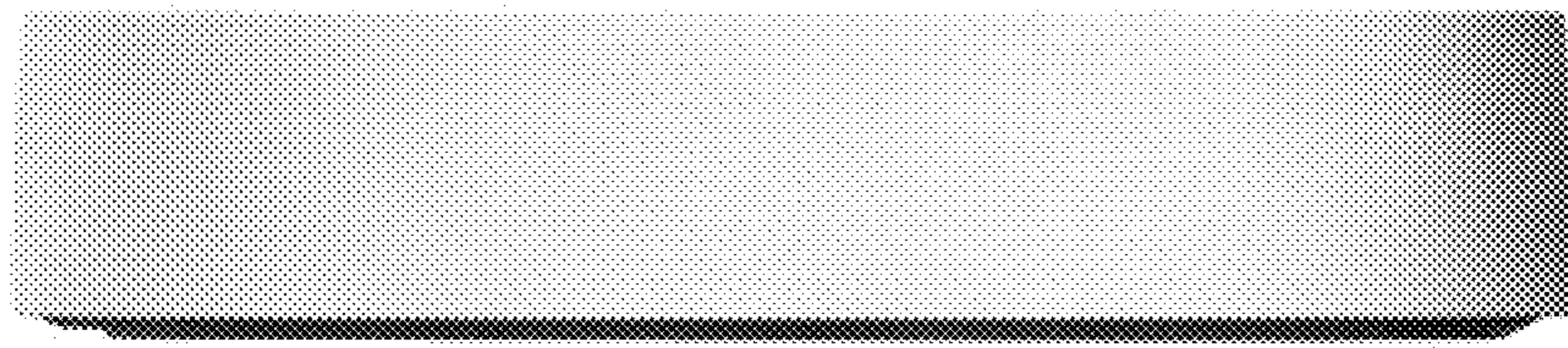

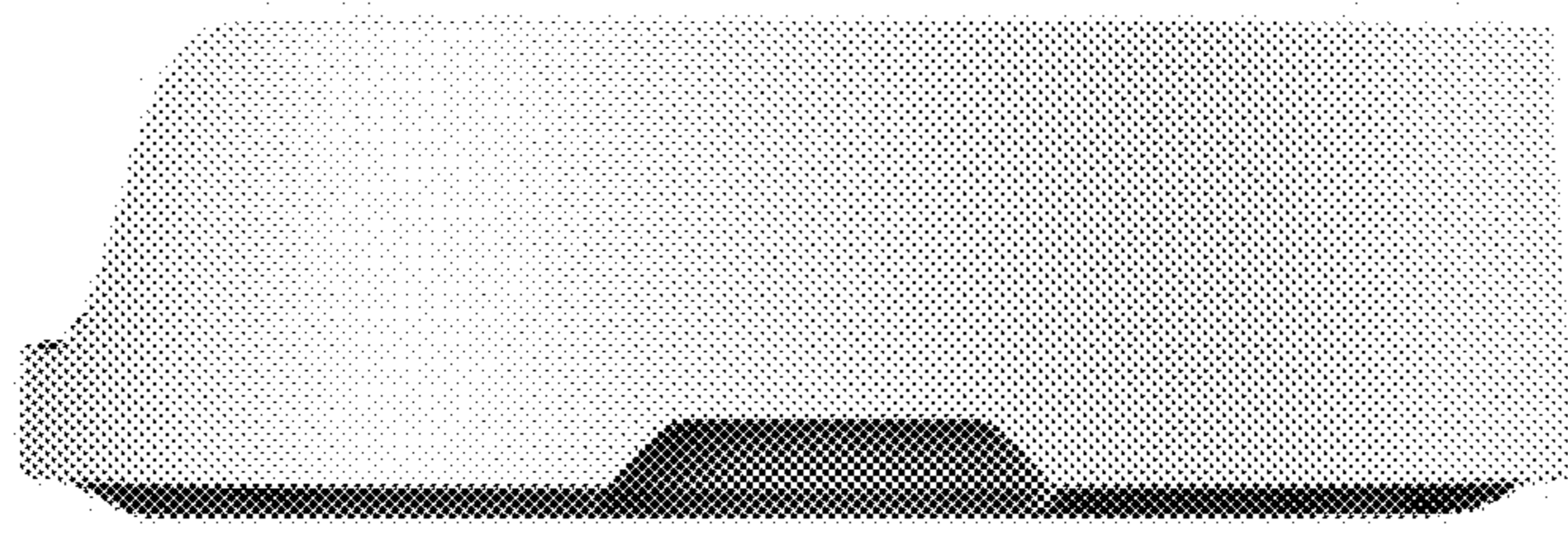
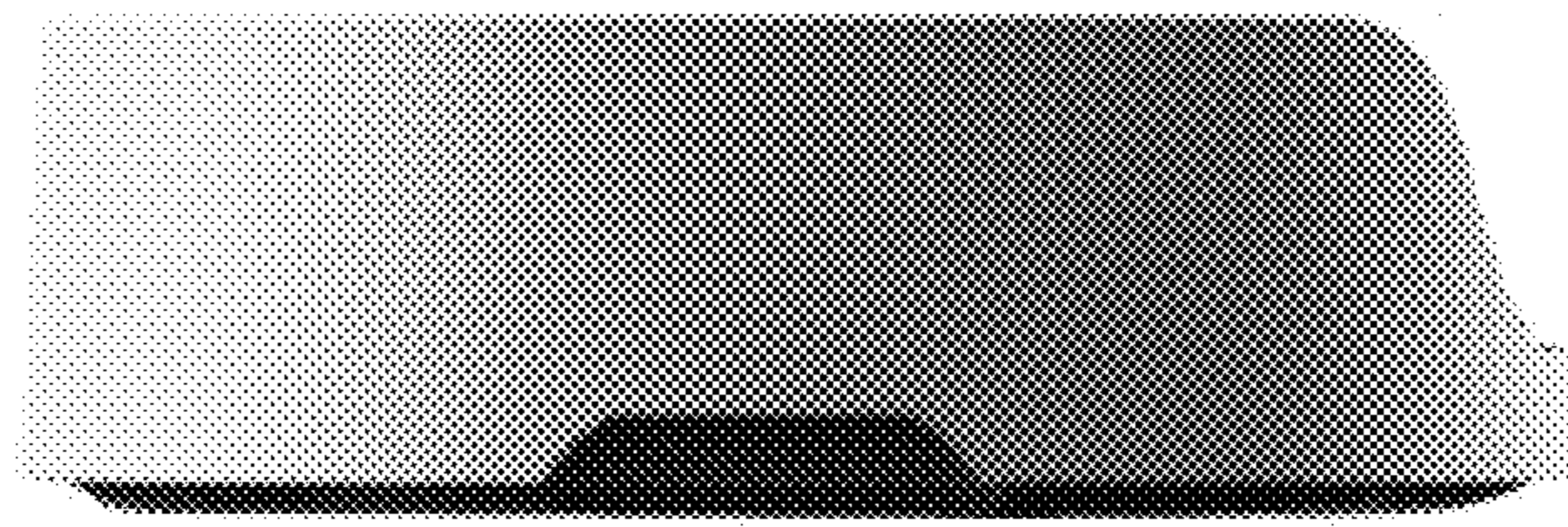

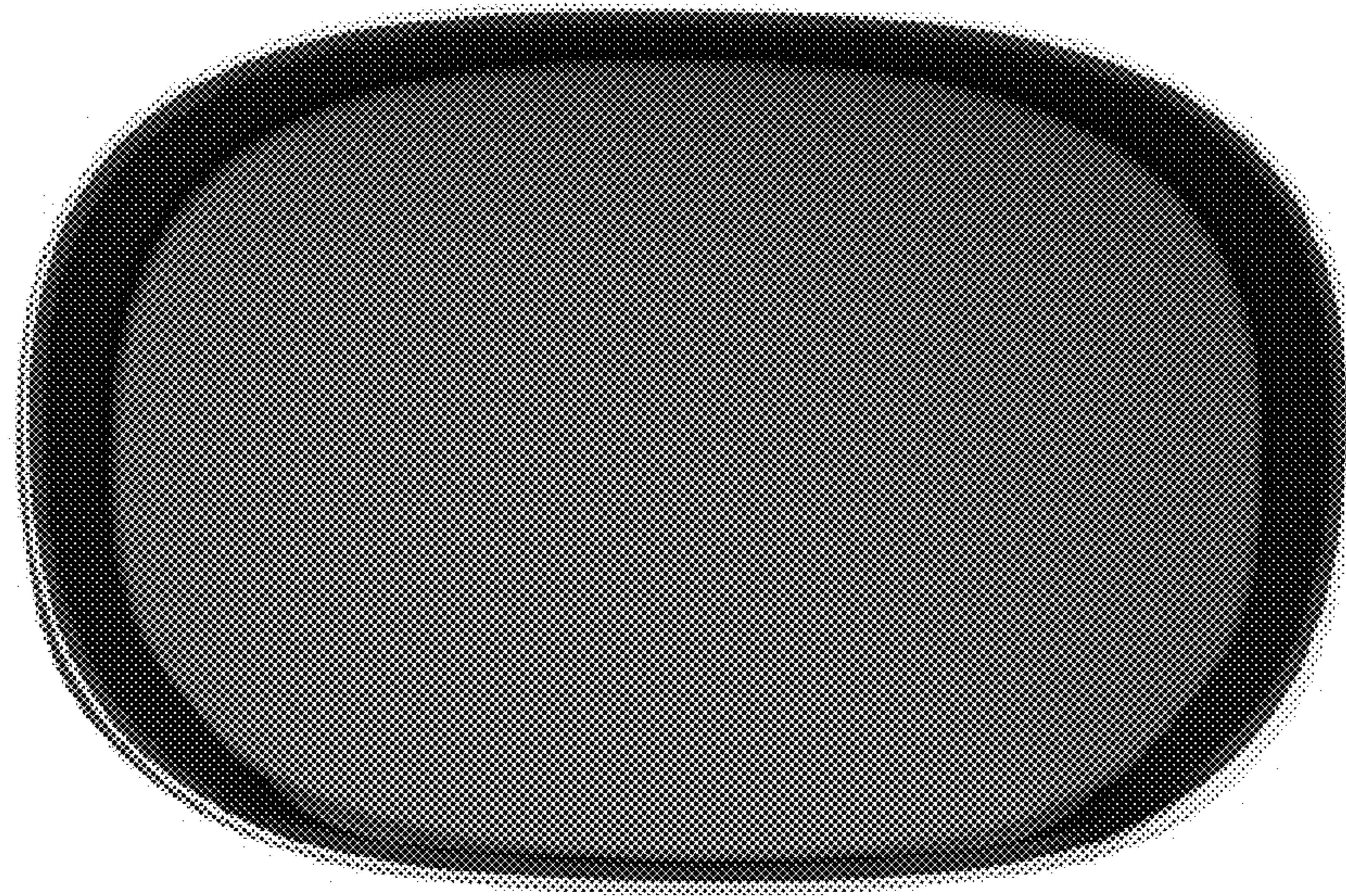

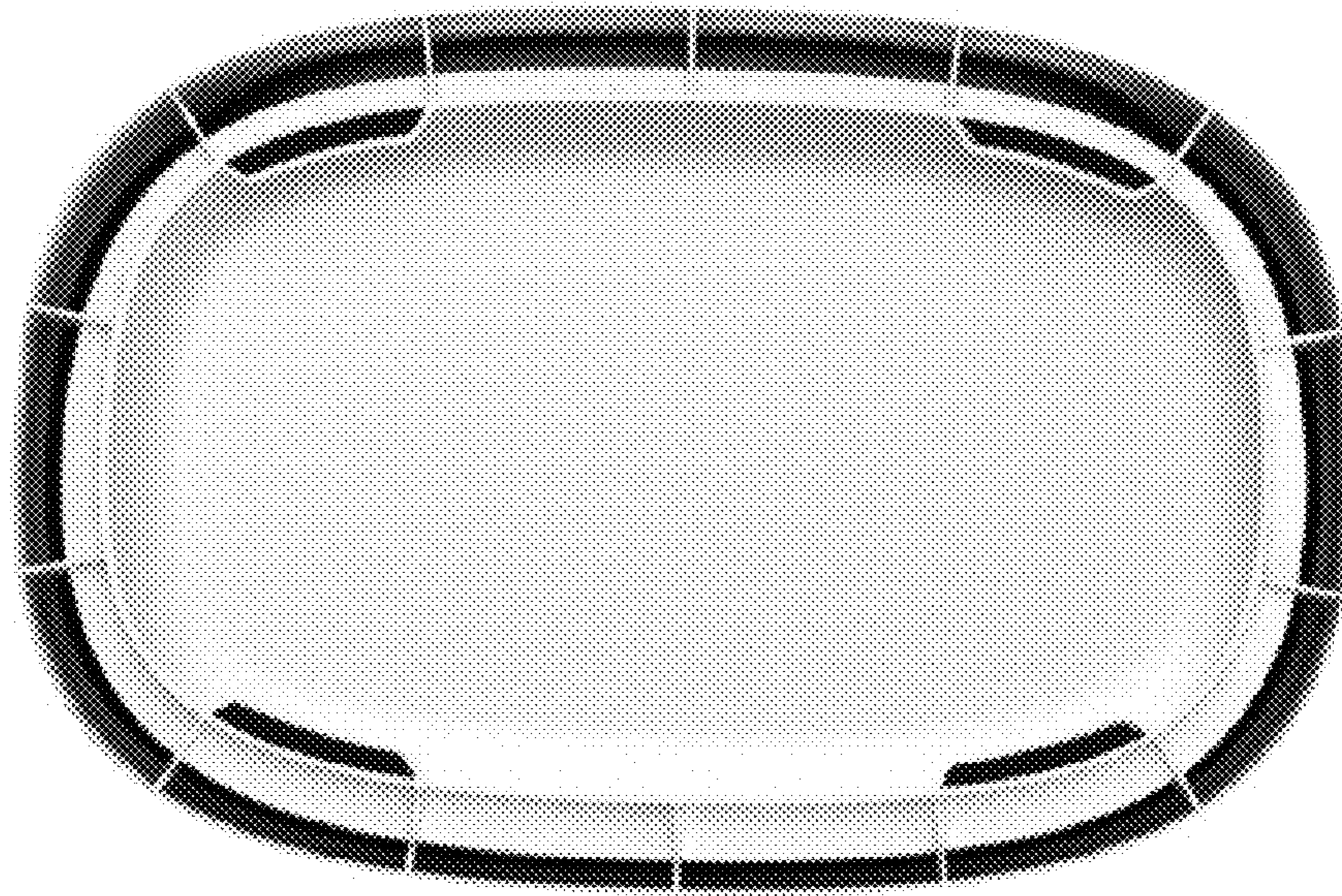

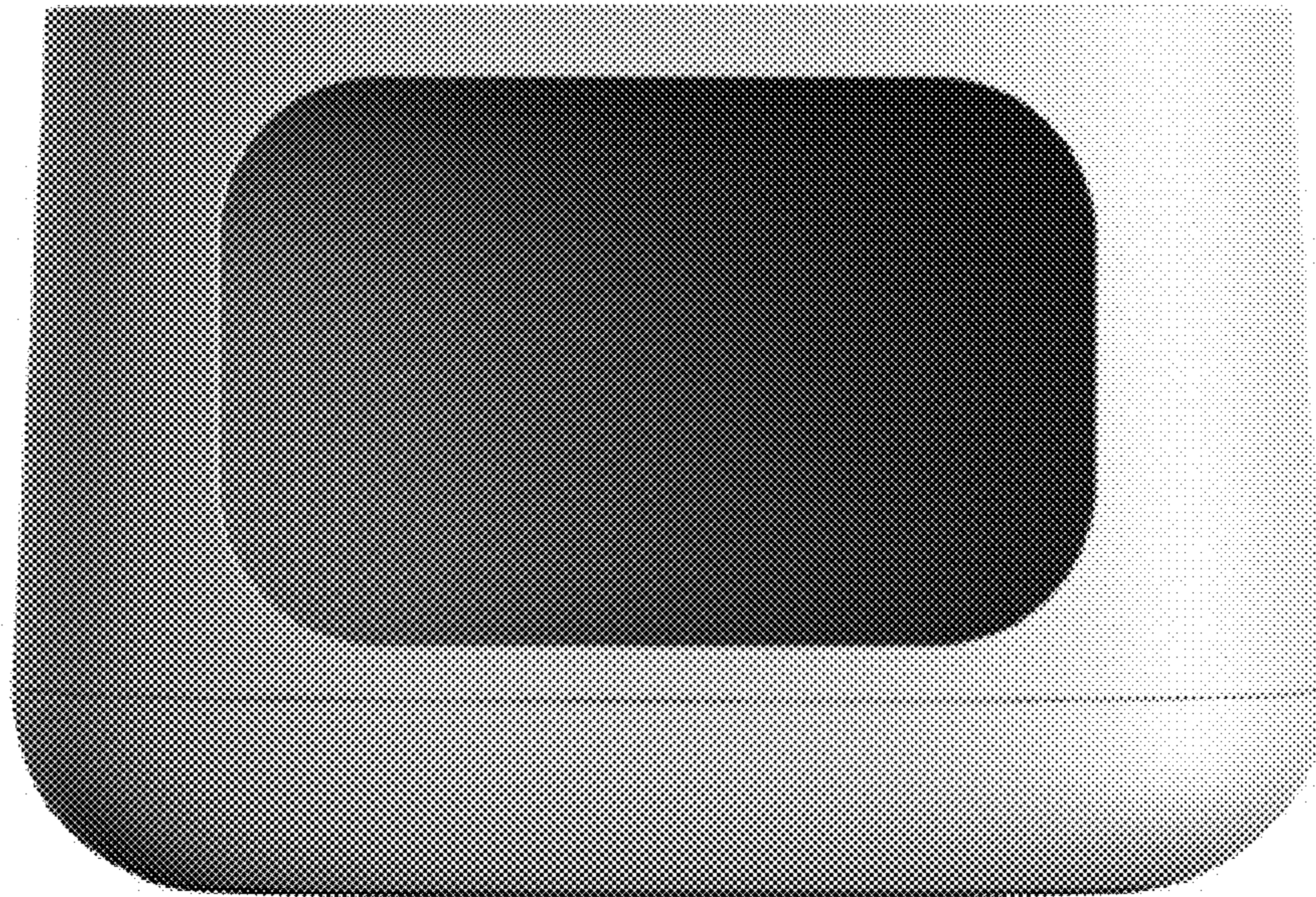

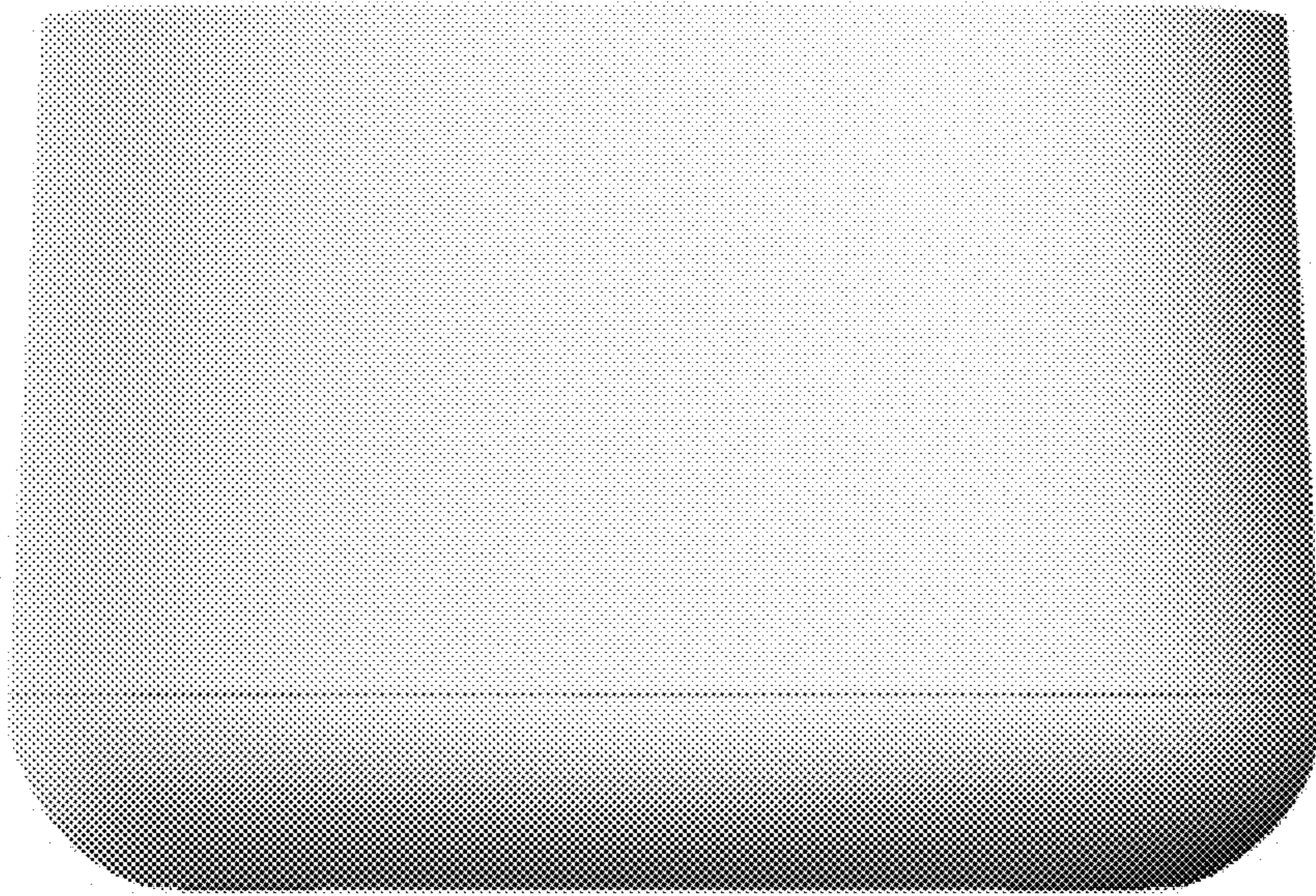

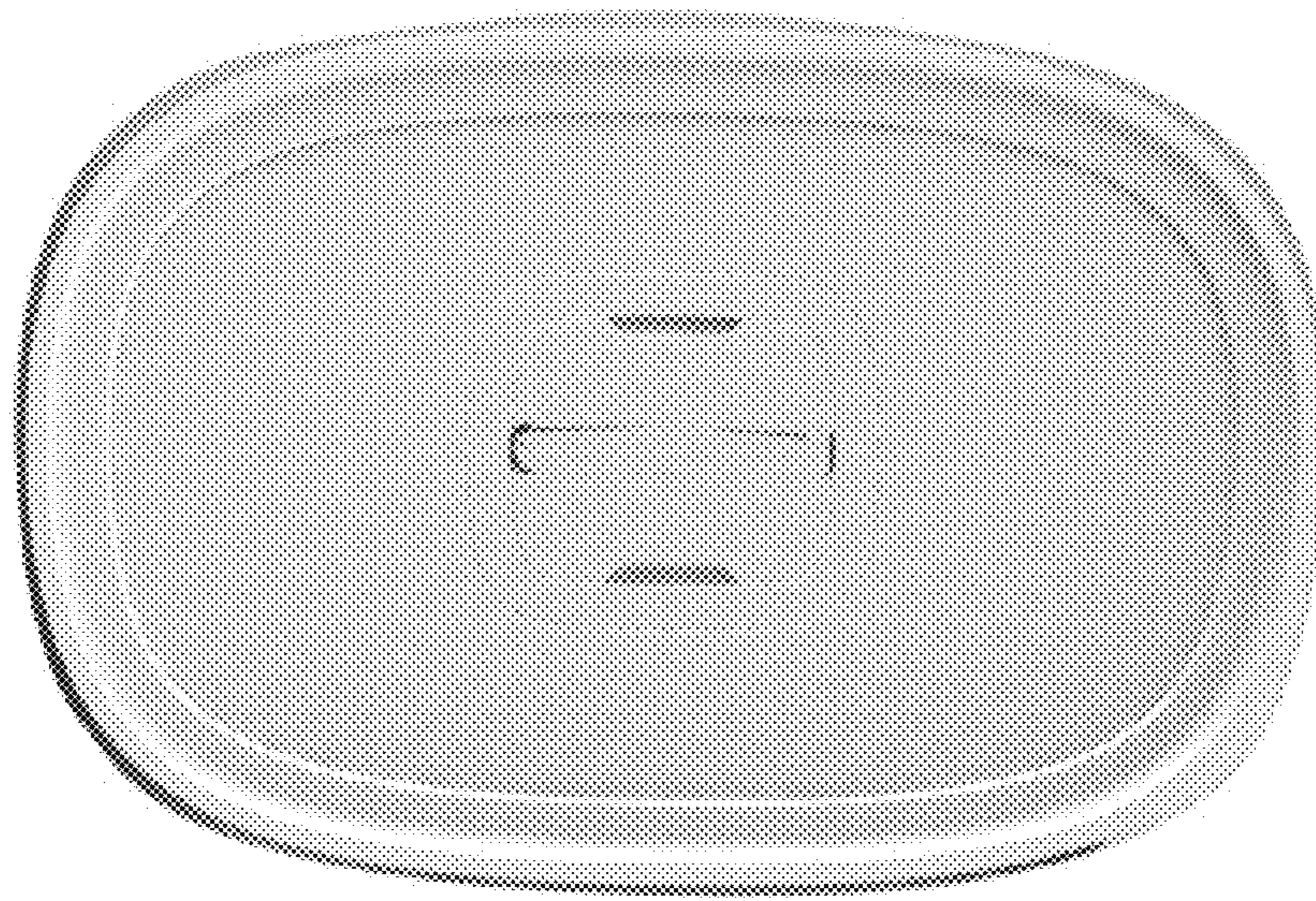
