The ornamental design for mesh sponge container, as shown and described.

DESCRIPTION

FIG. 1 is a left elevational view thereof;
FIG. 2 is similar to the previous figure except with the mesh sponge exposed;
FIG. 3 is a right elevational view thereof;
FIG. 4 is similar to the previous figure except with the mesh sponge exposed;
FIG. 5 is a front side elevational view thereof;

FIG. 7 is a rear side elevational view thereof;
FIG. 8 is similar to the previous figure except with the mesh sponge exposed;
FIG. 9 is a top elevational view thereof; and
FIG. 10 is similar to the previous figure except with the mesh sponge exposed;
FIG. 11 is a bottom elevational view thereof; and,
FIG. 12 is similar to the previous figure except with the mesh sponge exposed.

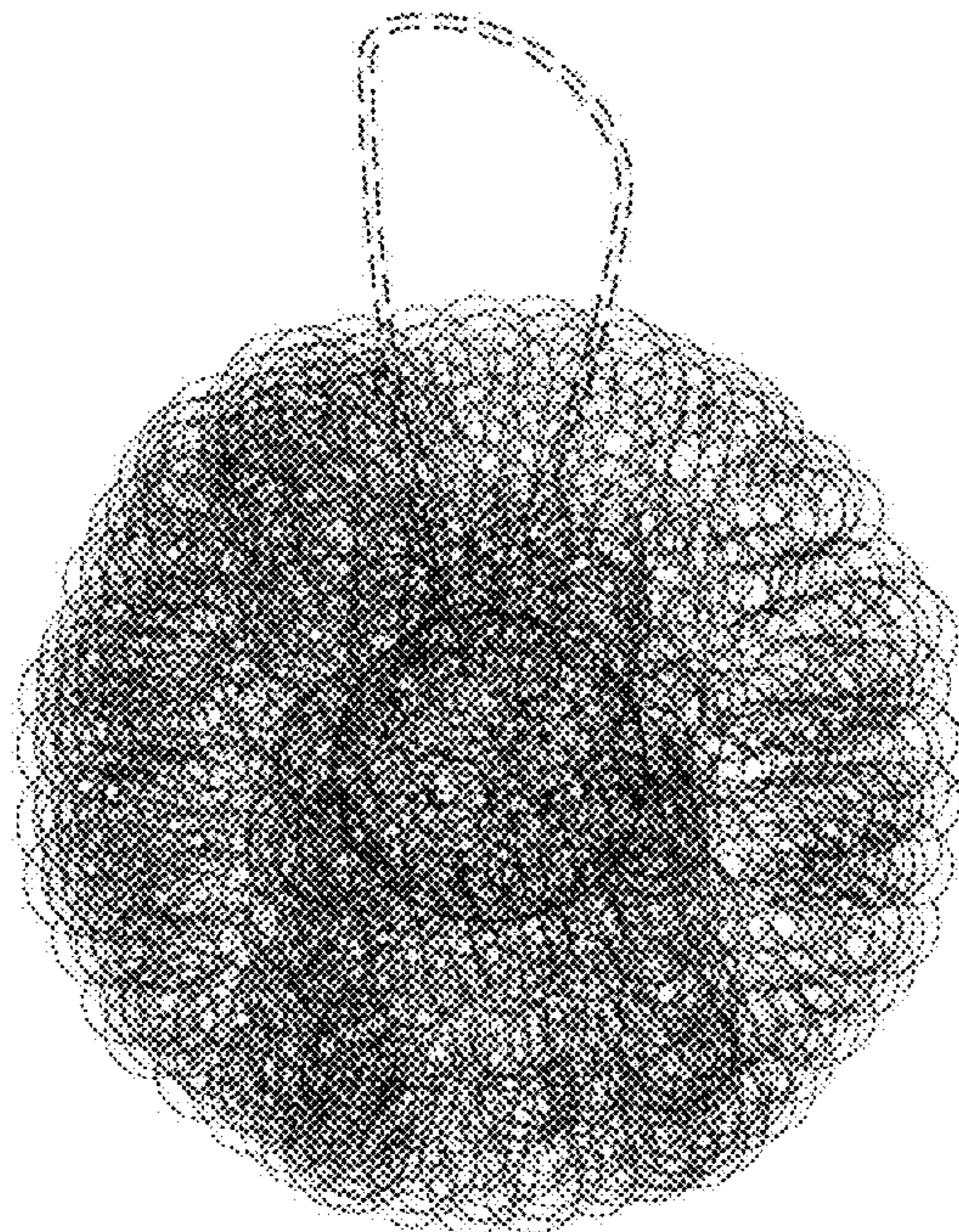

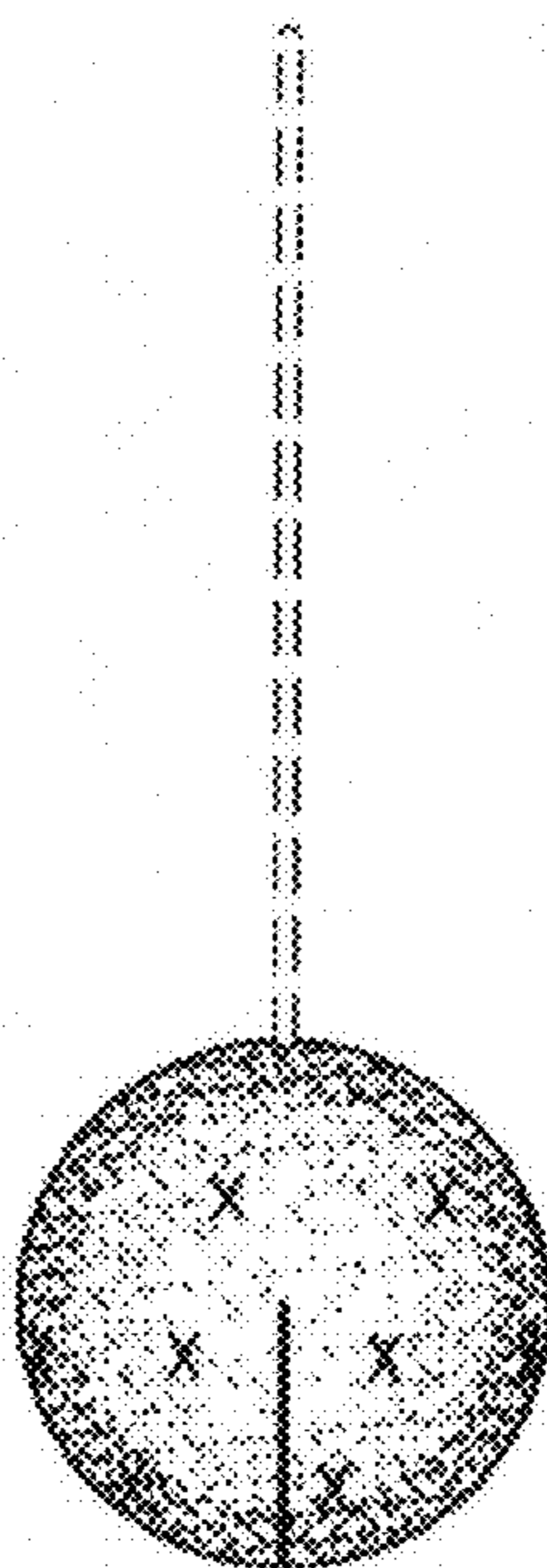

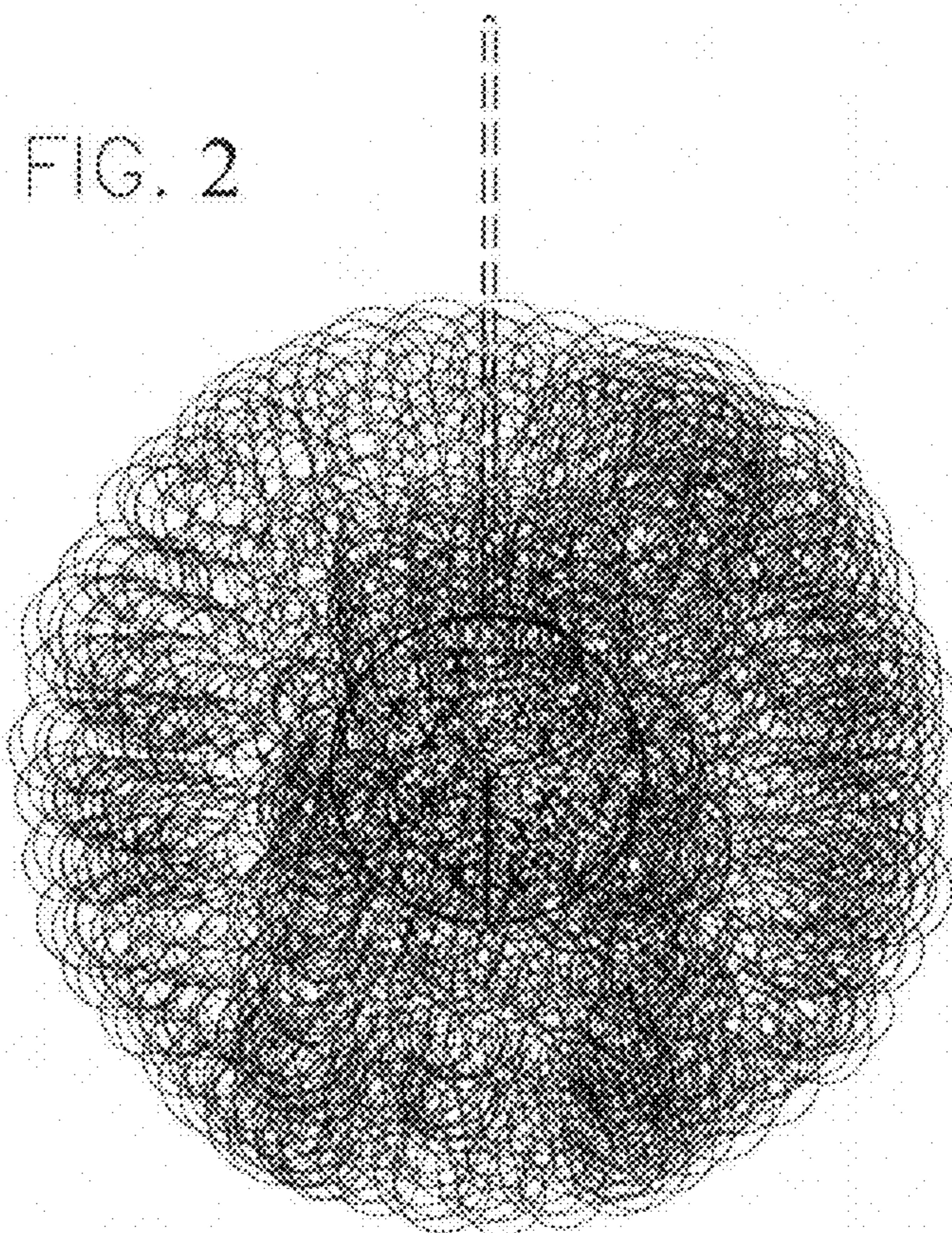

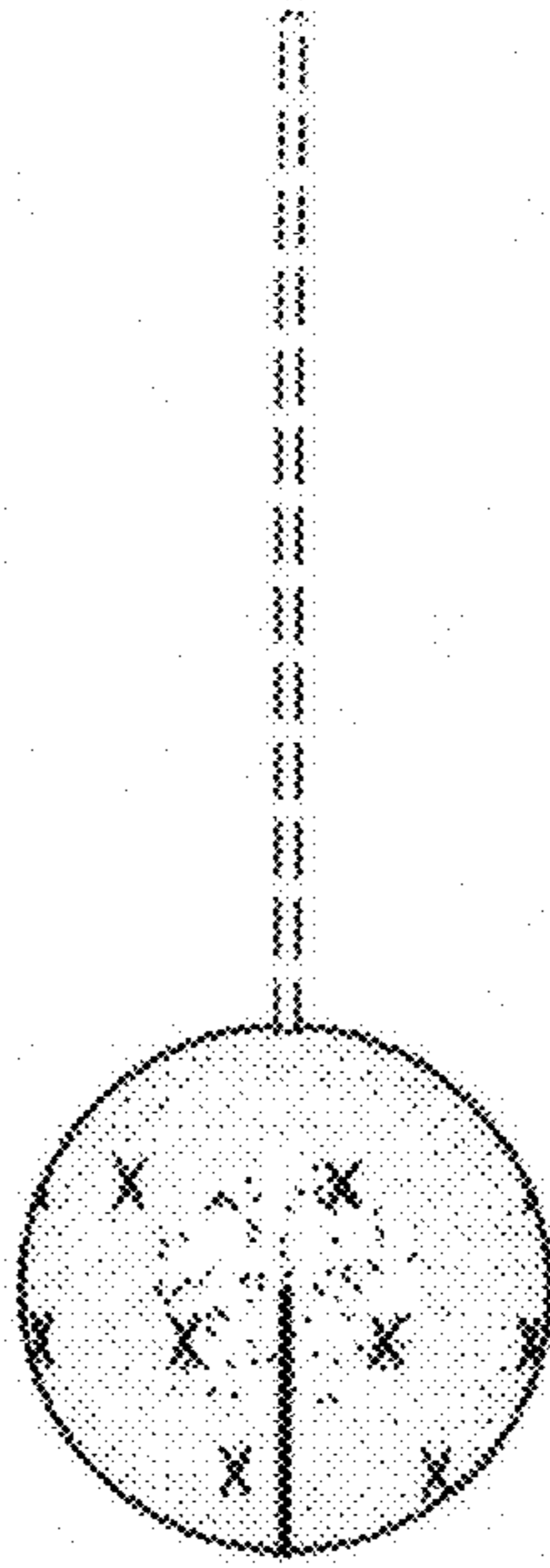

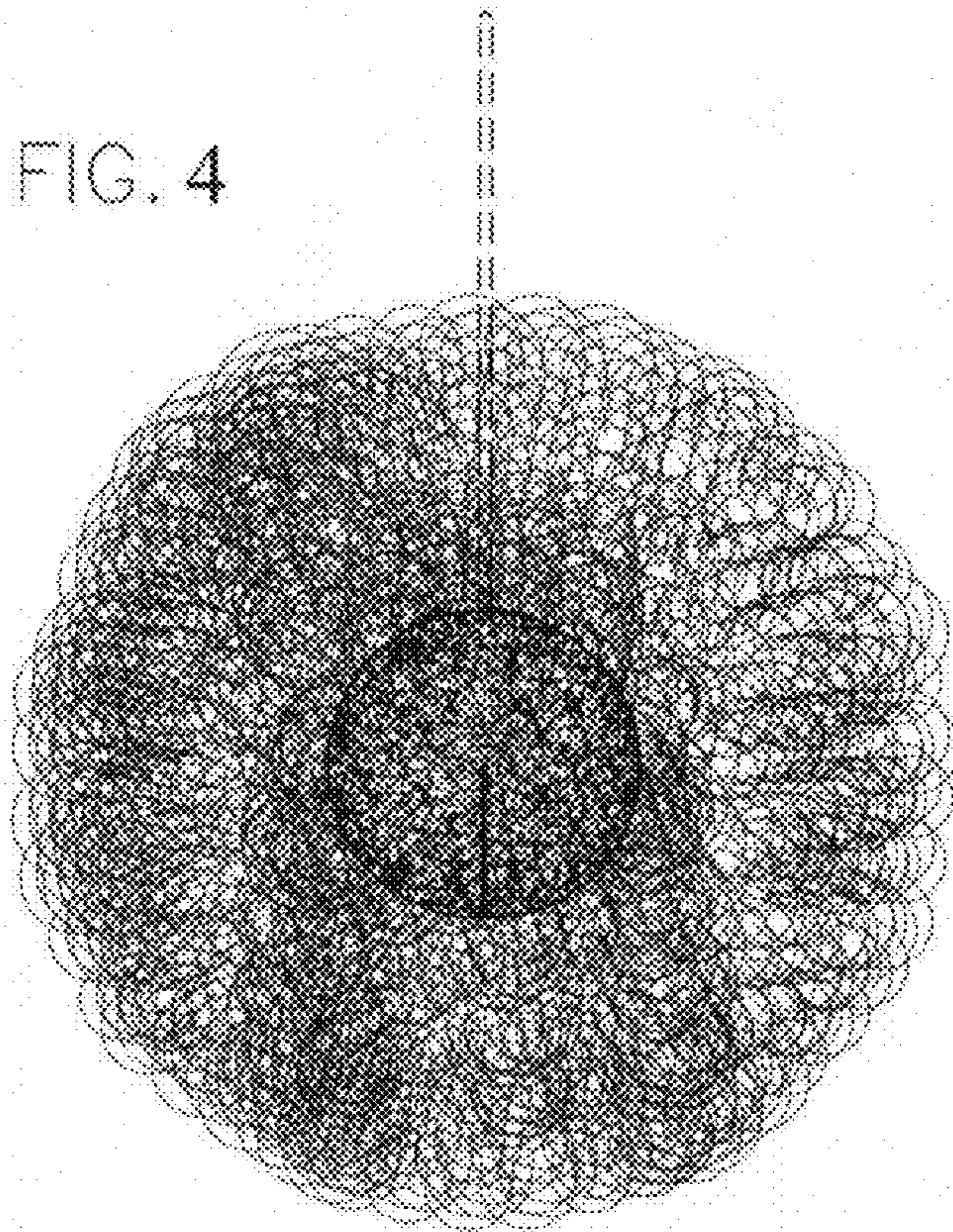

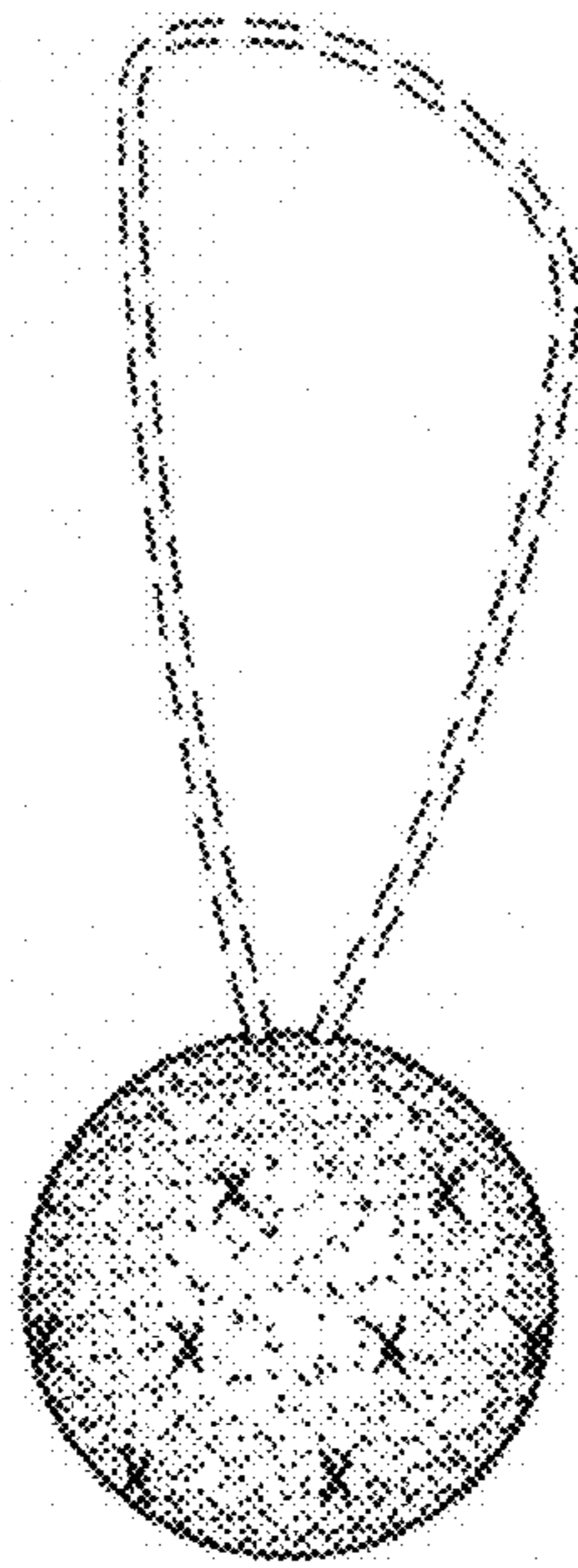

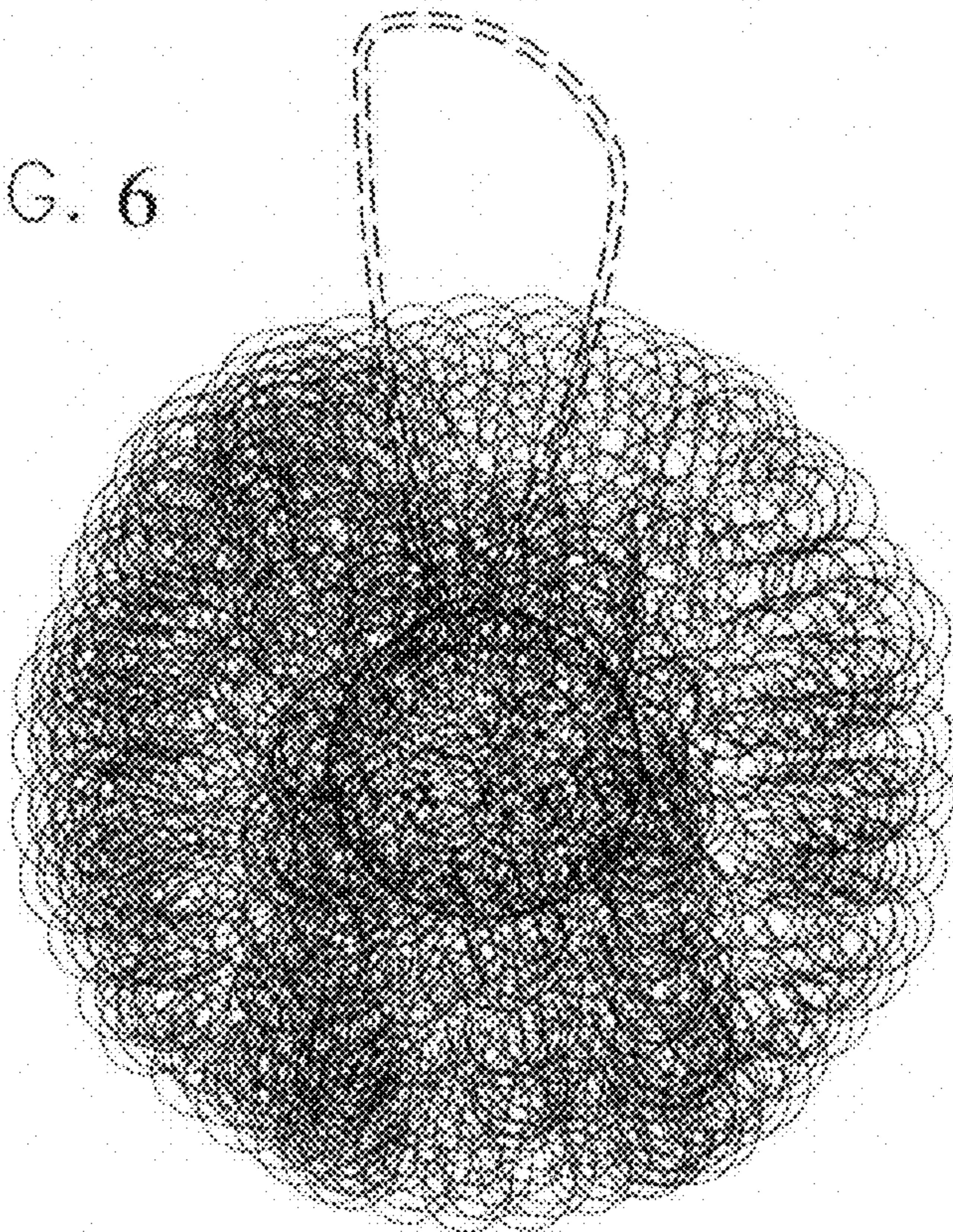

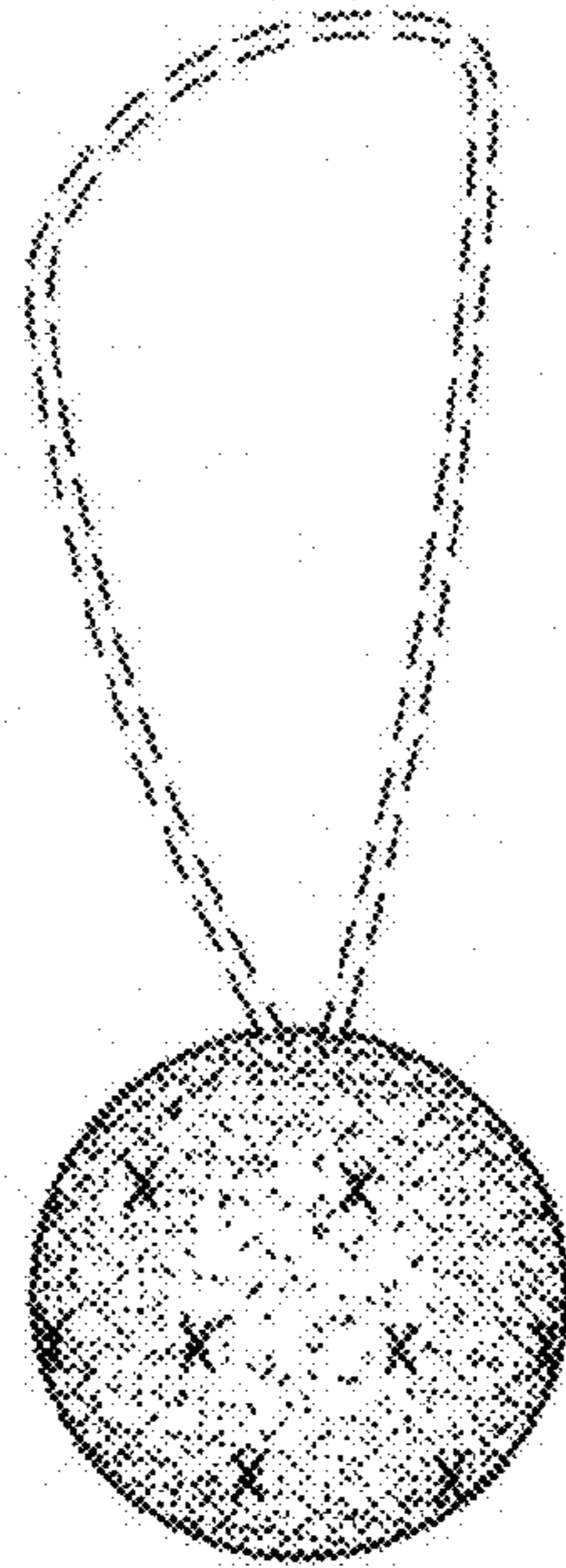
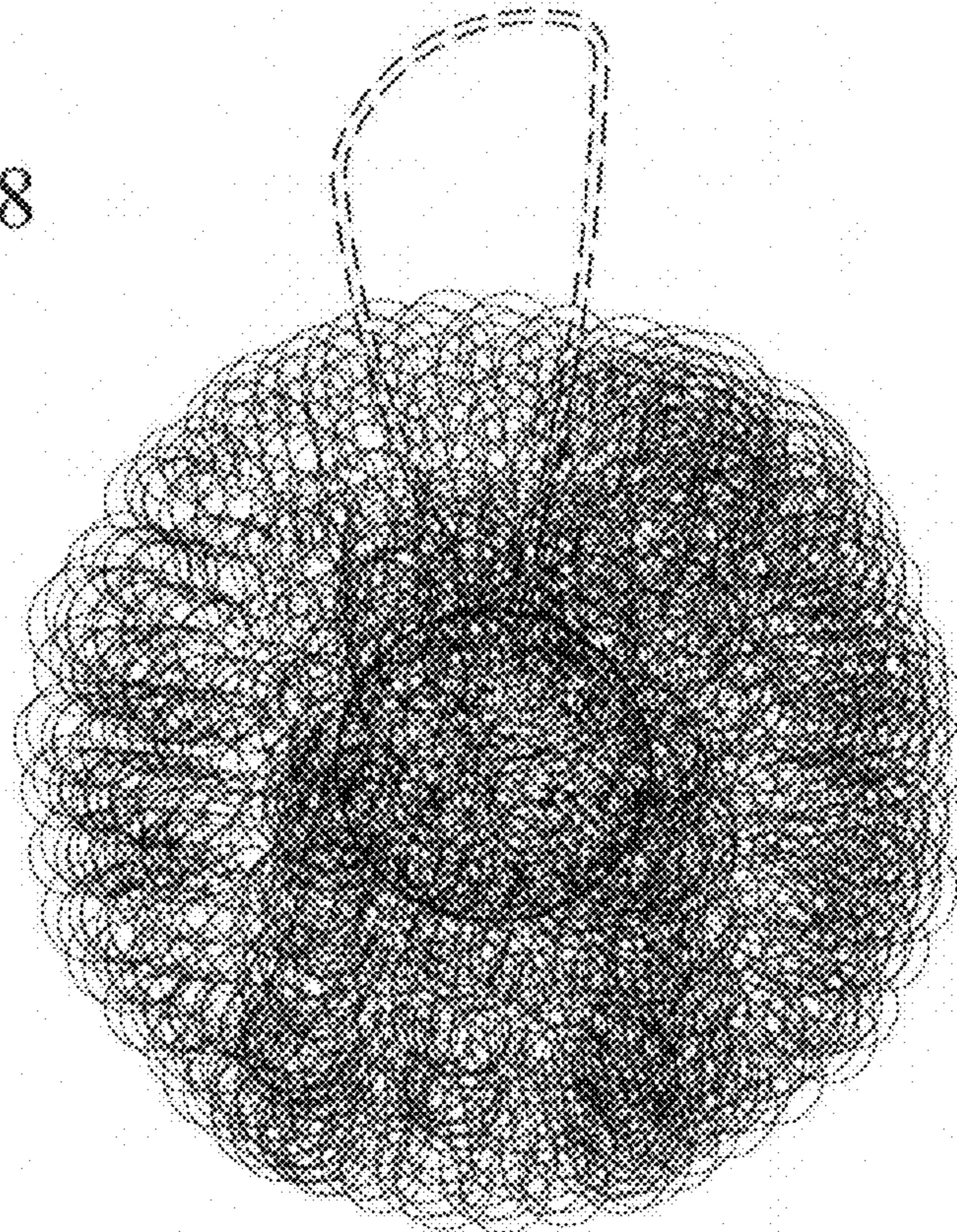

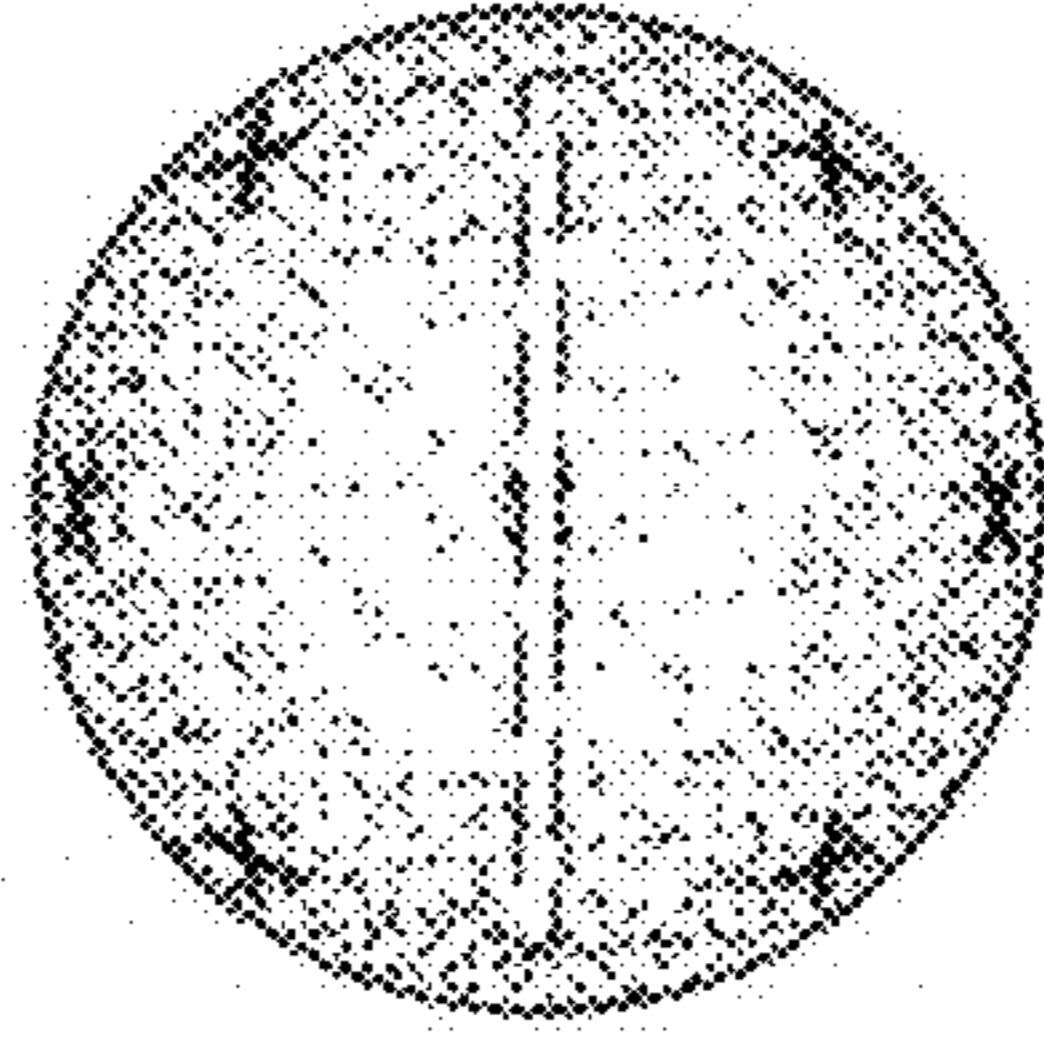
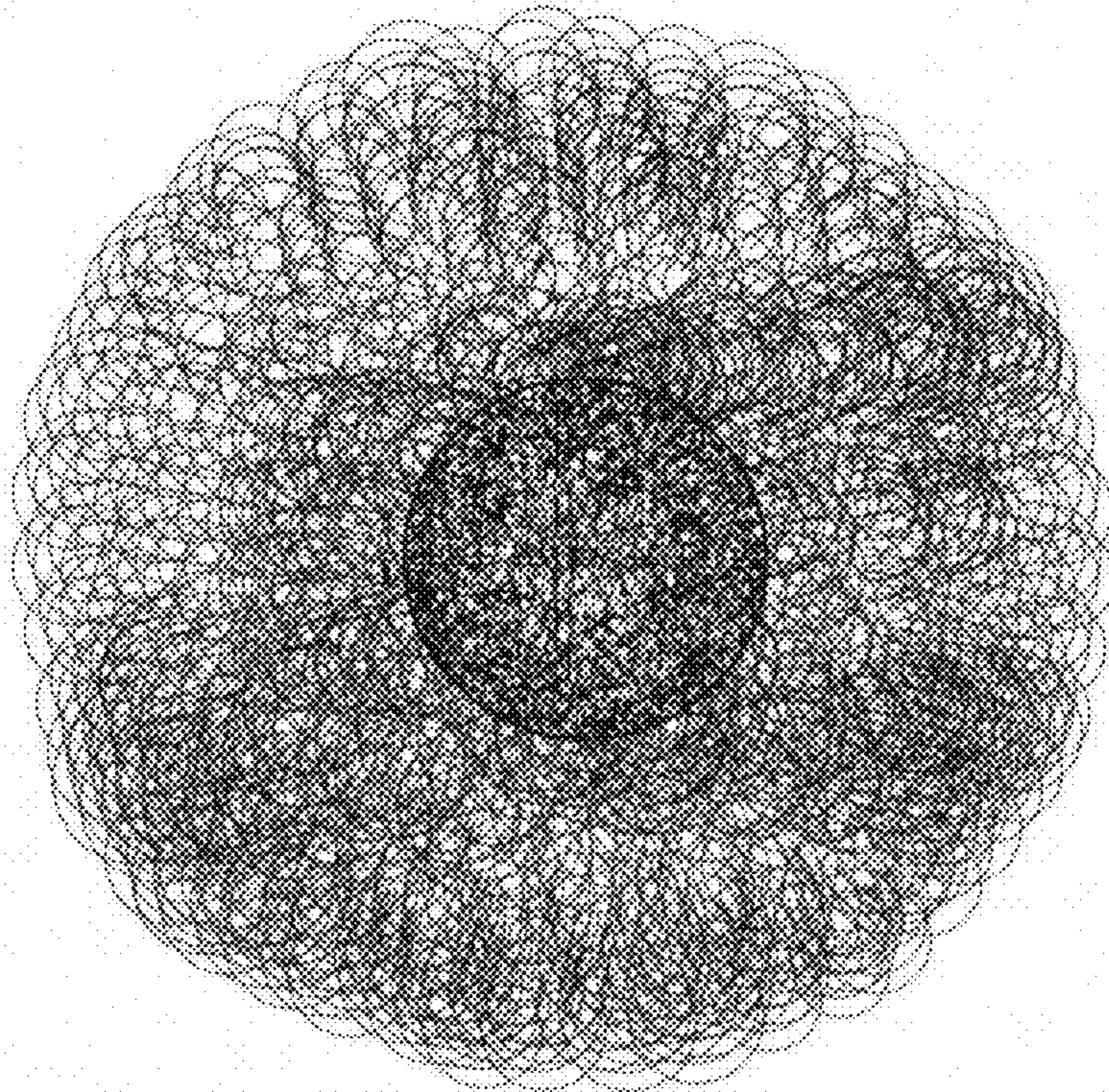

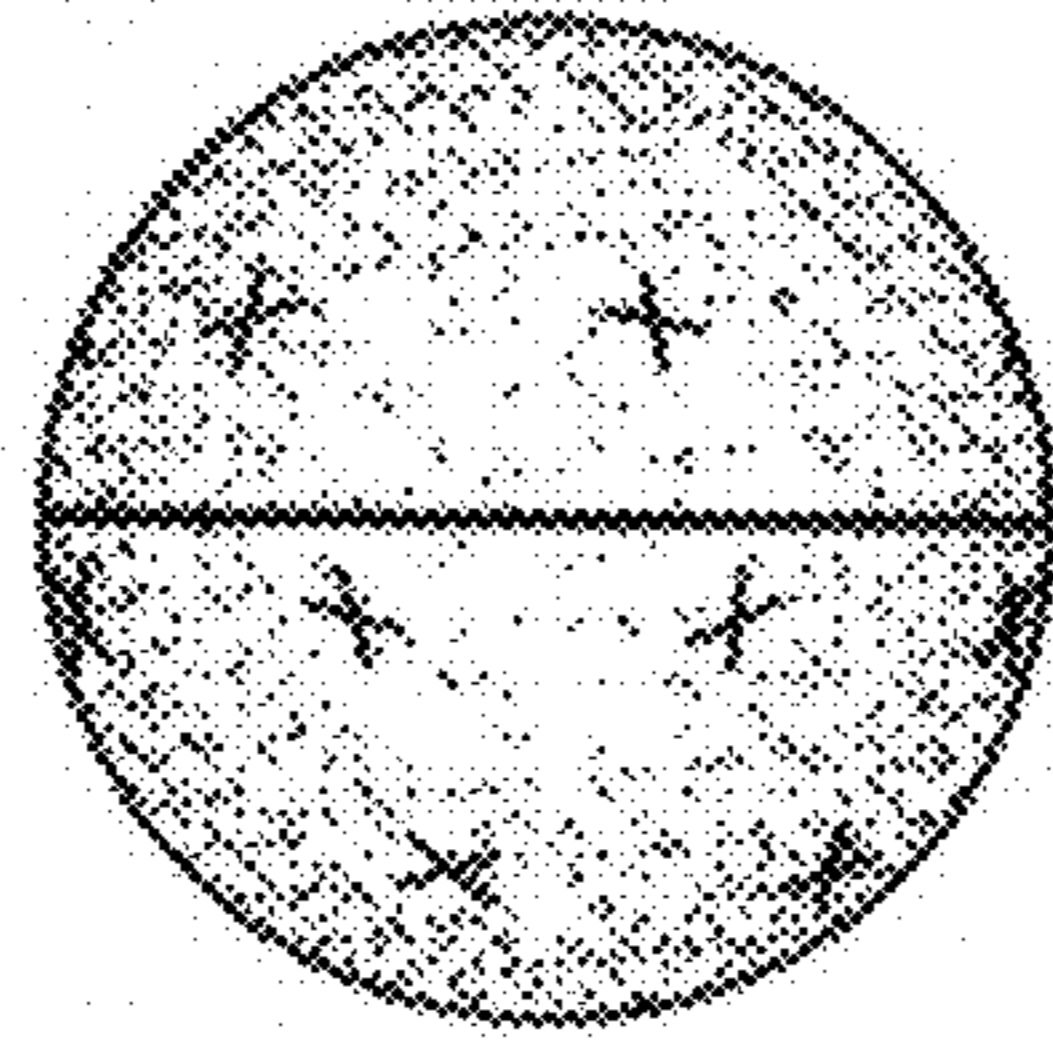
