(57) **CLAIM**

The ornamental design of a bow applique for a bottom garment, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bow applique for a bottom garment in accordance with the present invention;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof; the left side view is a mirror image;

FIG. 5 is a front perspective view of another embodiment of a bow applique for a bottom garment in accordance with the present invention;

FIG. 6 is a front view thereof;

FIG. 7 is a rear view thereof;

FIG. 8 is a right side view thereof; the left side view is a mirror image;

FIG. 9 is a front perspective view of another embodiment of a bow applique for a bottom garment in accordance with the present invention;

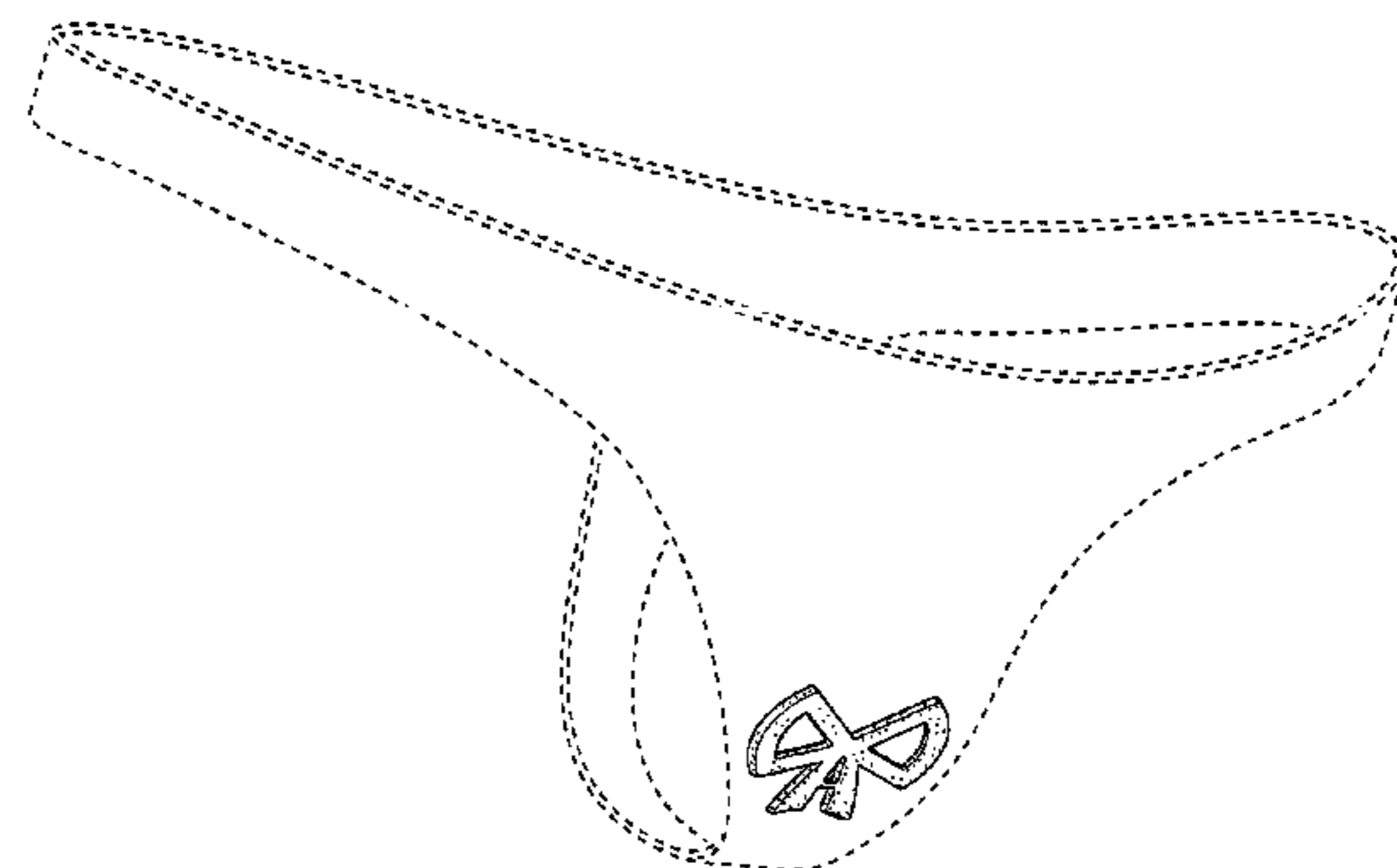
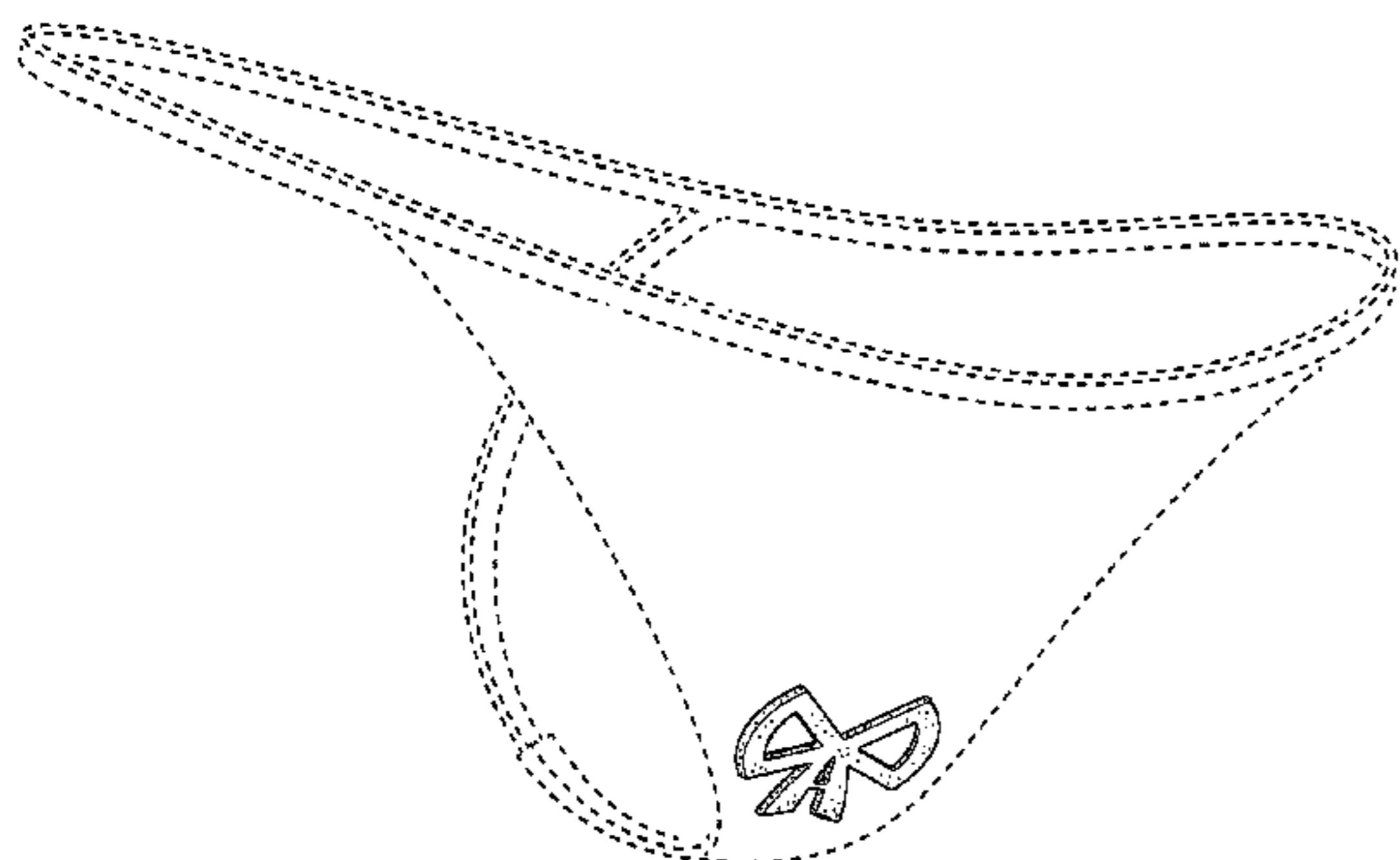
FIG. 10 is a front view thereof;

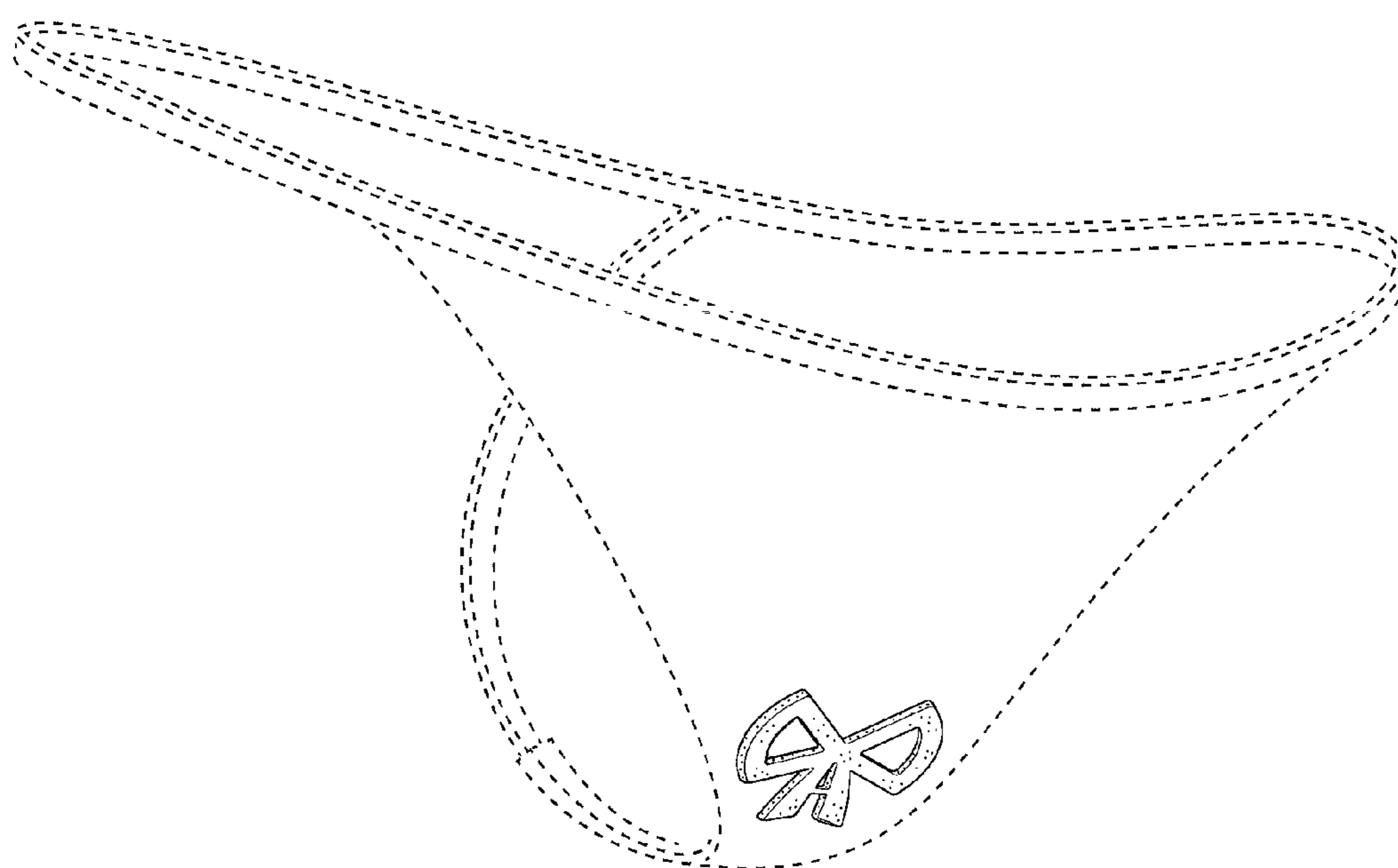

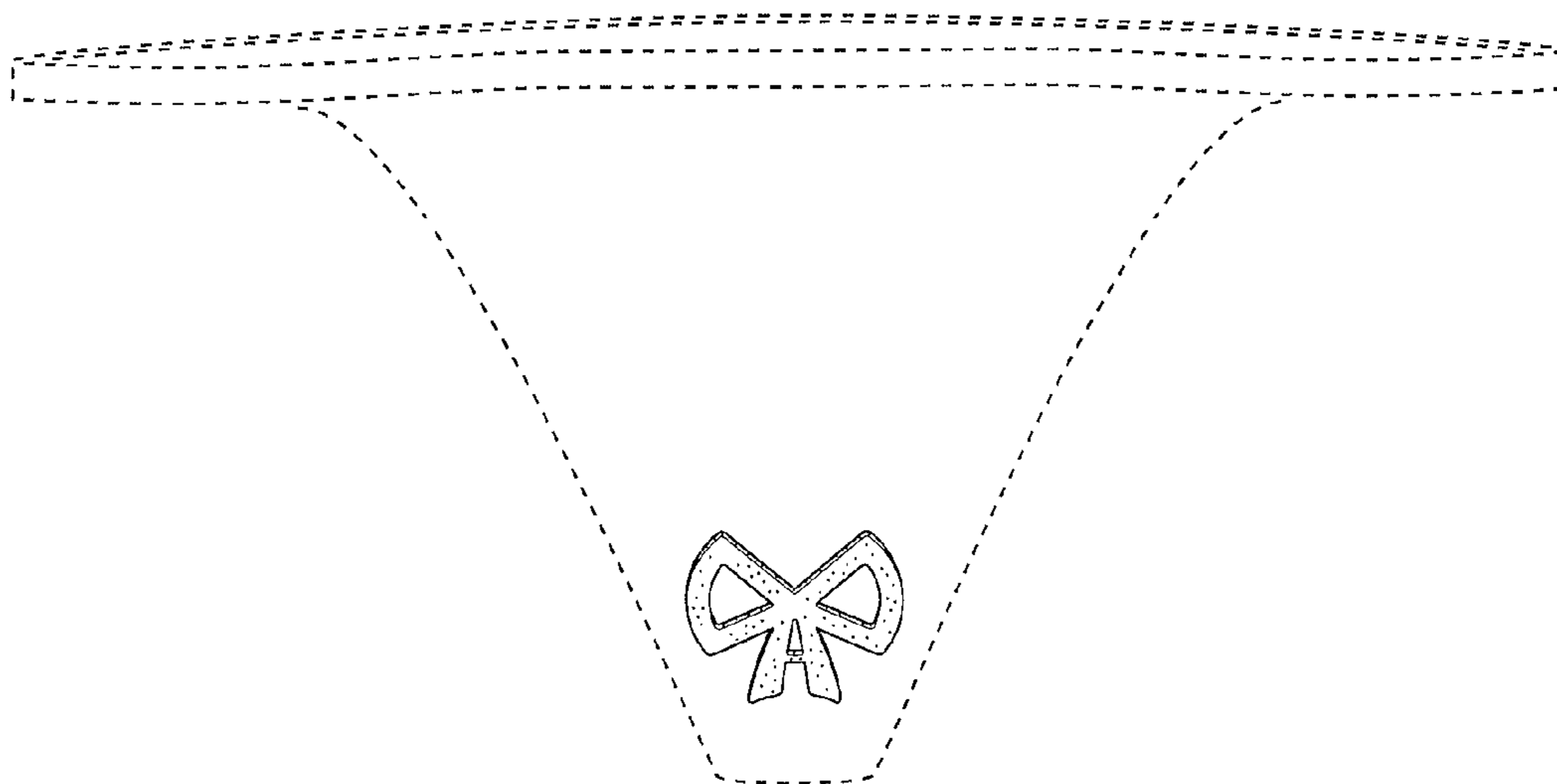

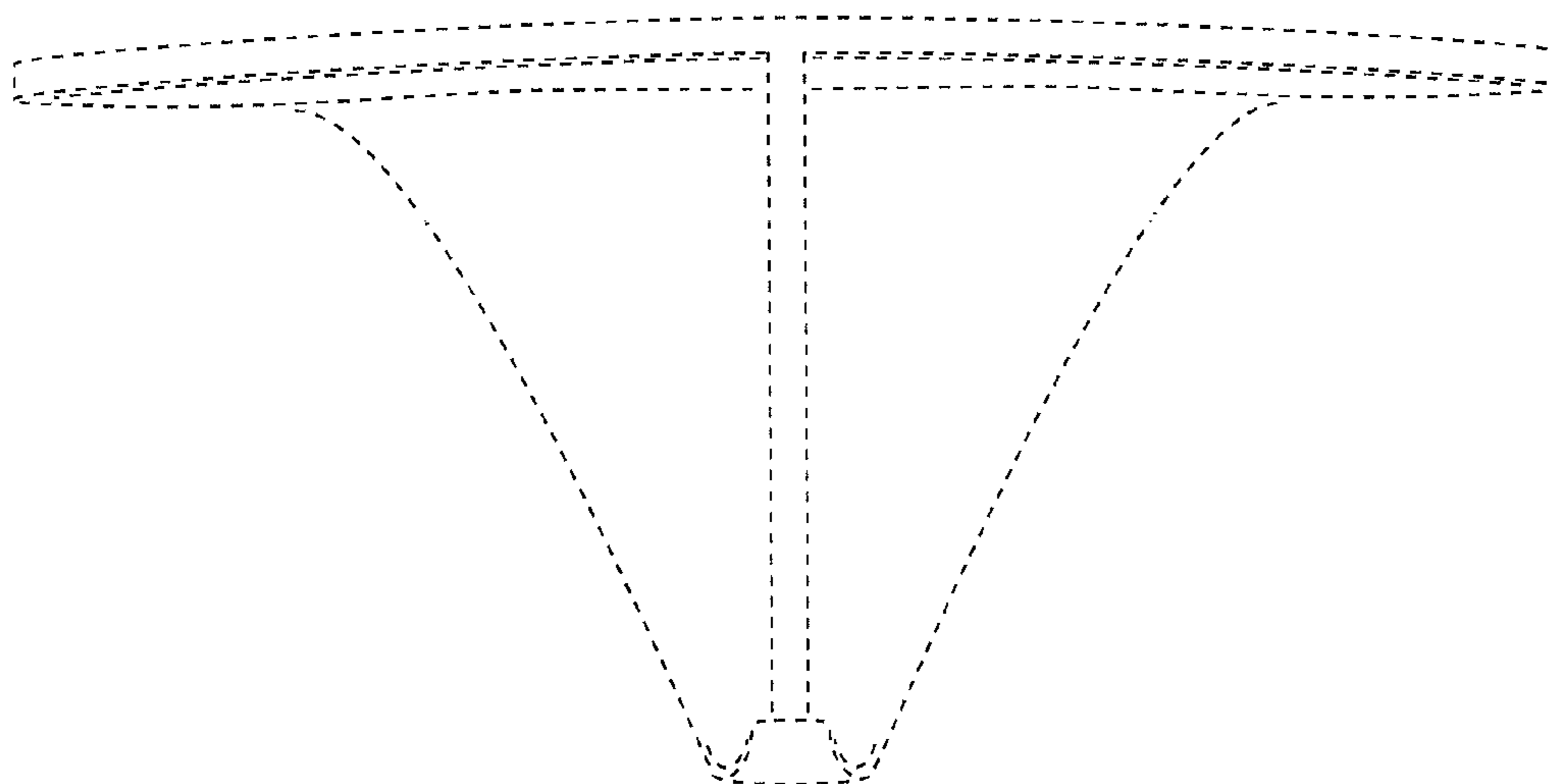

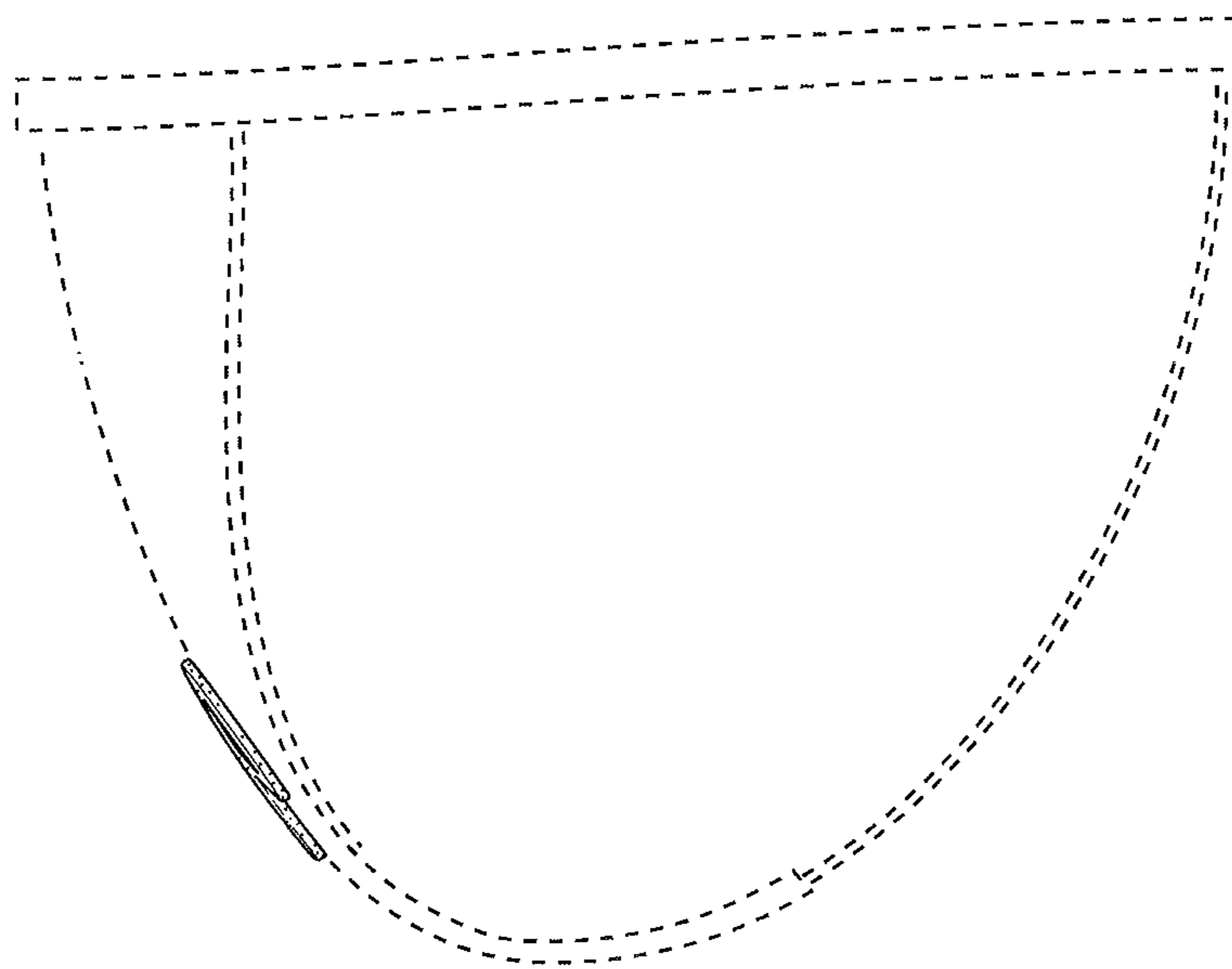

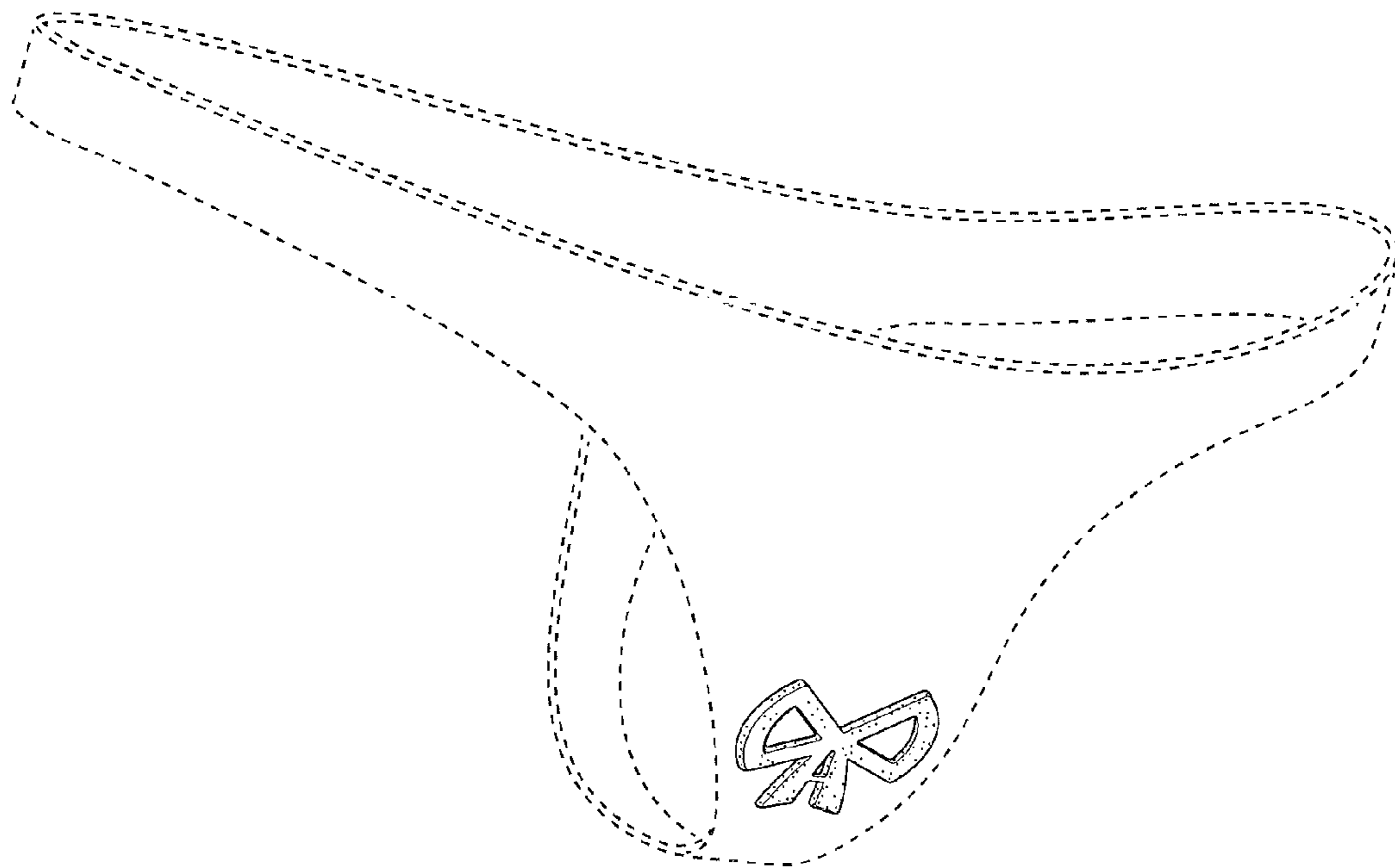

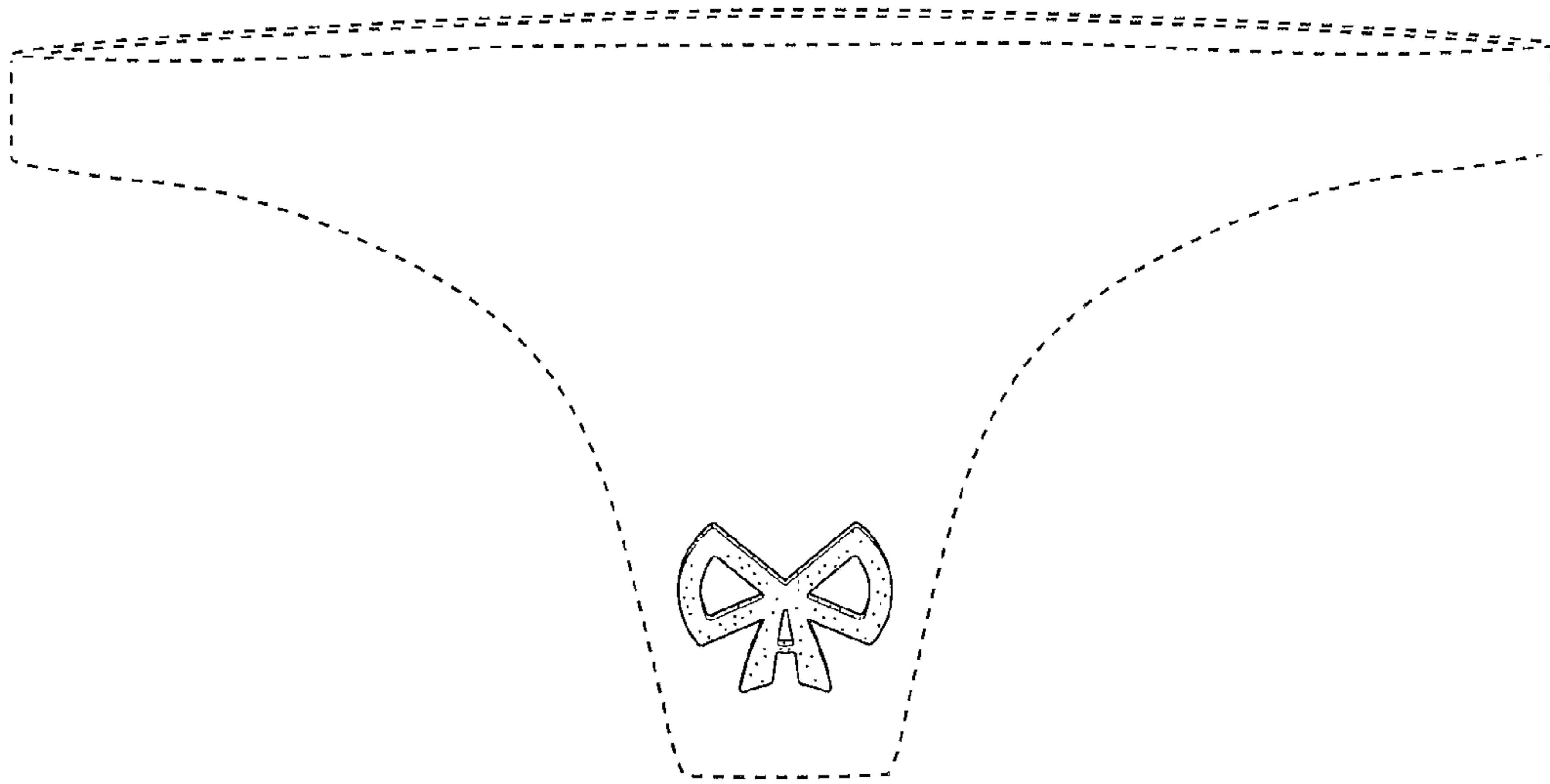

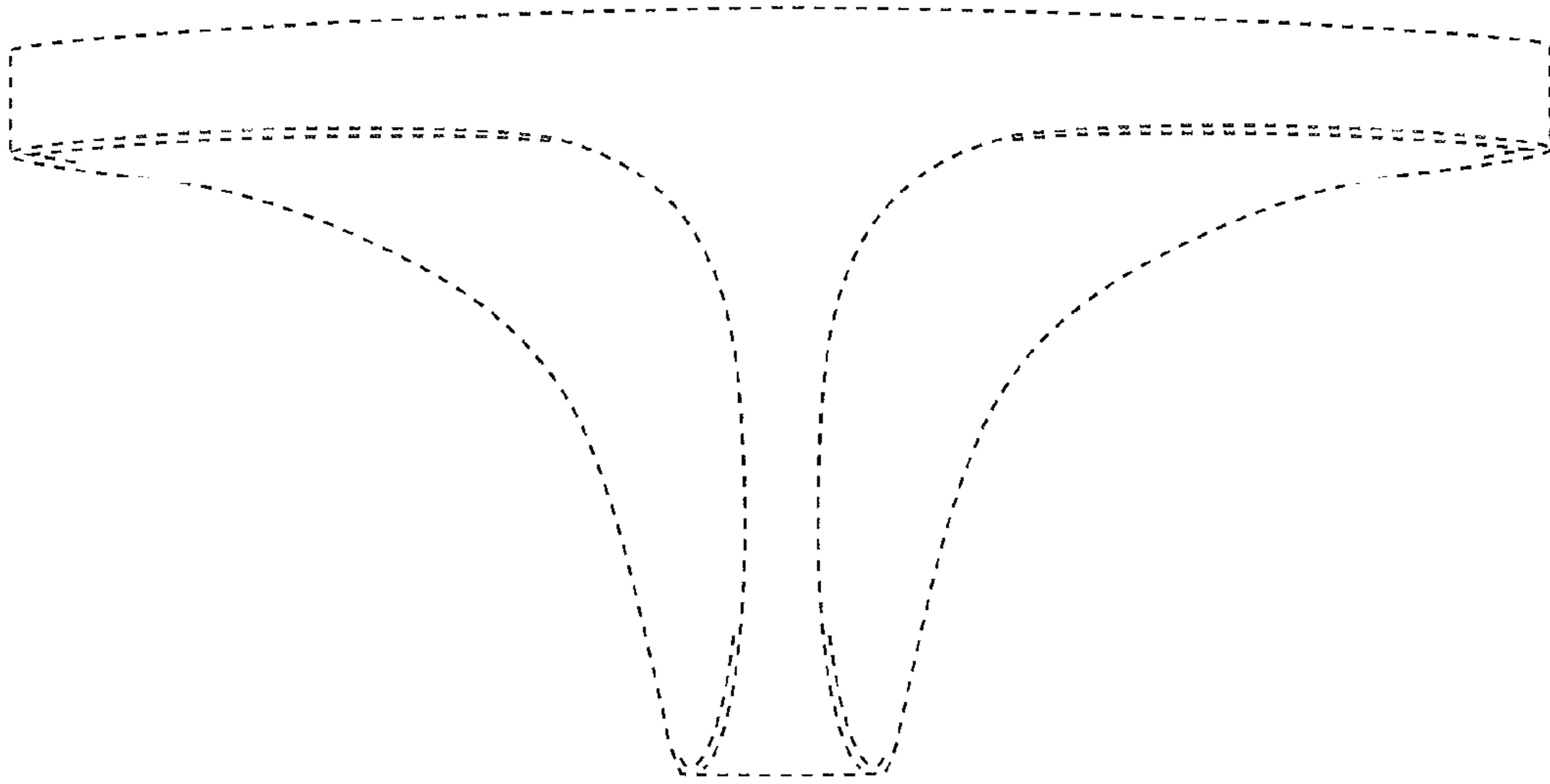

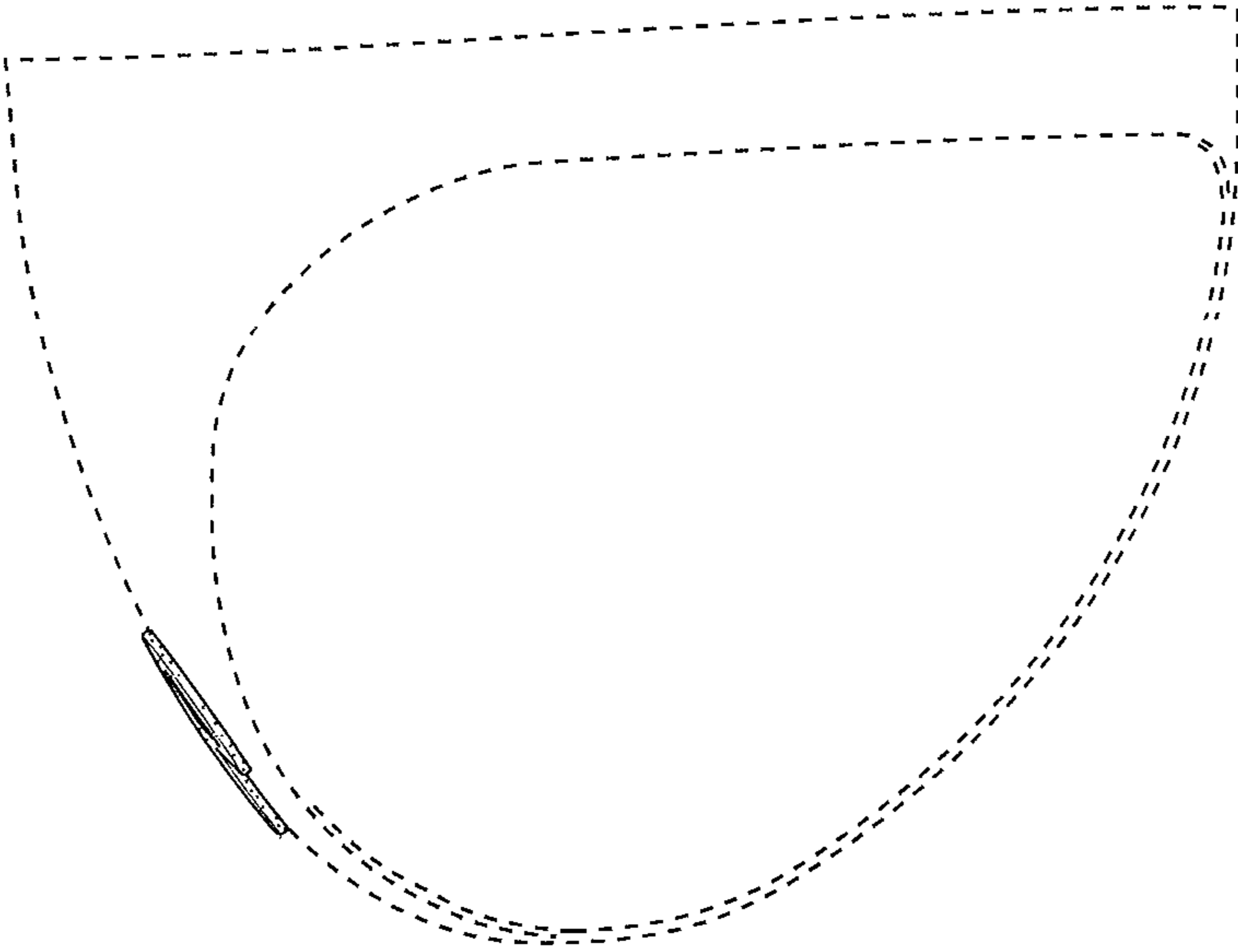

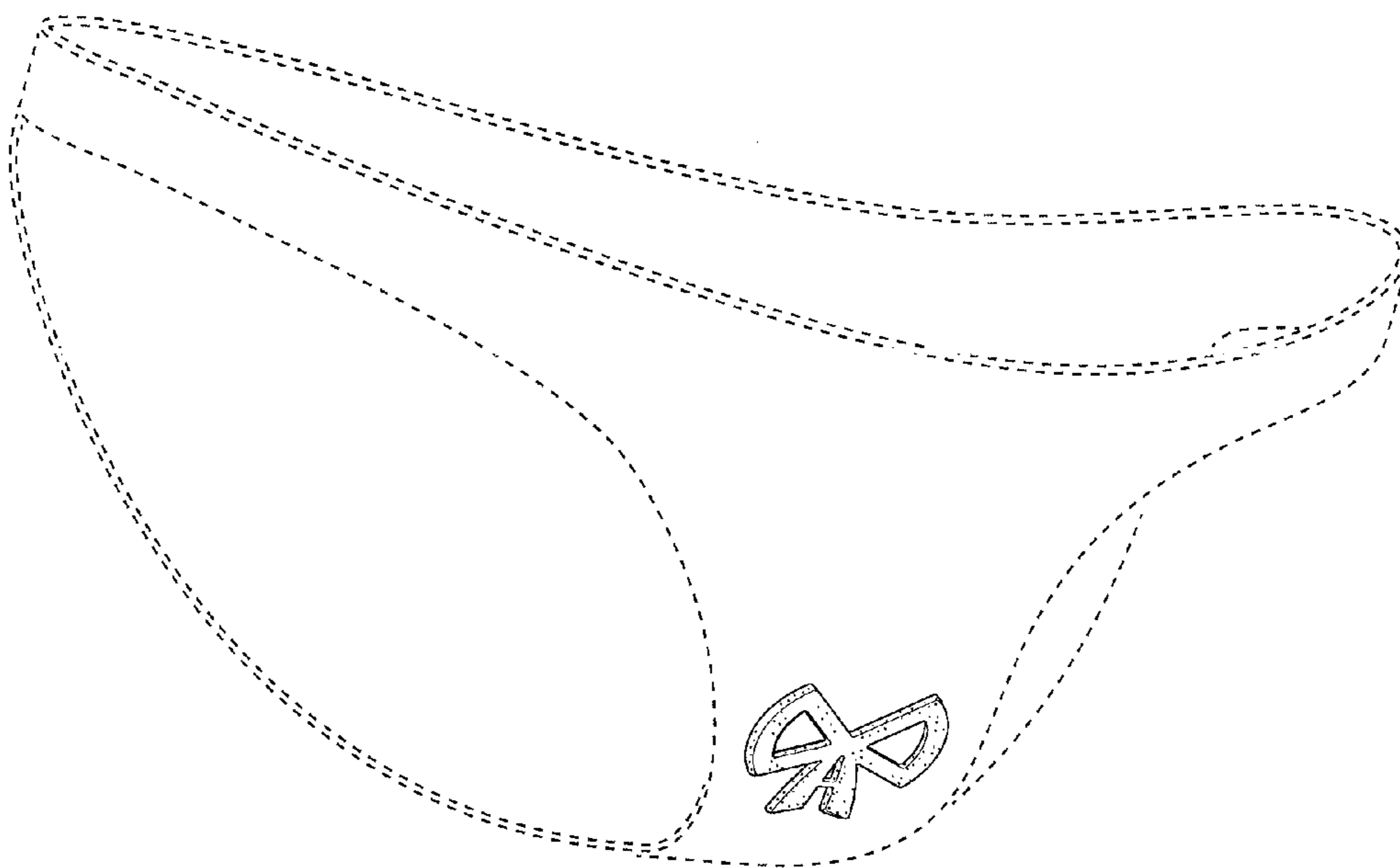

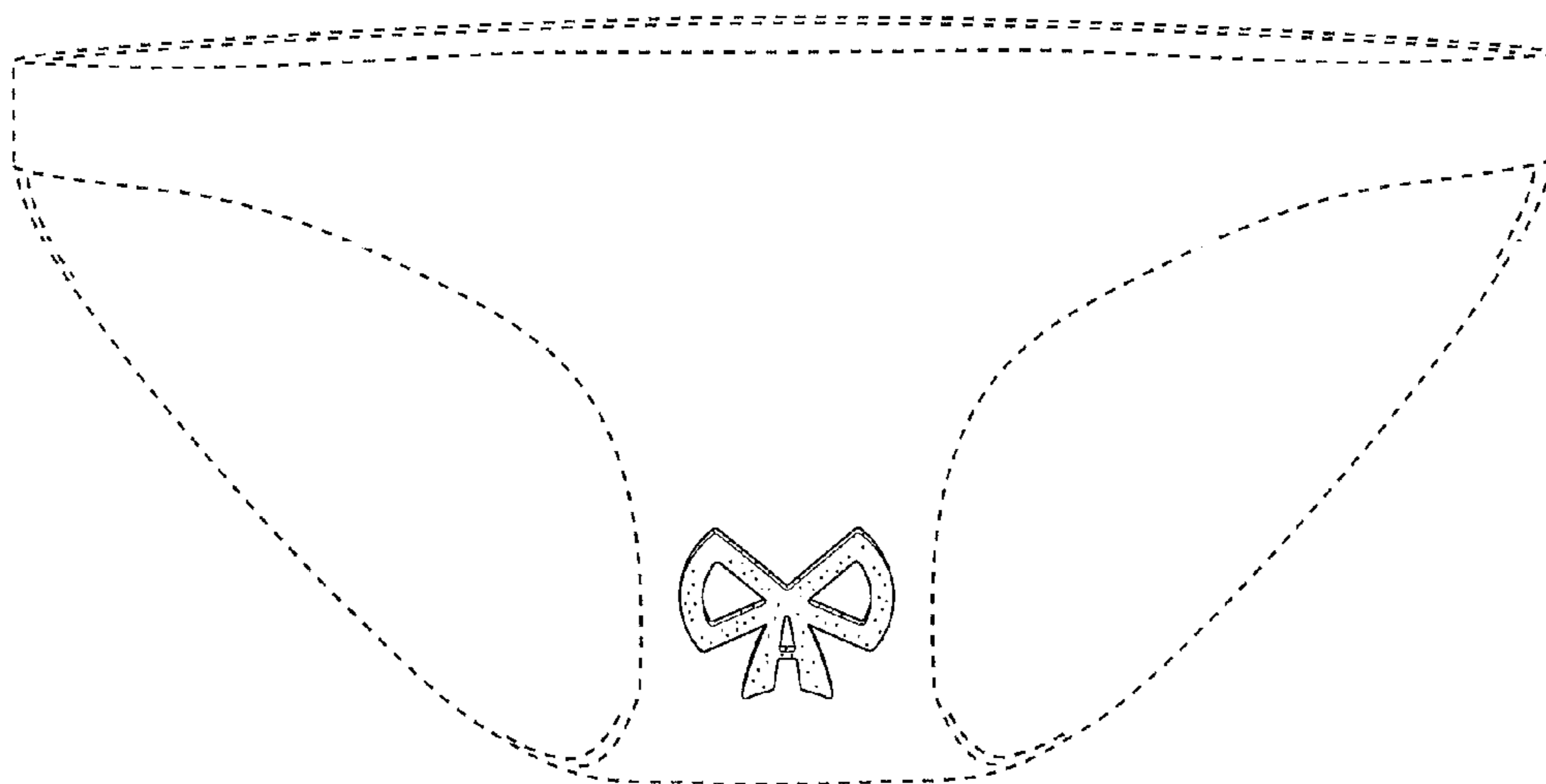

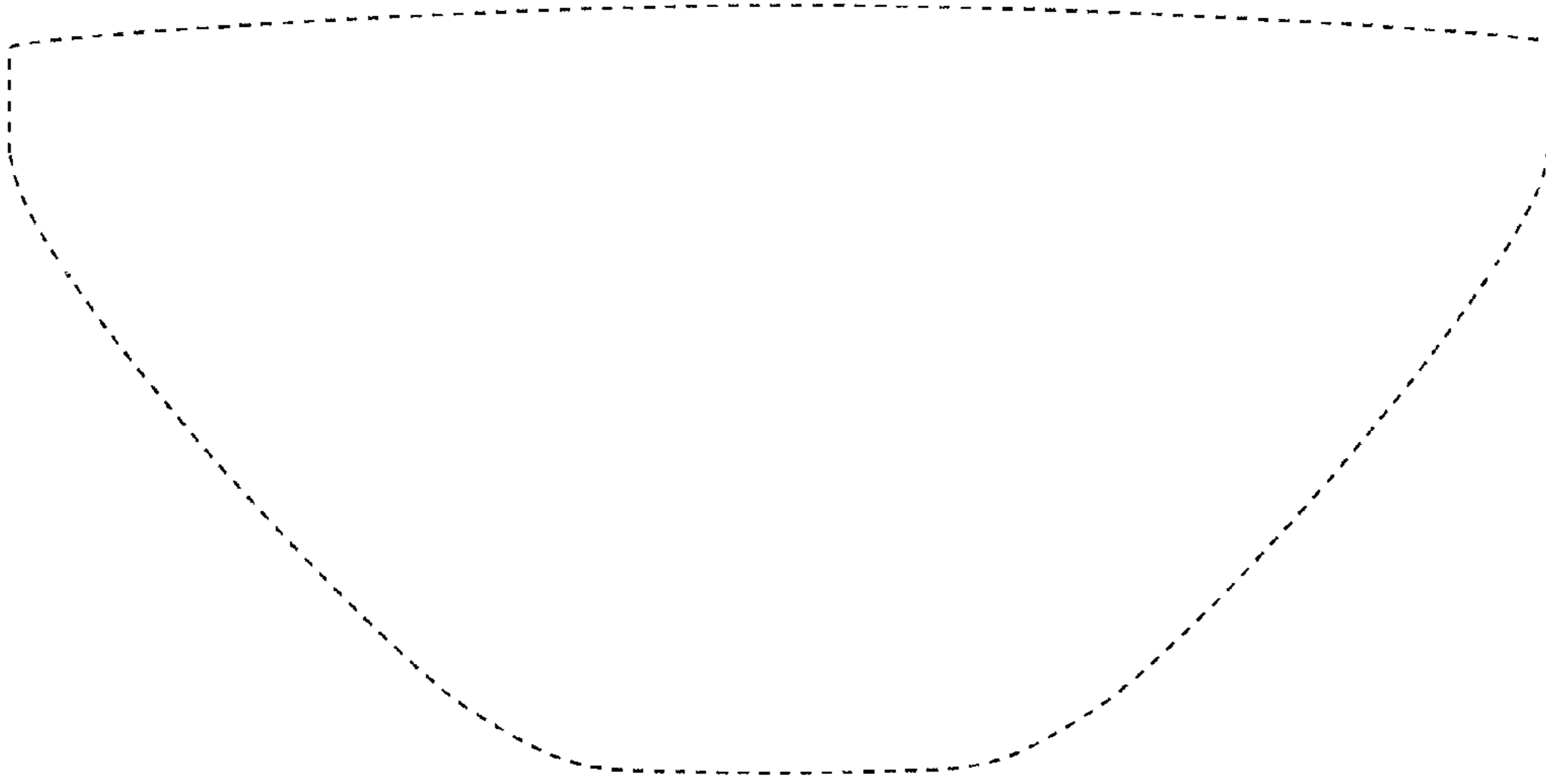

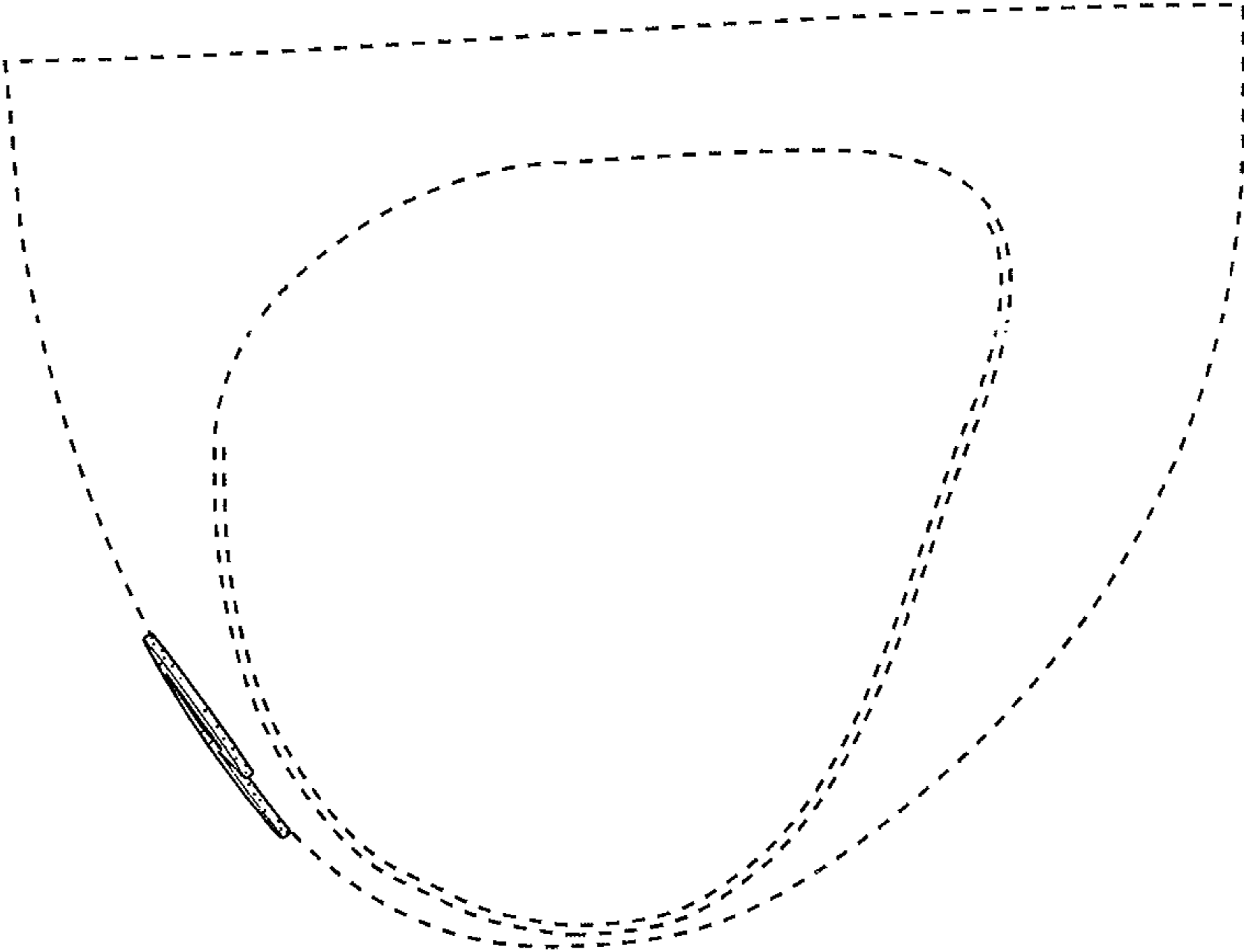
