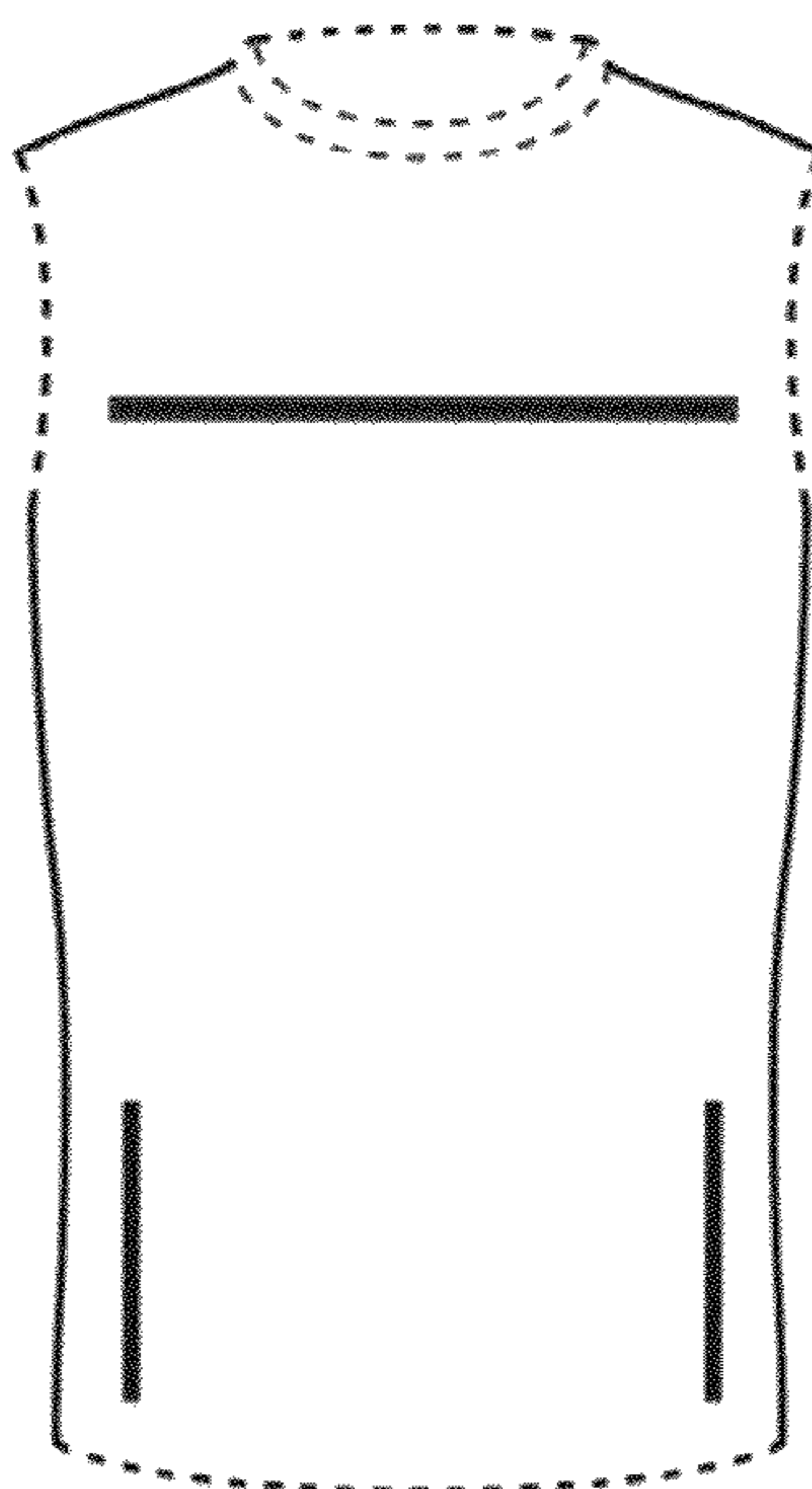
FIG. 1 is a front view of an exercise shirt;

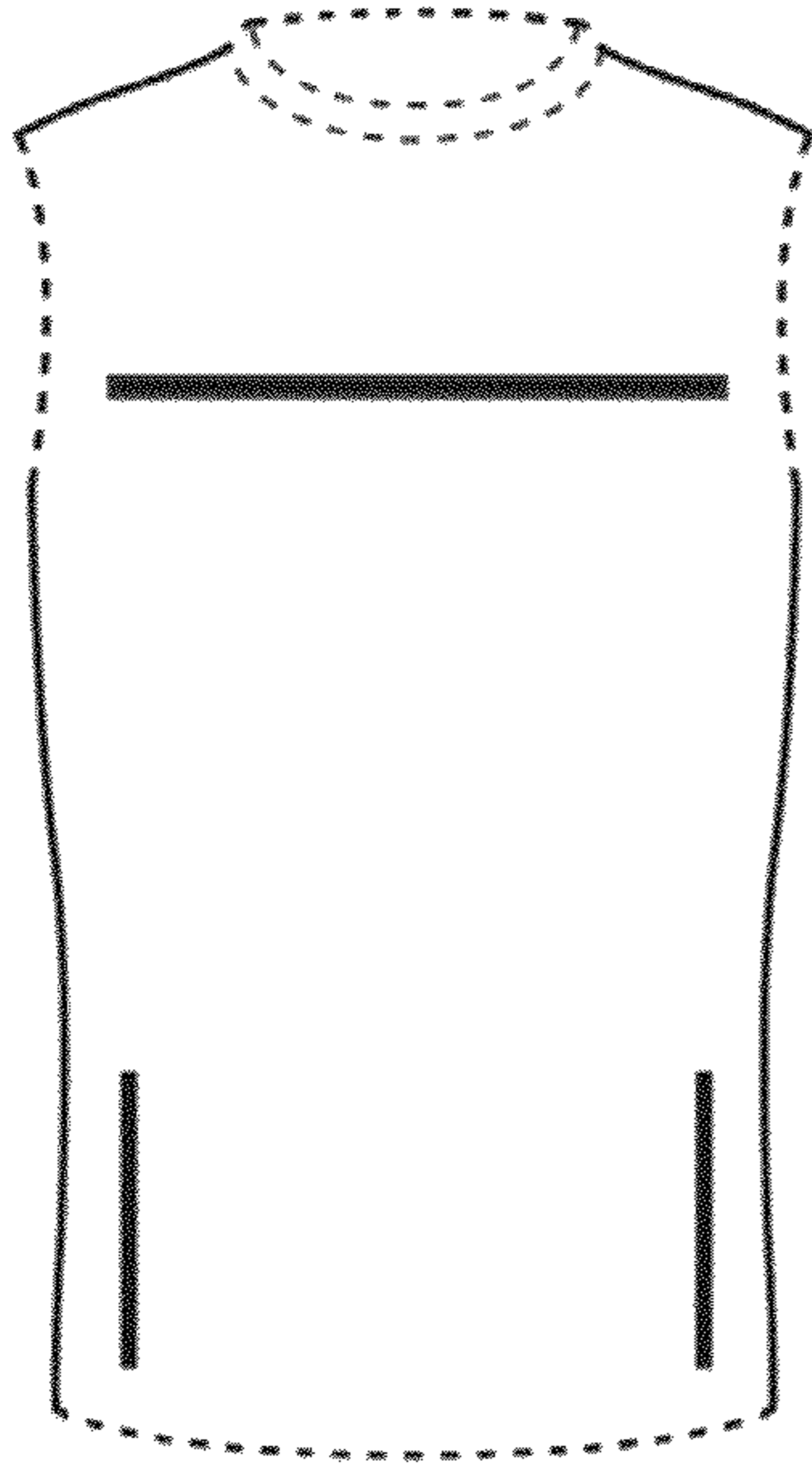

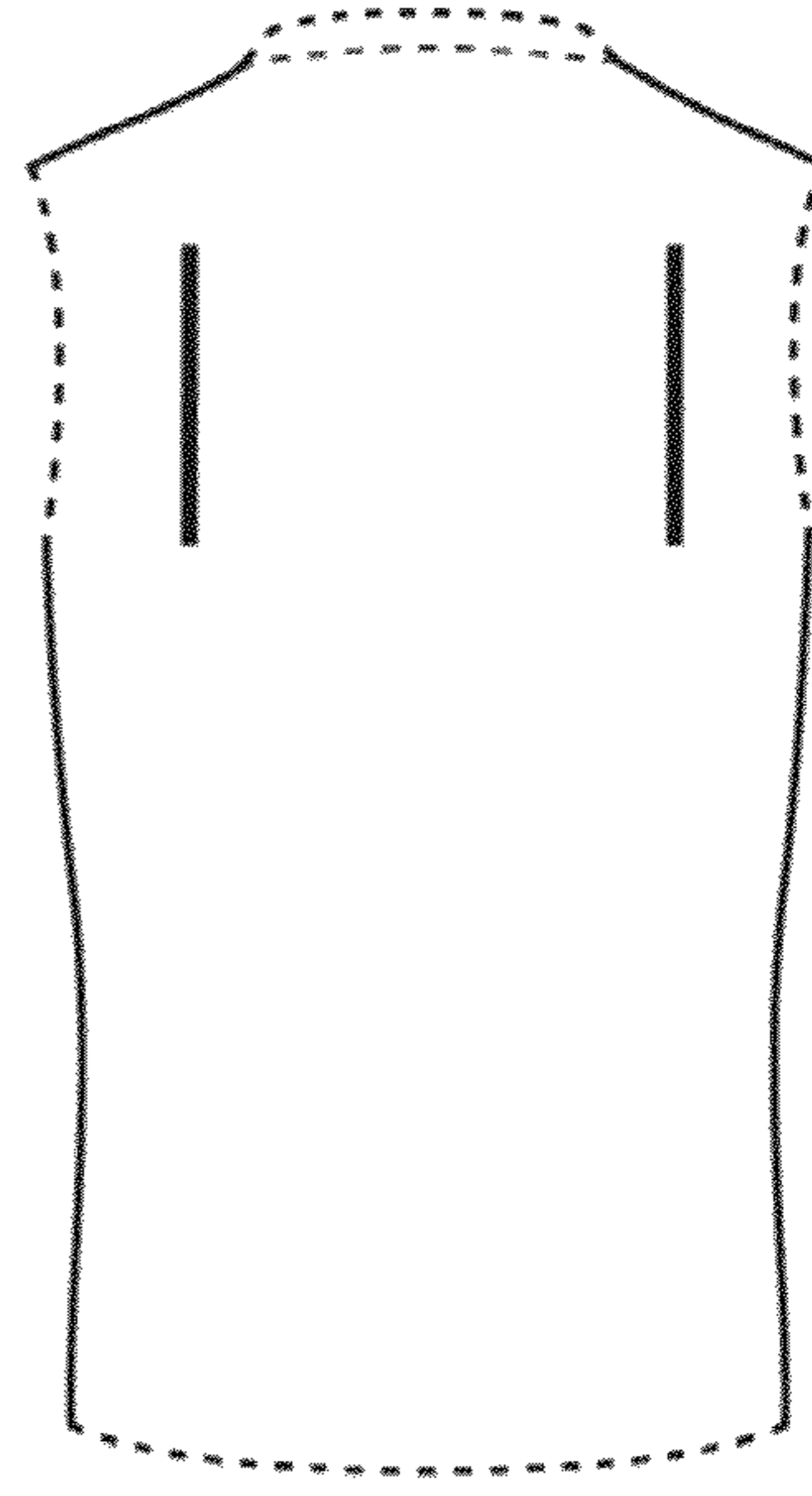

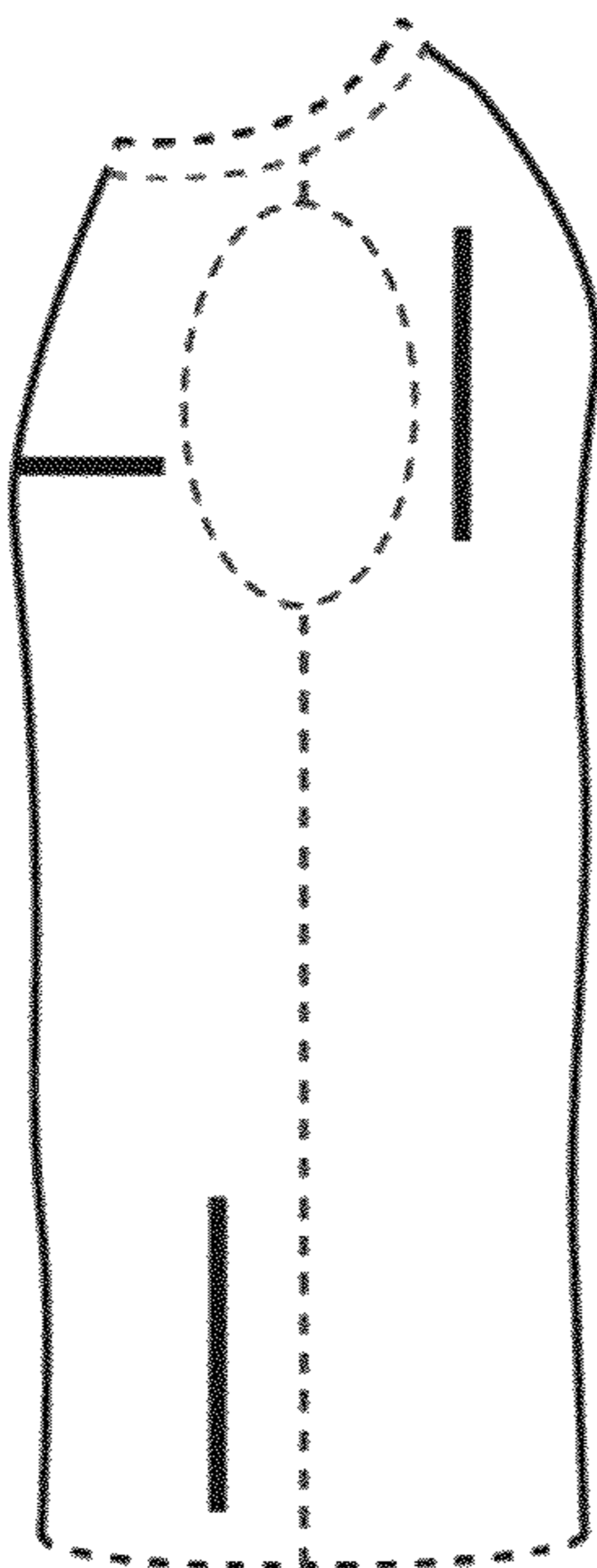

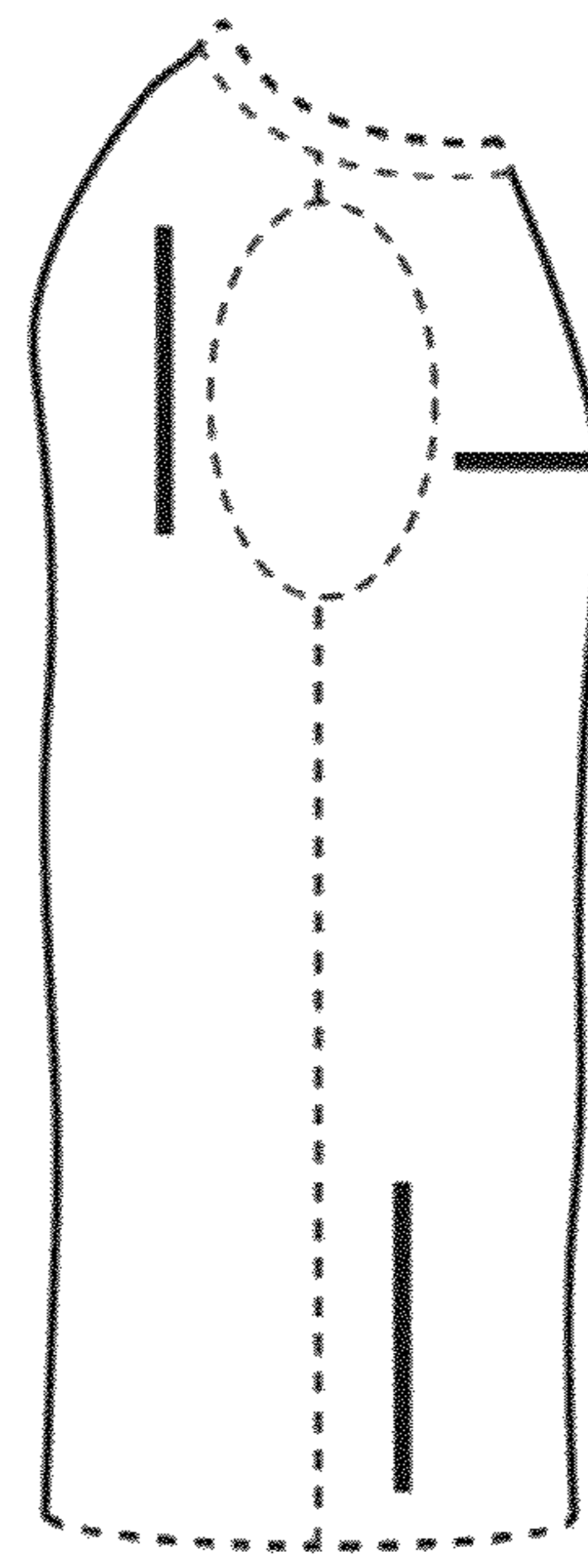

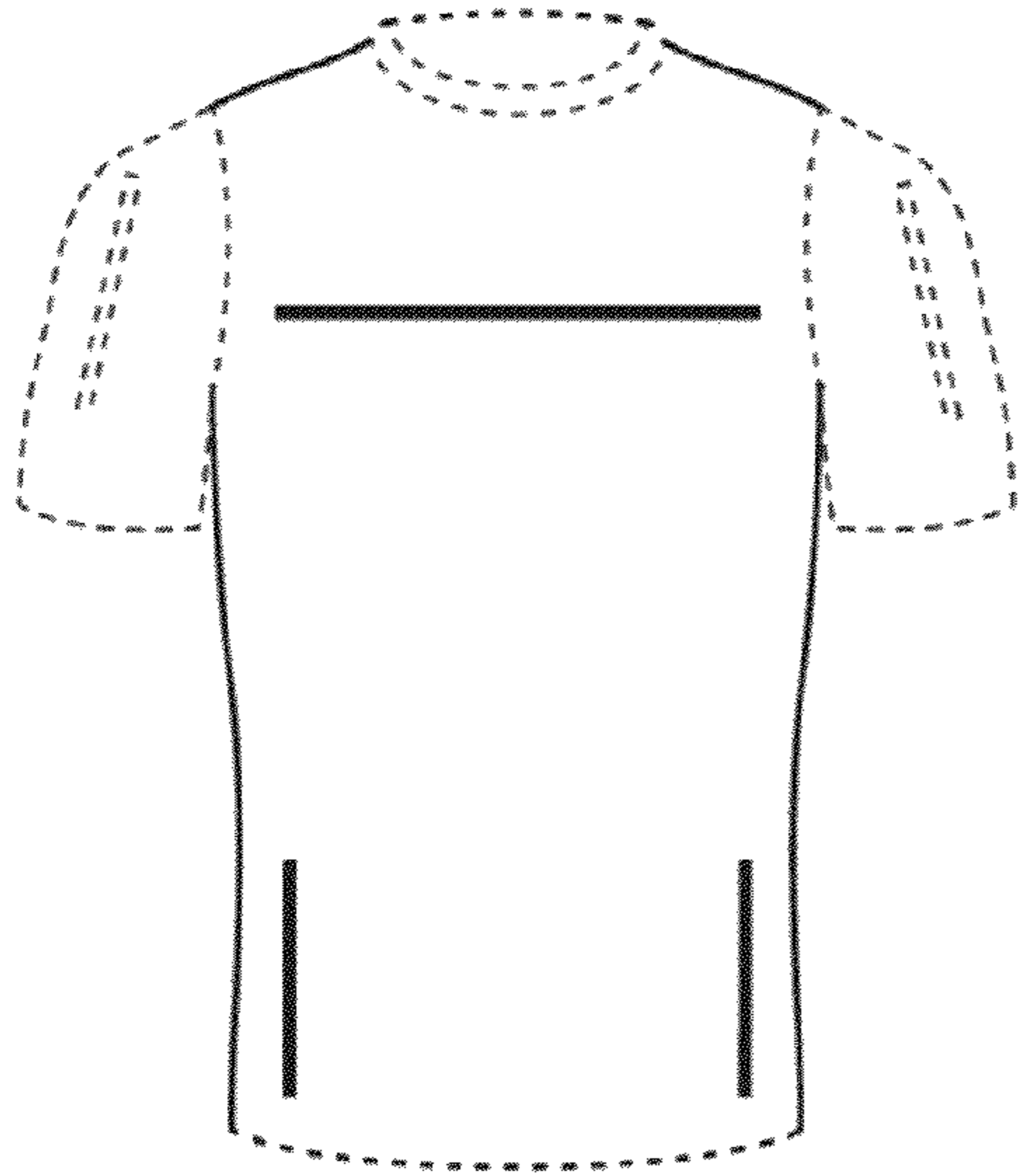

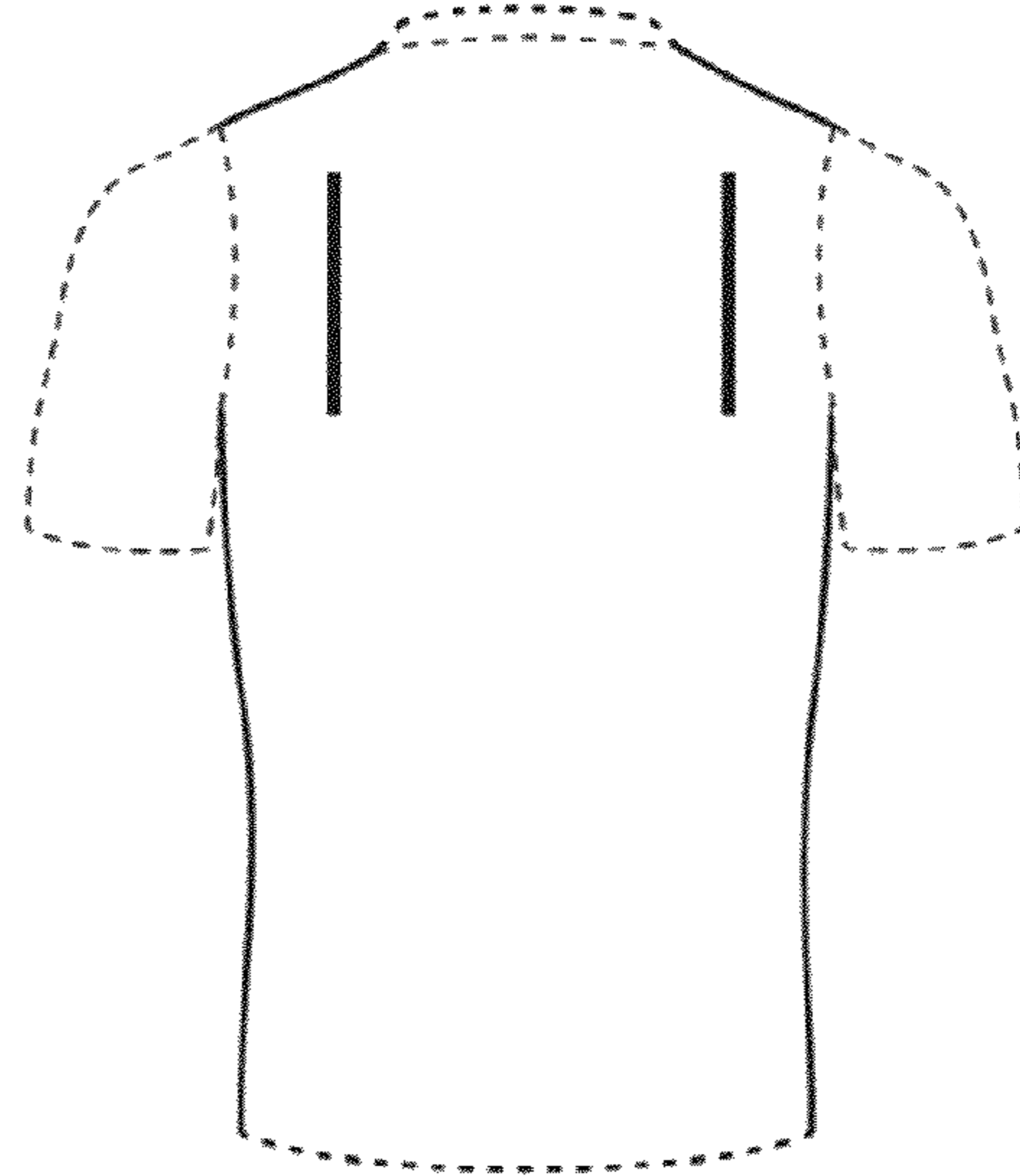

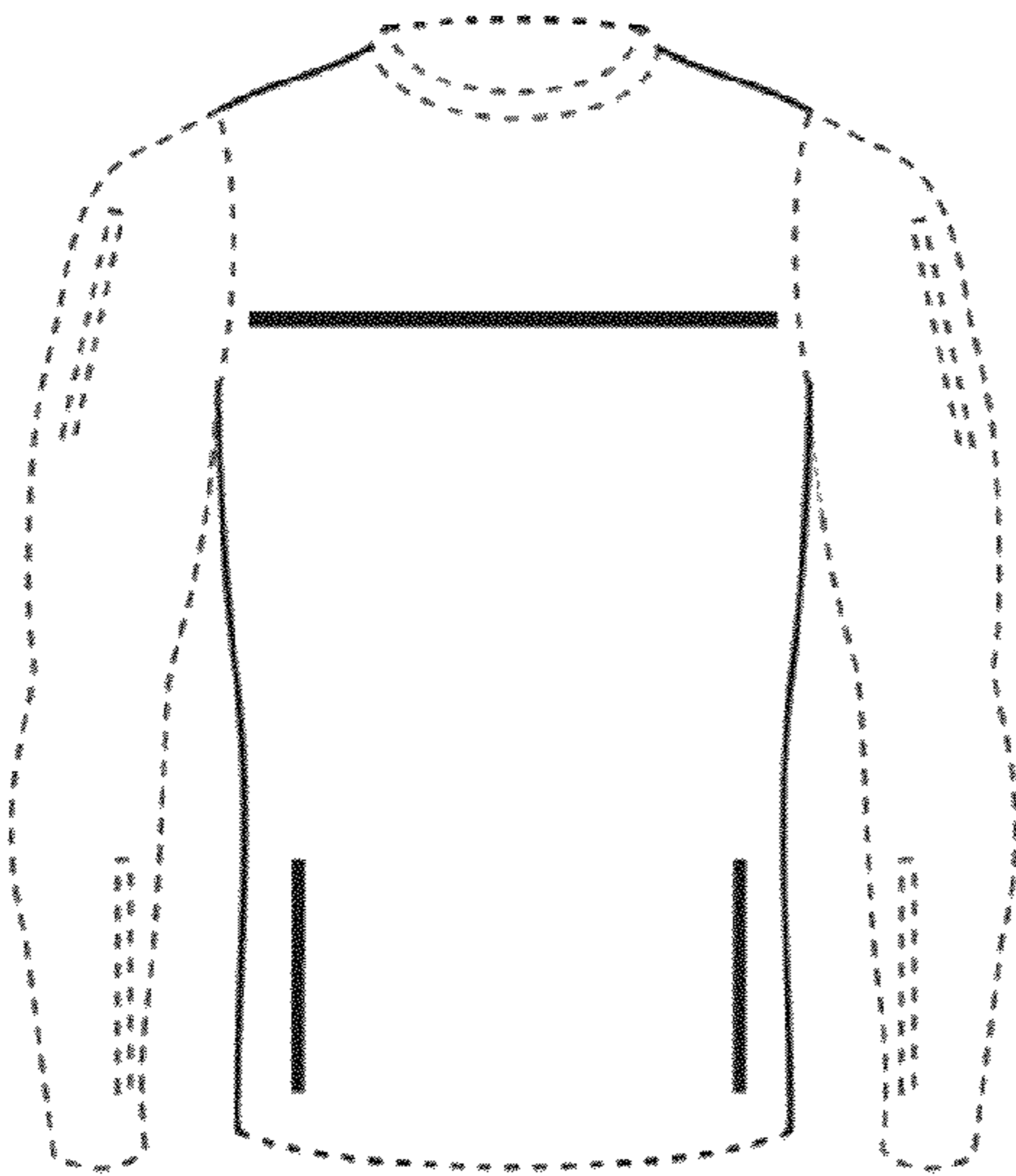

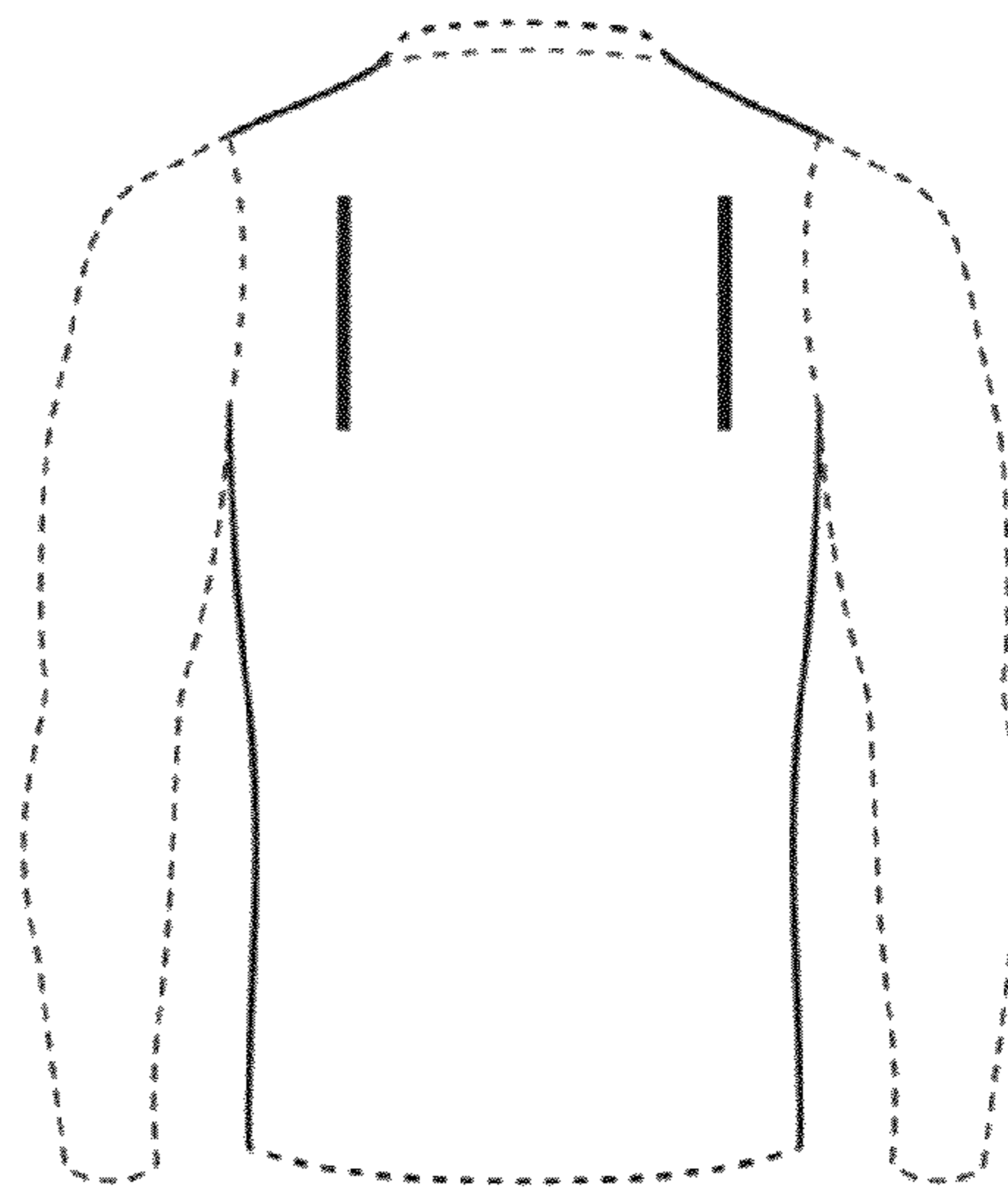

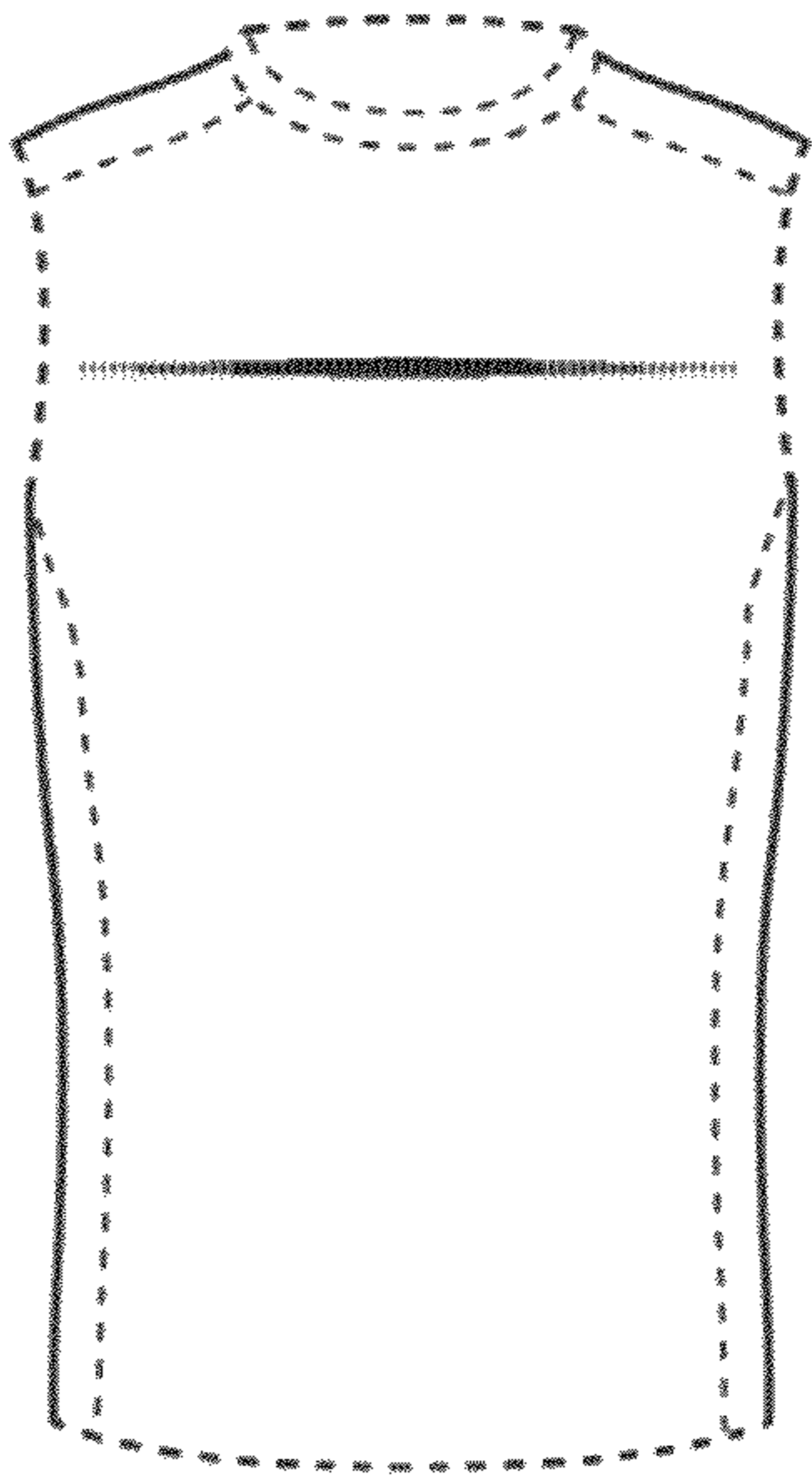

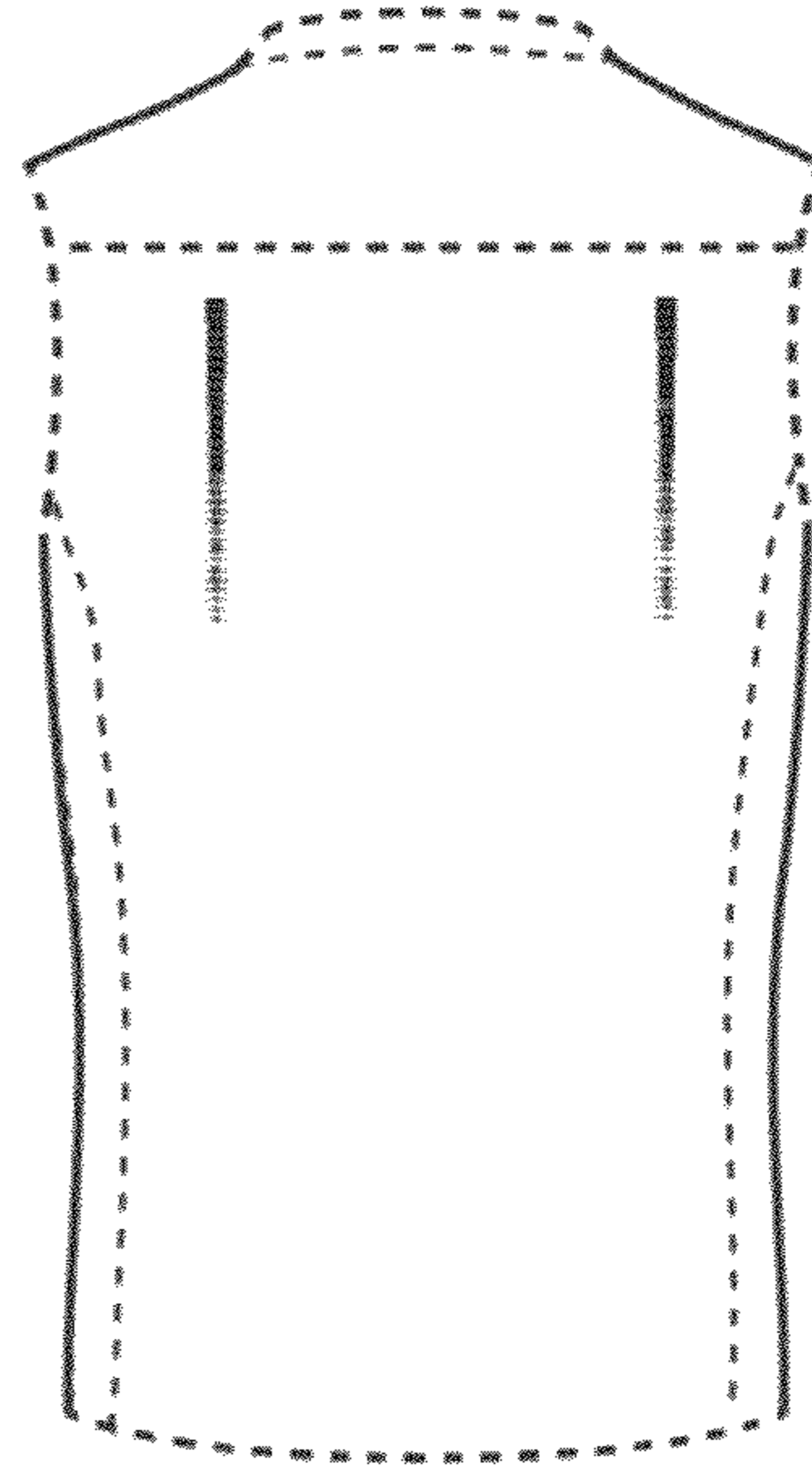

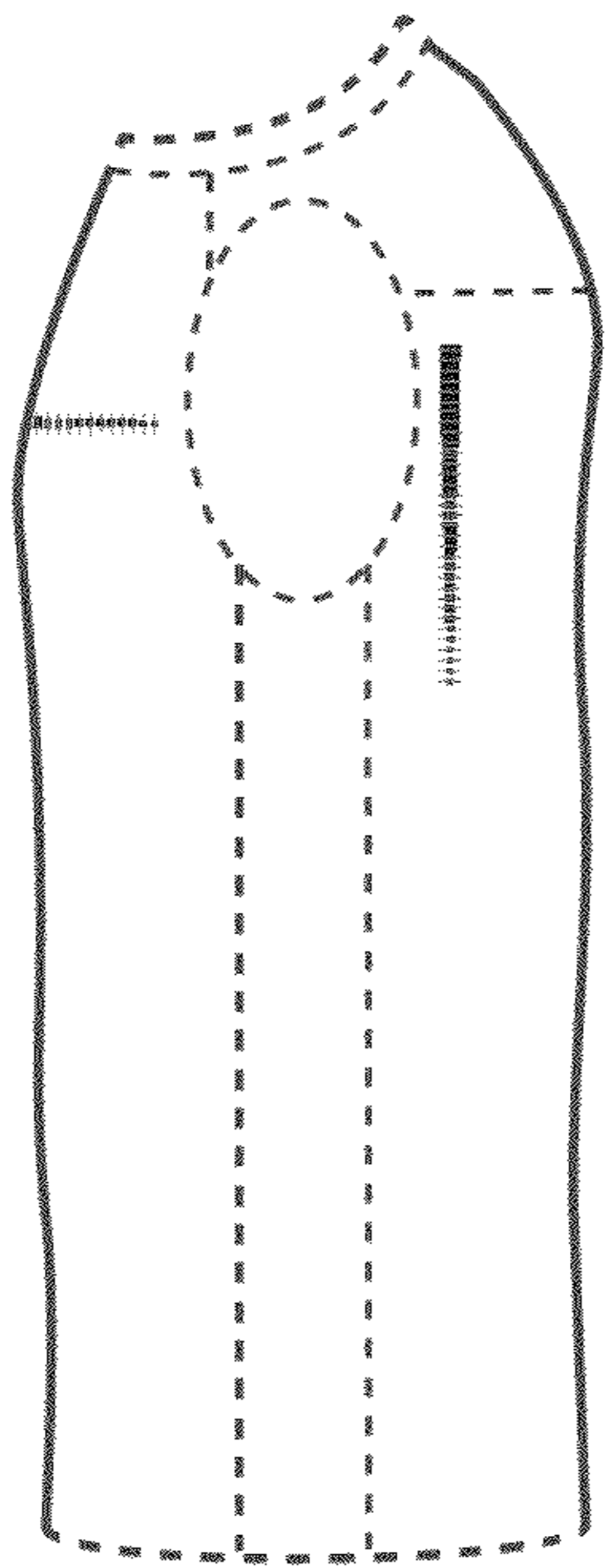

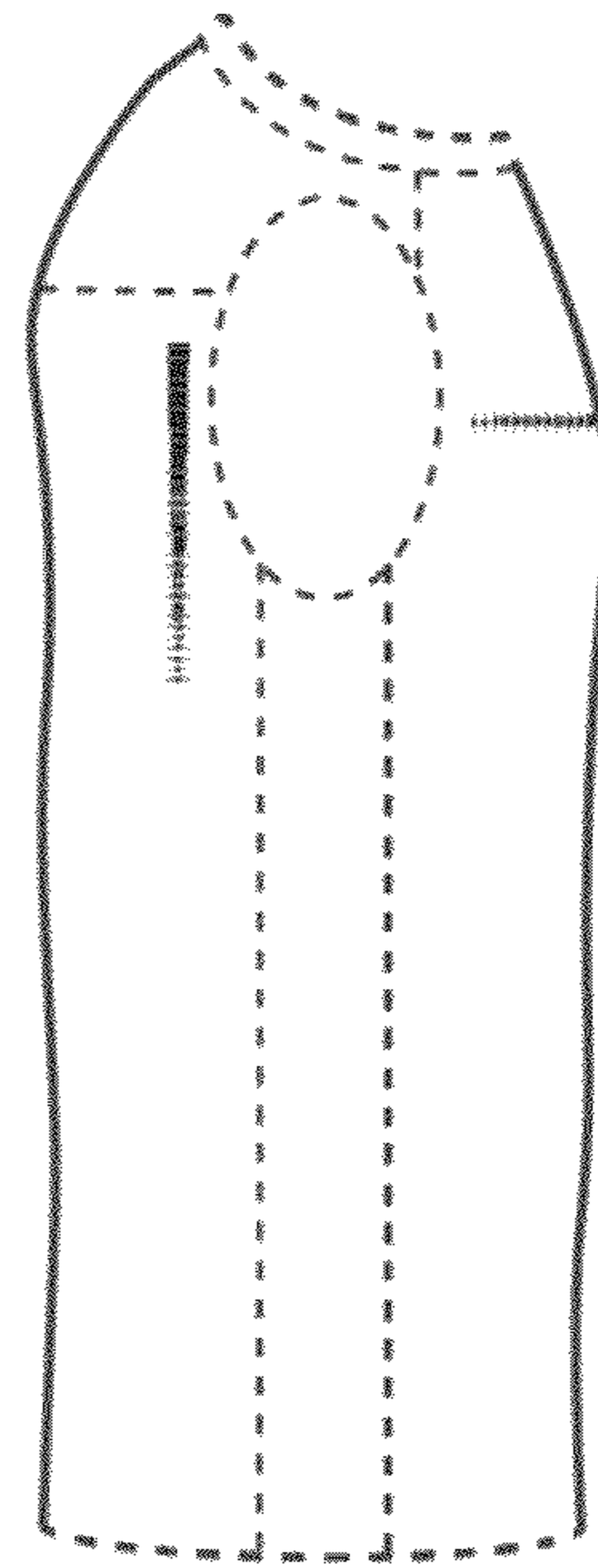

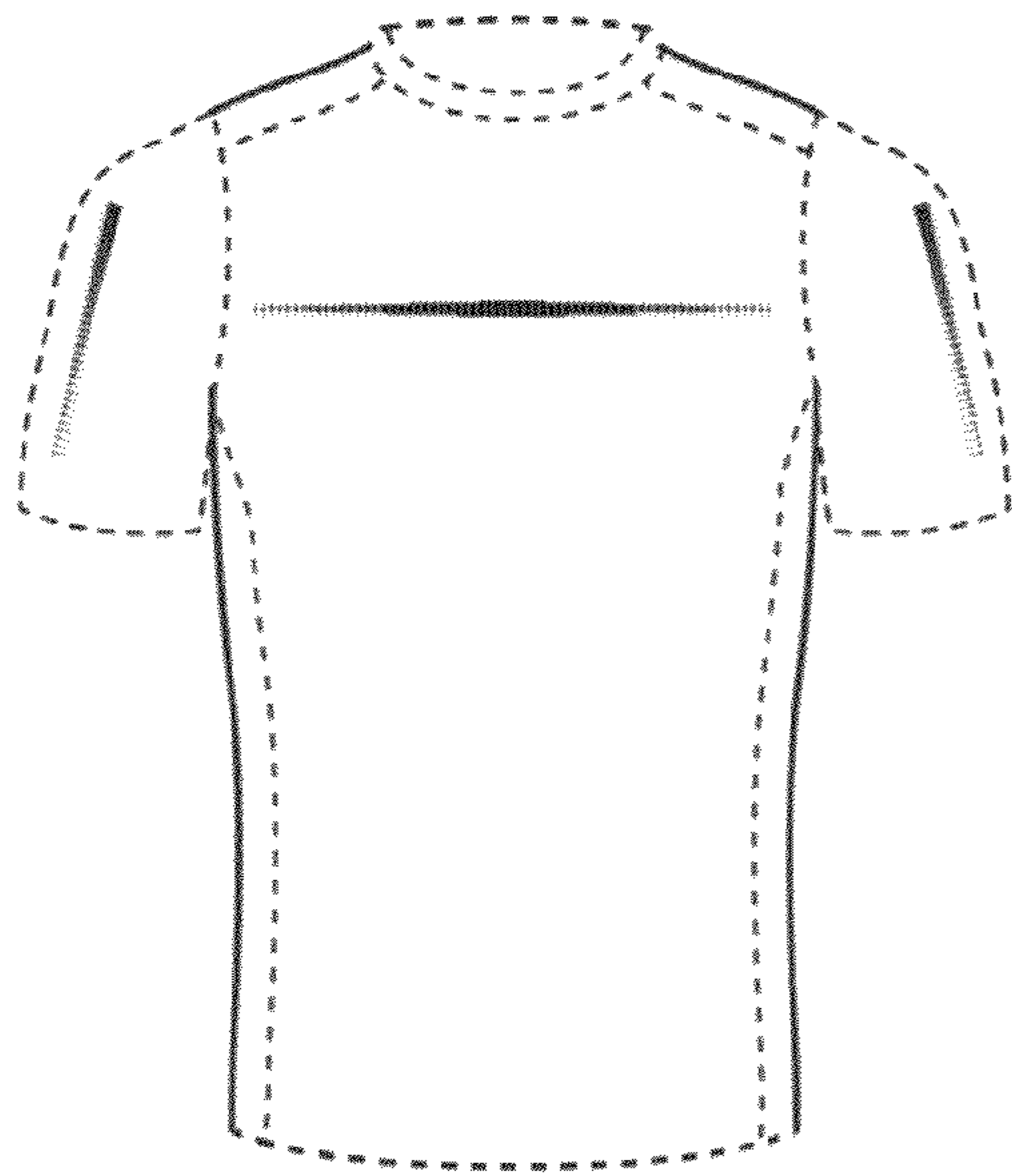

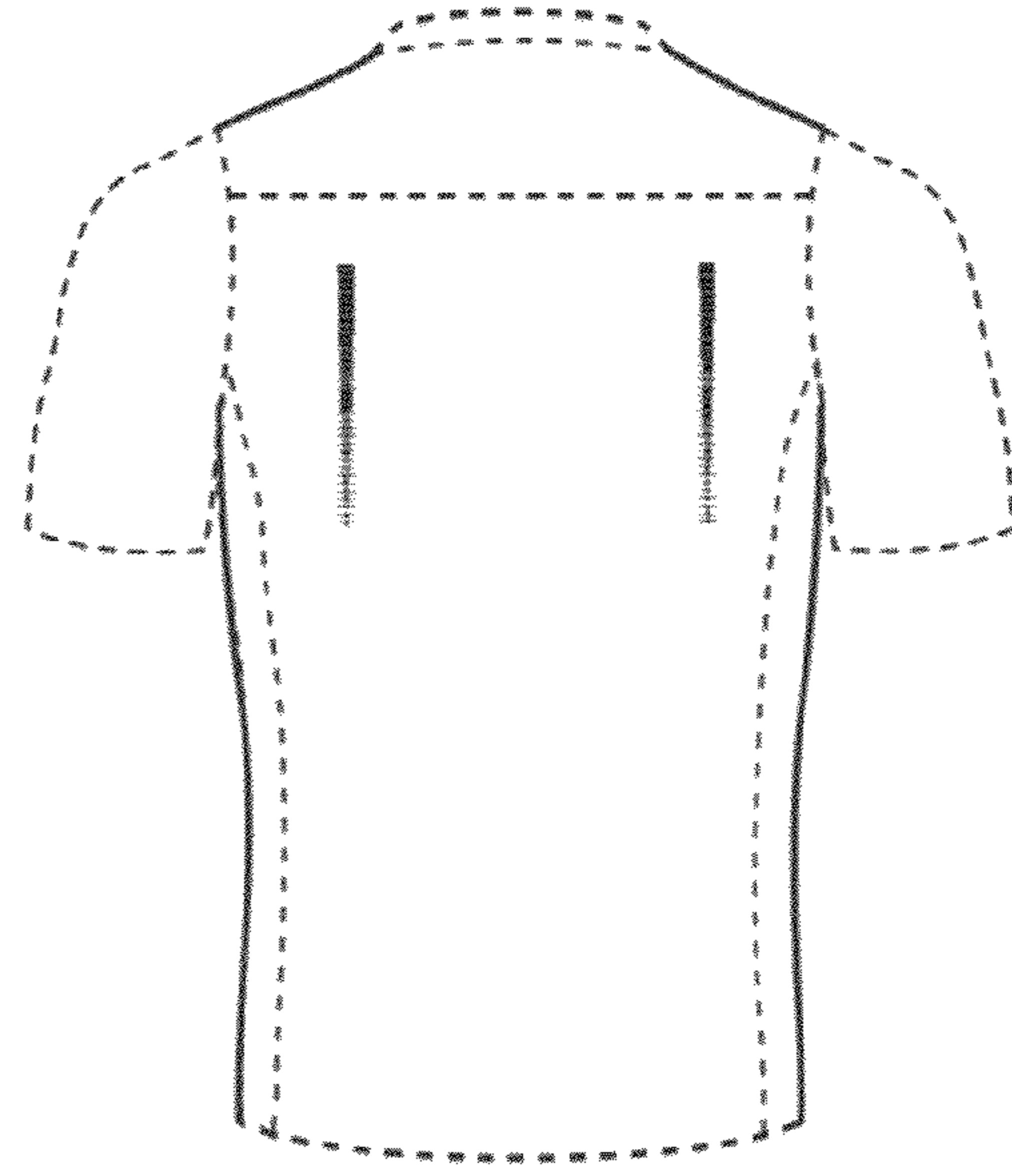
