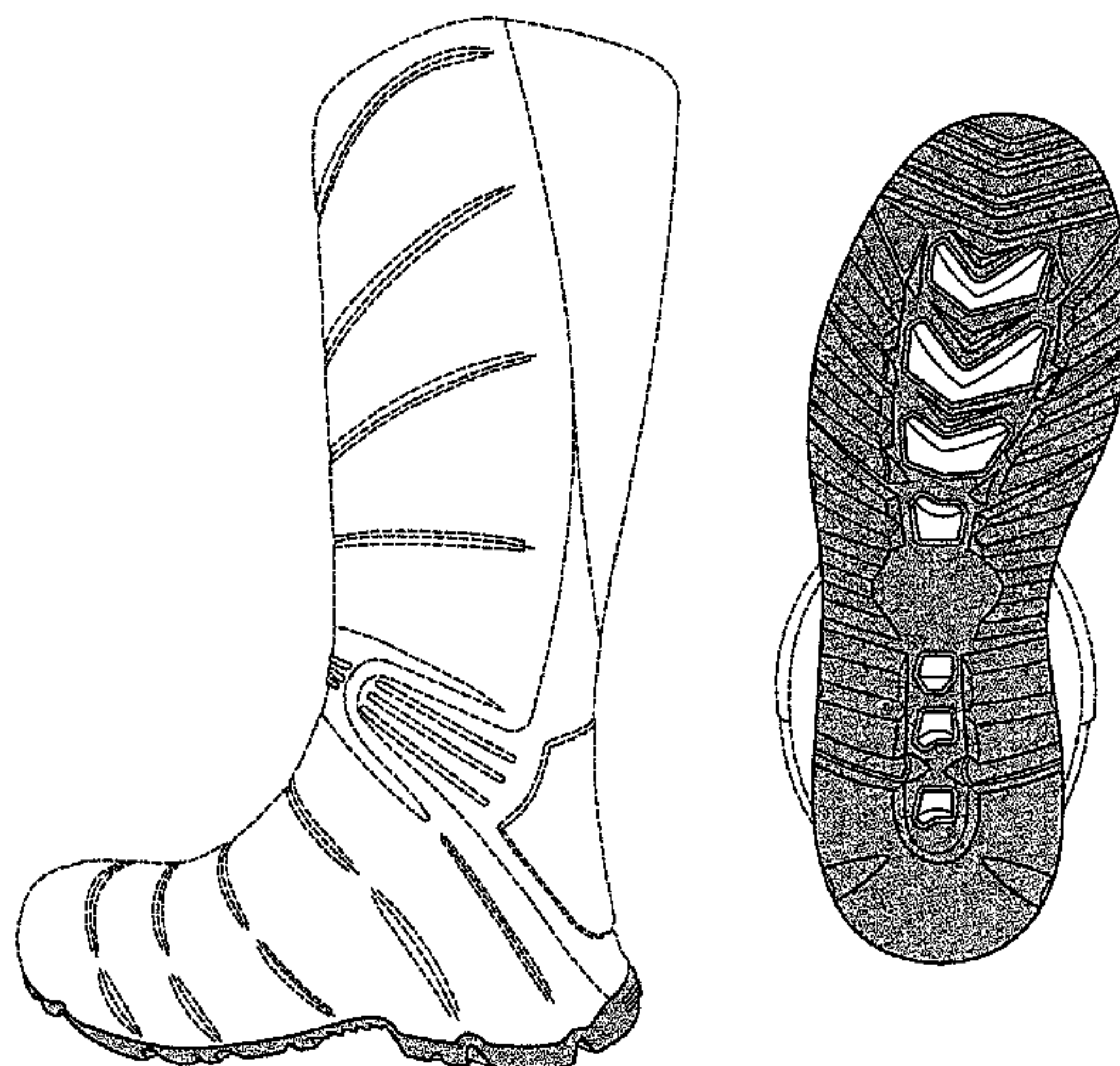
The ornamental design for a boot outsole, as shown and described.

DESCRIPTION

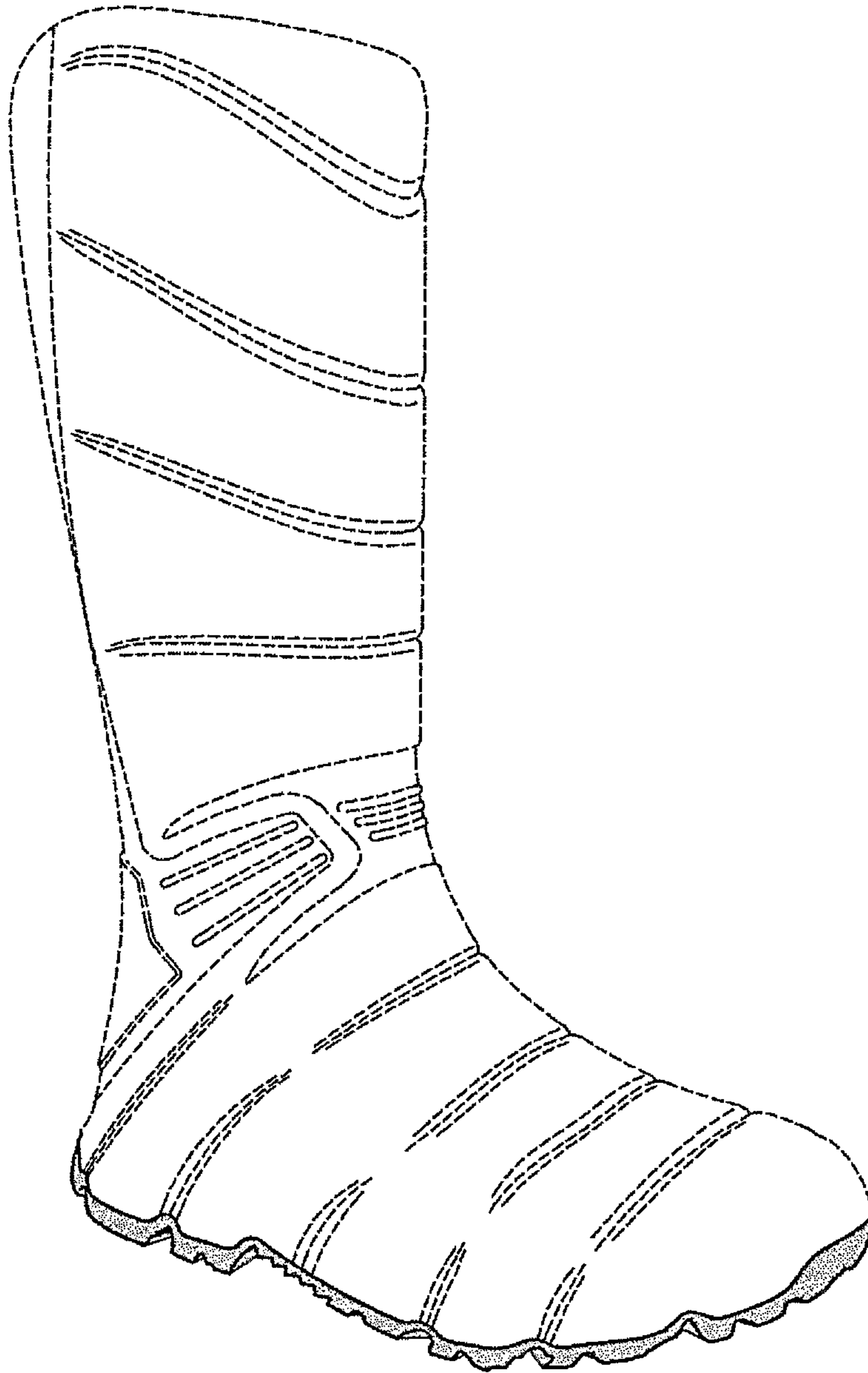

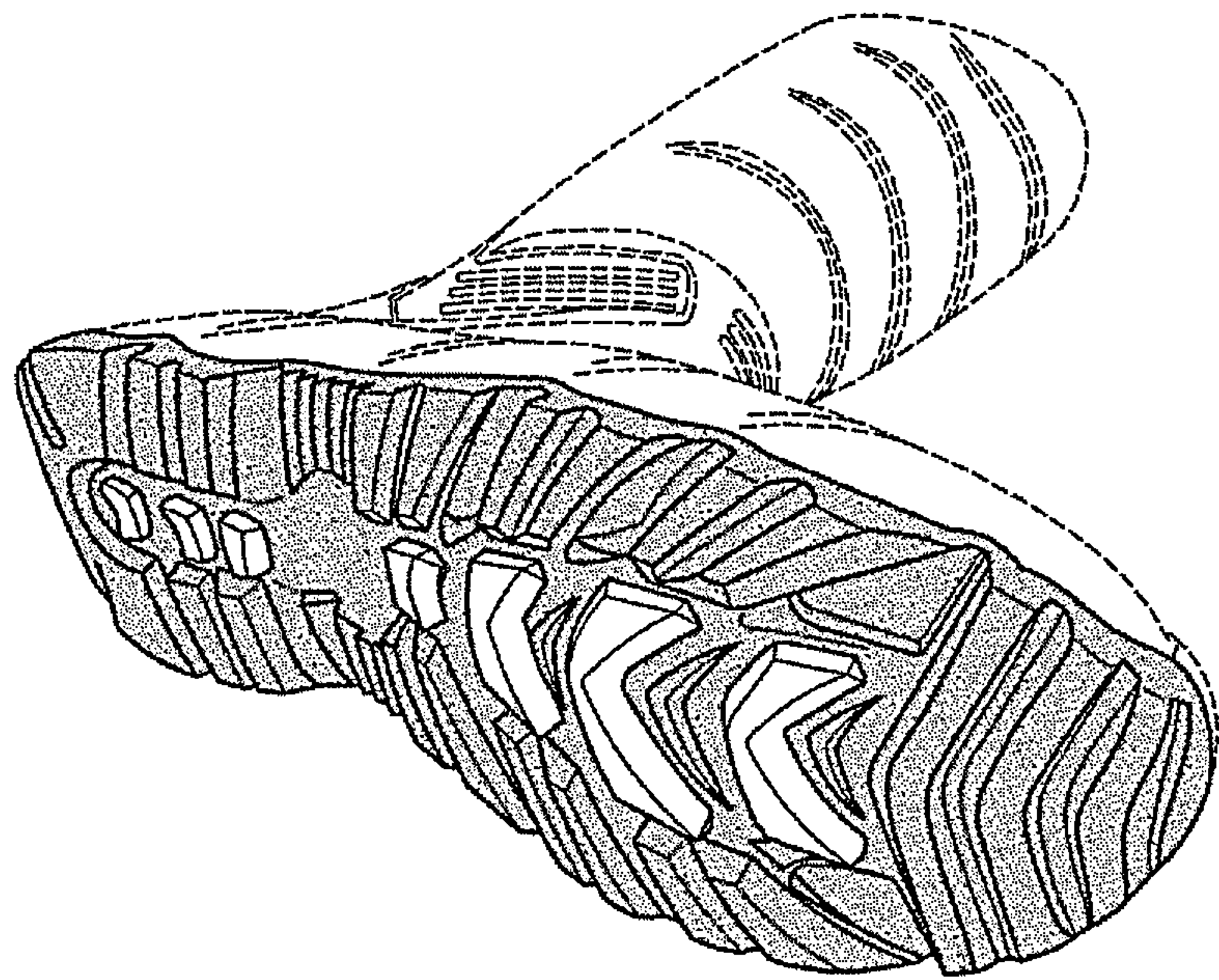

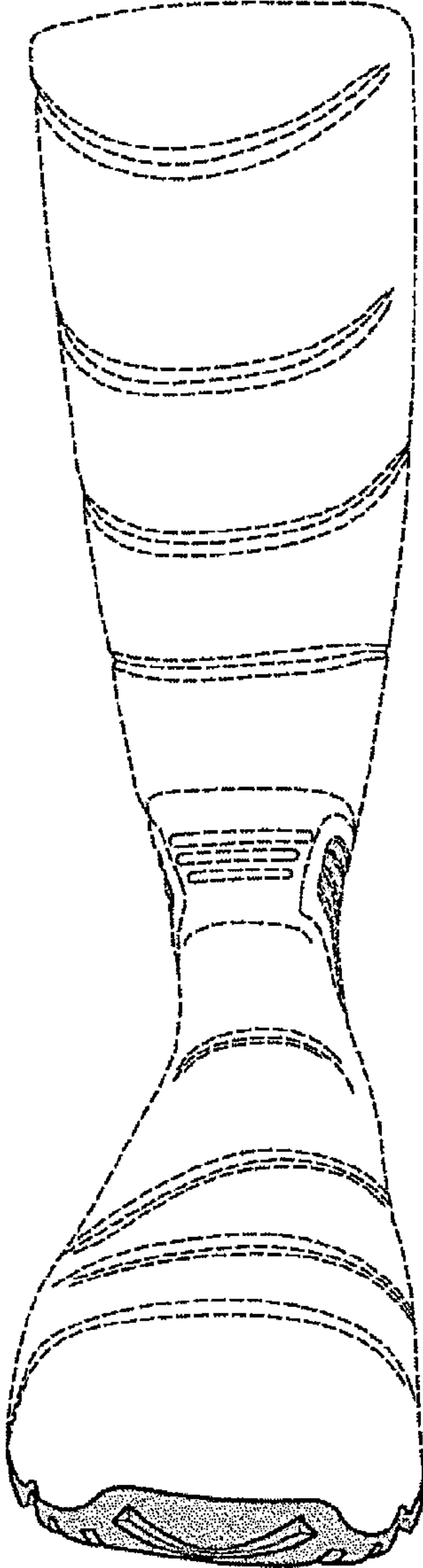

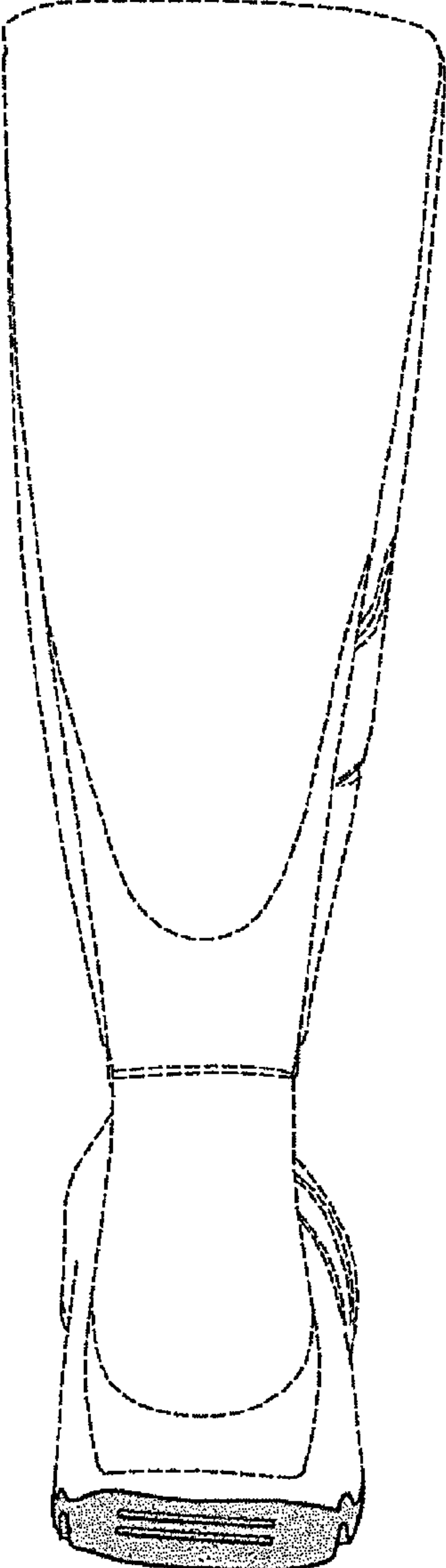

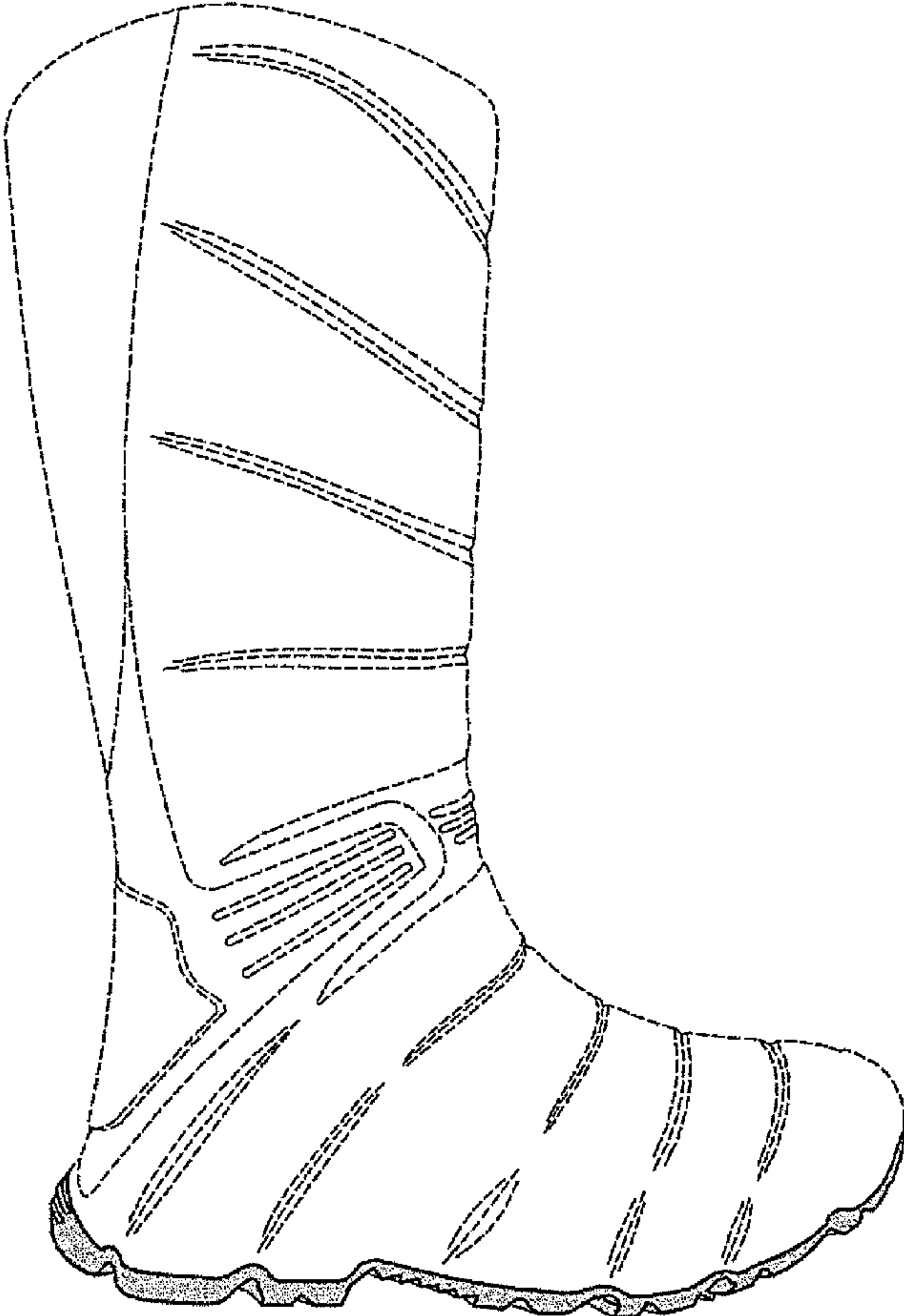

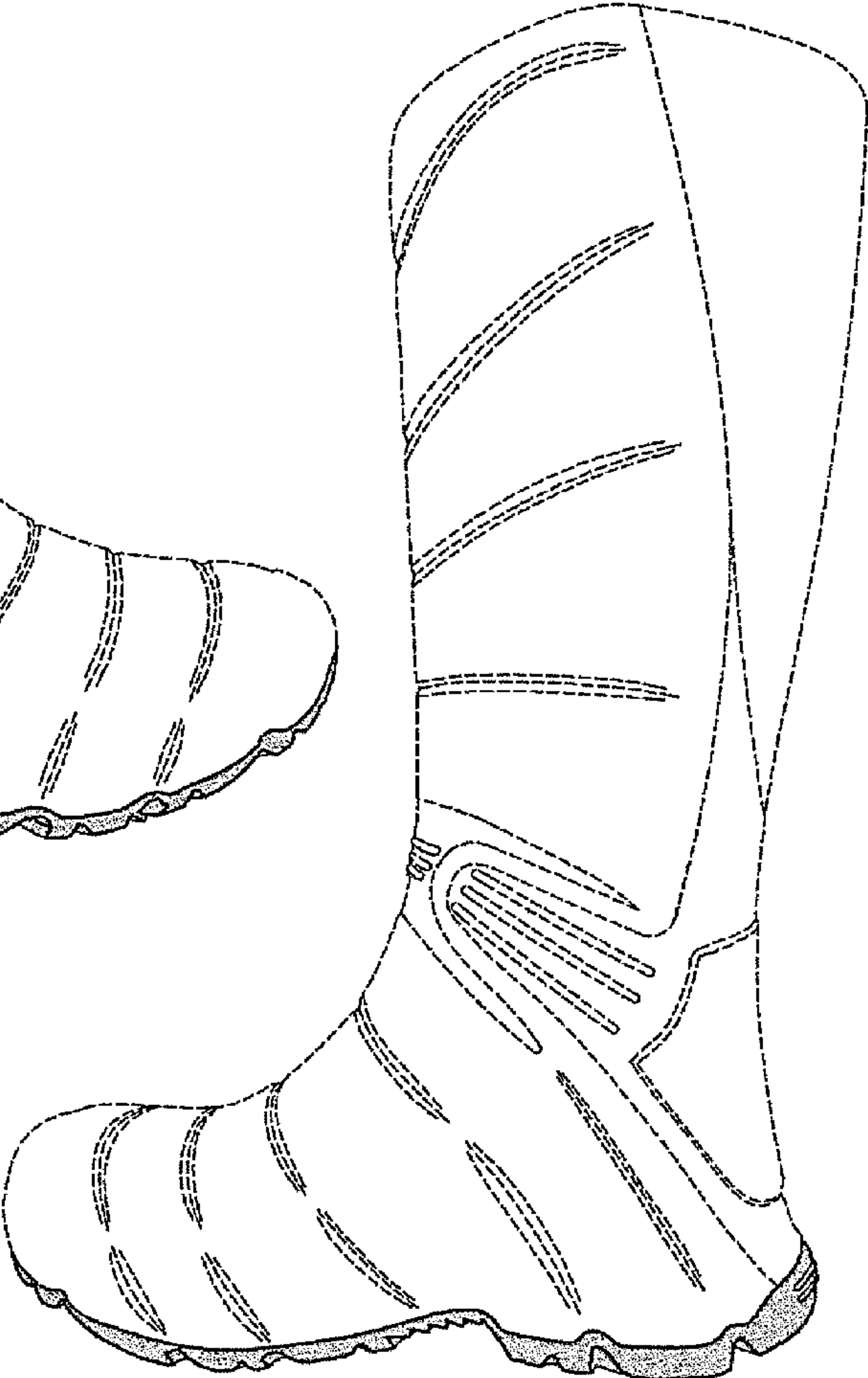

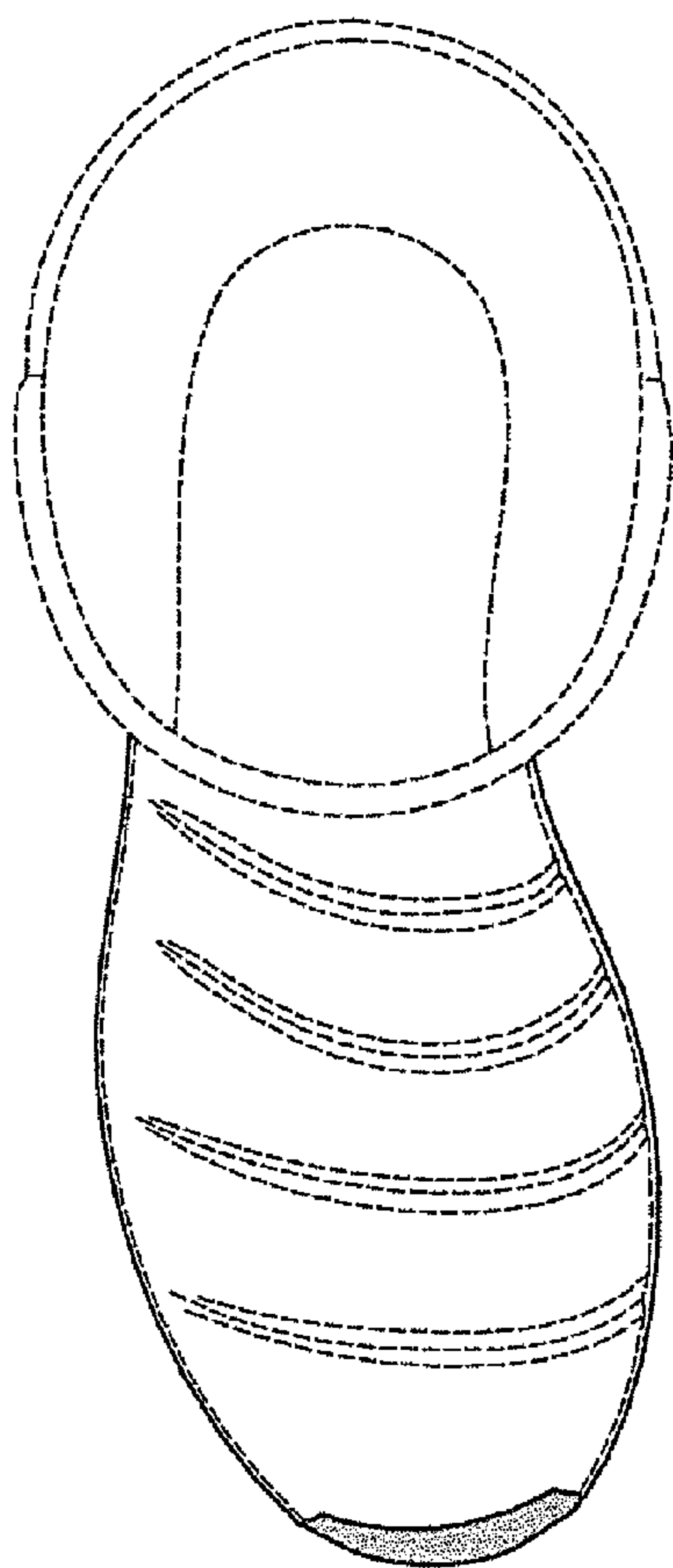

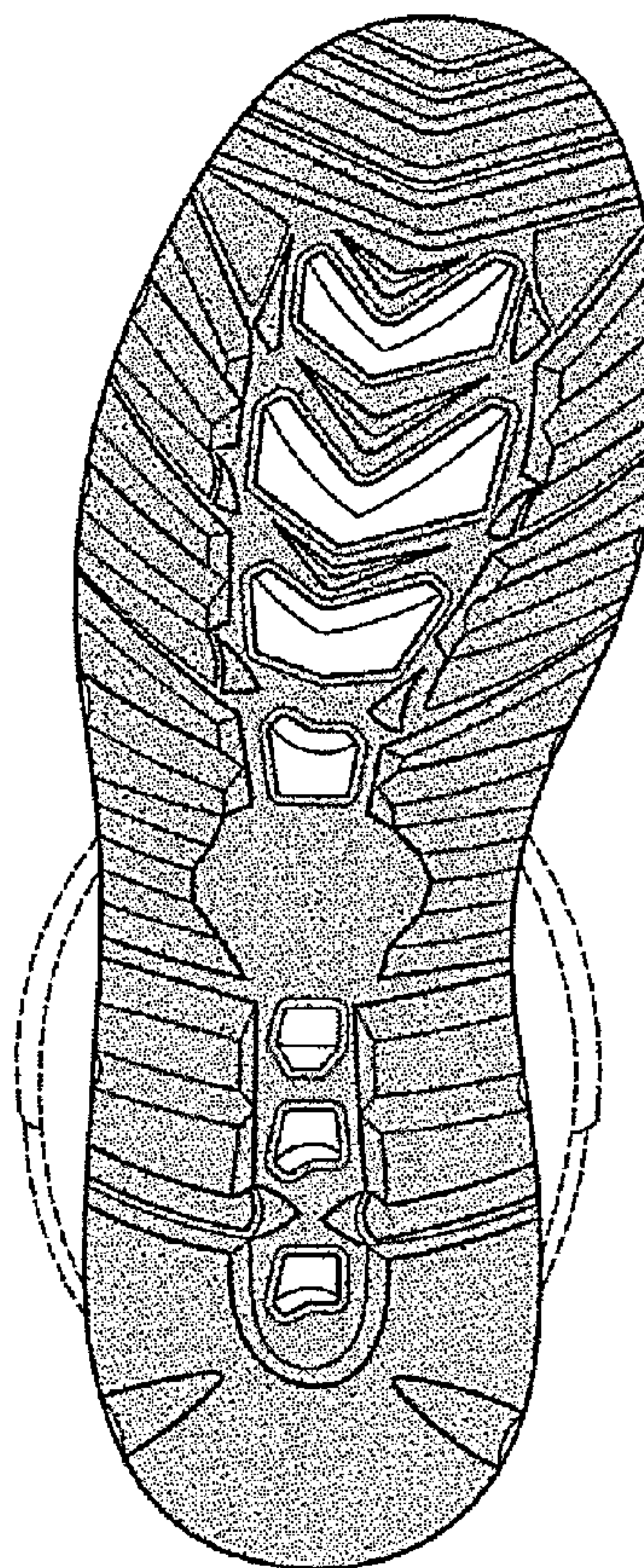

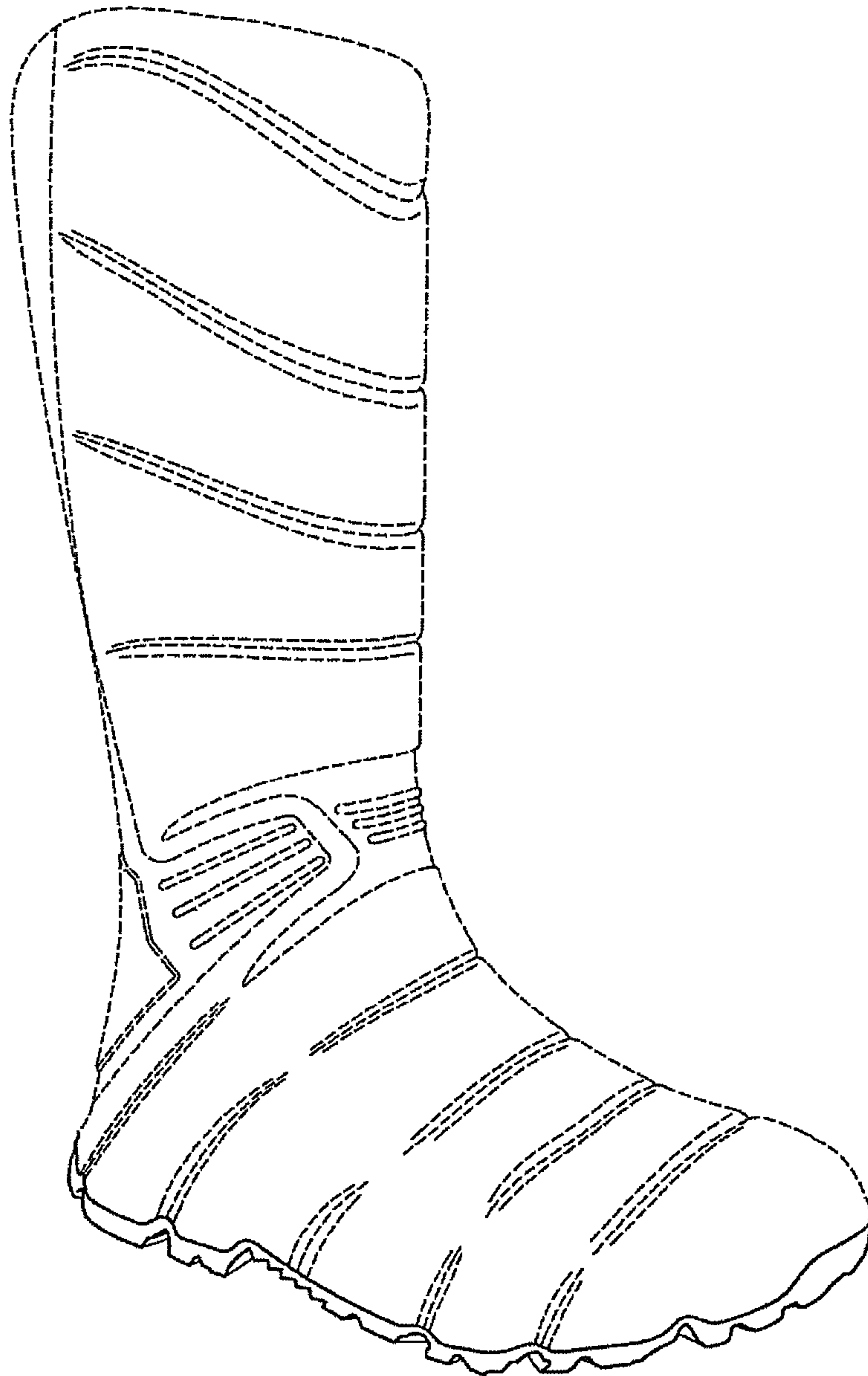

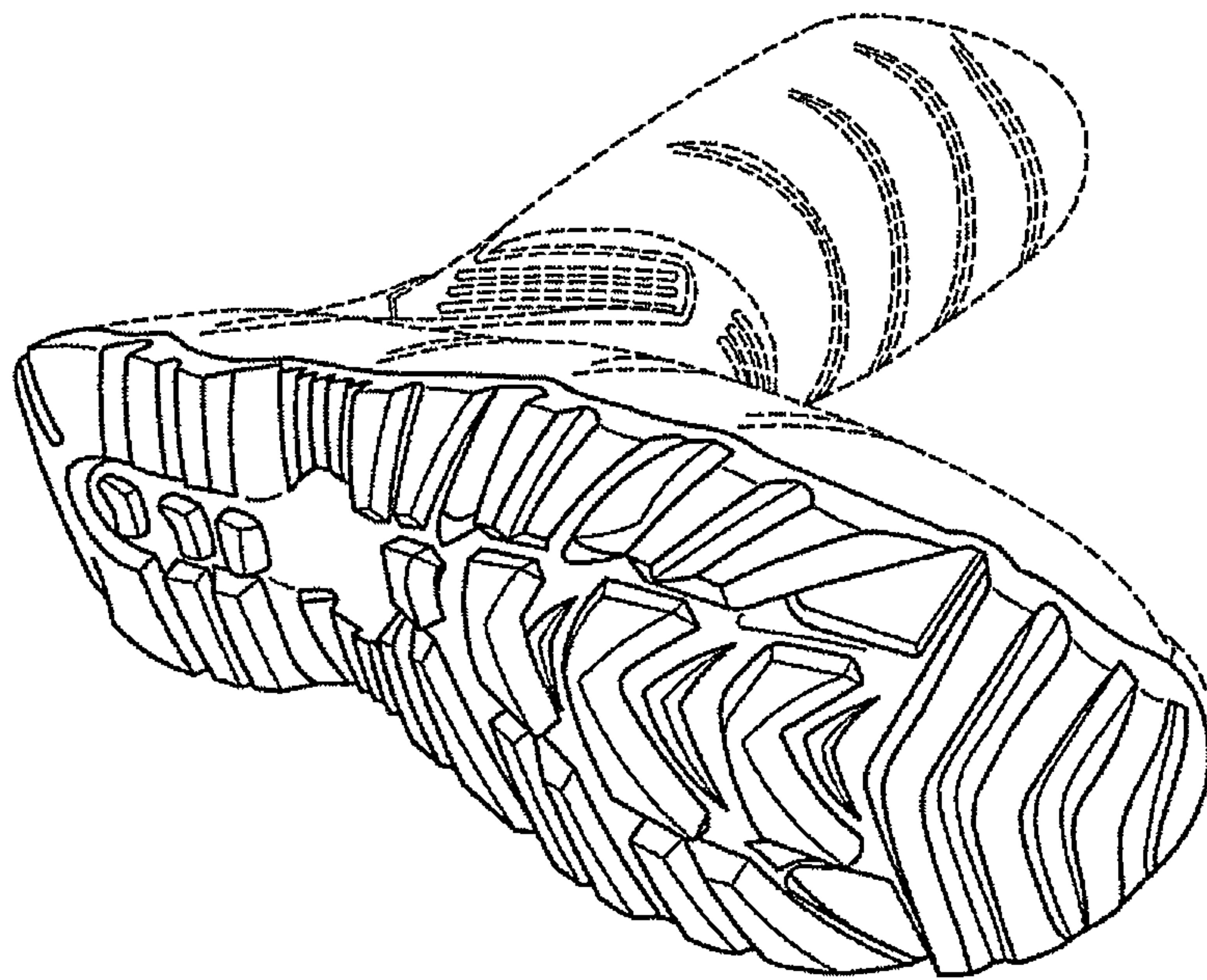

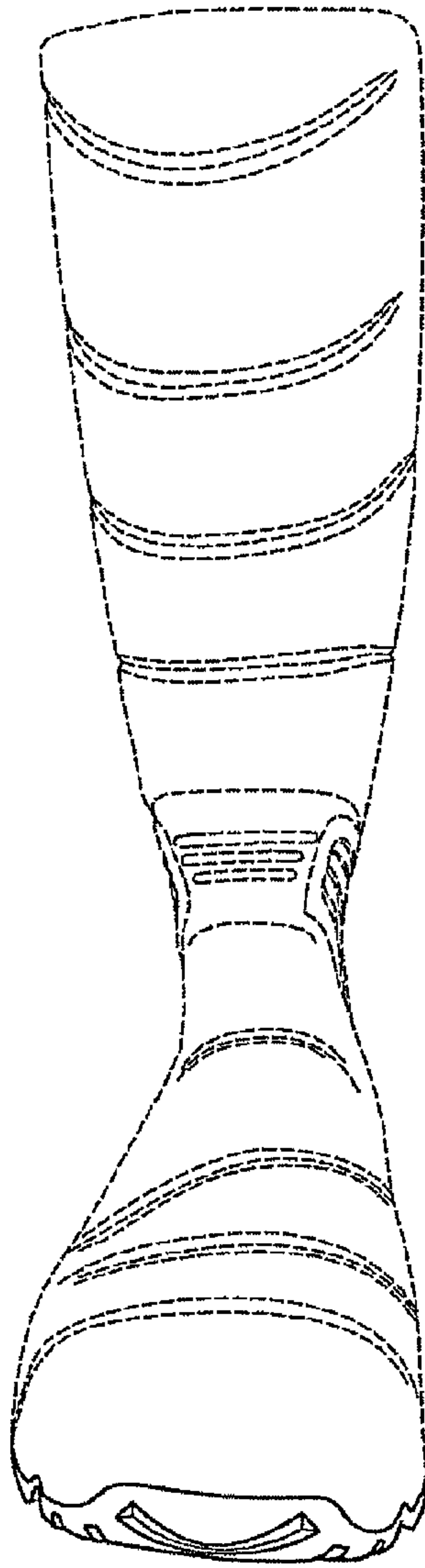

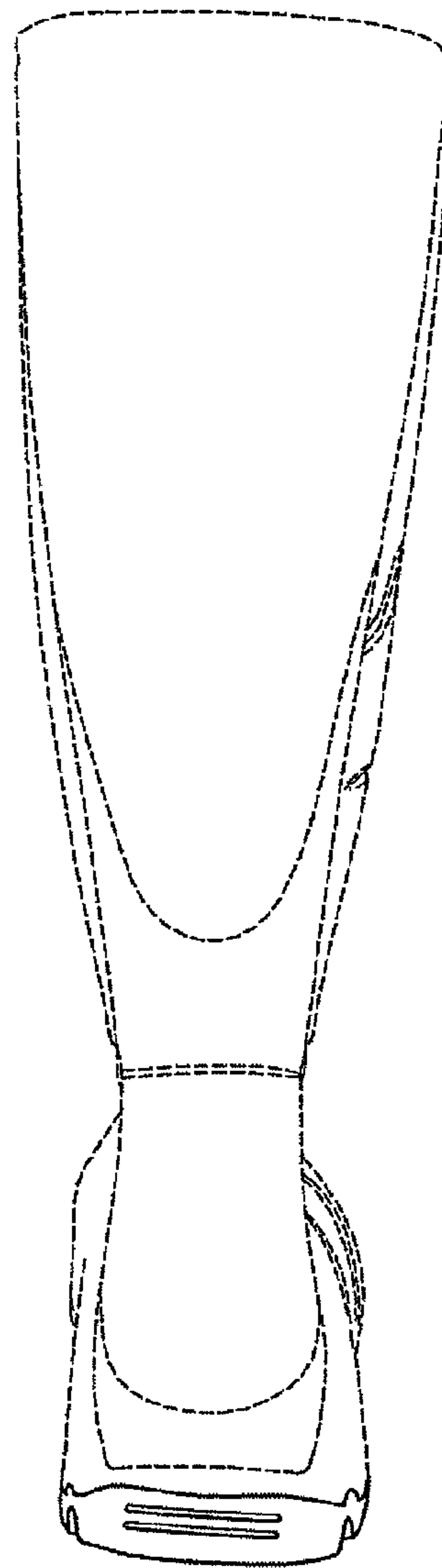

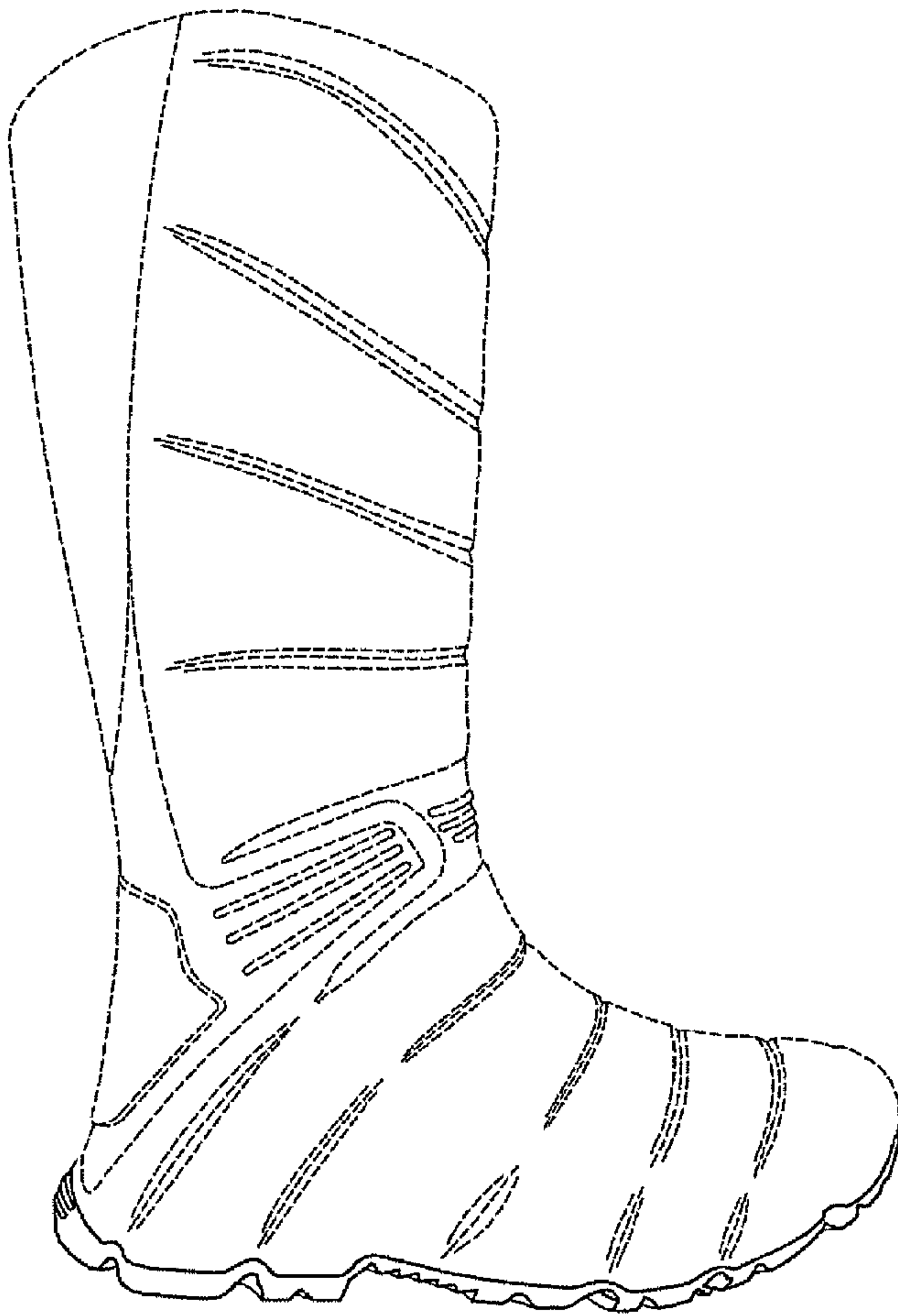

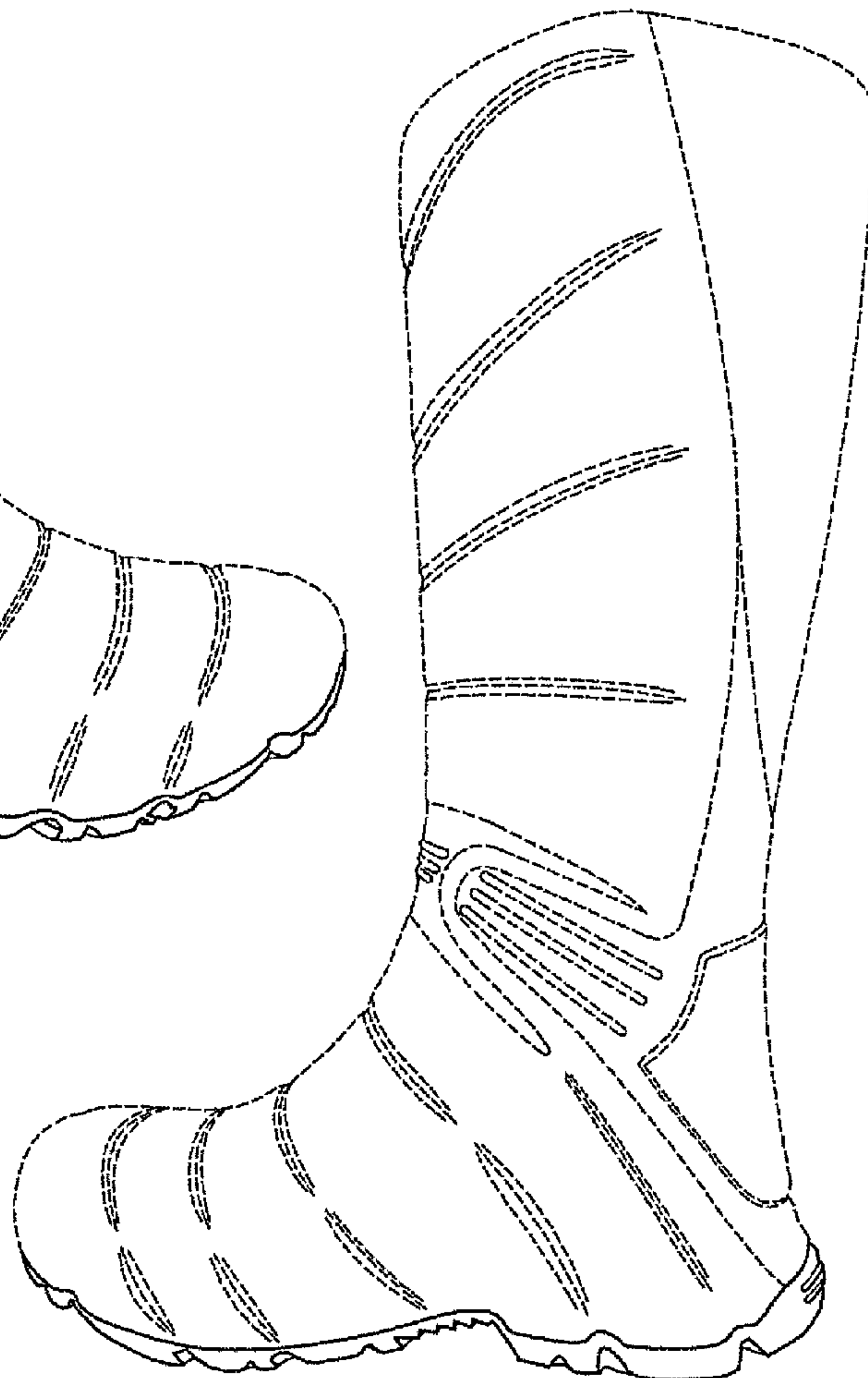

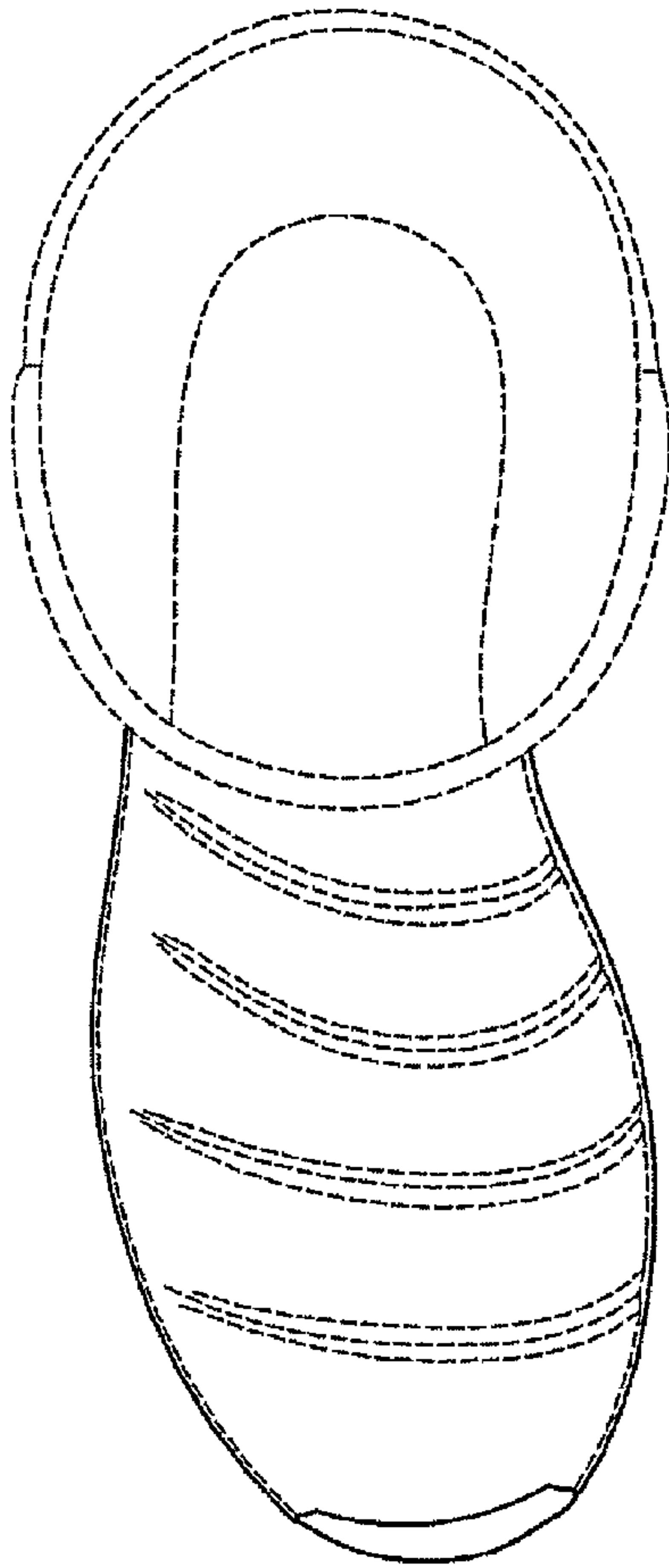

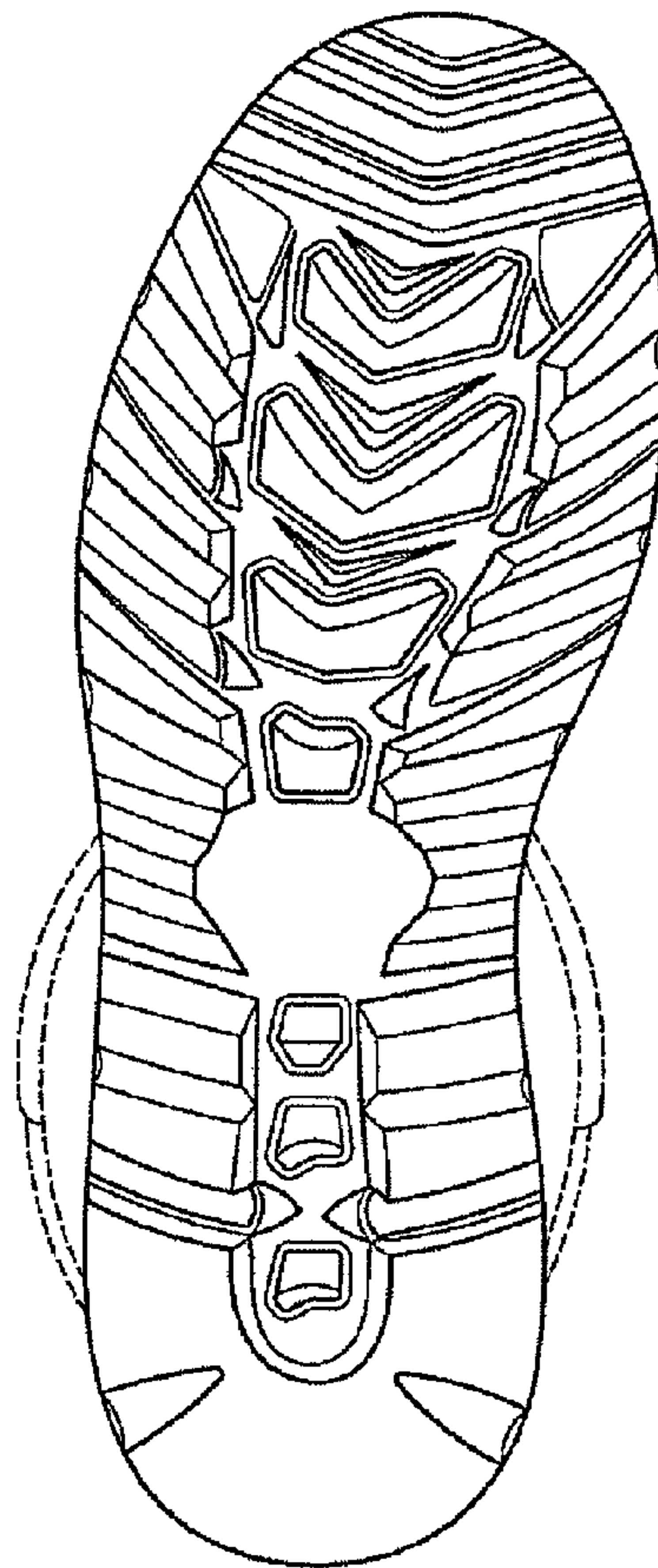
