FIG. 6 is a left view thereof;

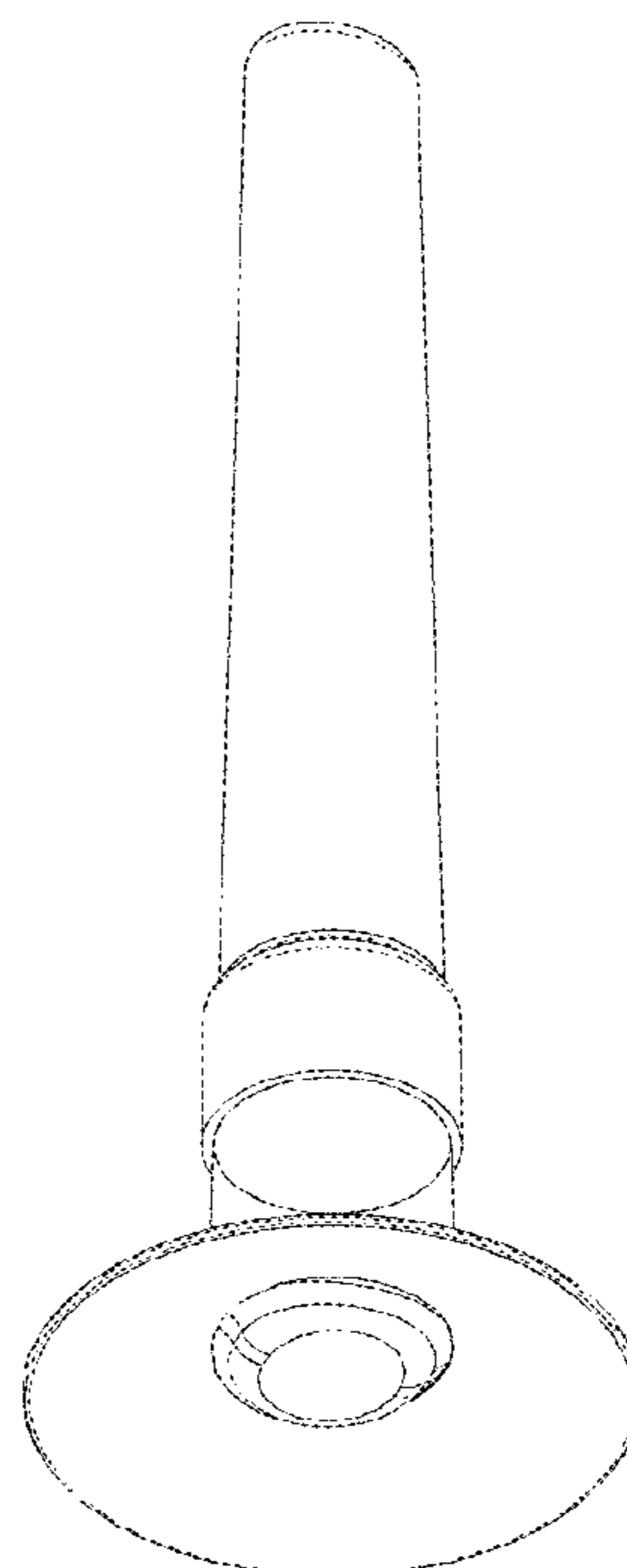
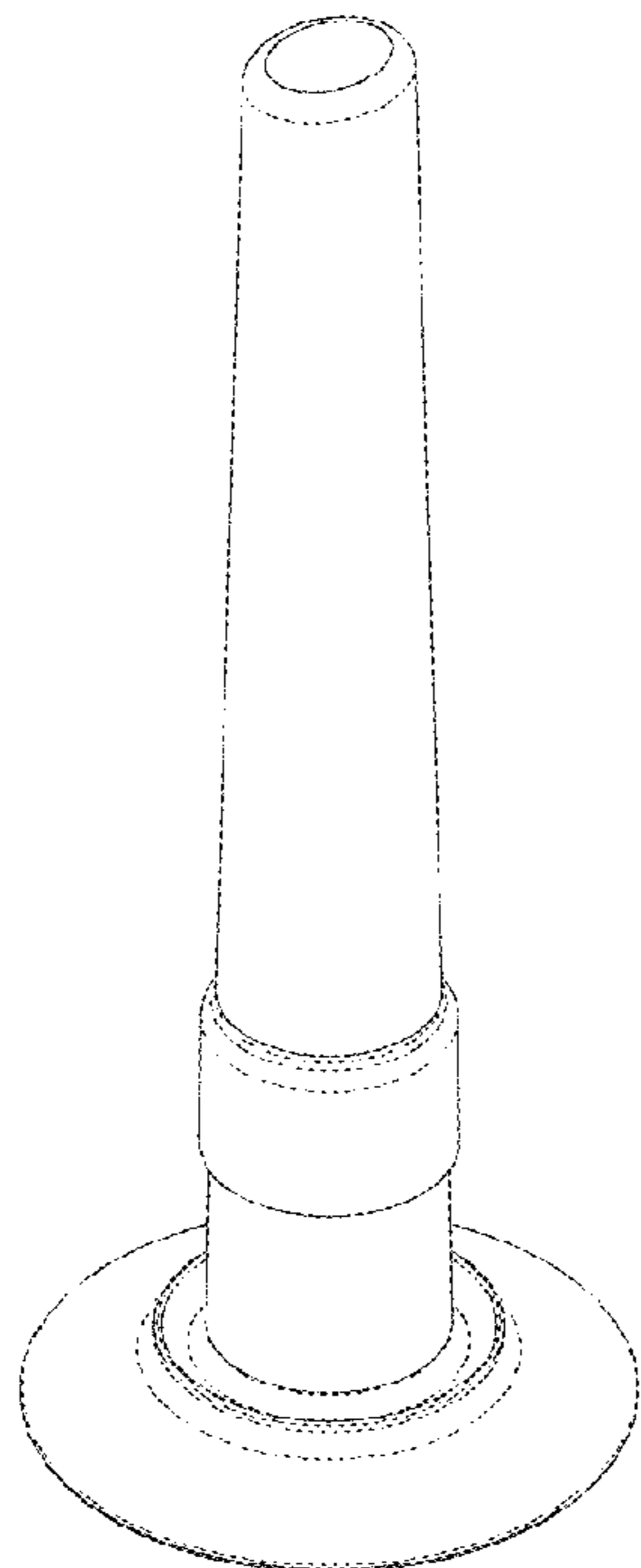
FIG. 7 is a top view thereof;

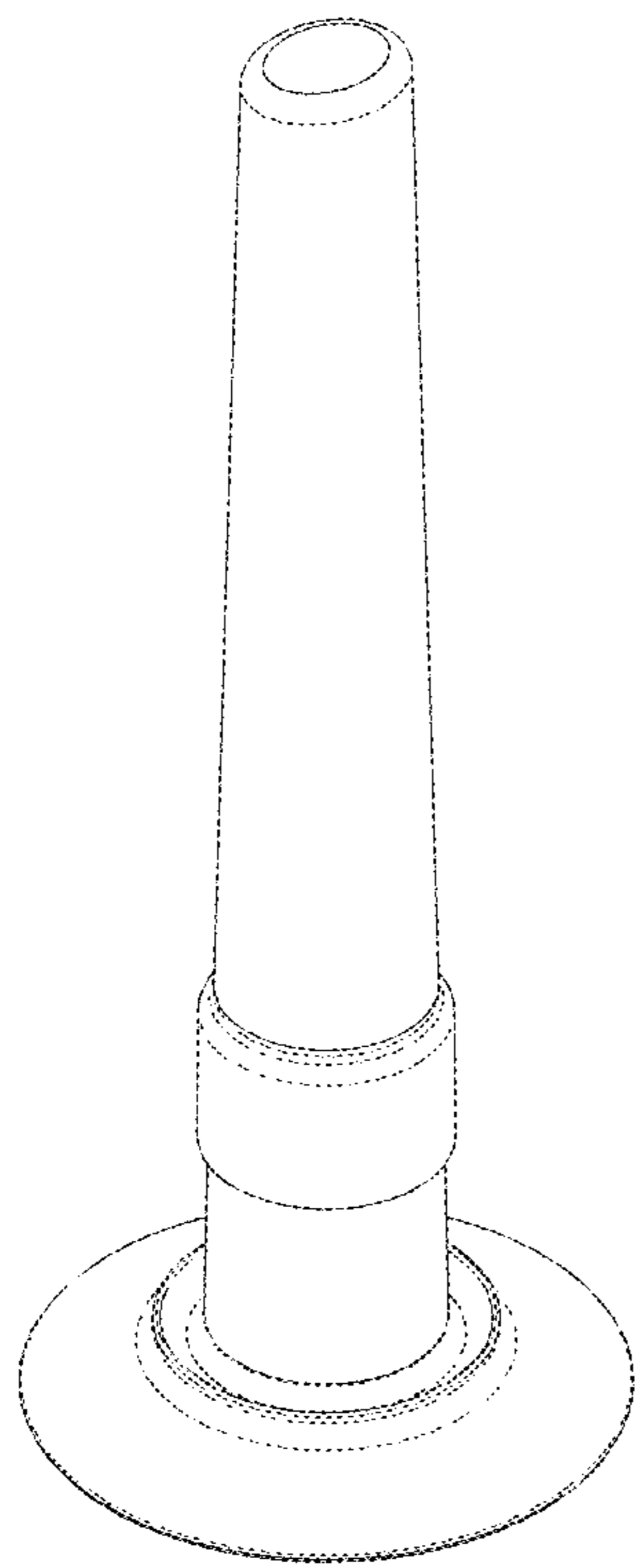

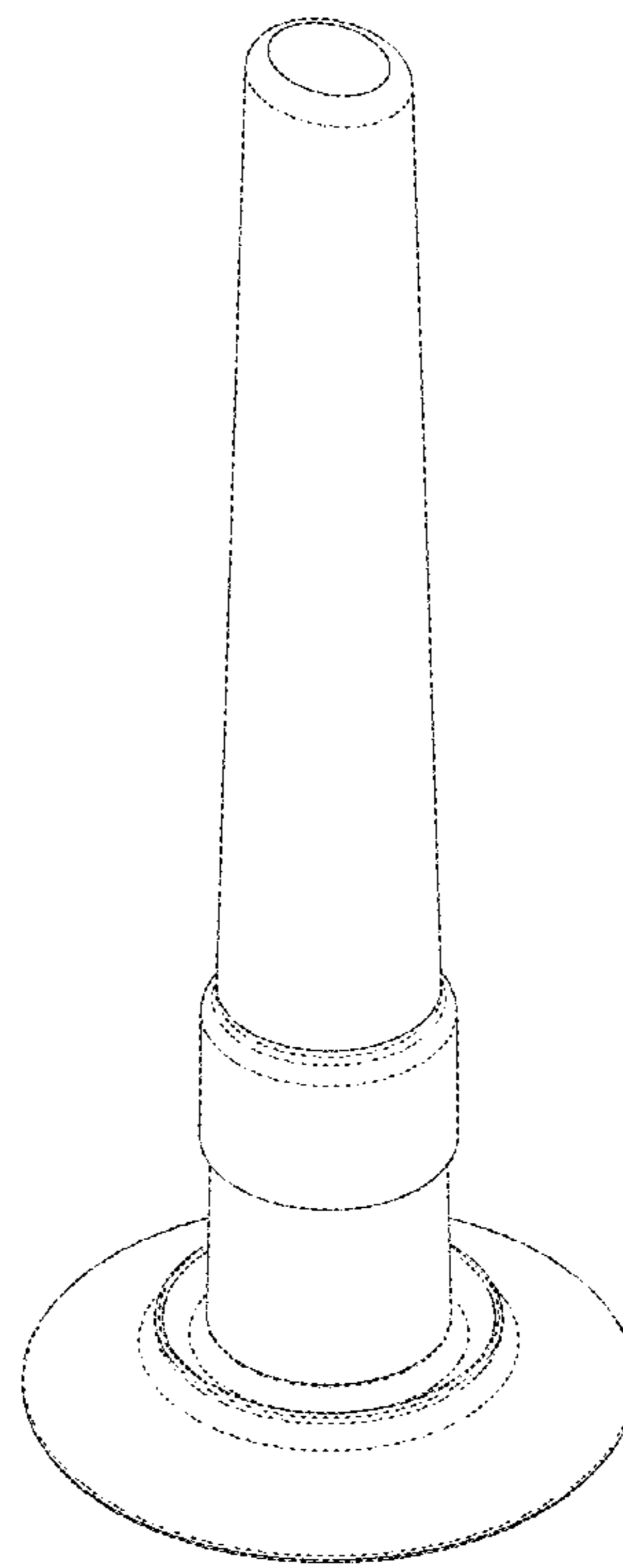

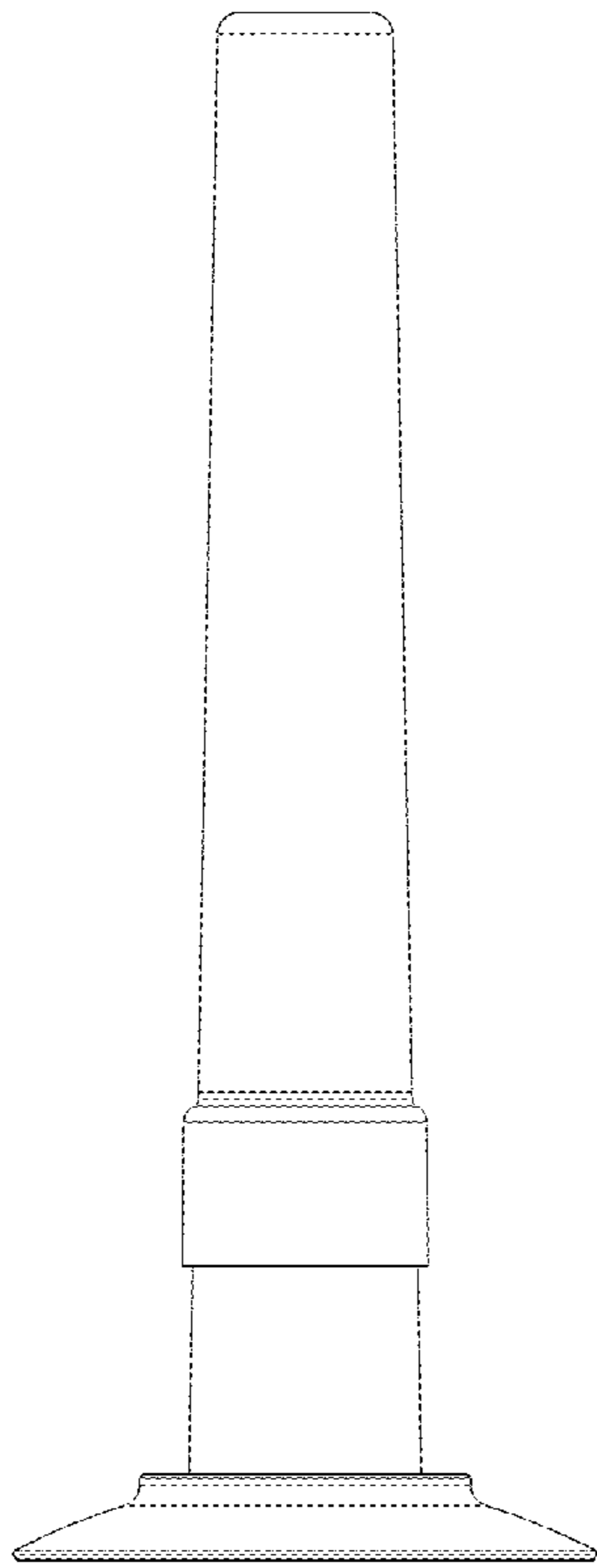

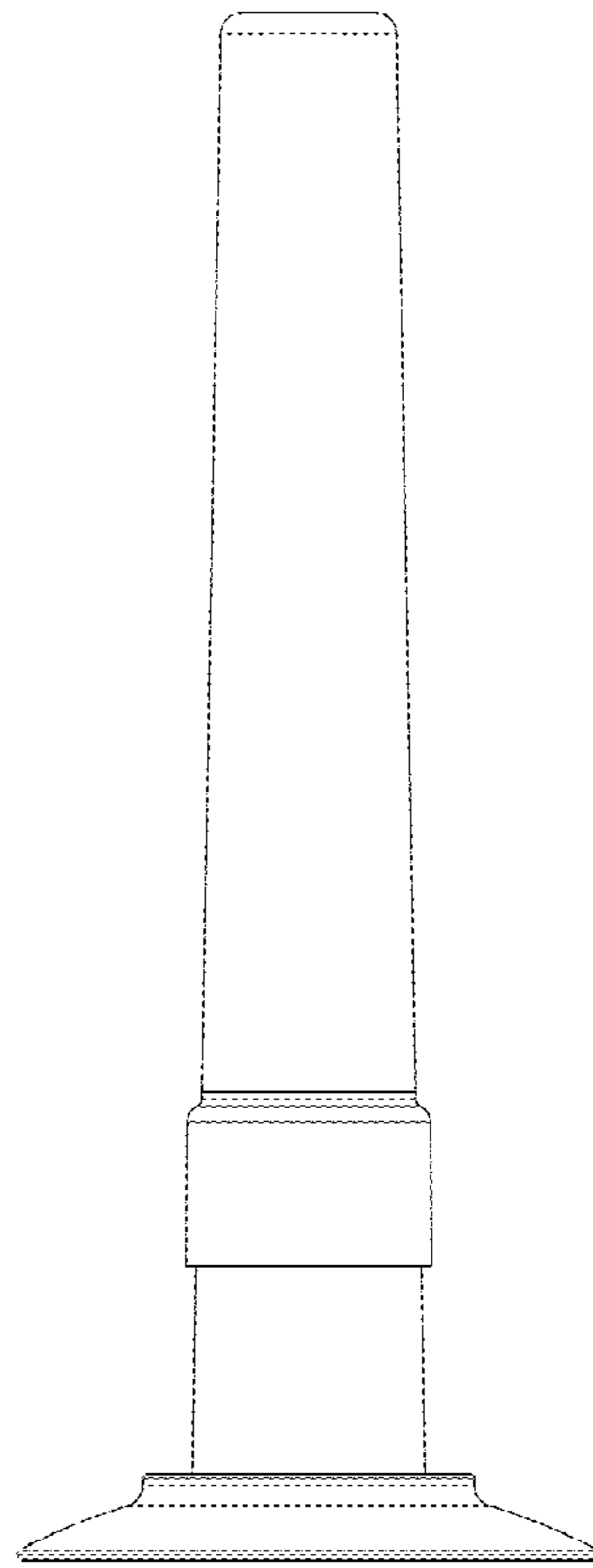

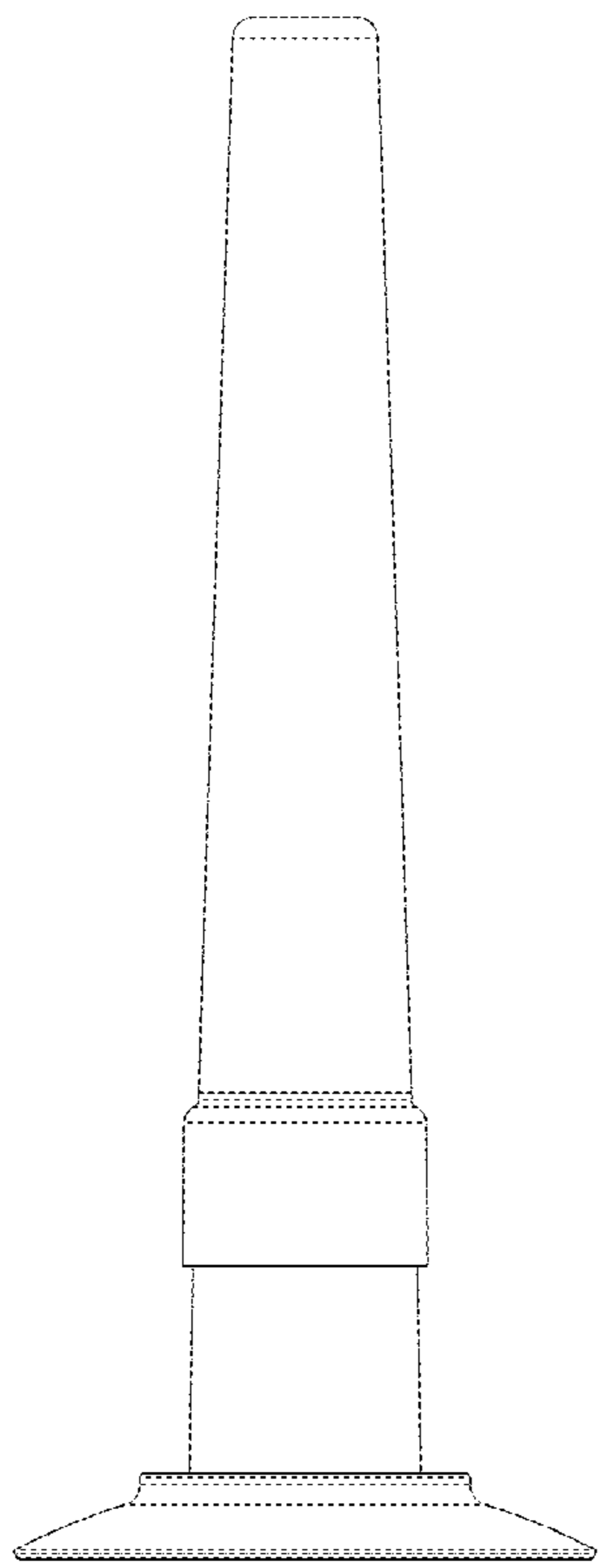

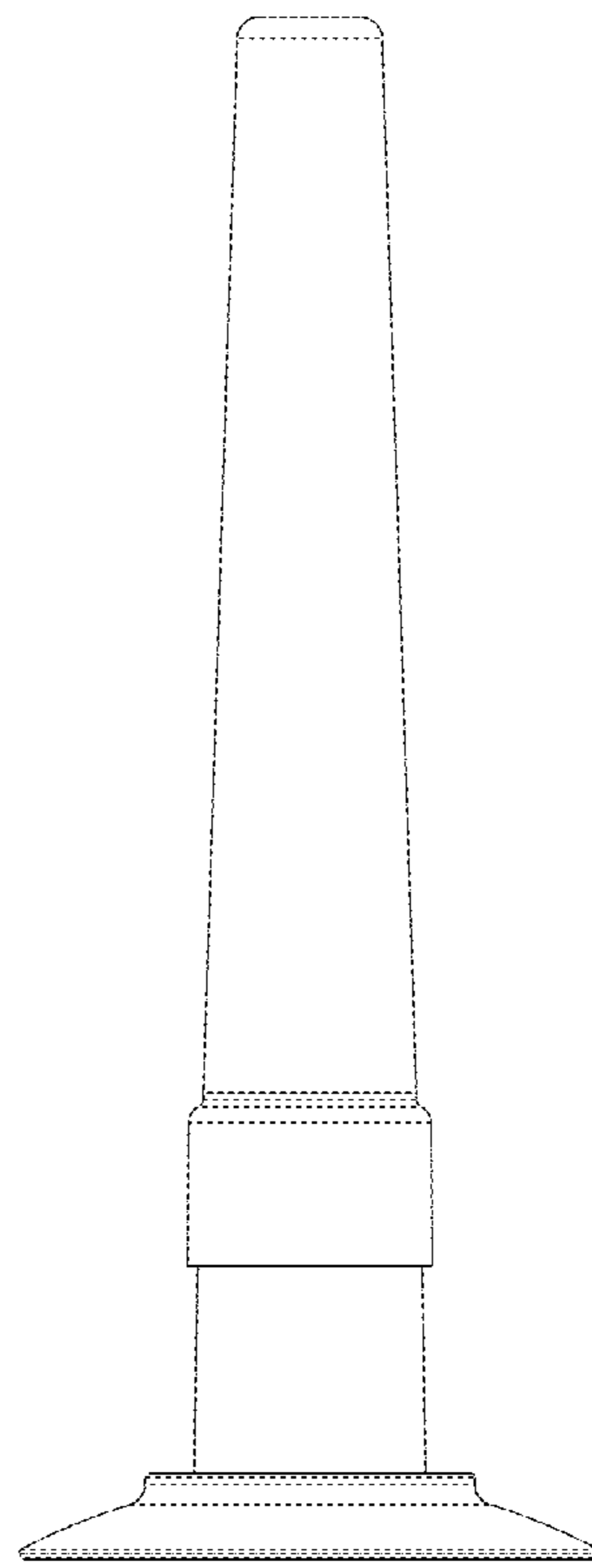

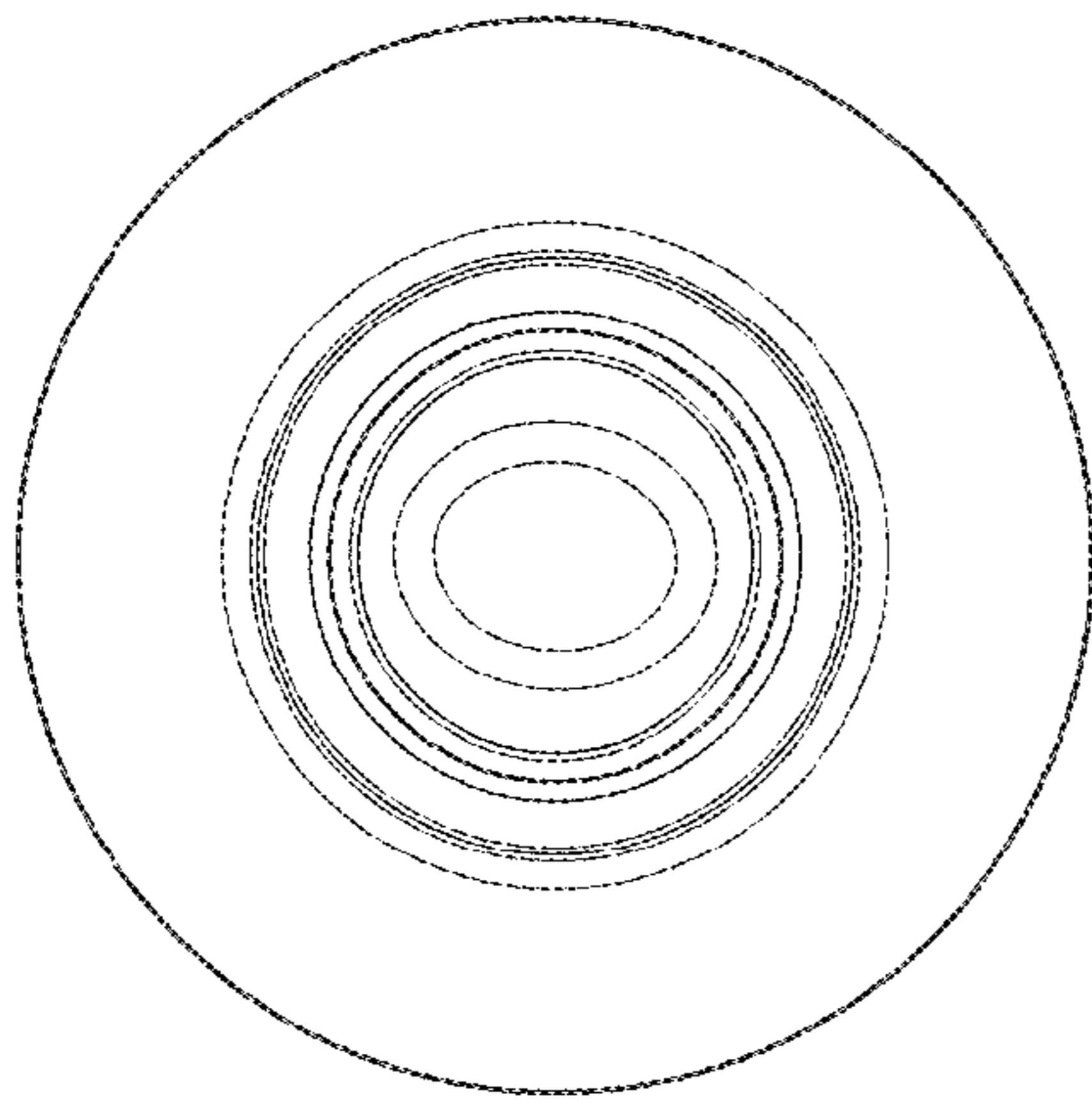

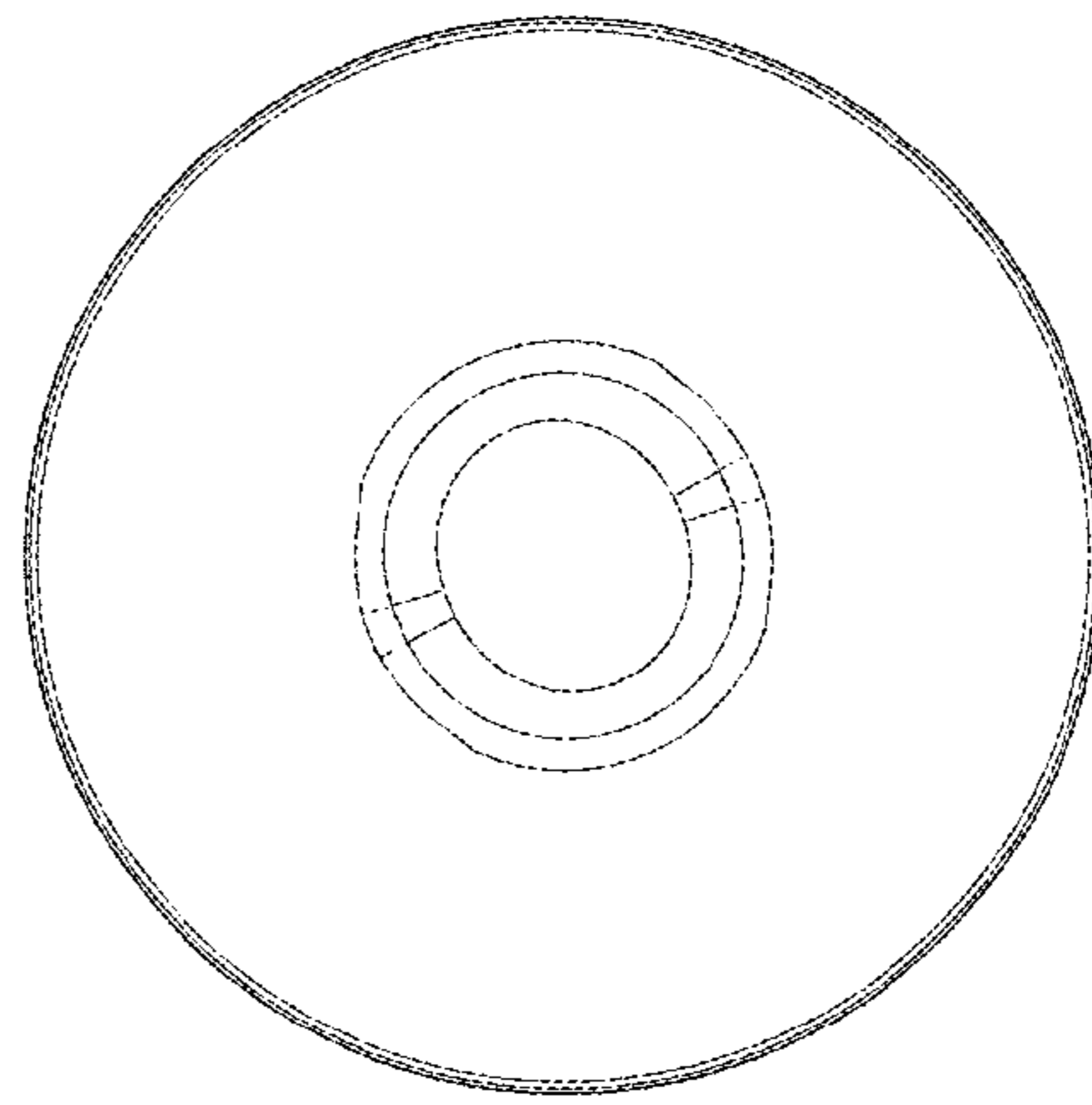

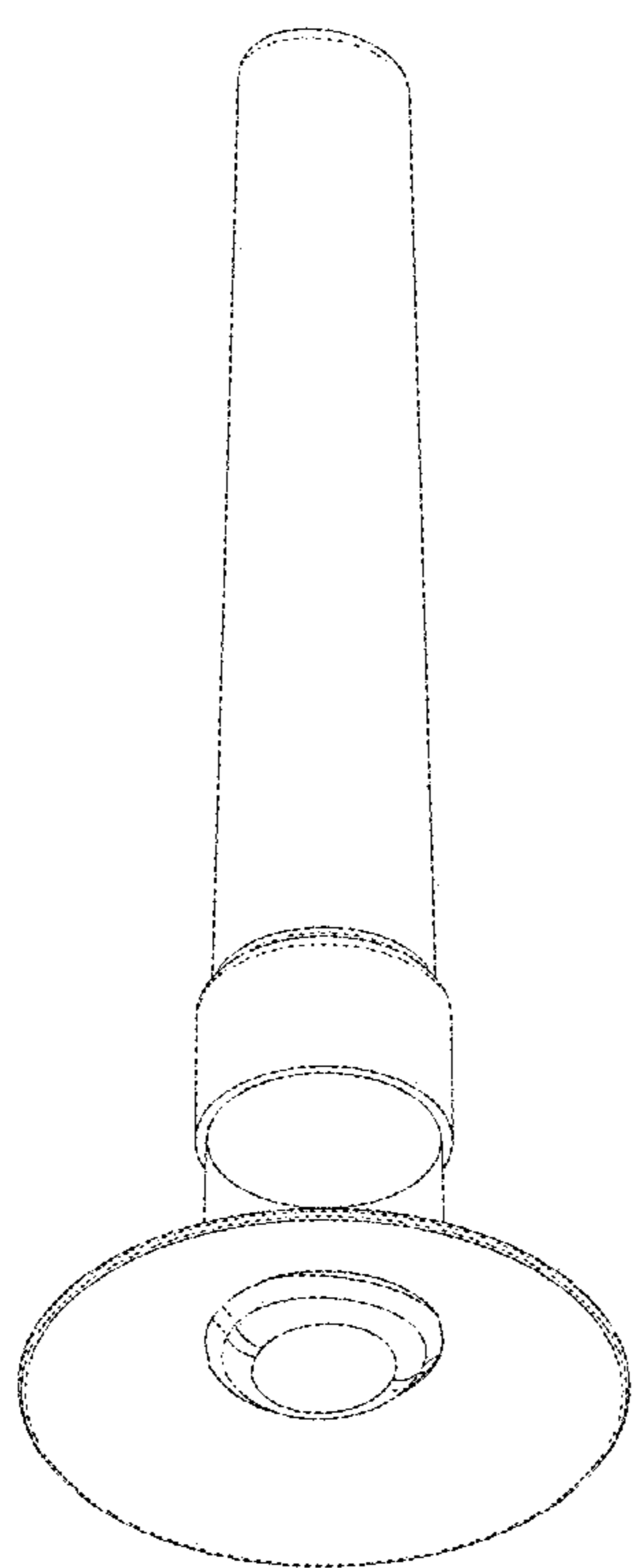

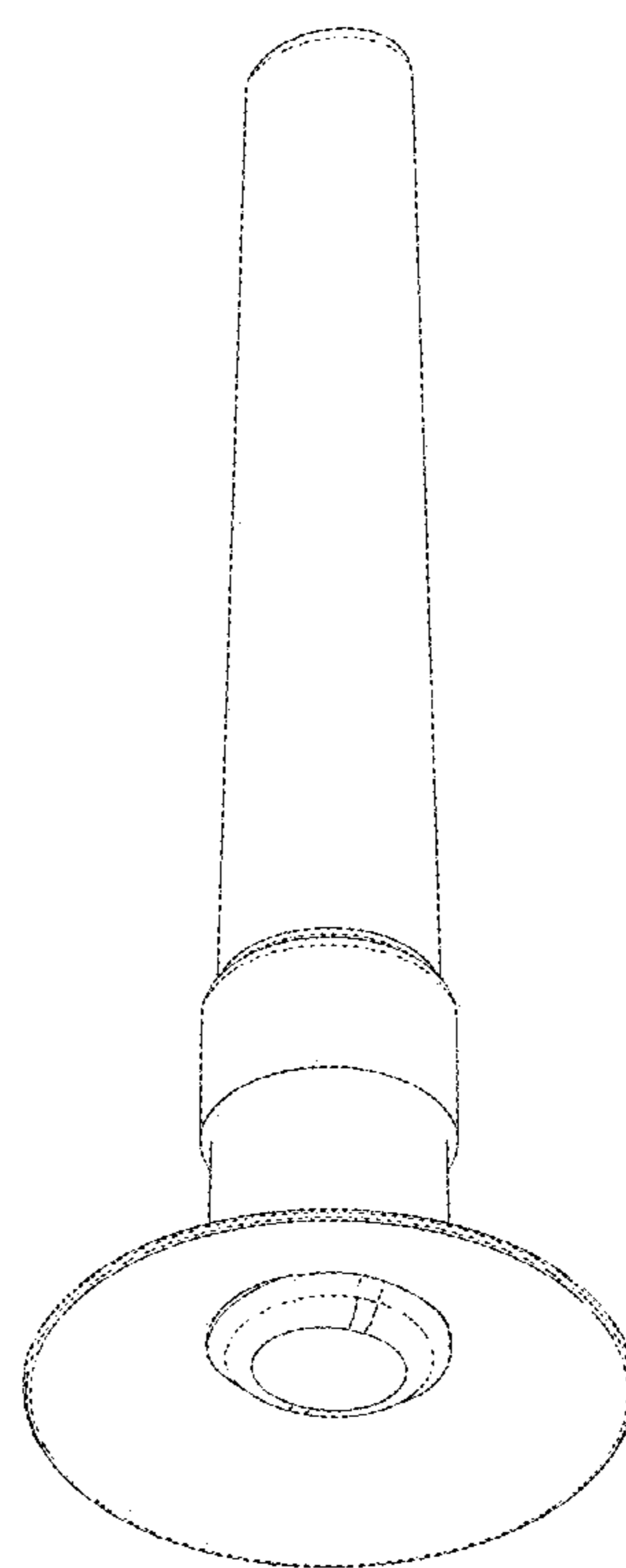
