(57) **CLAIM**

I claim the ornamental design for a pocketed bag, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the pocketed bag showing
twelve transparent pockets.

FIG. 2 is a front view of the pocketed bag.

FIG. 3 is a rear view of the pocketed bag.

FIG. 4 is a left side view of the pocketed bag.

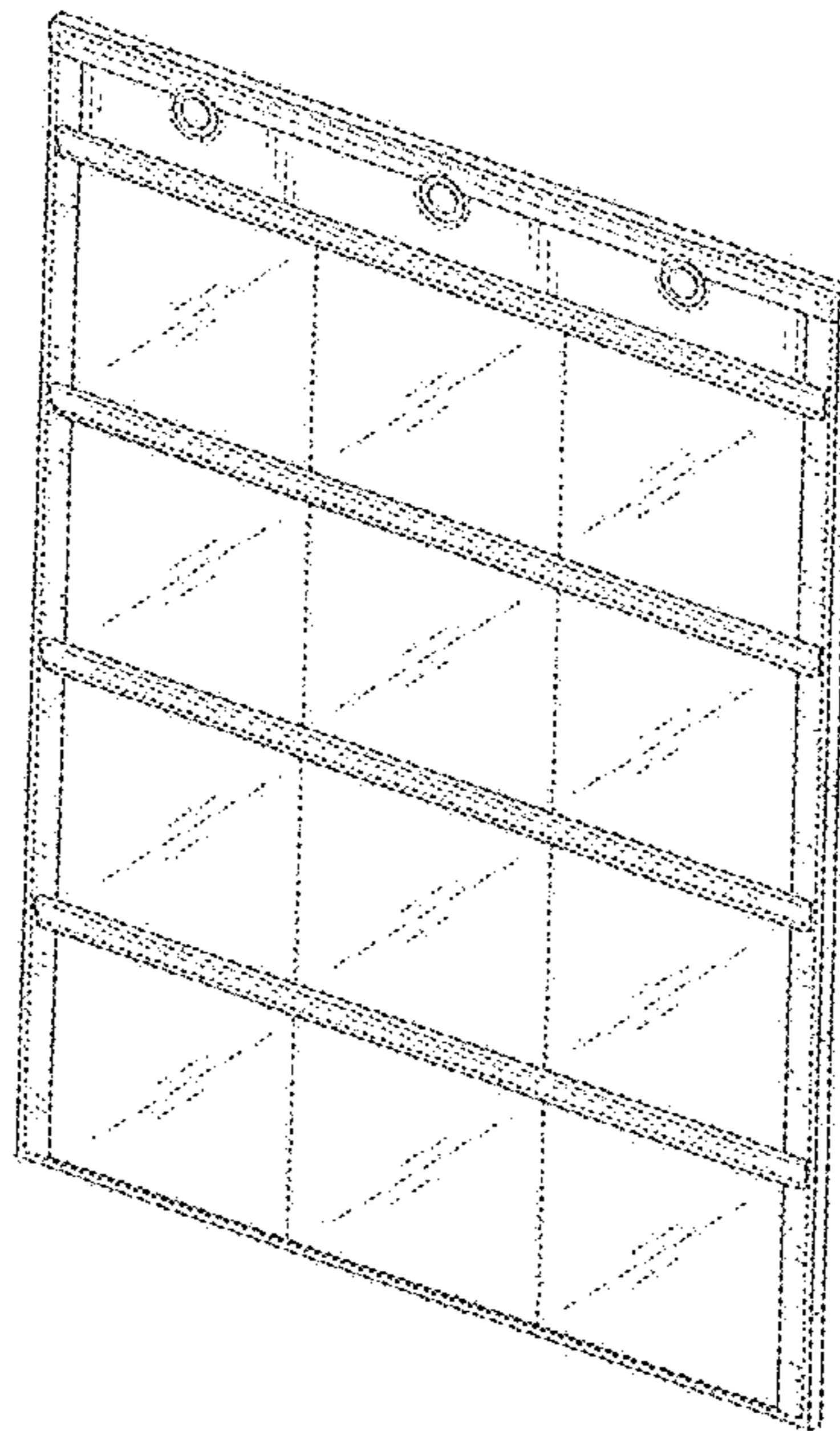
FIG. 5 is a right side view of the pocketed bag.

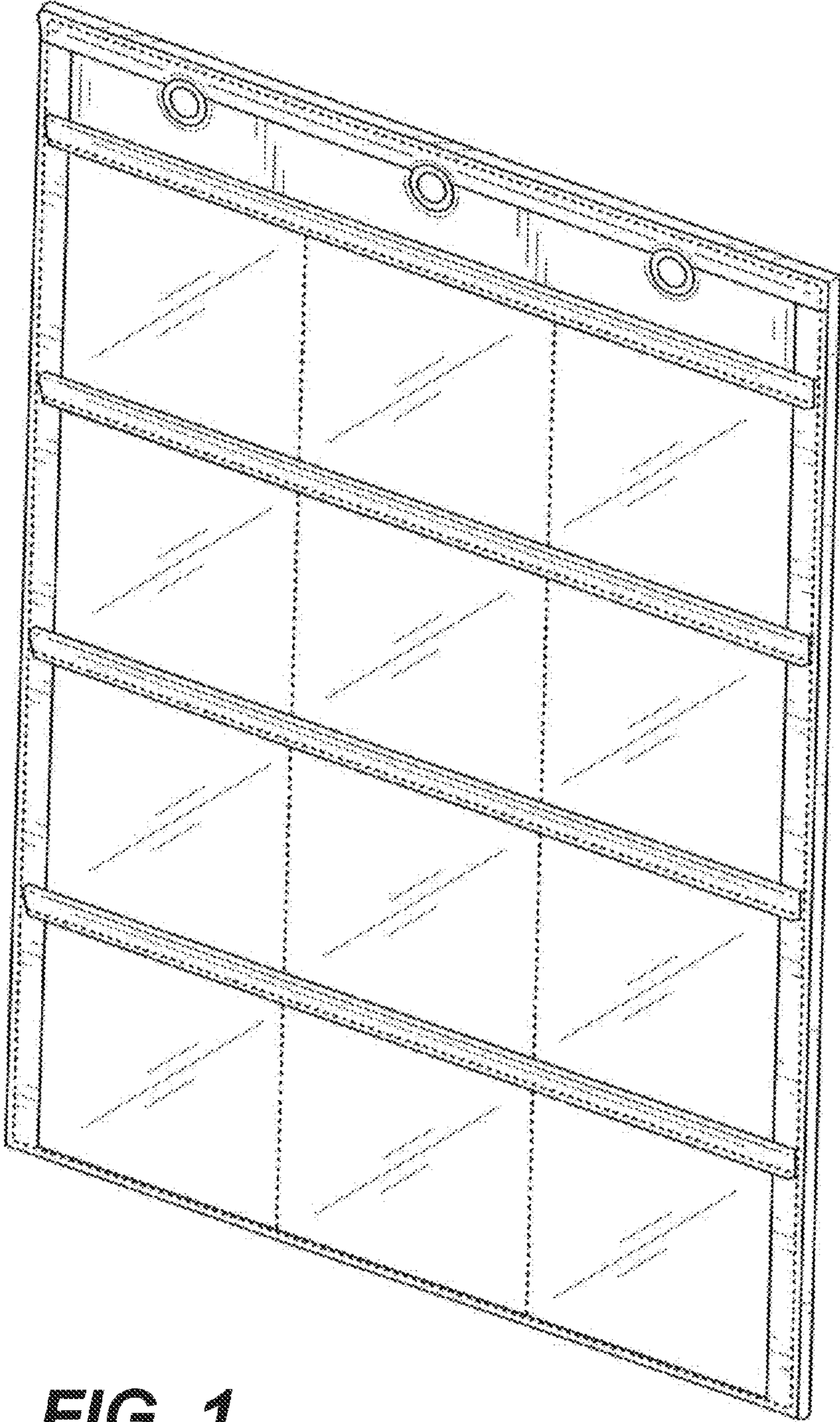

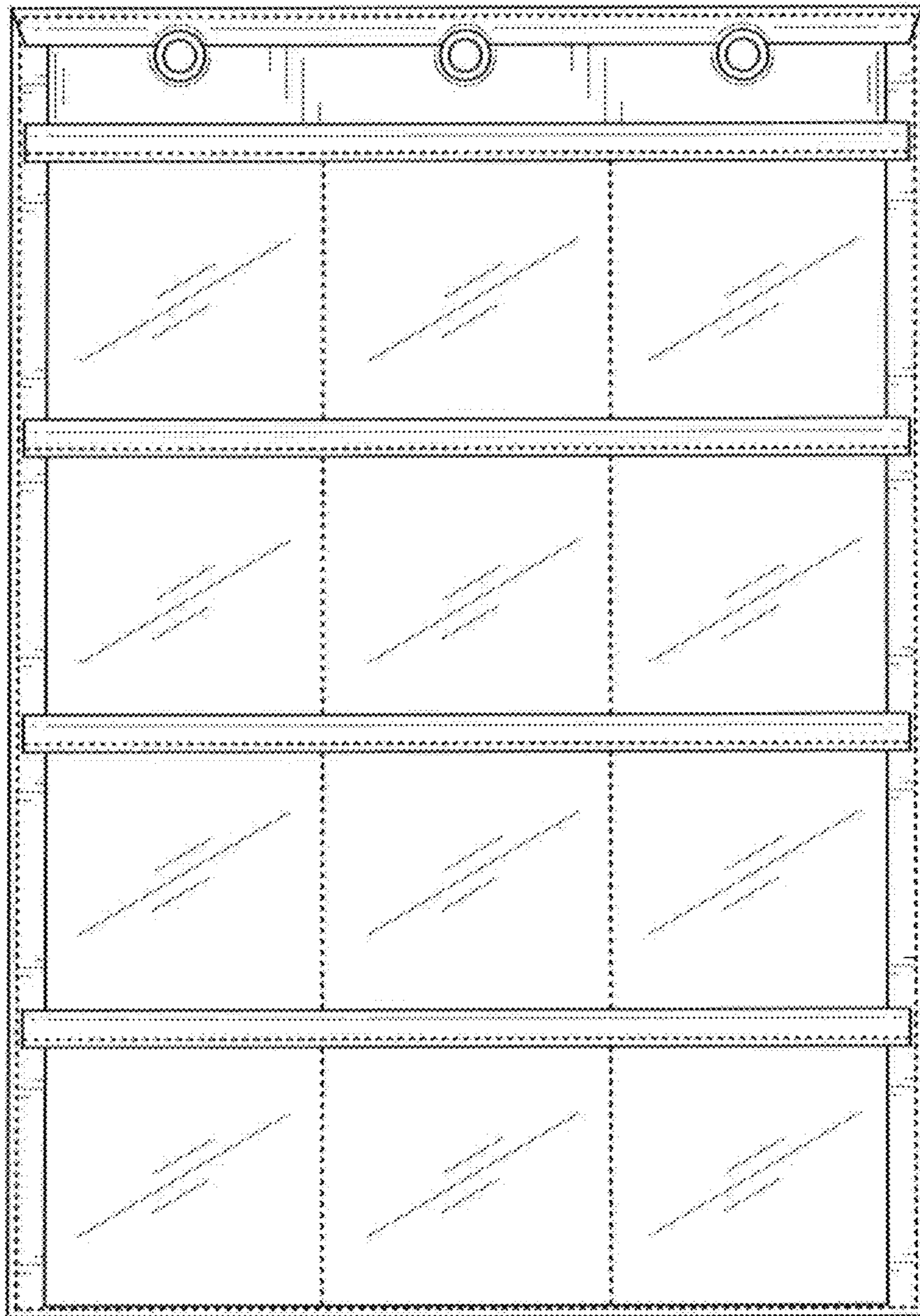

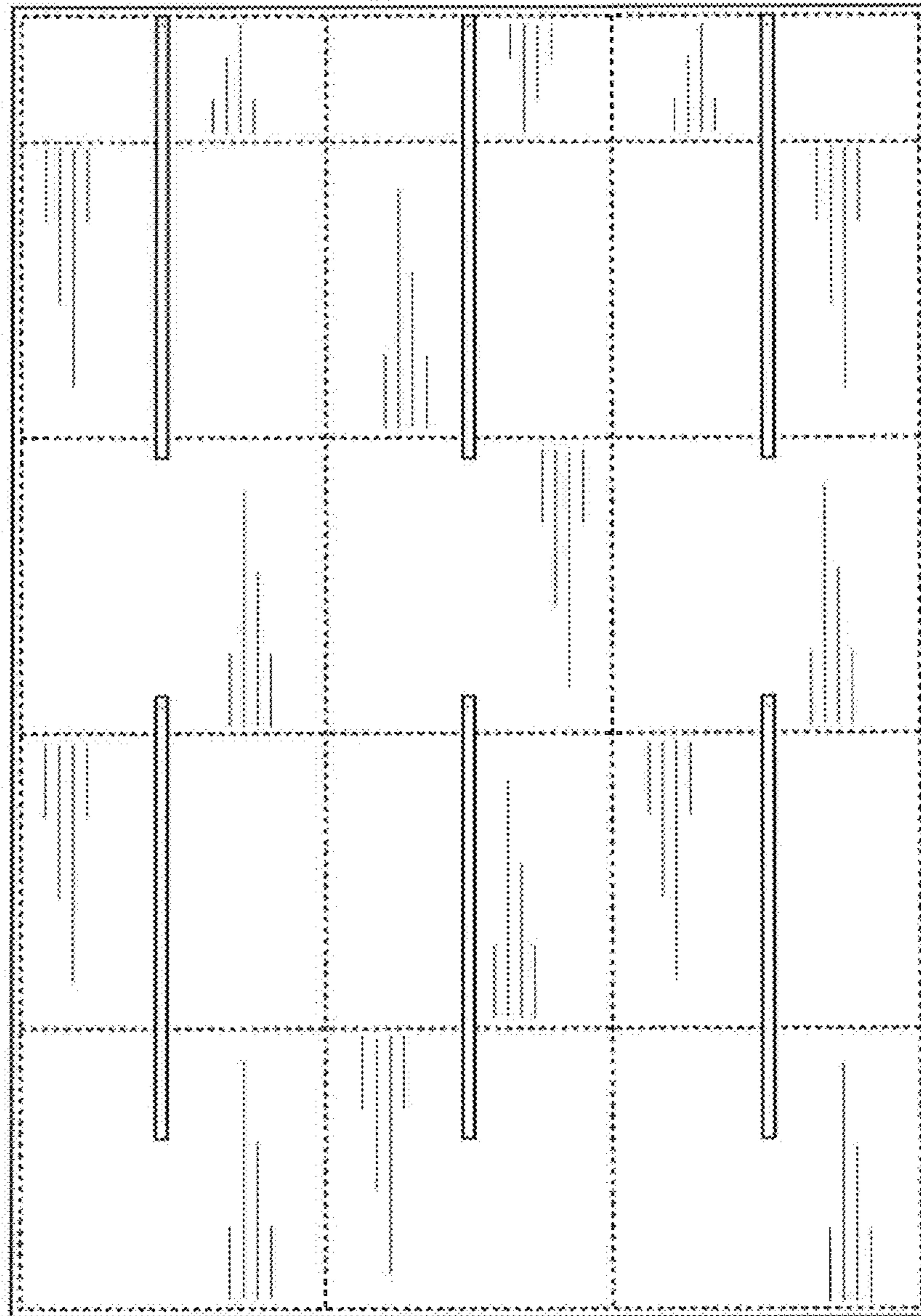

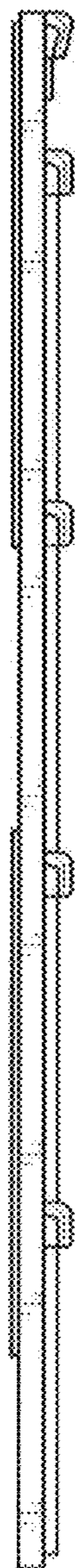

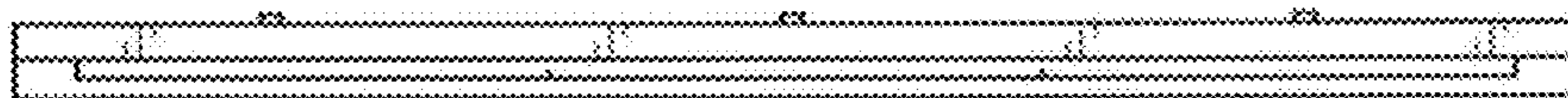
