(57) **CLAIM**

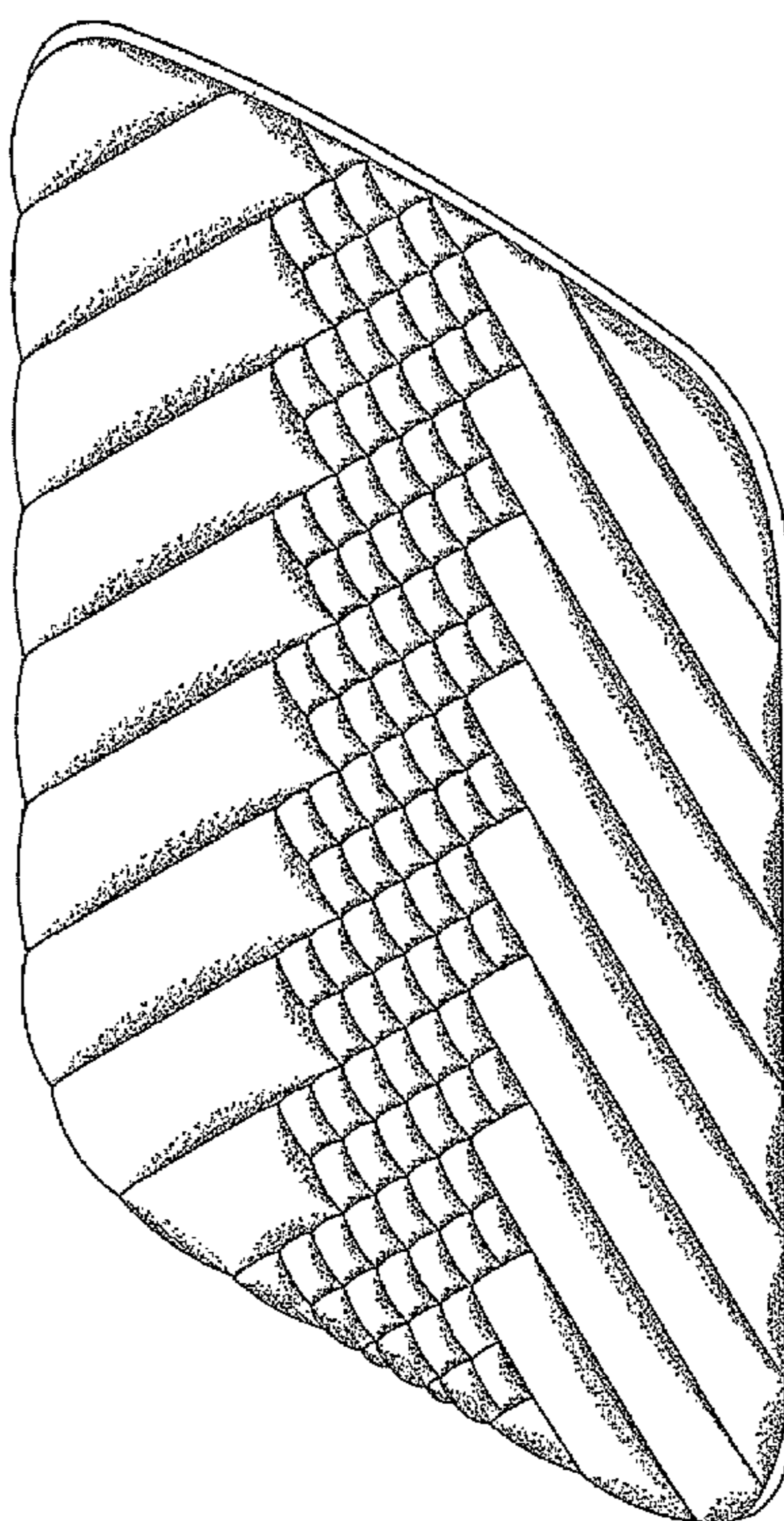
The ornamental design for a front luggage panel, as shown and described.

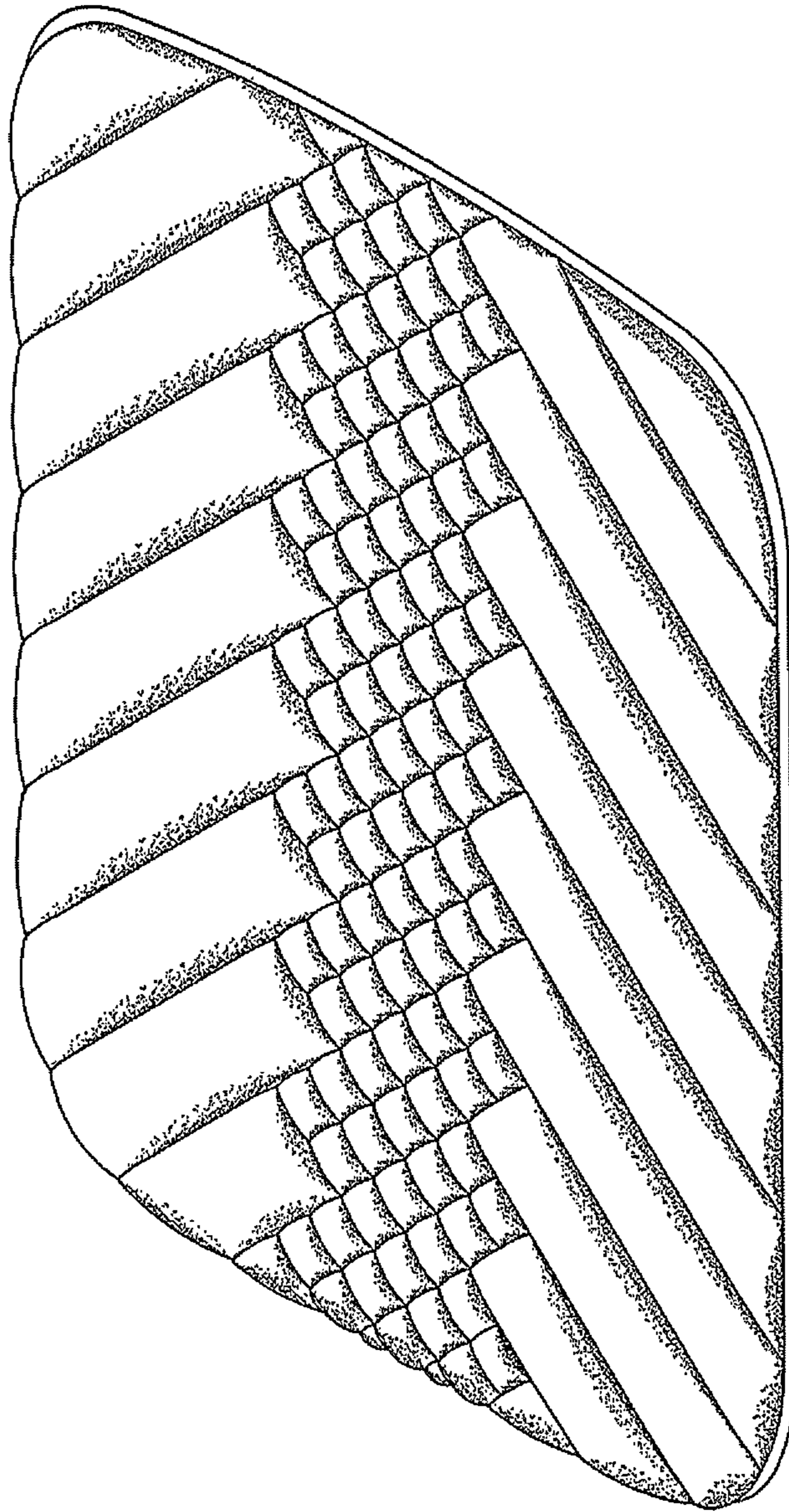

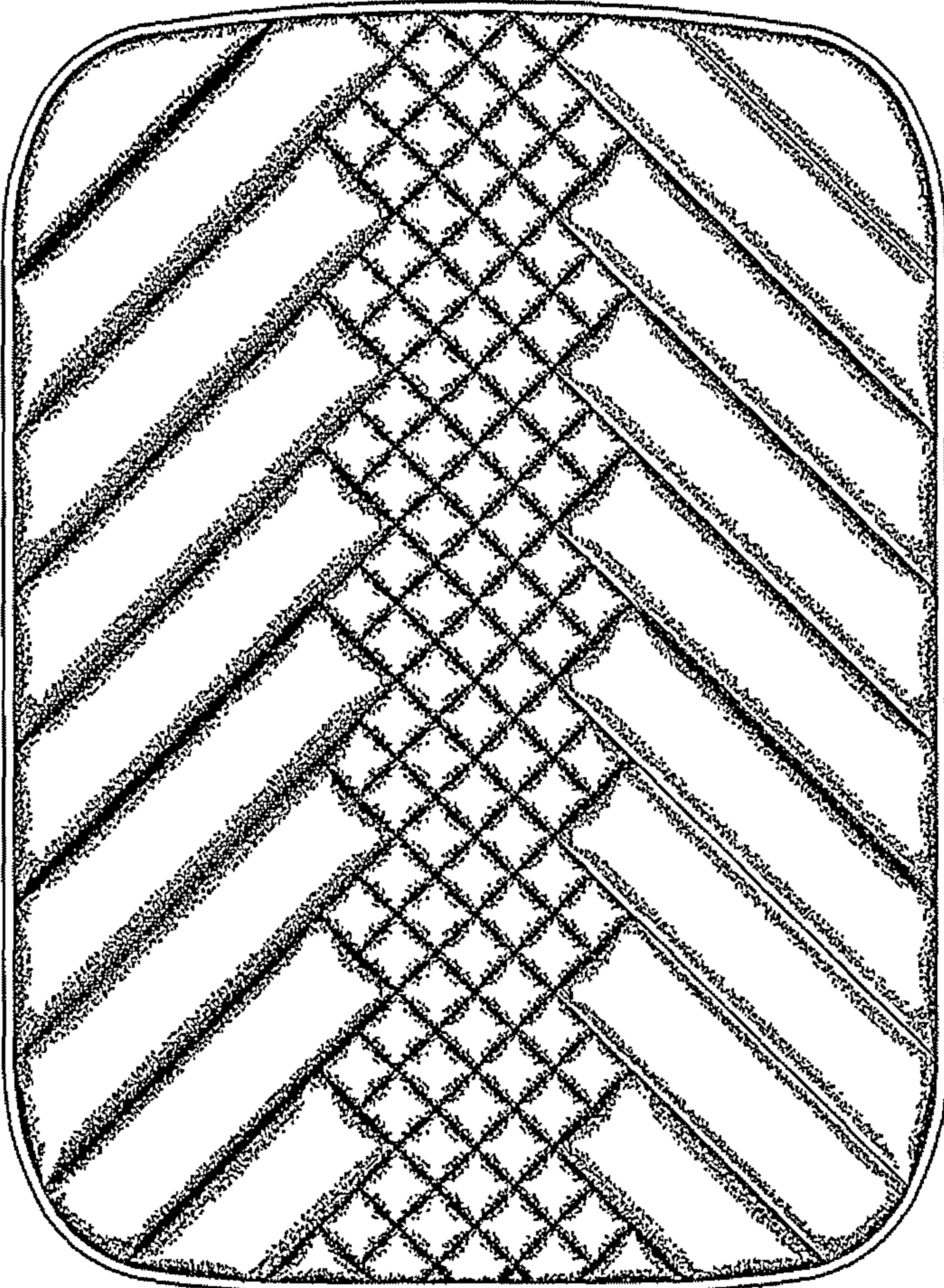

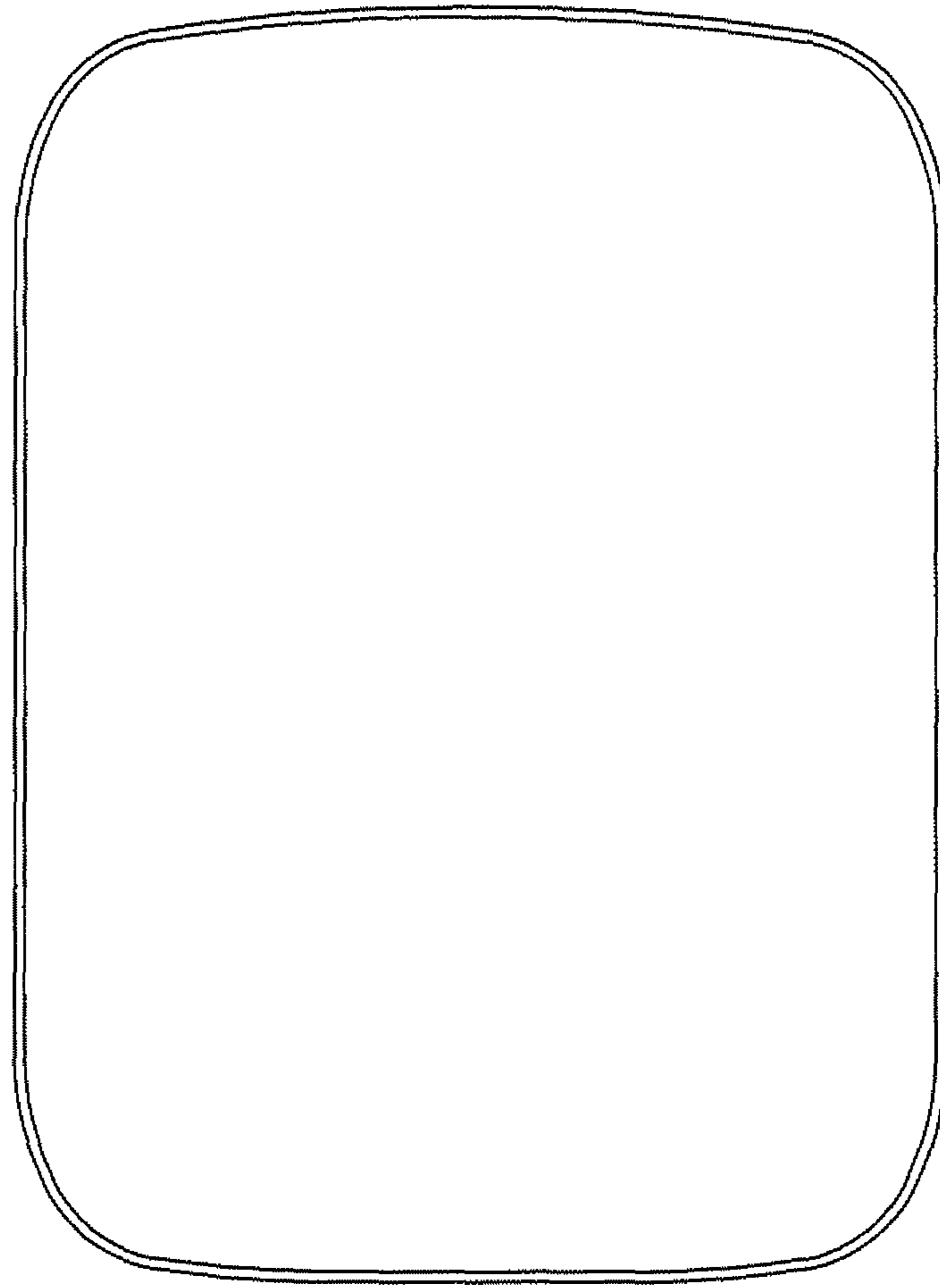

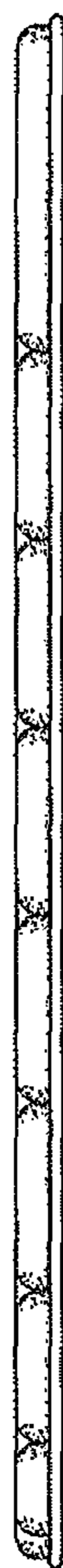

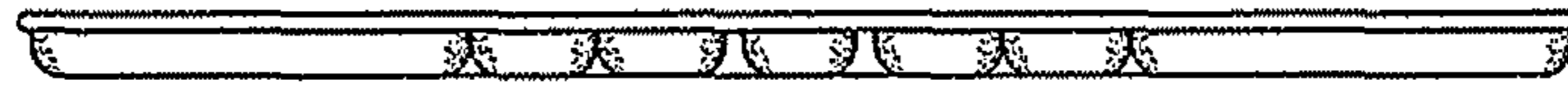

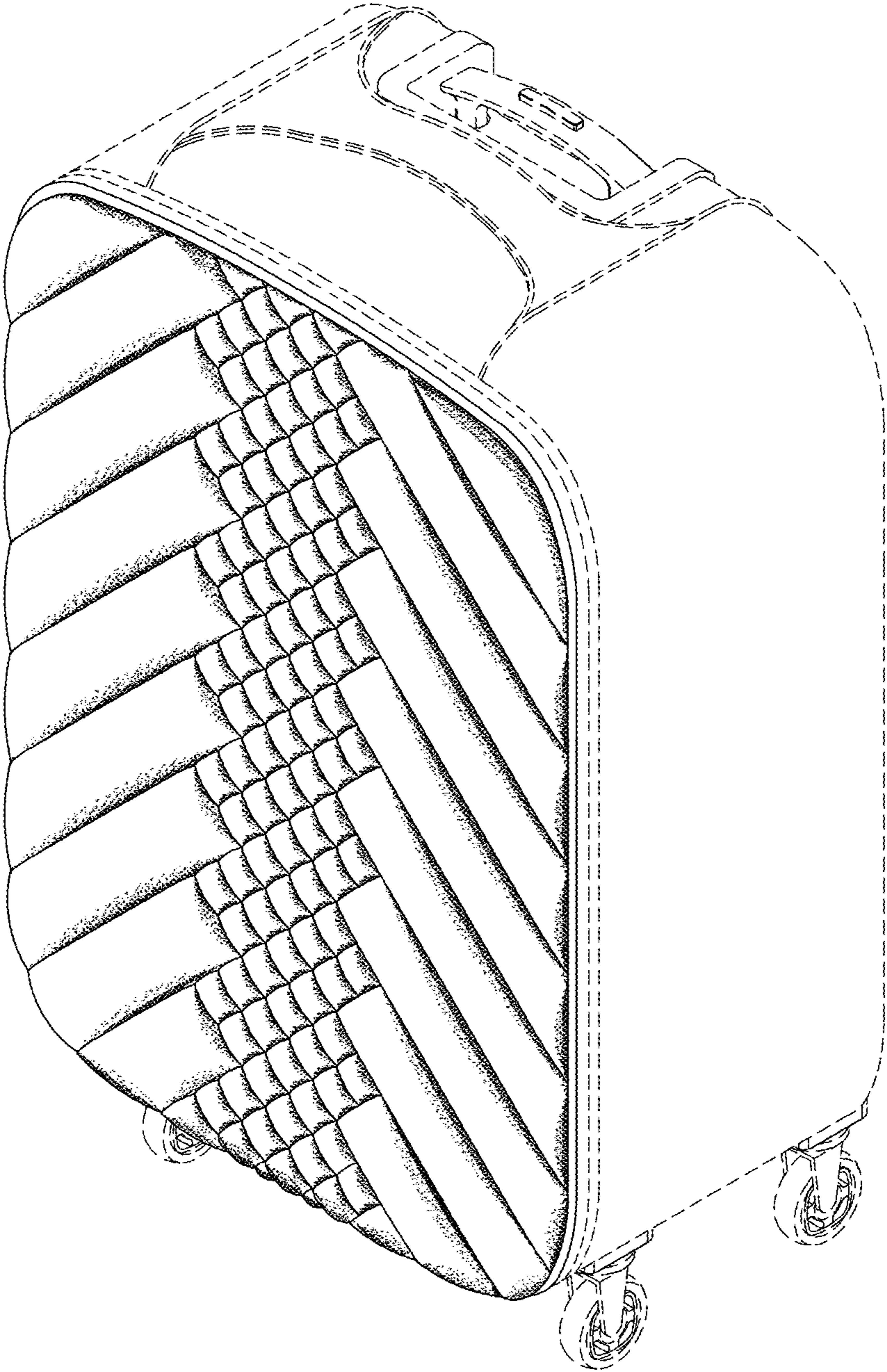
