FIG. 3 depicts a perspective left side view of the decorative stool of the invention.

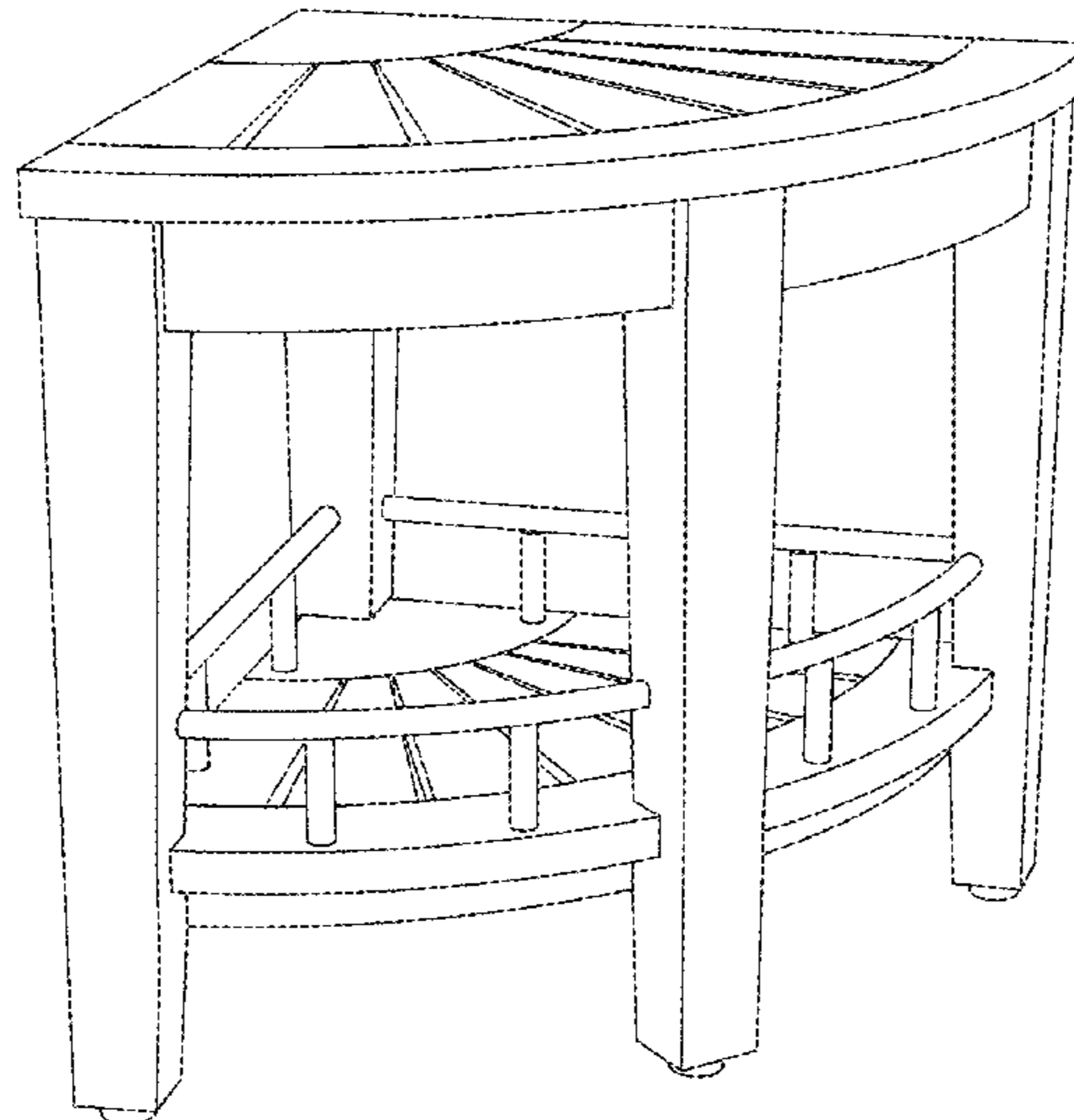
FIG. 4 depicts a perspective front side view of the decorative stool of the invention.

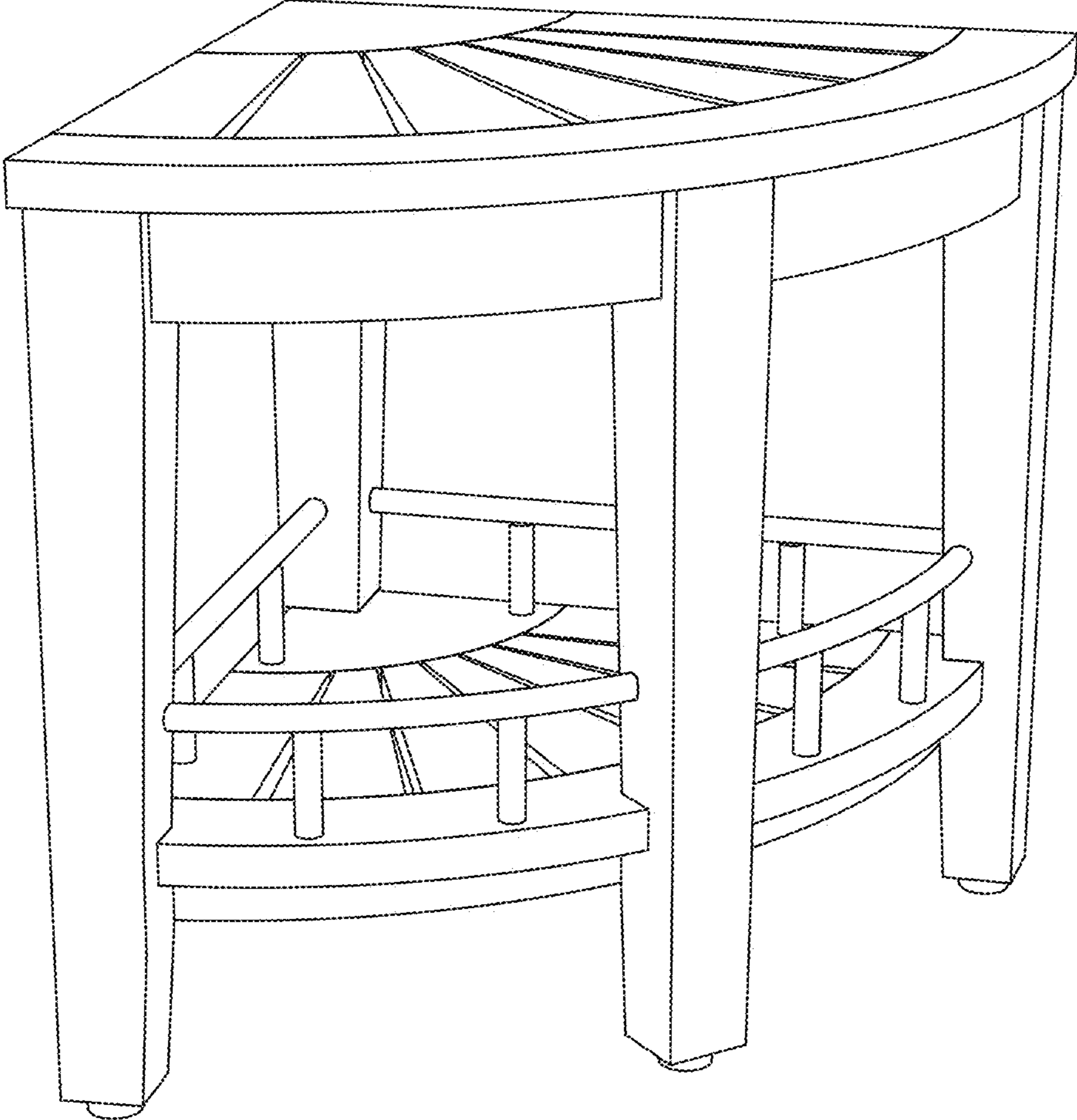

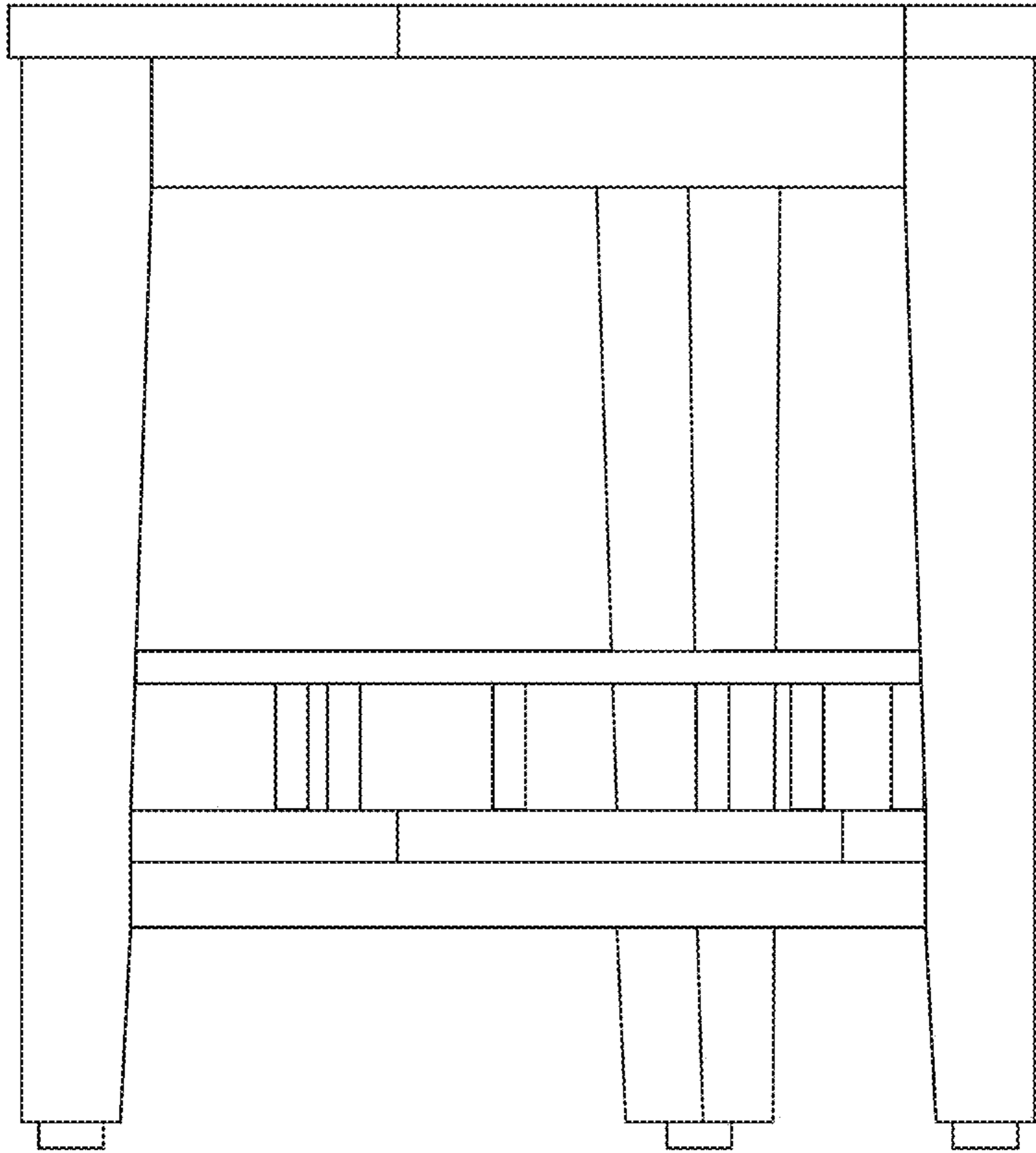

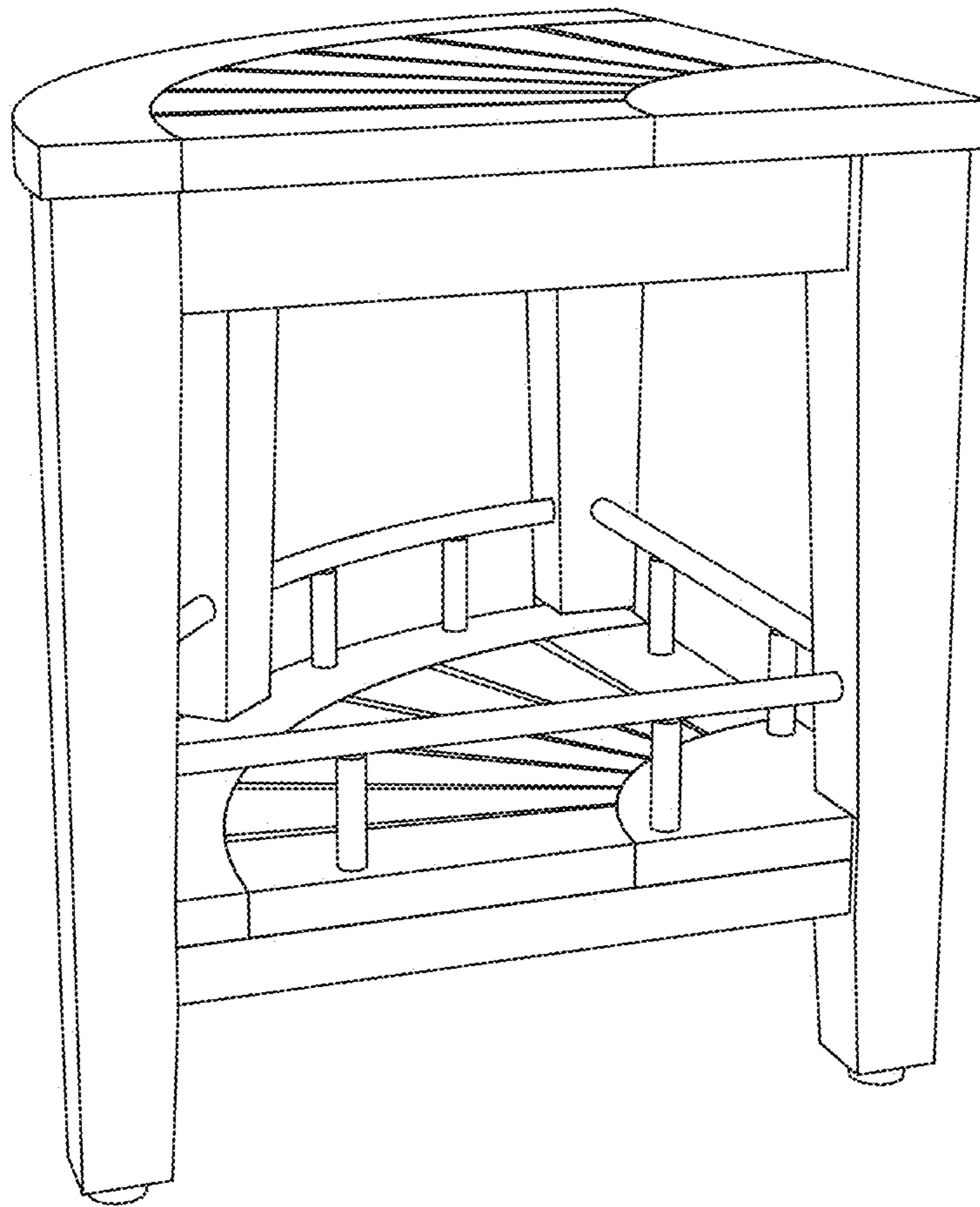

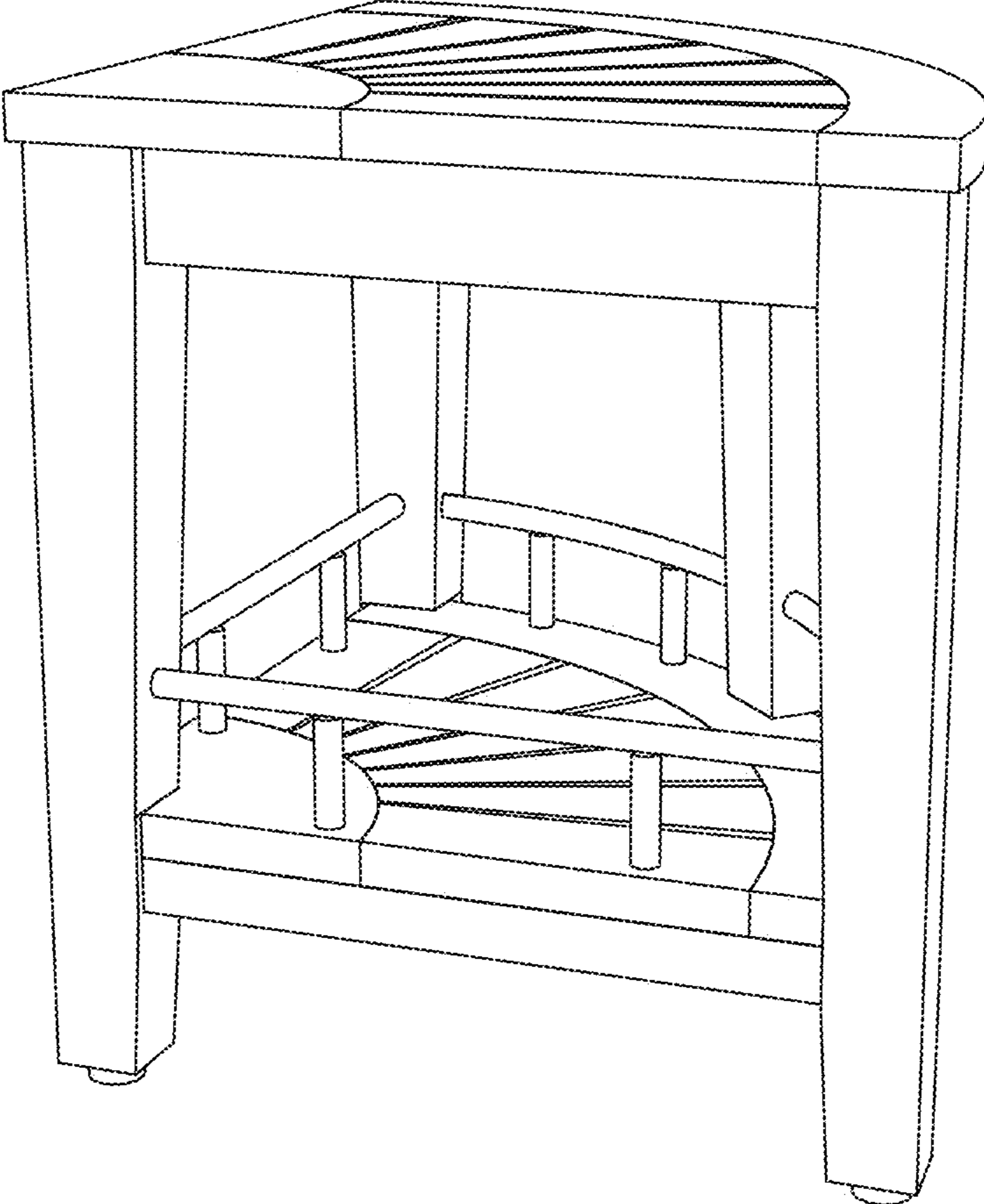

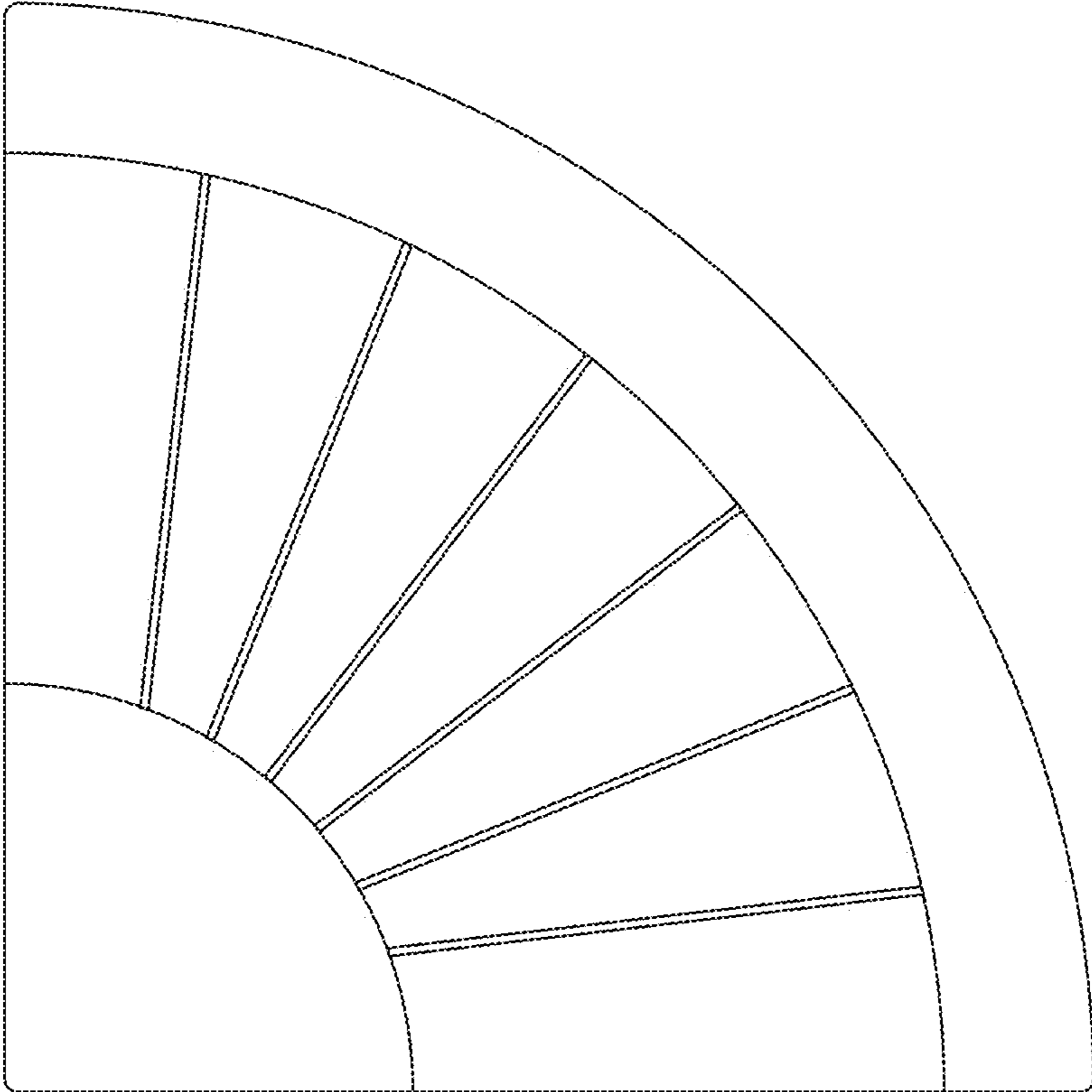

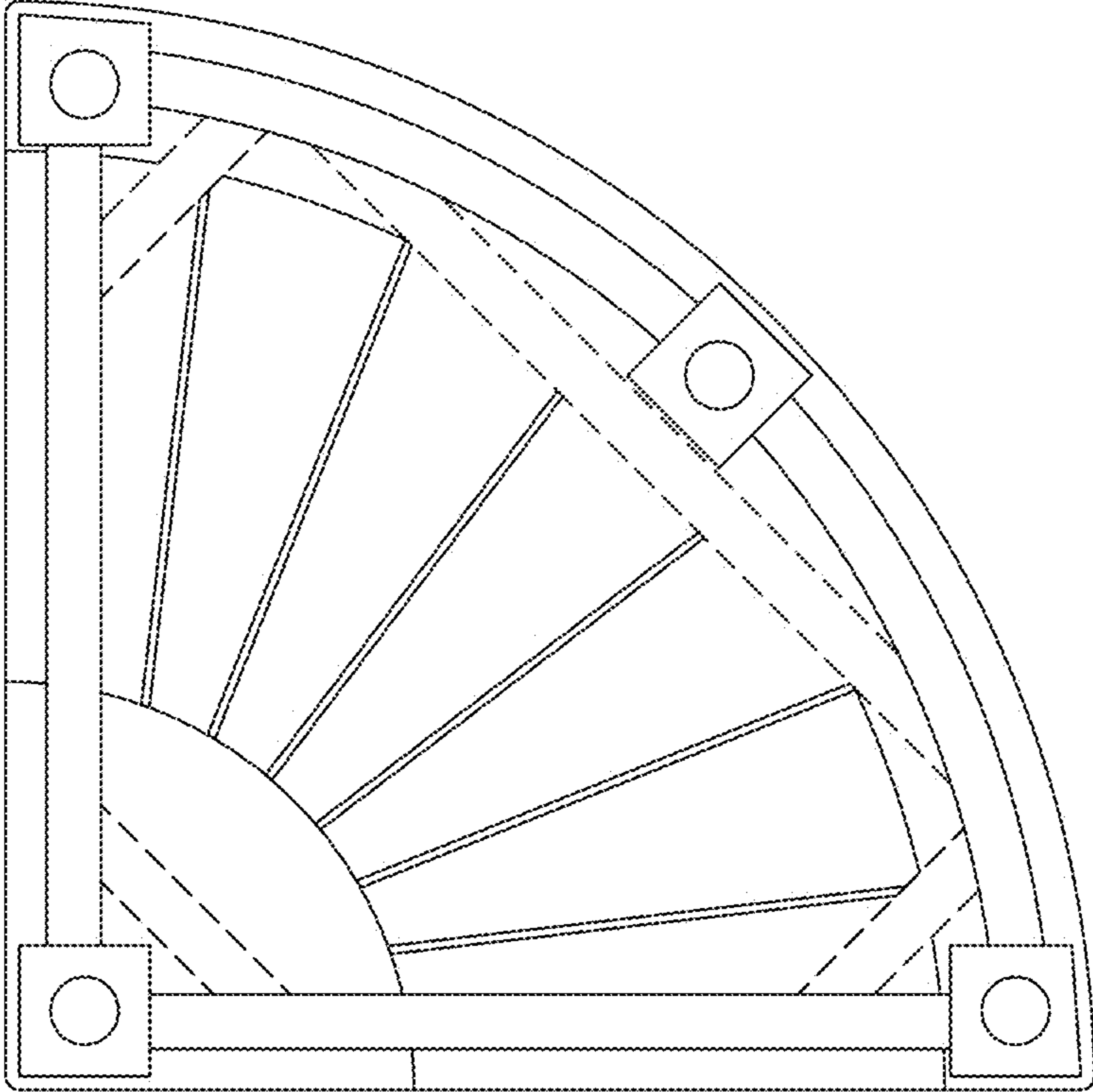
