(57) **CLAIM**

The ornamental design for a lid dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a lid dispenser according to the present invention;  
FIG. 2 is a rear view of the lid dispenser of FIG. 1;  
FIG. 3 is a front view of the lid dispenser of FIG. 1;  
FIG. 4 is a right side view of the lid dispenser of FIG. 1, the left side view substantially the same as the first side view;  
FIG. 5 is a top view of the lid dispenser of FIG. 1; and,  
FIG. 6 is a bottom view of the lid dispenser of FIG. 1.

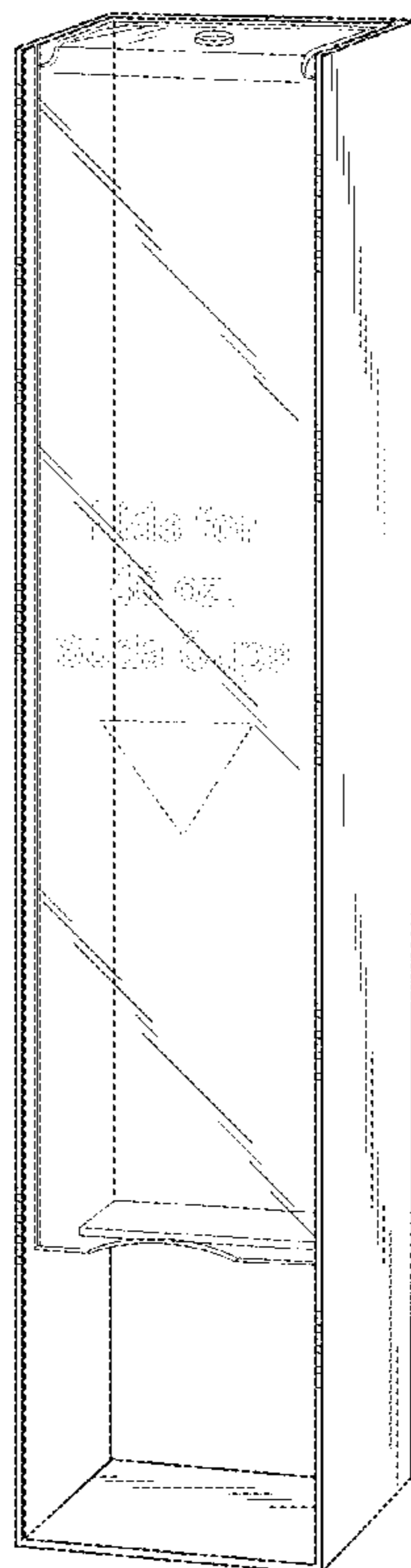

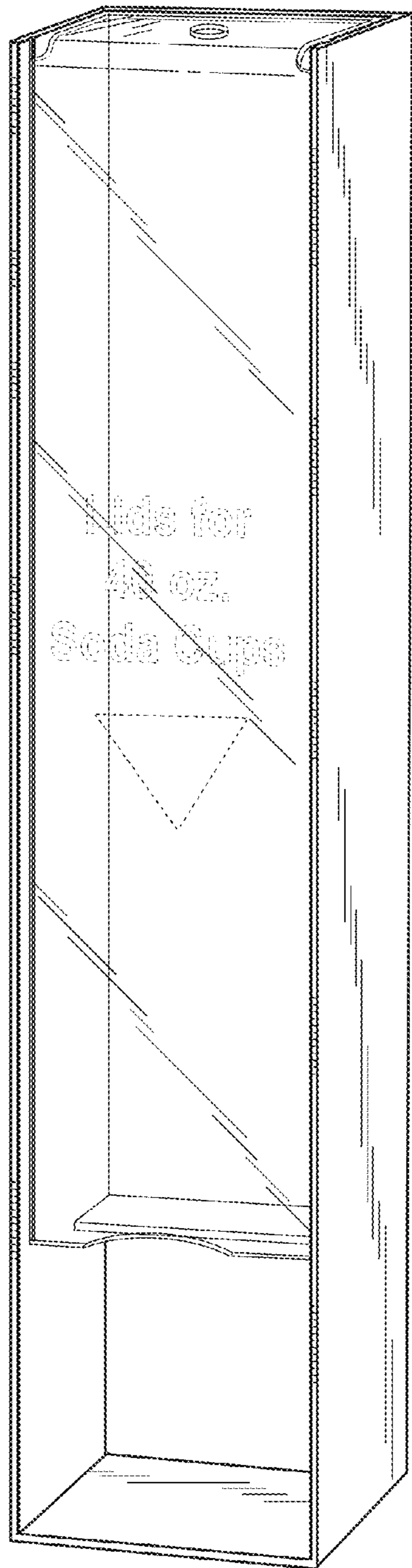

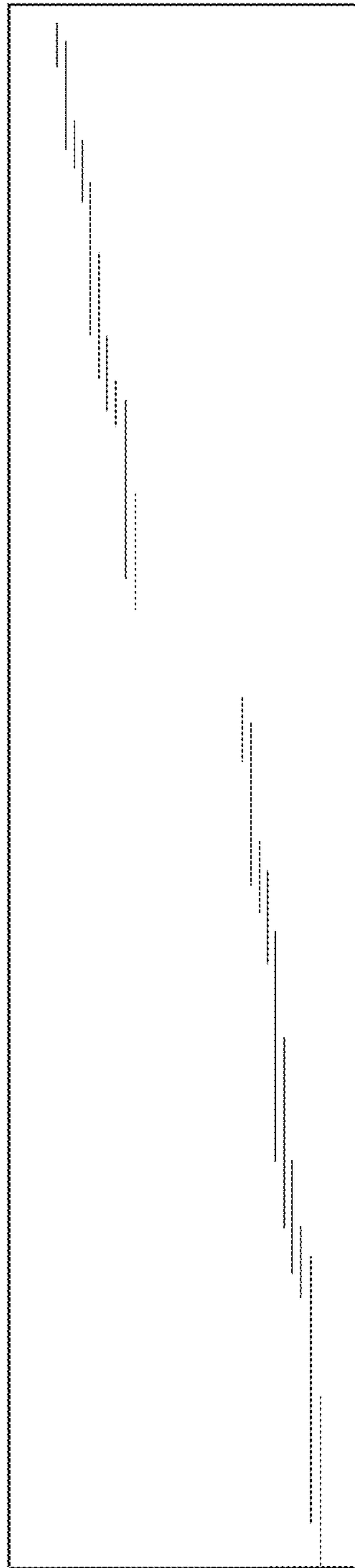

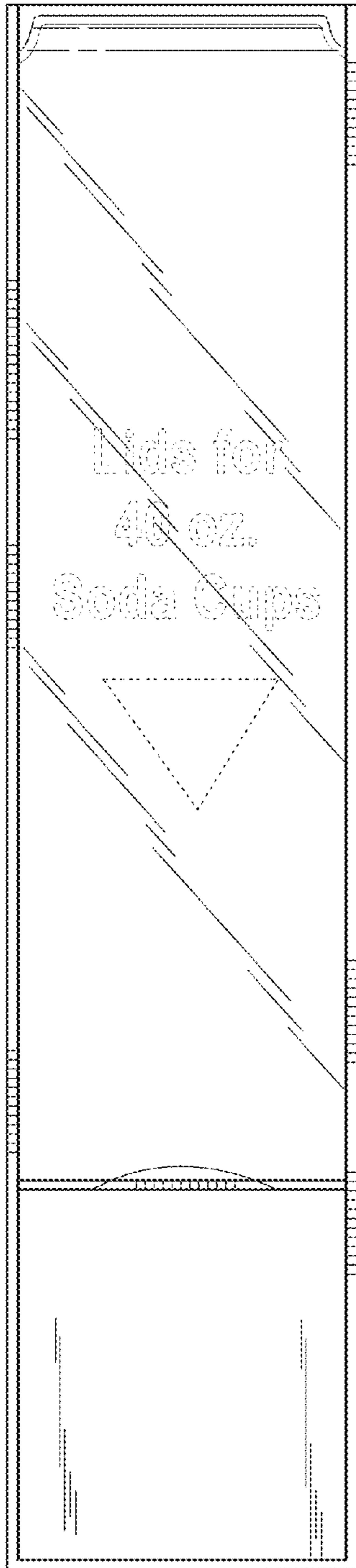
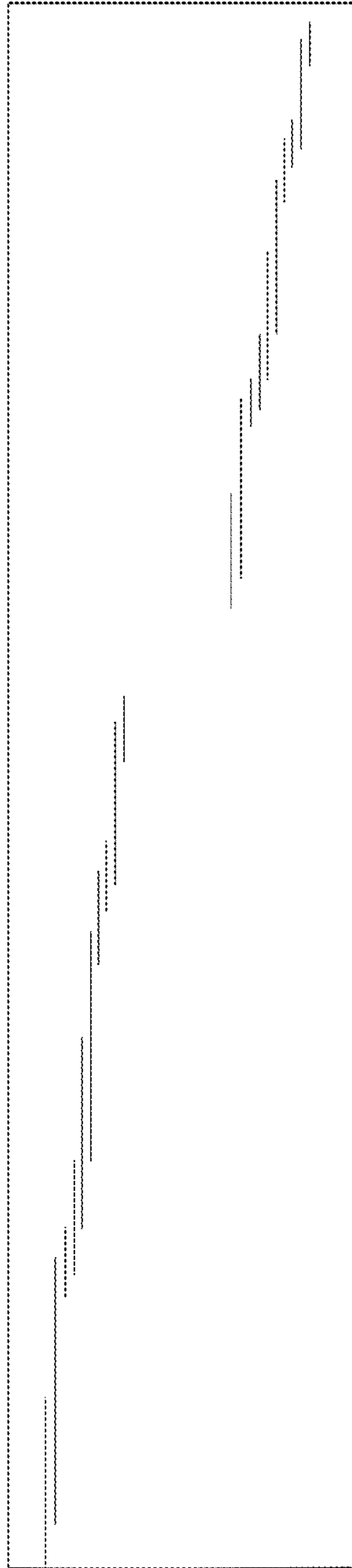
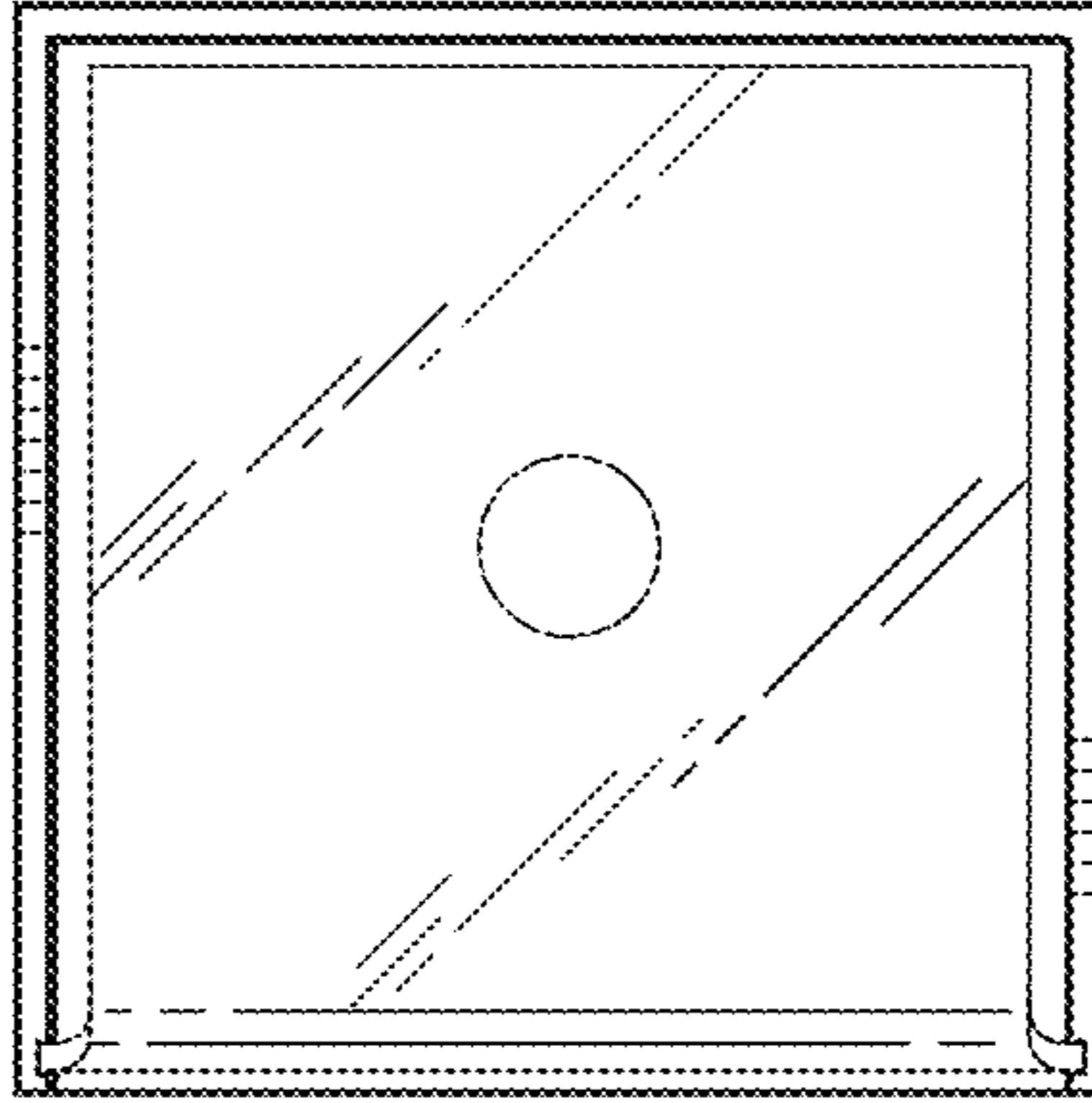
