DESCRIPTION

FIG. 1 is a perspective view of a tissue dispenser showing my new design;

FIG. 3 is a left-side elevation view thereof;

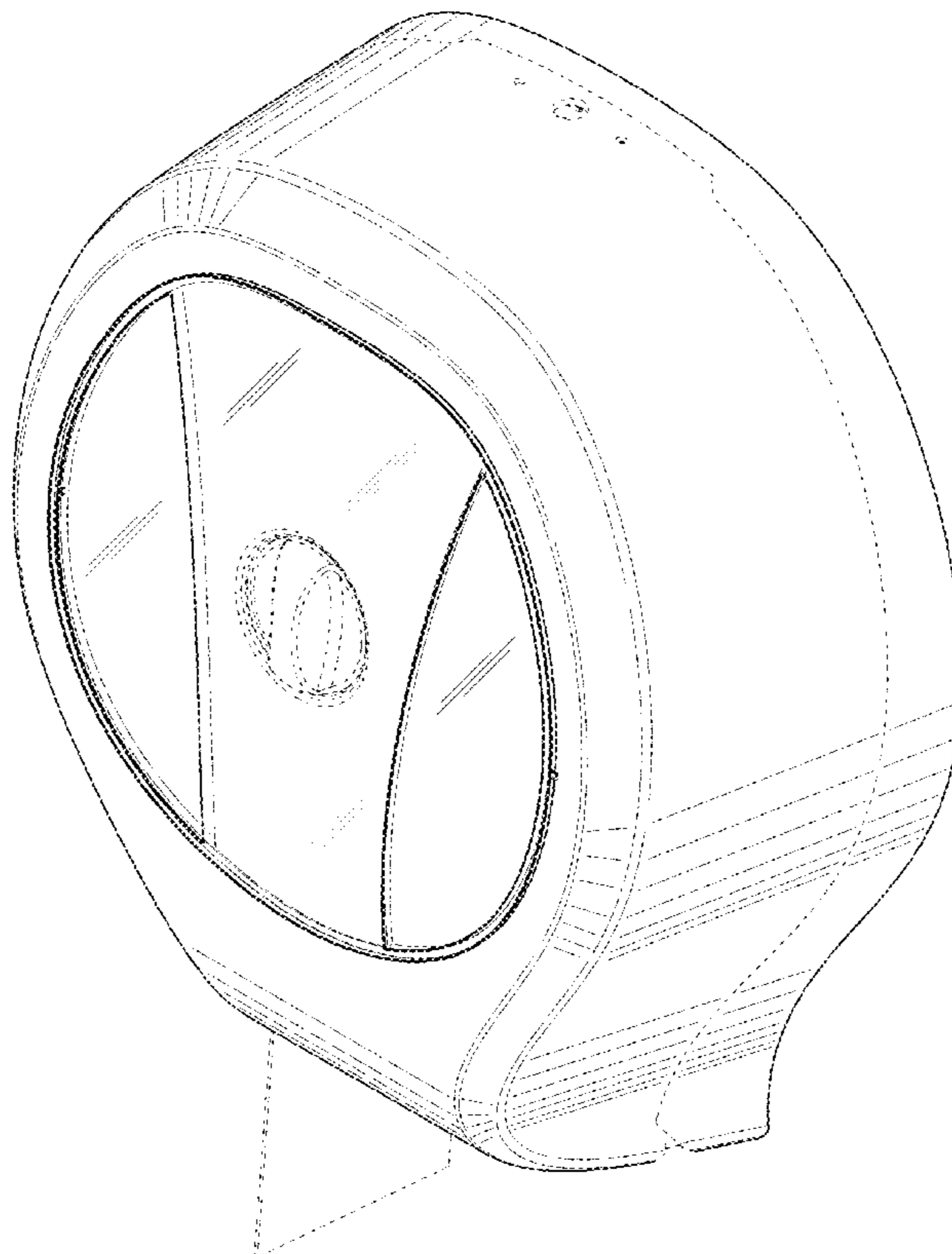
FIG. 4 is a right-side elevation view thereof;

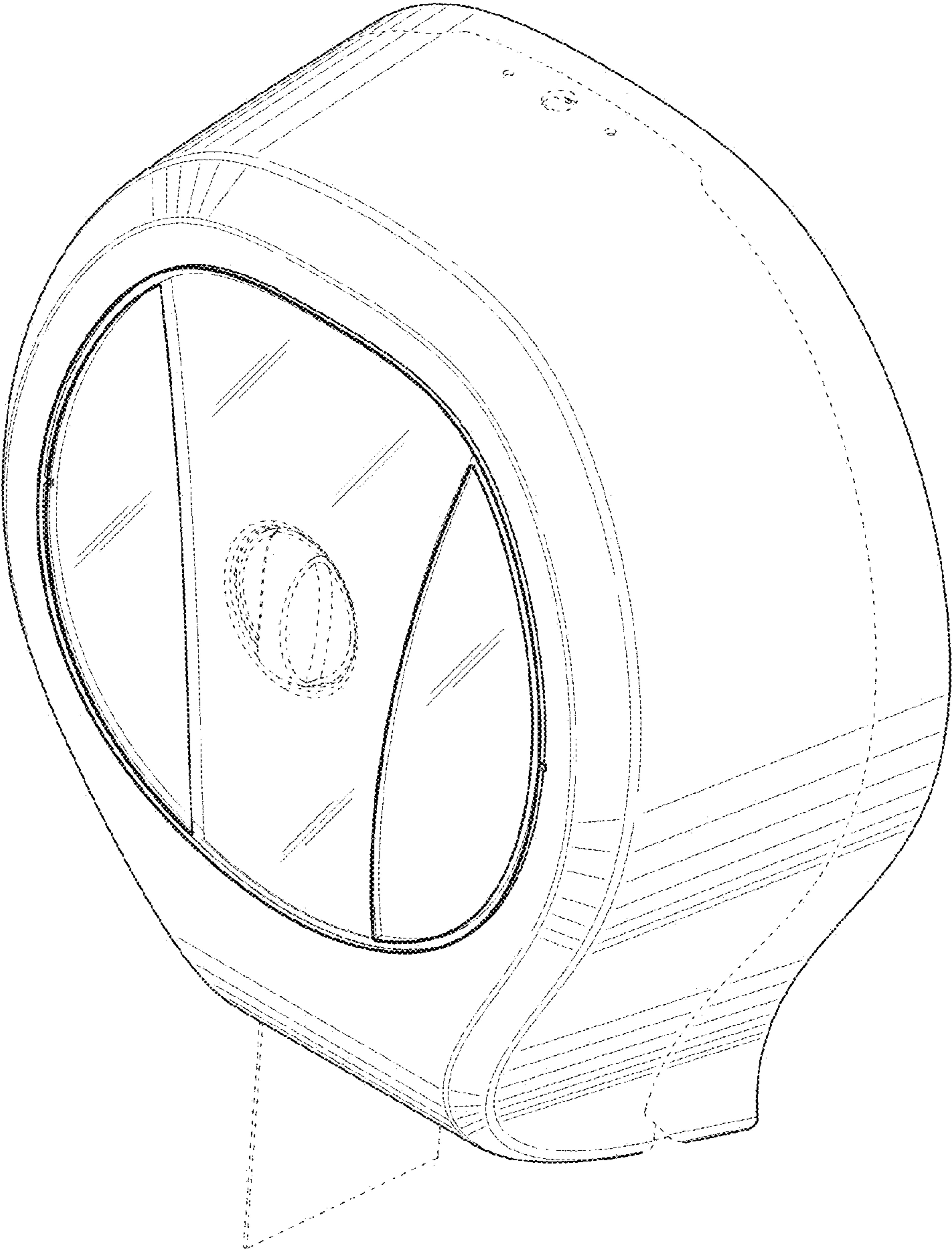

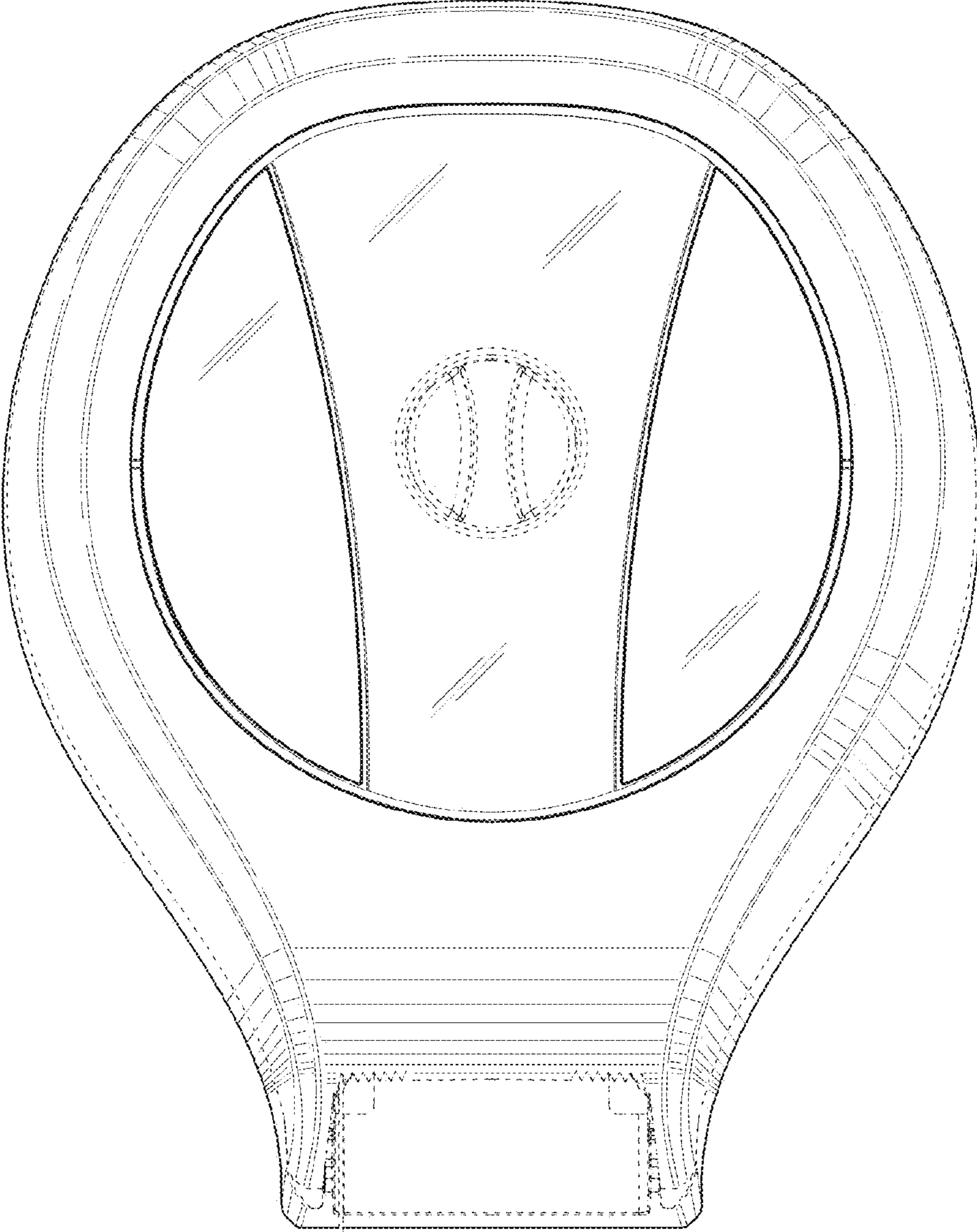

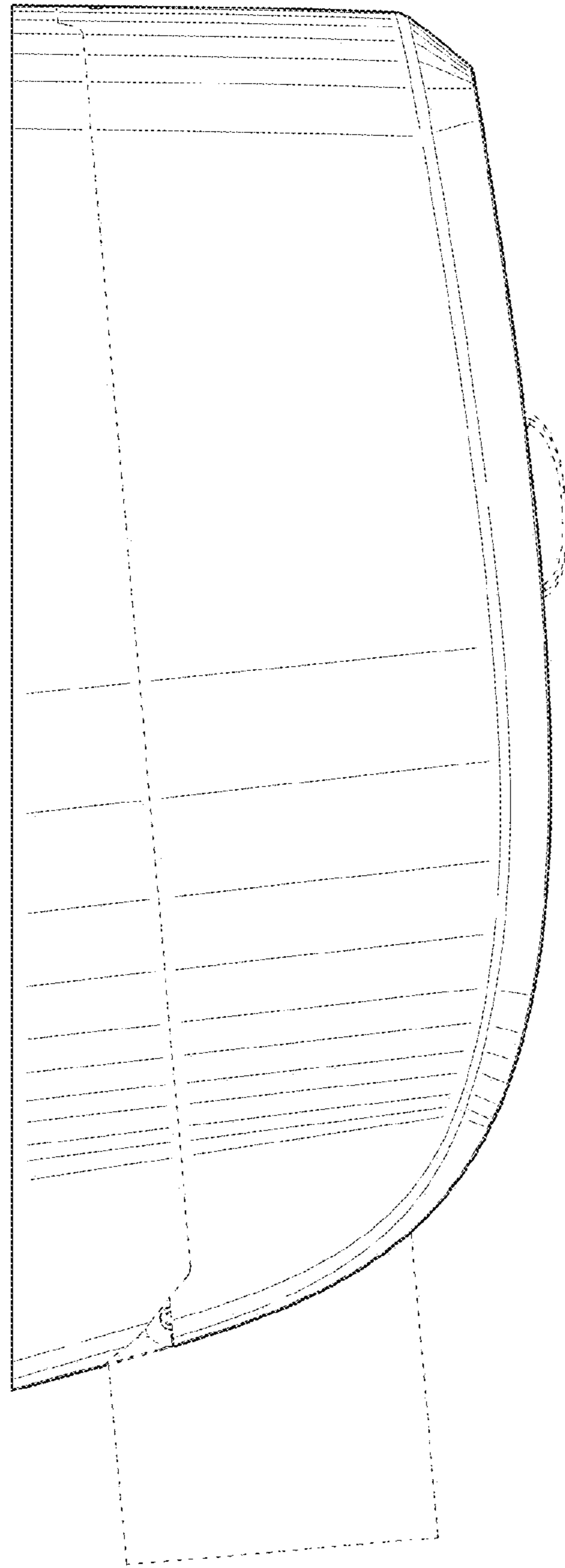

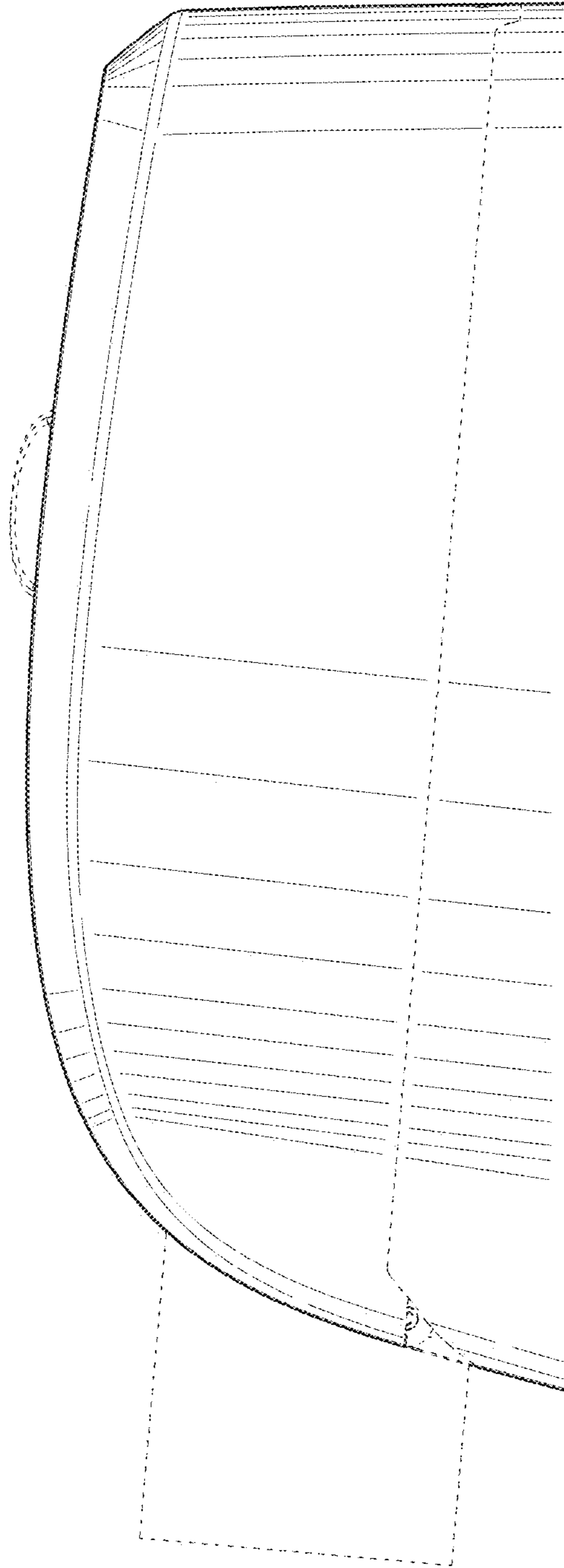

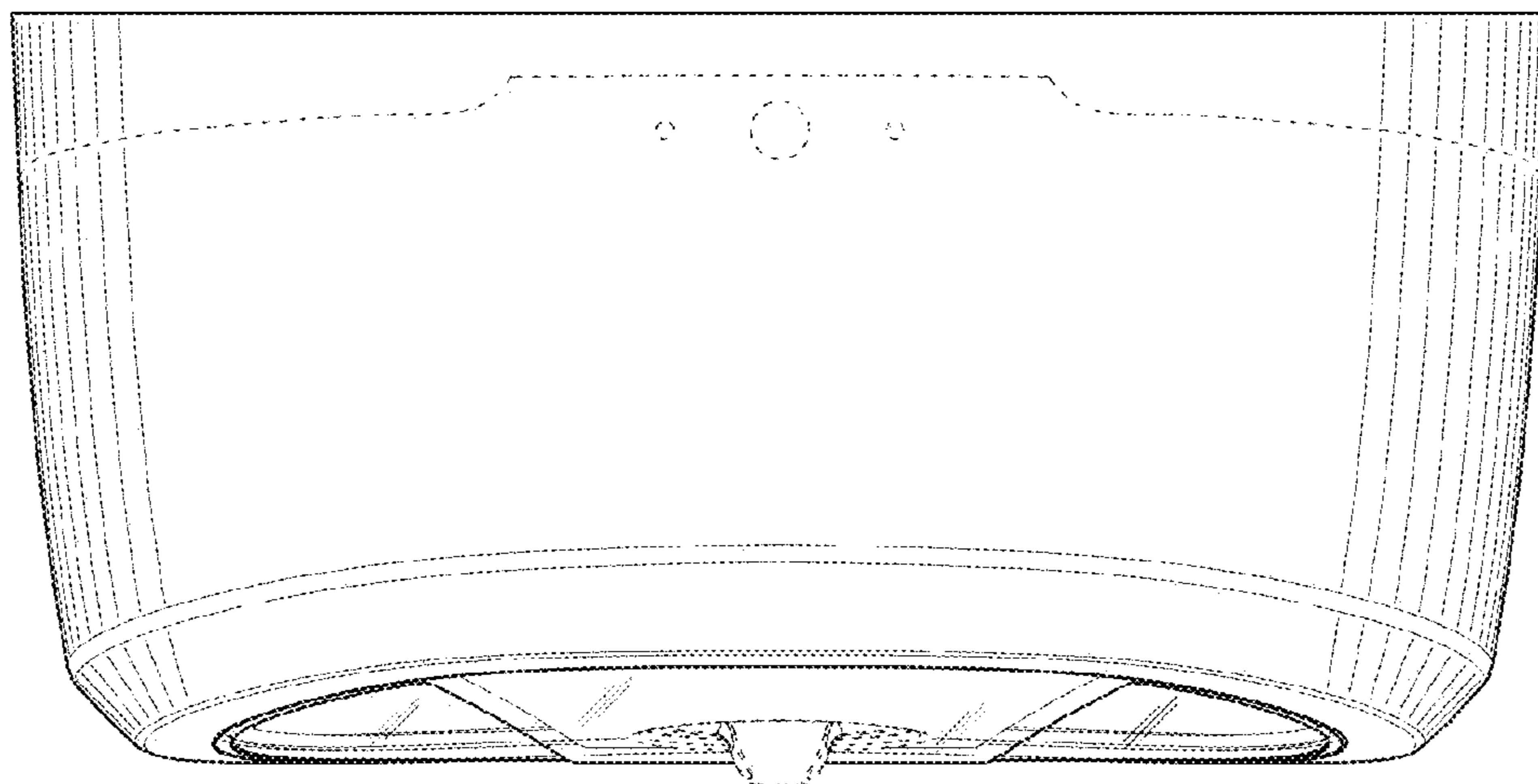

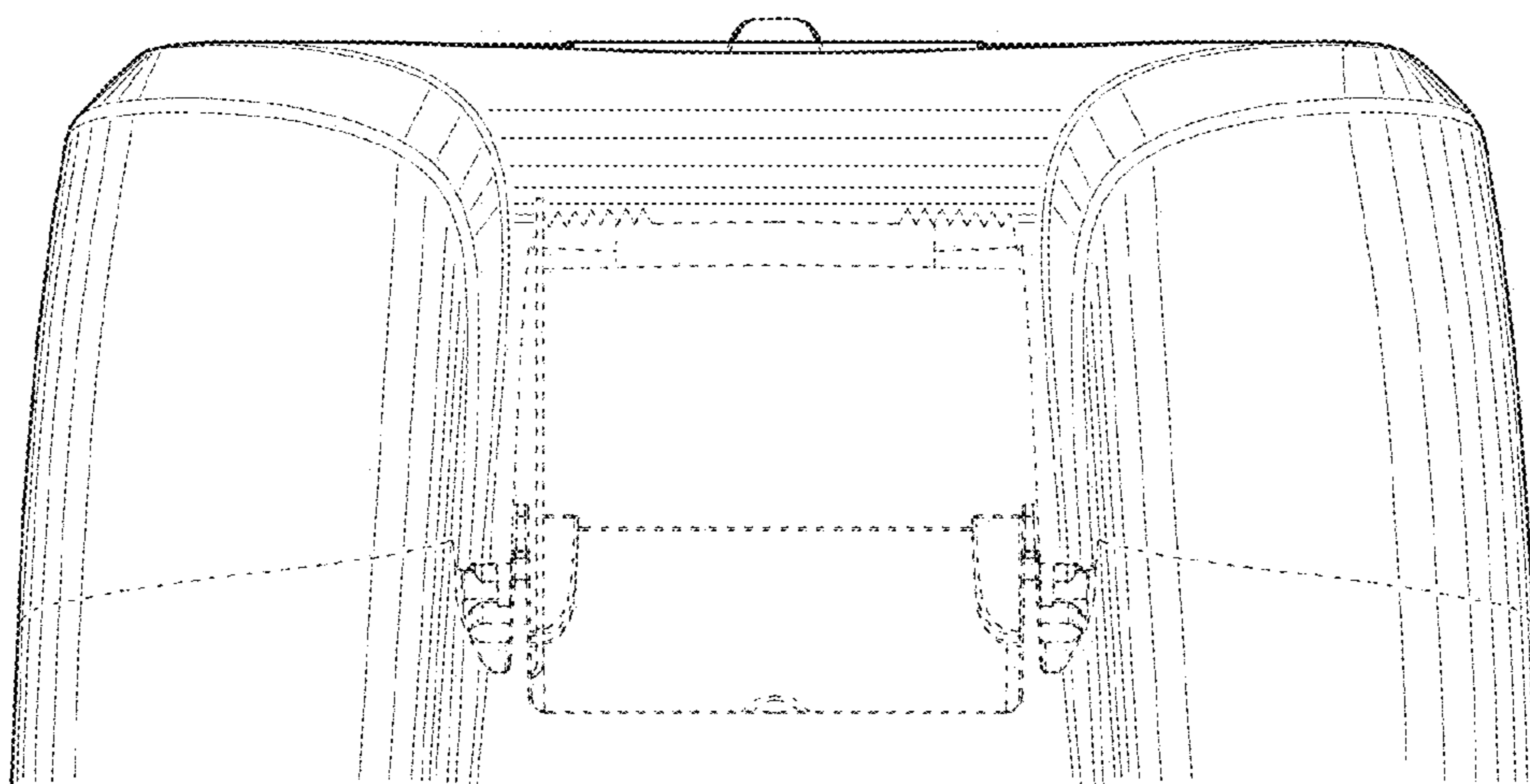
