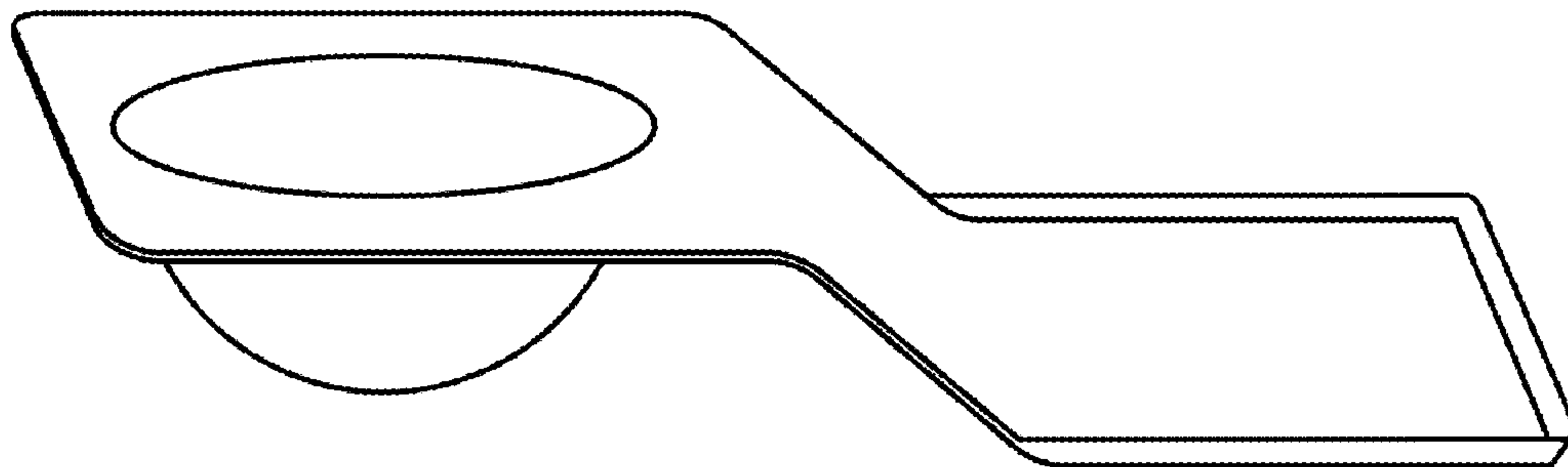
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top front perspective view of a dish showing my new design;  
FIG. 2 is a front elevational view with the opposite being a mirror image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof; and,

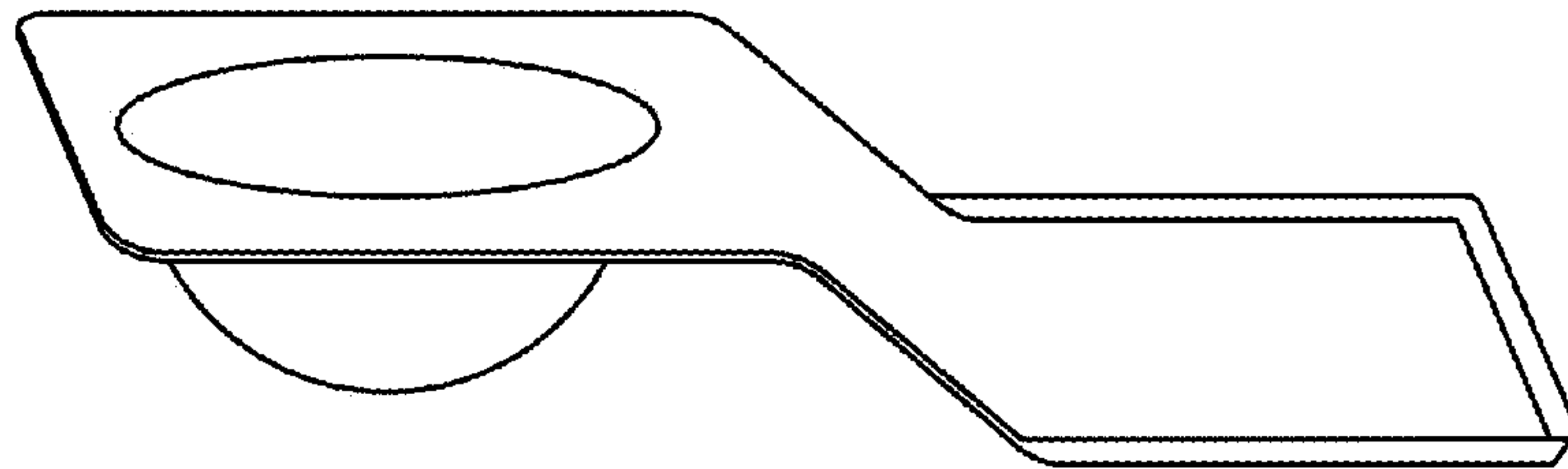

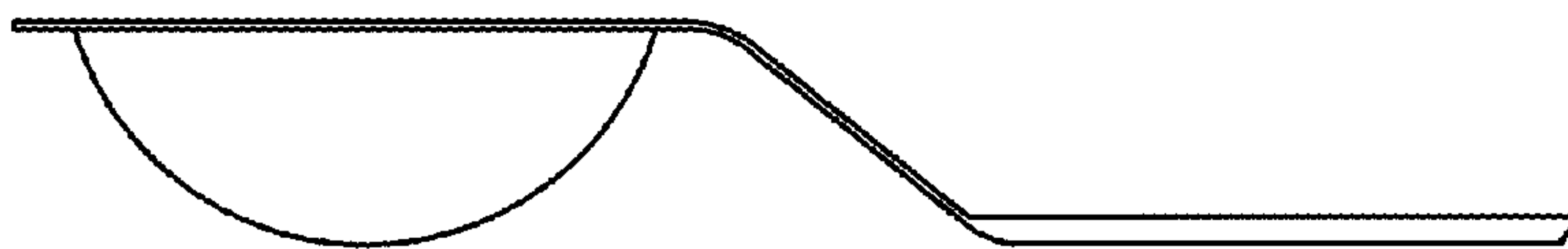

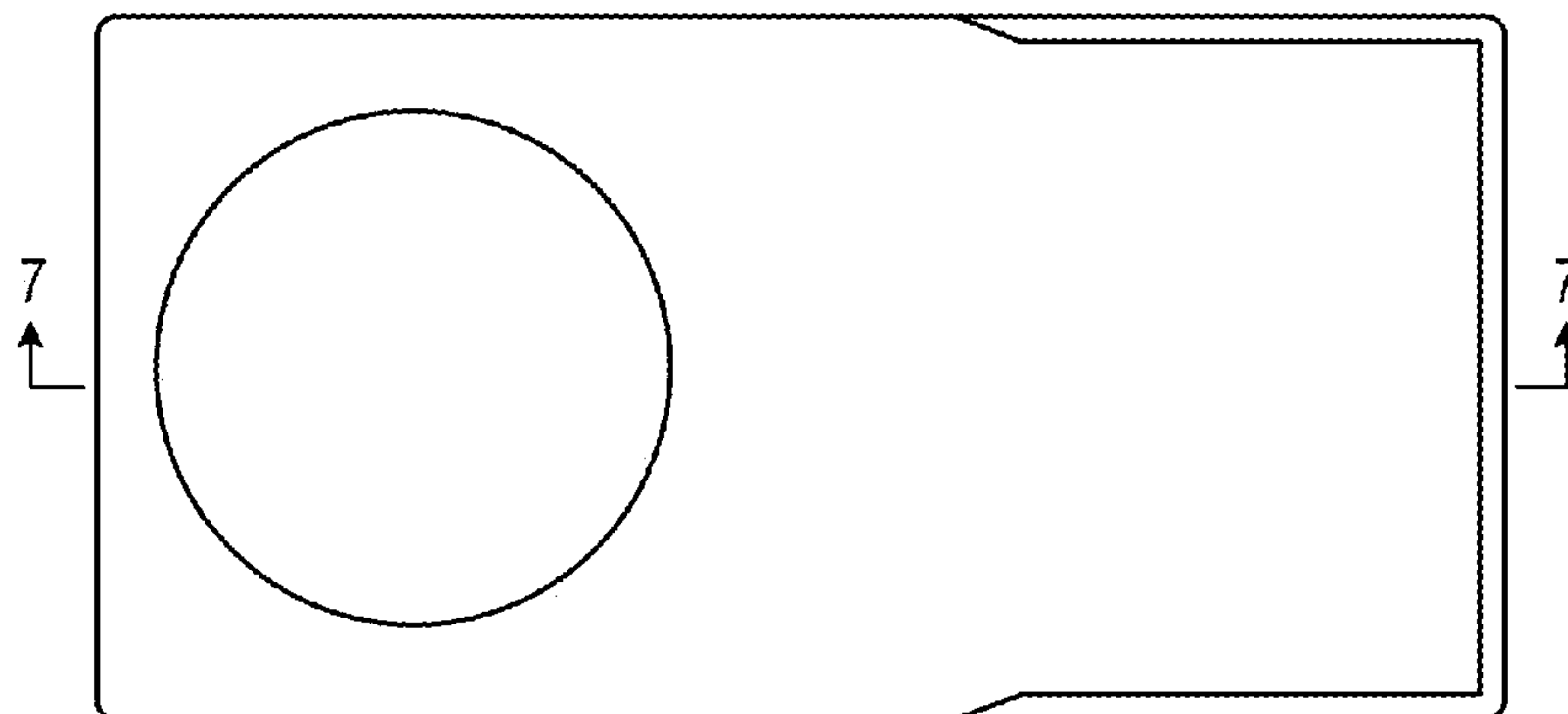

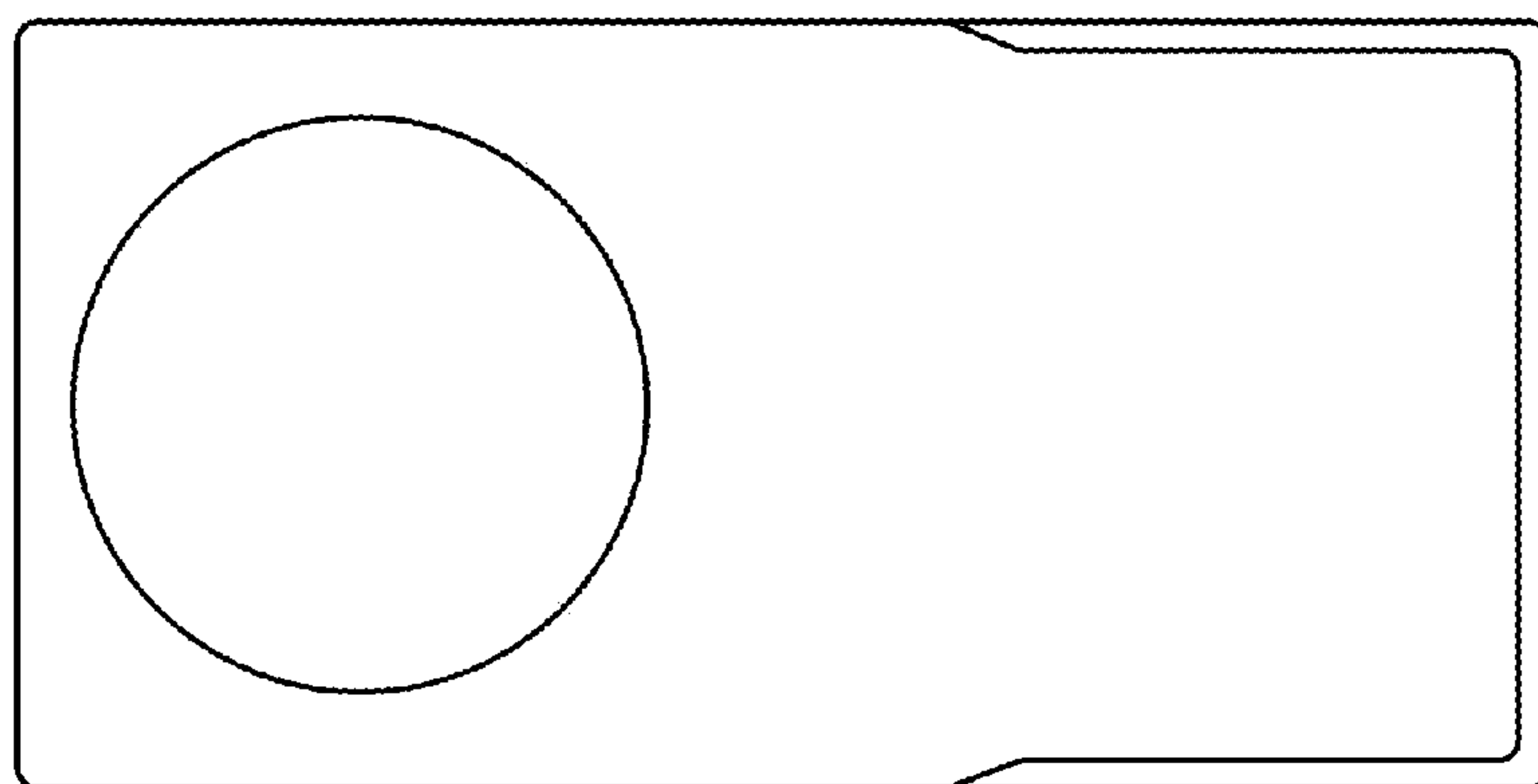

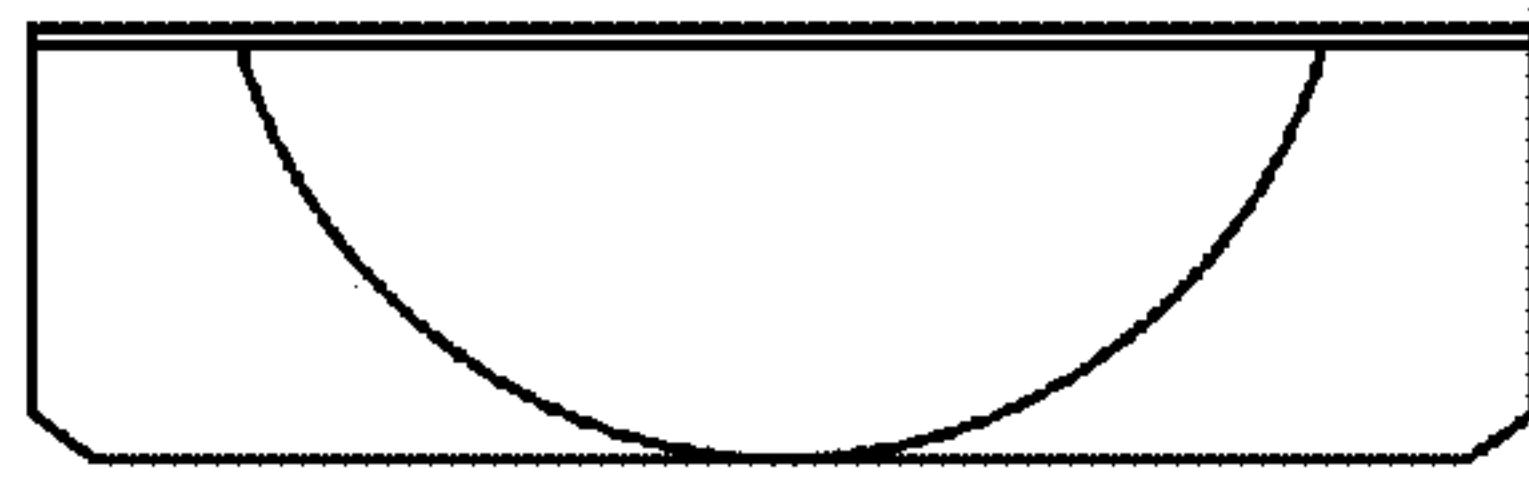

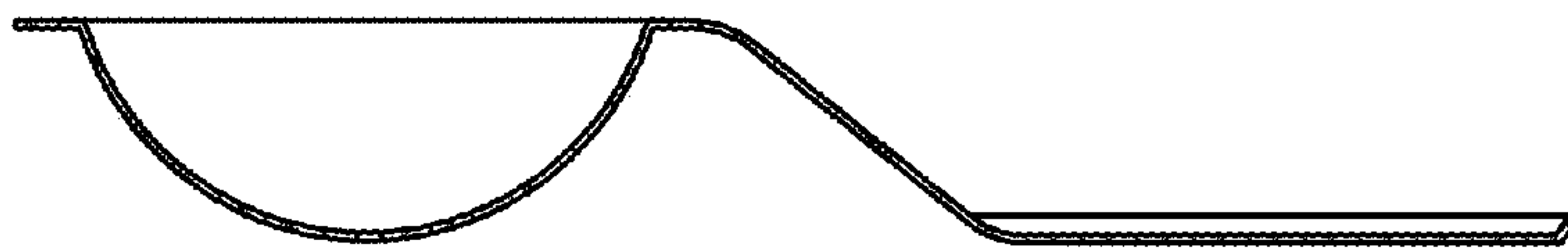
