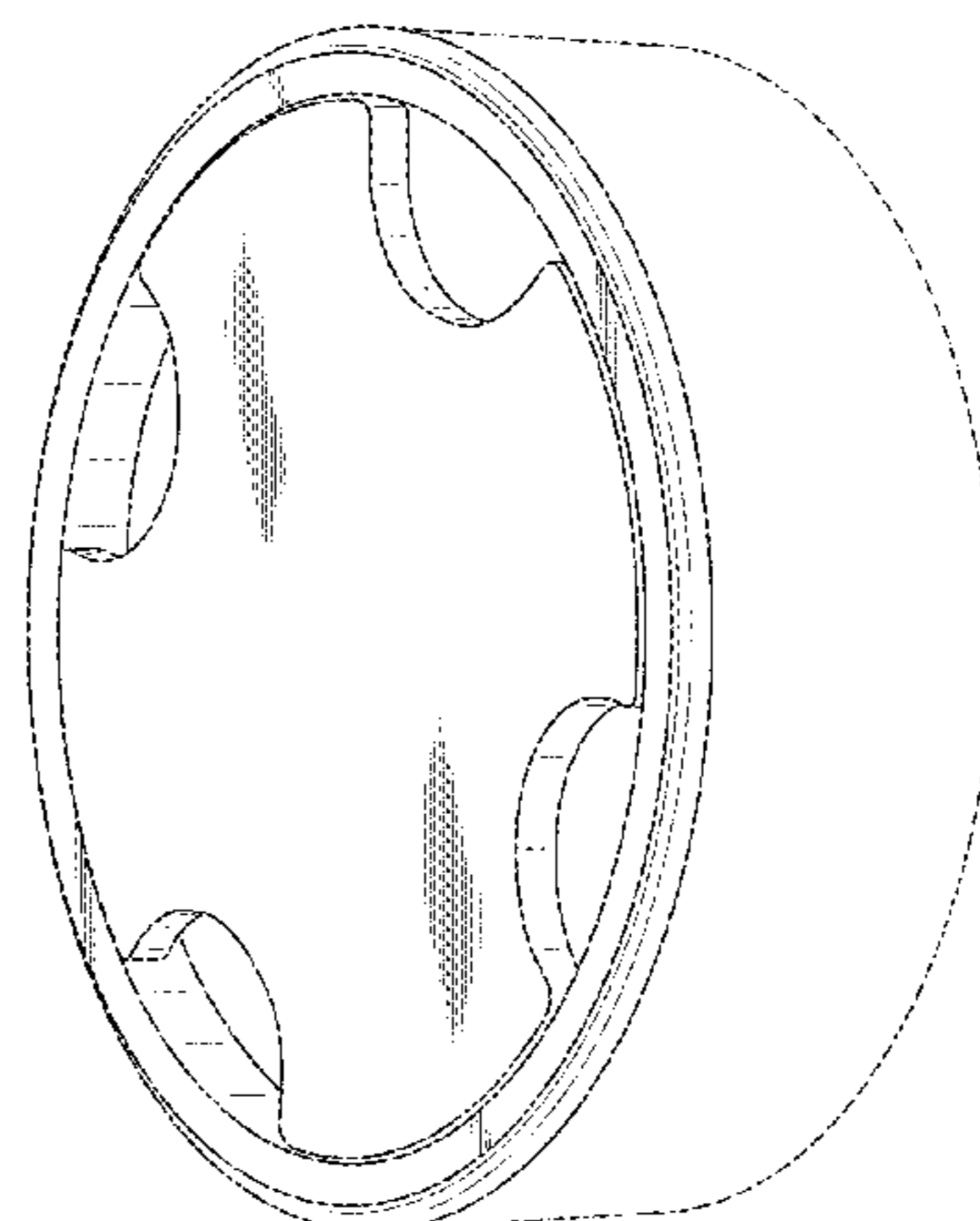
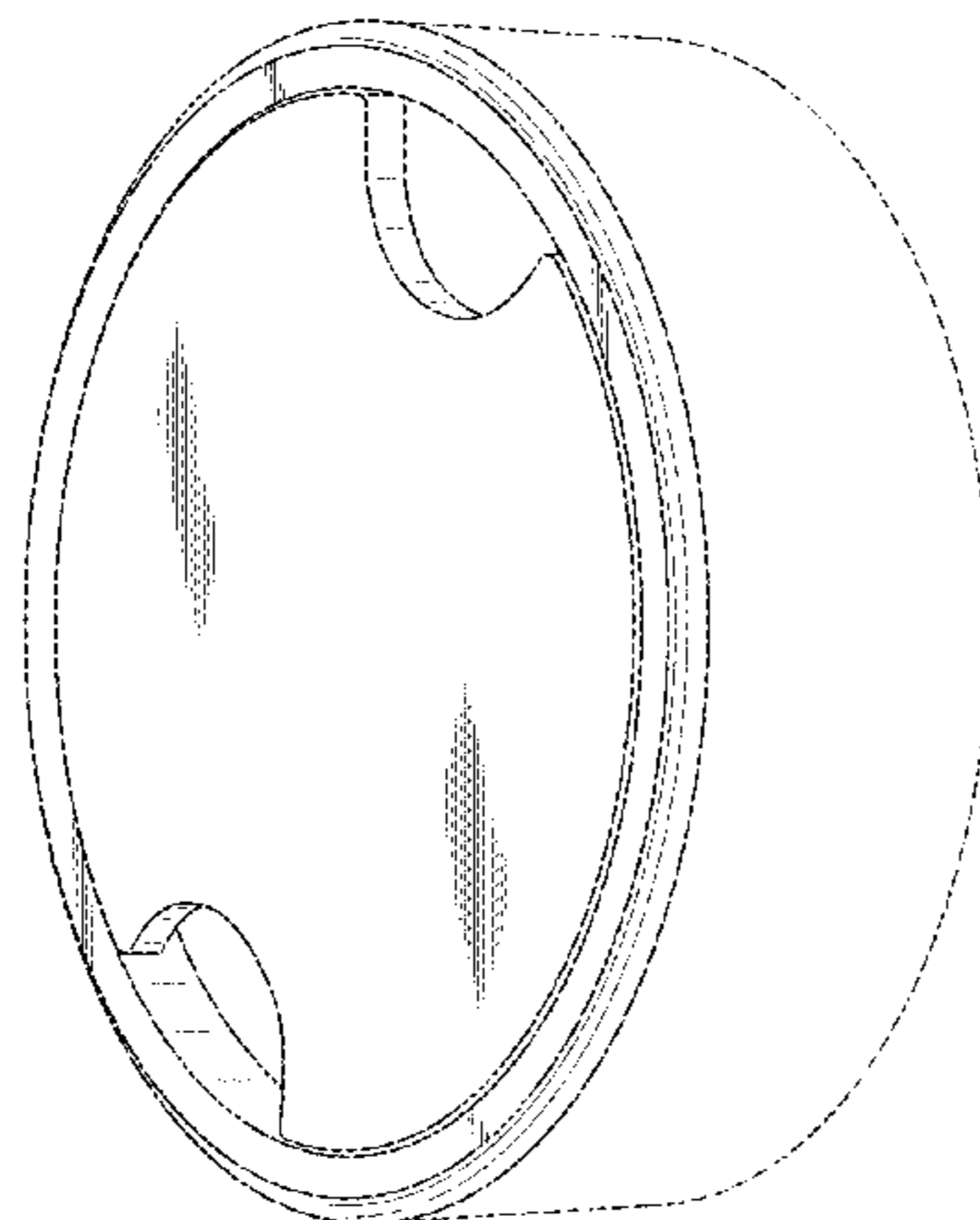
(57) **CLAIM**

We claim the ornamental design for a tobacco box, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing an embodiment of the new design for a tobacco box;  
FIG. 2 is a top view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is a perspective view showing a second embodiment of the new design for a tobacco box;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a side view thereof.  
The broken lines immediately adjacent to the shaded areas represent the bounds of the claim. Only the surfaces with applied surface shading are included in the claimed design. Those surface areas with no surface shading and the broken lines illustrate the portions of the design that form no part of the claim.

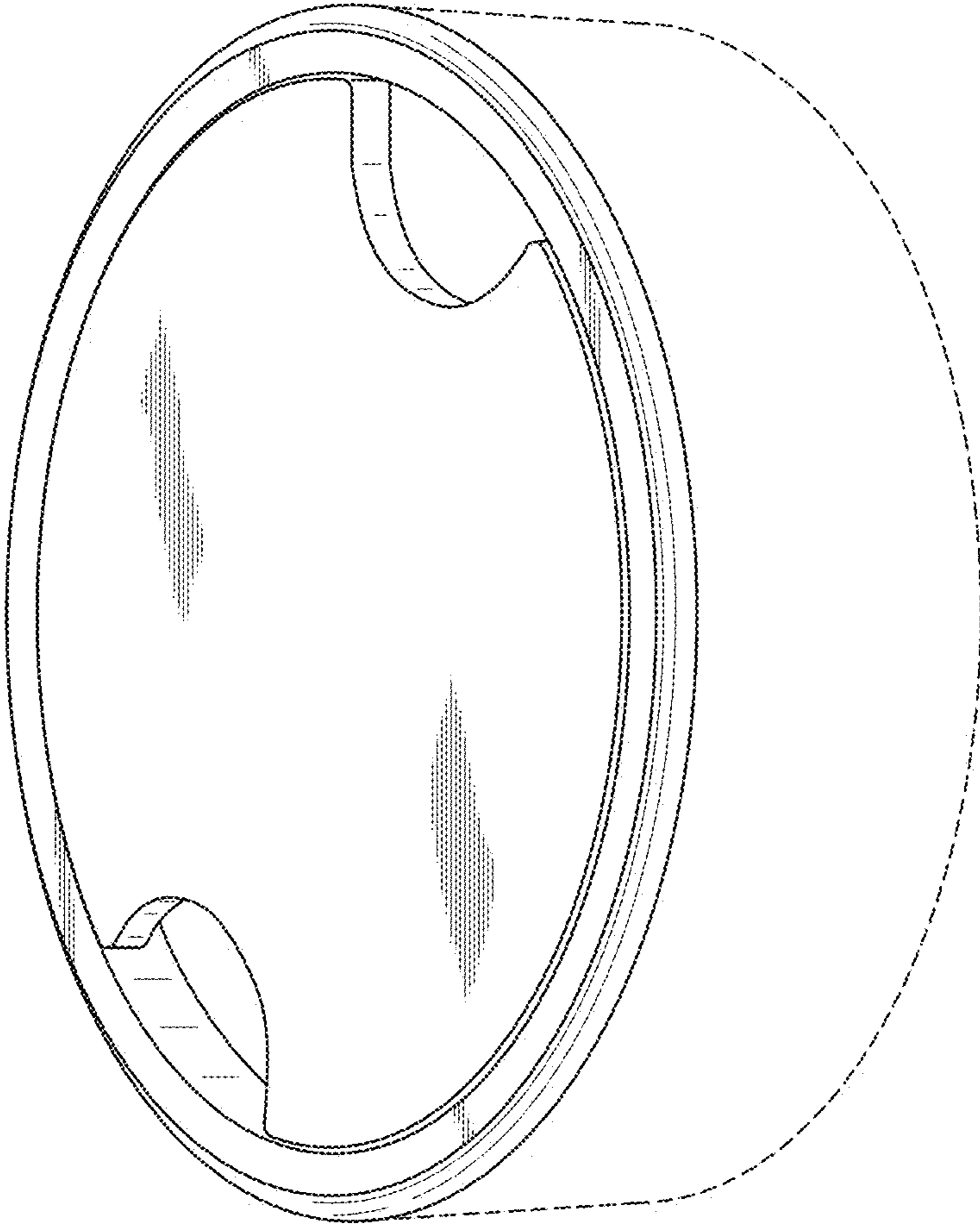

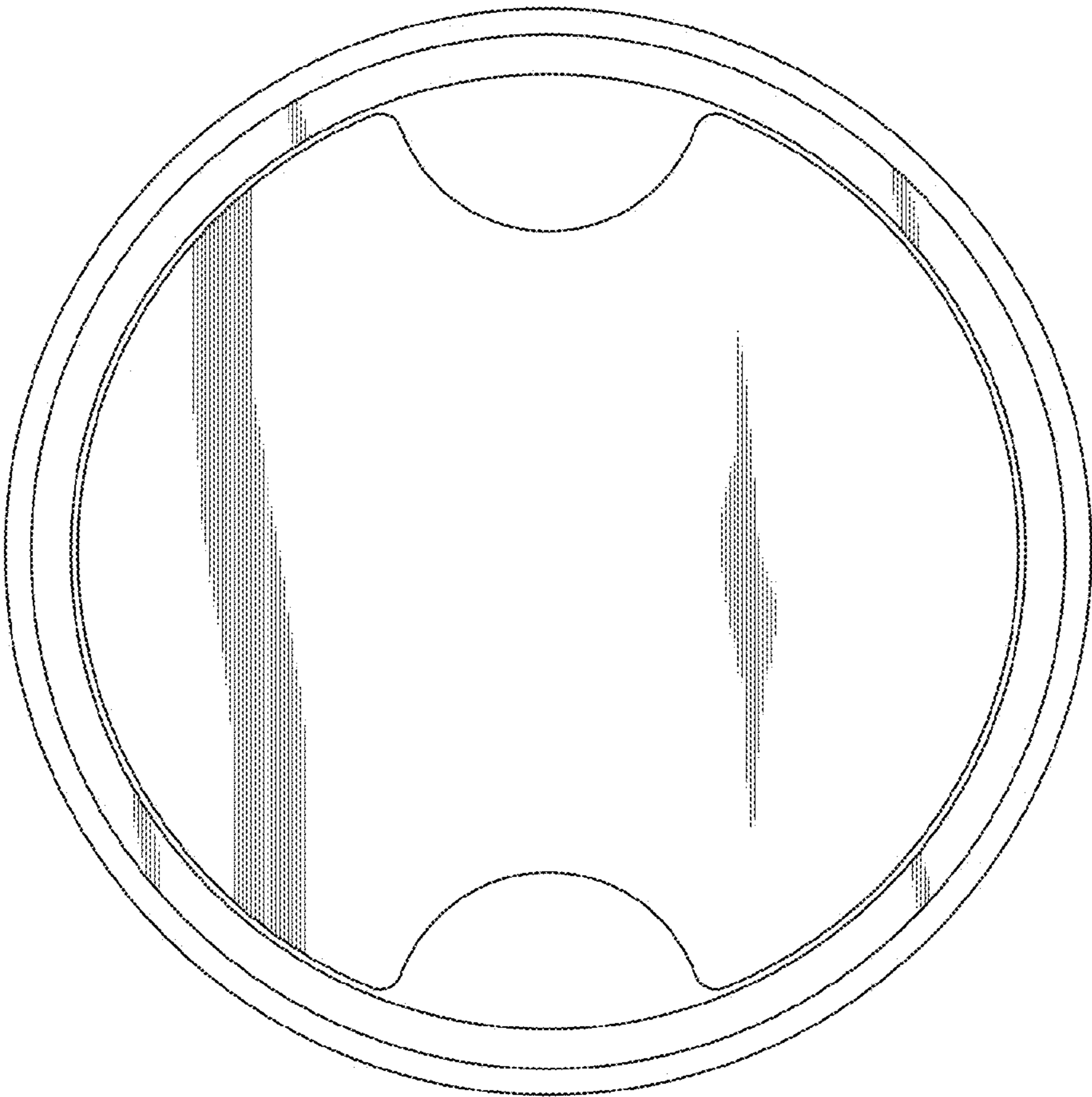

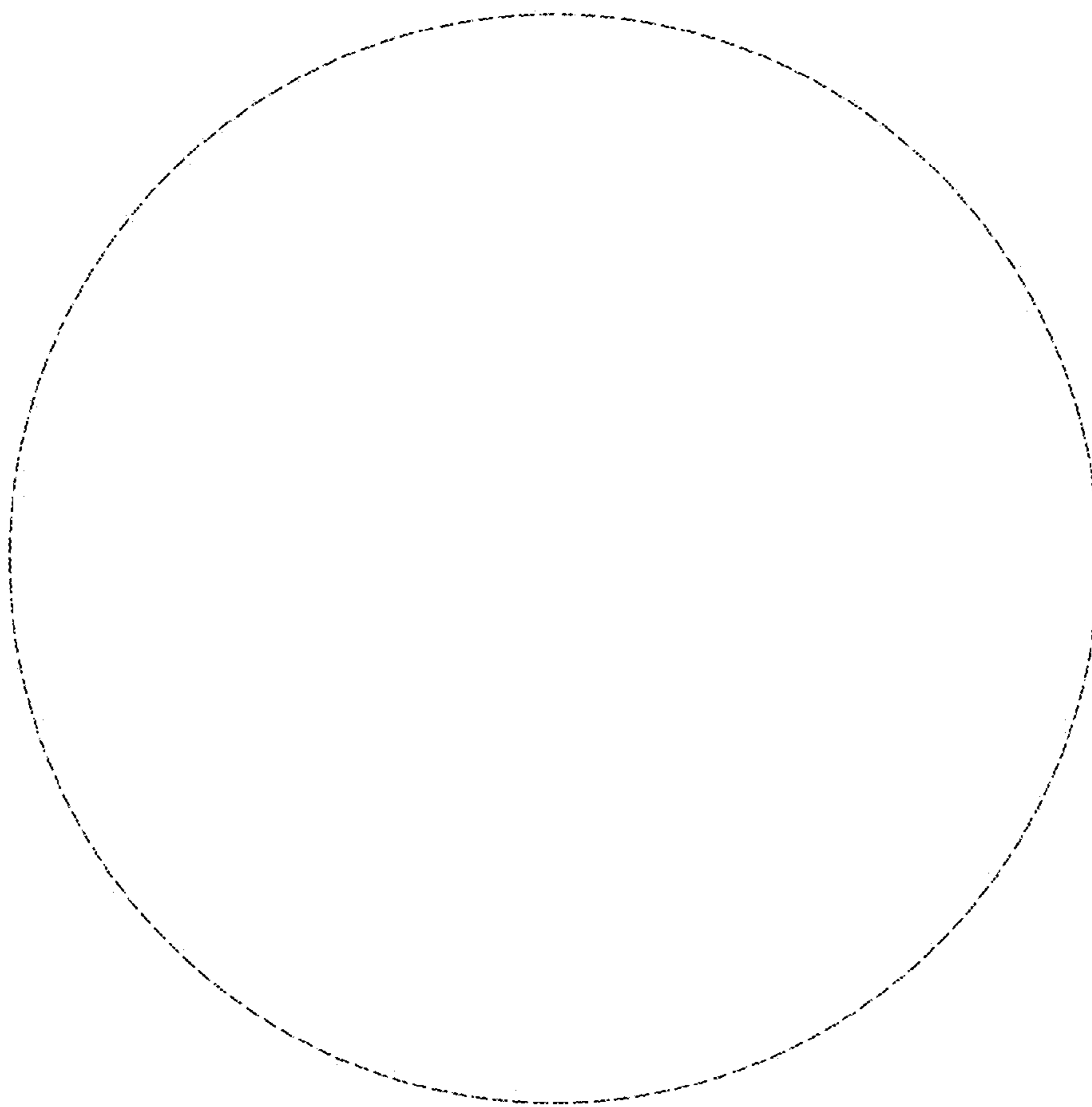

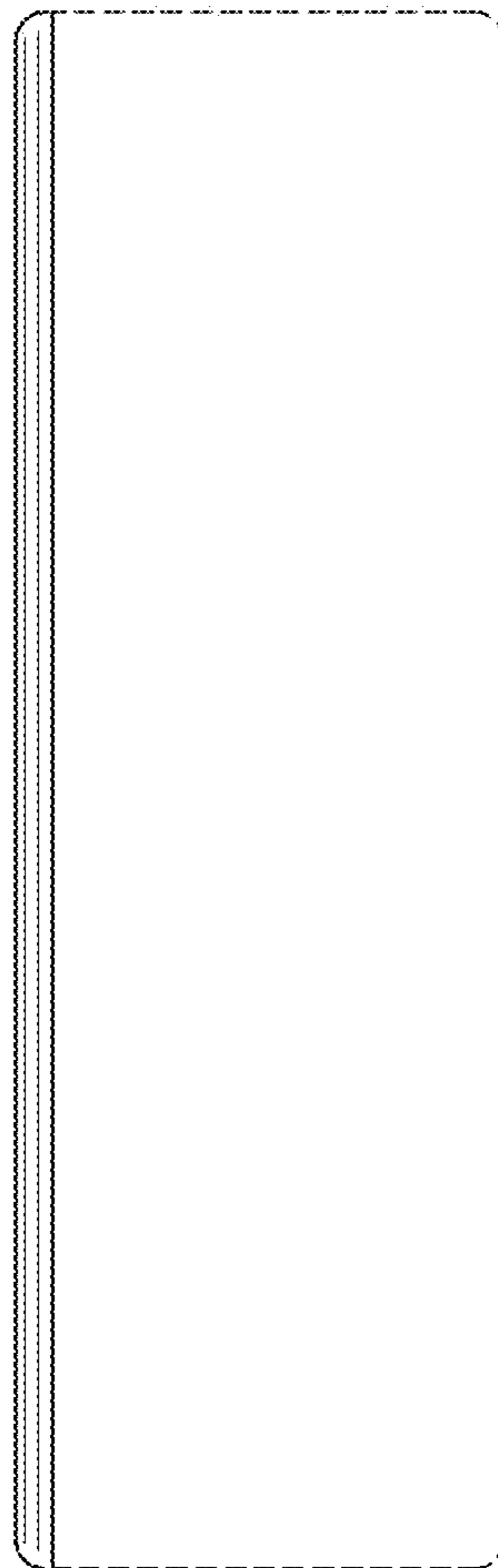

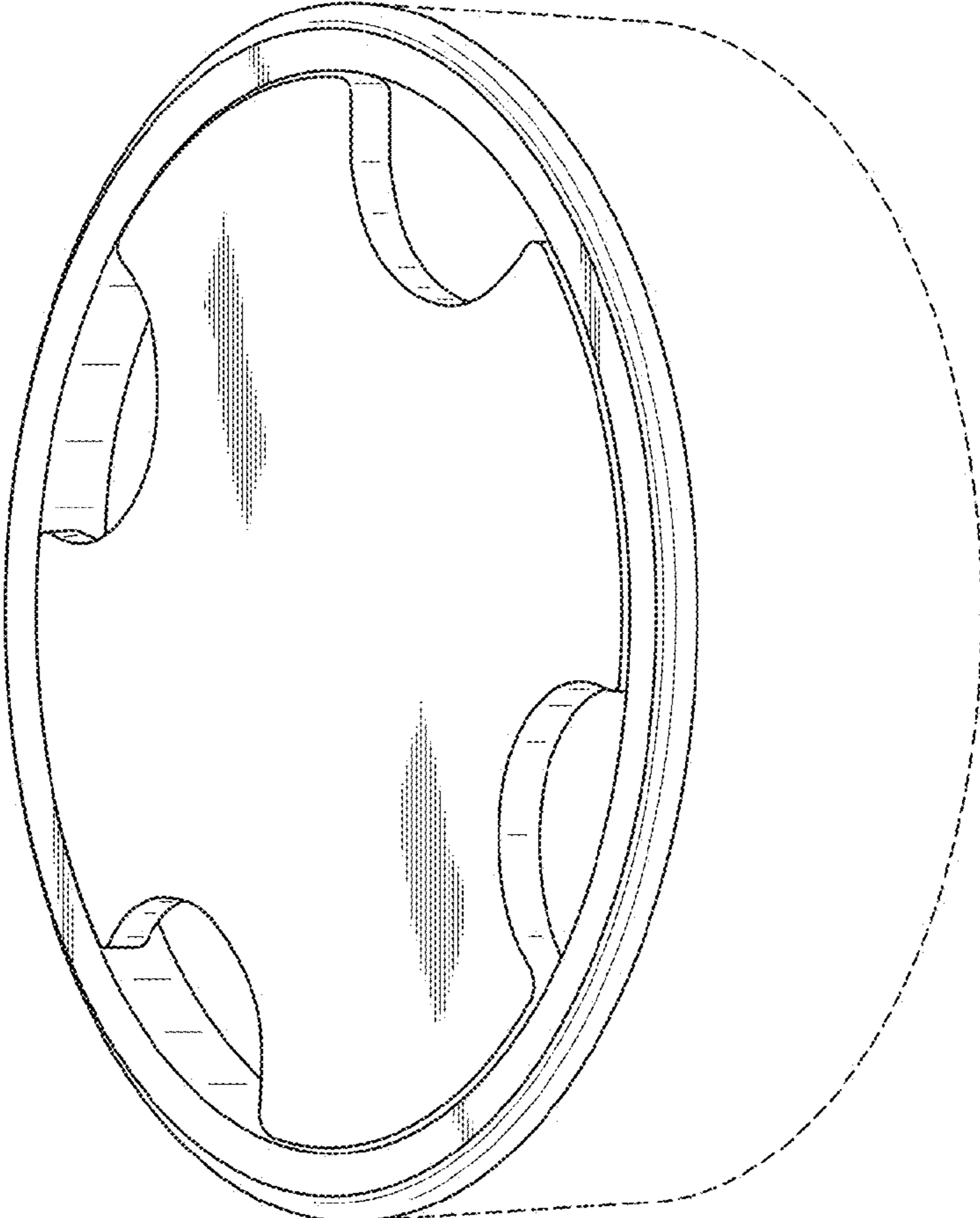

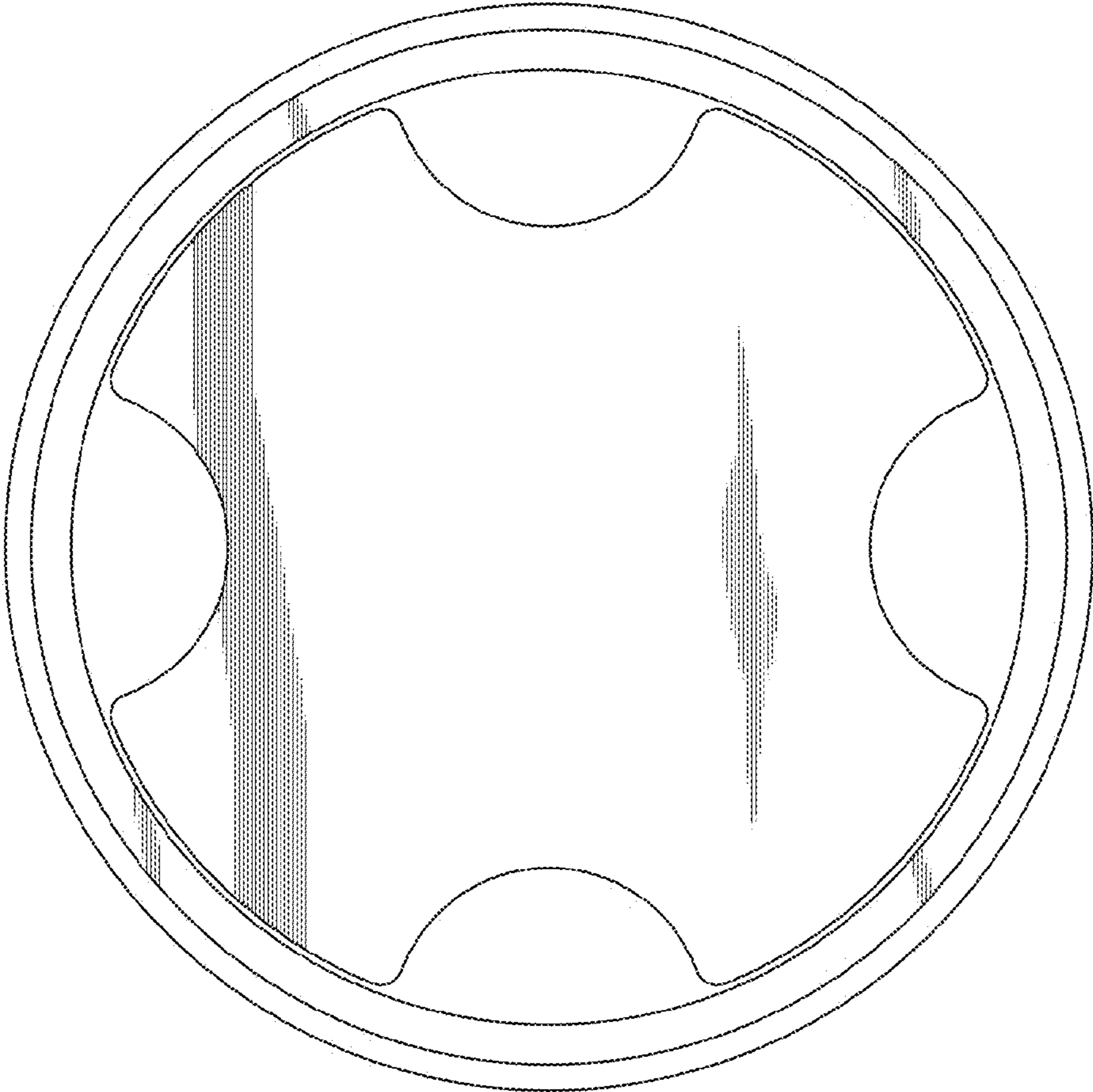

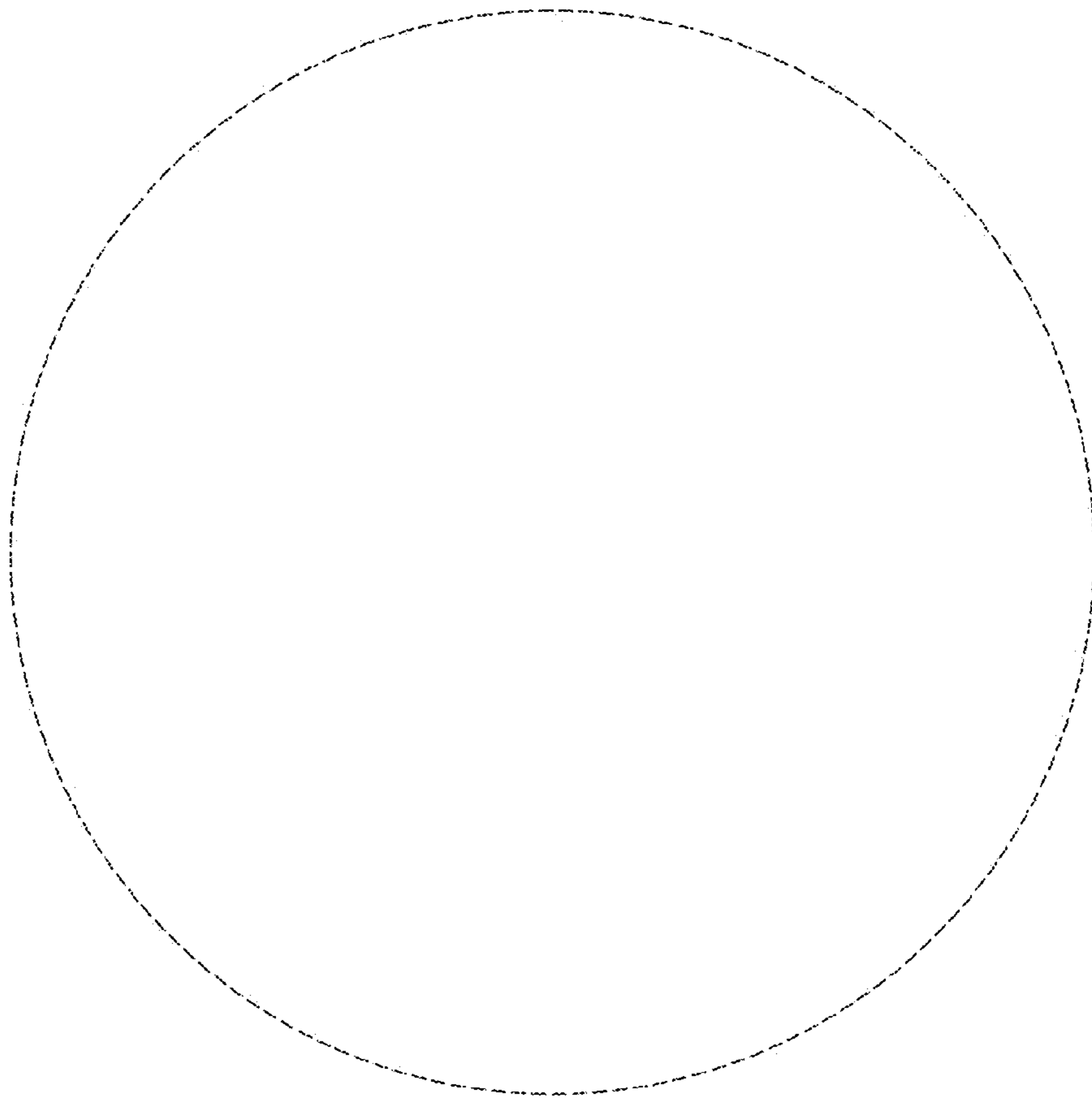

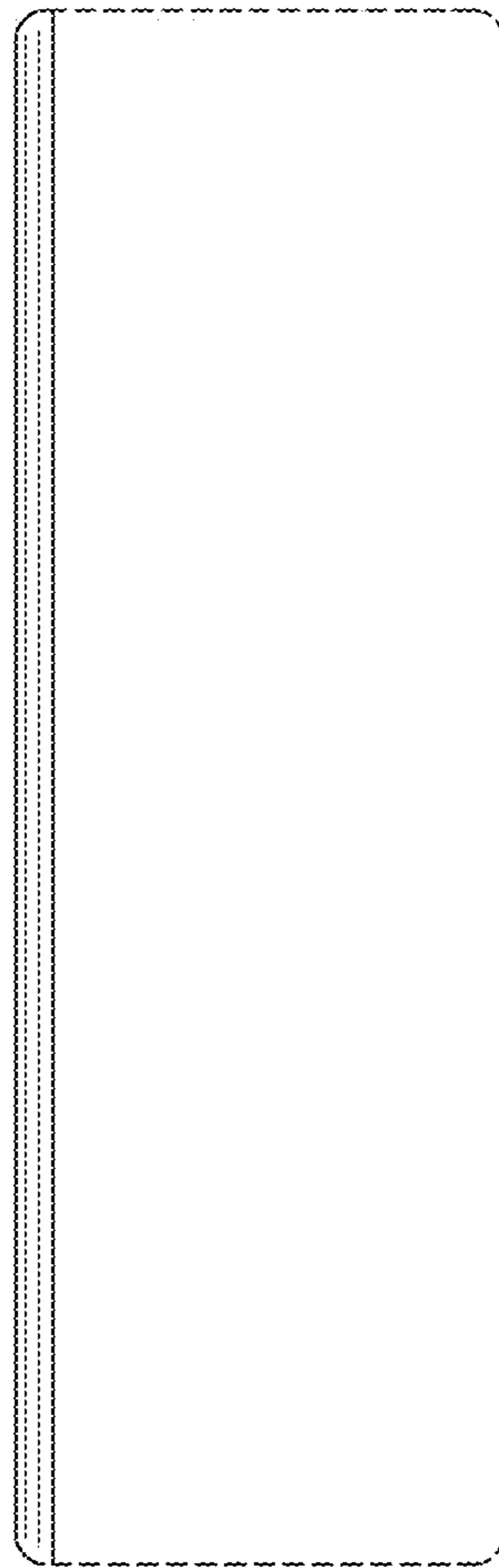
