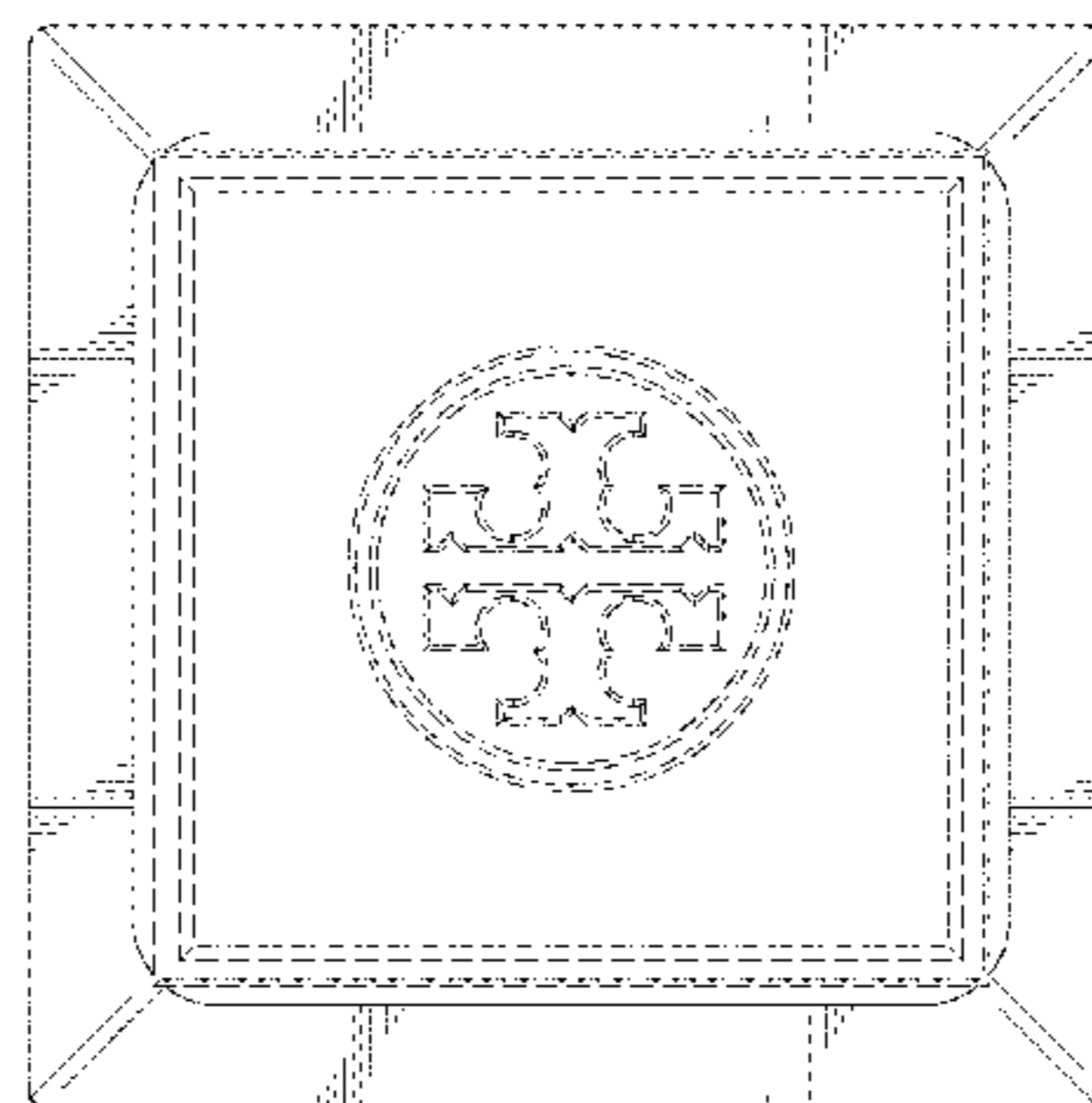
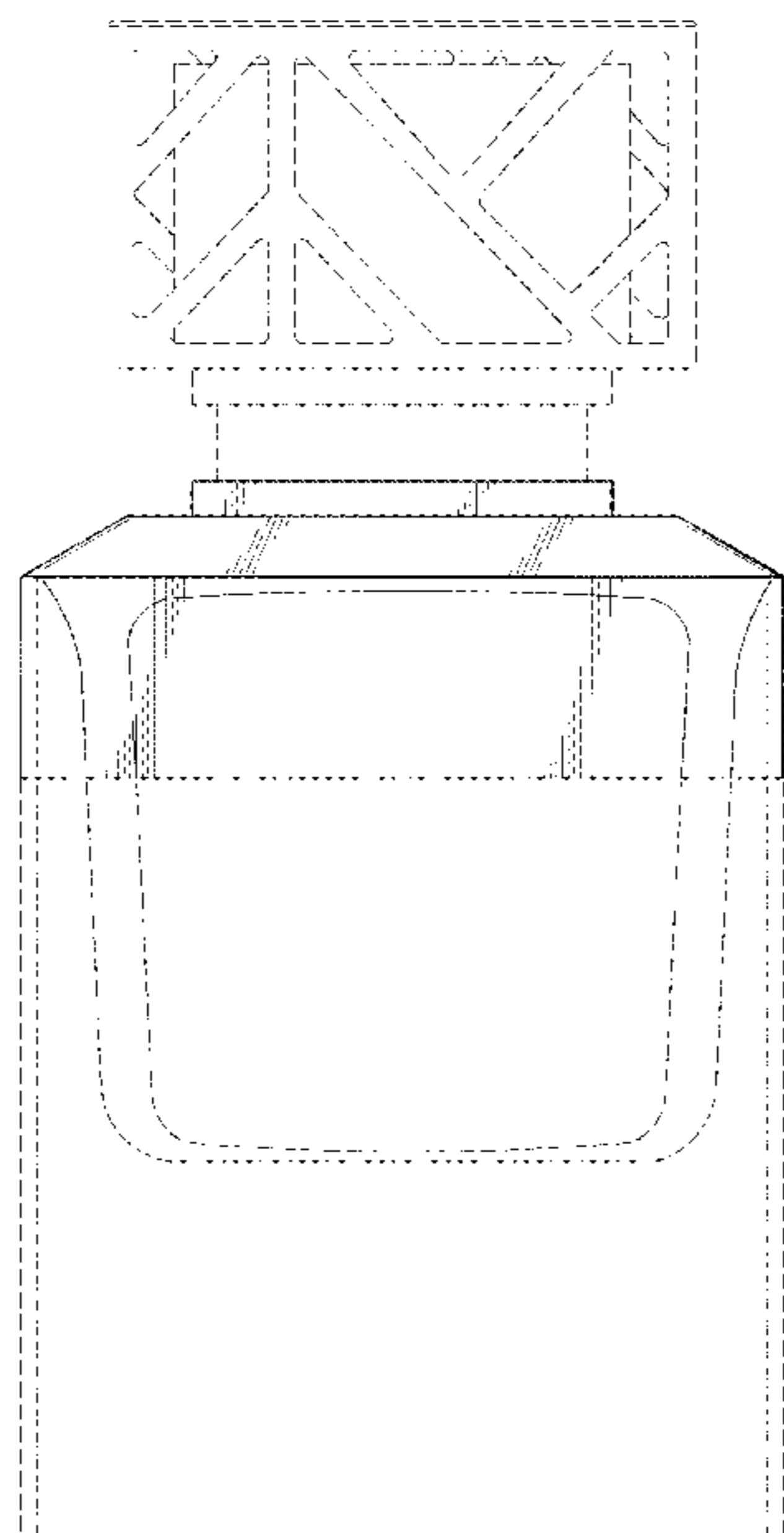
(57) **CLAIM**

The ornamental design for a perfume bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a perfume bottle.  
FIG. 2 is a front view of the perfume bottle of FIG. 1.  
FIG. 3 is a right side view of the perfume bottle of FIG. 1, the left side view being a mirror image of the right side view; and, FIG. 4 is a top view of the perfume bottle of FIG. 1.

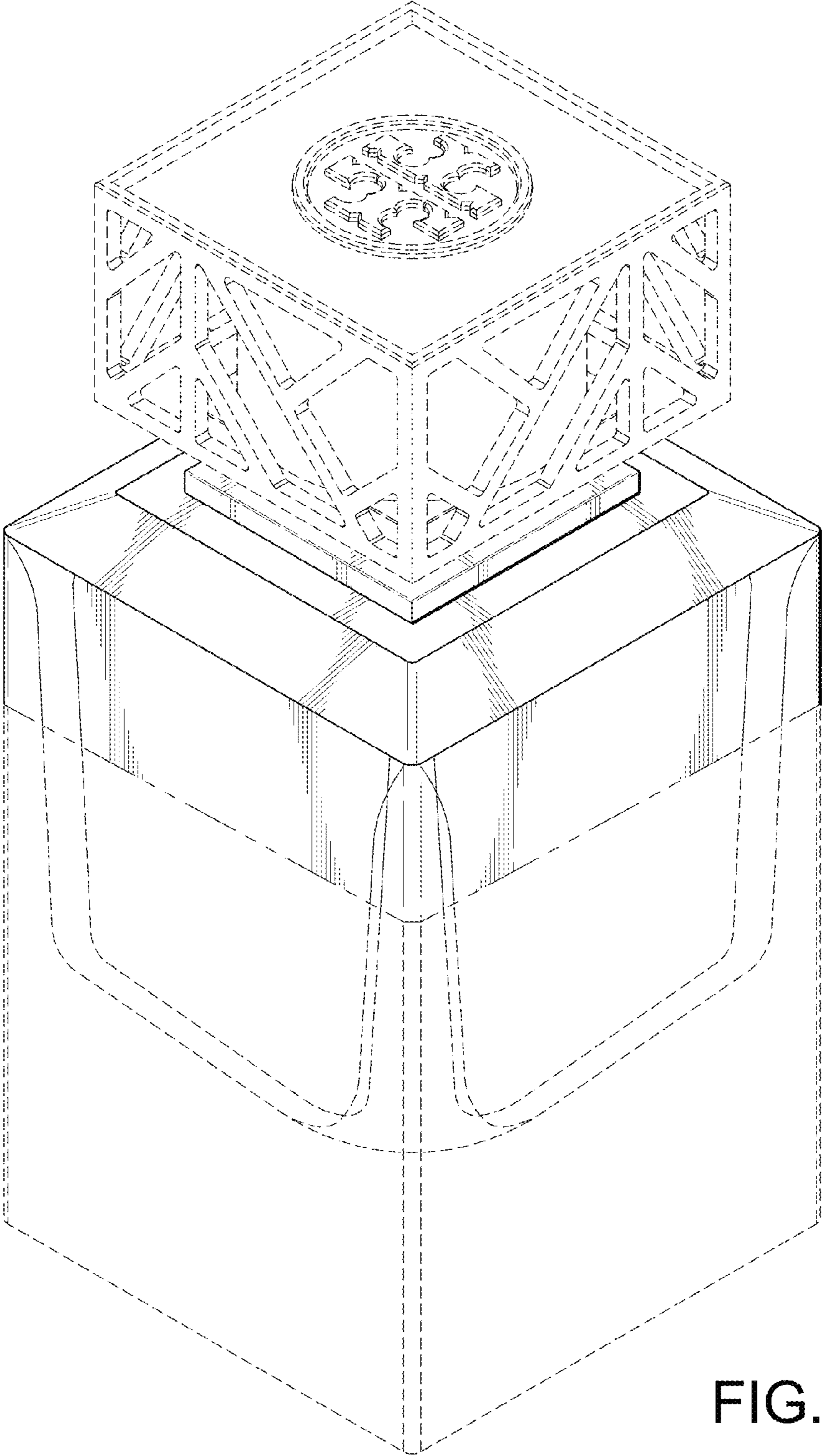

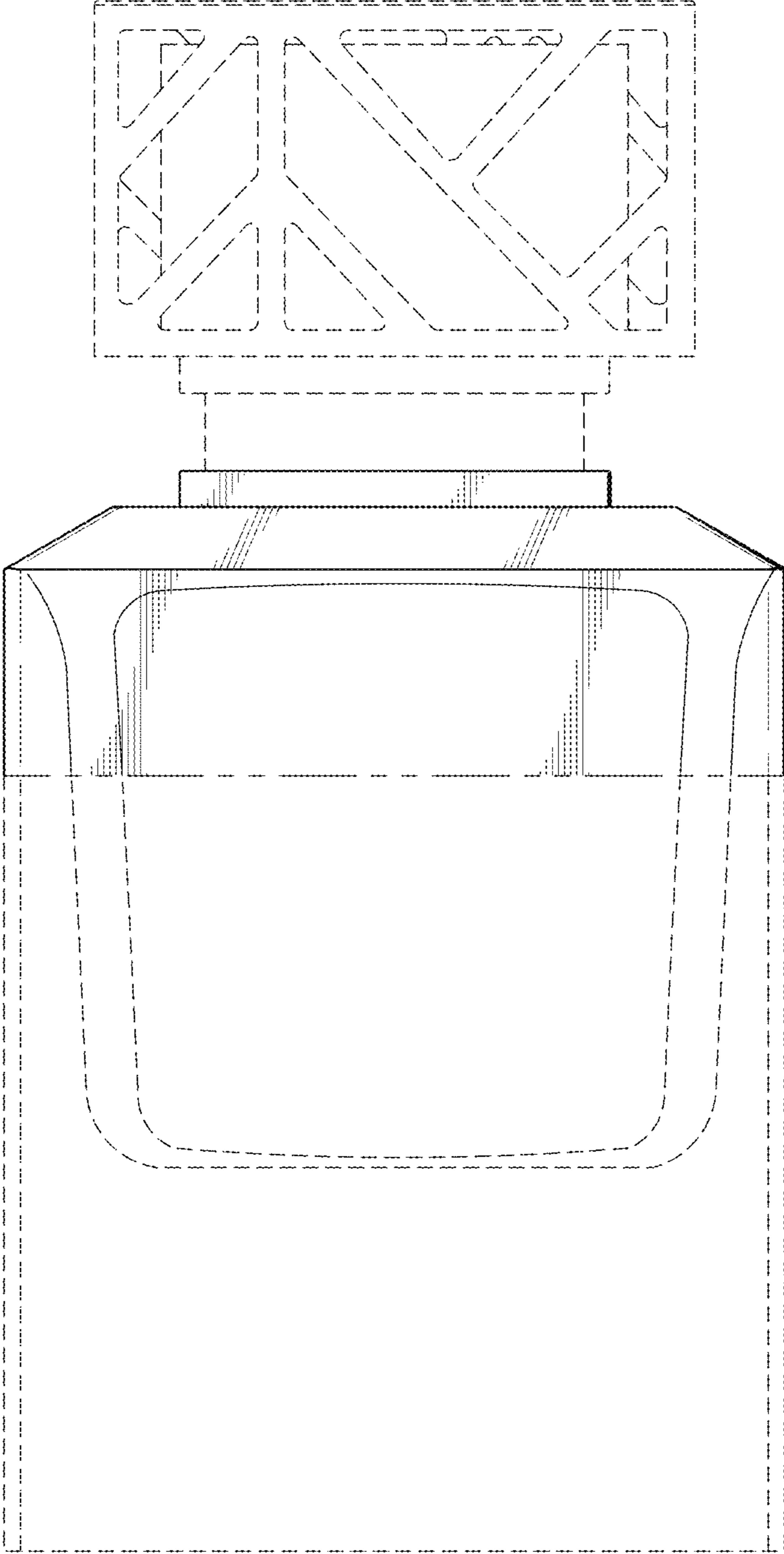

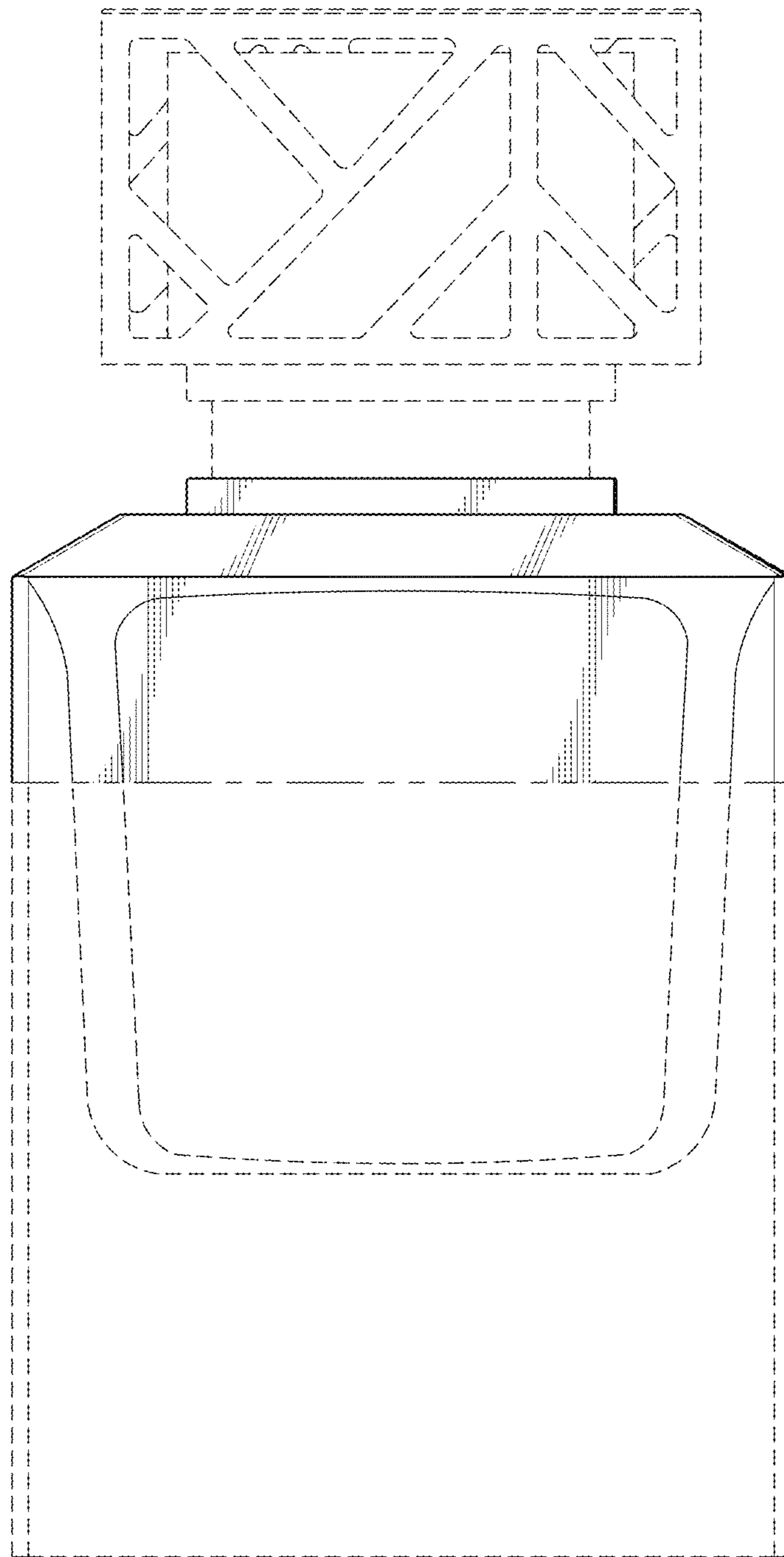

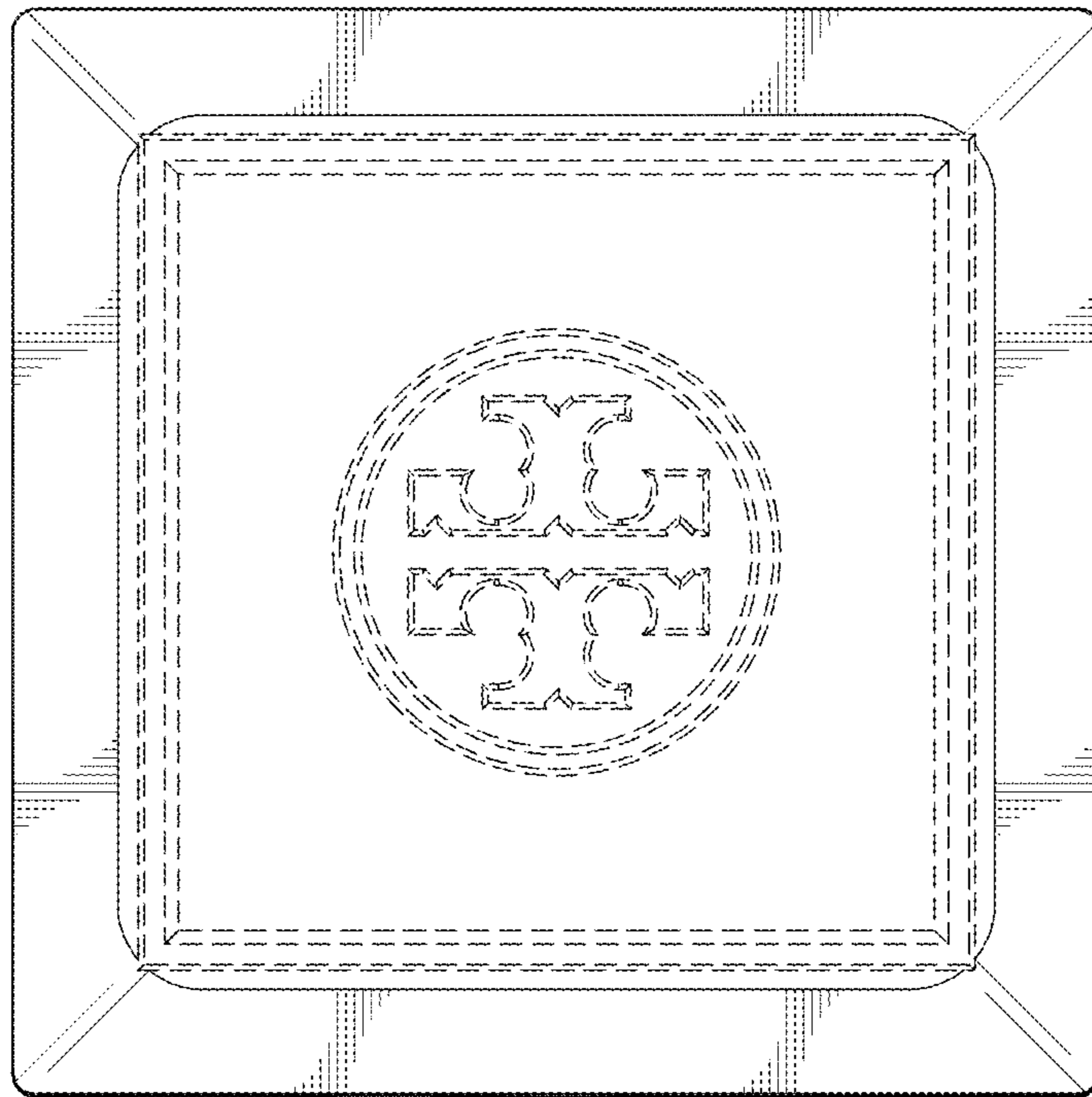
