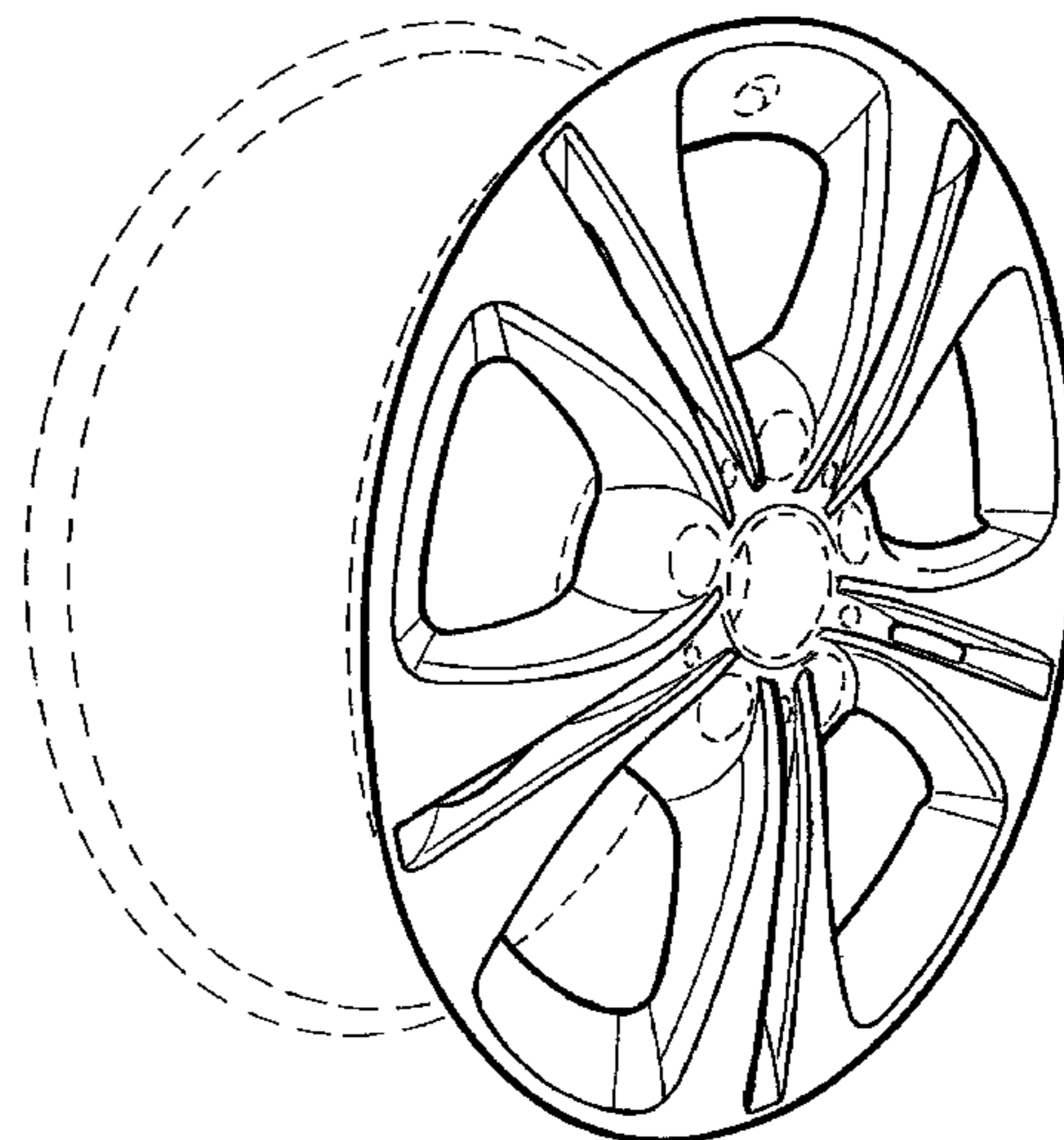
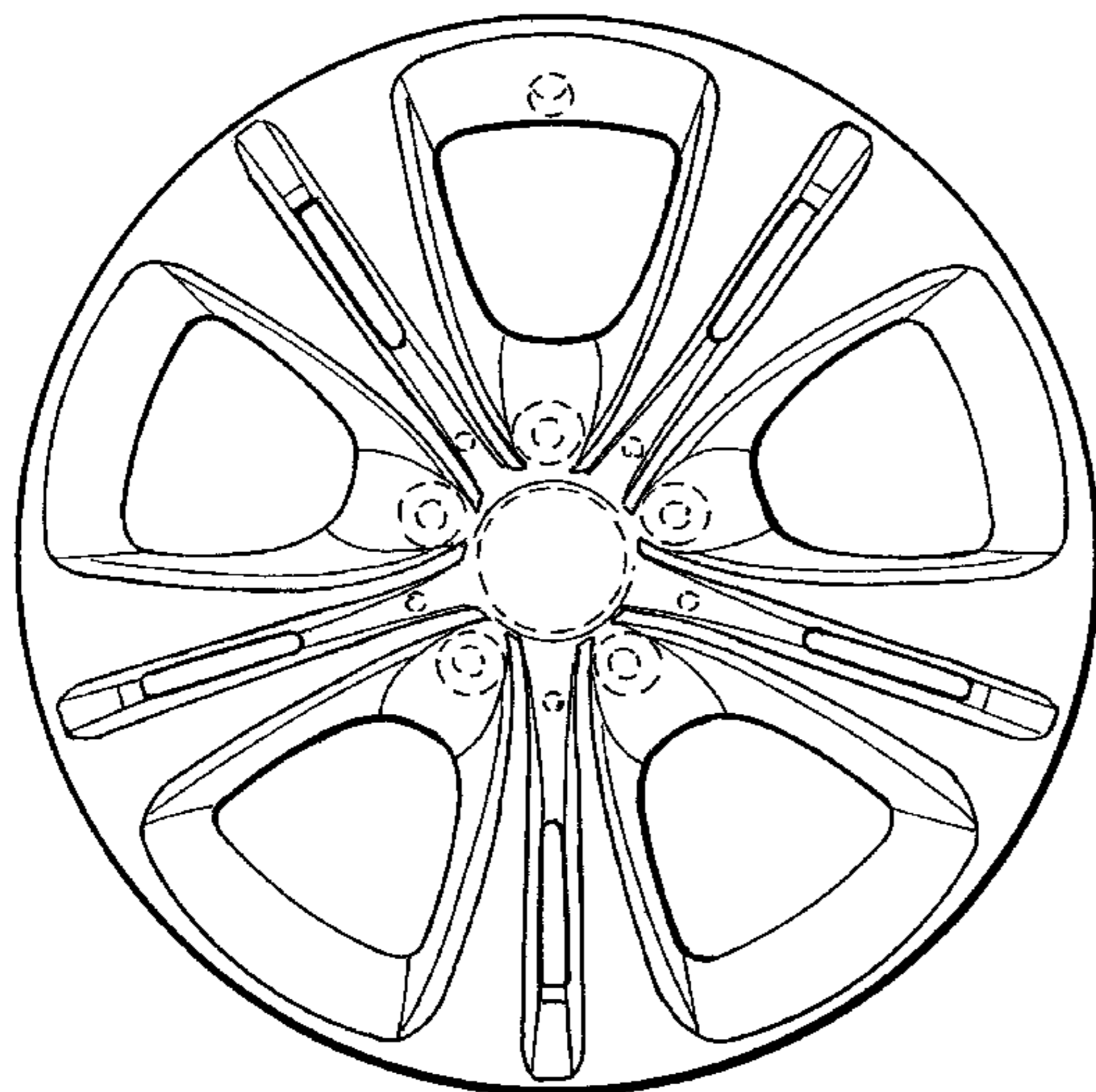
(57) **CLAIM**

The ornamental design for a wheel or wheel cover, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a wheel or wheel cover according to the design; and,
FIG. 2 is a perspective view thereof.
The broken line showing of the rear of the wheel, the valve stem hole and the bolts holes and center hole in the central hub area is included for the purpose of illustrating environment and forms no part of the claimed design.

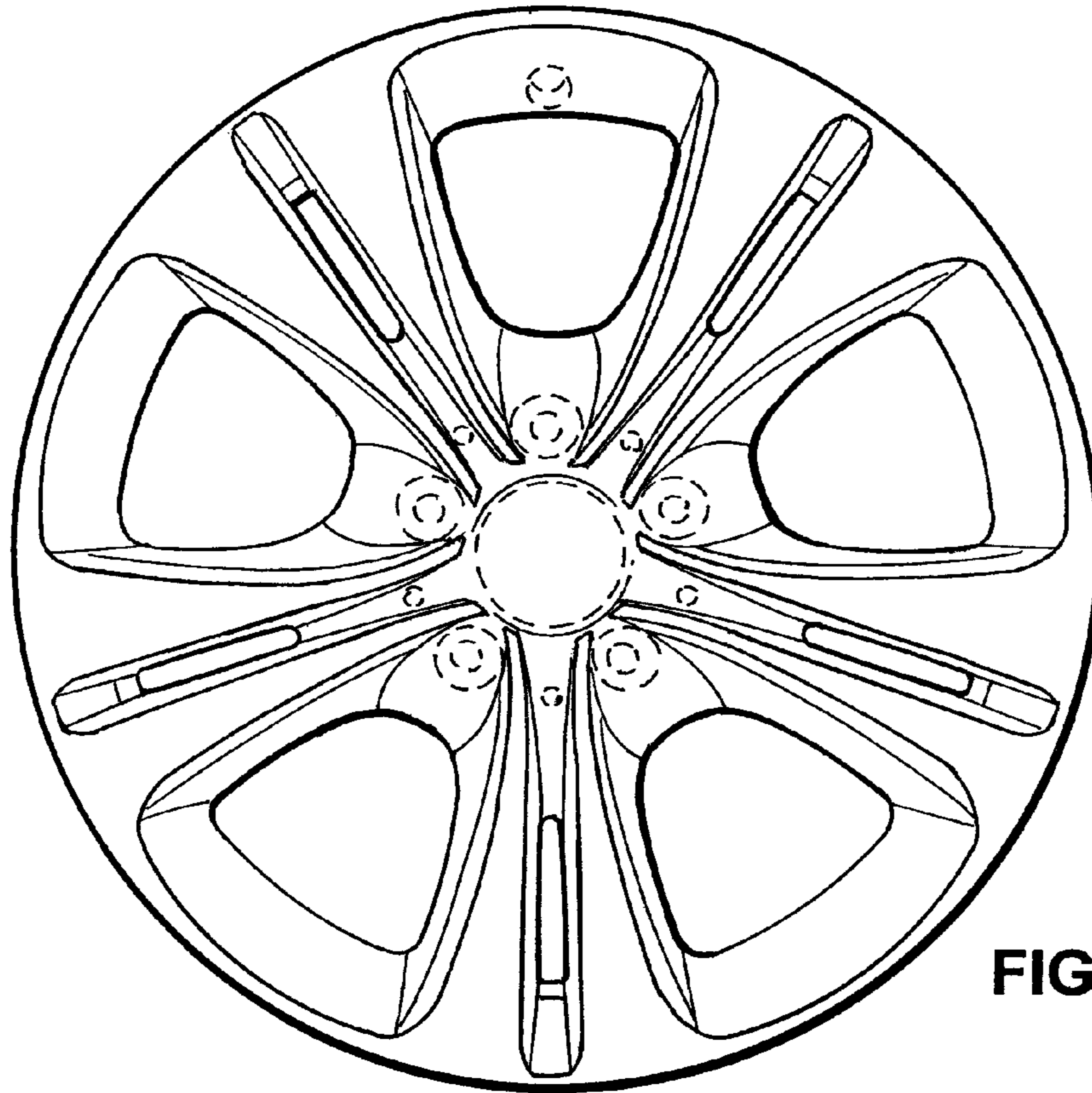

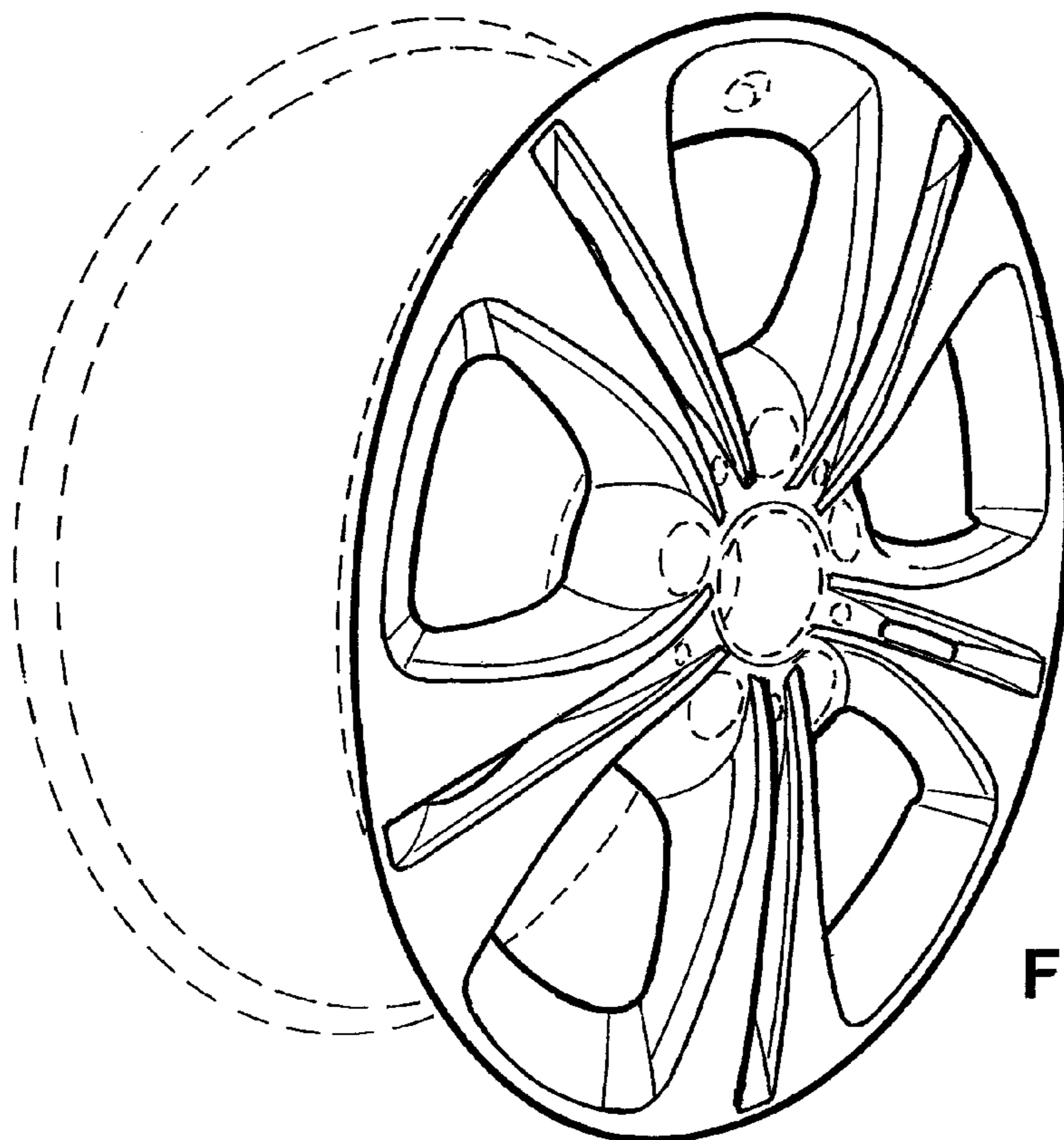
