(57) **CLAIM**

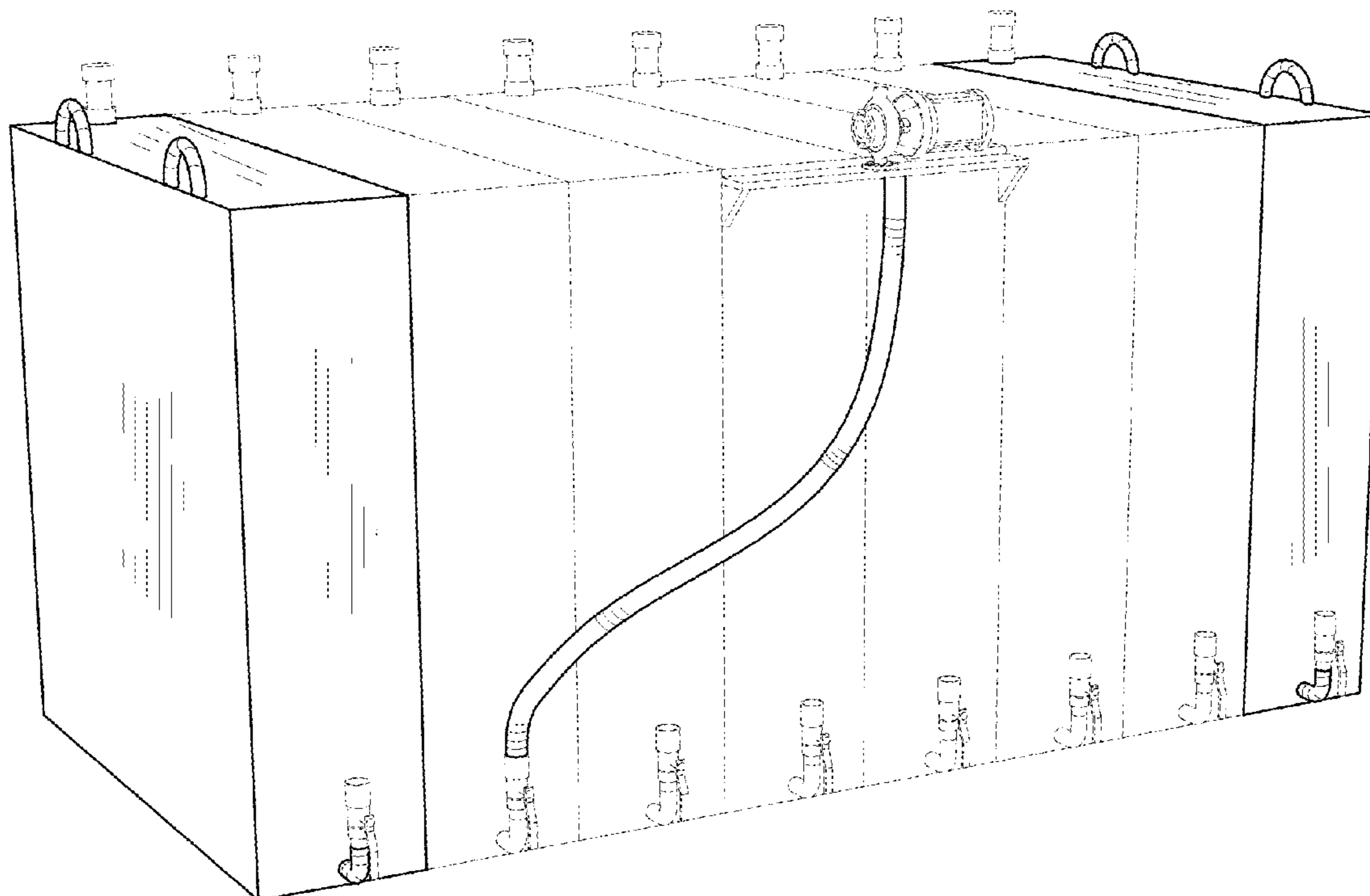
The ornamental design for a fuel tank, as shown and described.

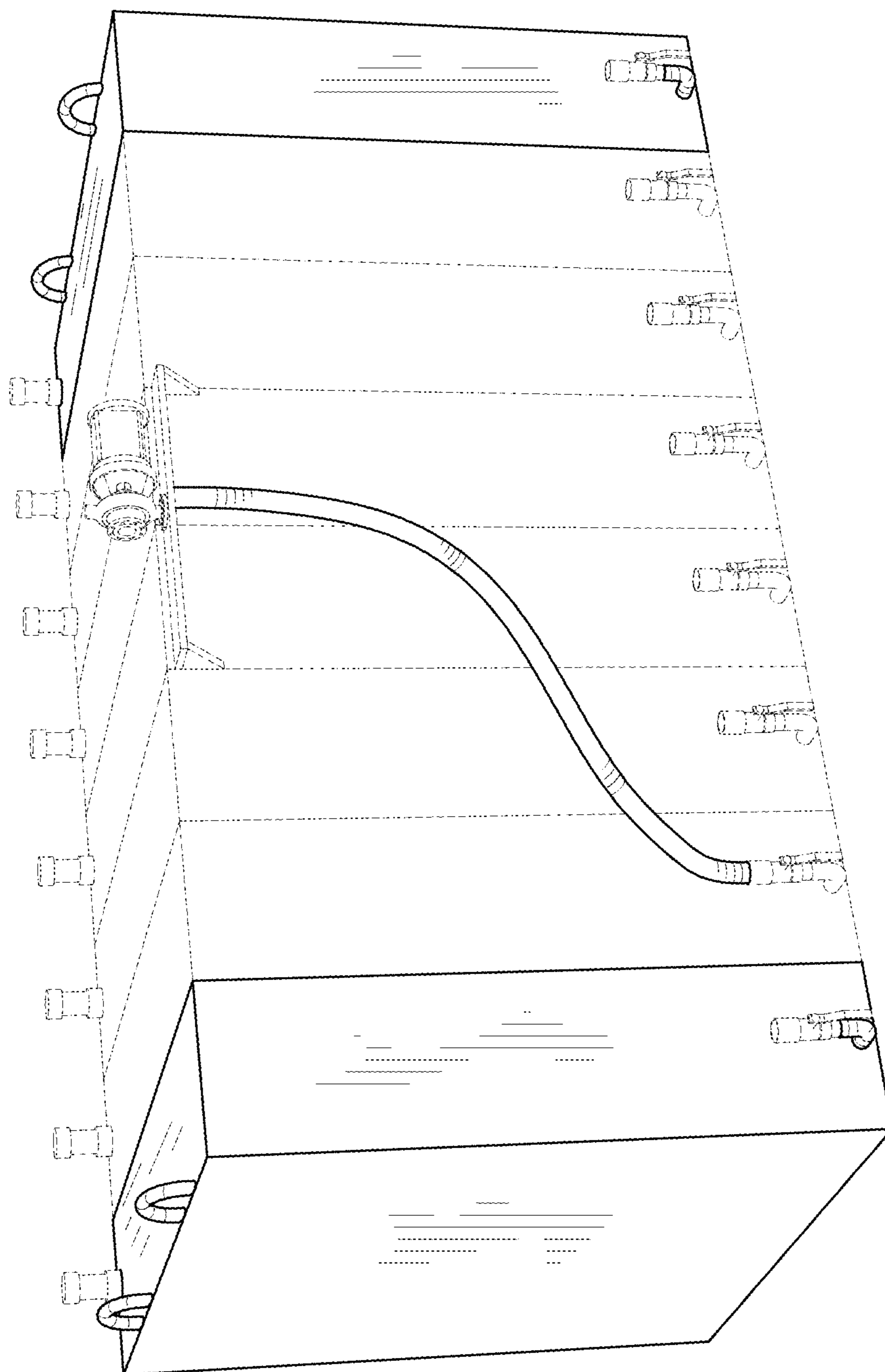

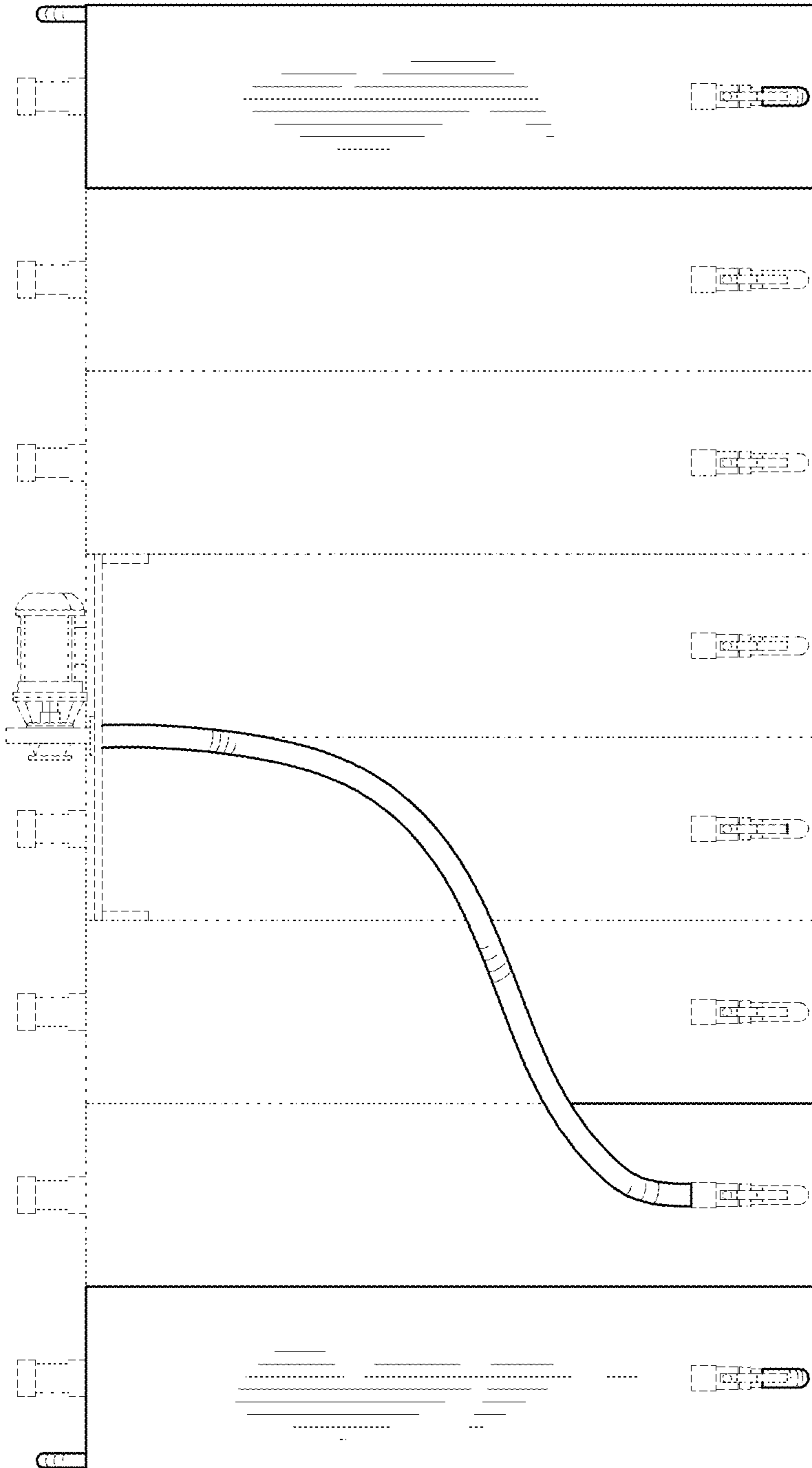

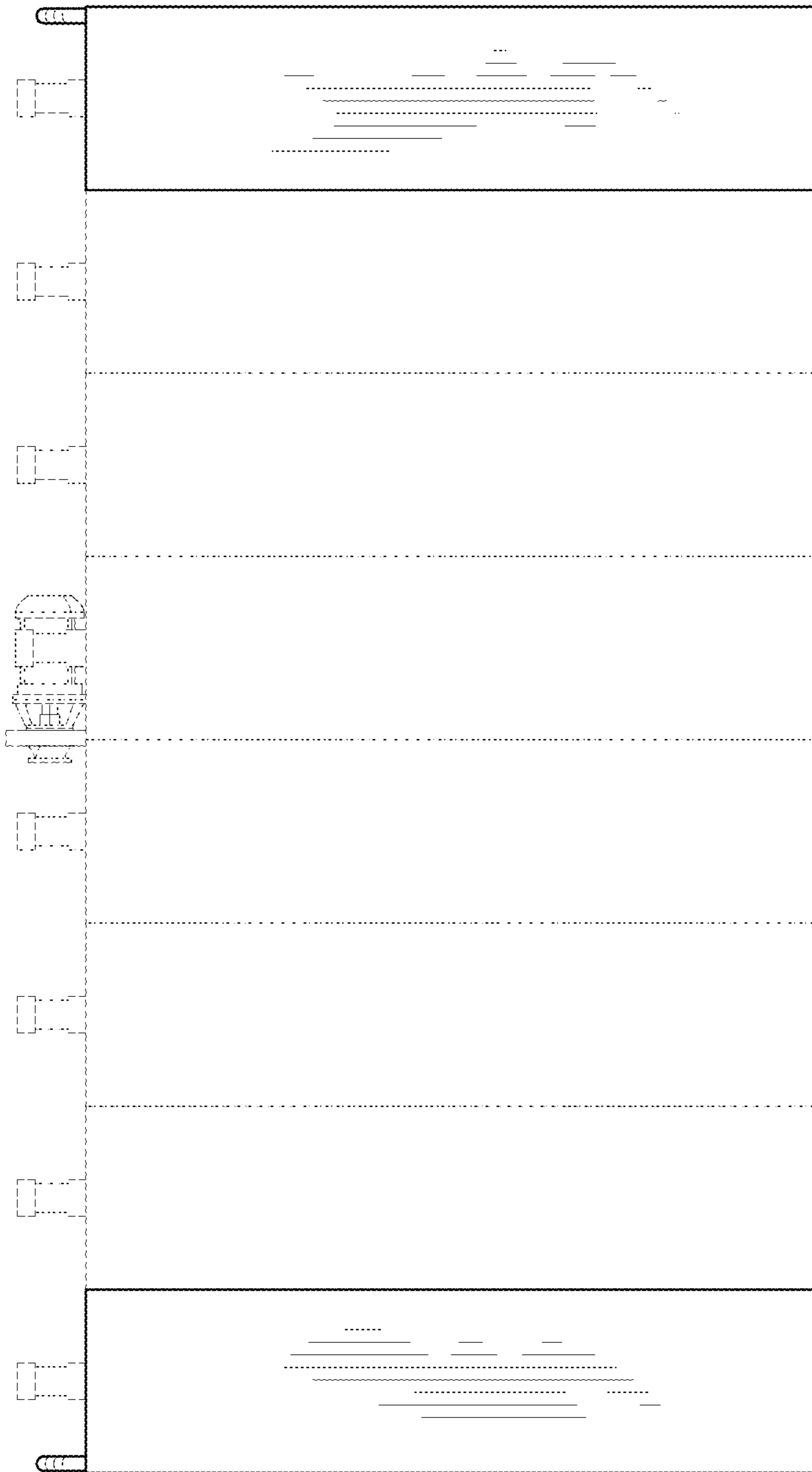

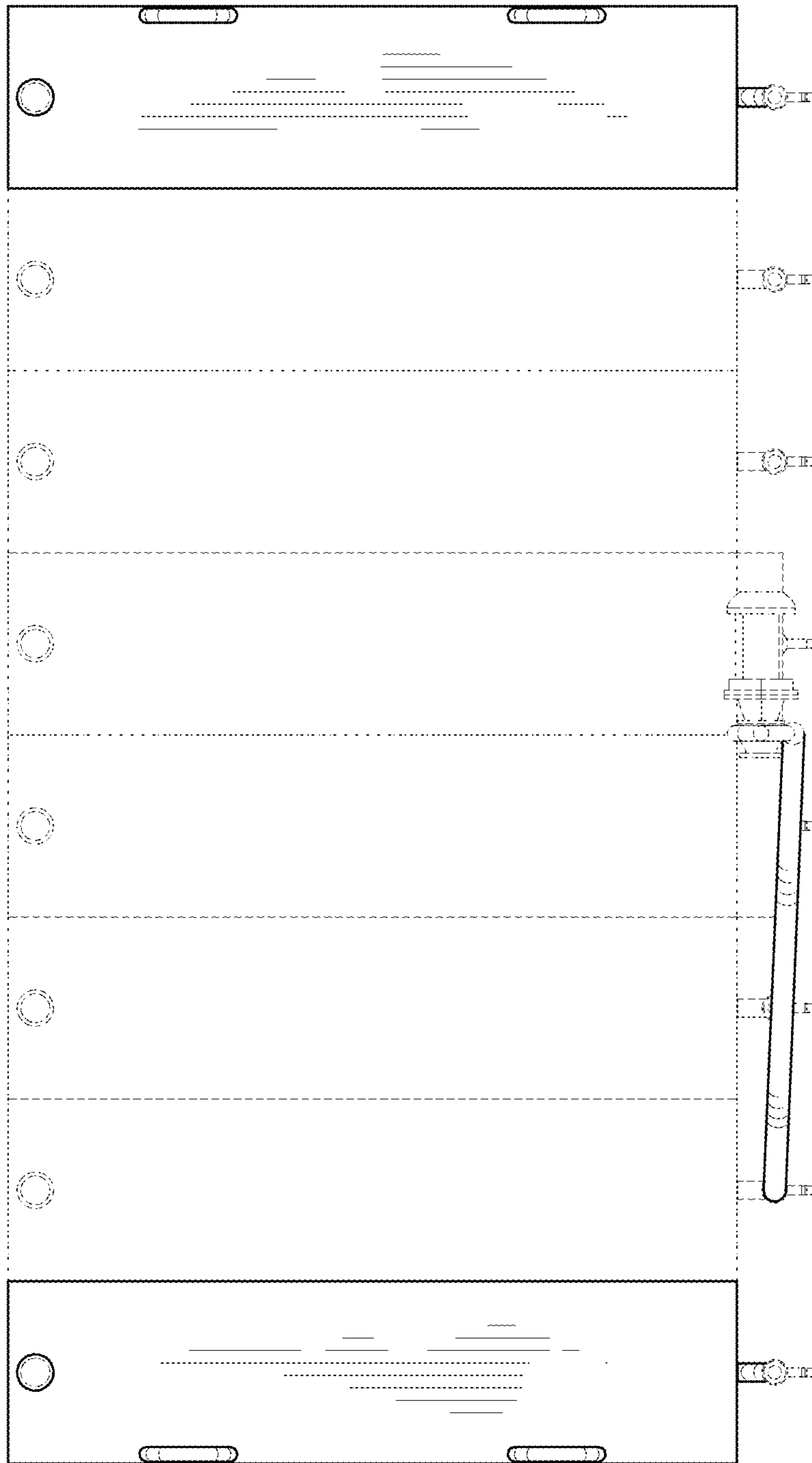

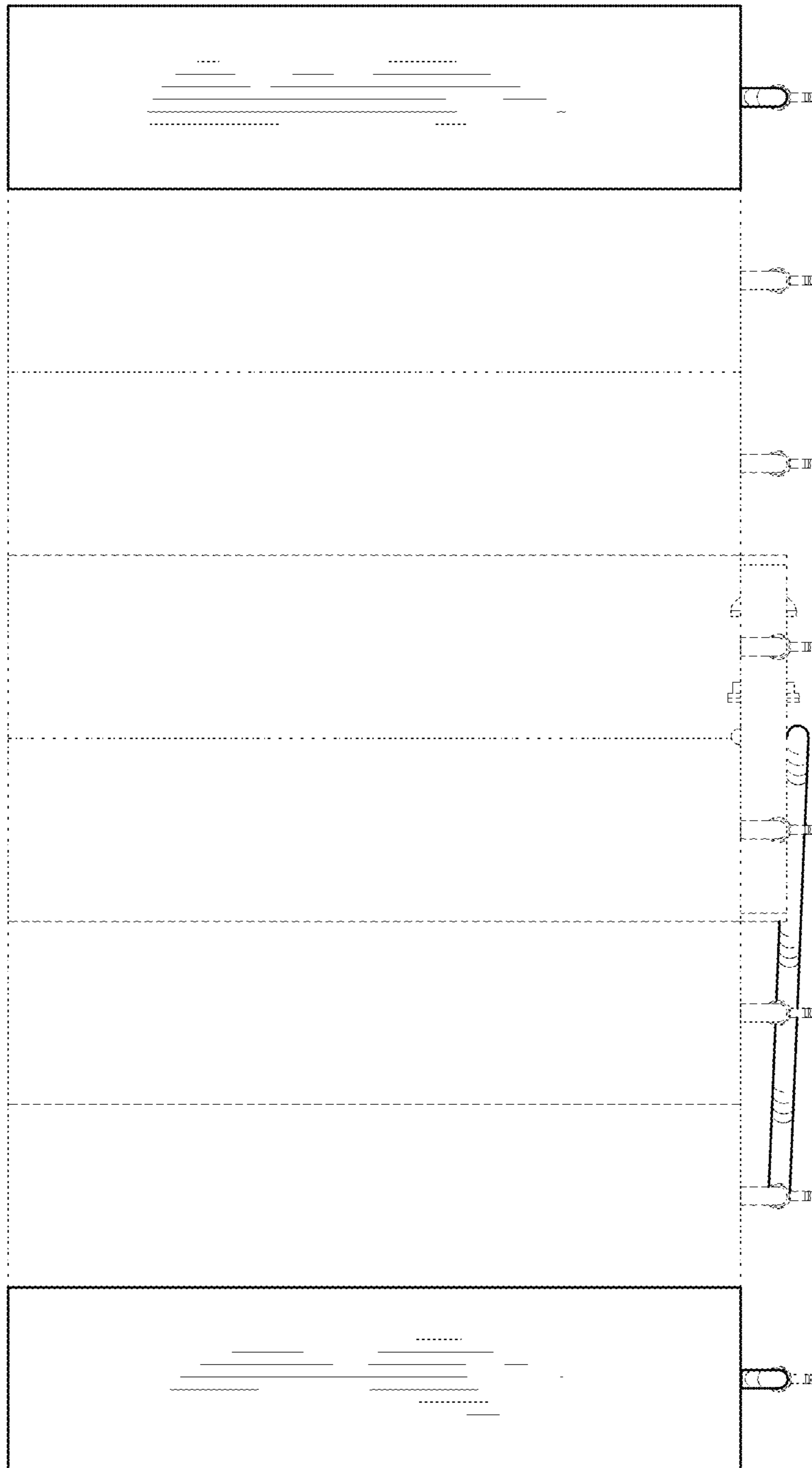

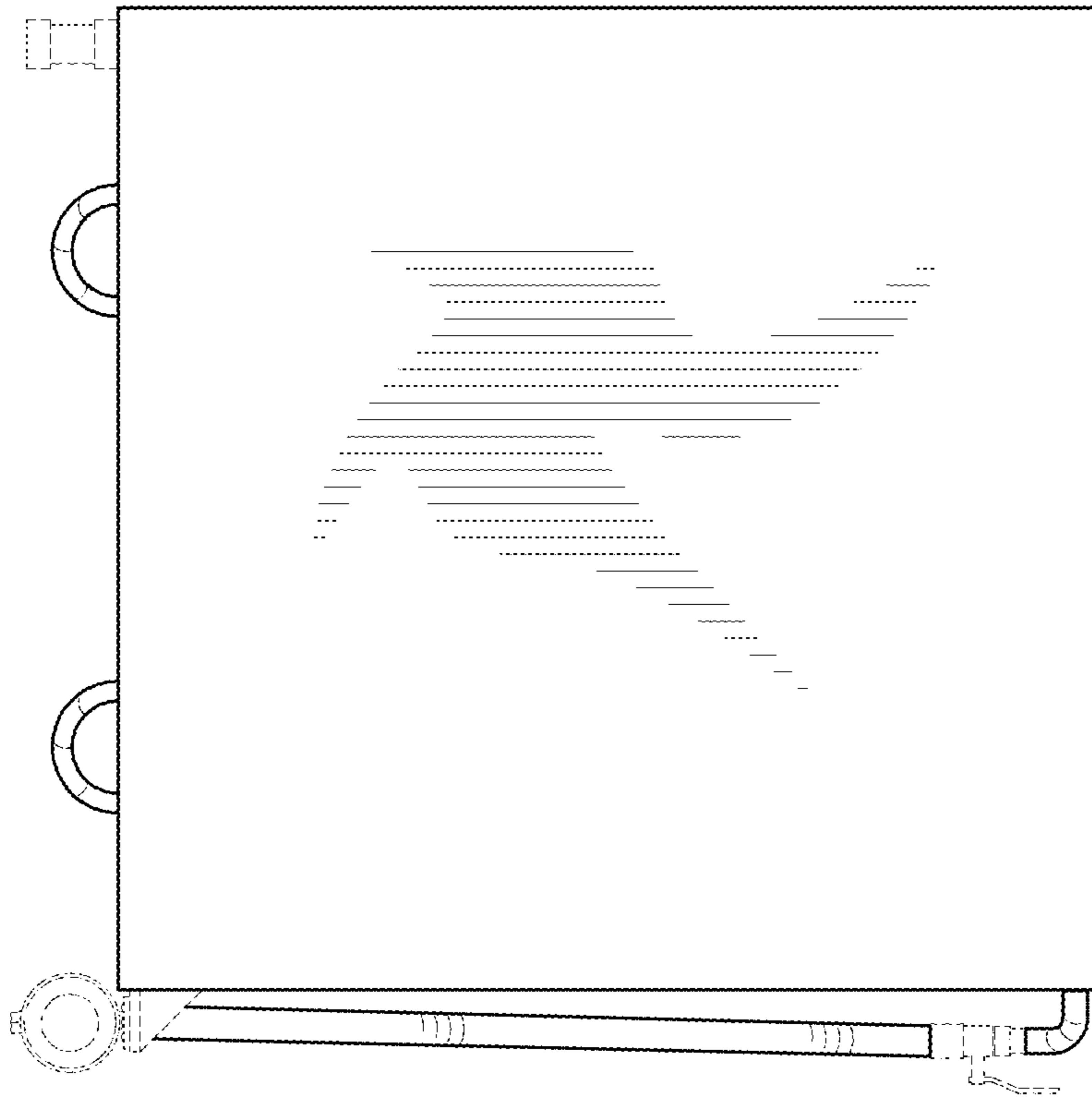

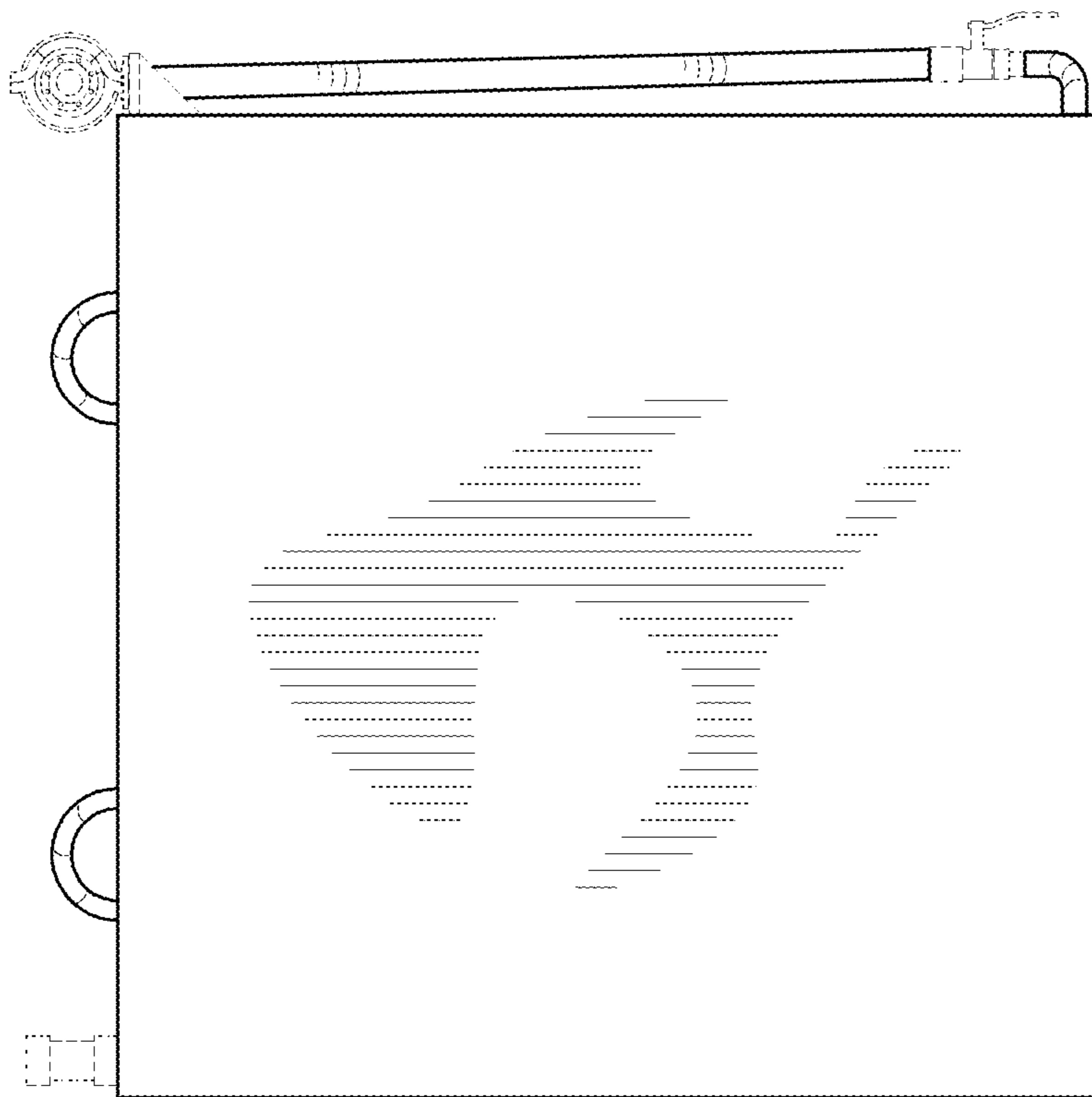
