FIG. 2. illustrates a right, perspective view thereof;

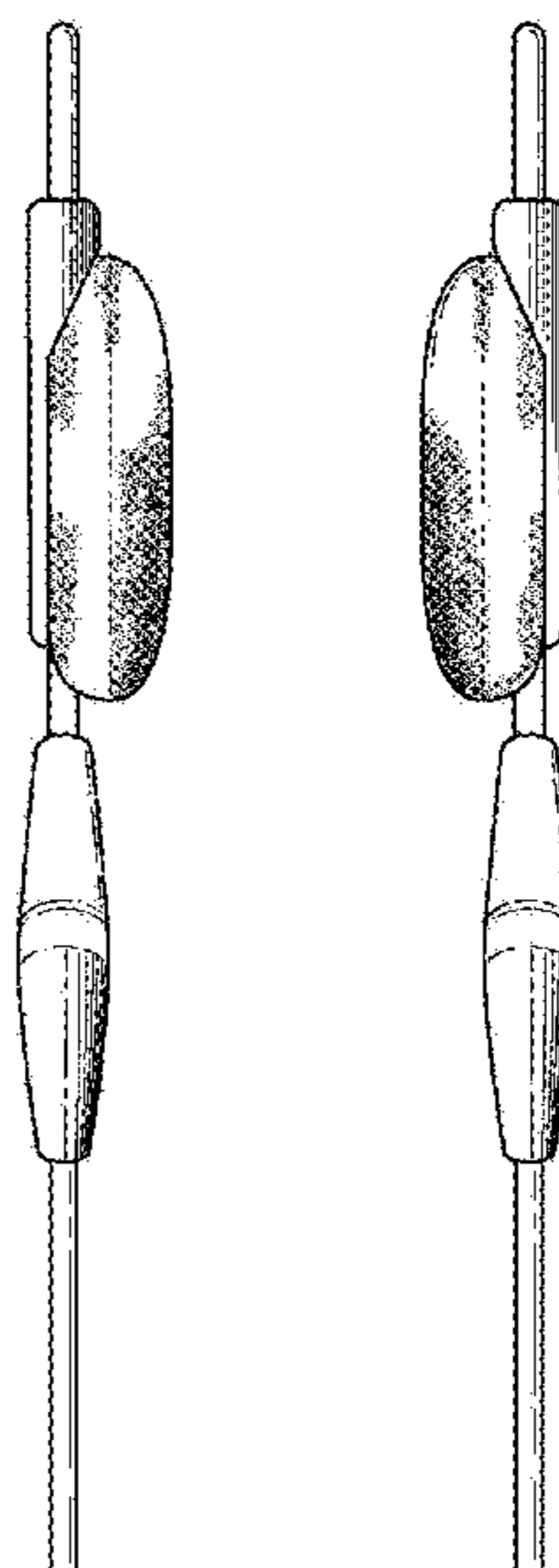
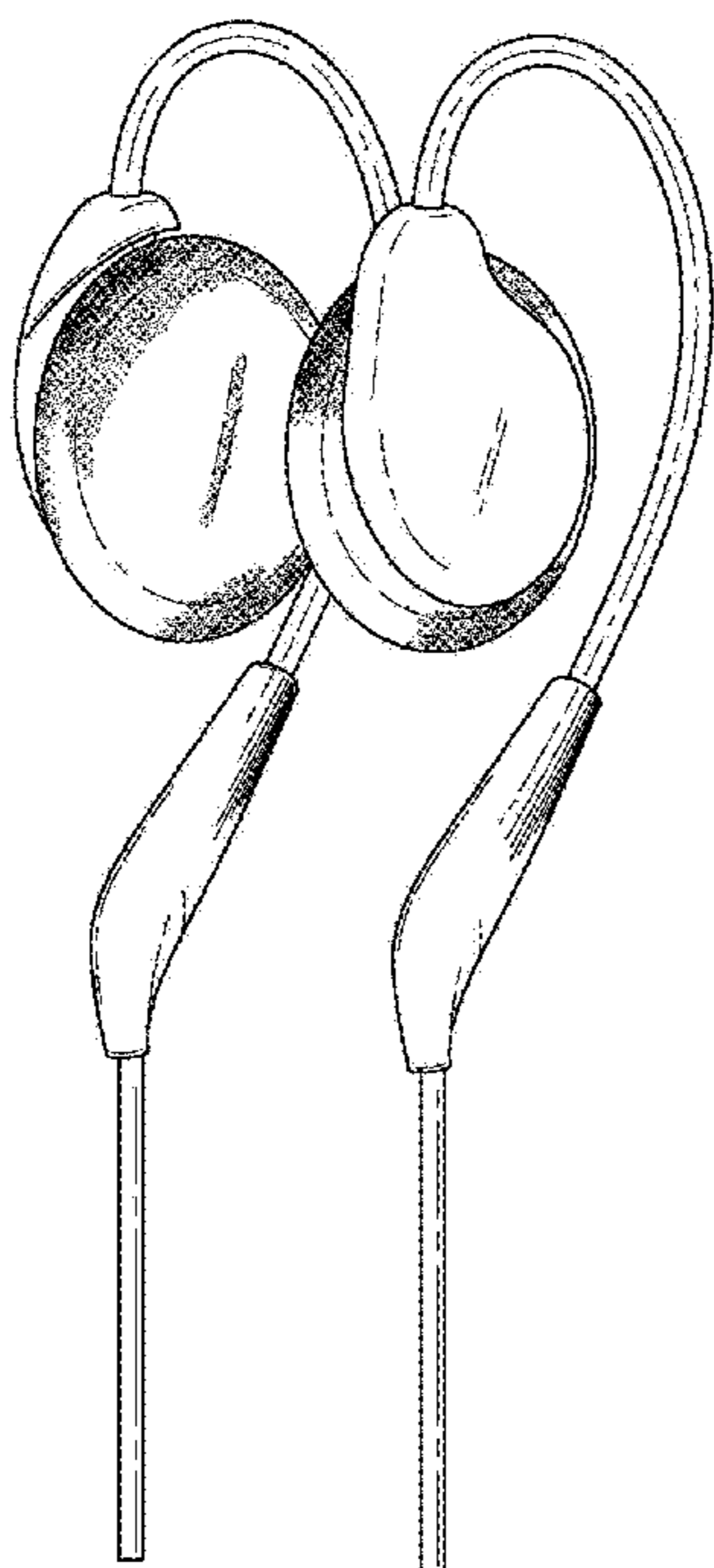
FIG. 3. illustrates a left, perspective view thereof;

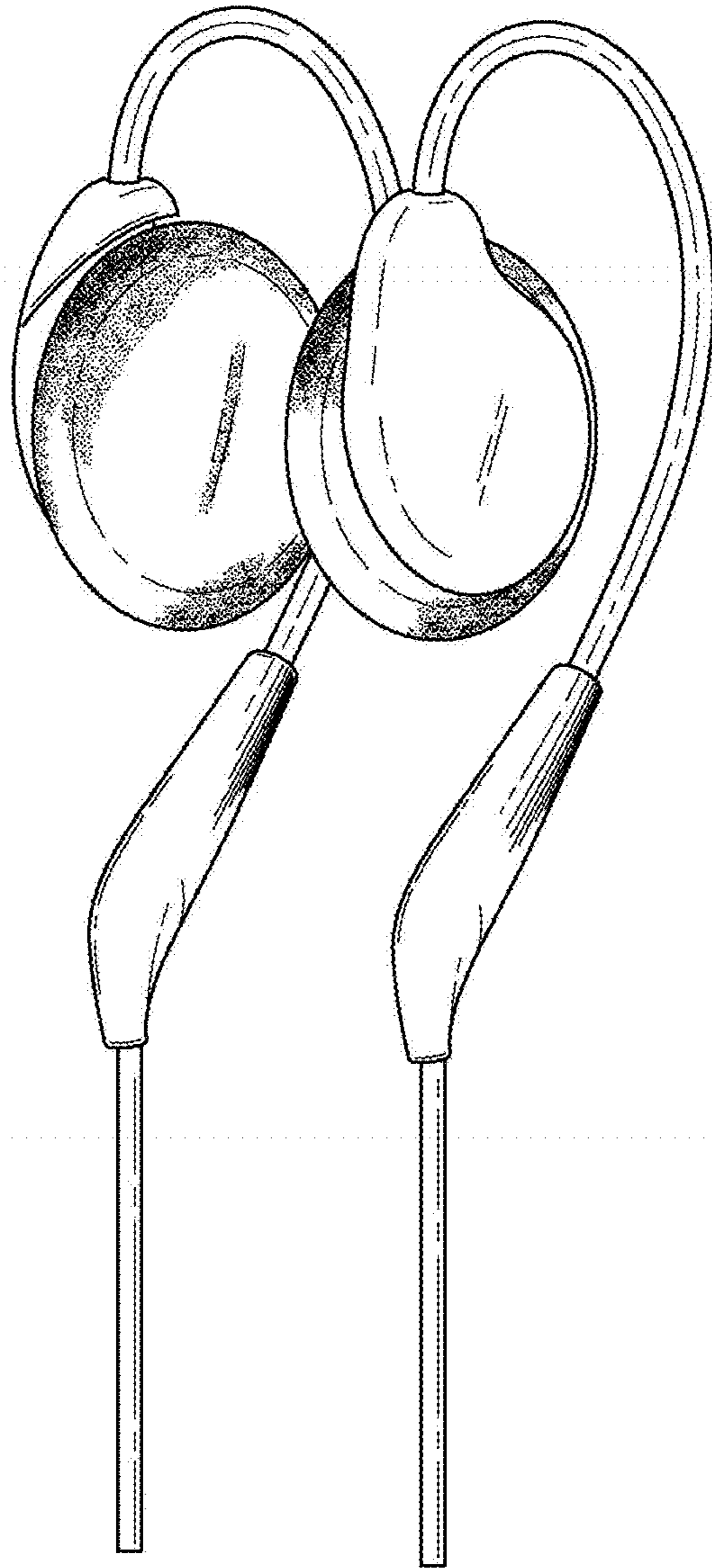

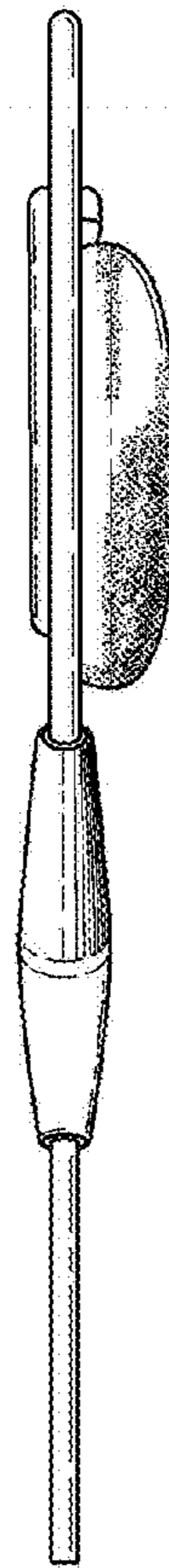
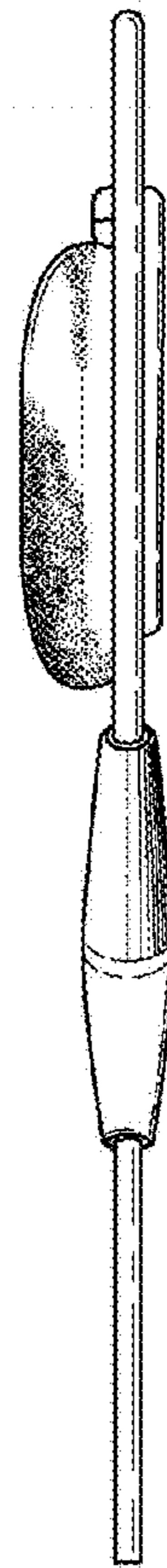

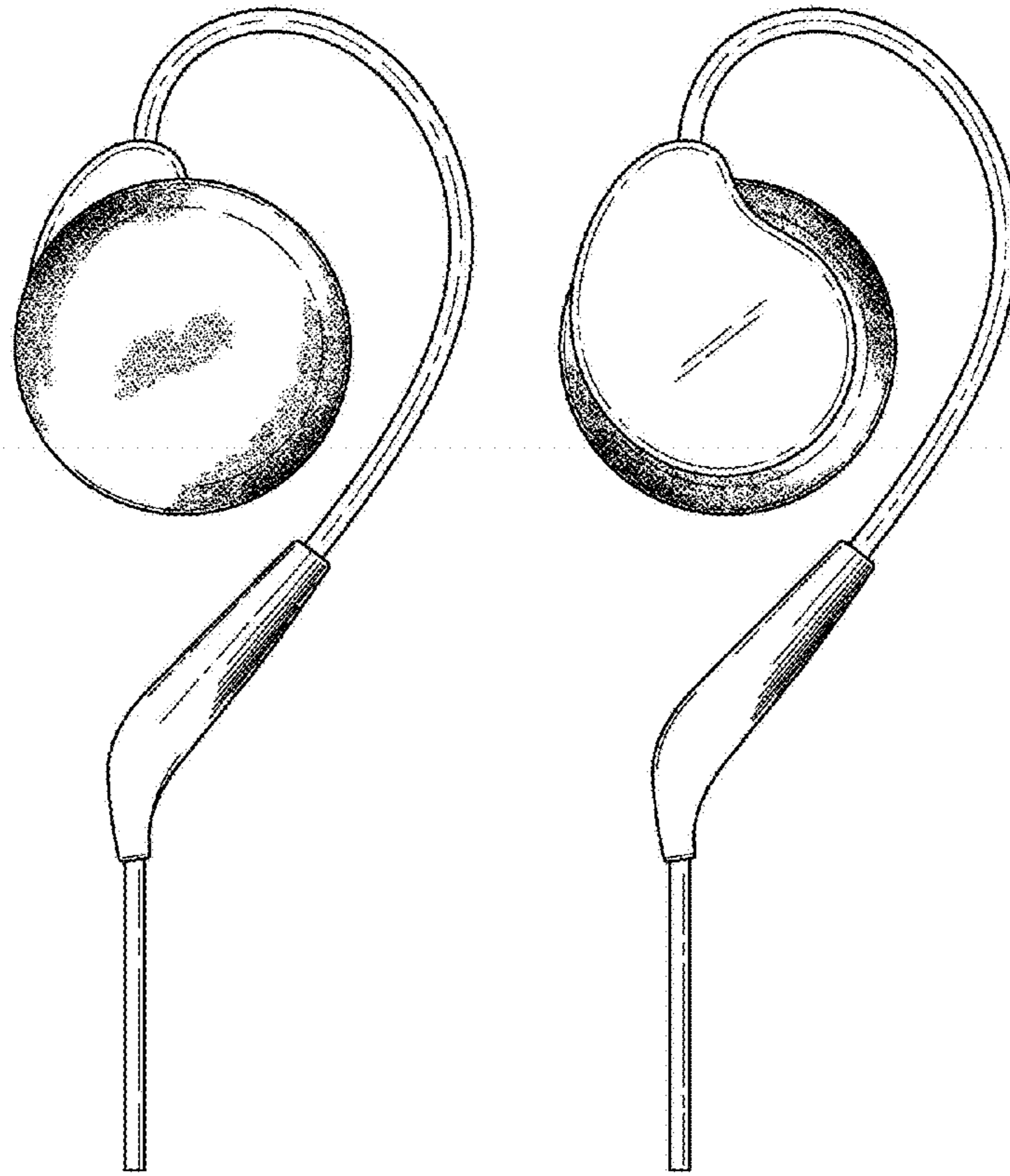

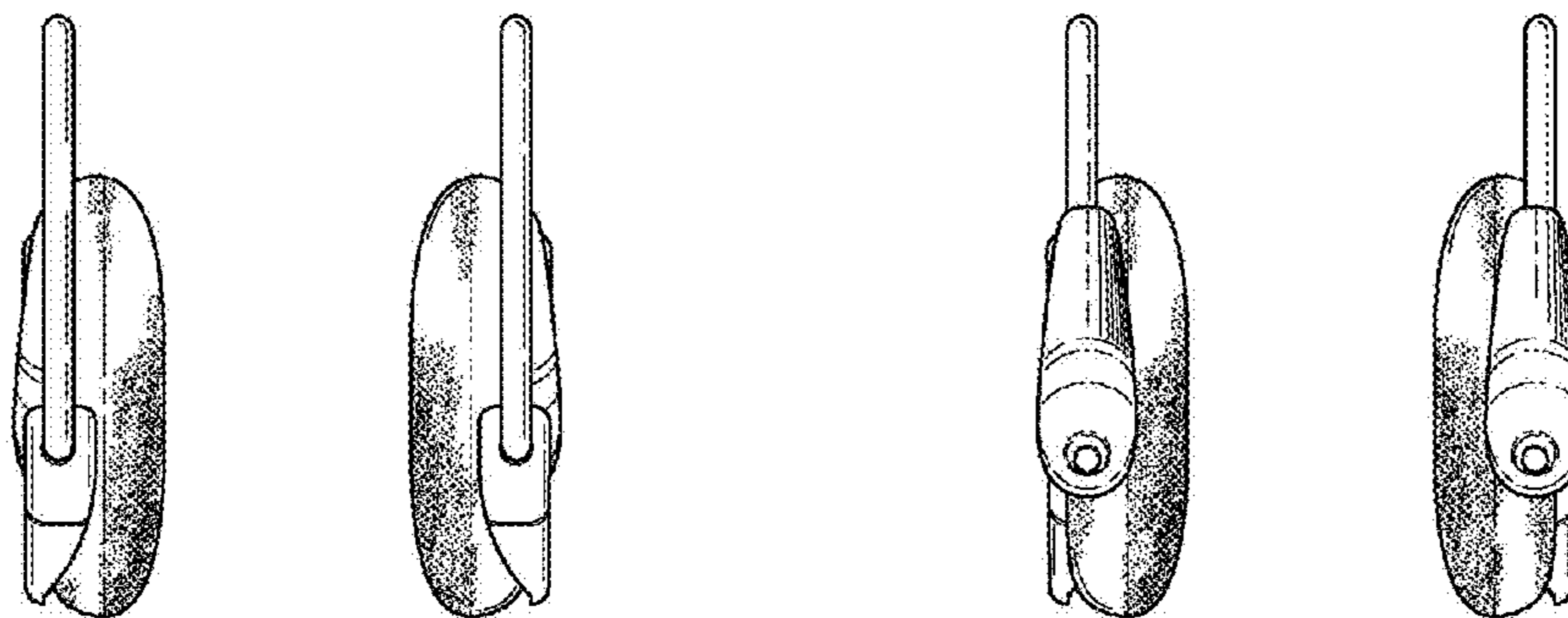
