(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing my new design; and, FIG. 2 is an enlarged front view thereof, shown separately from the device for clarity of illustration.

The broken lines in FIGS. 1 and 2 represent portions of the display screen with graphical user interface that form no part of the claimed design.

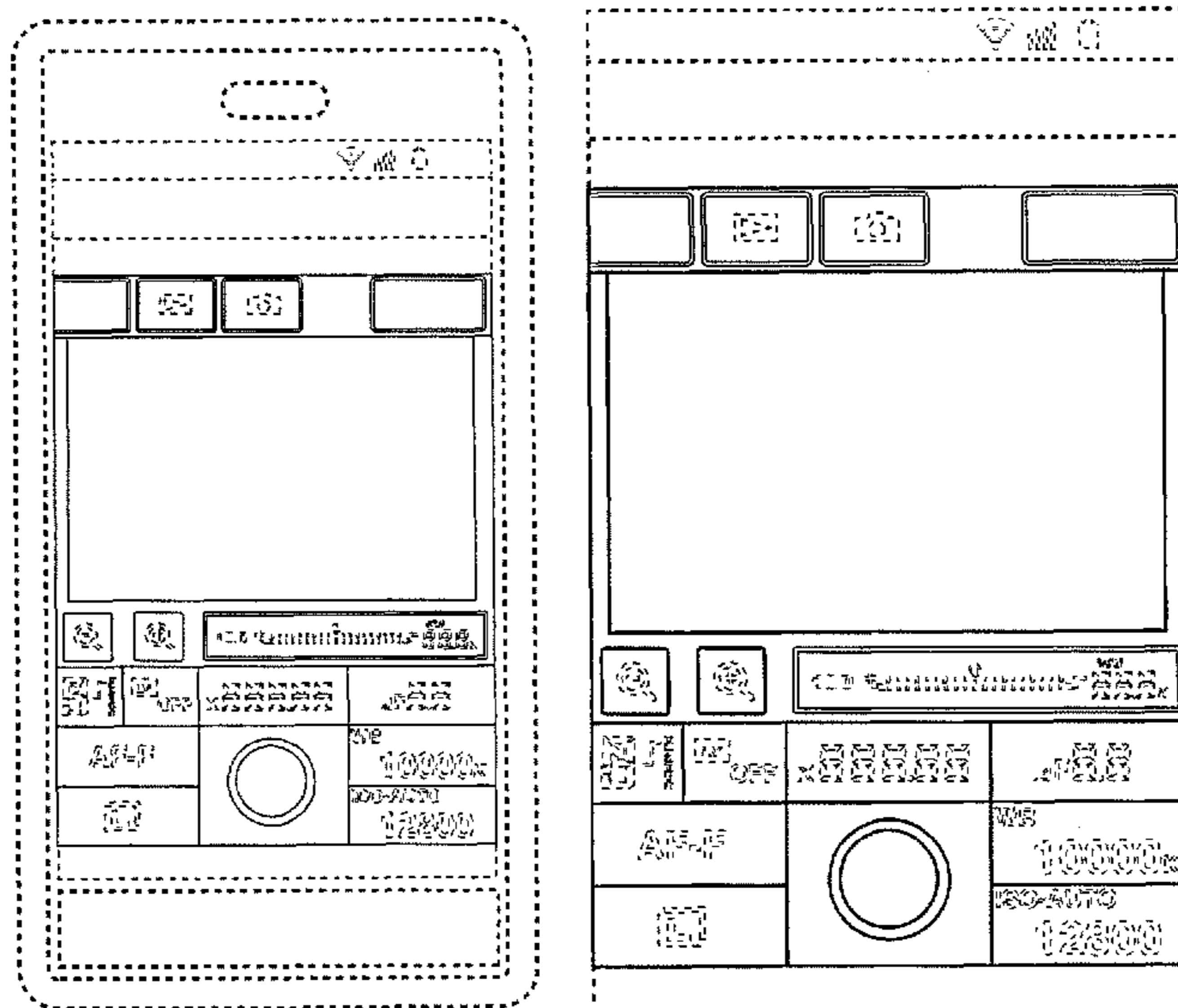

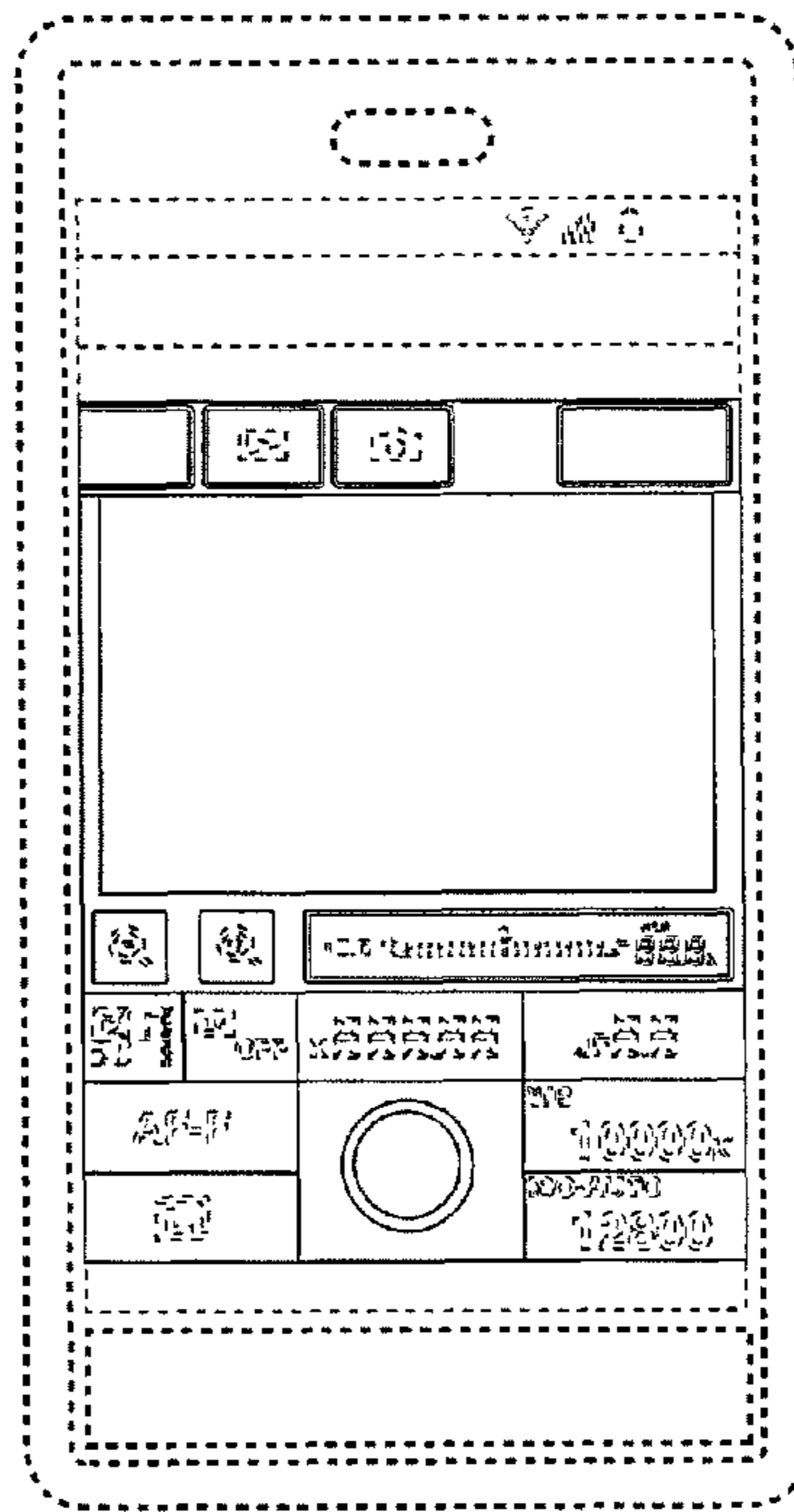
