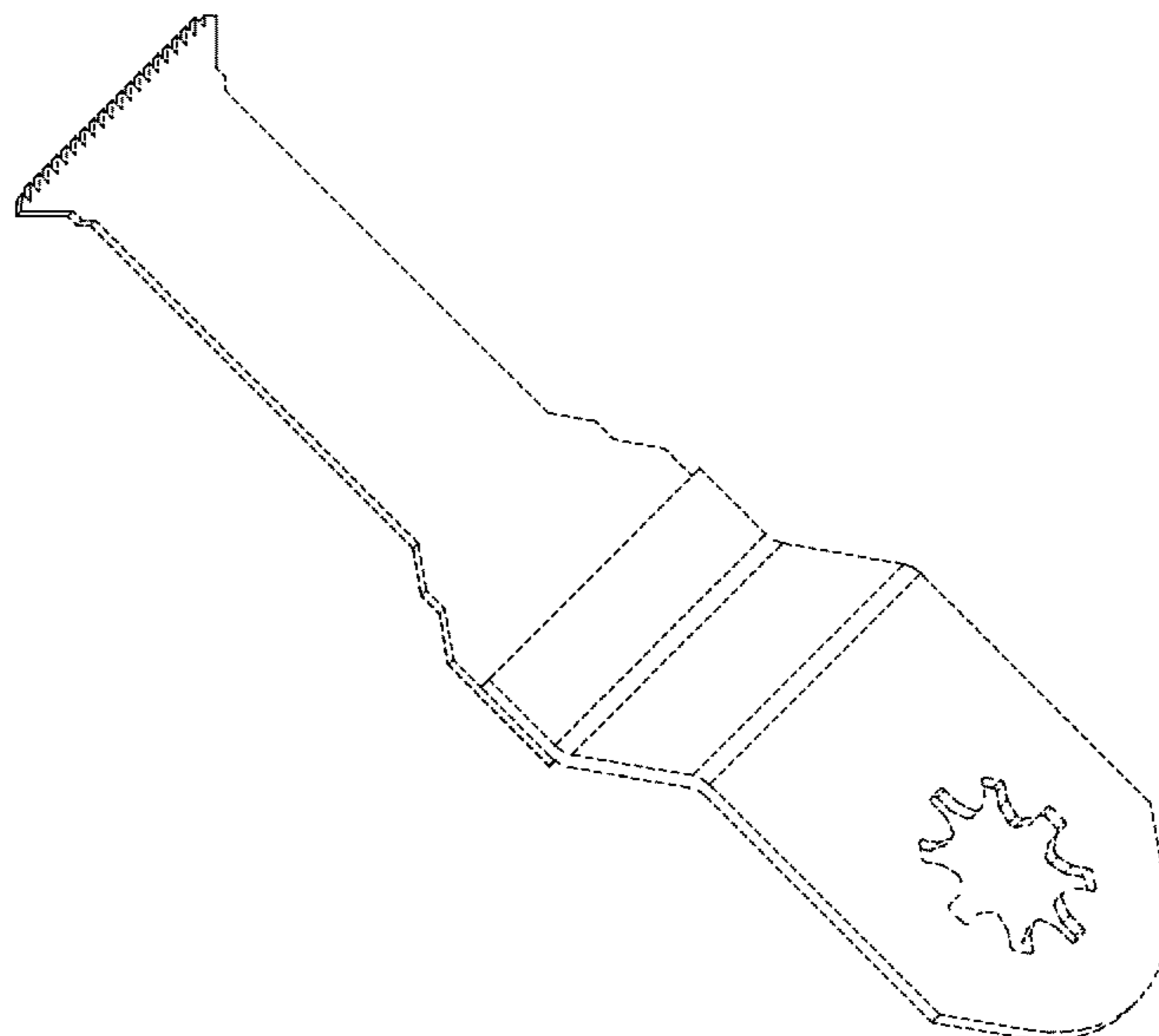
(57) **CLAIM**

What is claimed is the ornamental design for a saw blade, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a saw blade showing our new design;
 FIG. 2 is an enlarged detail, top plan view of the saw blade in circle 2 of FIG. 1;
 FIG. 3 is an enlarged detail, top plan view of the saw blade in circle 3 of FIG. 1;
 FIG. 4 is a bottom plan view of the saw blade of FIG. 1;
 FIG. 5 is a front side elevational view of the saw blade of FIG. 1;
 FIG. 6 is a rear side elevational view of the saw blade of FIG. 1;
 FIG. 7 is a right side elevational view of the saw blade of FIG. 1;
 FIG. 8 is a left side elevational view of the saw blade of FIG. 1; and,
 FIG. 9 is a perspective view of the saw blade of FIG. 1.

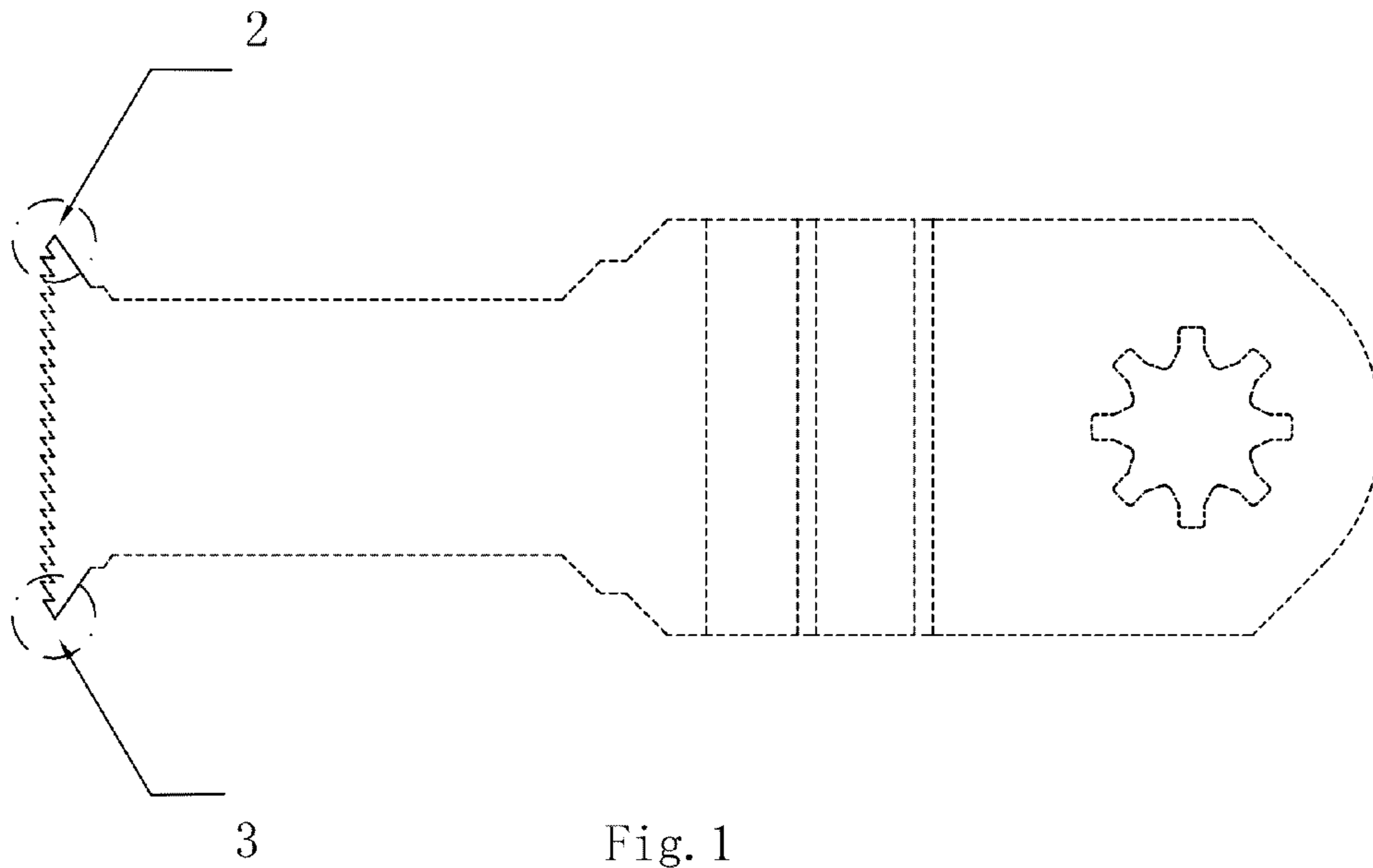

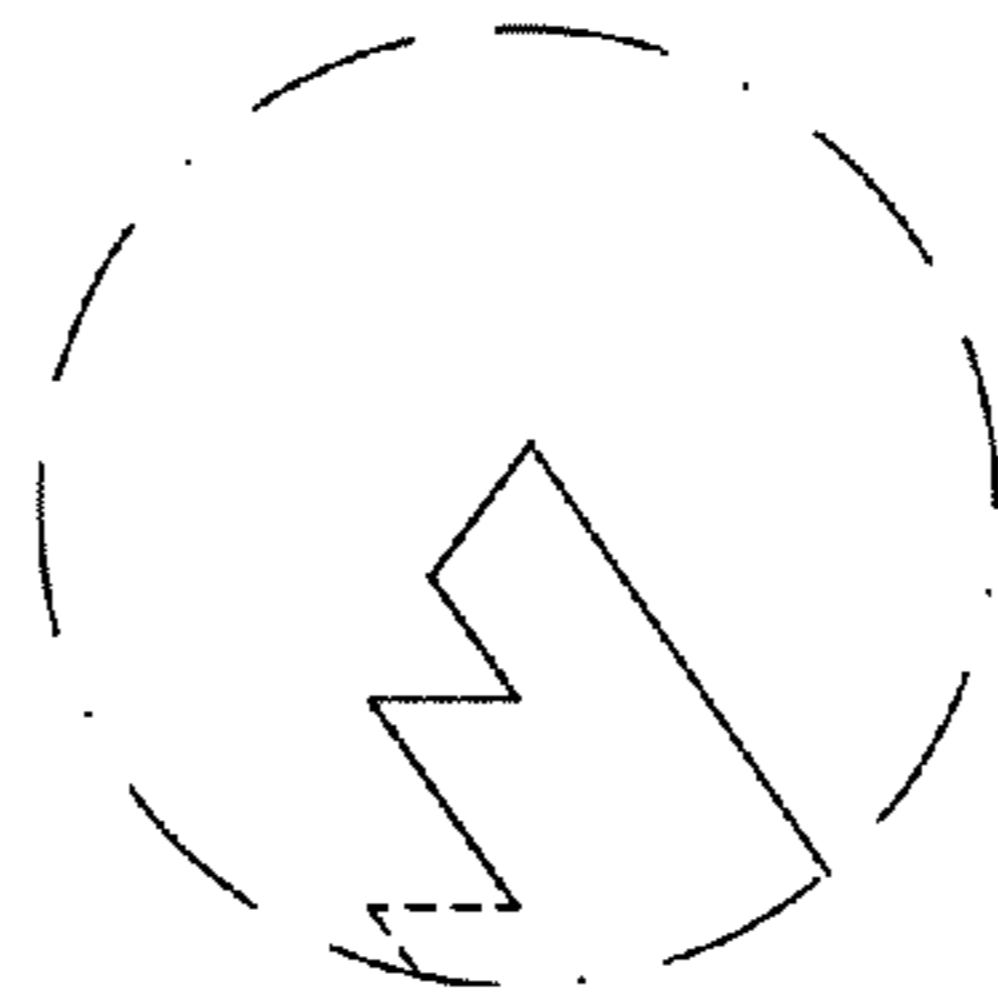

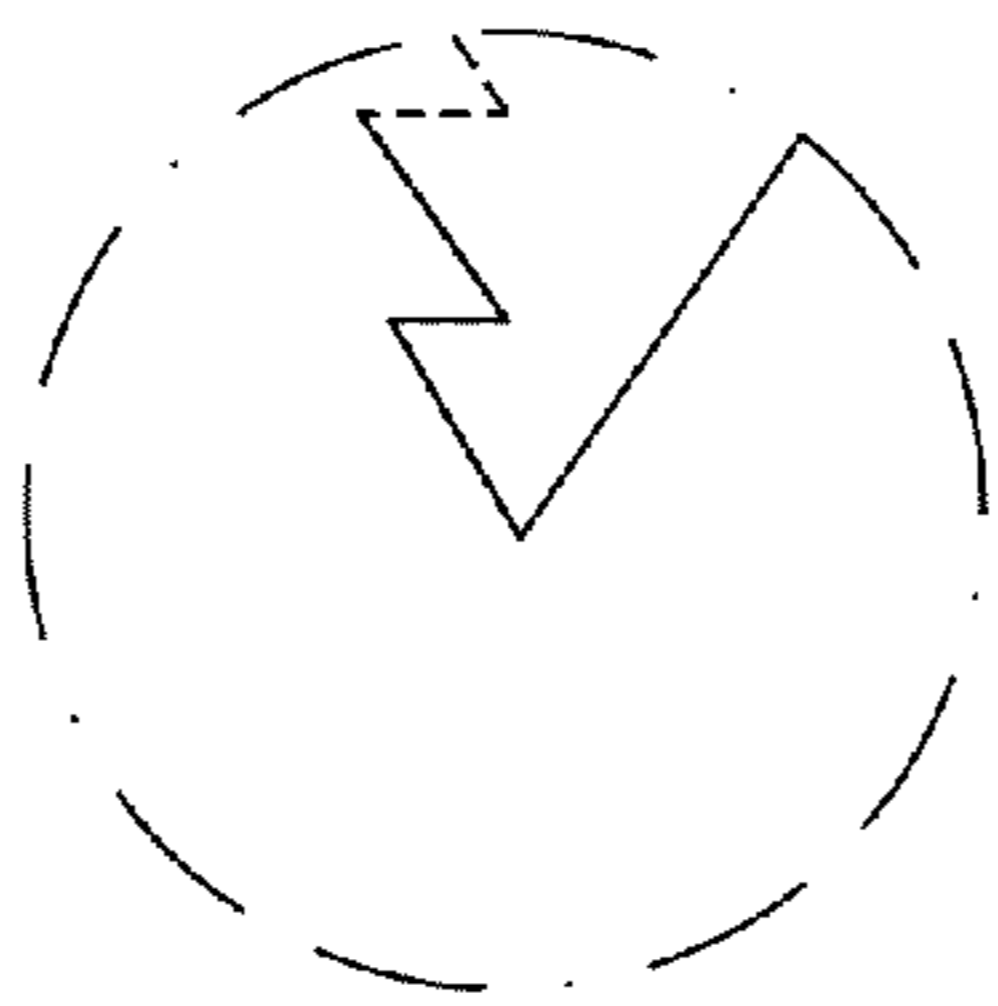

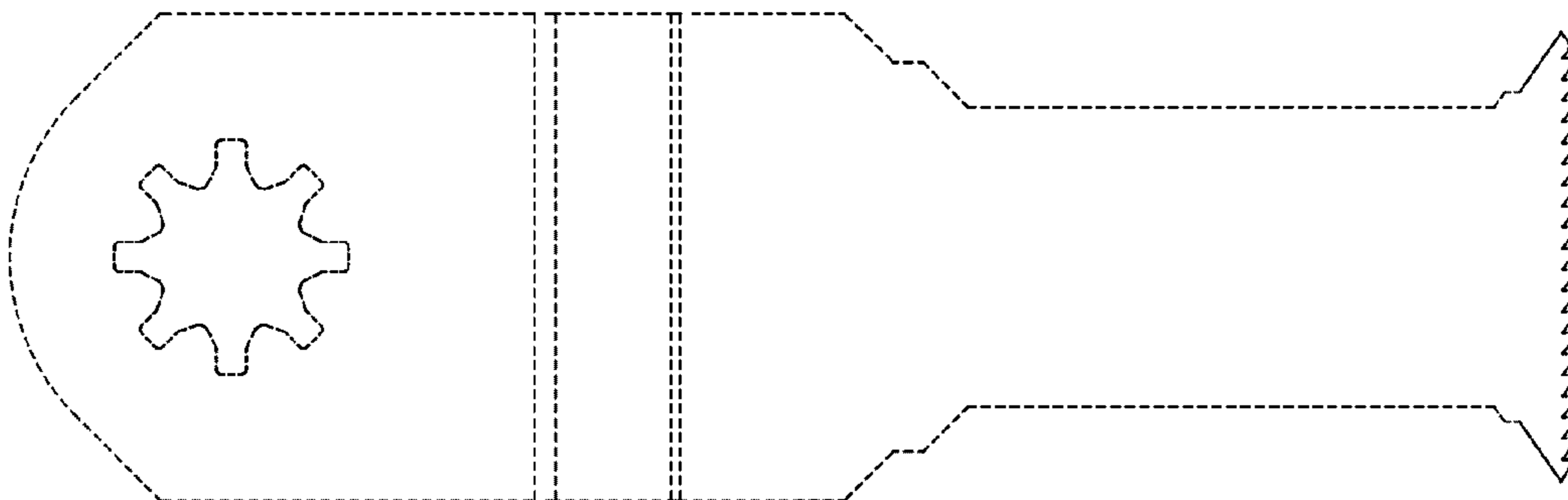

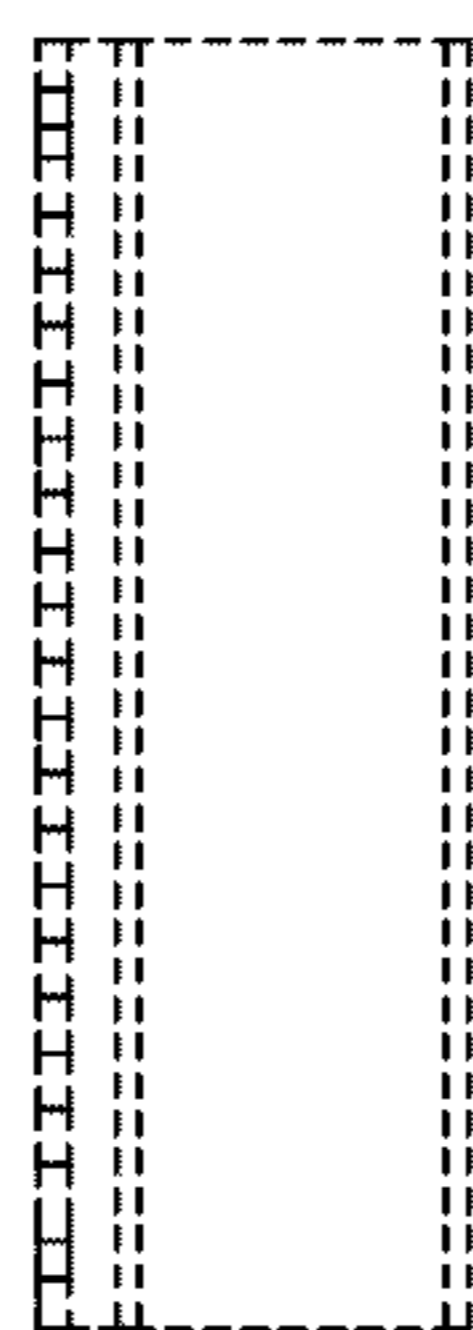

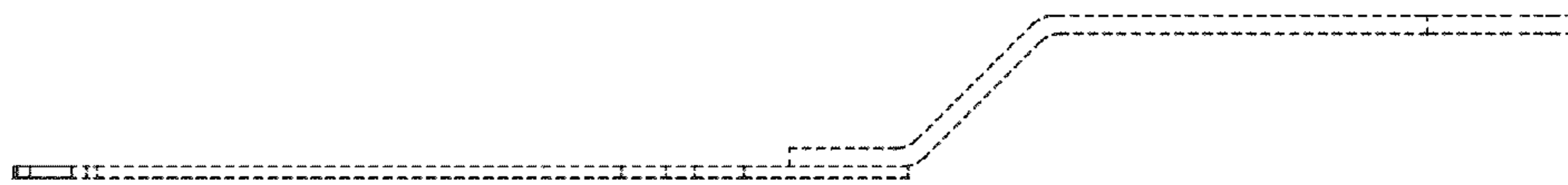

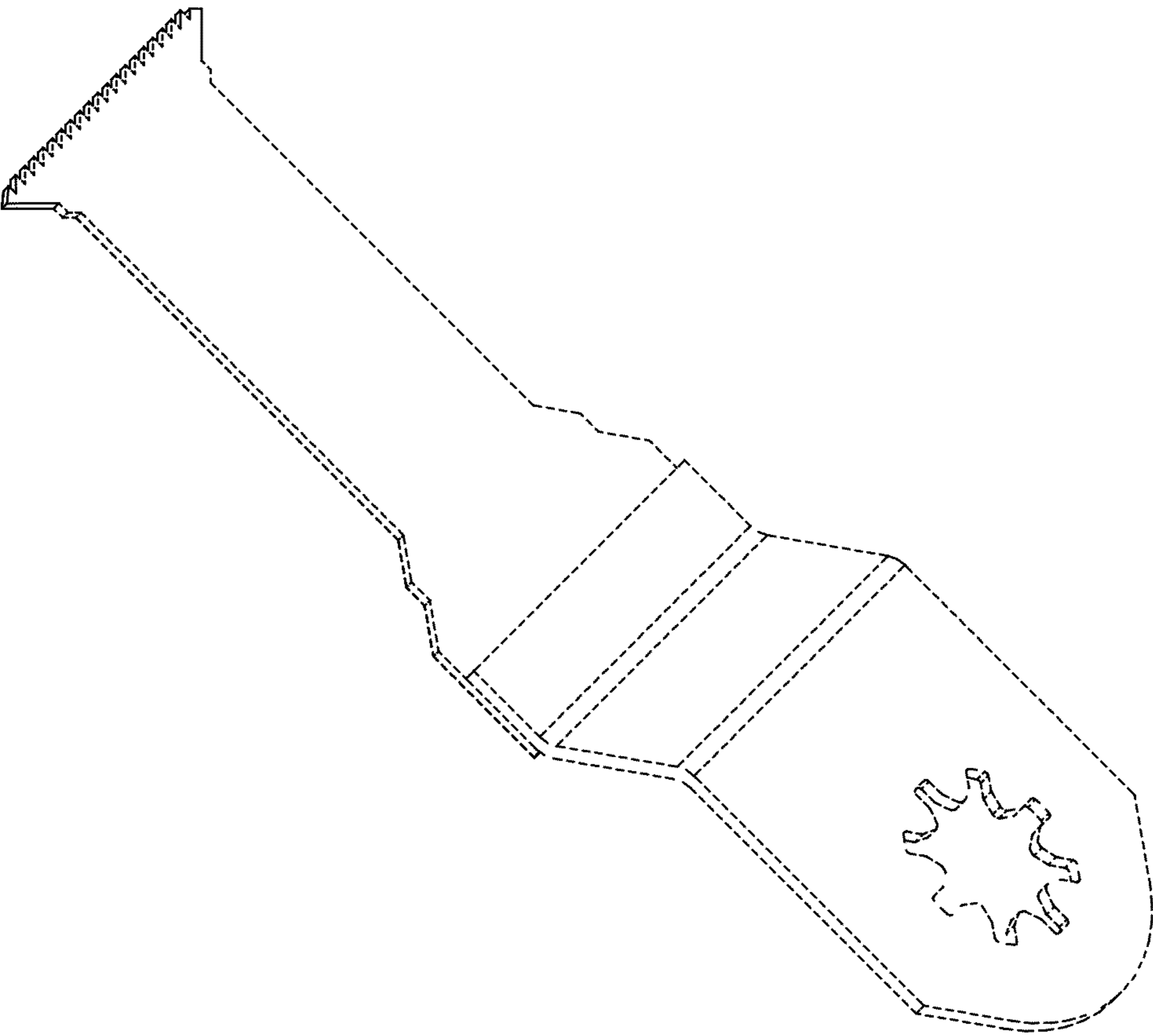
