DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a monitoring camera of the present invention;

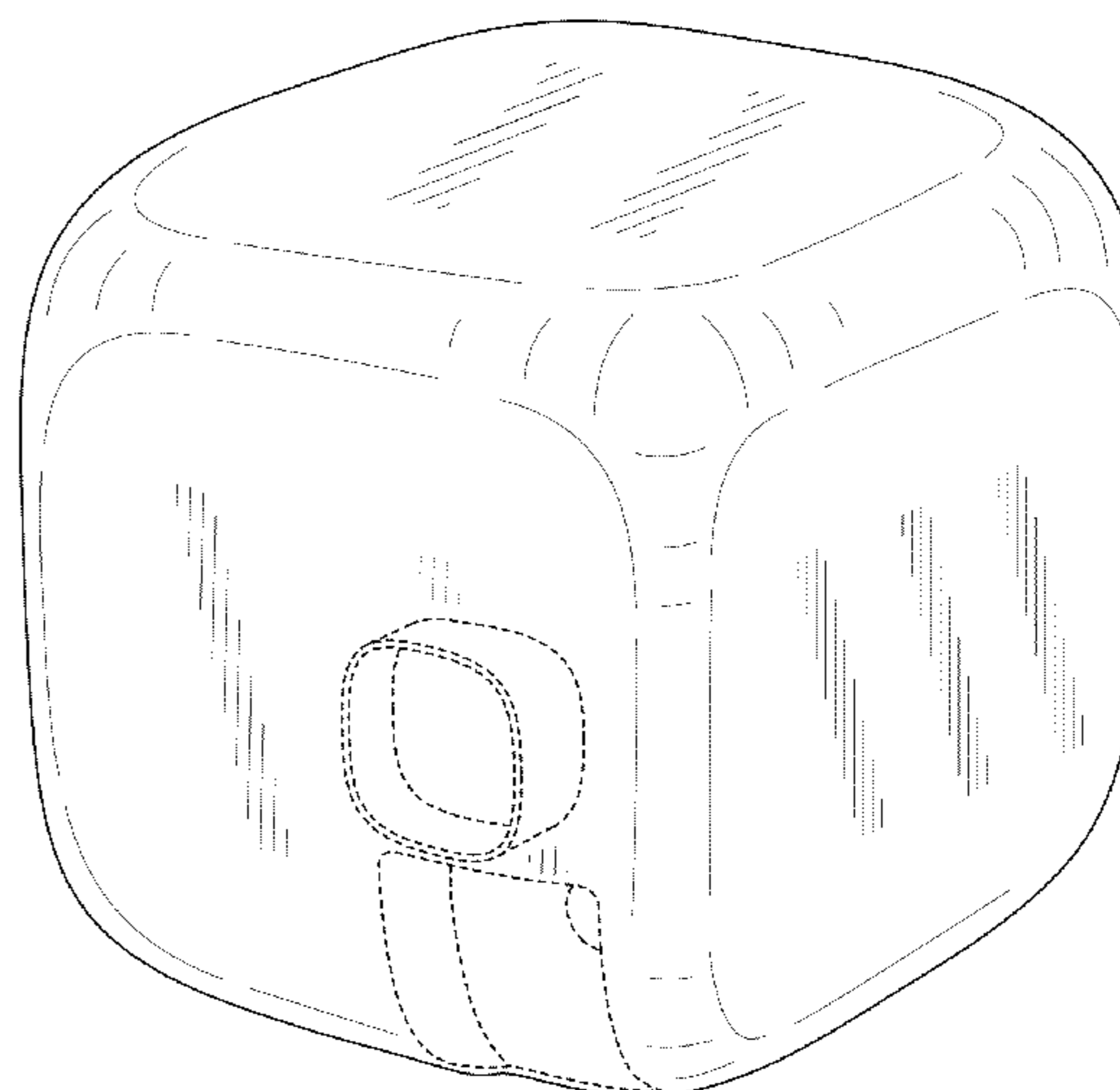
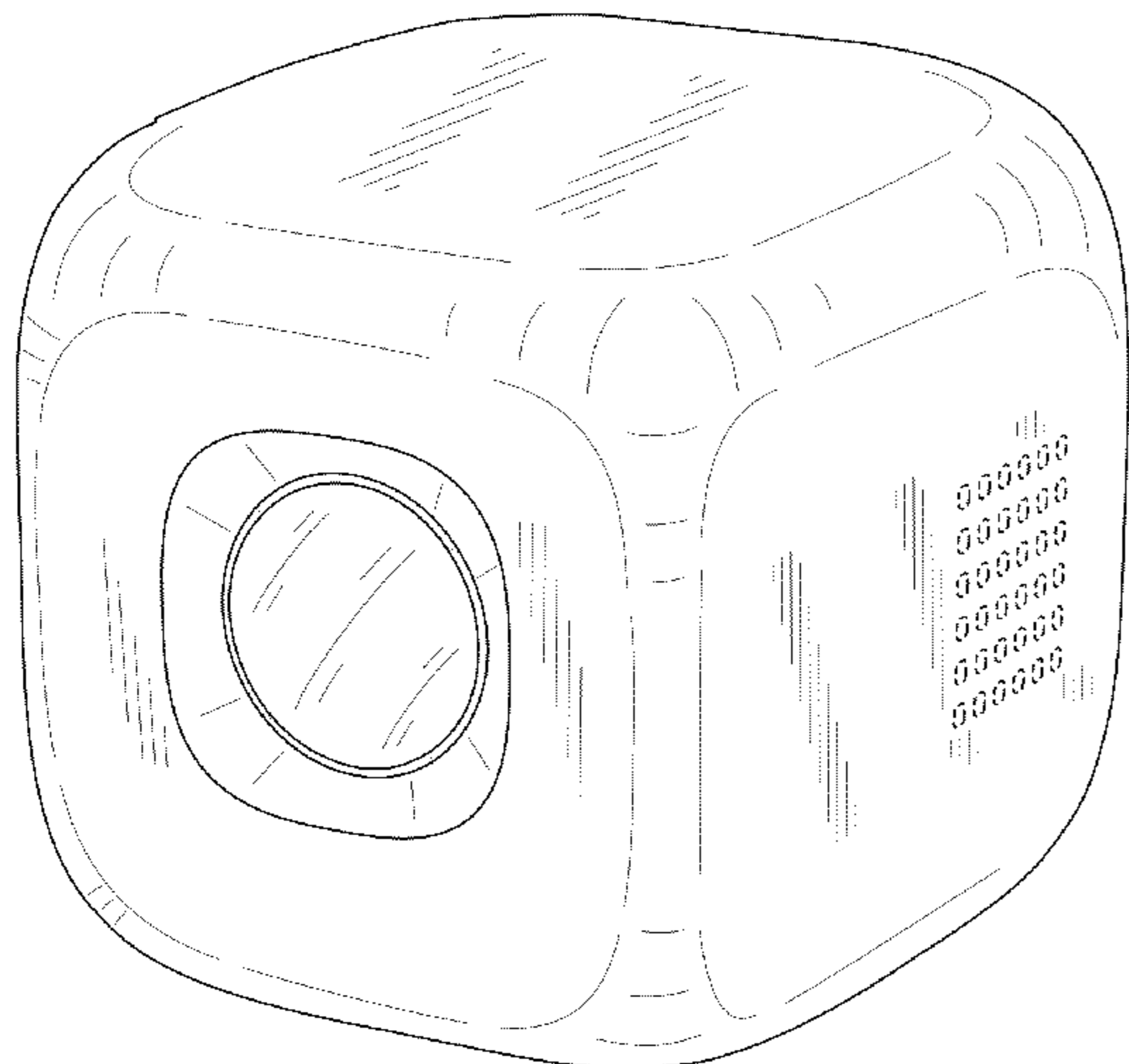

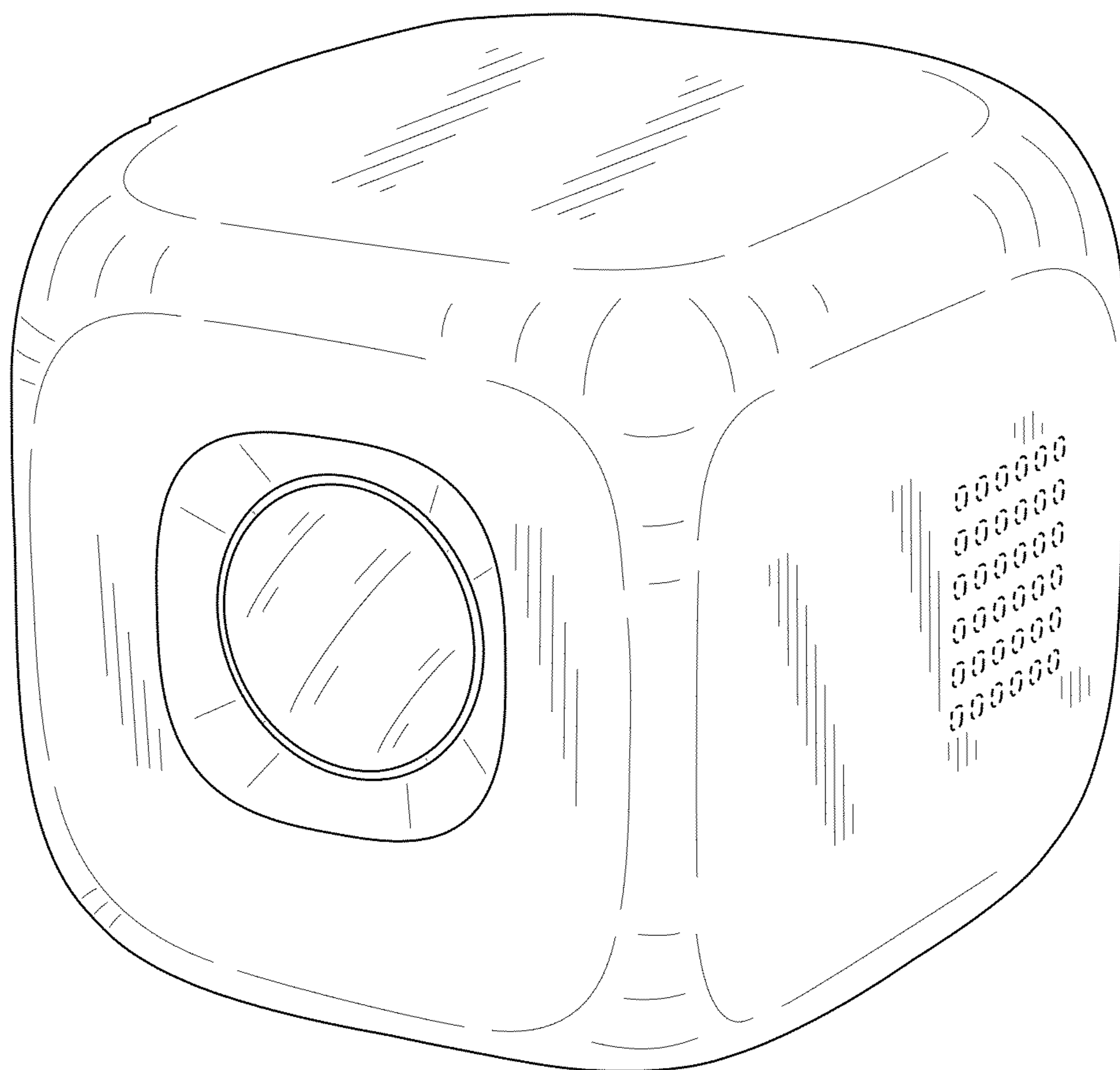

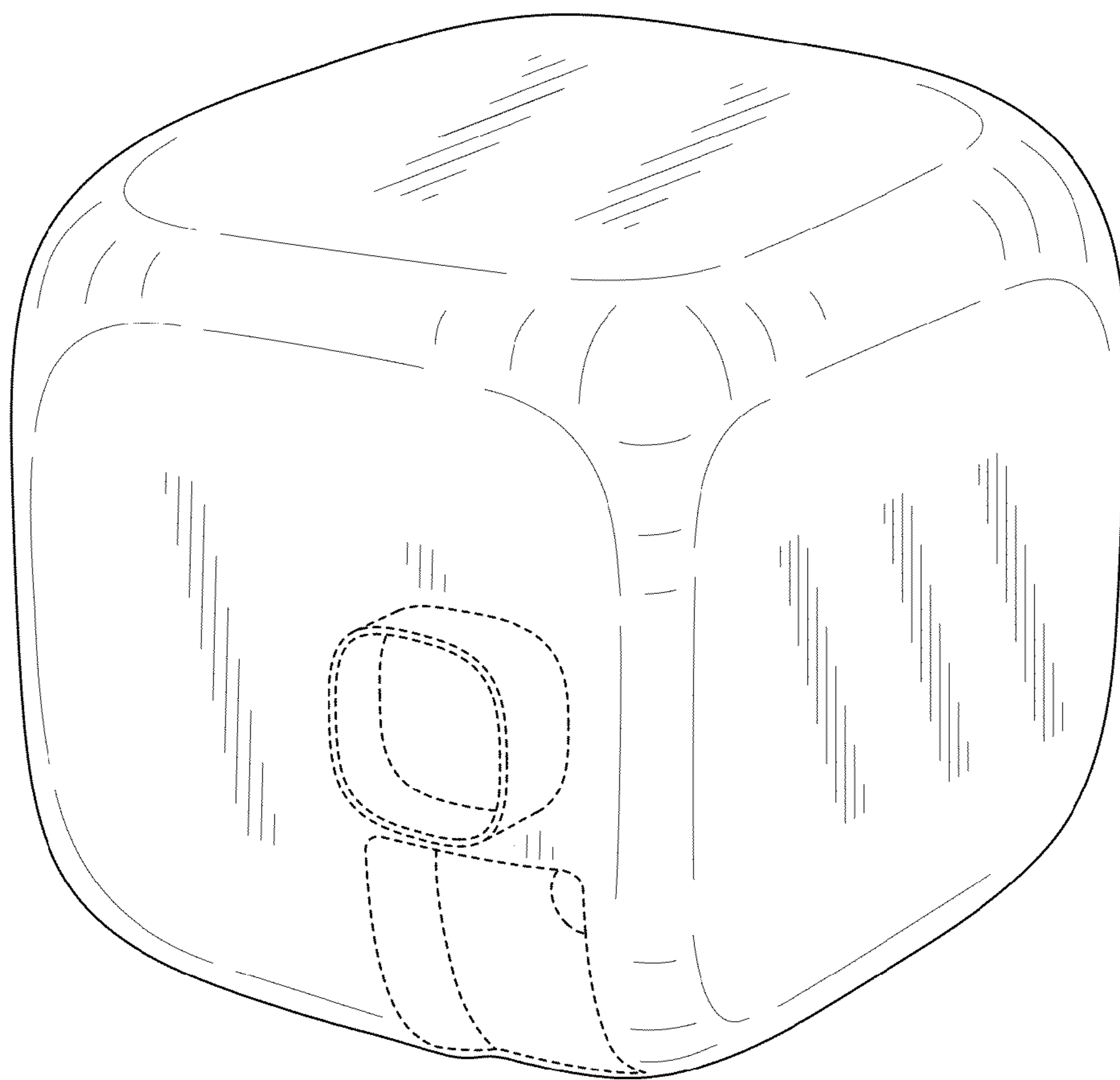

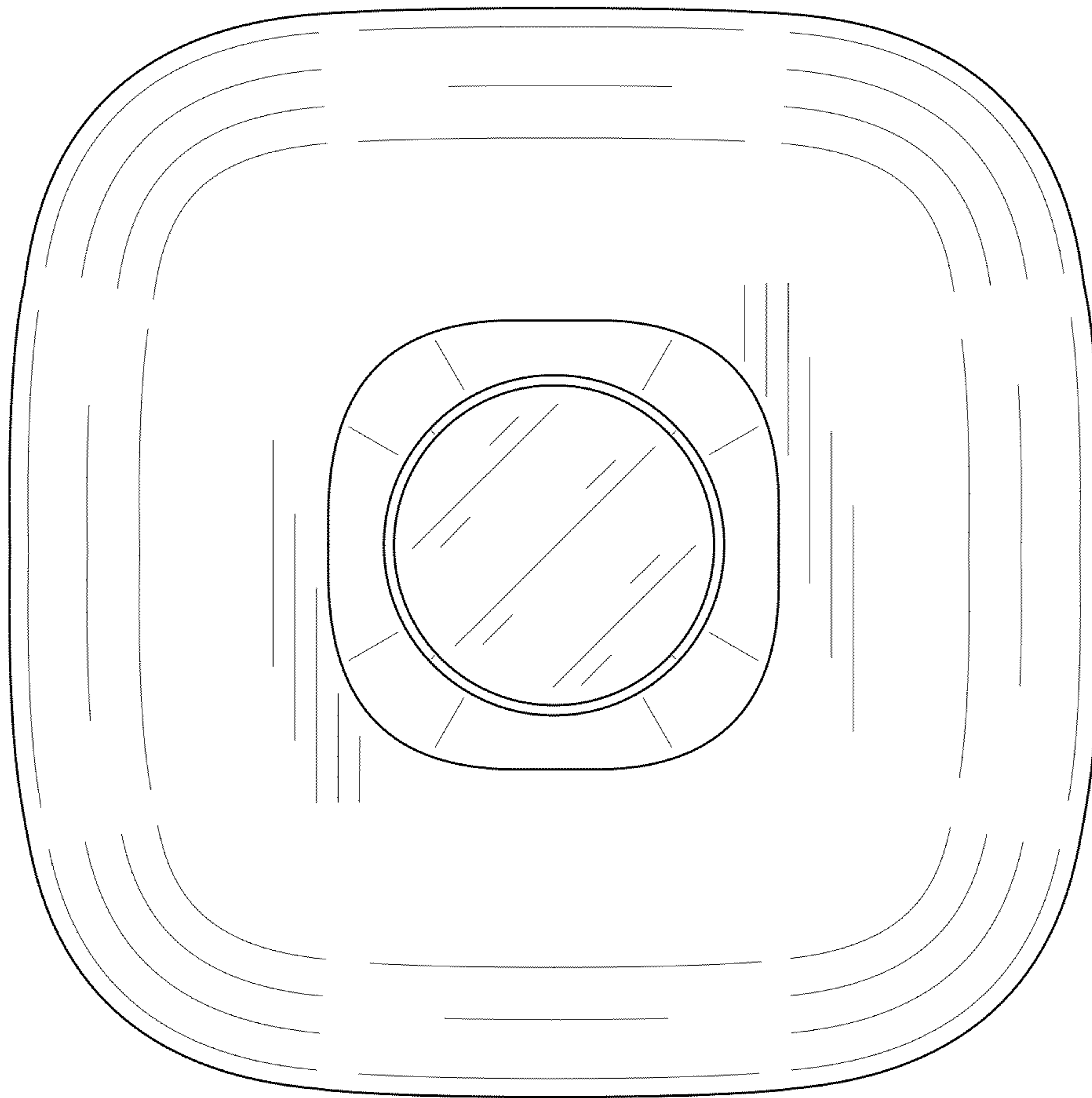

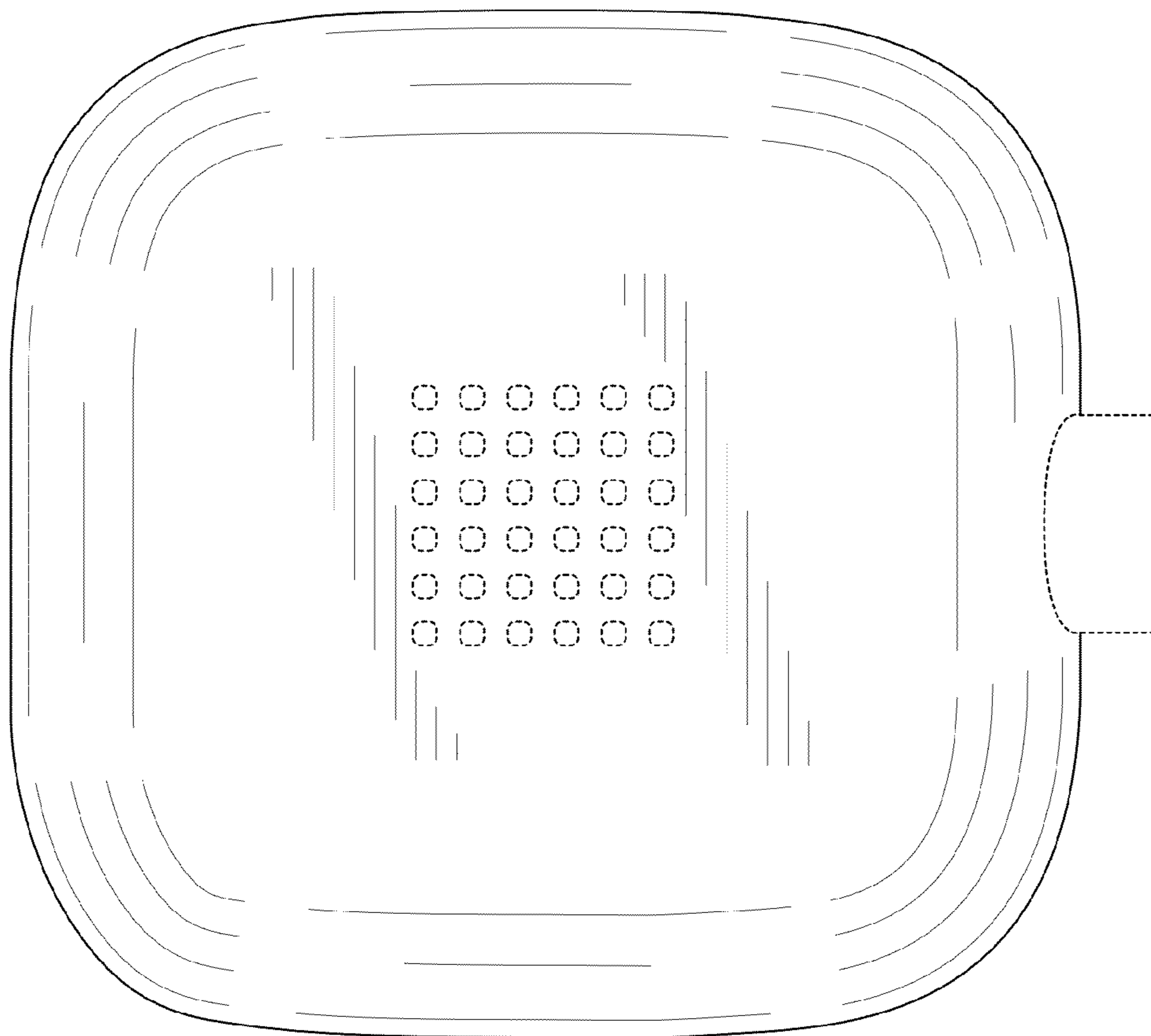

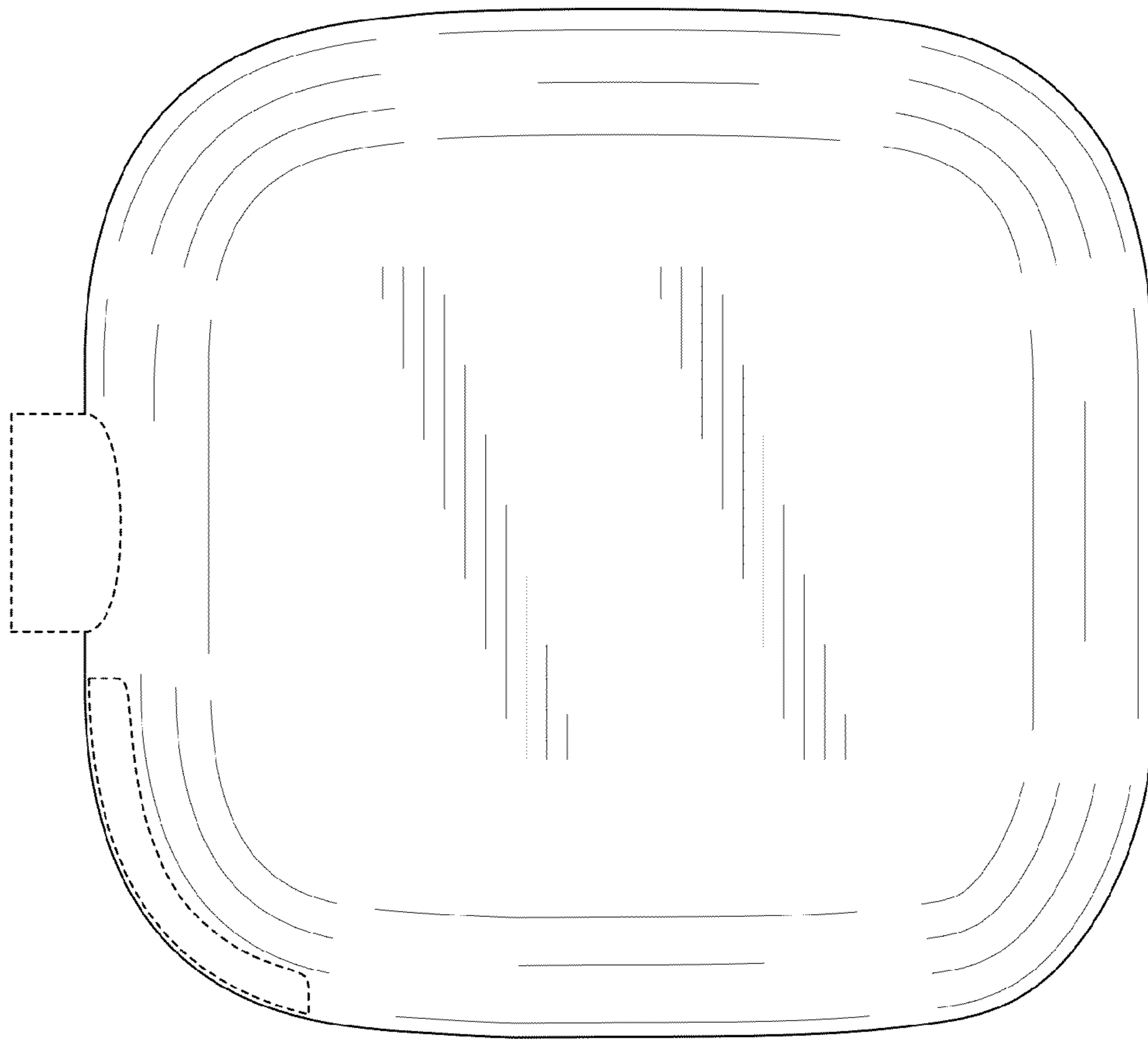

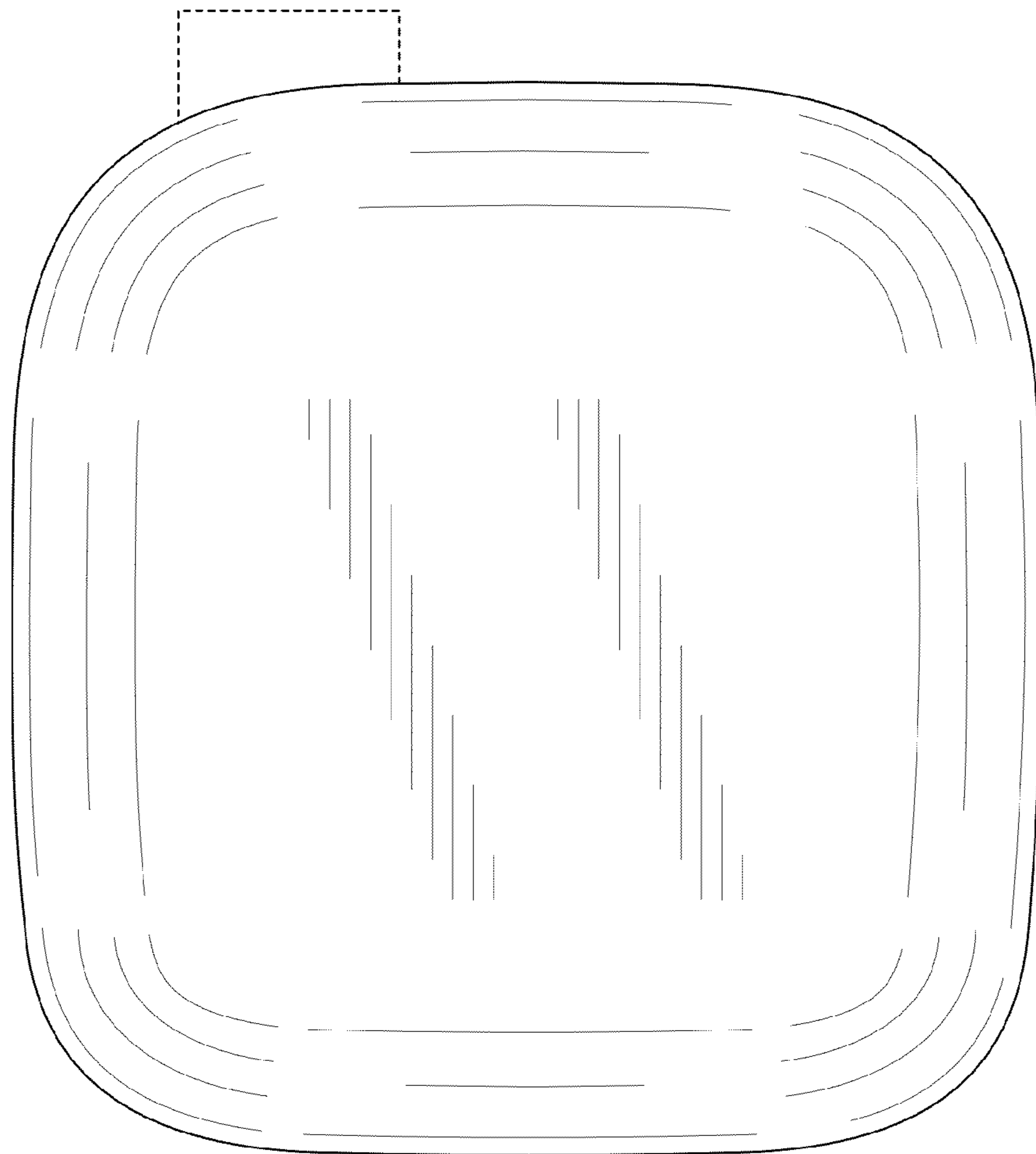

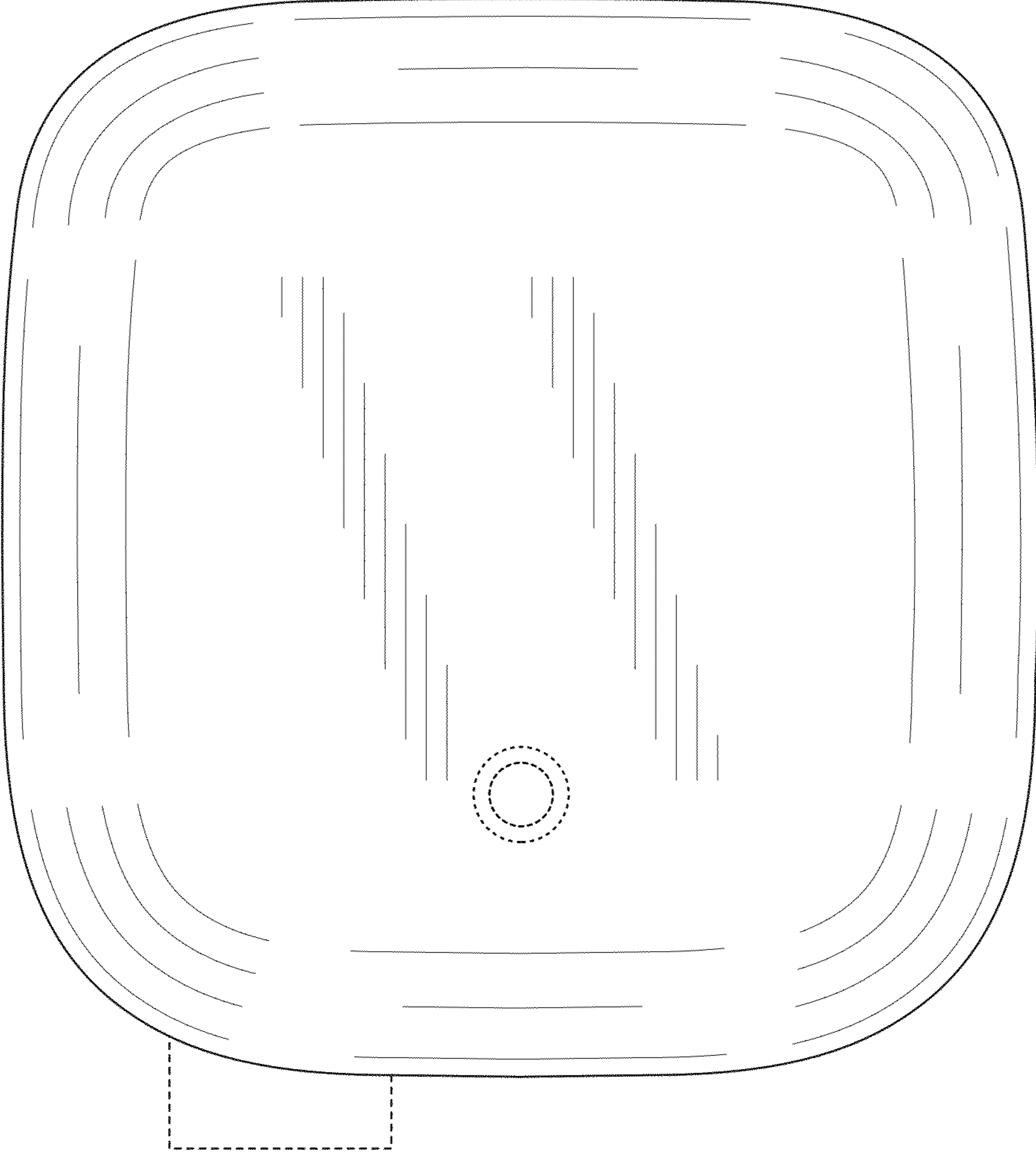
