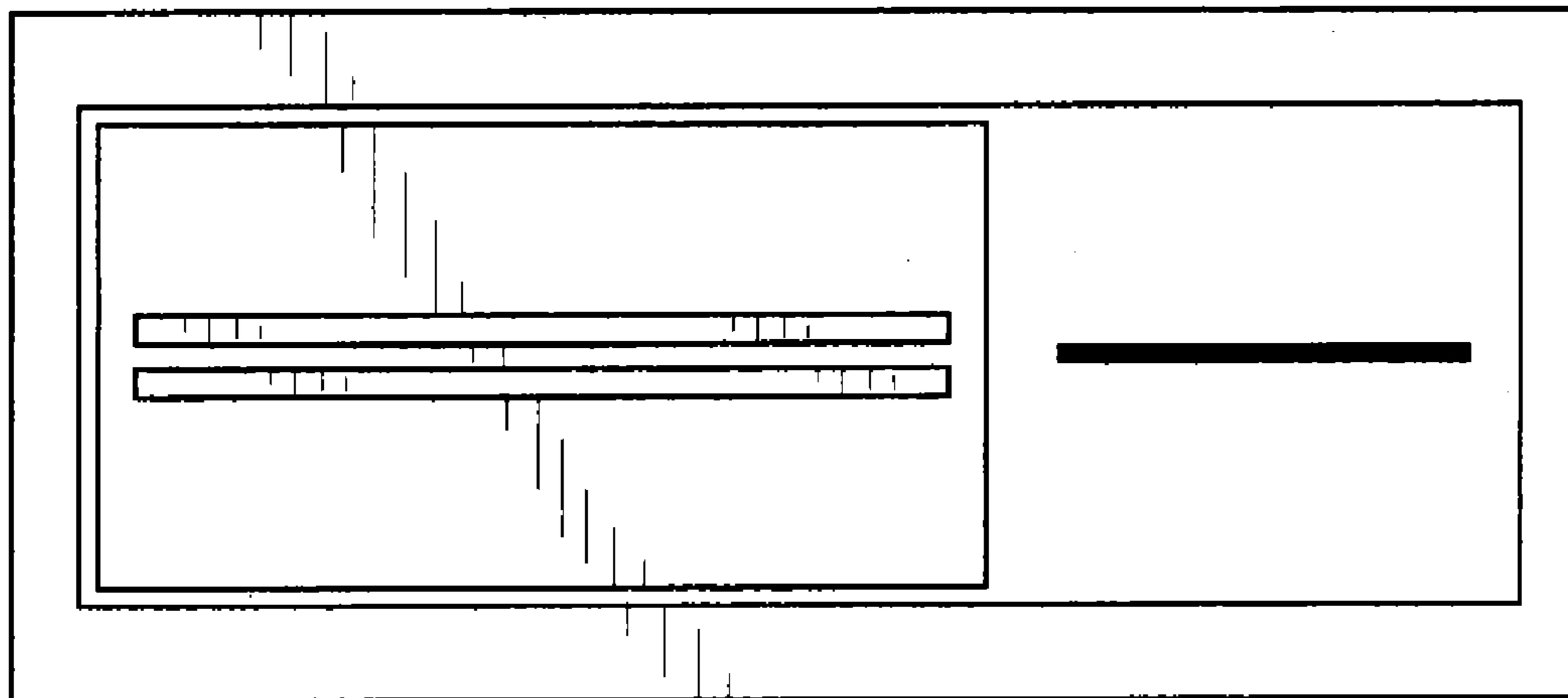

DESCRIPTION

FIG. 1 is a front, isometric view of a label showing our design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a top view thereof; the bottom view being a mirror image; and,
FIG. 5 is a left side view thereof, the right side view being a mirror image.

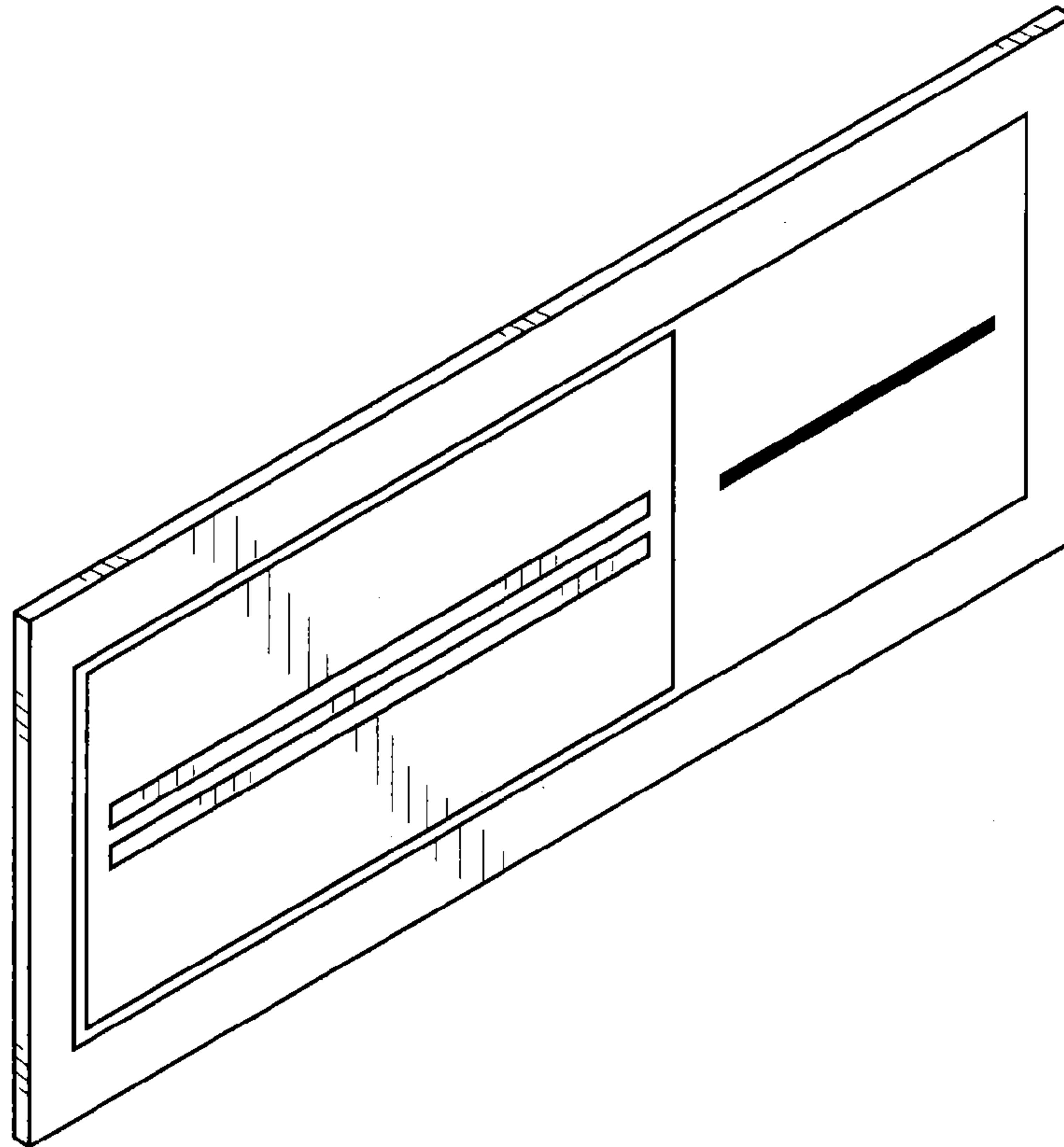

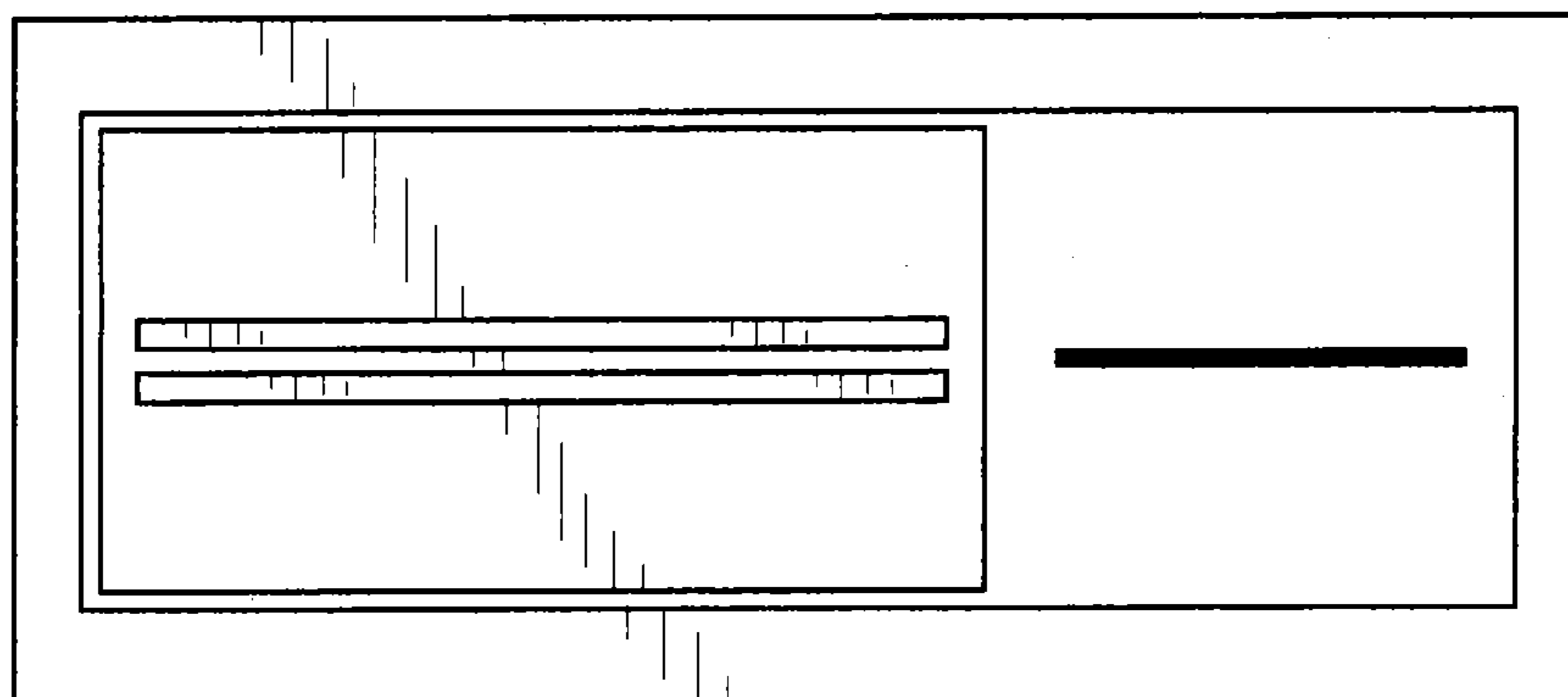

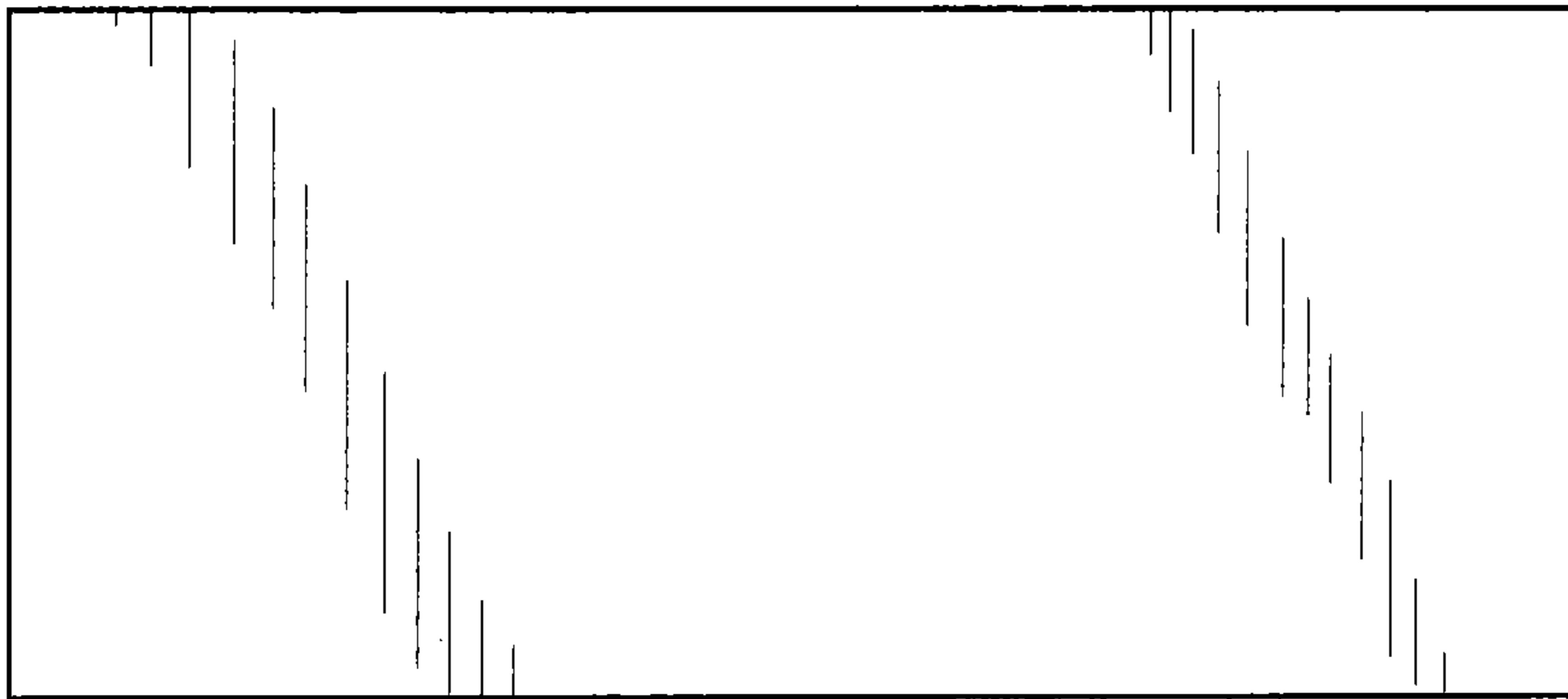
