The ornamental design for a puzzle with twelve pieces, as shown and described.

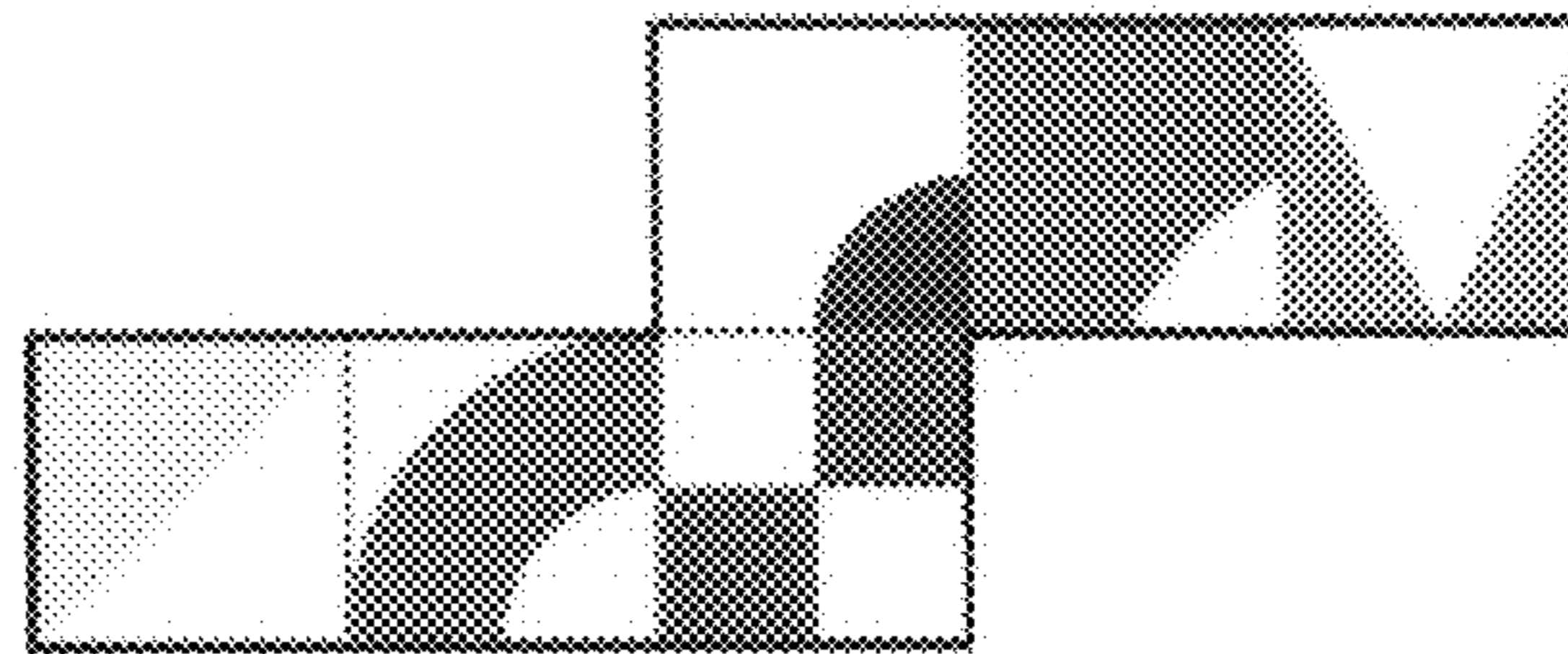
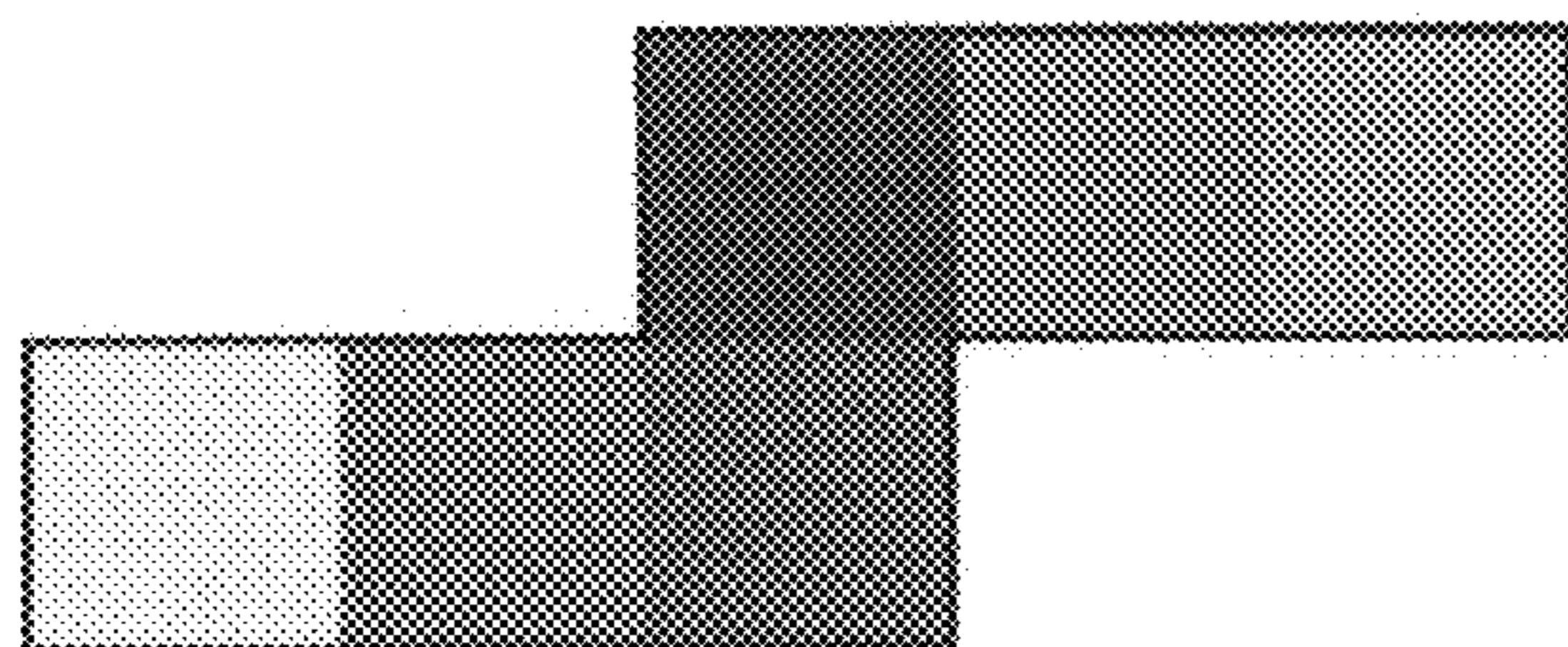
DESCRIPTION

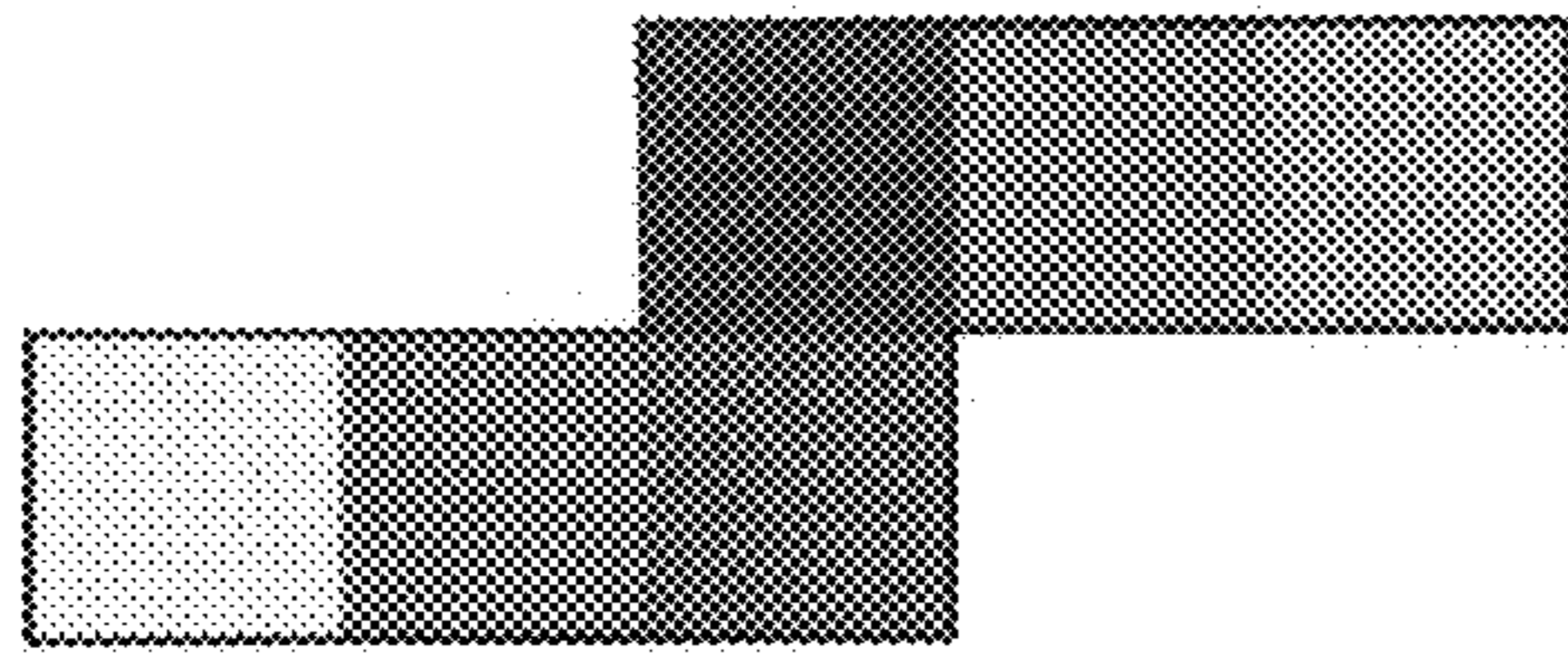

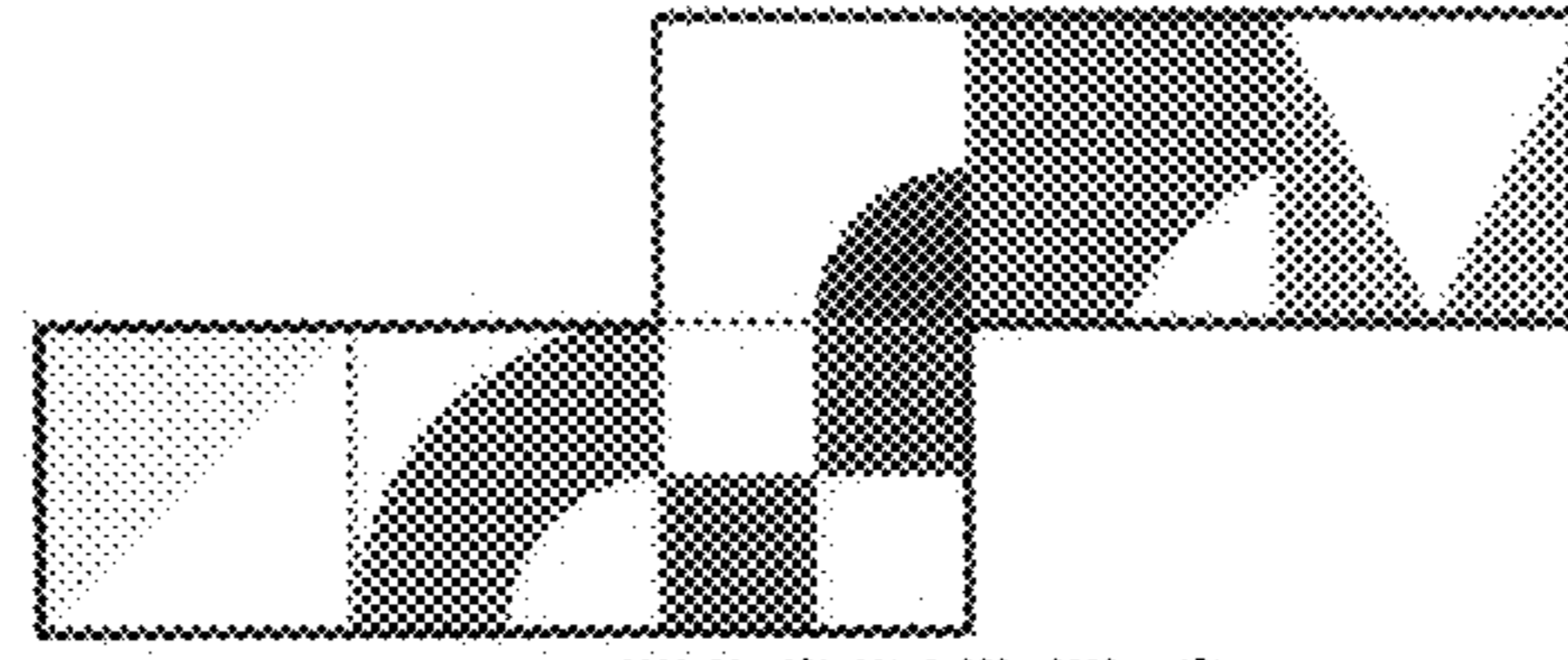

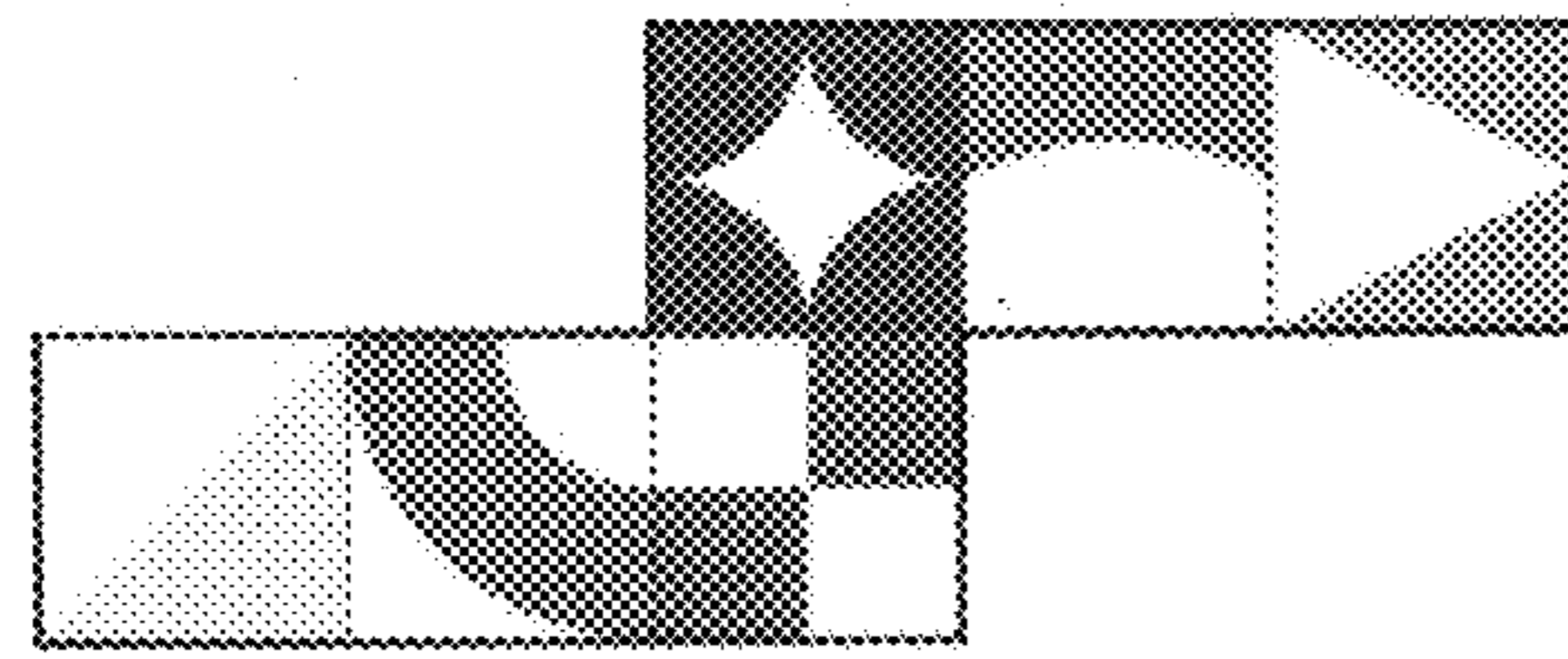

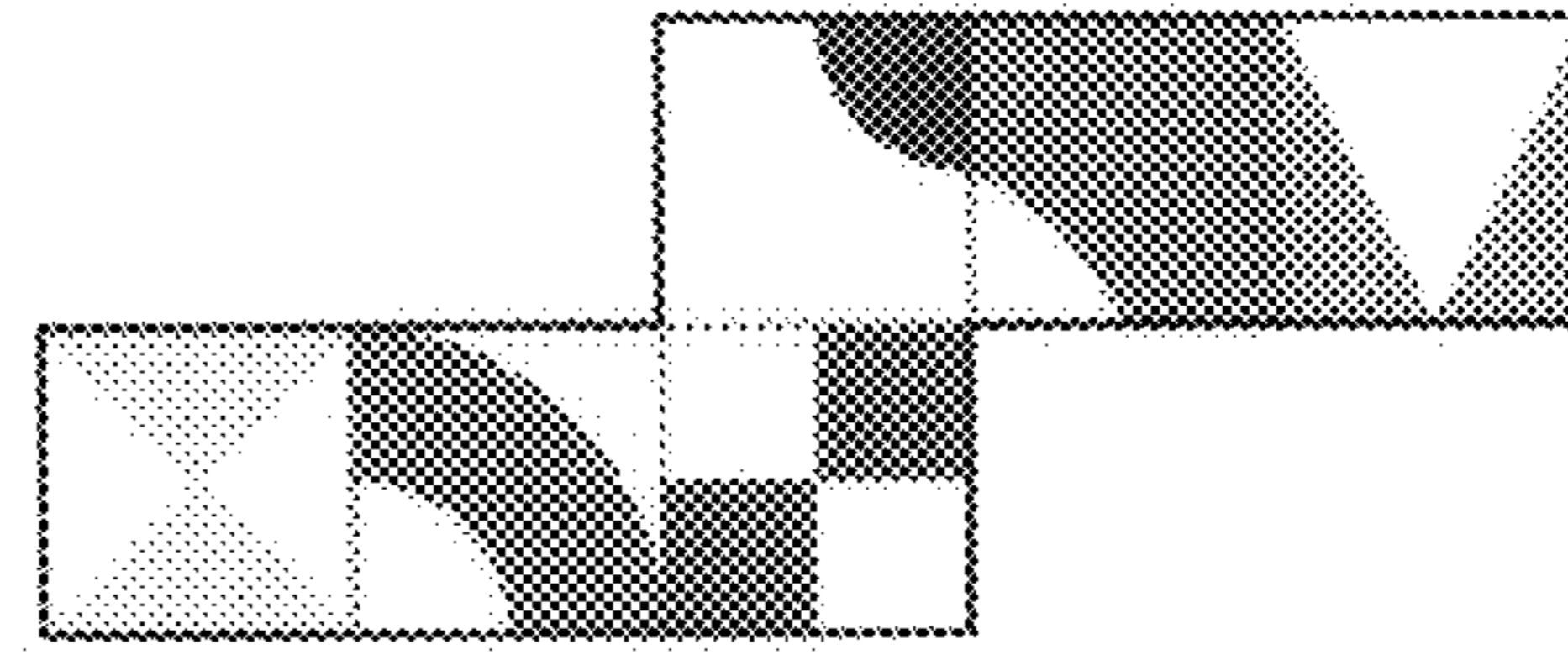

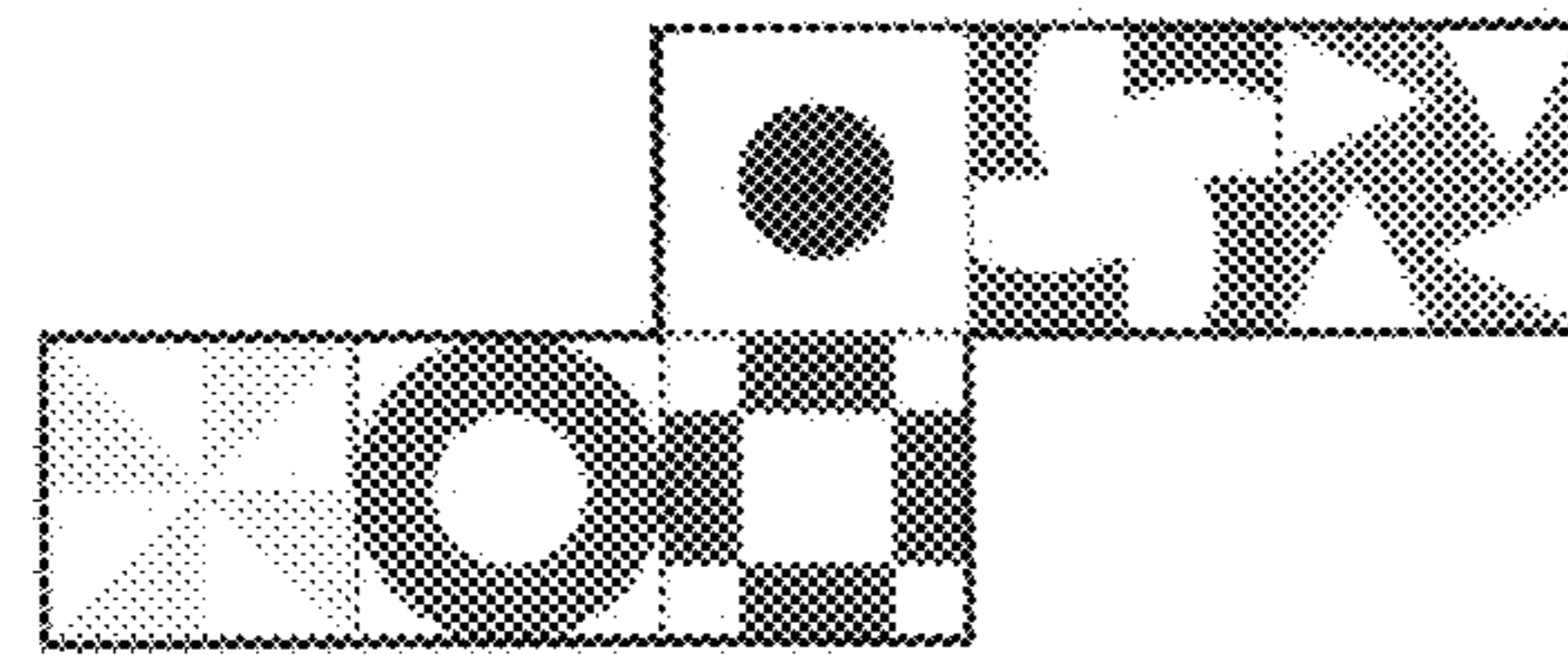

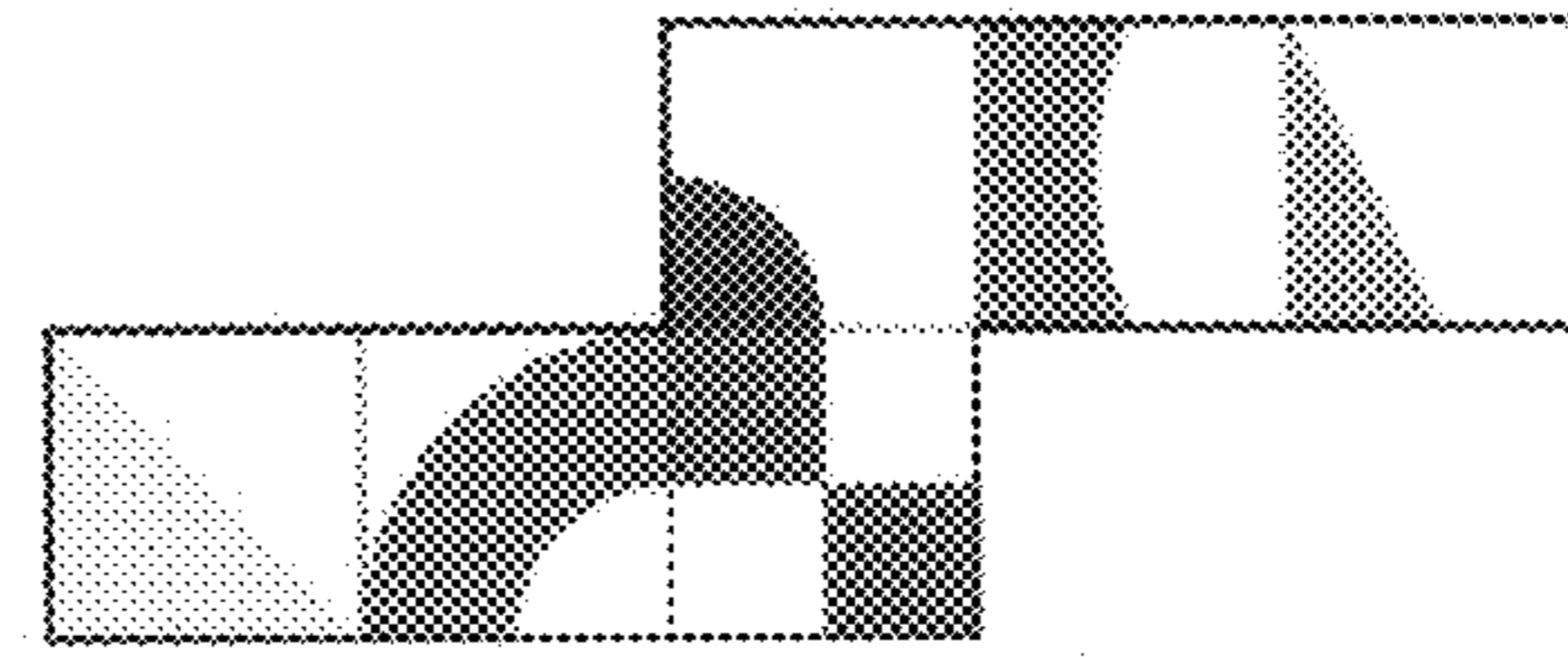

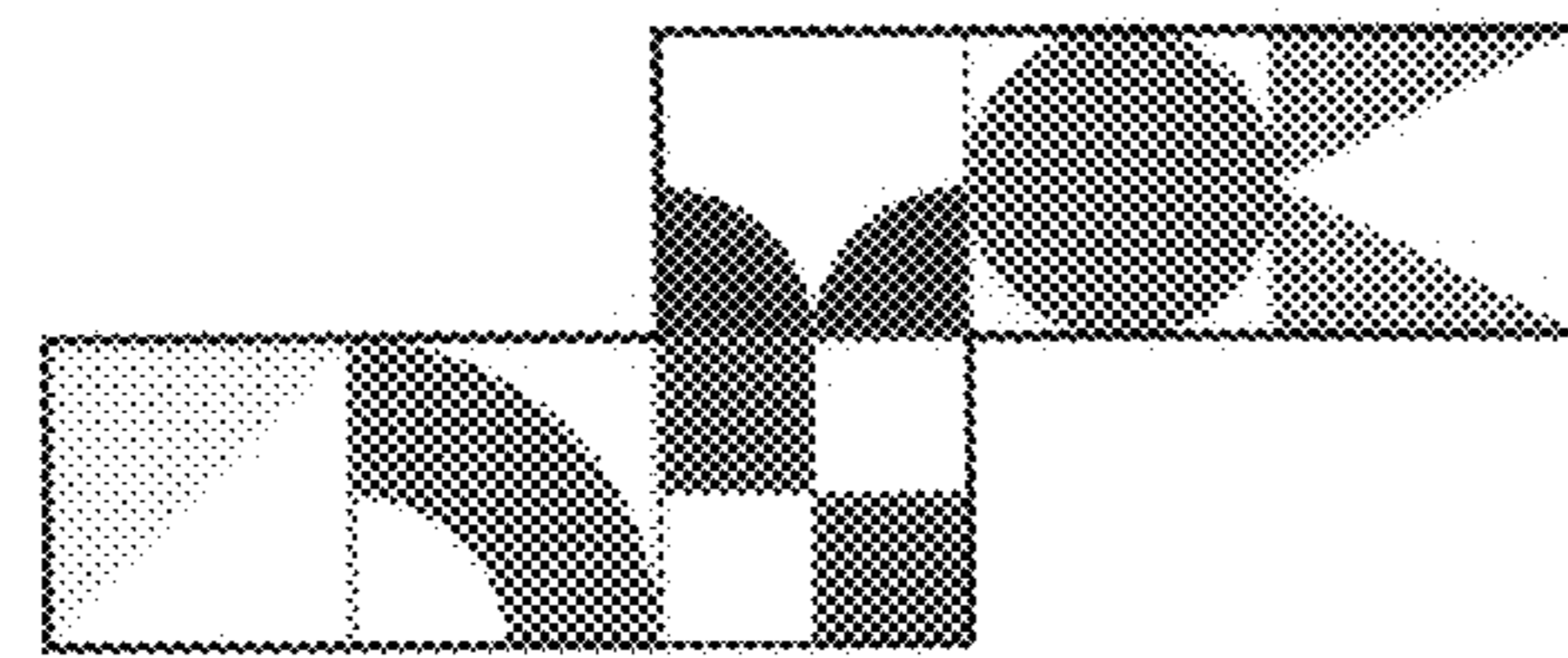

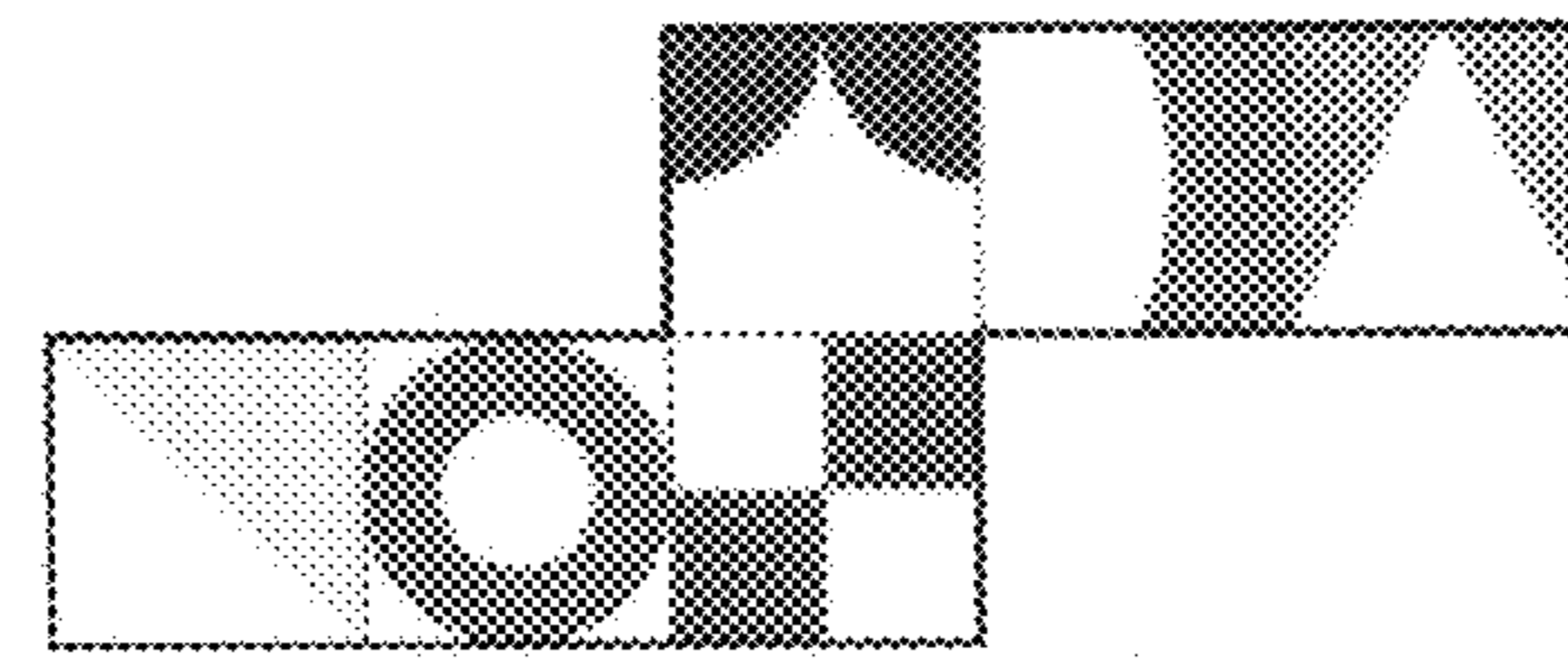

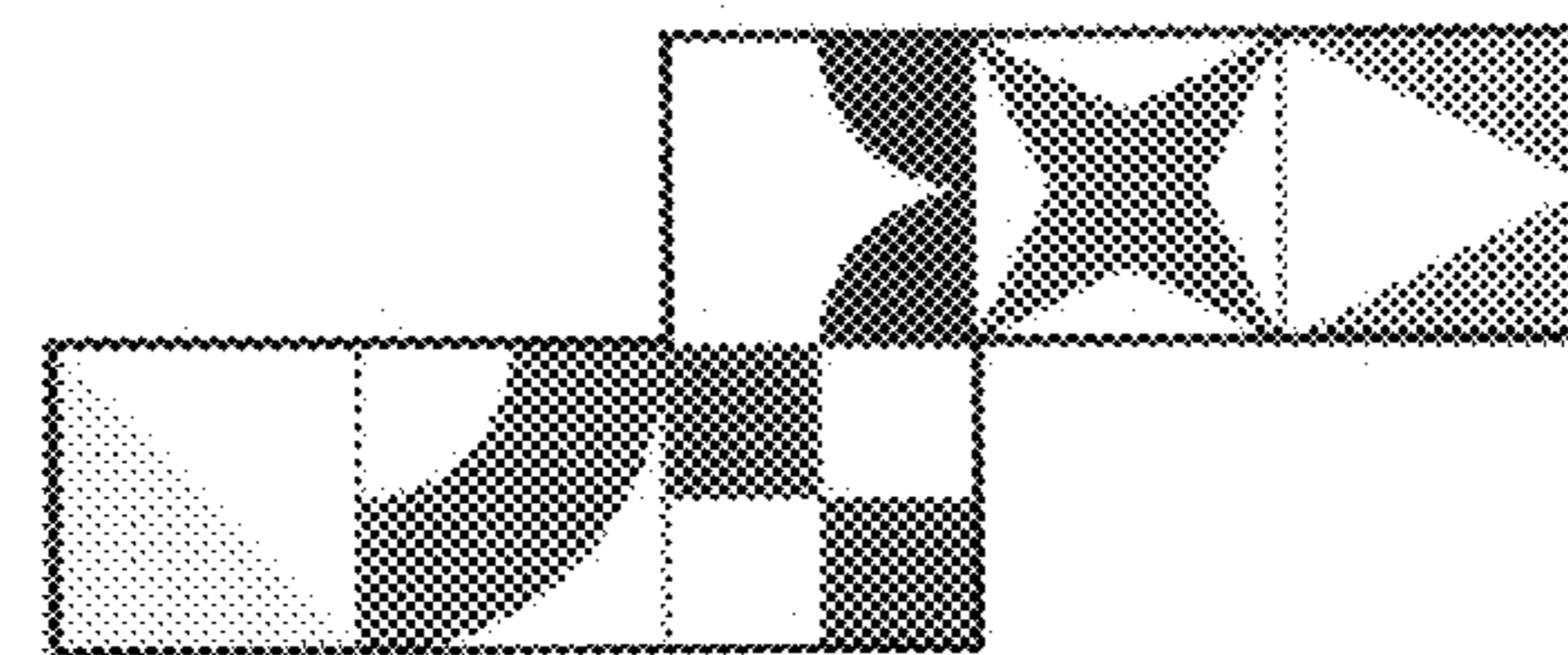

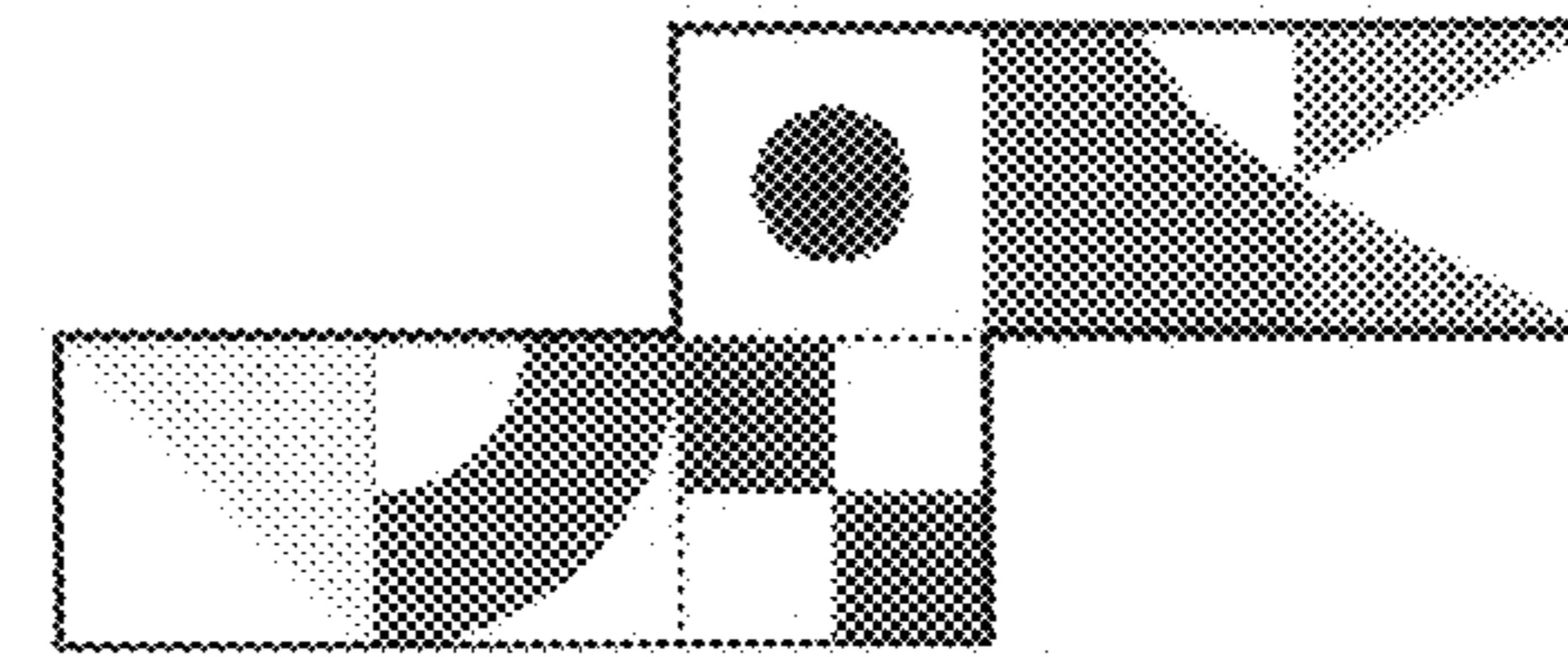

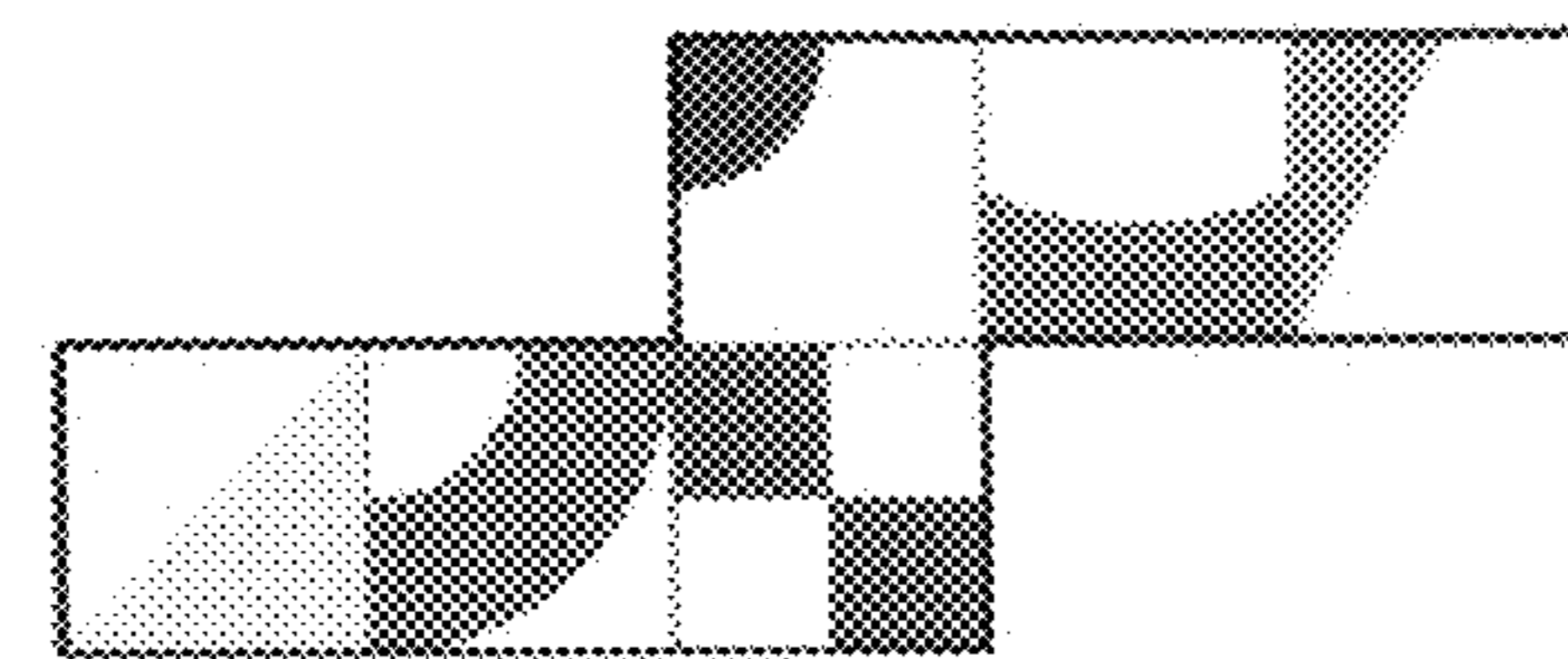

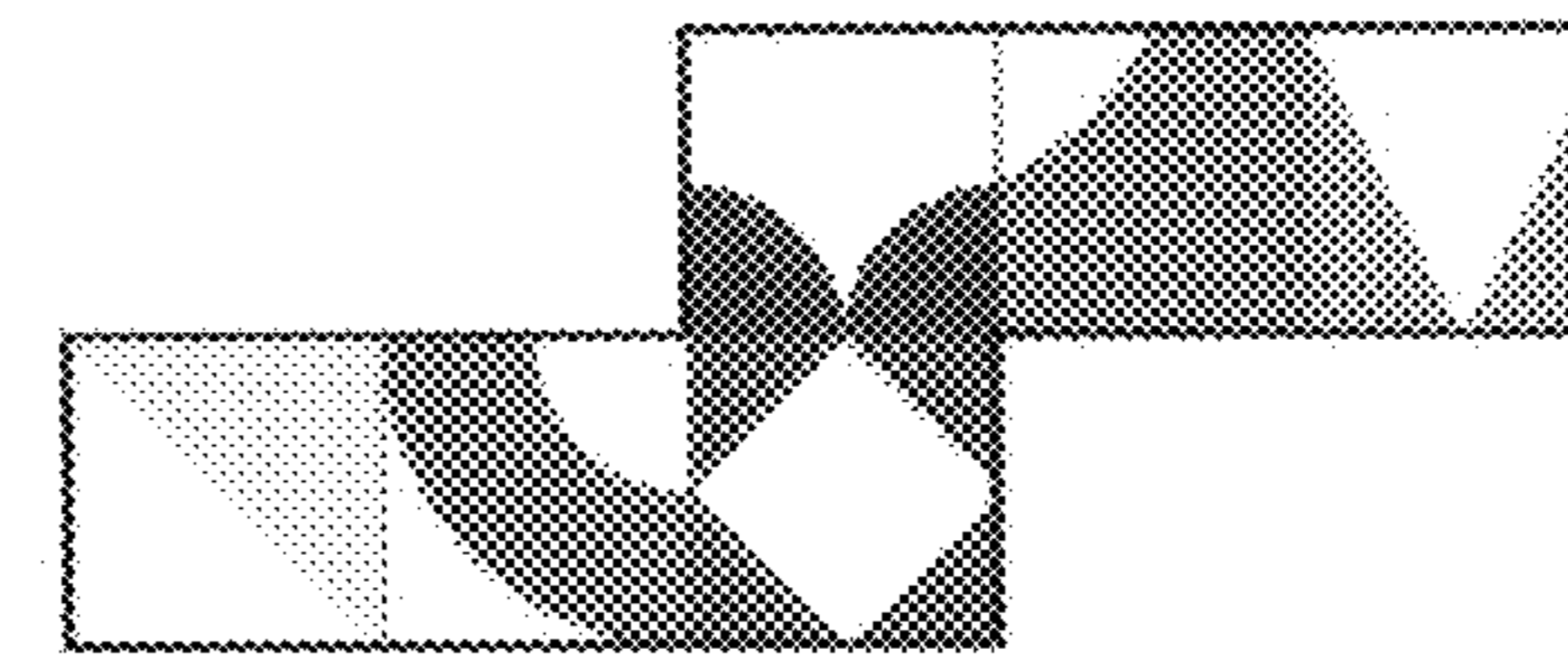

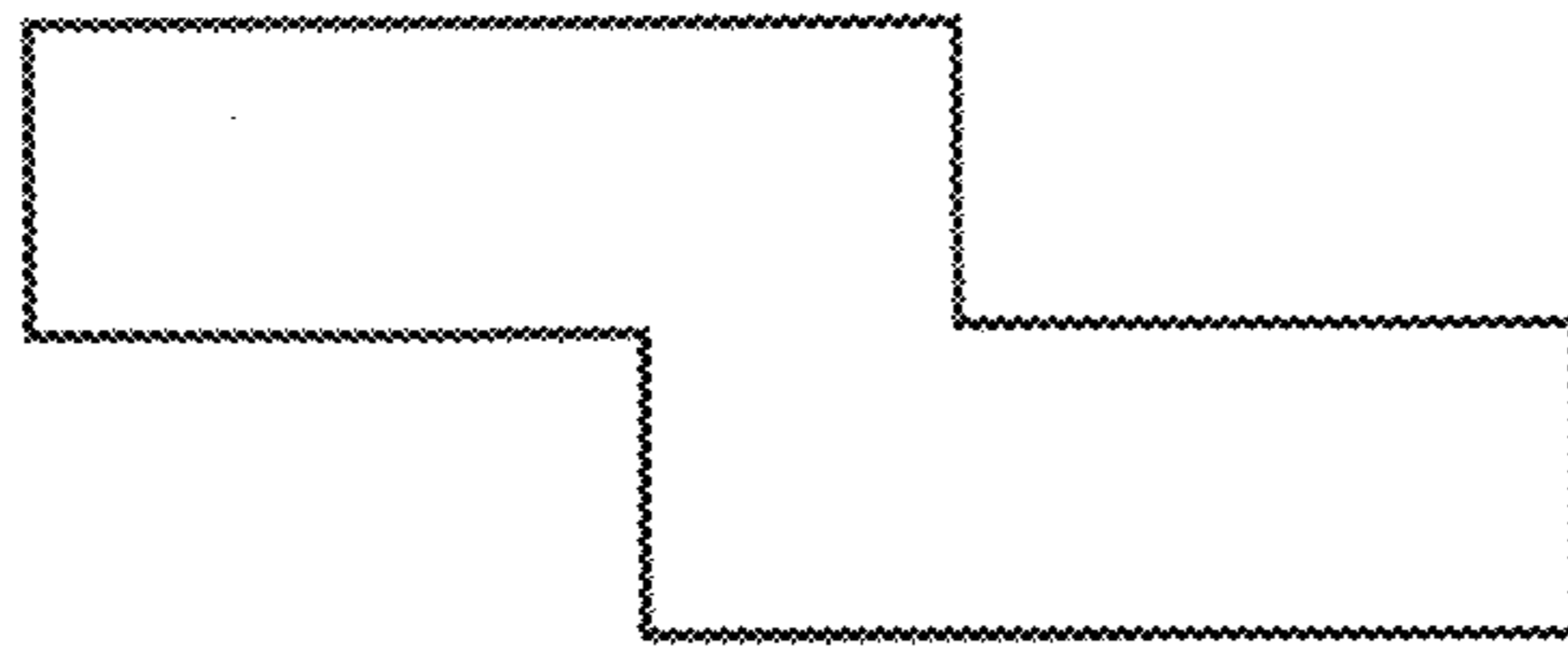
