FIG. 3 is a front view of the valve cover;

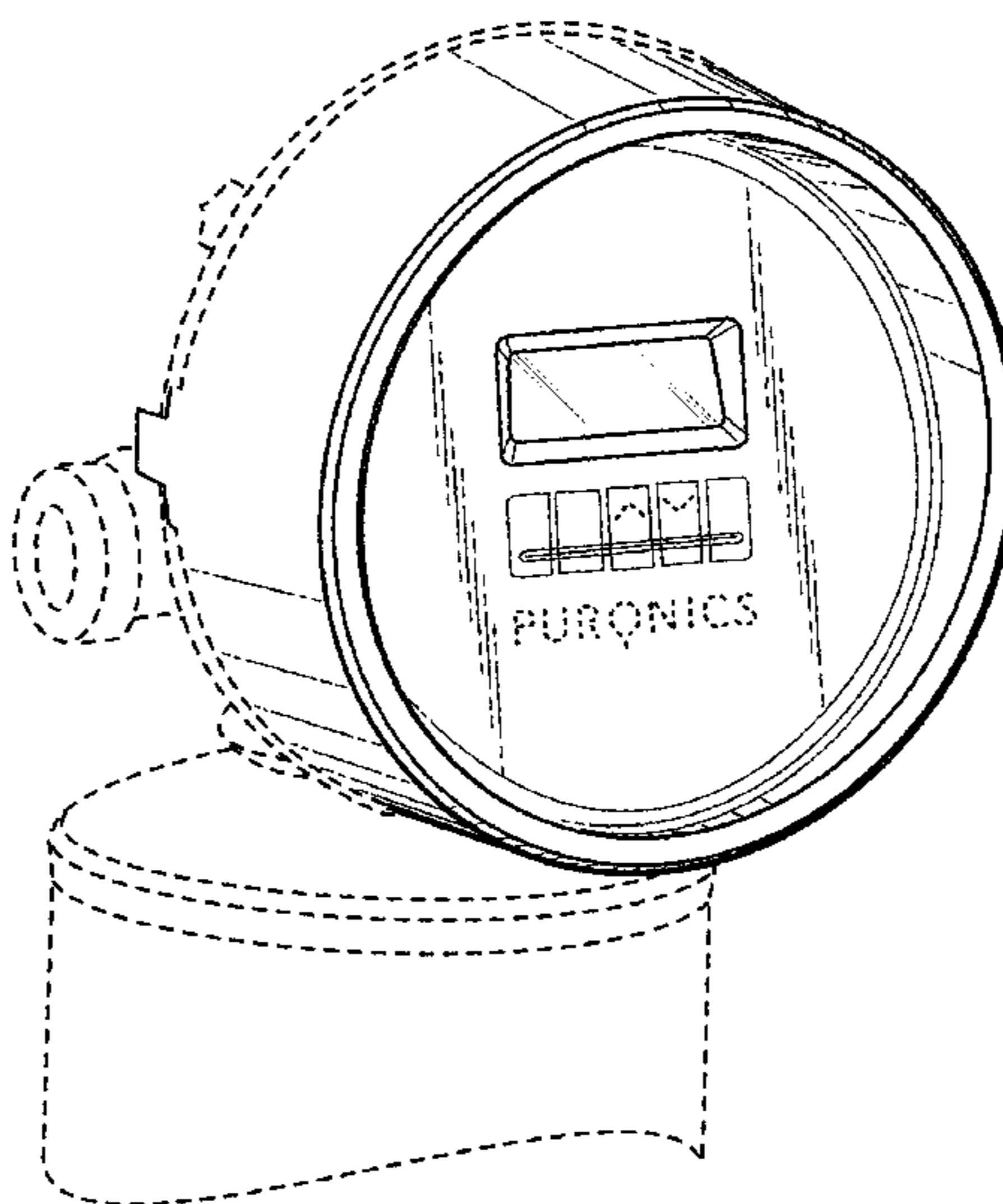
FIG. 4 is a left side view of the valve cover;

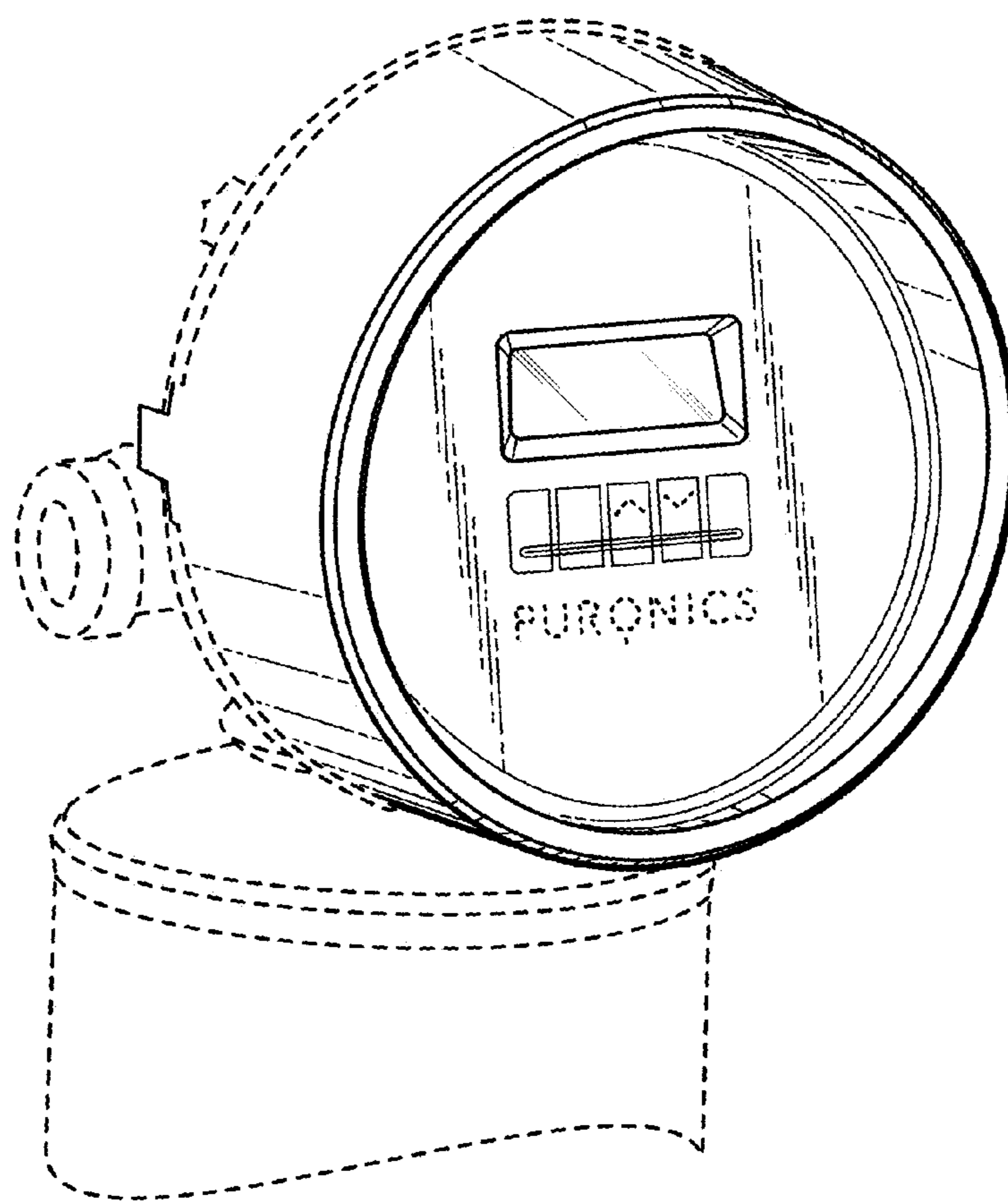

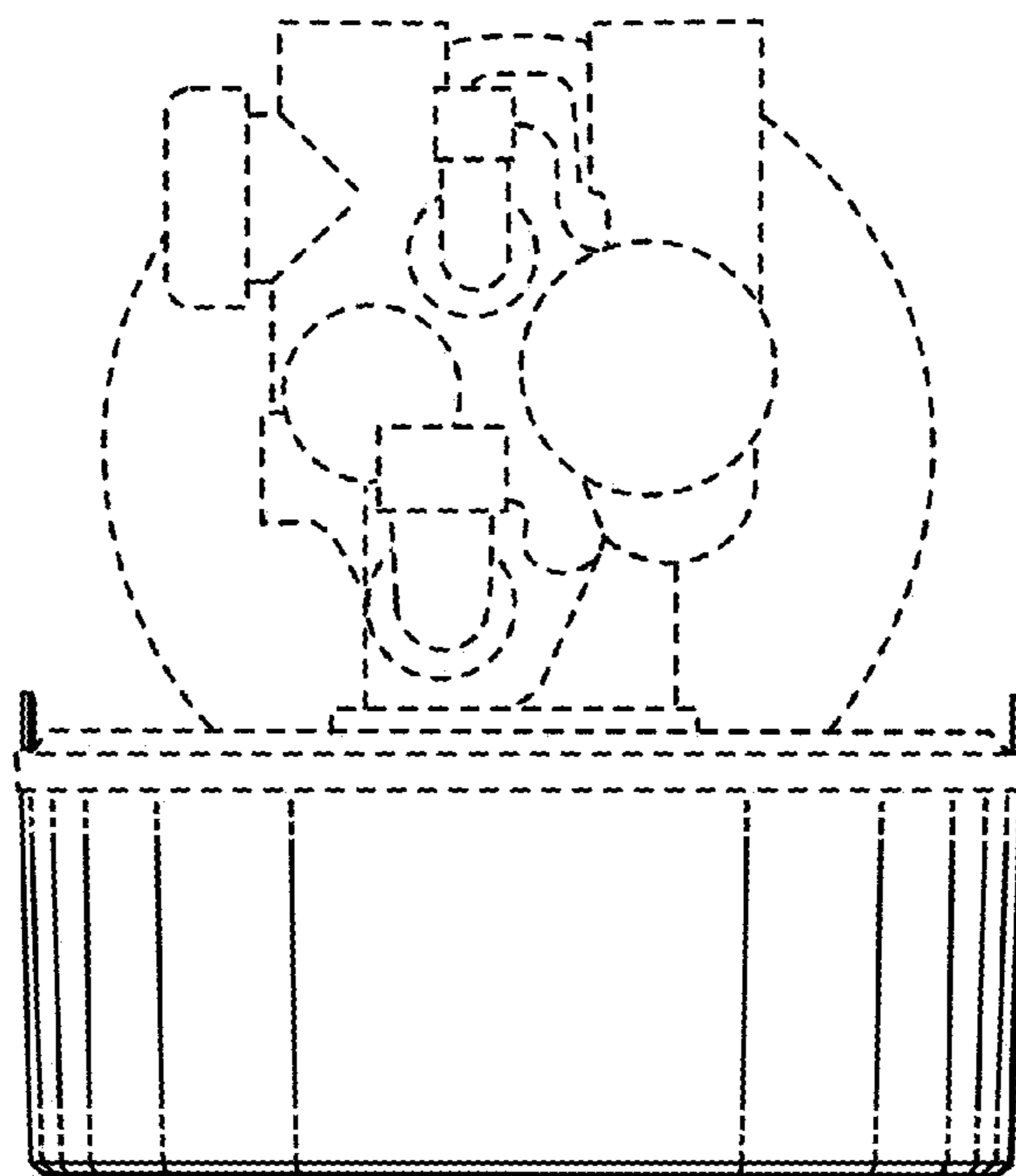

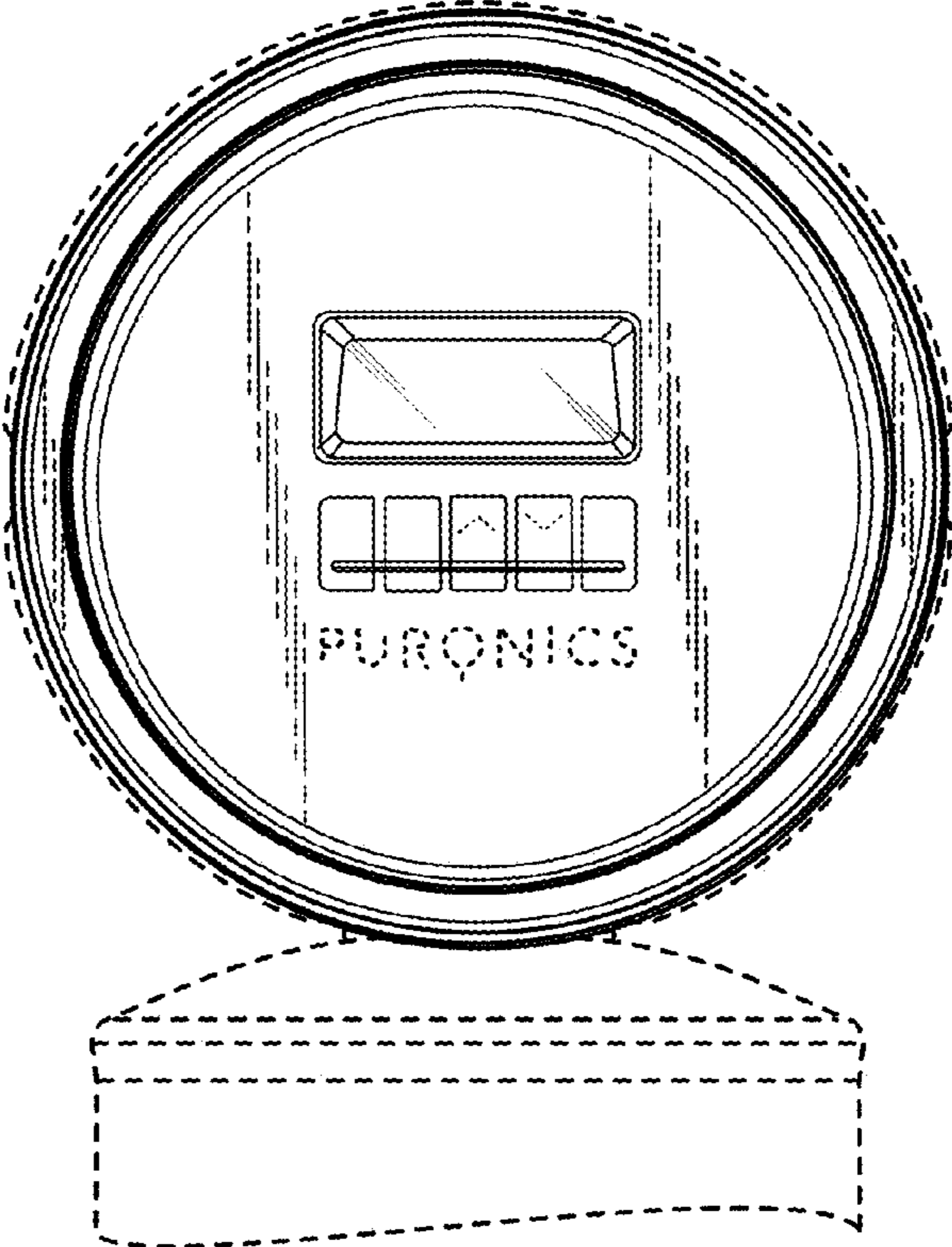

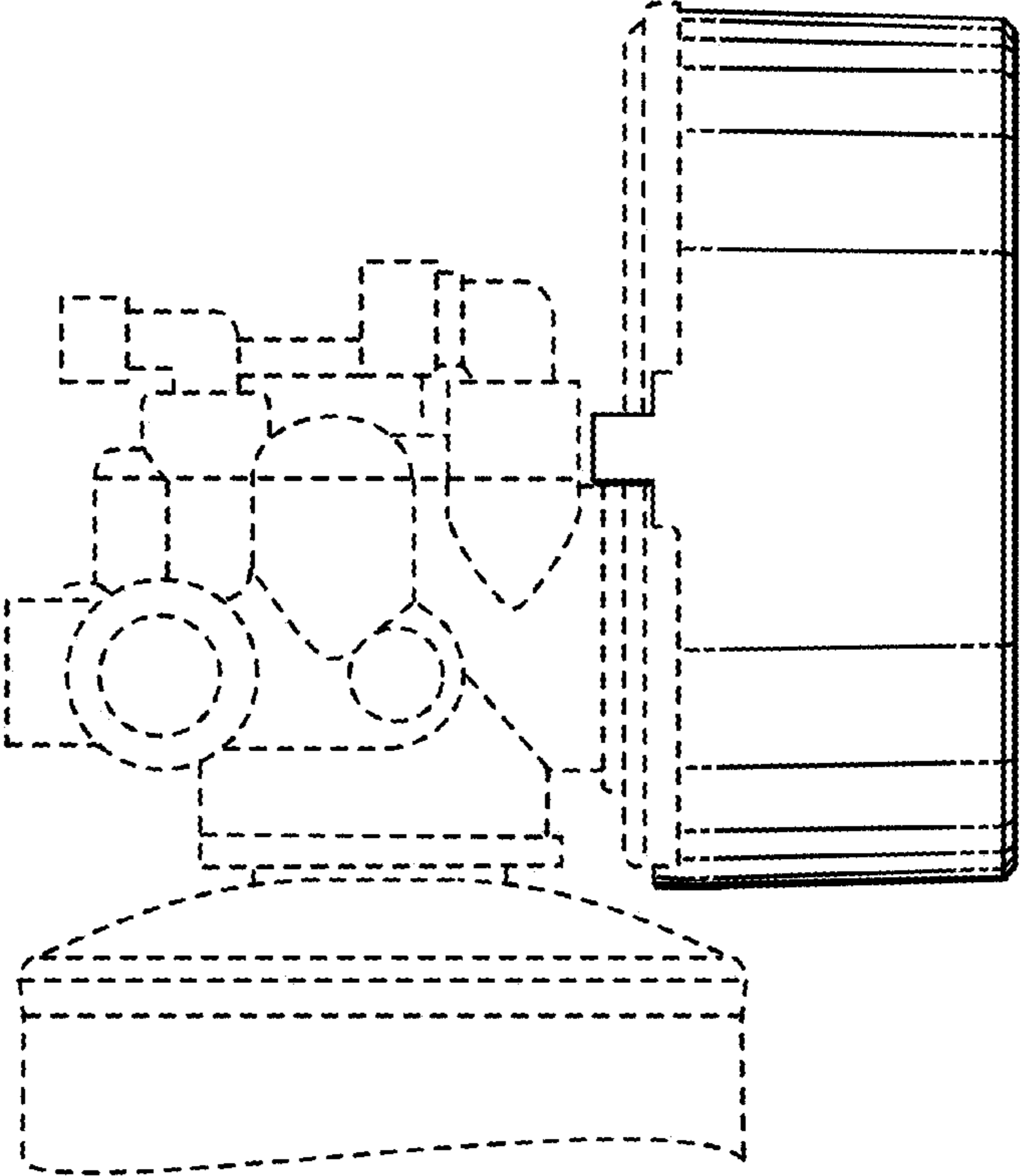

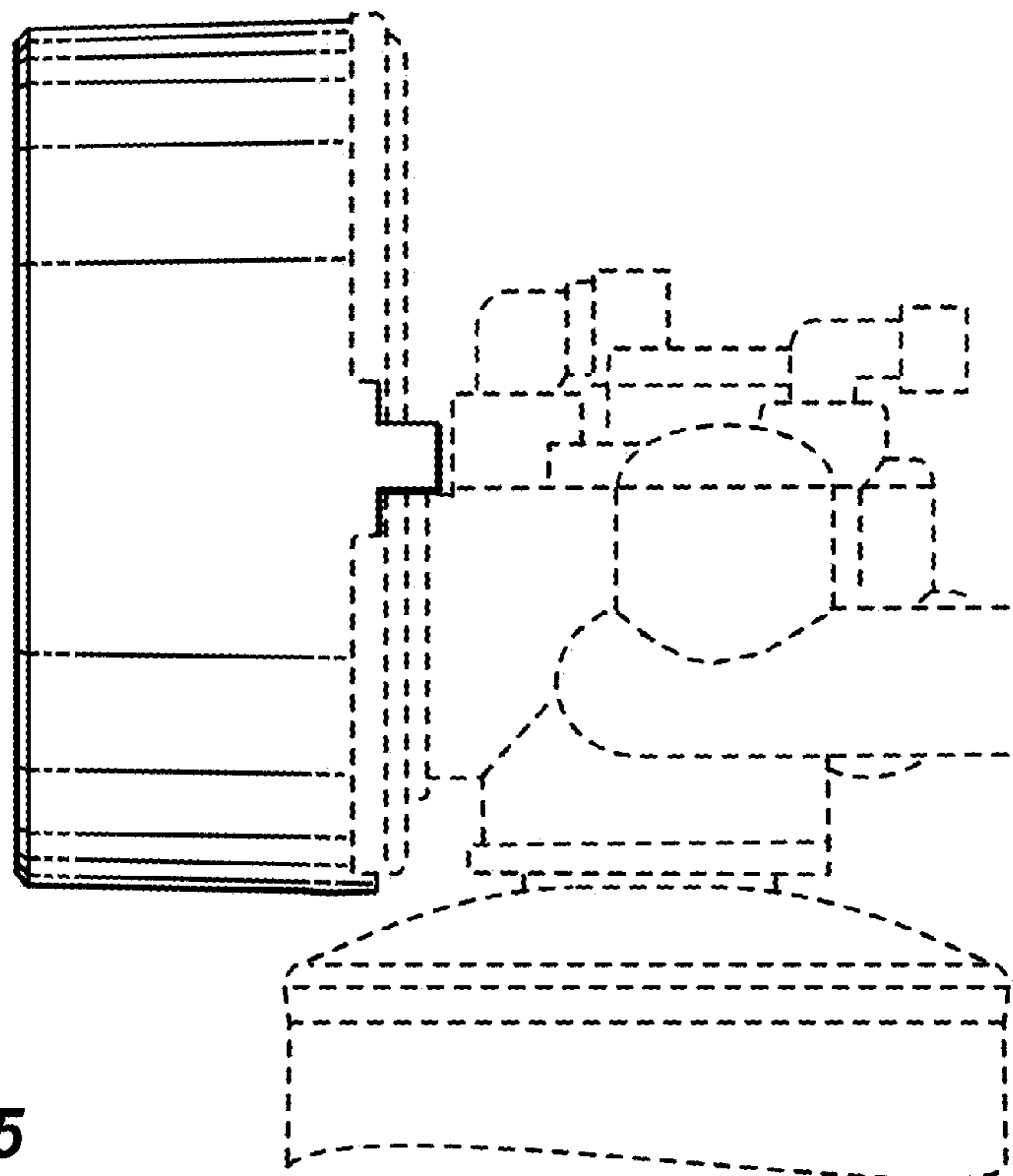

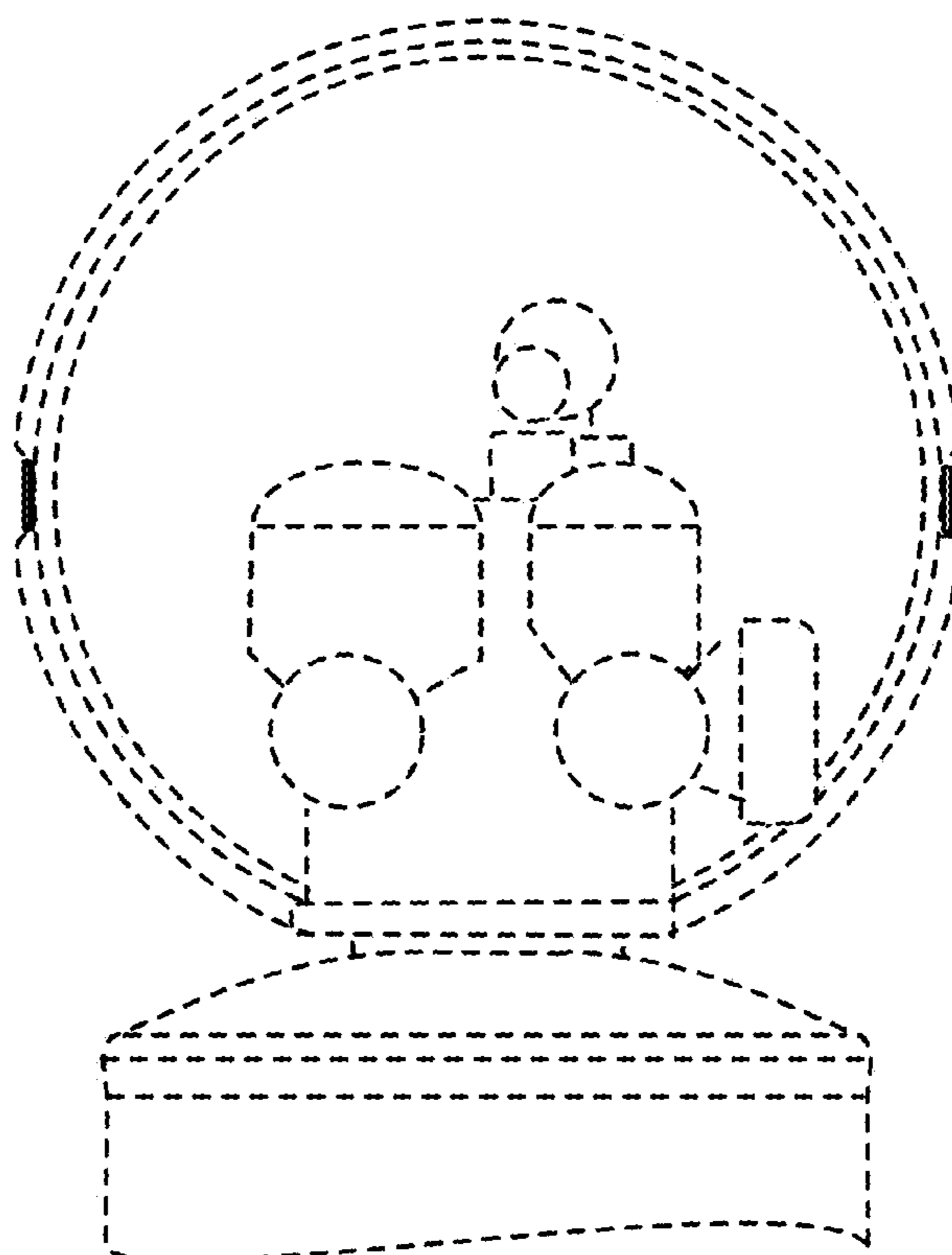
