CLAIM

The ornamental design for a X-ray tube for medical device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a X-ray tube for medical device showing my new design,

FIG. 2 is a rear perspective view thereof,

FIG. 3 is a front elevational view thereof,

FIG. 4 is a rear elevational view thereof,

FIG. 5 is a left side elevational view thereof,

FIG. 6 is a right side elevational view thereof,

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

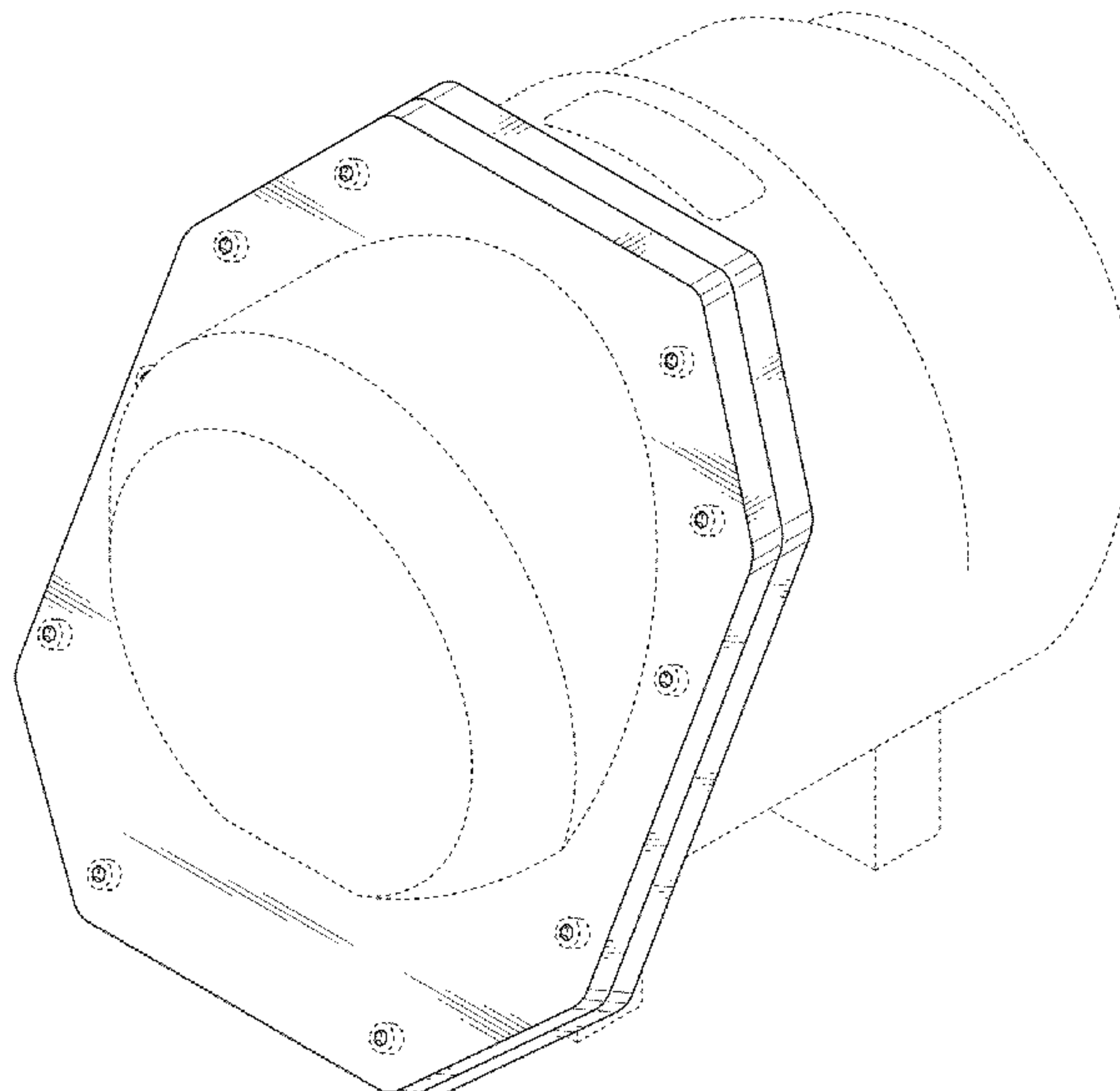

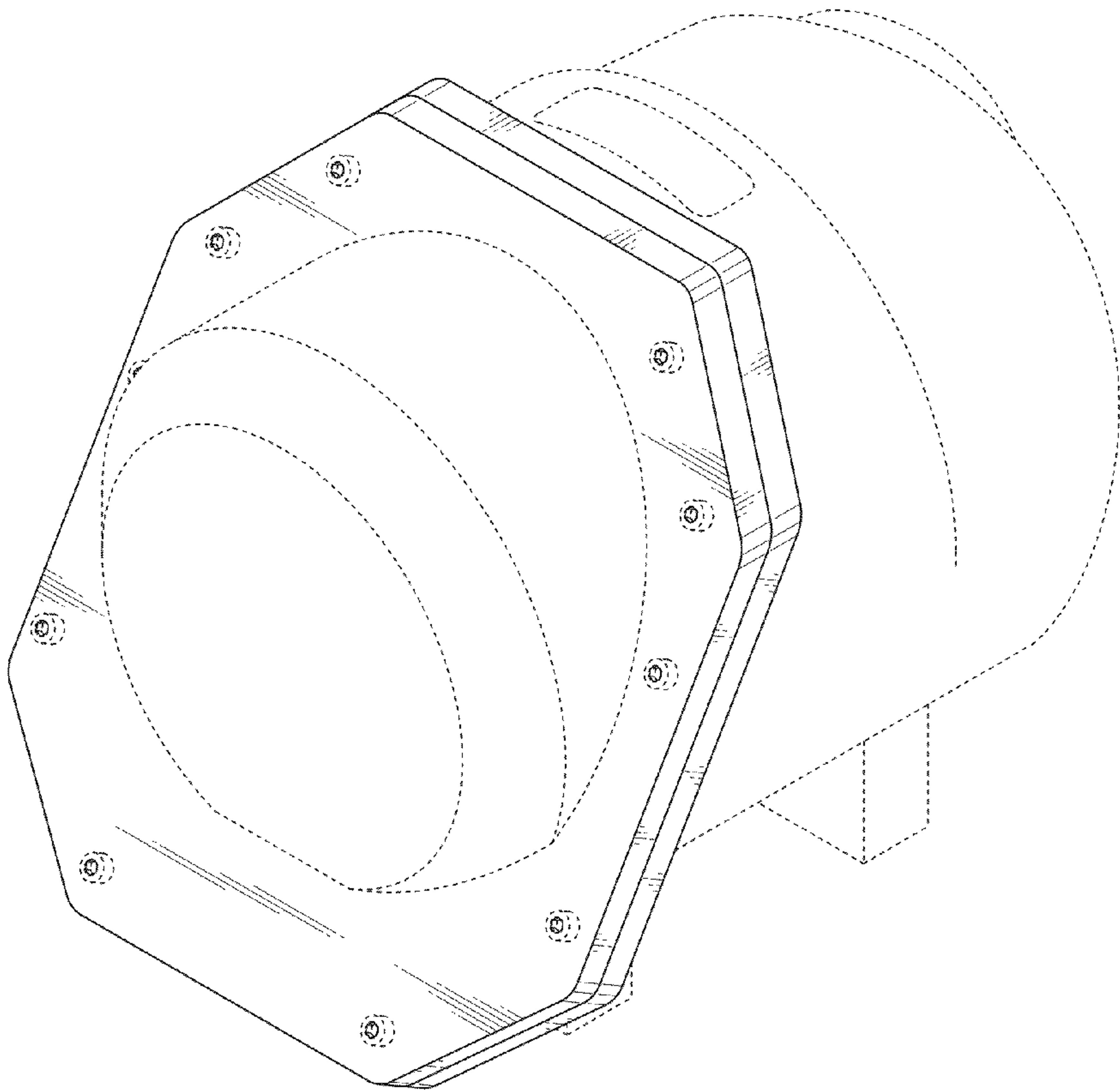

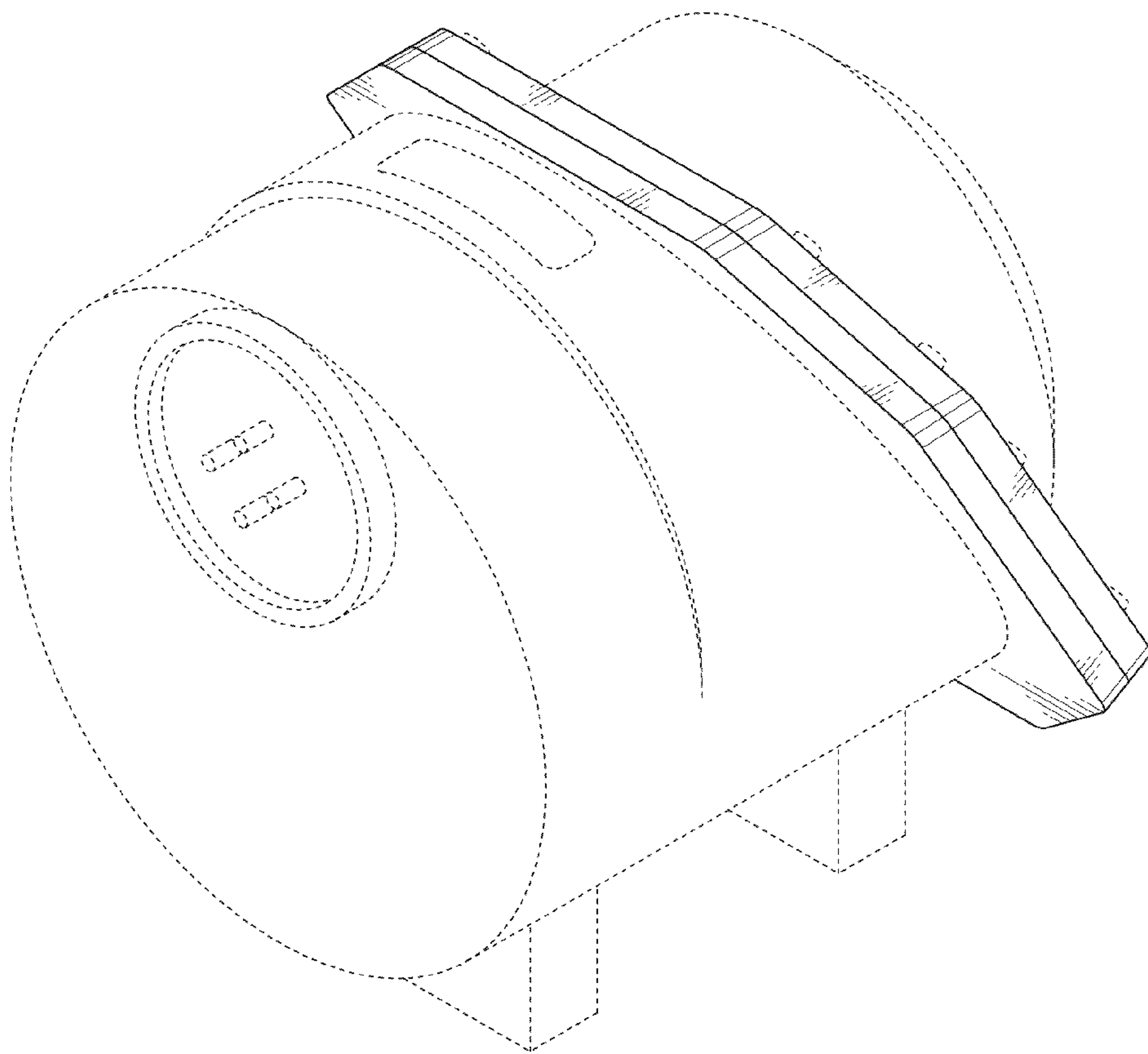

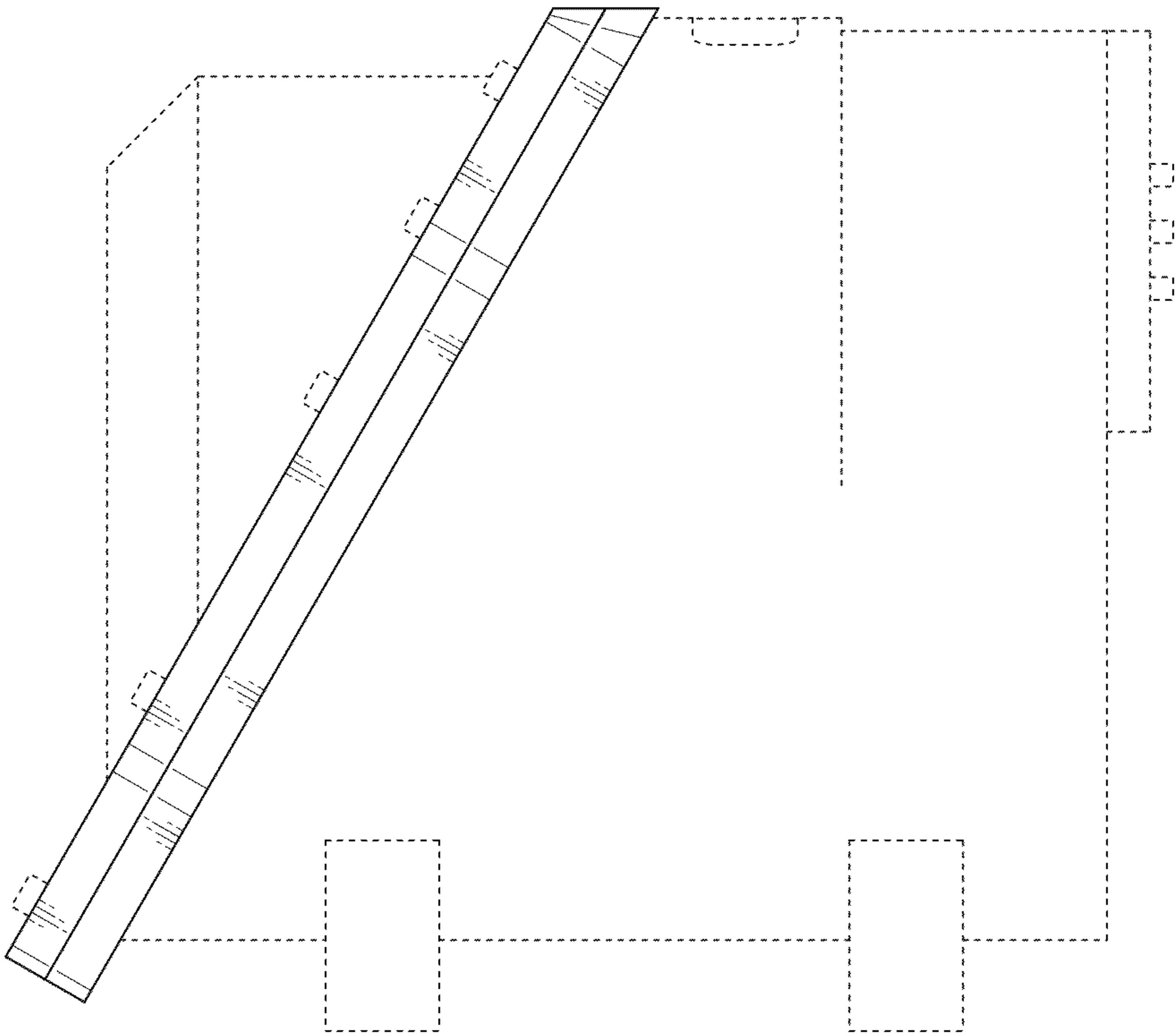

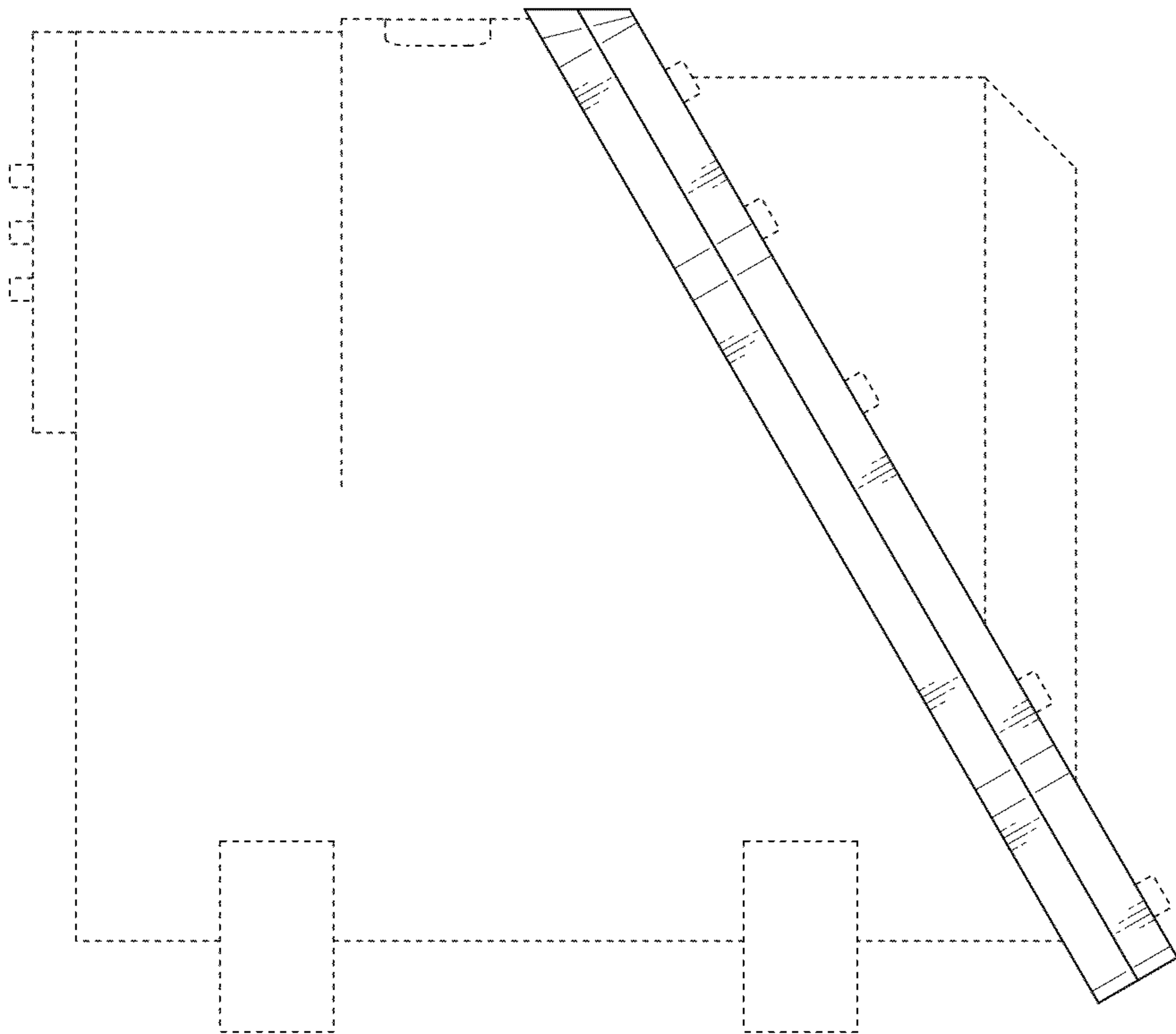

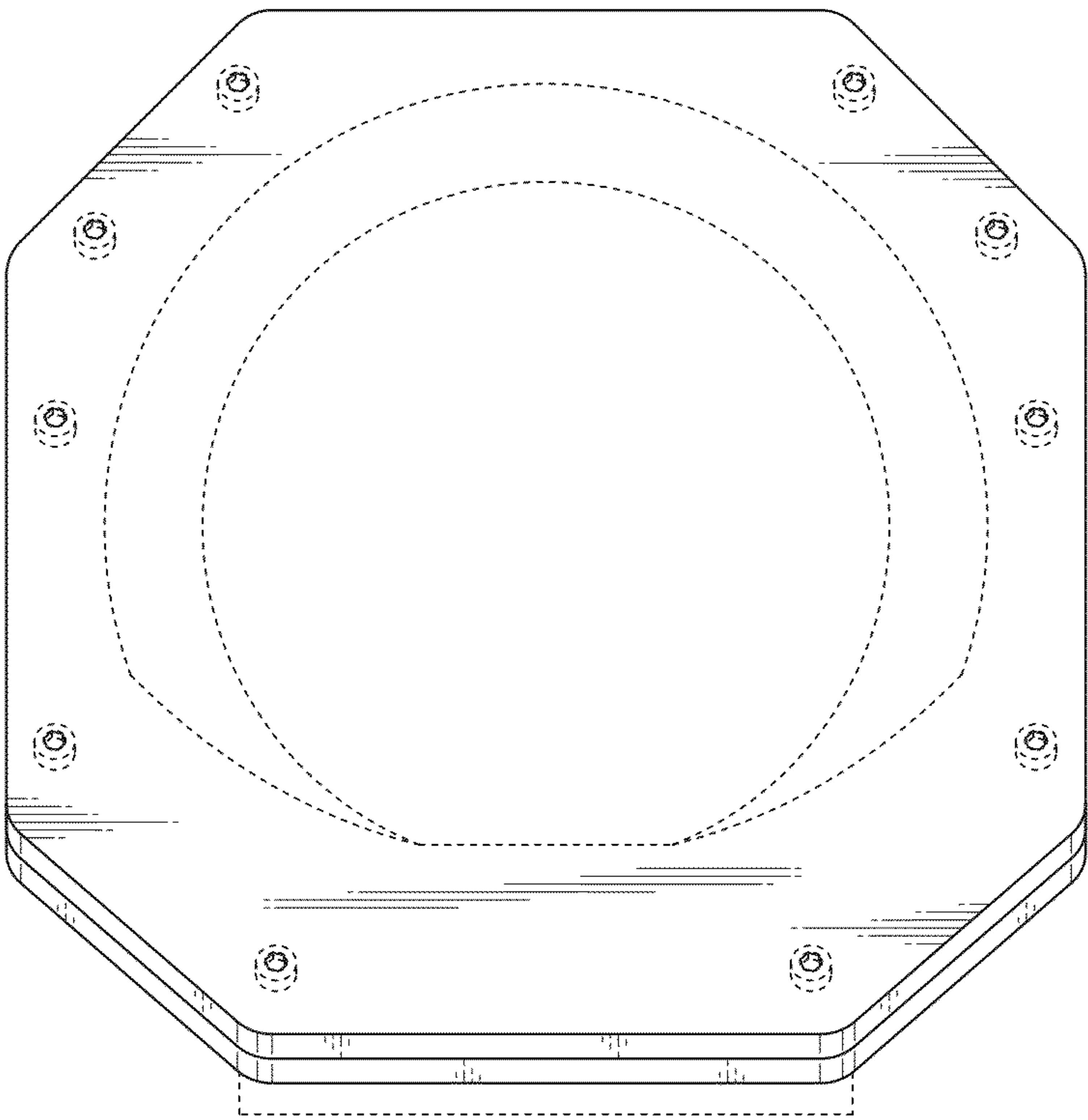

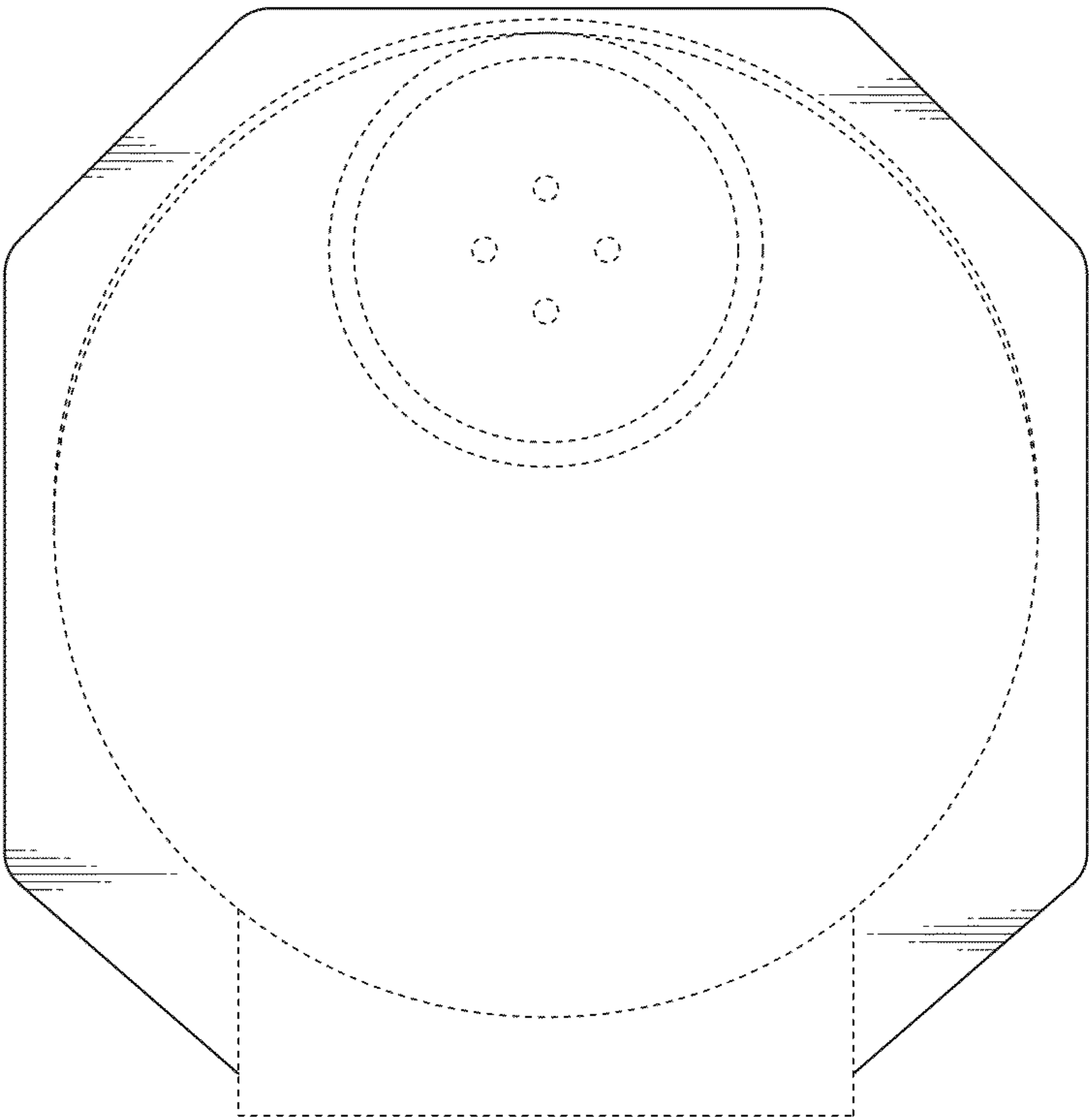

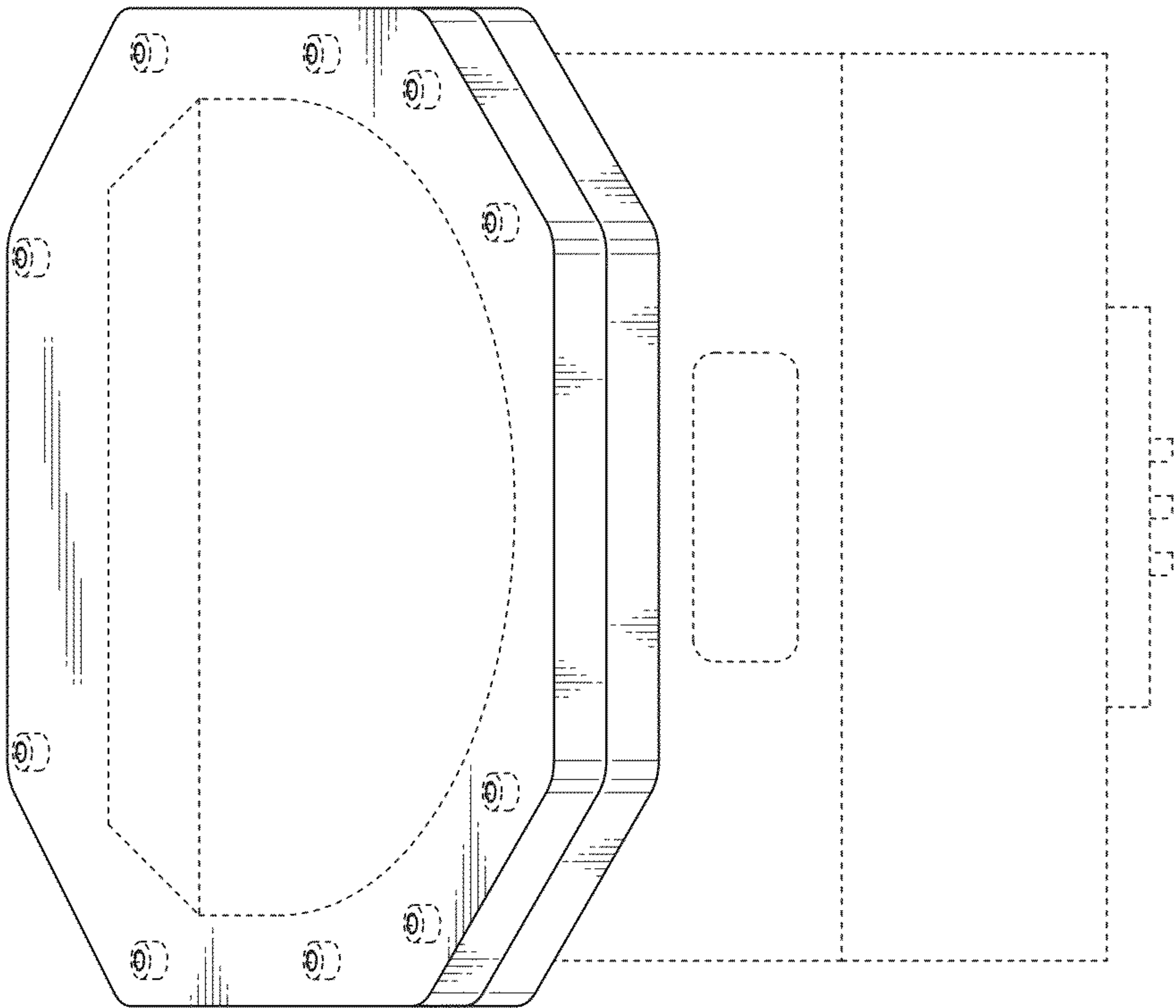
