DESCRIPTION

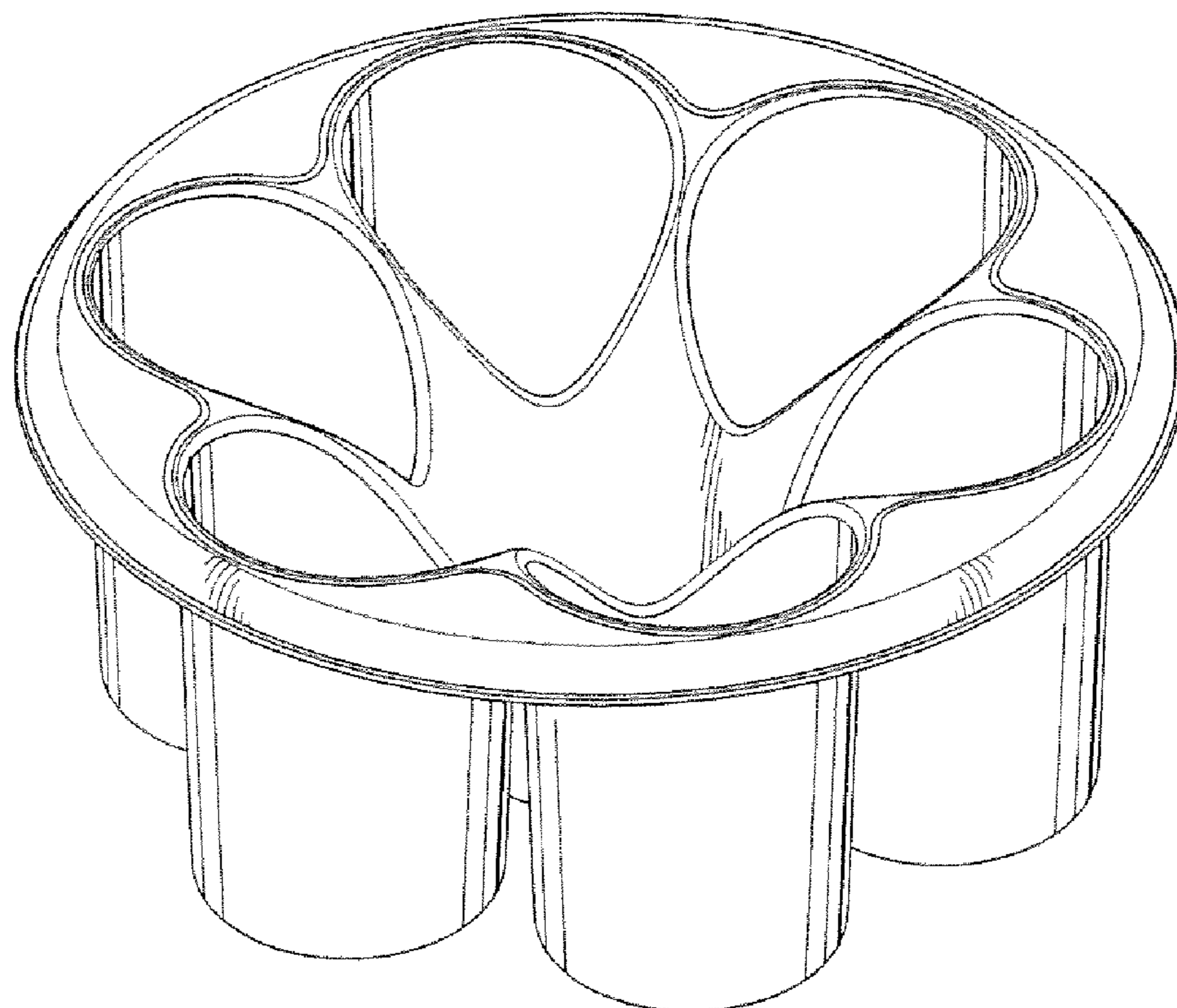
FIG. 1 is a perspective view of a feeding bottle holder my new design;

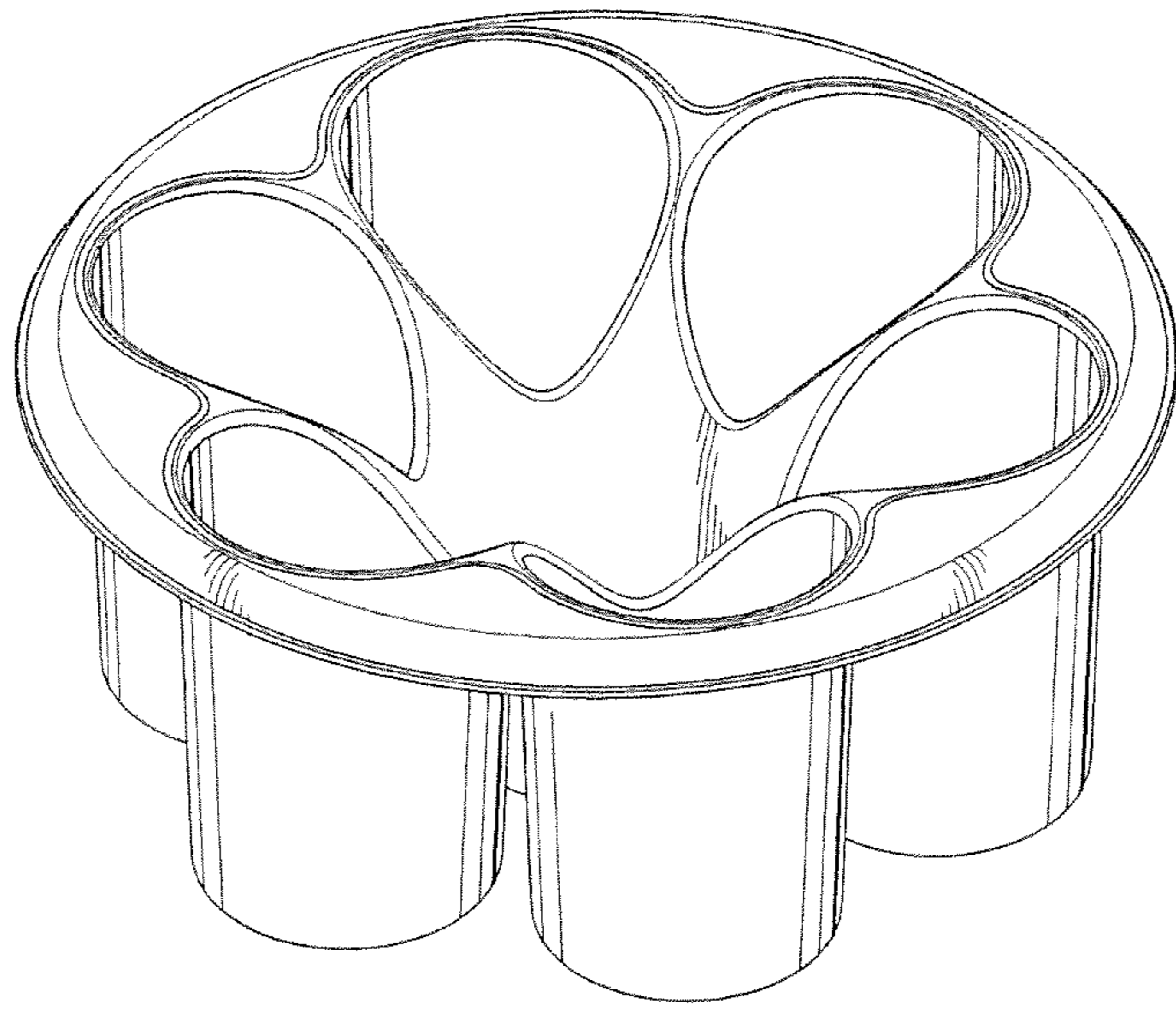

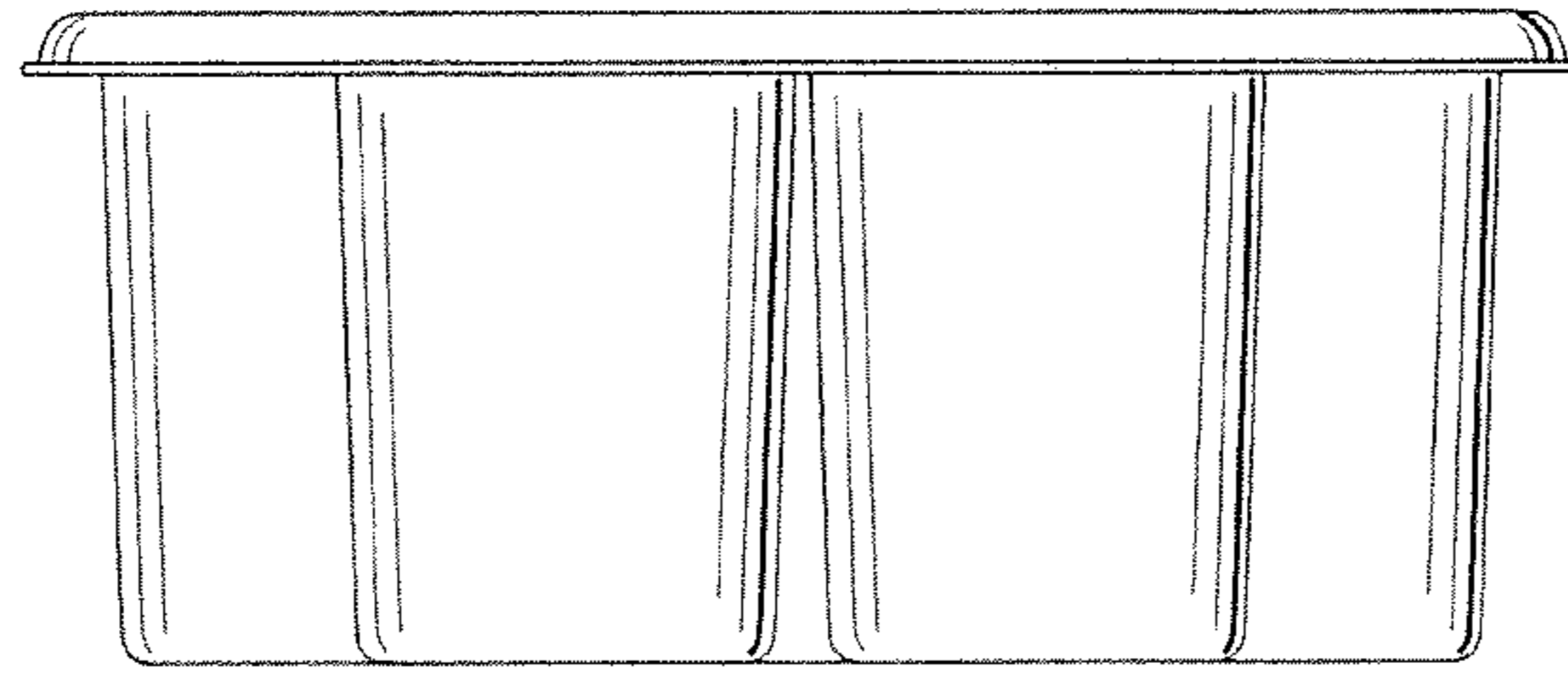

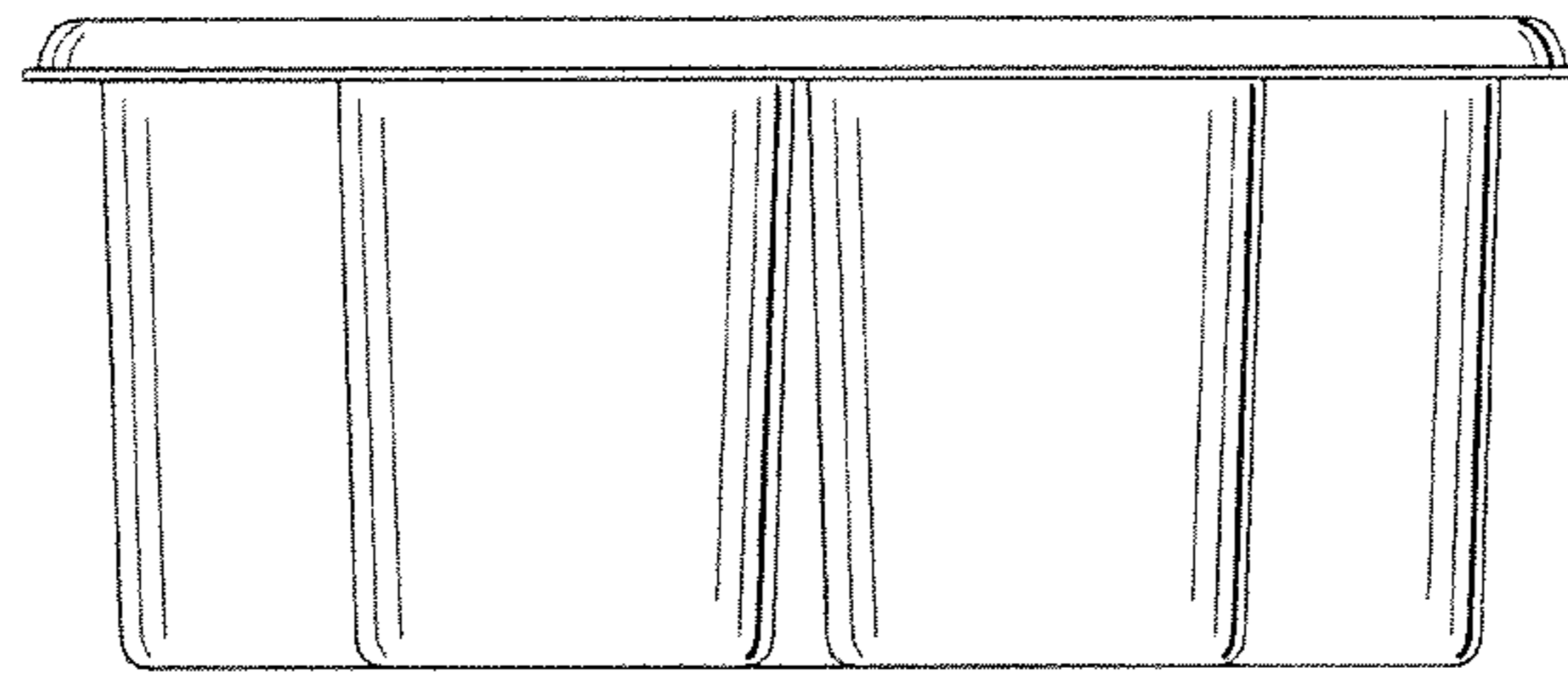

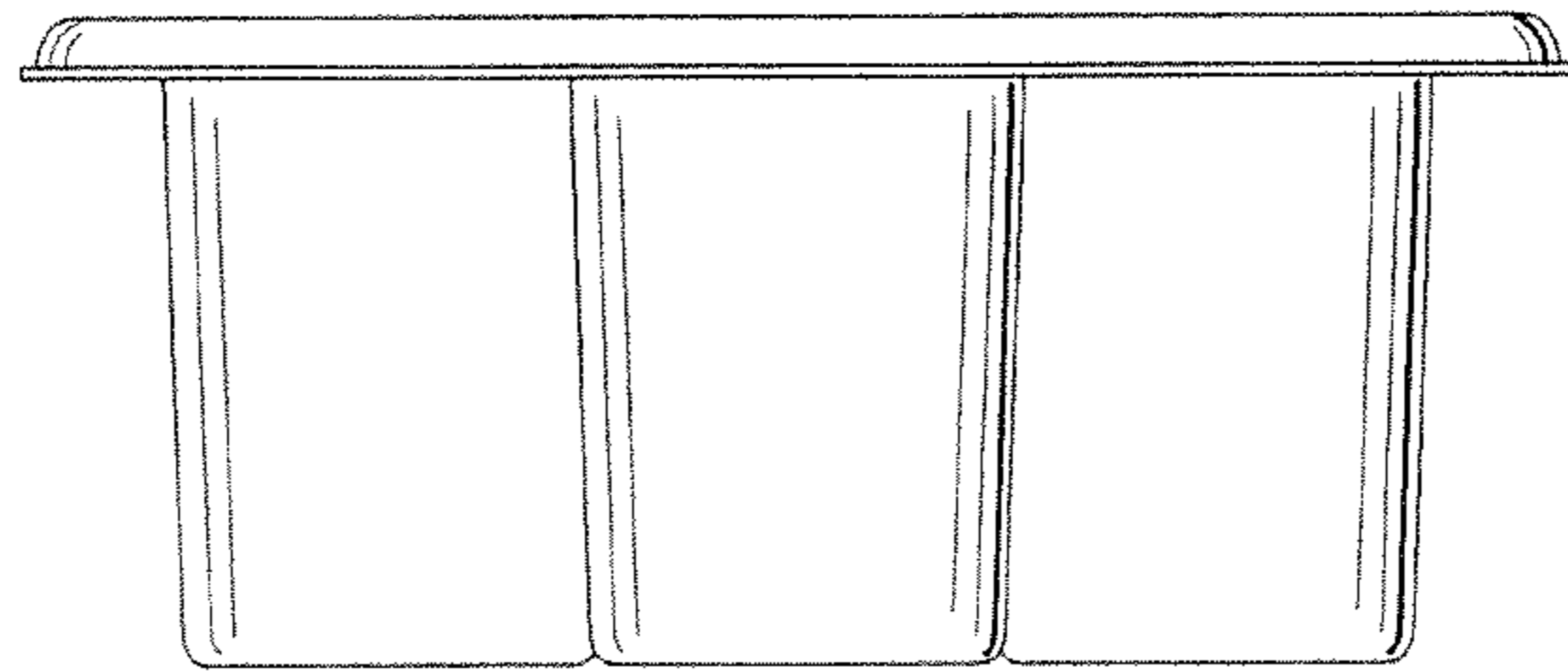

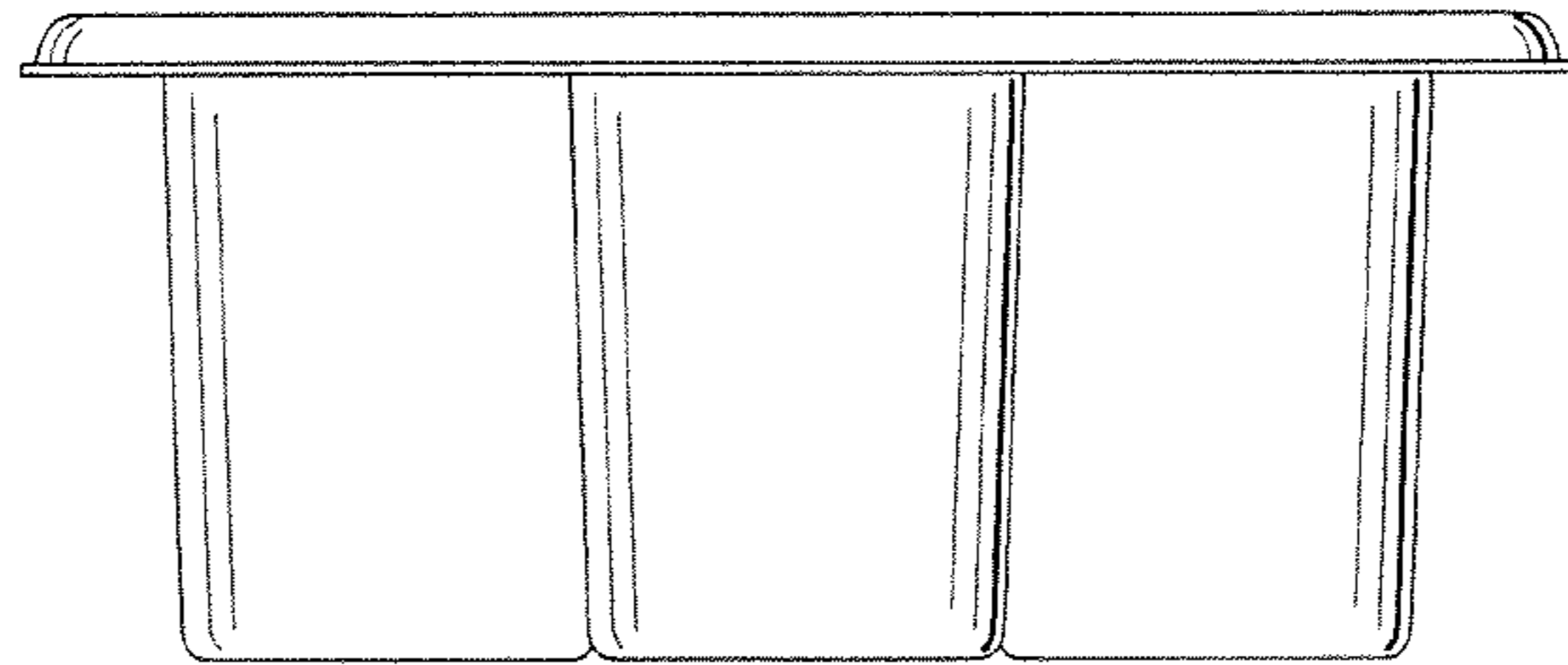

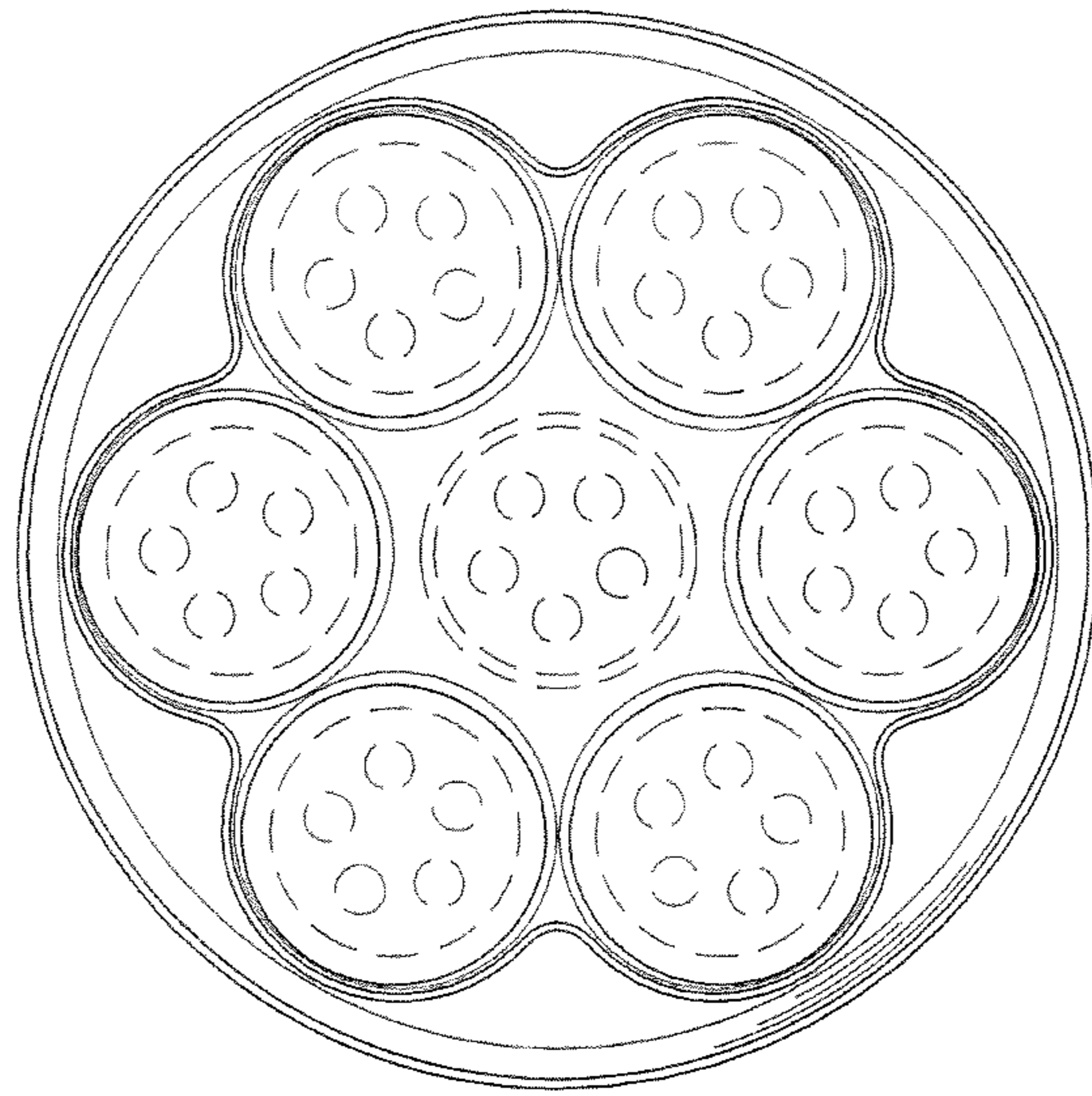

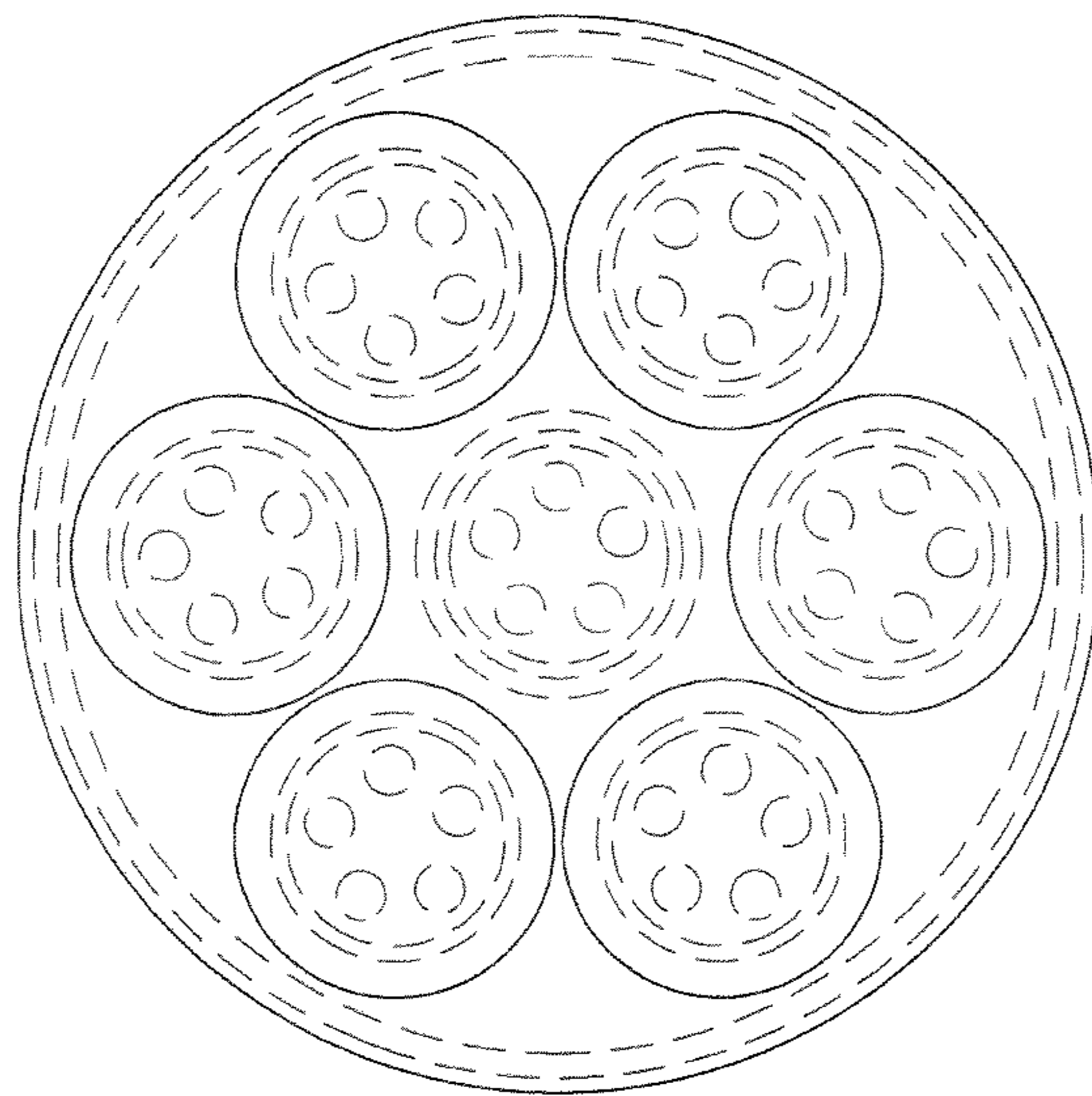
