(57) **CLAIM**

The ornamental design for a foot basin for a spa chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a foot basin for a spa chair constructed in accordance with the invention;  
 FIG. 2 is a front view of the foot basin for a spa chair shown in FIG. 1, the rear view being identical thereto;  
 FIG. 3 is a right side elevational view of the foot basin for a spa chair shown in FIG. 1, the left side being a mirror image thereof; and,  
 FIG. 4 is a top view of the foot basin for a spa chair shown in FIG. 1.

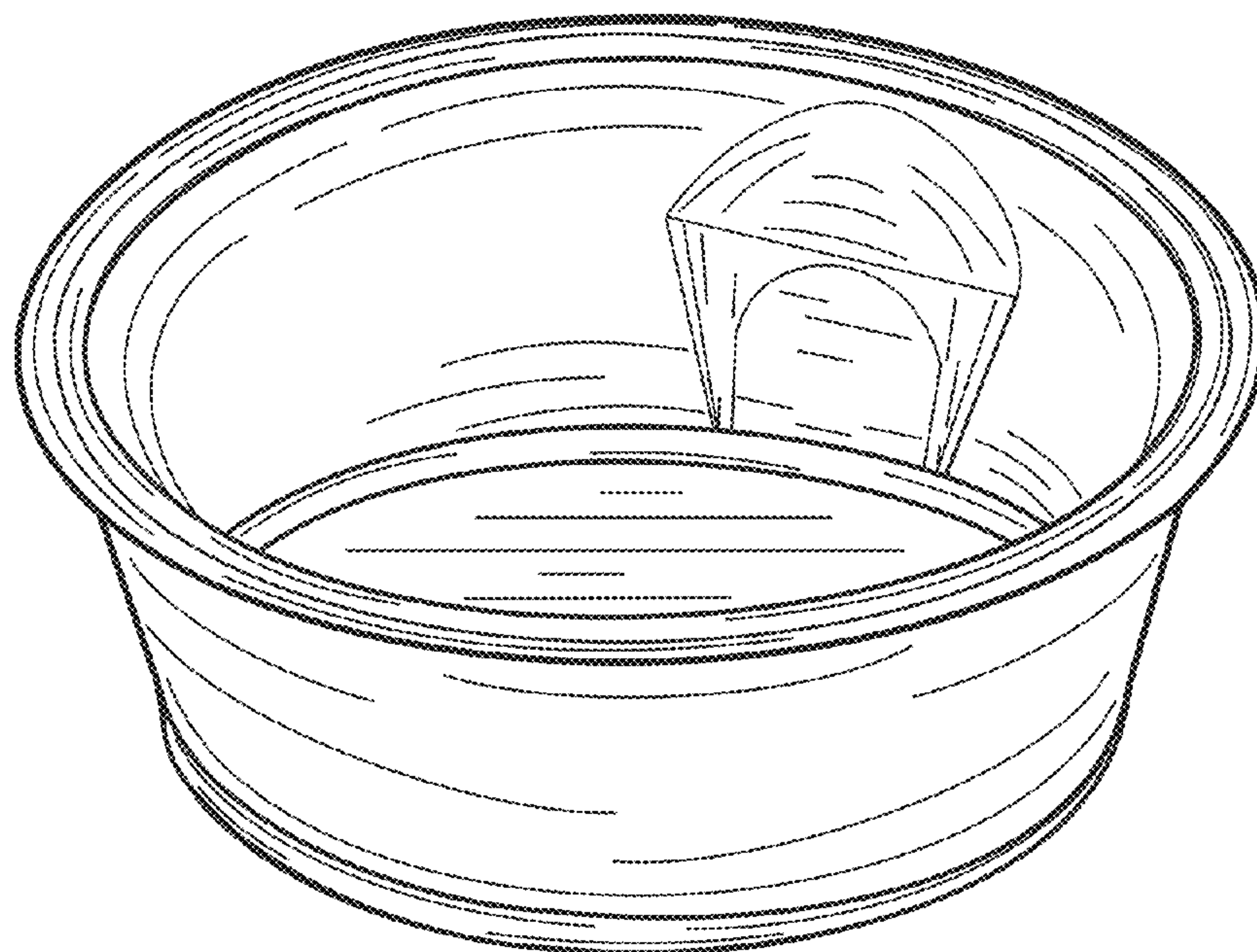

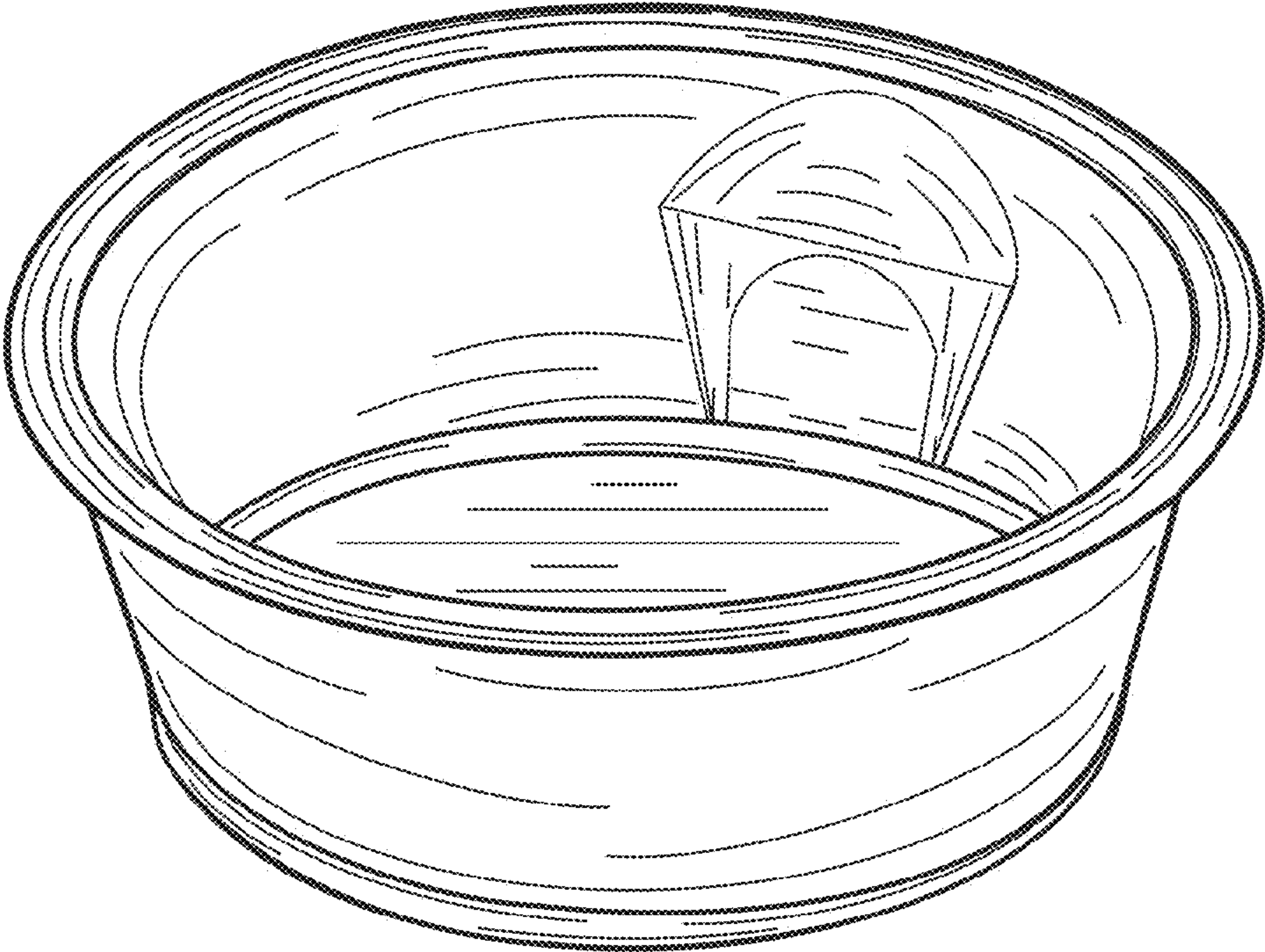

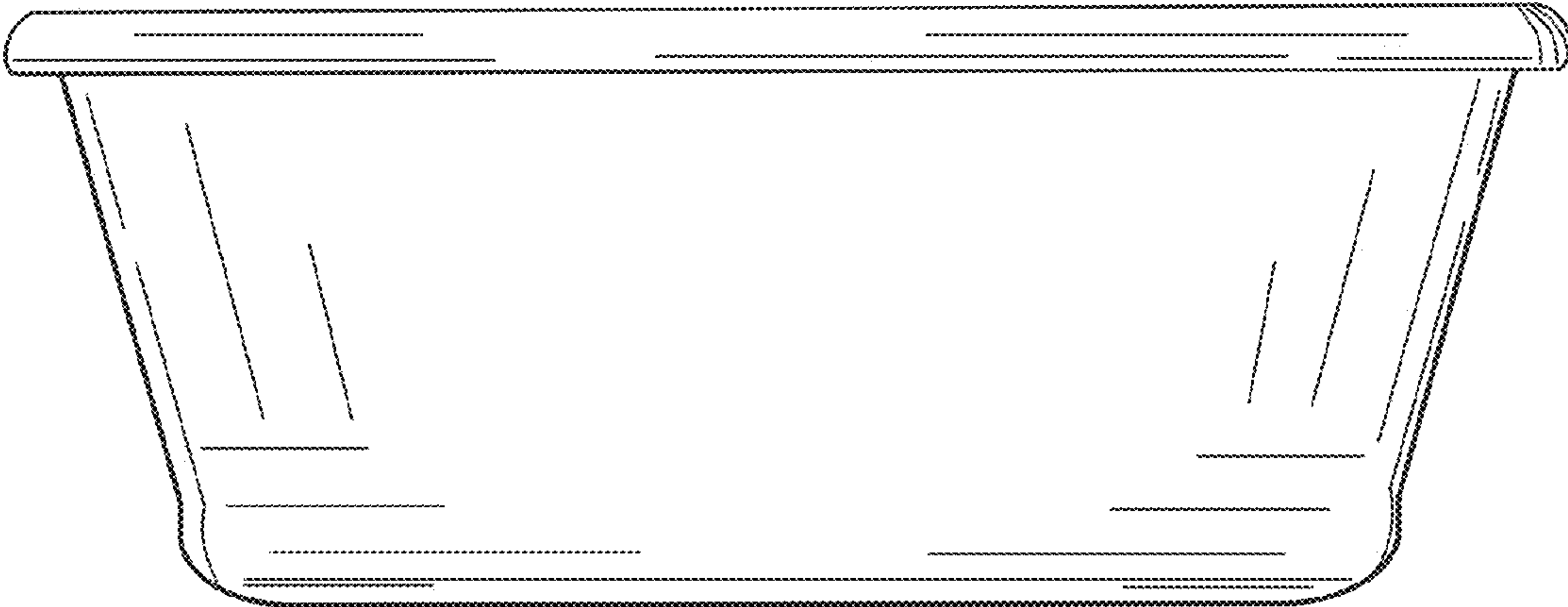

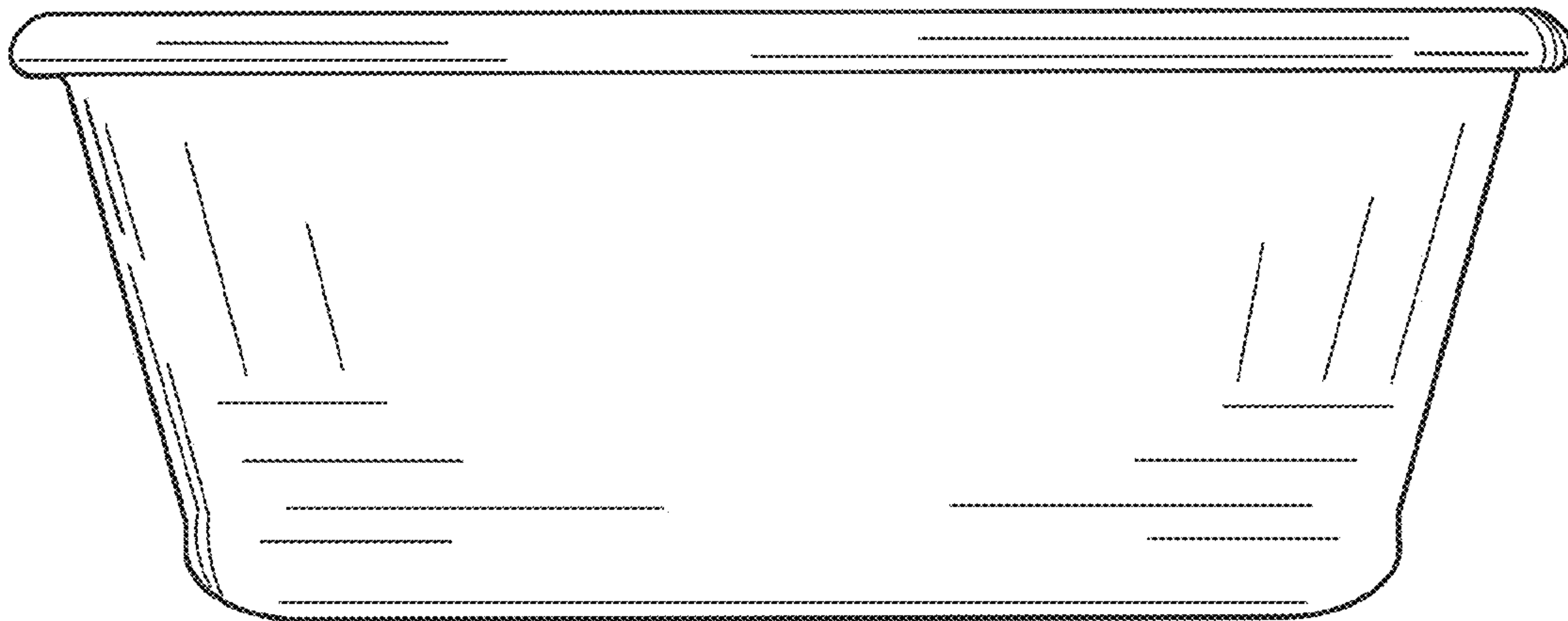

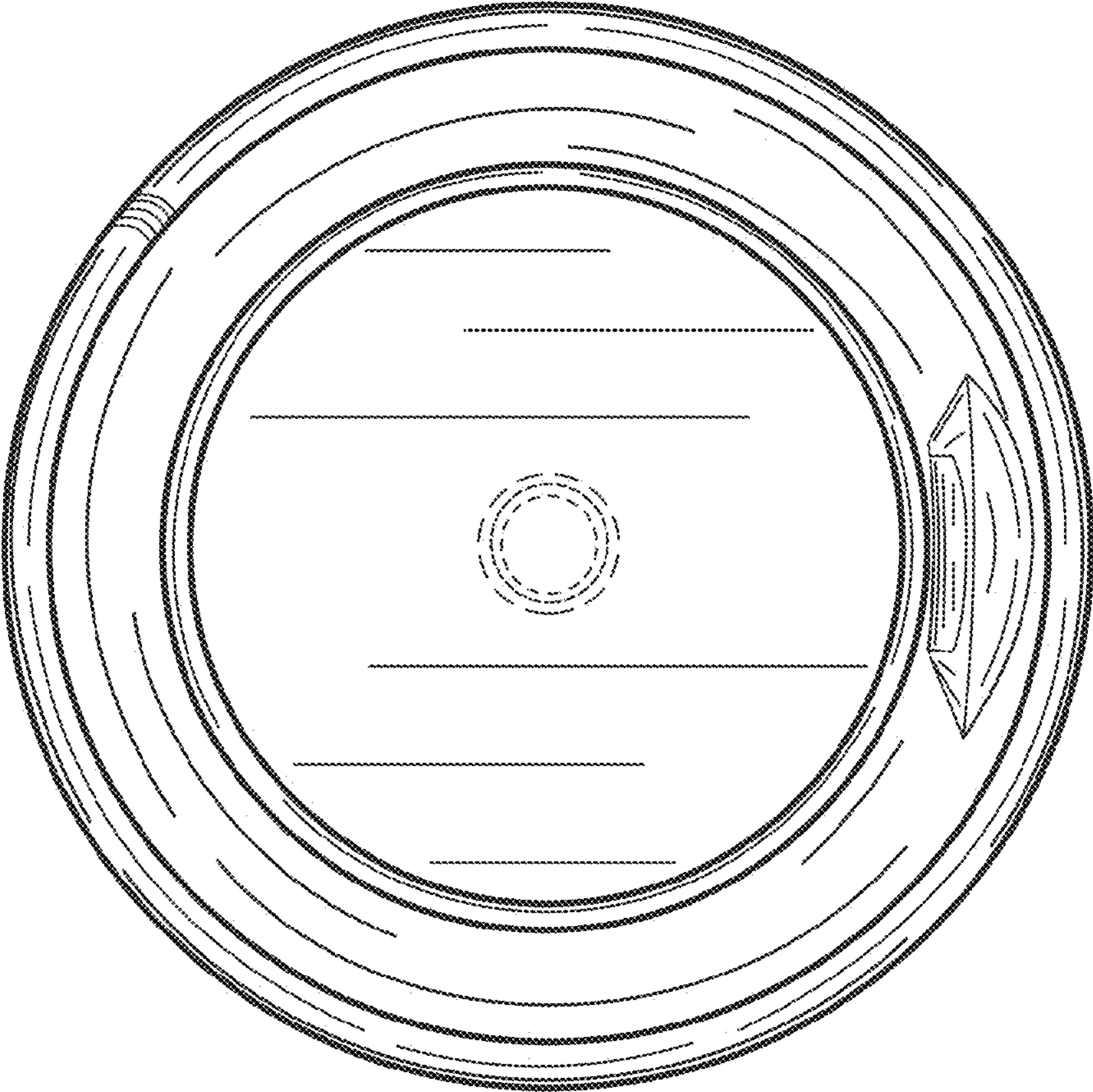
