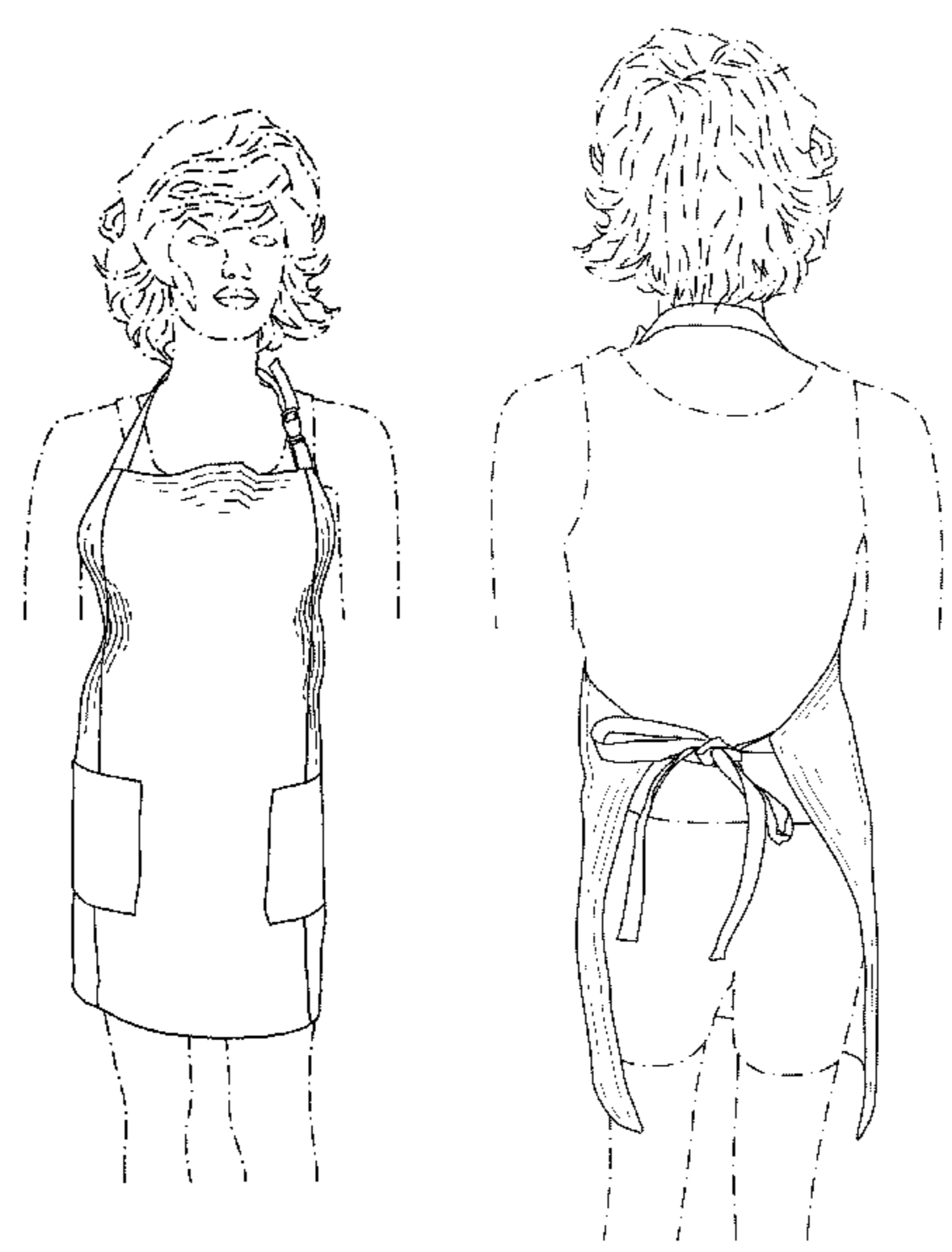

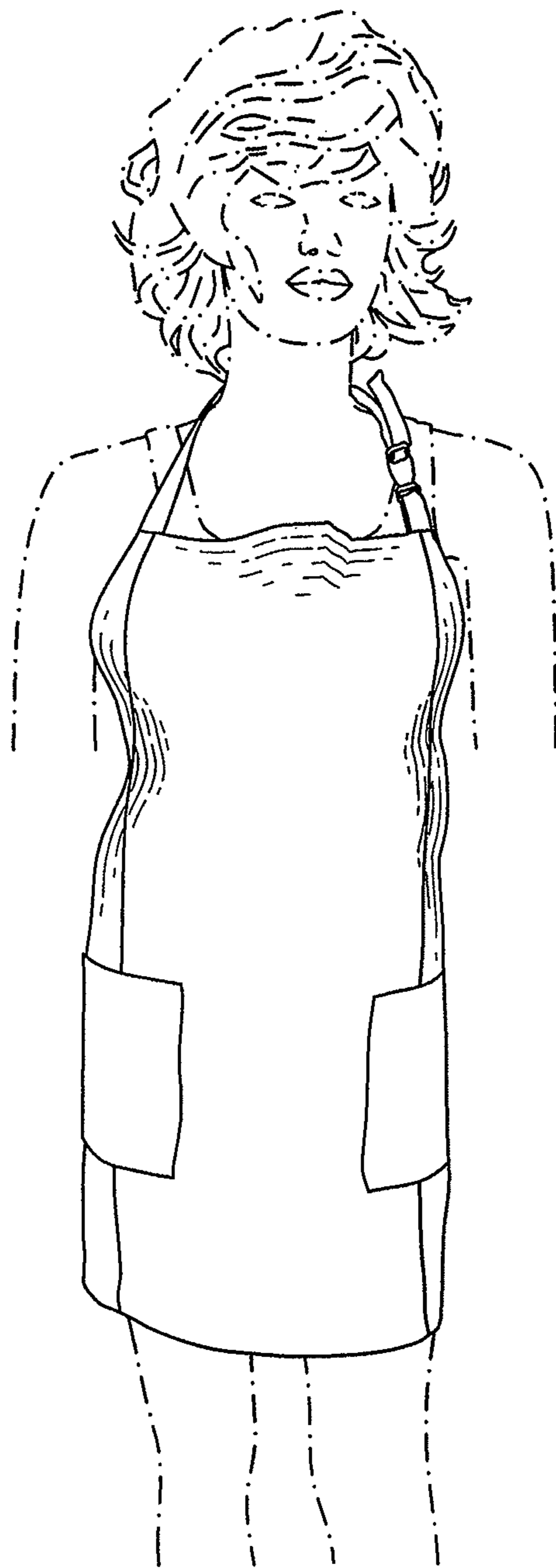
(57) **CLAIM**

**DESCRIPTION**

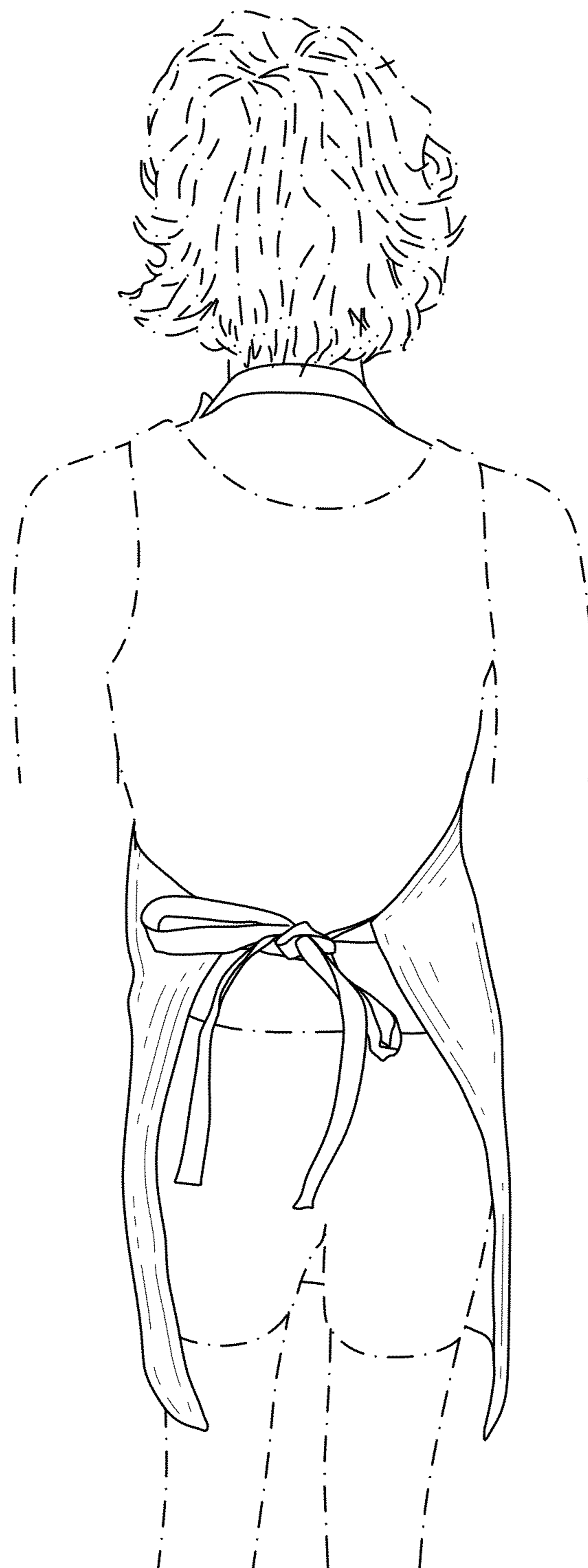
FIG. 1 is a front elevation view of an apron showing the new design;

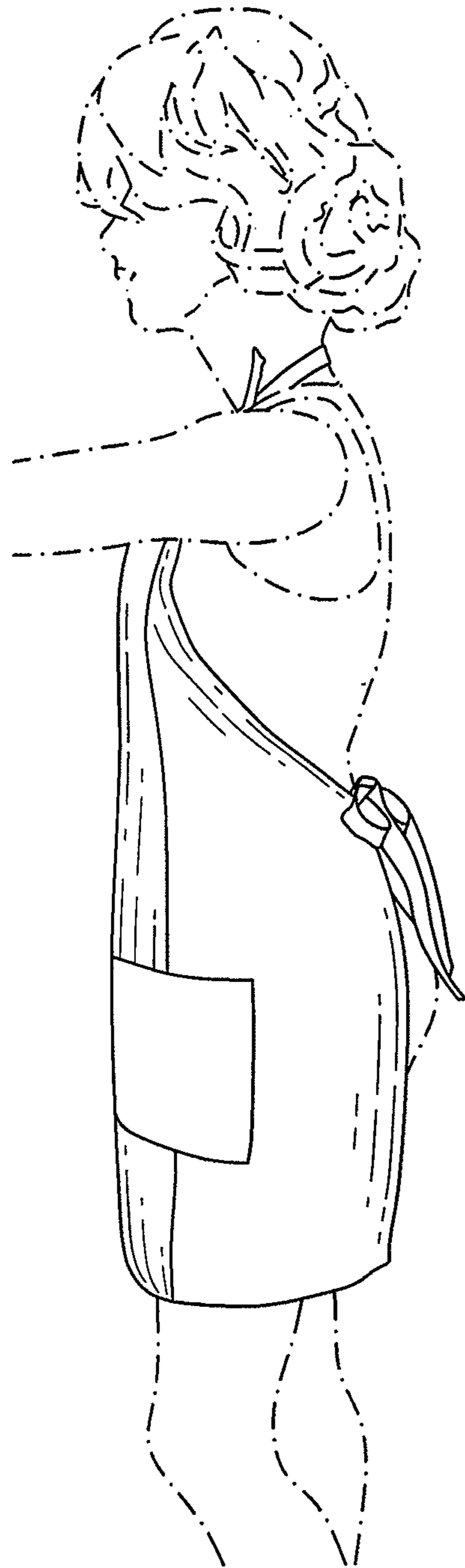




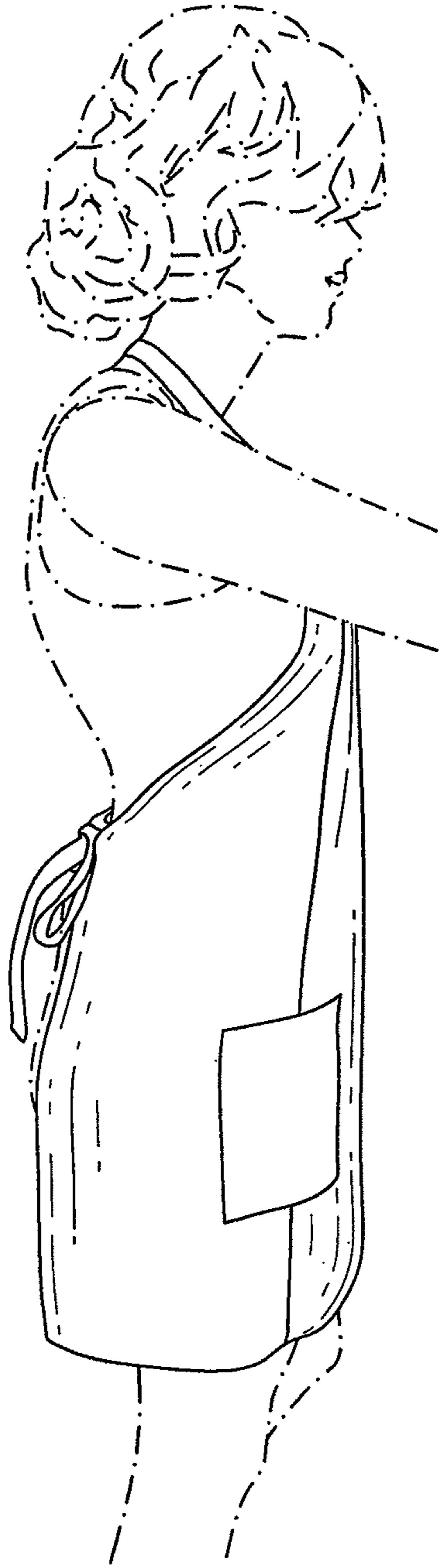
