(57) **CLAIM**

The ornamental design for an elongated aquatic cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of an elongated aquatic cap as worn by a user.

FIG. 2 is a top plan view thereof.

FIG. 3 is a left side elevation view thereof.

FIG. 4 is a right side elevation view thereof.

FIG. 5 is a rear elevation view thereof.

FIG. 11 is a right side elevation view thereof.

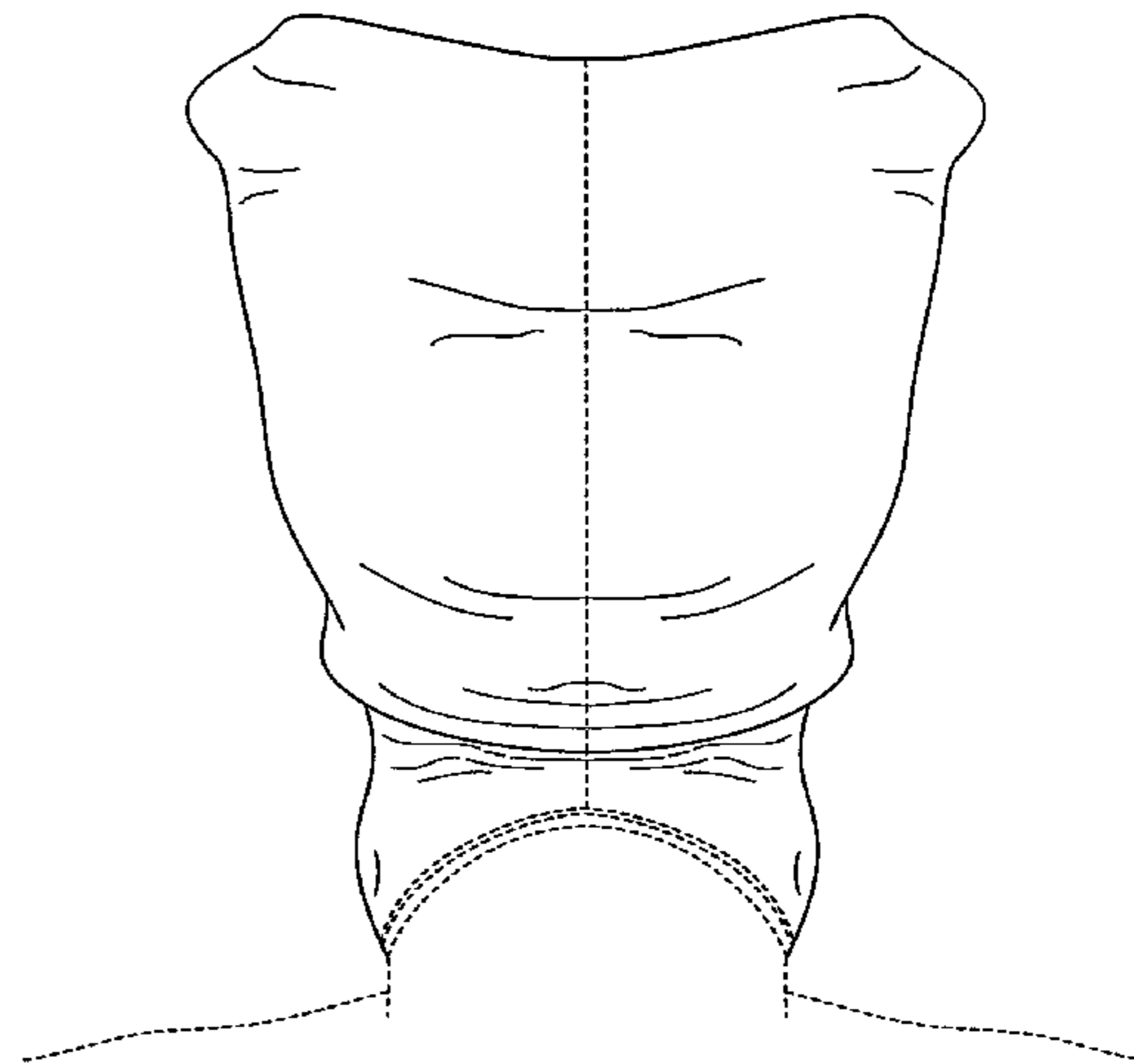
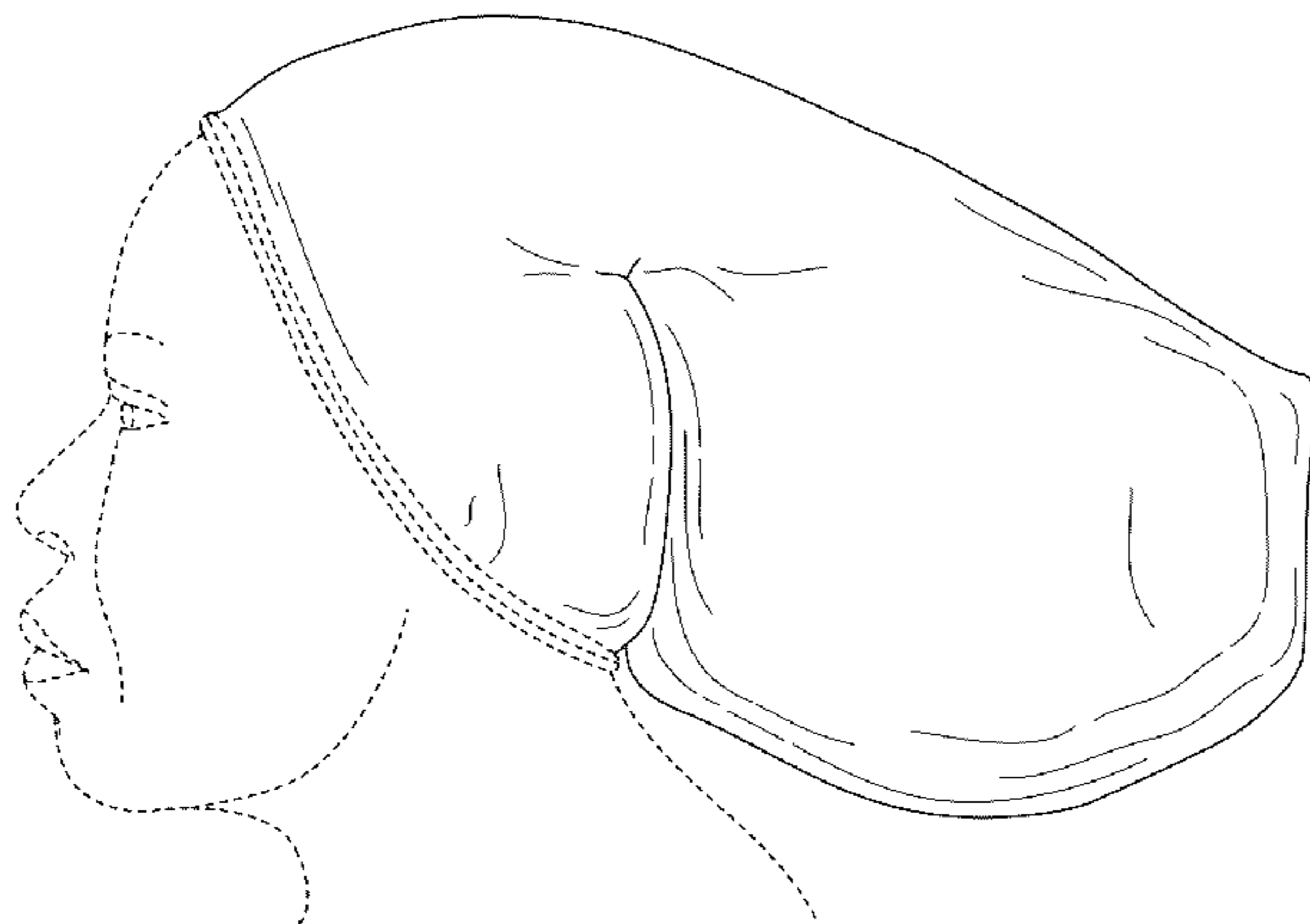
FIG. 12 is a left side elevation view thereof.

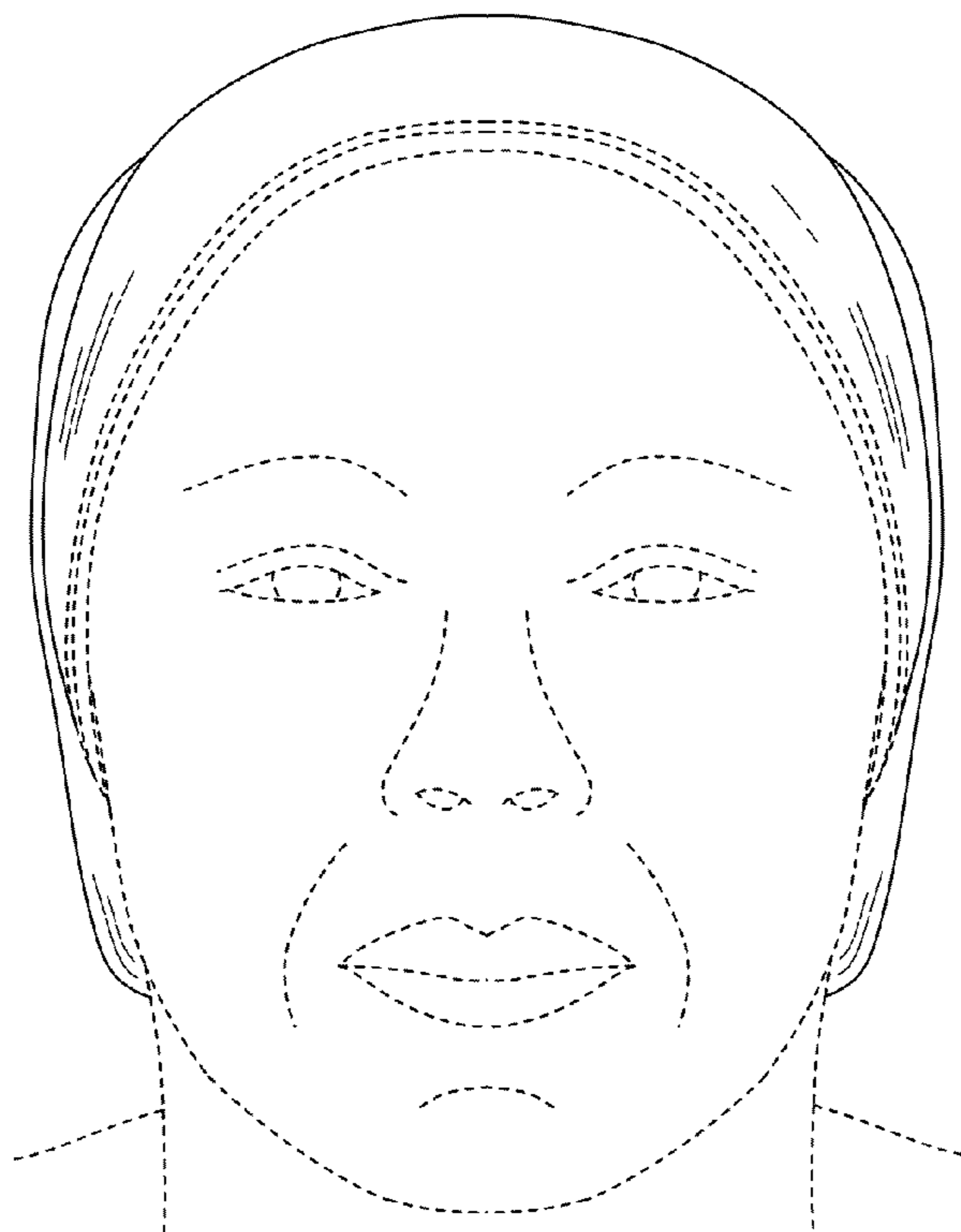
FIG. 13 is a front elevation view thereof; and,

FIG. 14 is a rear elevation view thereof.

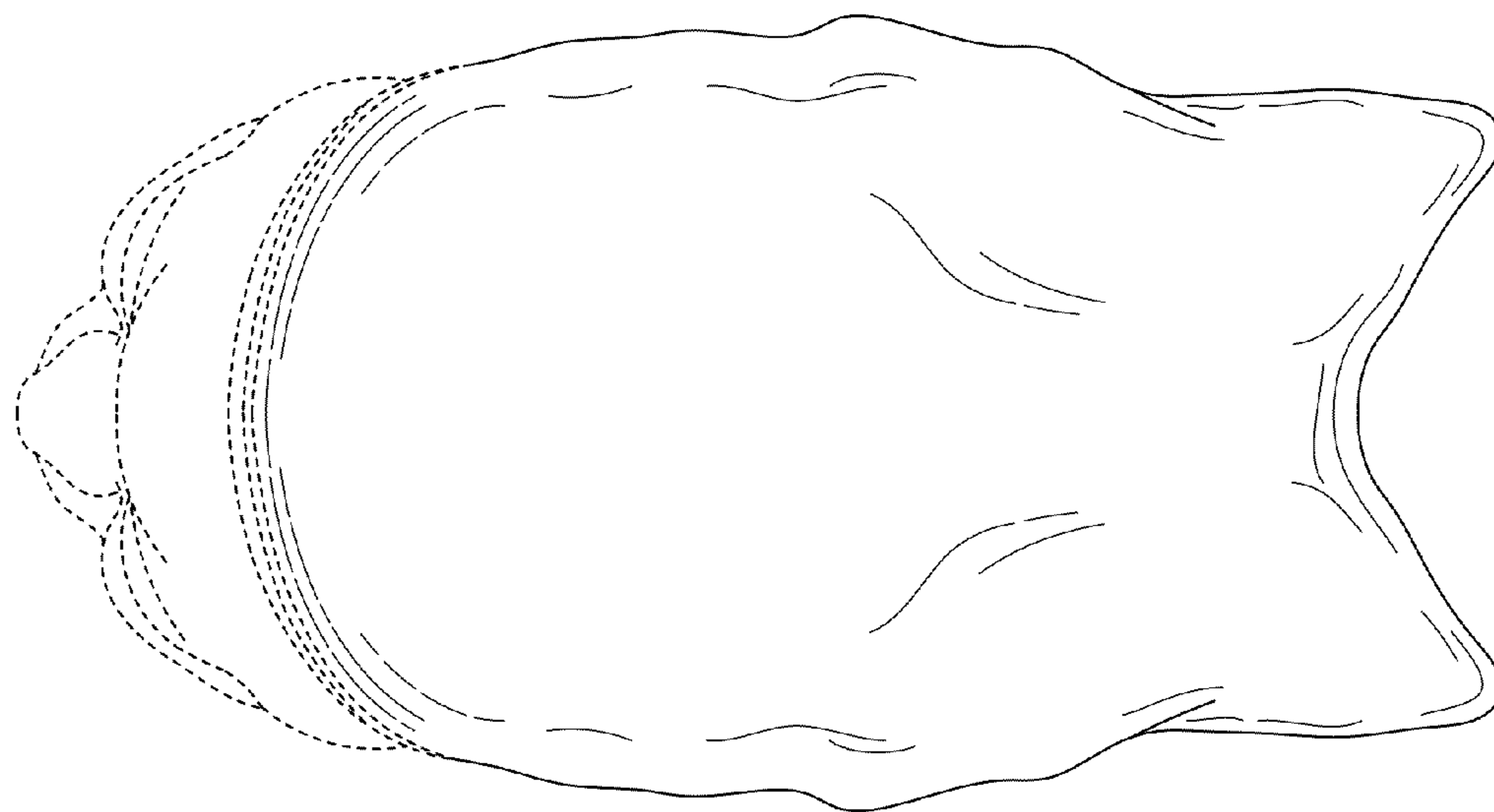

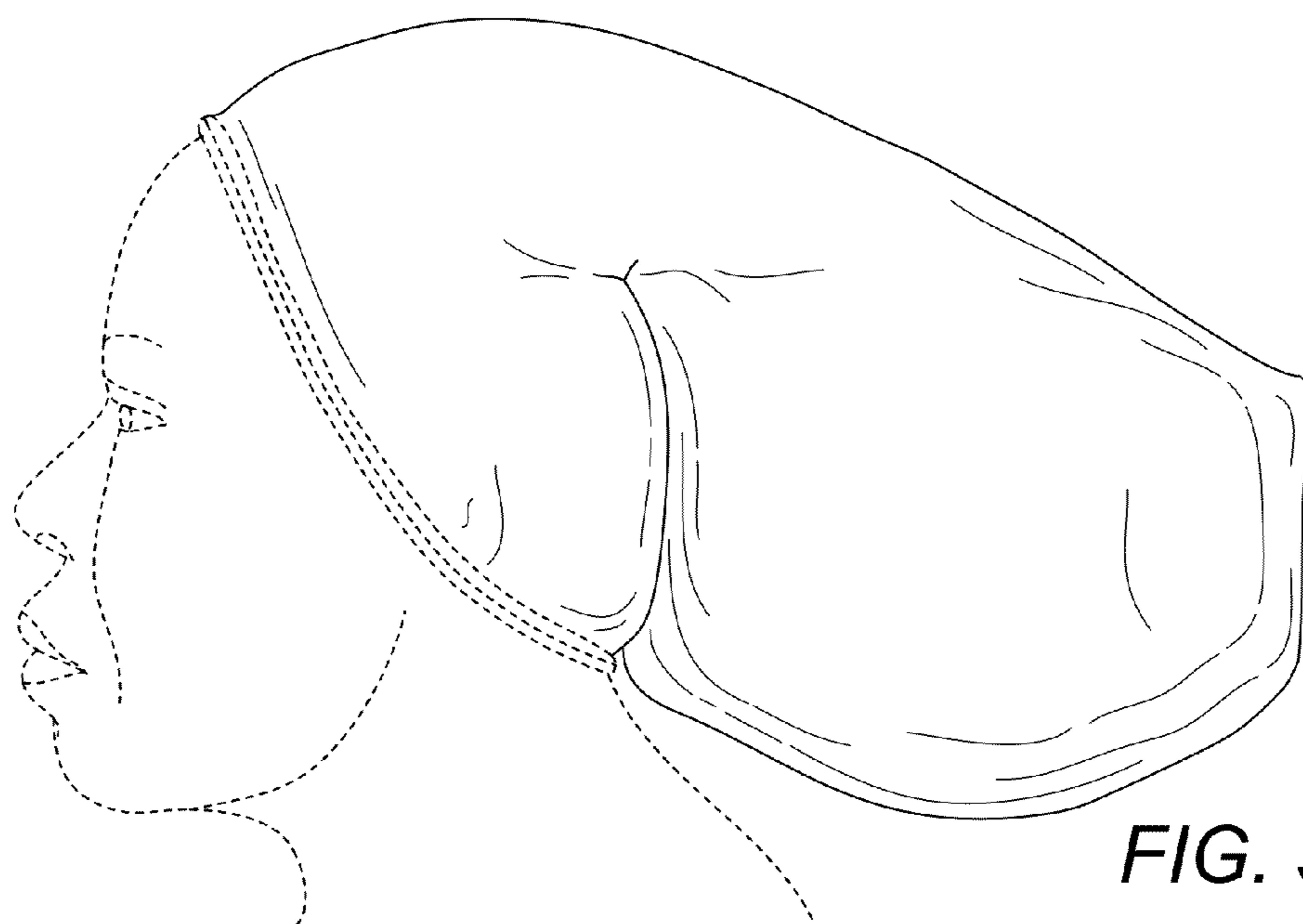




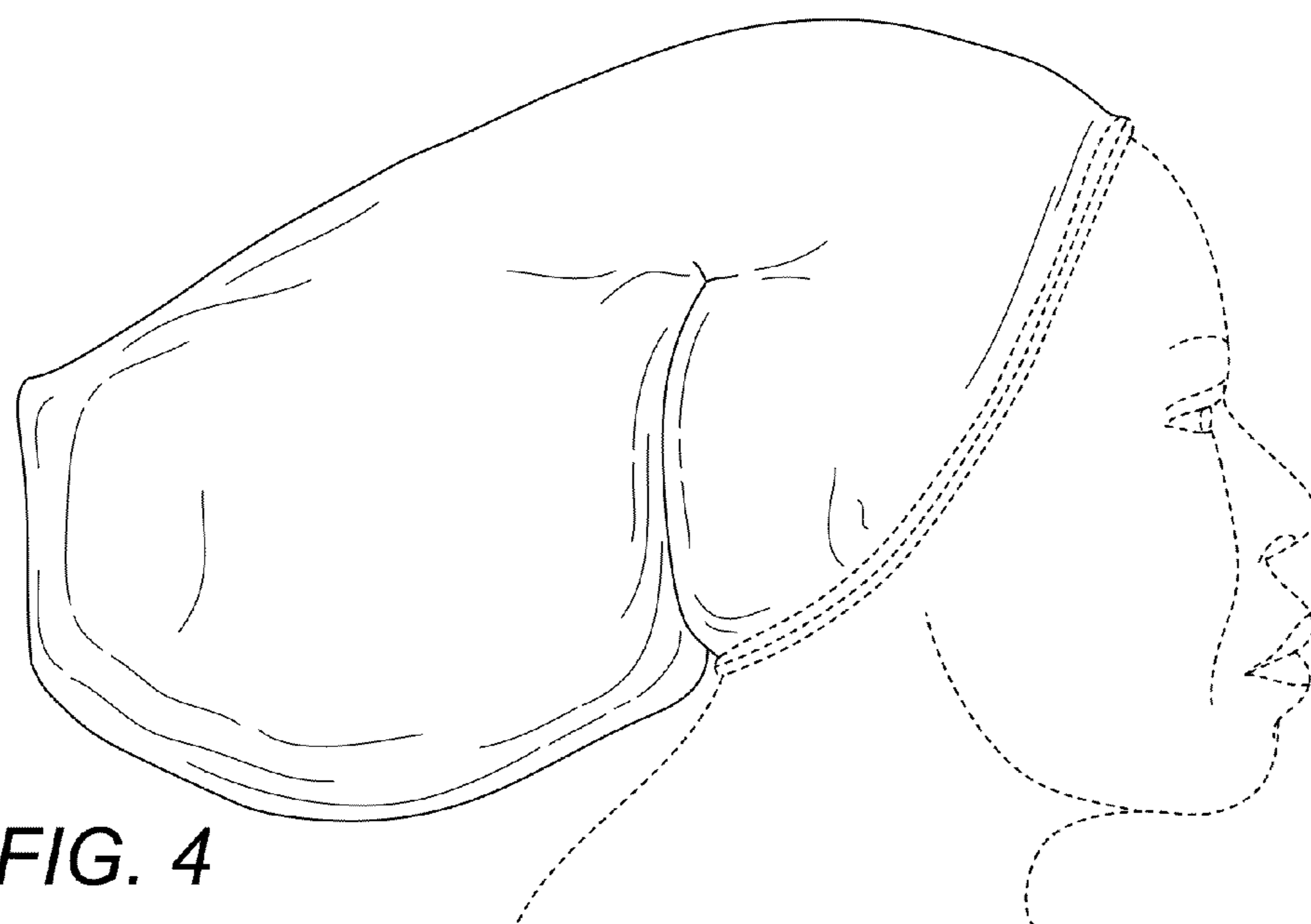

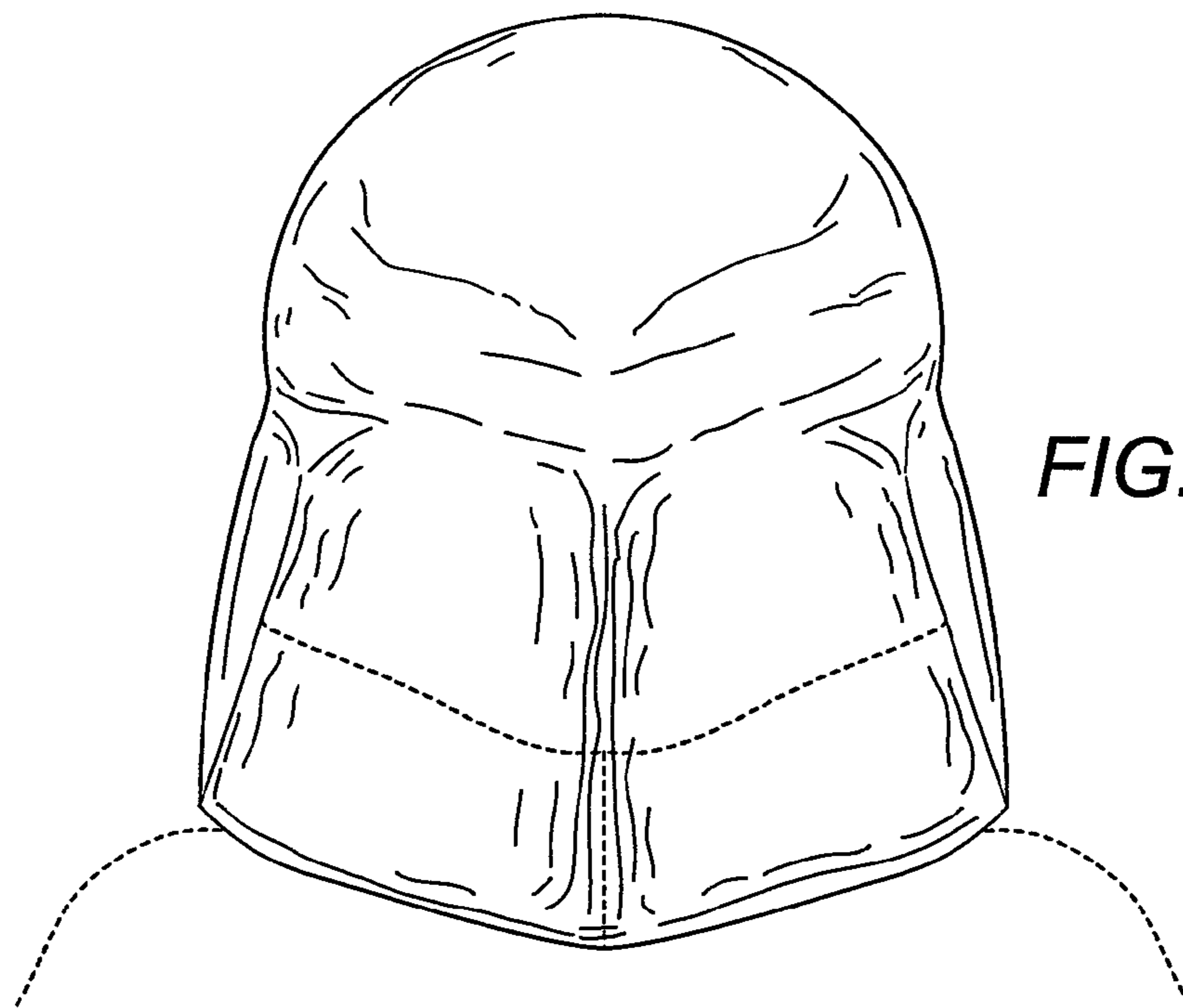

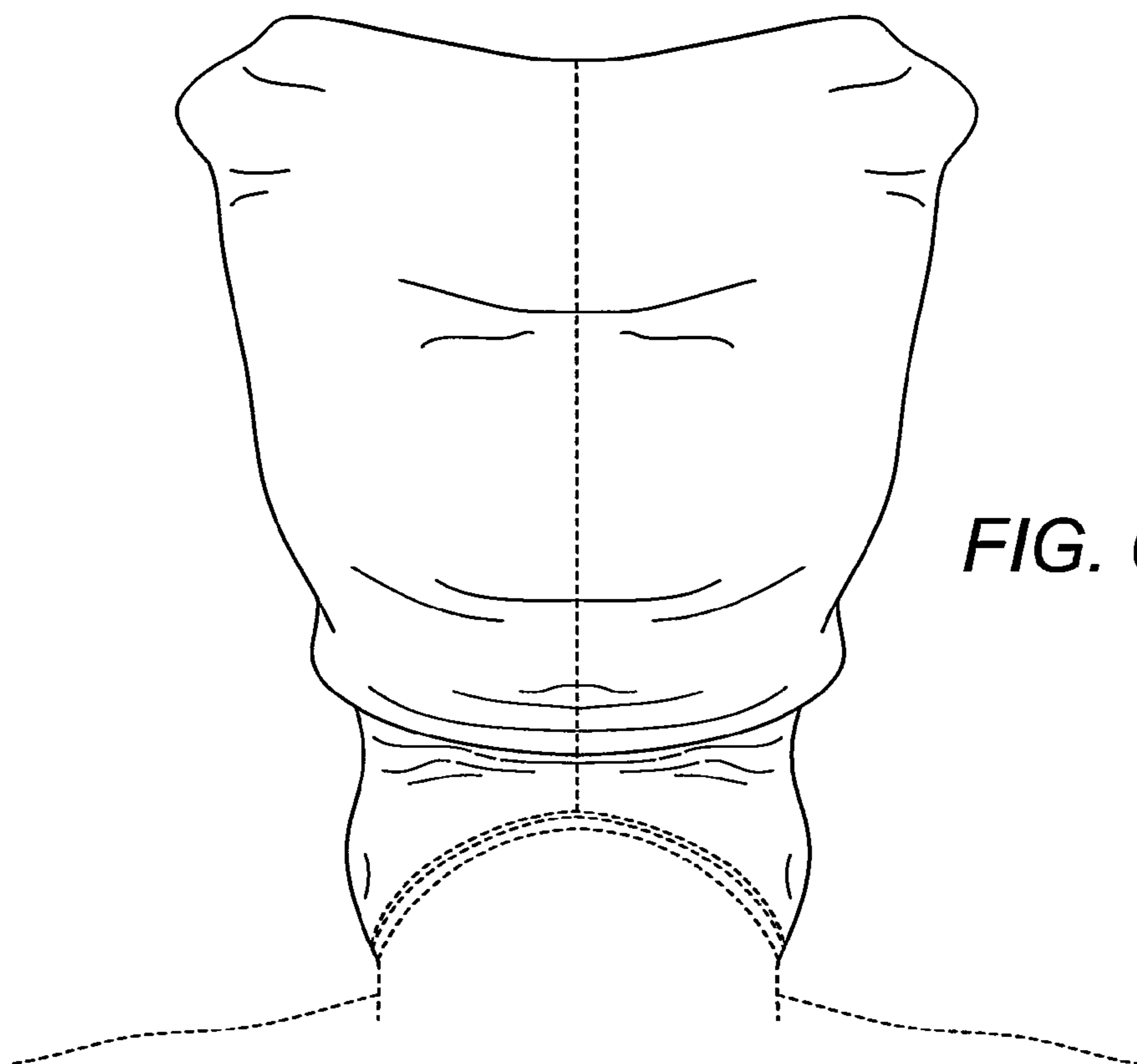

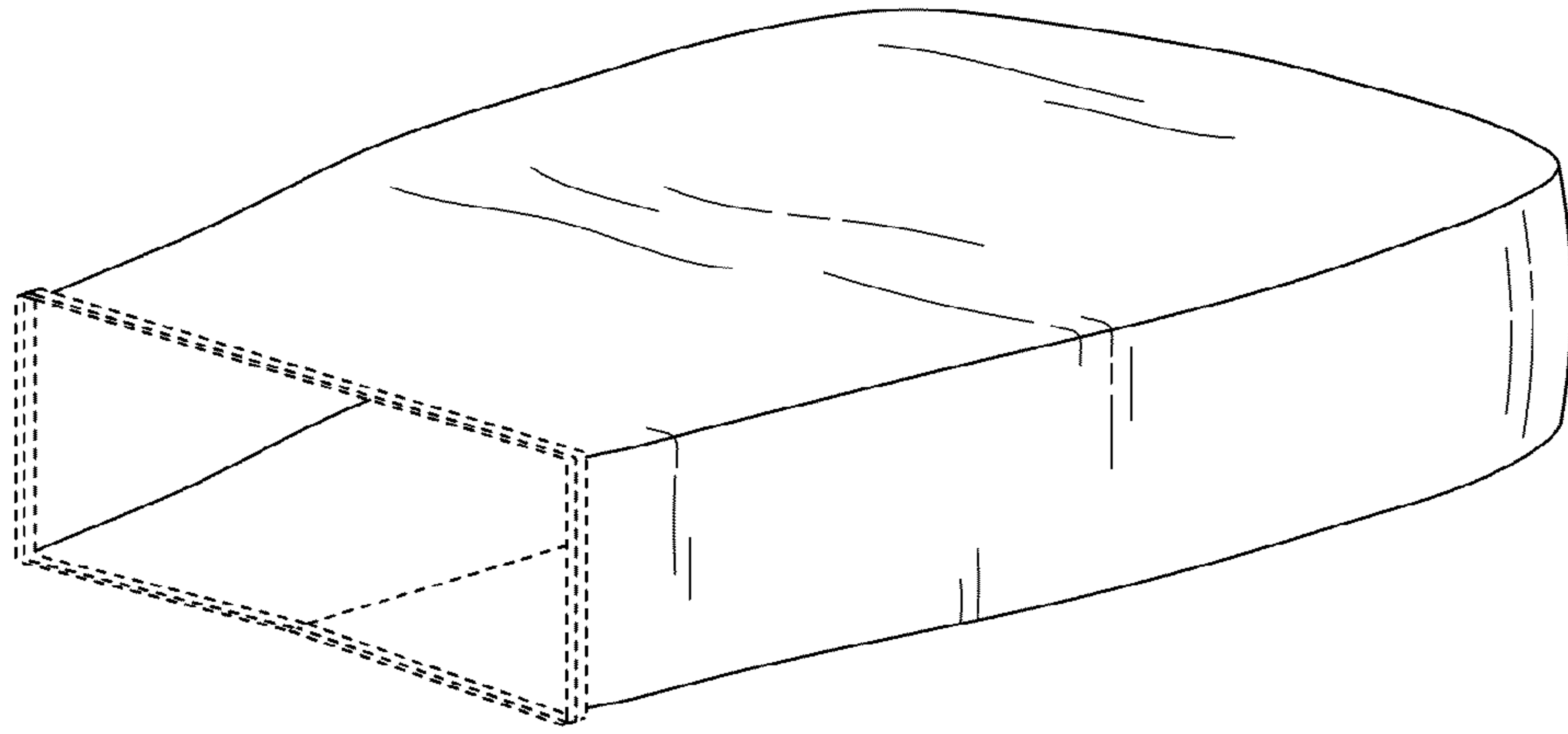

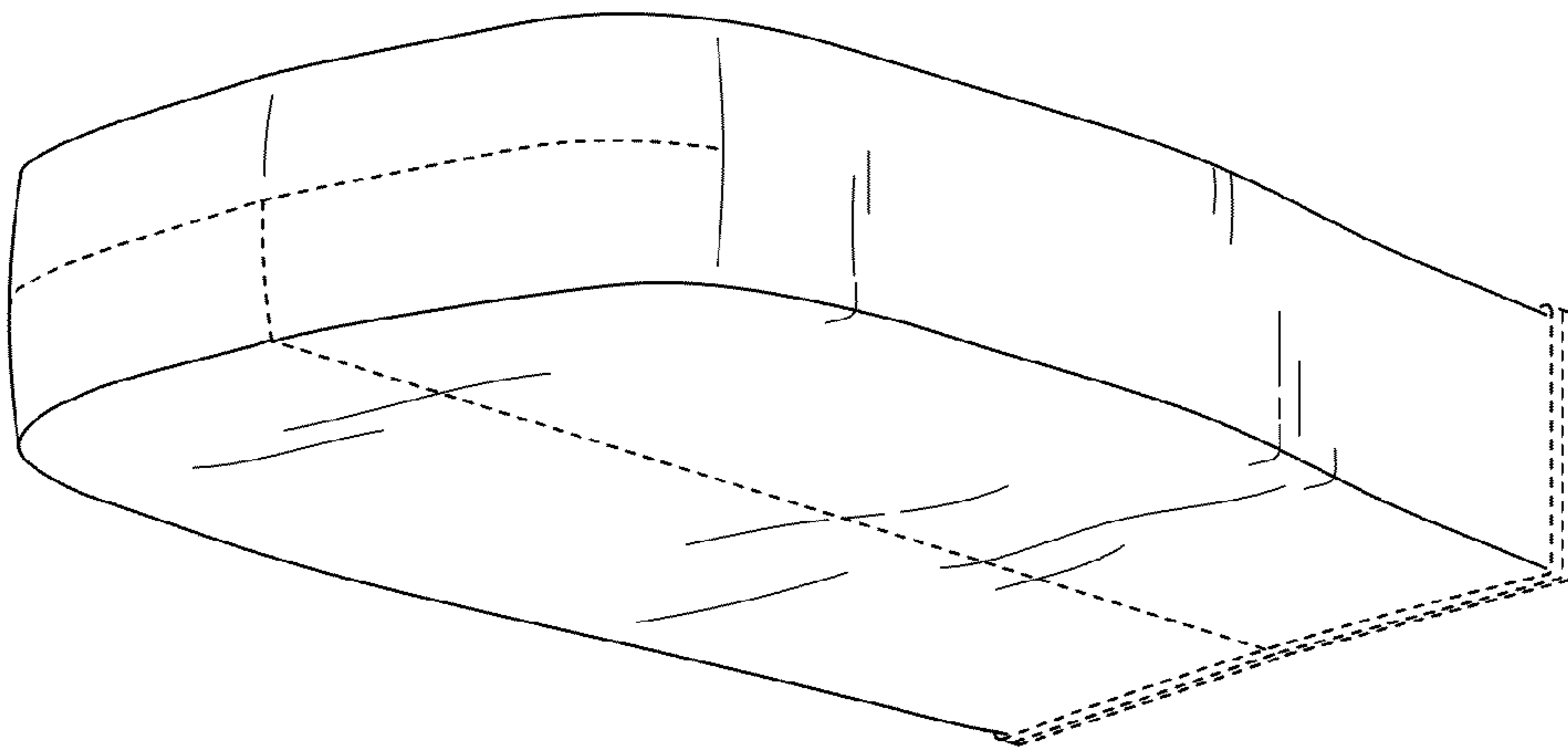

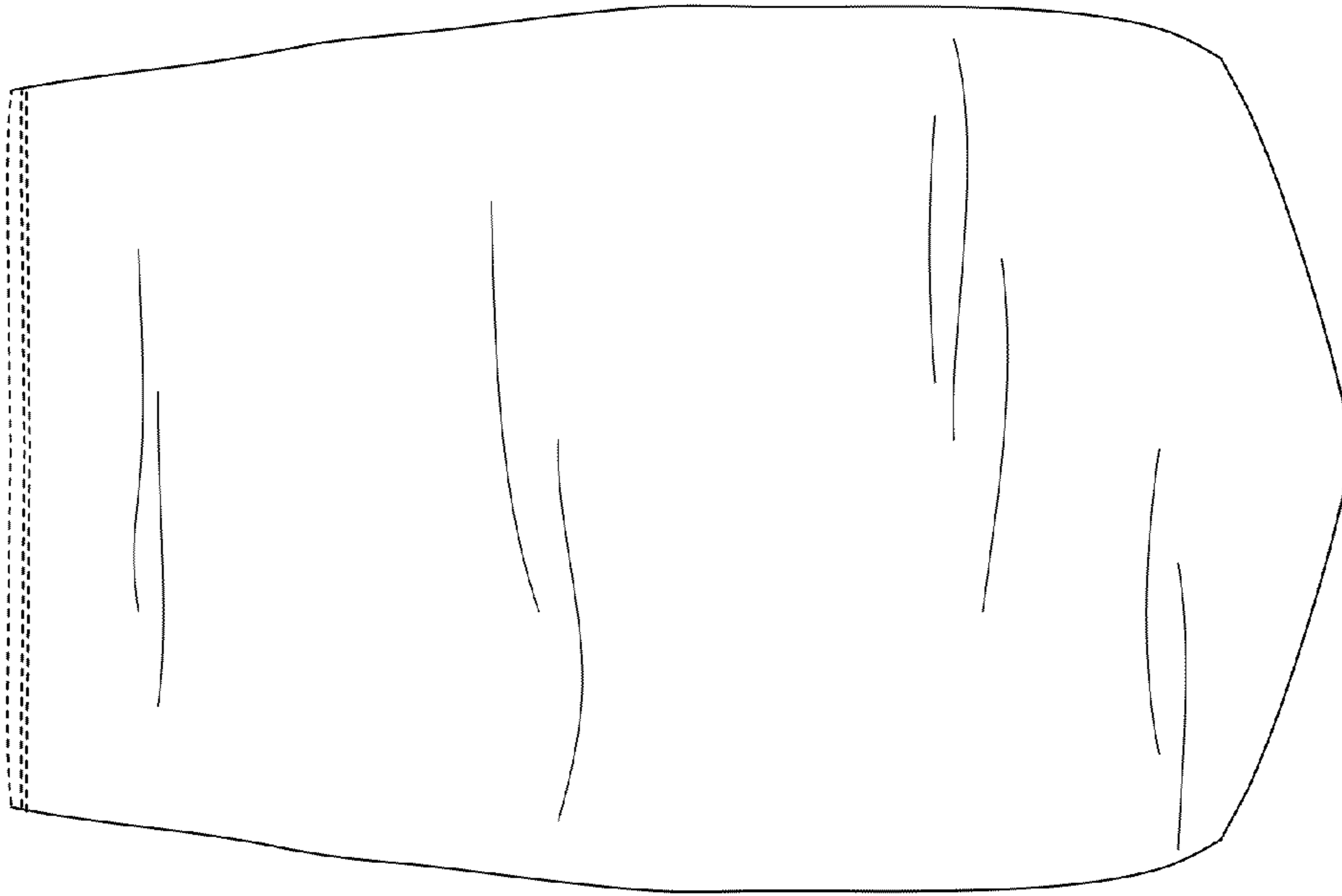

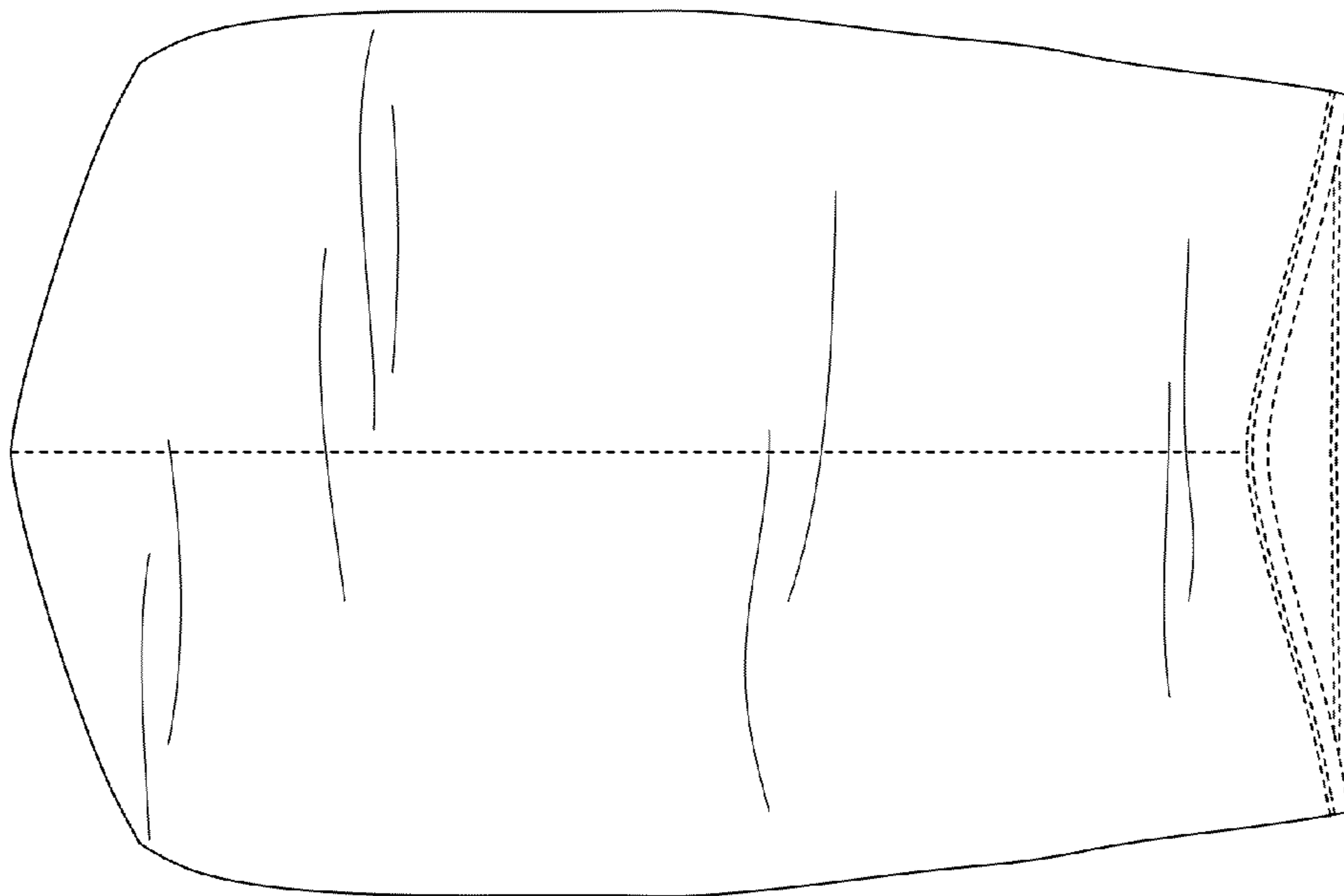

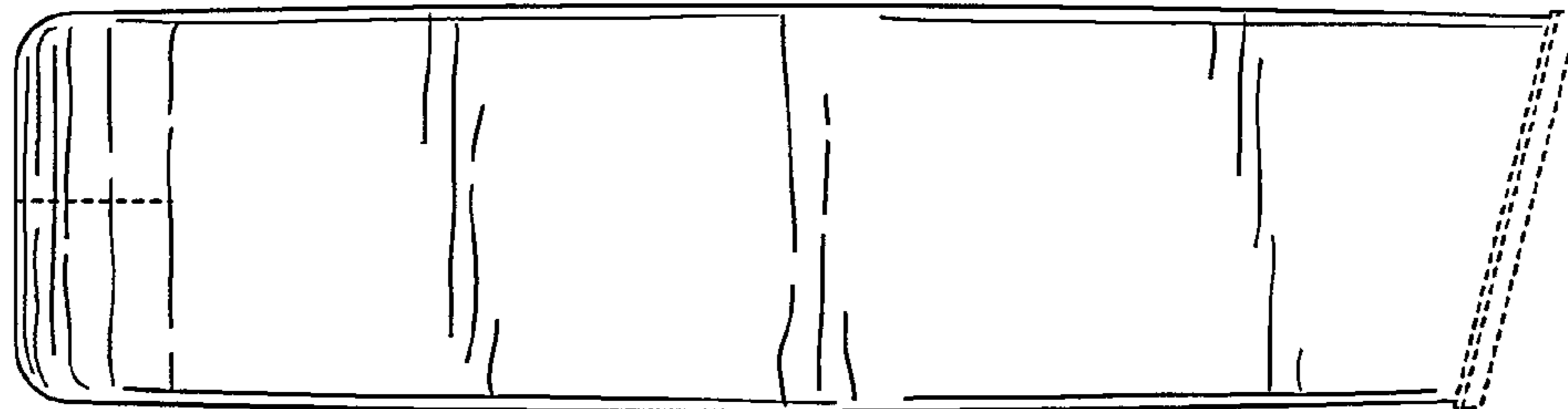

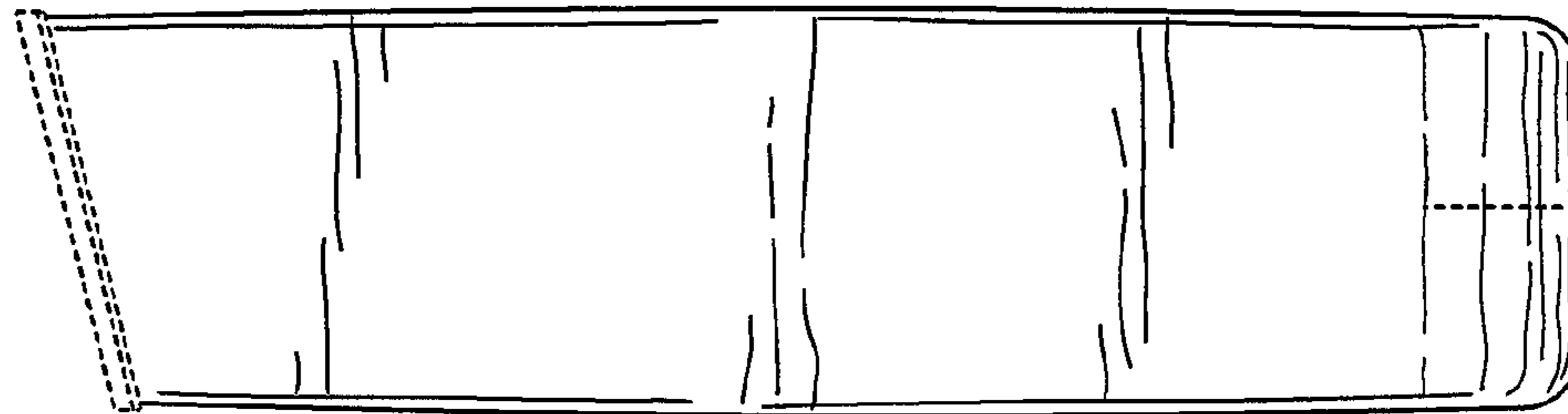

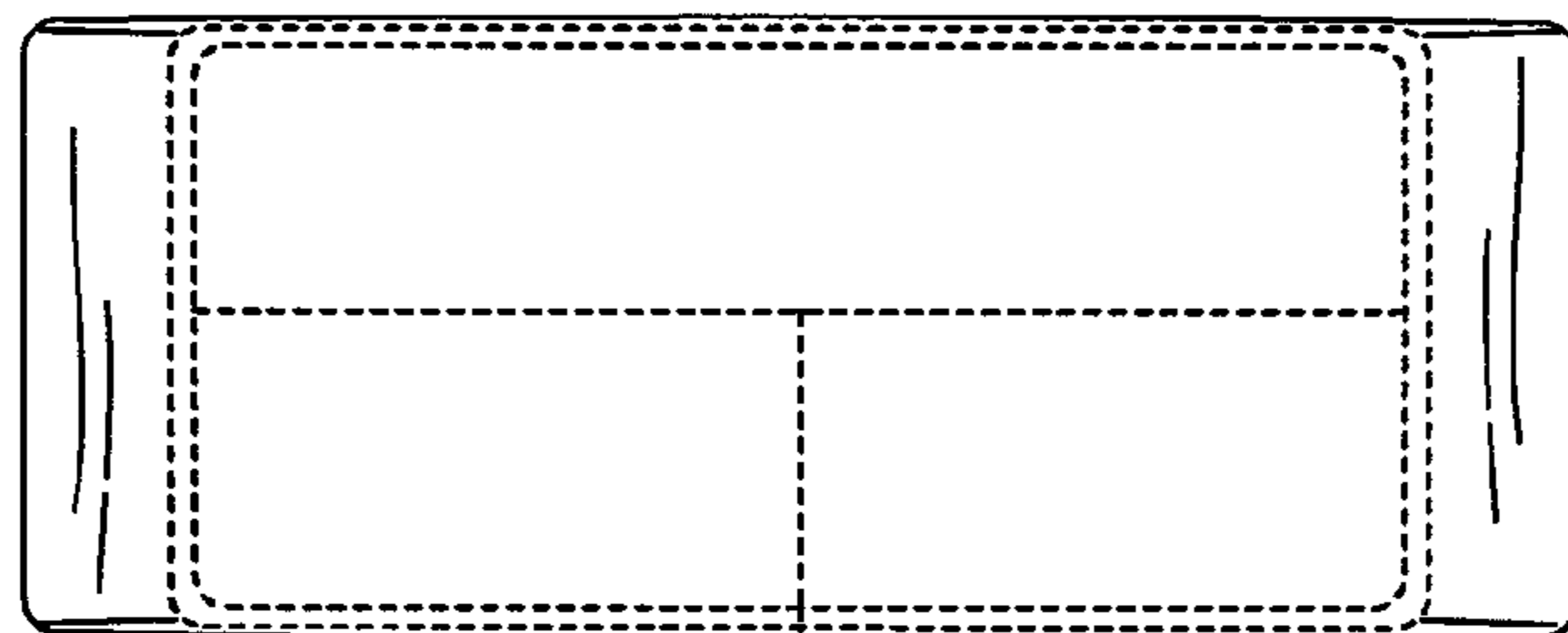

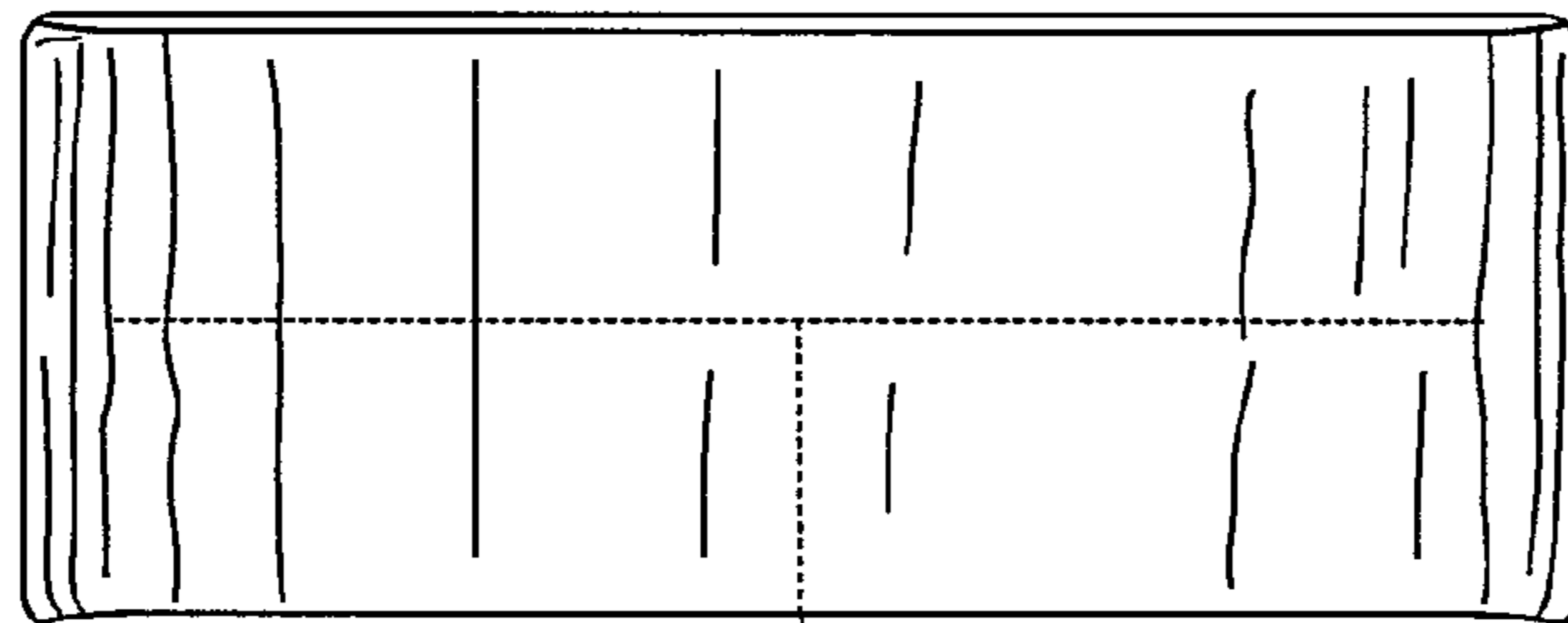
