We claim the ornamental design for an upper portion of sock, substantially as shown and described.

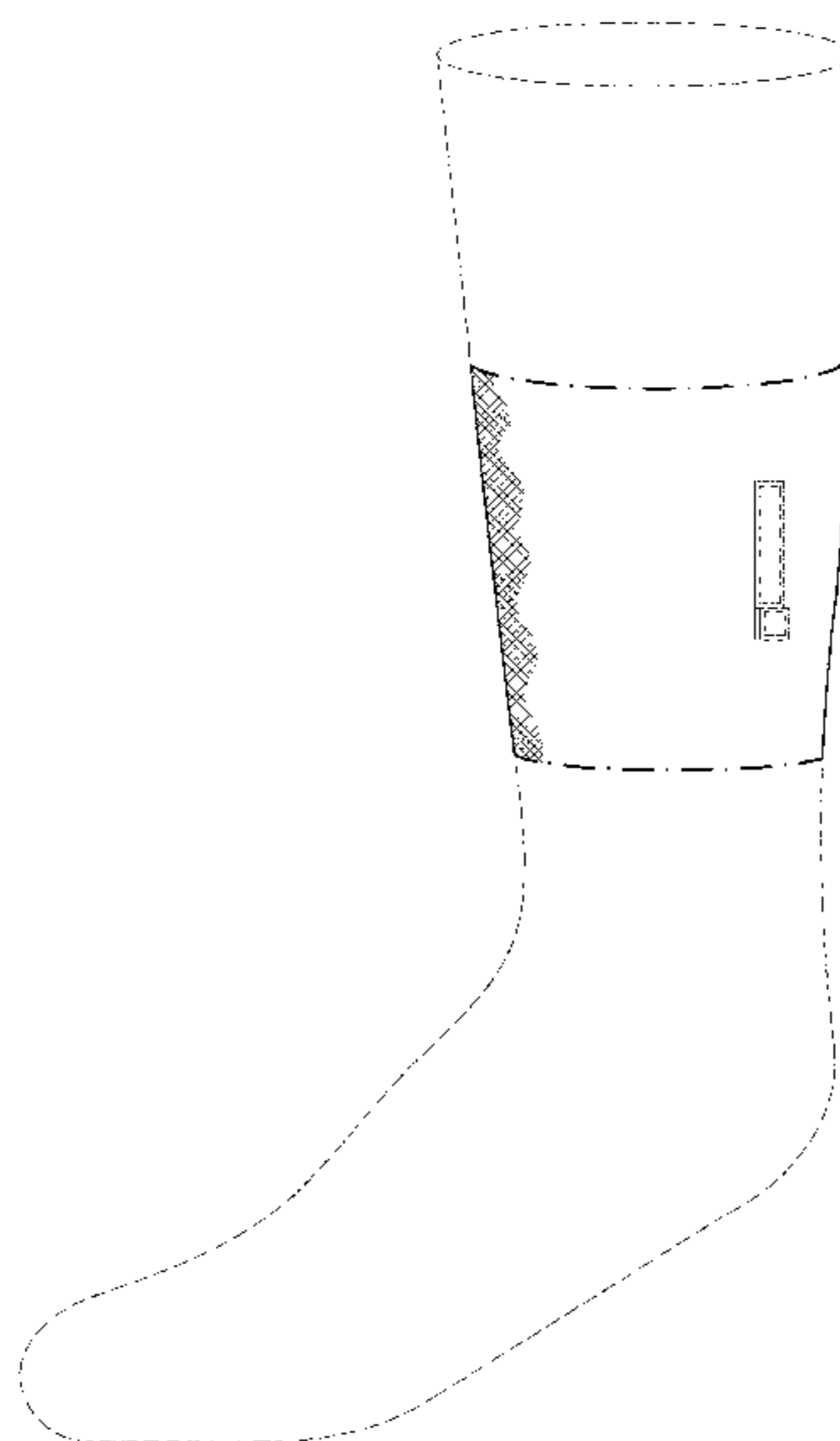
**DESCRIPTION**

FIG. 1 is a side perspective view of an upper portion of sock showing our new design;  
 FIG. 2 is an elevational view of the right side thereof;  
 FIG. 3 is an elevational view of the left side thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a side perspective view of an upper portion of sock in a different position of use;  
 FIG. 9 is an elevational view of the left side thereof;  
 FIG. 10 is an elevational view of the right side thereof;  
 FIG. 11 is a front elevational view thereof;  
 FIG. 12 is a rear elevational view thereof;  
 FIG. 13 is a top plan view thereof; and,  
 FIG. 14 is a bottom plan view thereof.

The dot-dash-dot-dash type broken lines shown in the drawings define the boundaries of the claimed design.

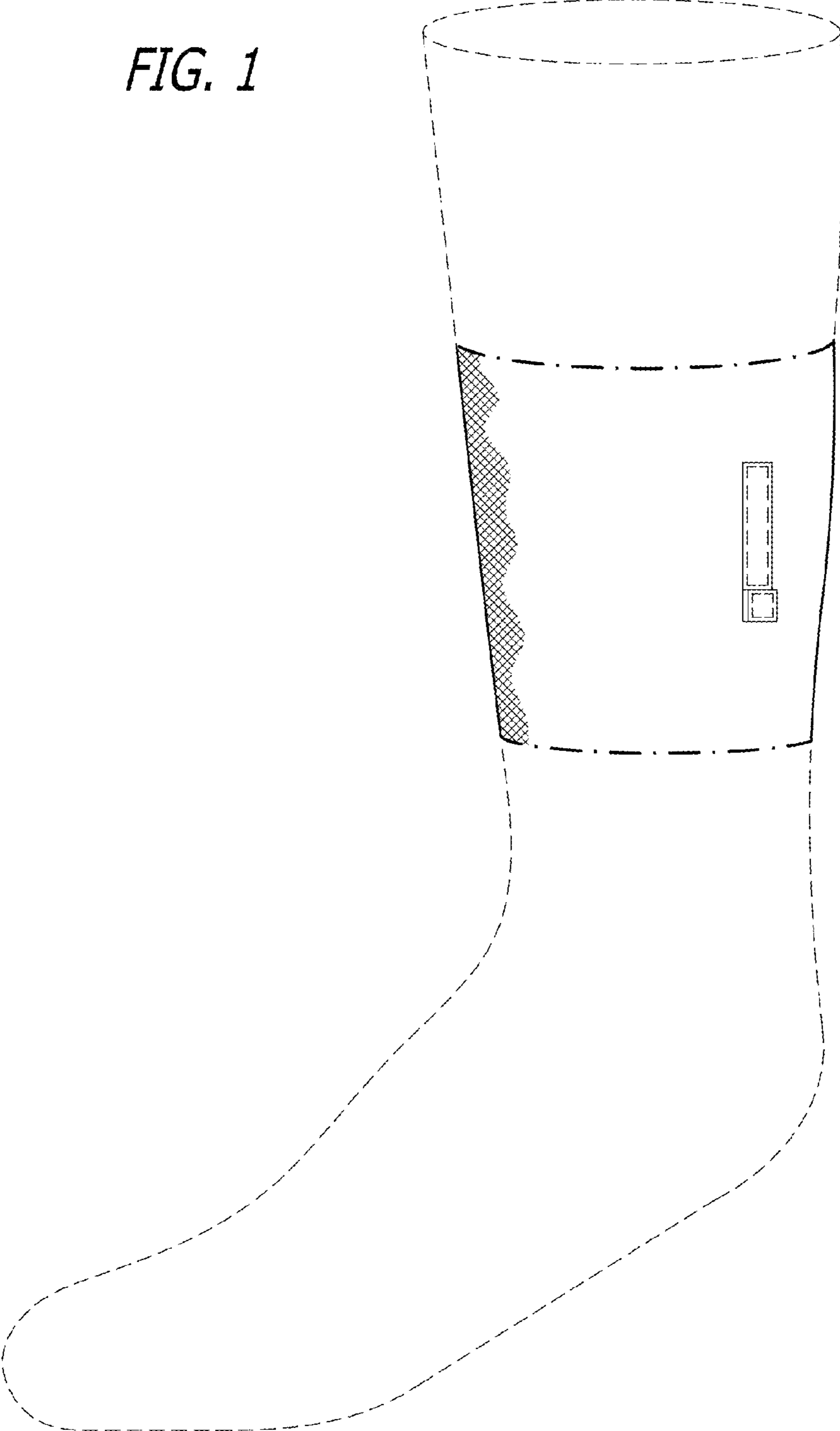

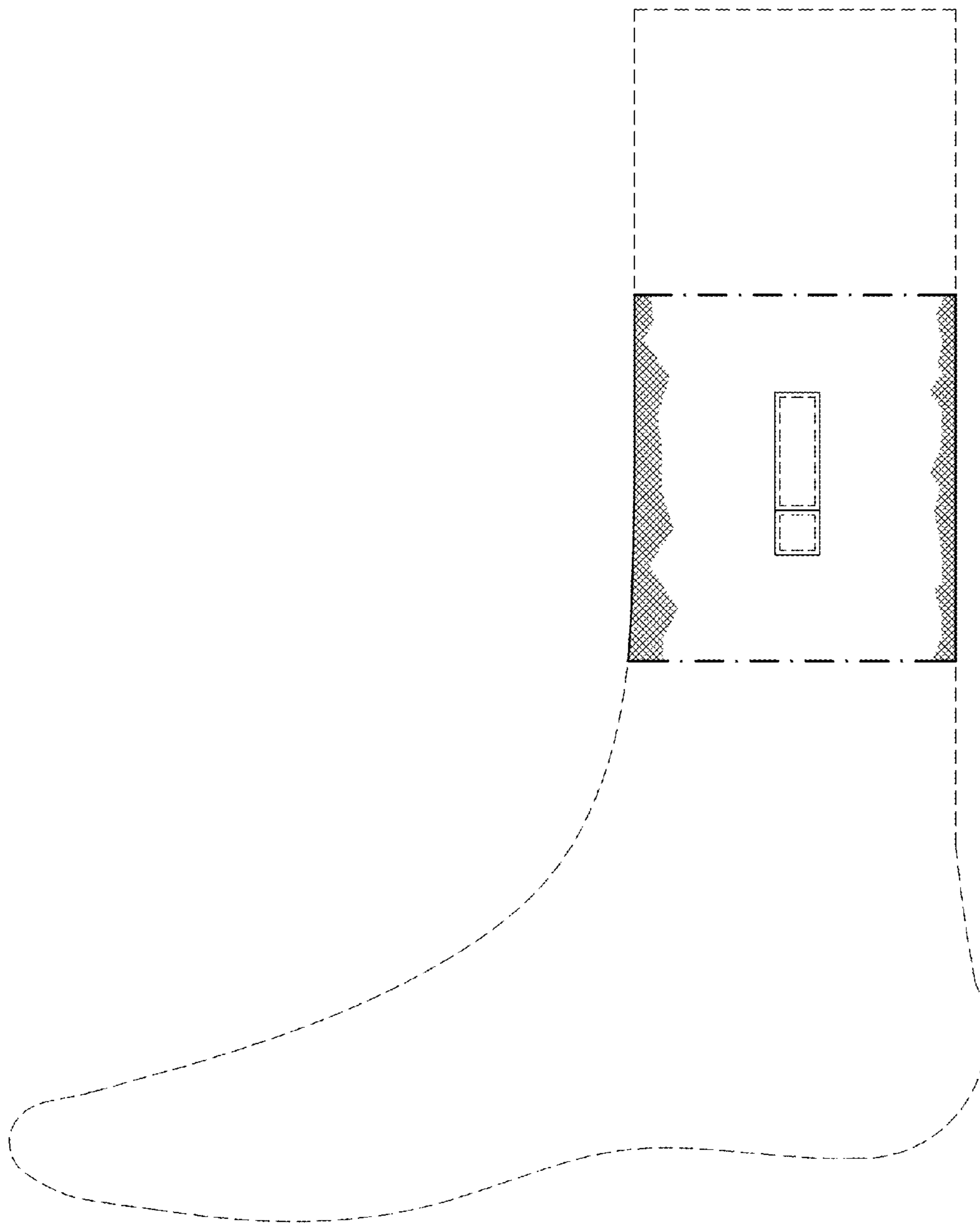
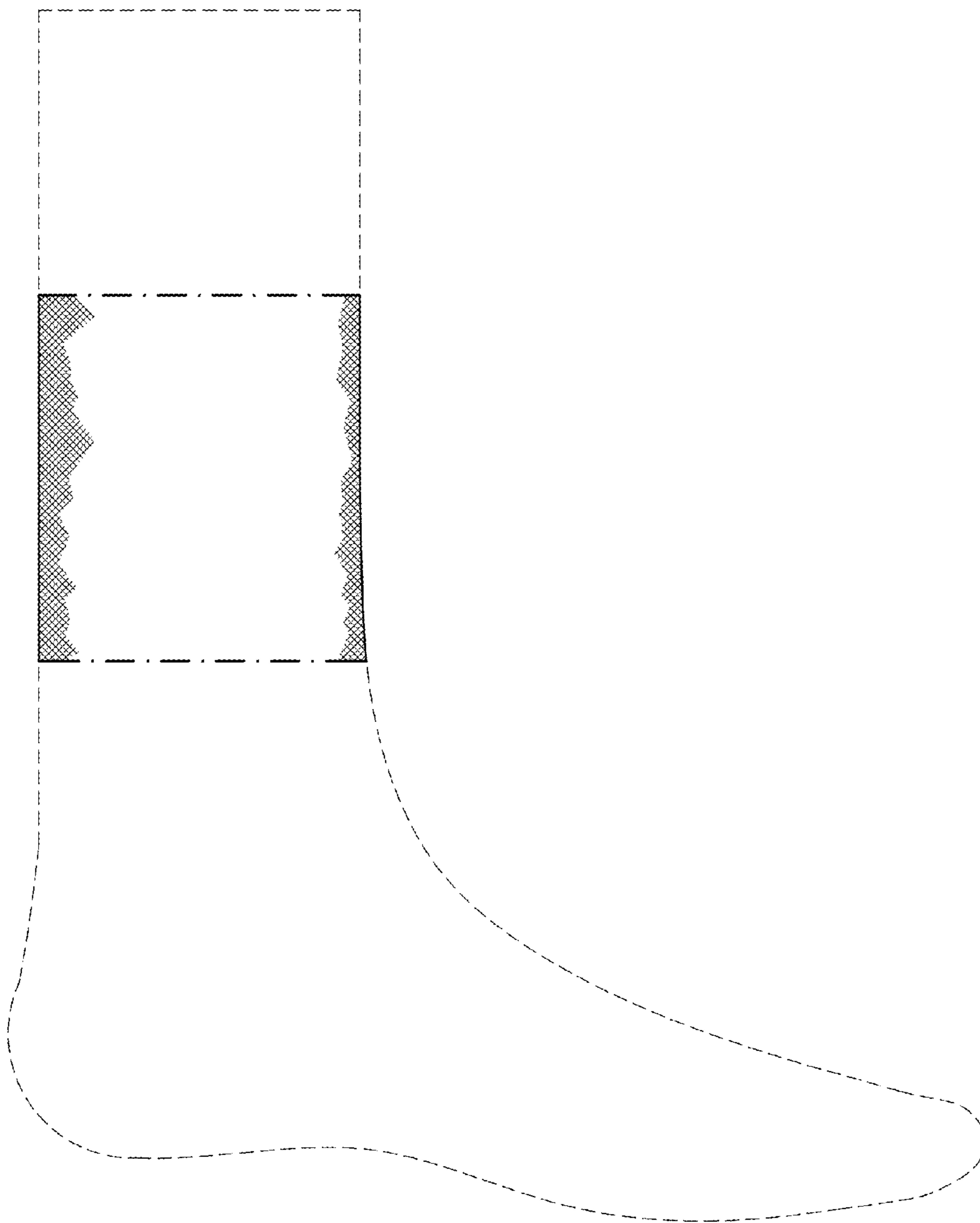

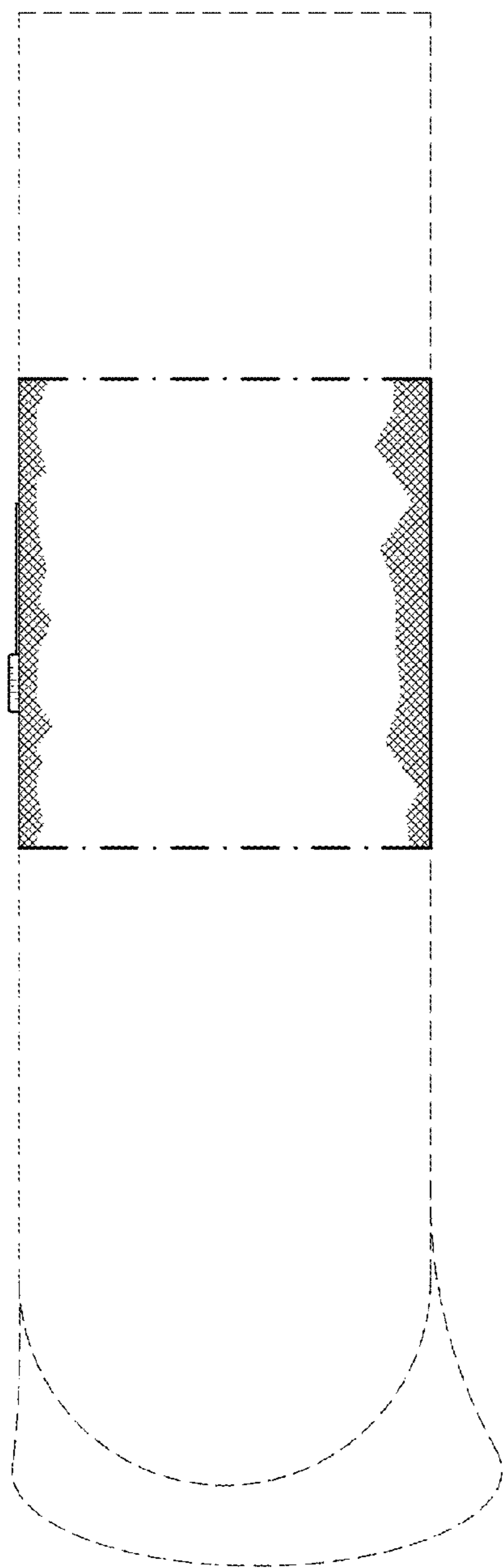

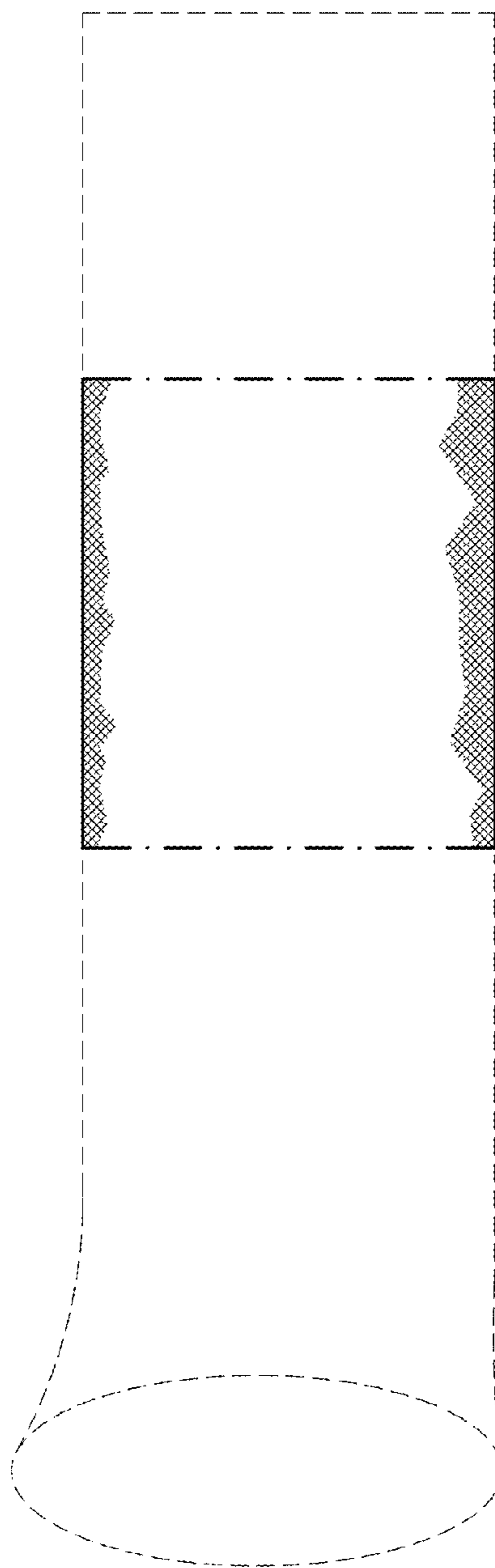
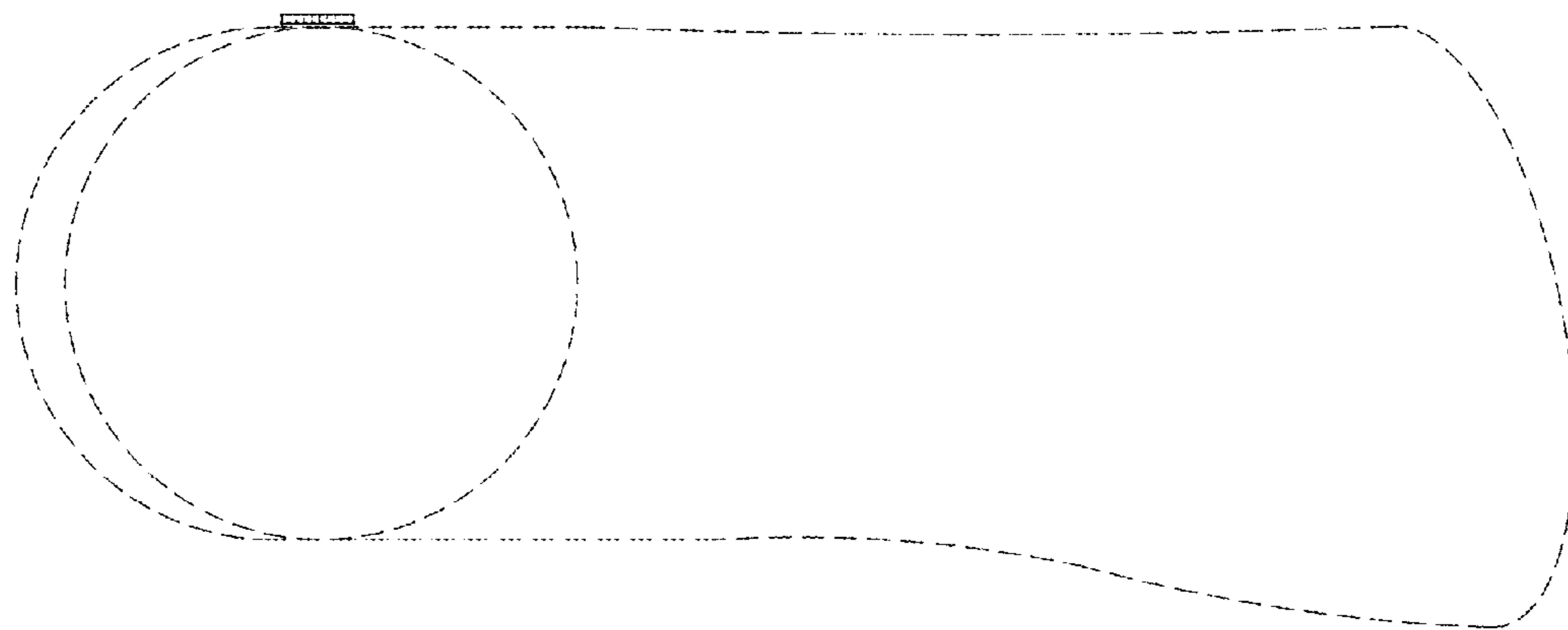
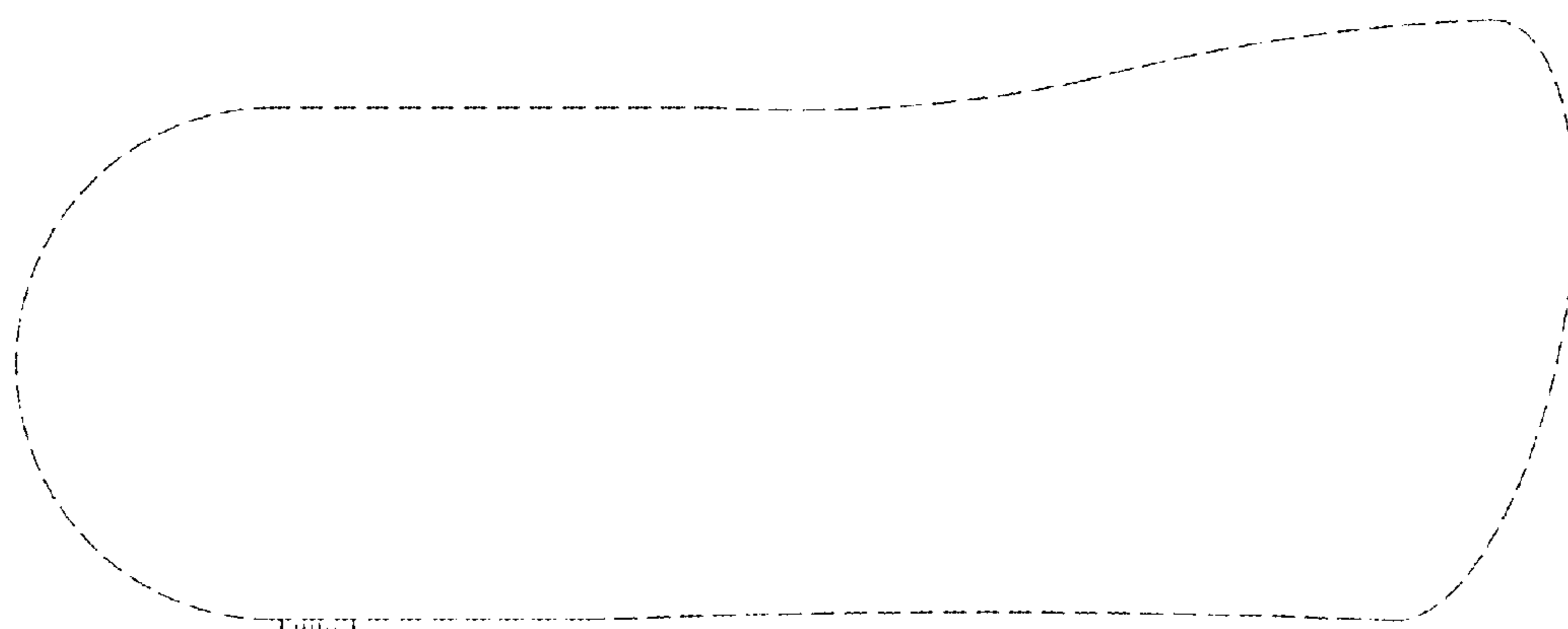


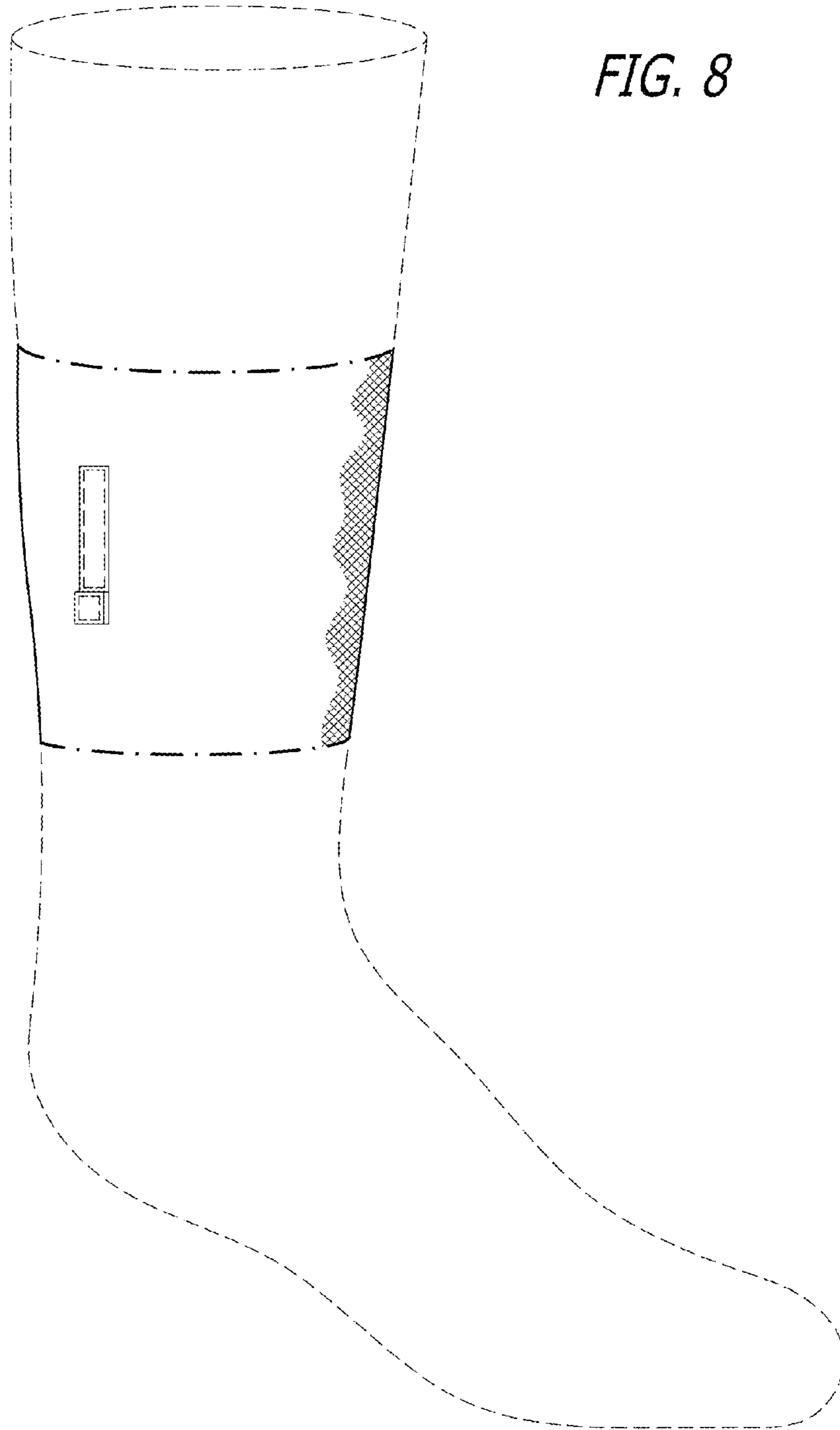

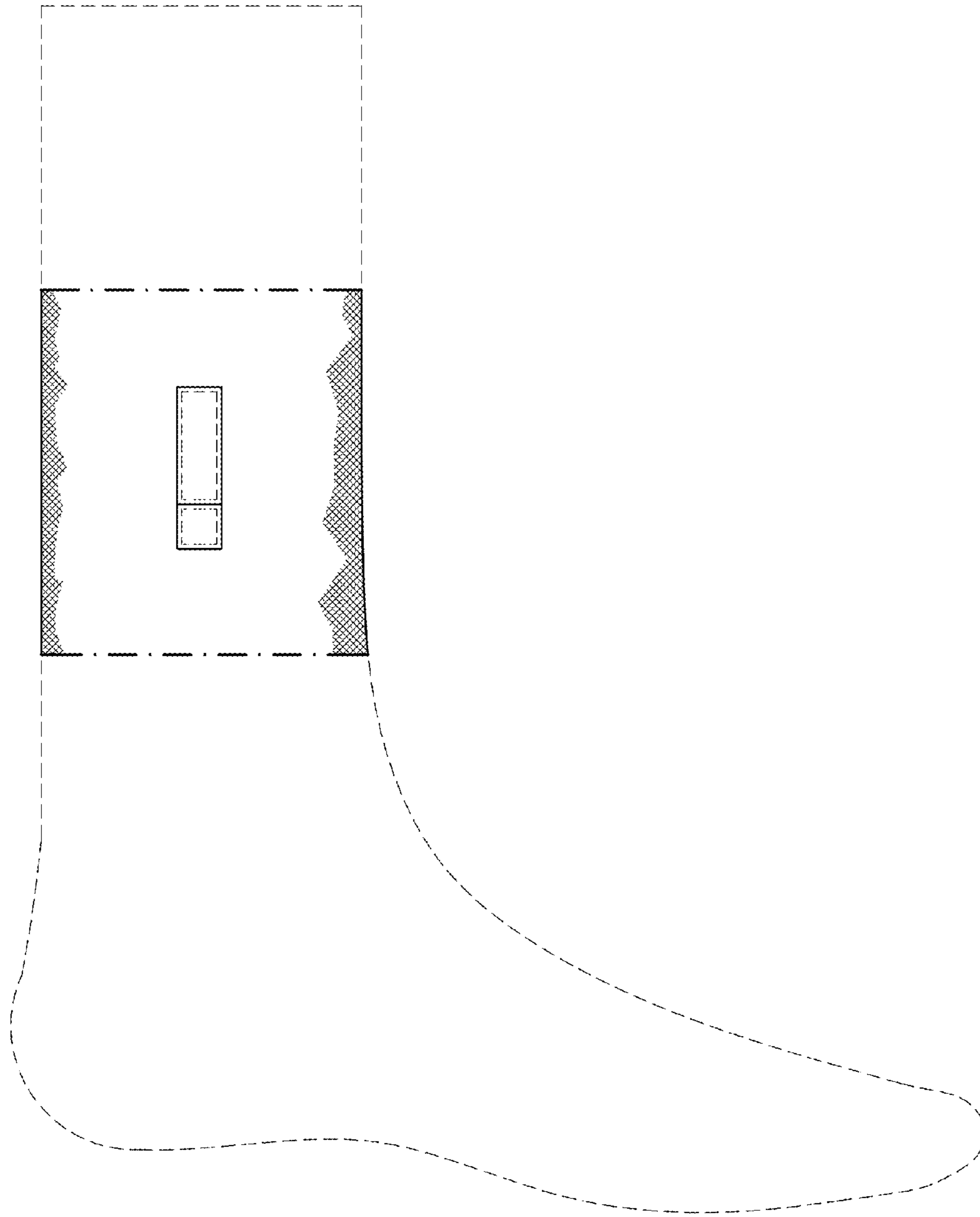
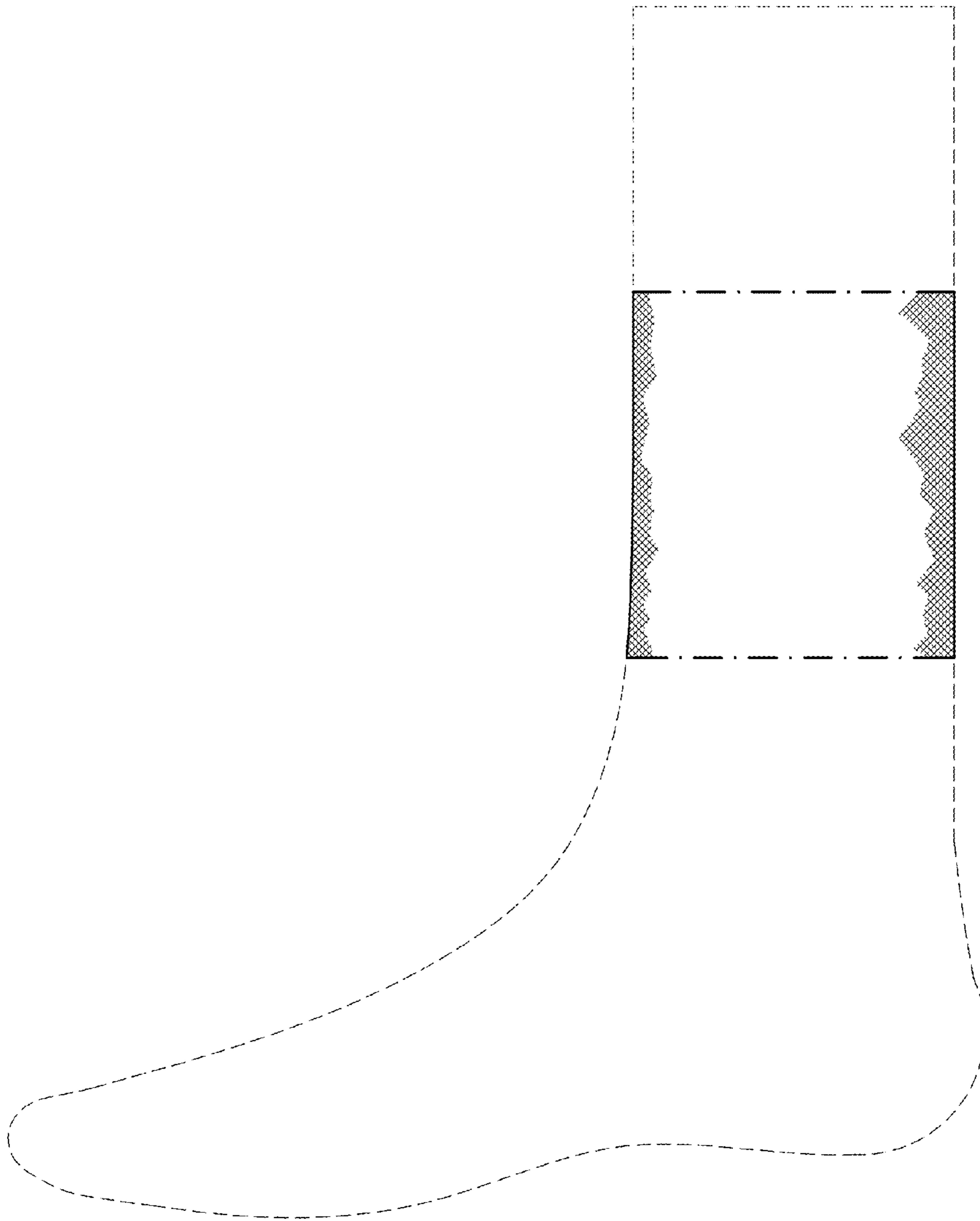
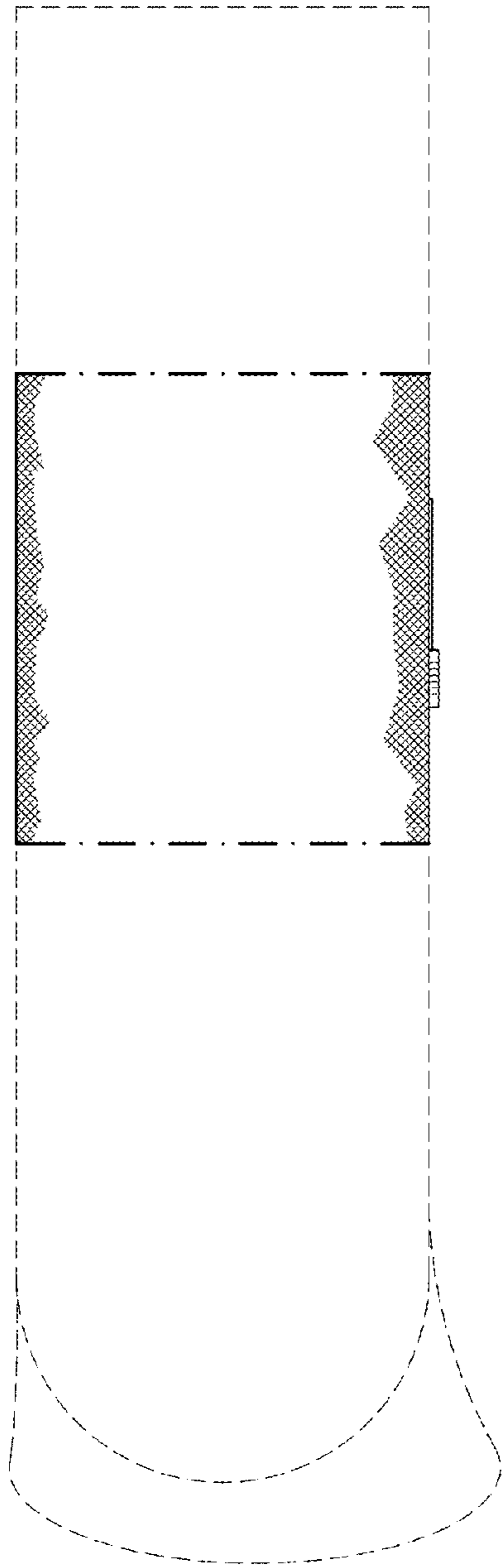


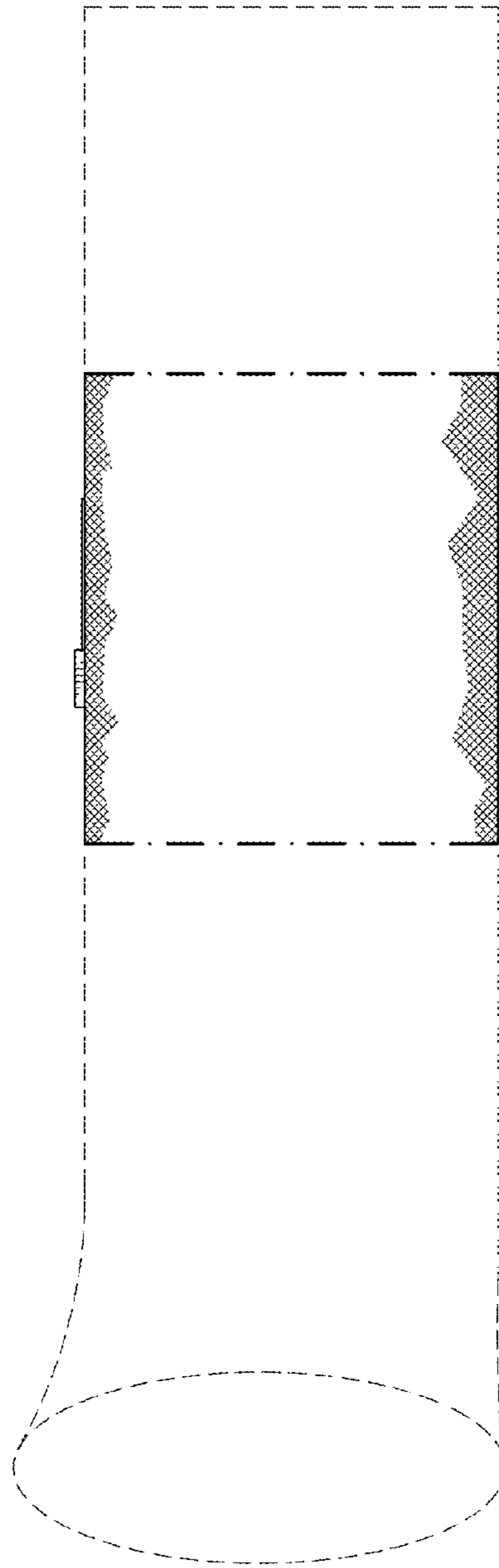

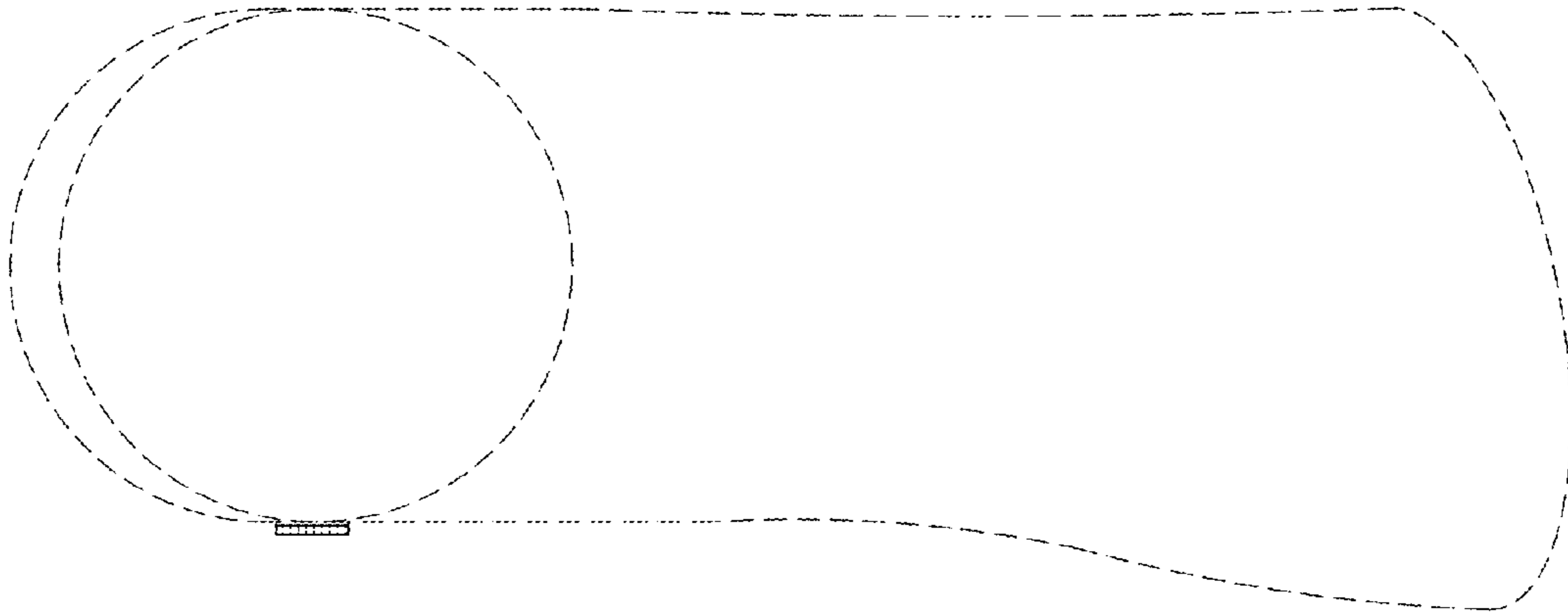

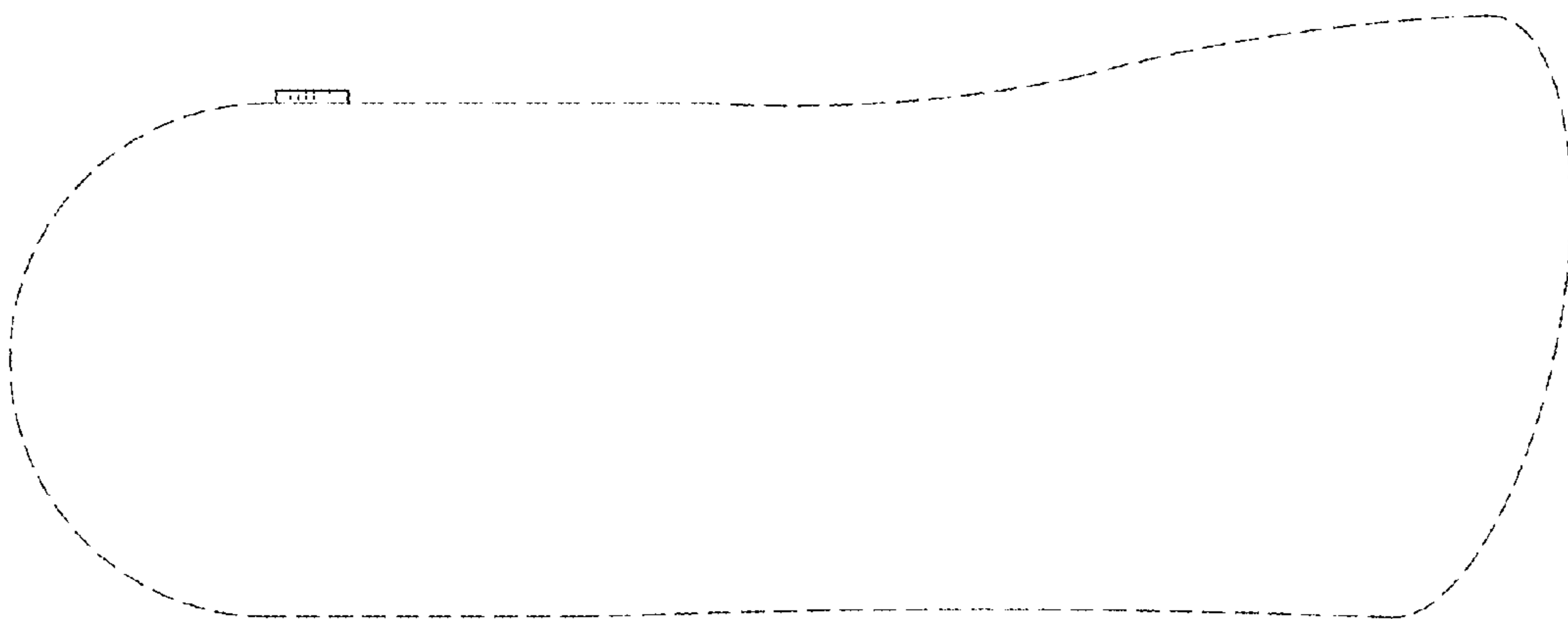
