DESCRIPTION

FIG. 1 is a perspective view of a walking stick in accordance with the present invention.

FIG. 6 is a top view thereof; and

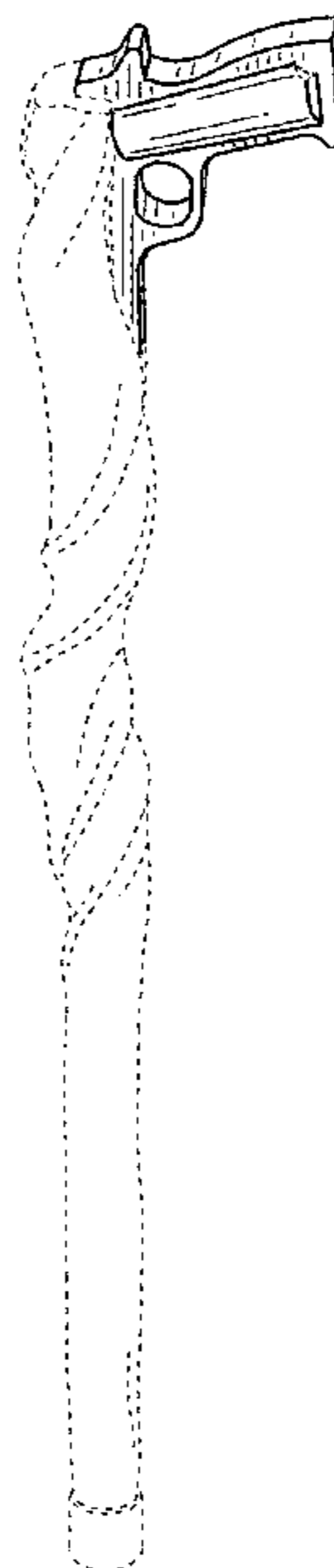
FIG. 7 is a bottom view thereof.

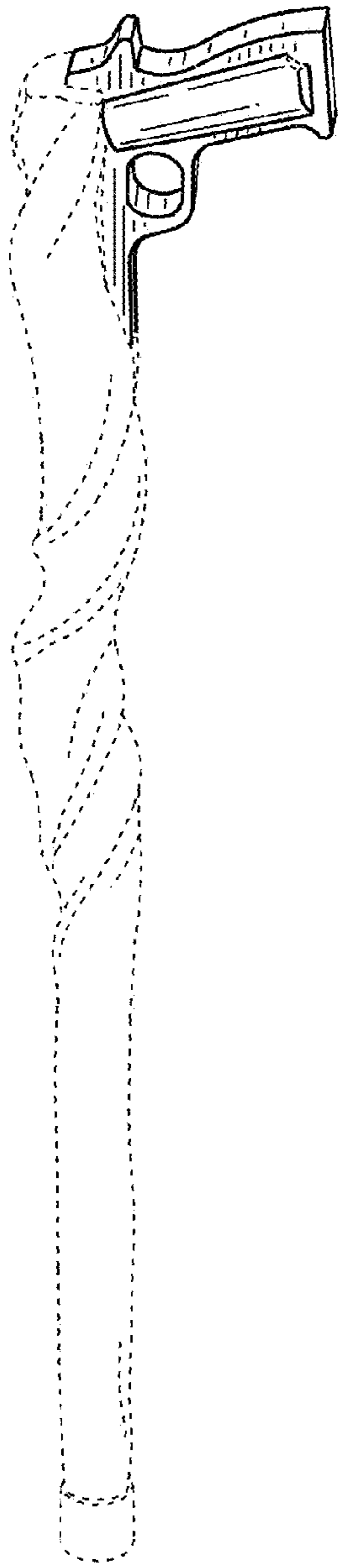

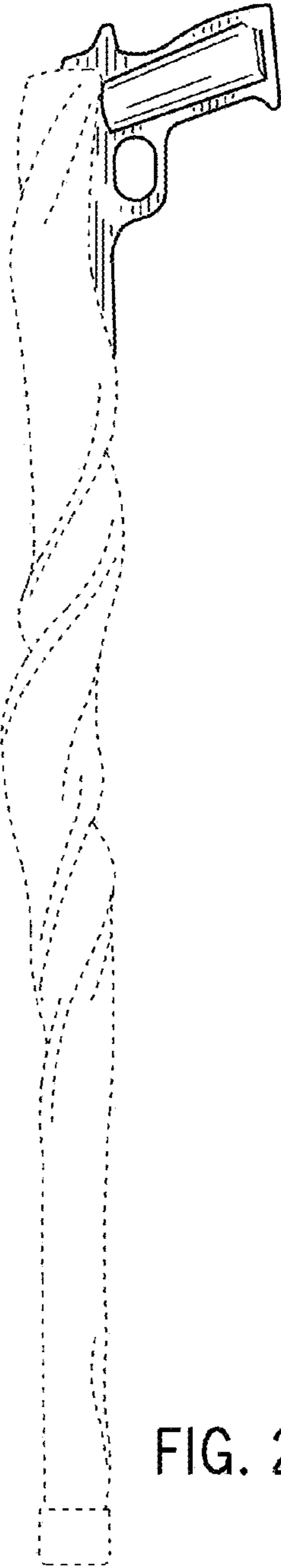

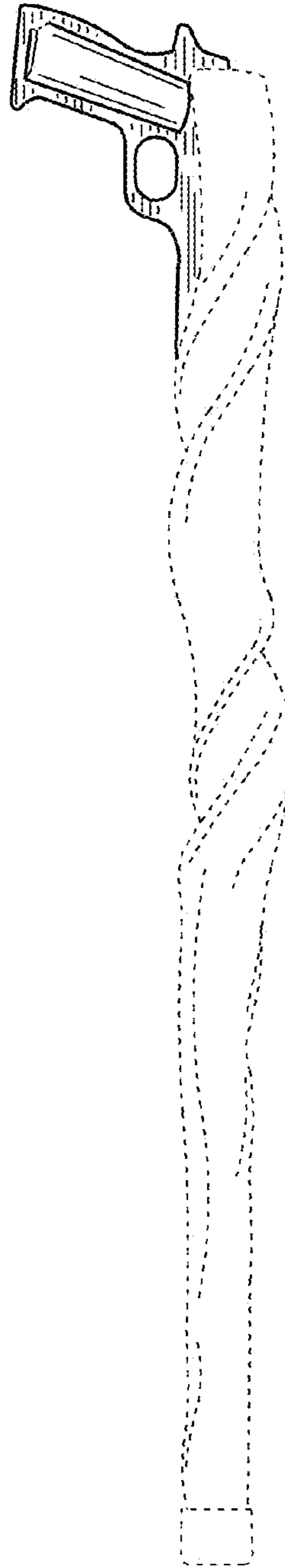

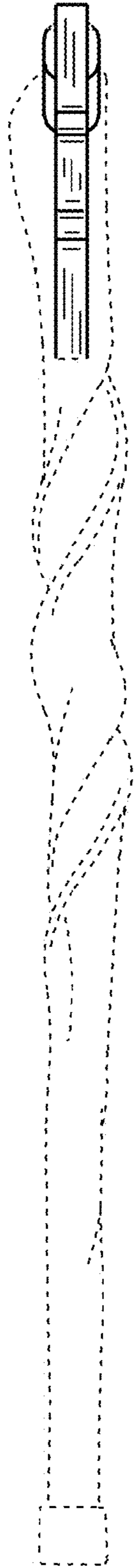

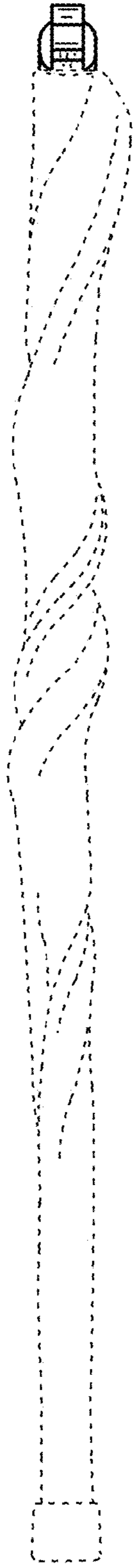

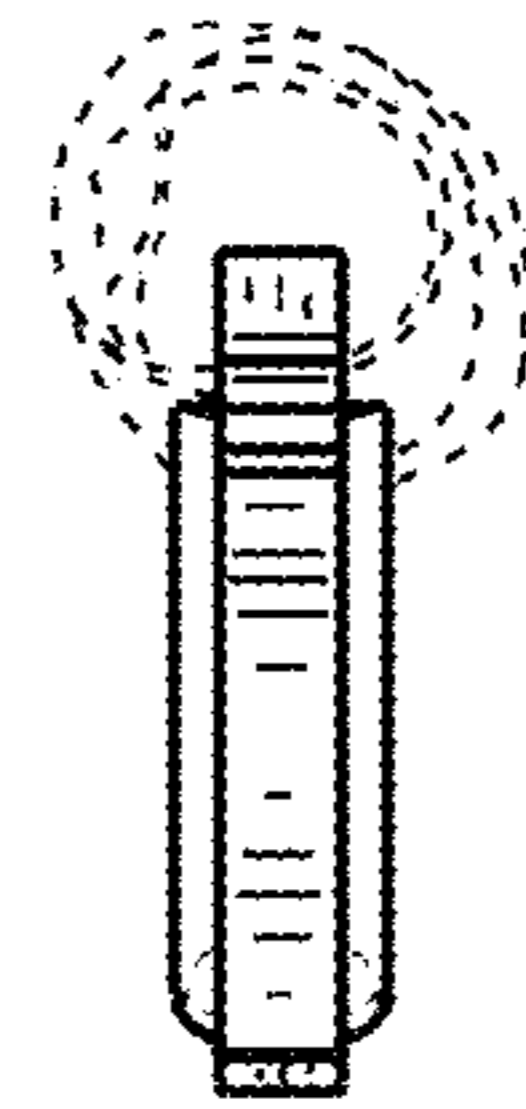

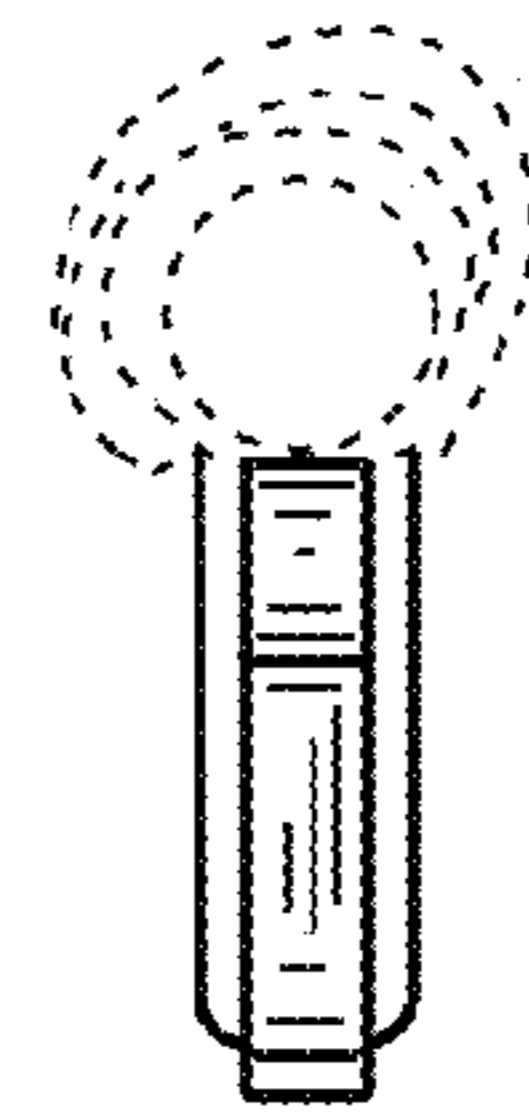

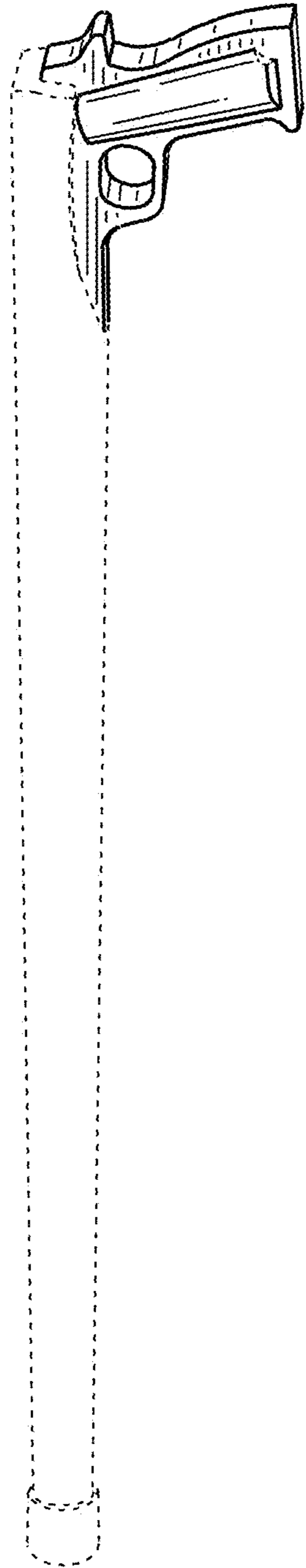

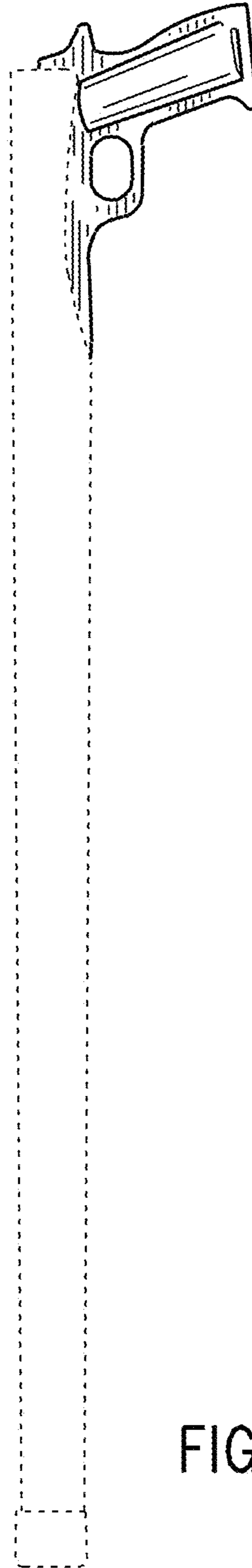
