FIG. 12 is a top plan view of a further configuration of the bag with attached storage pouch.

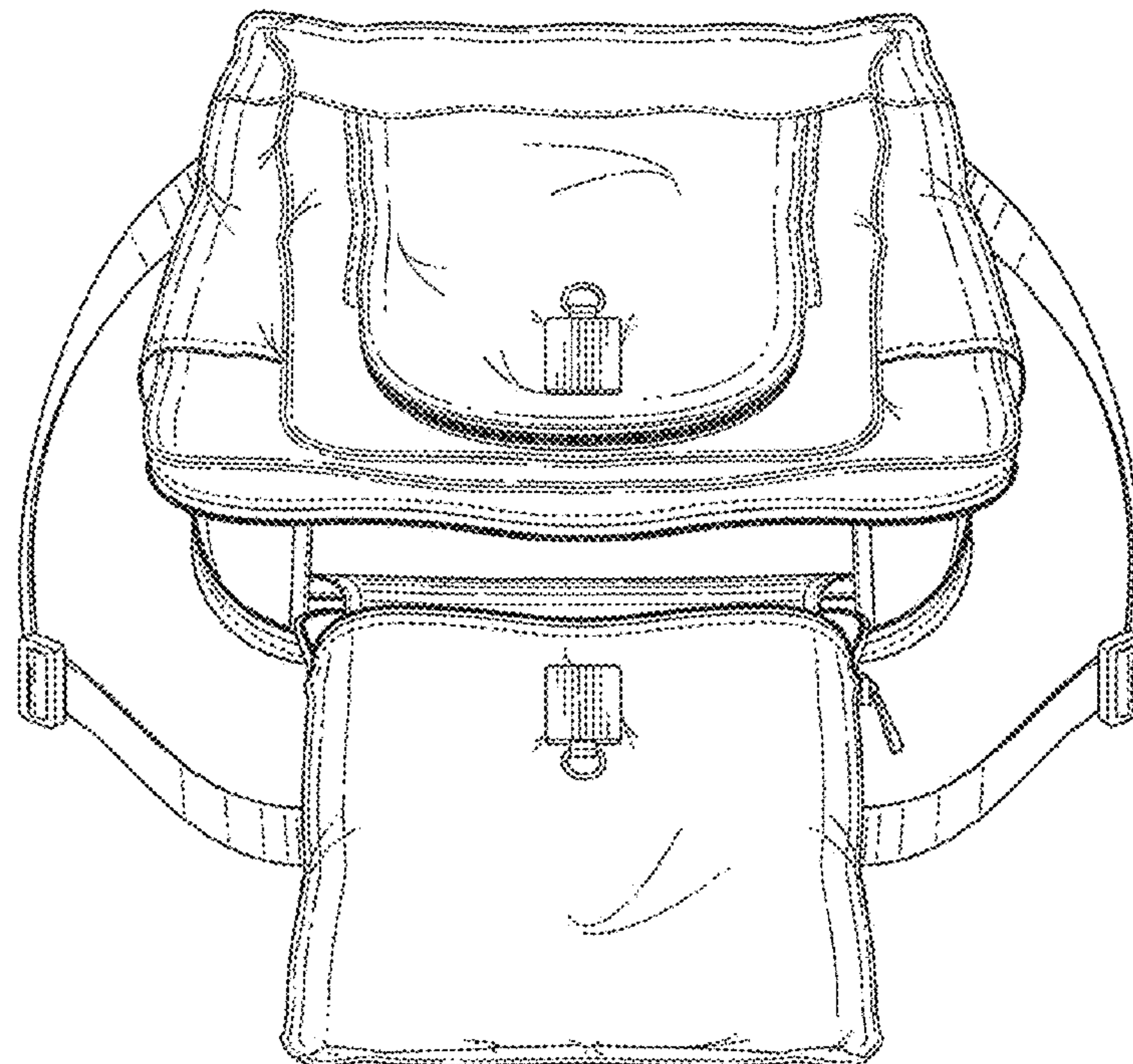
The broken lines representing stitching are part of the claimed design.

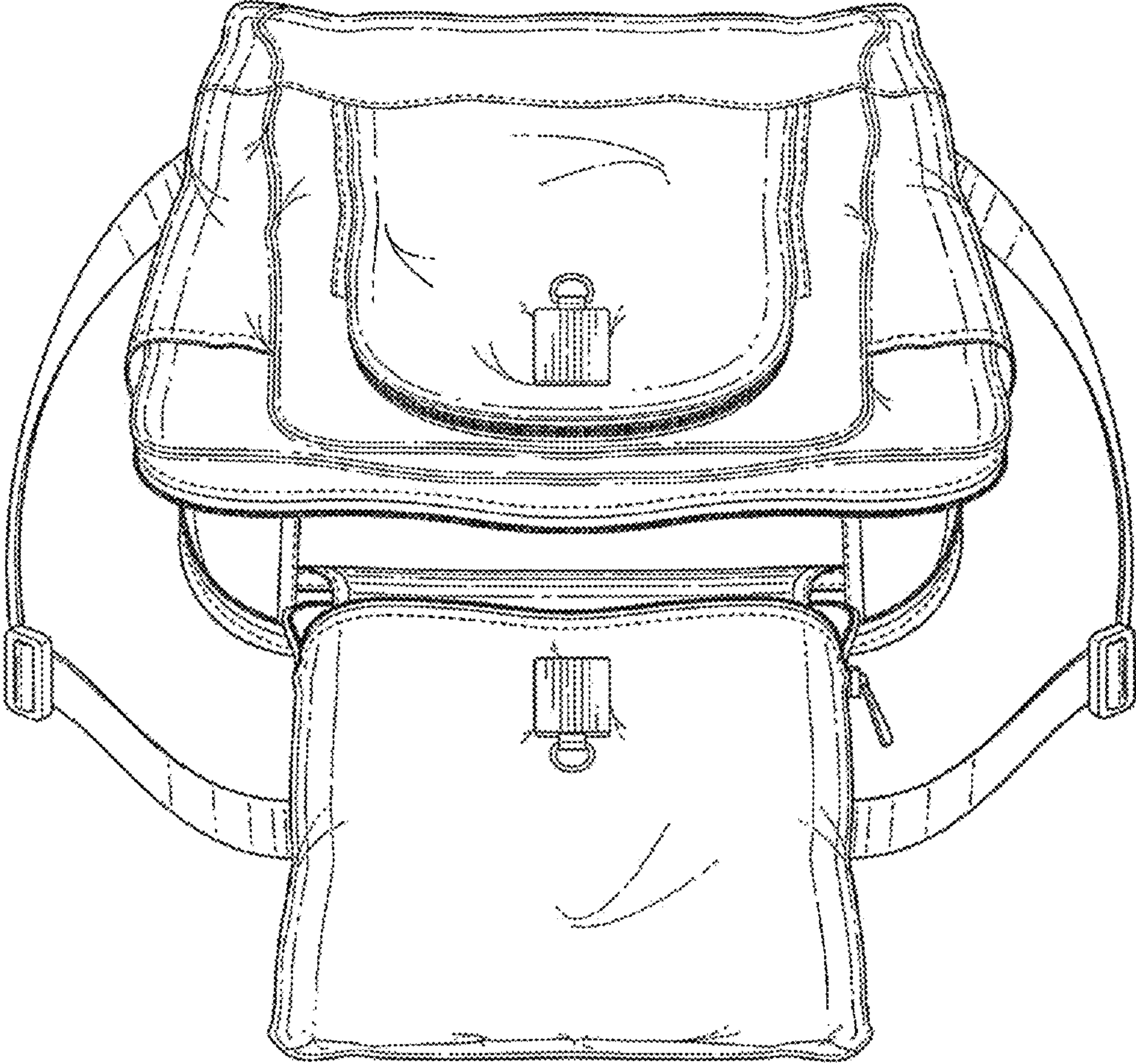

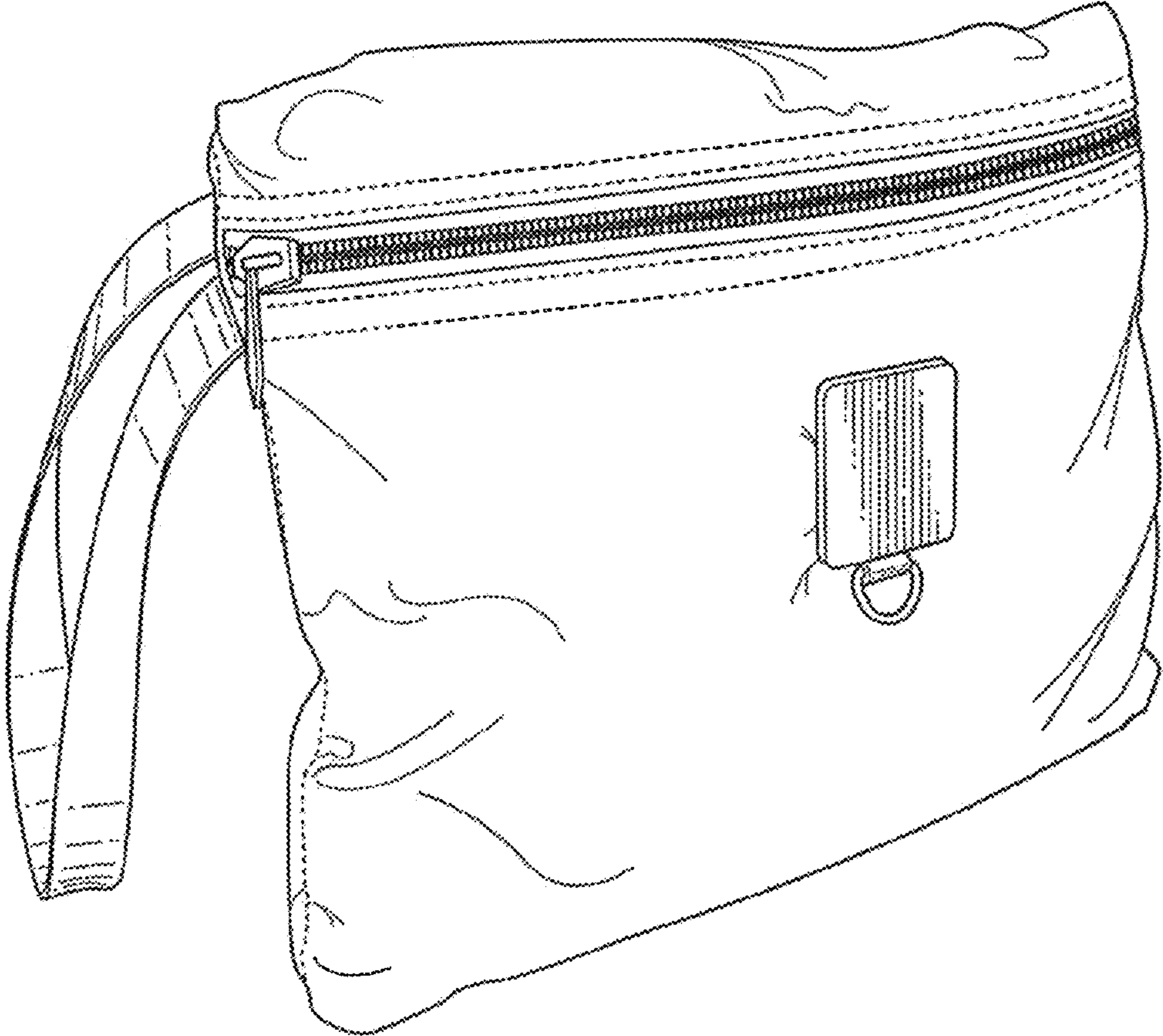
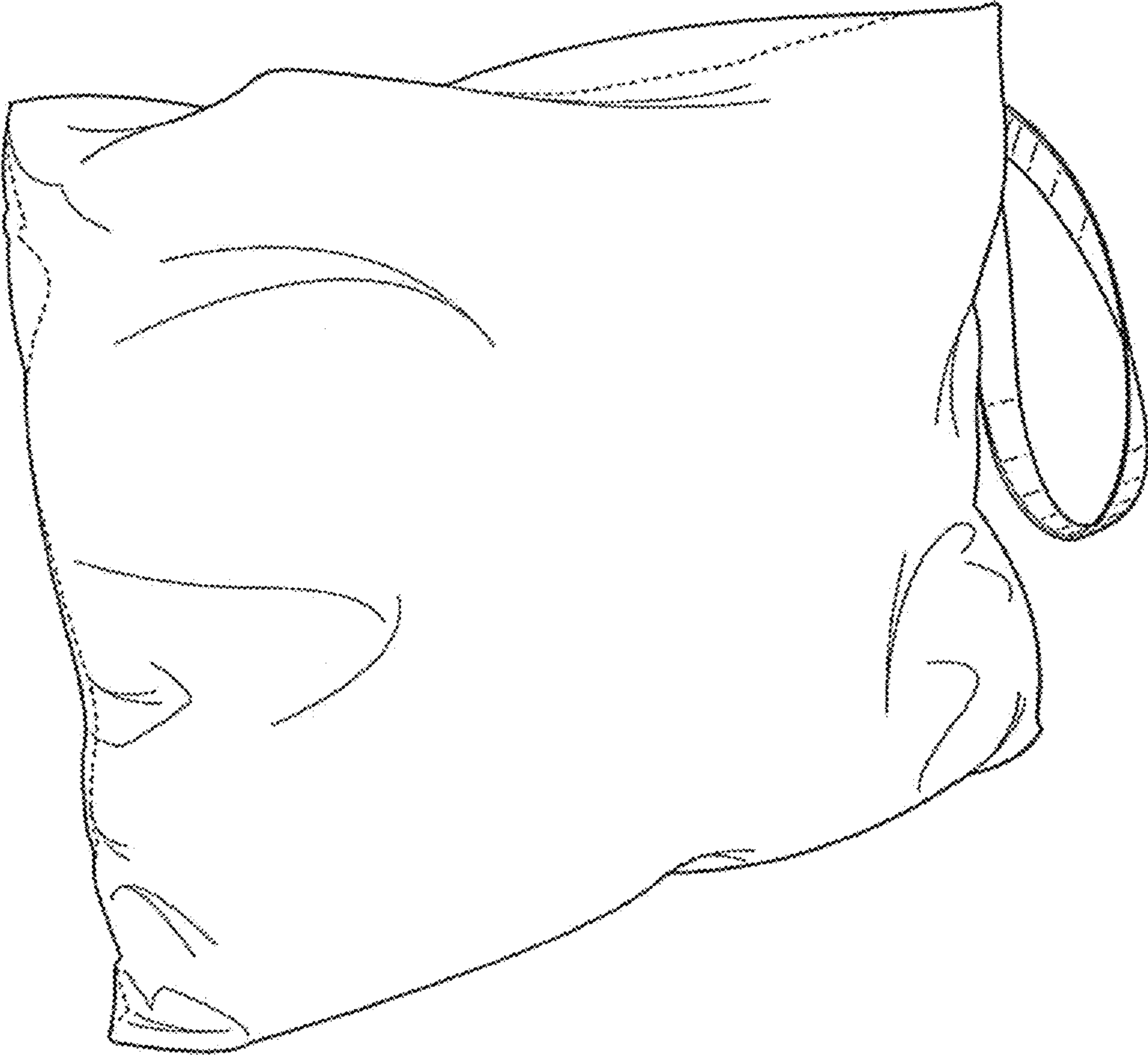

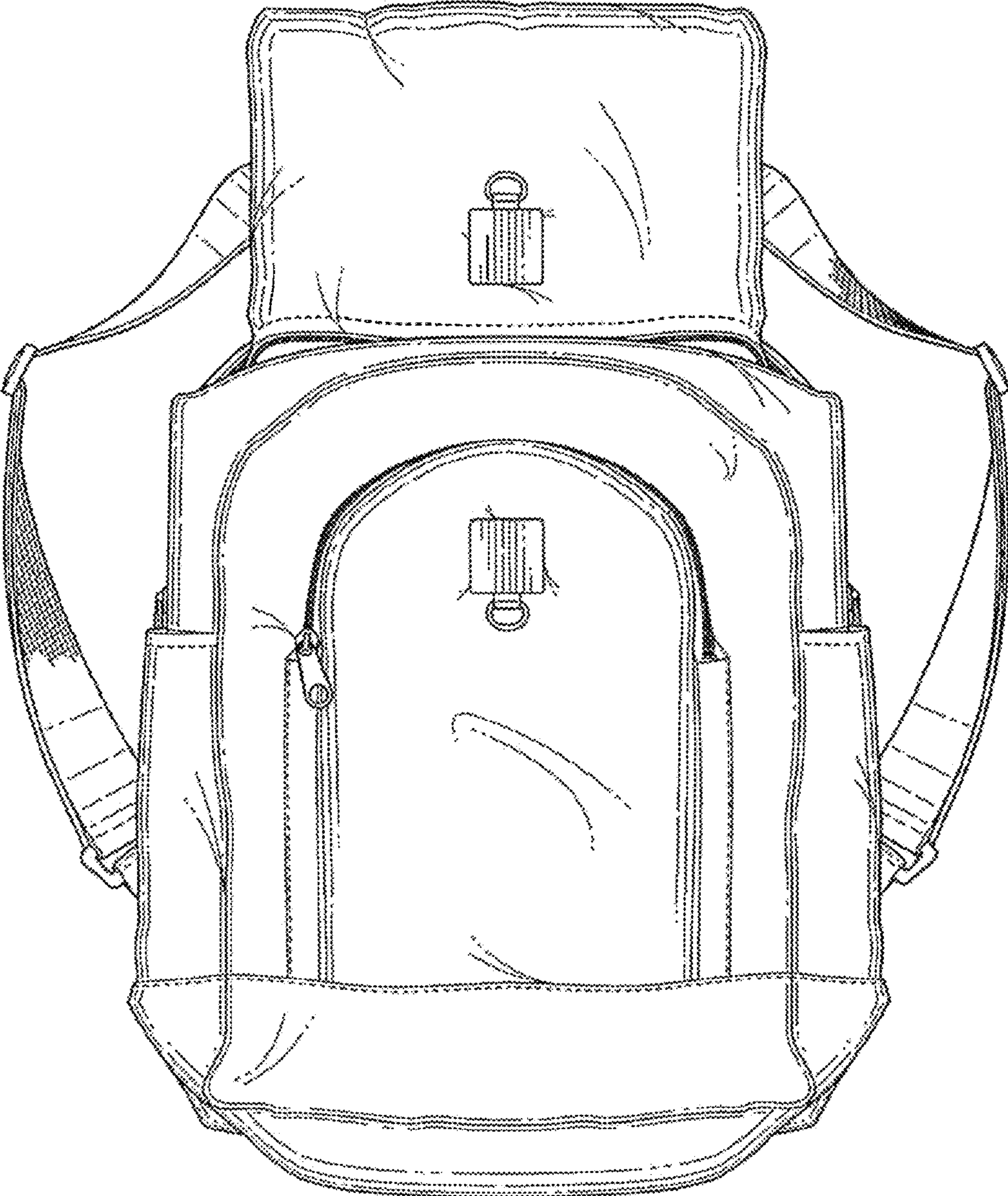

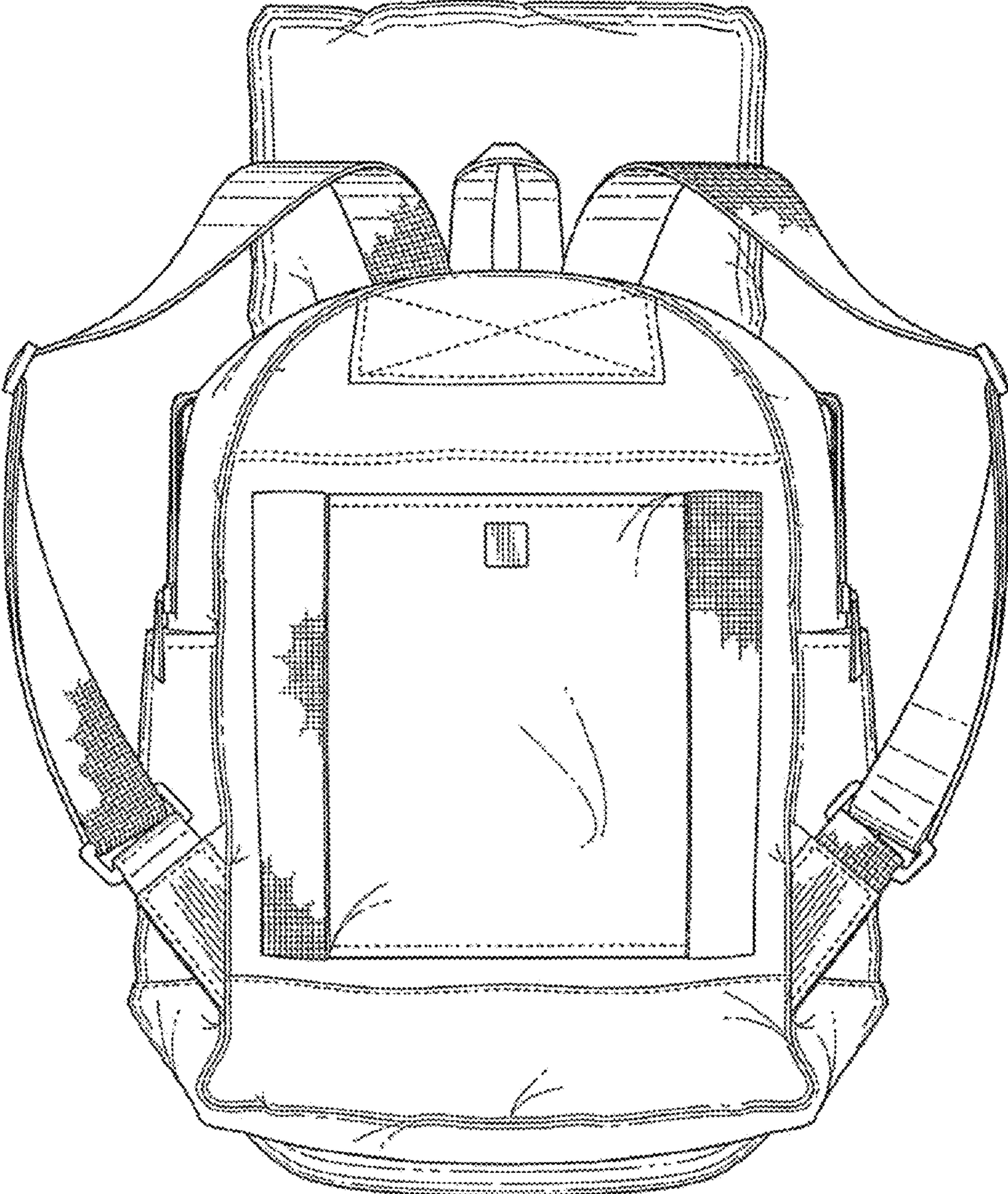
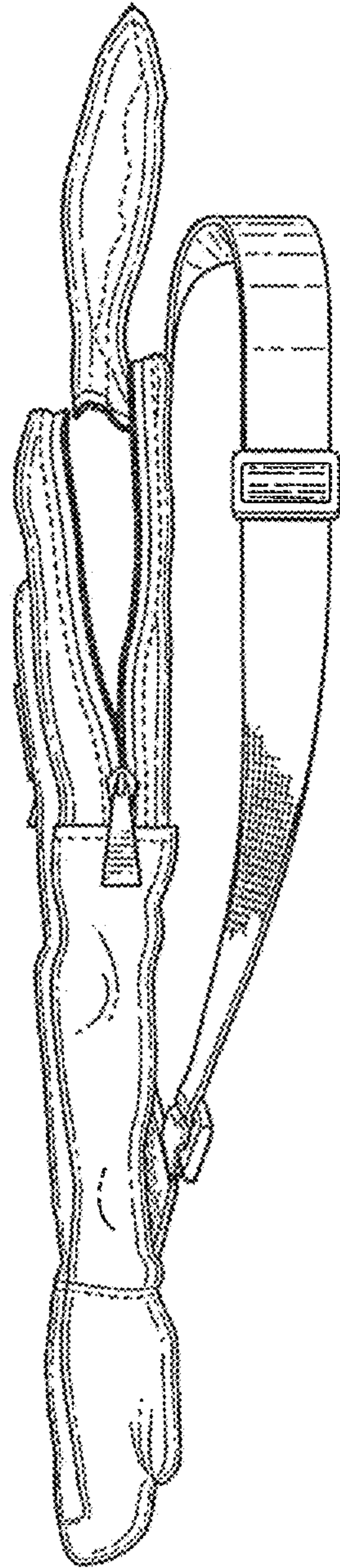
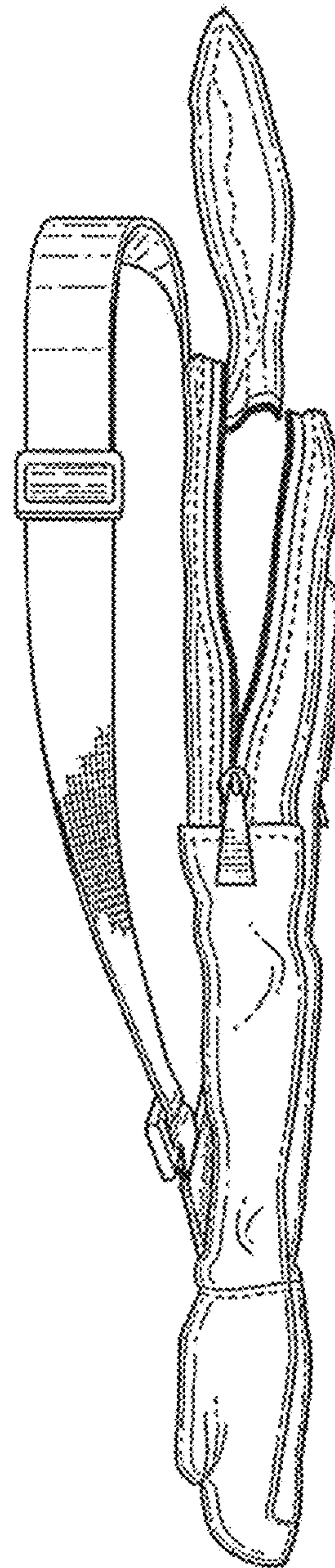

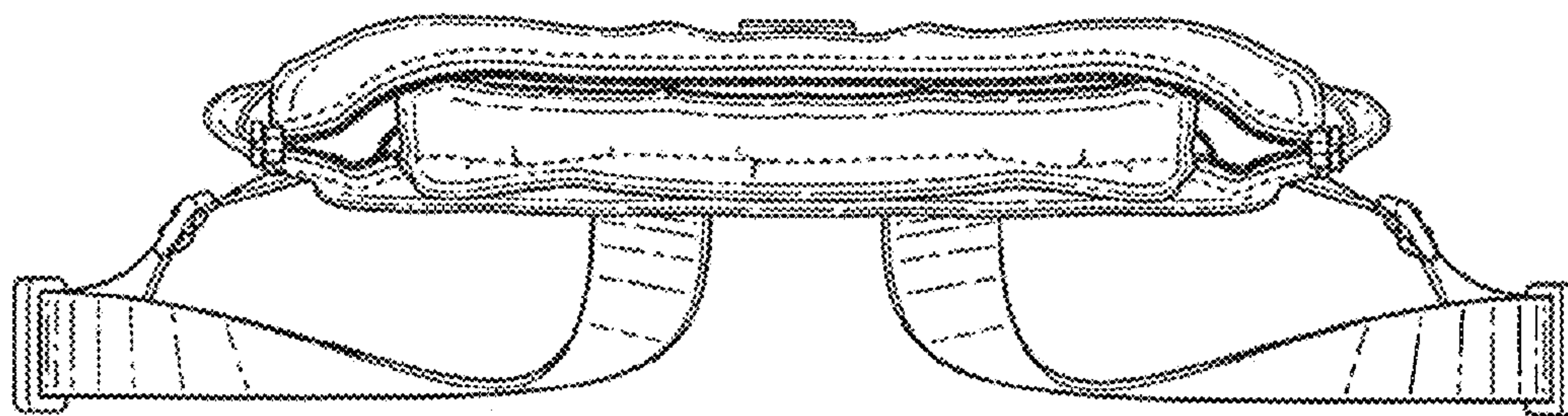

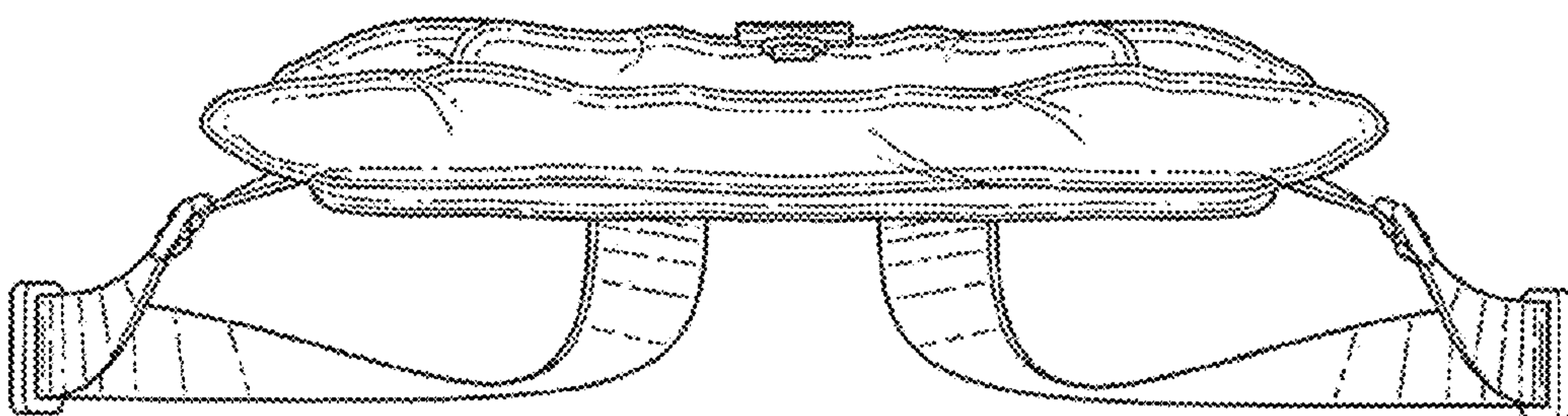

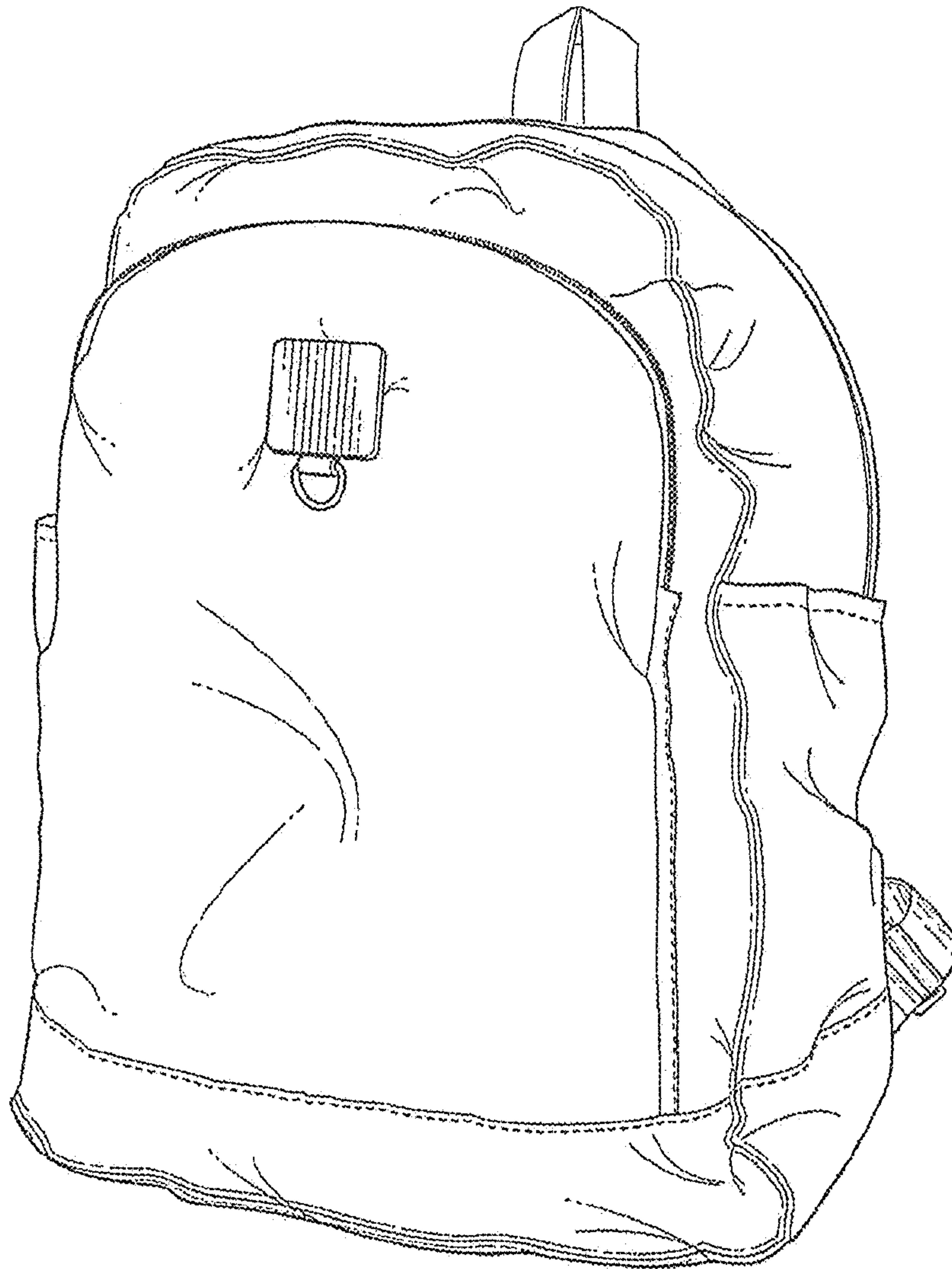

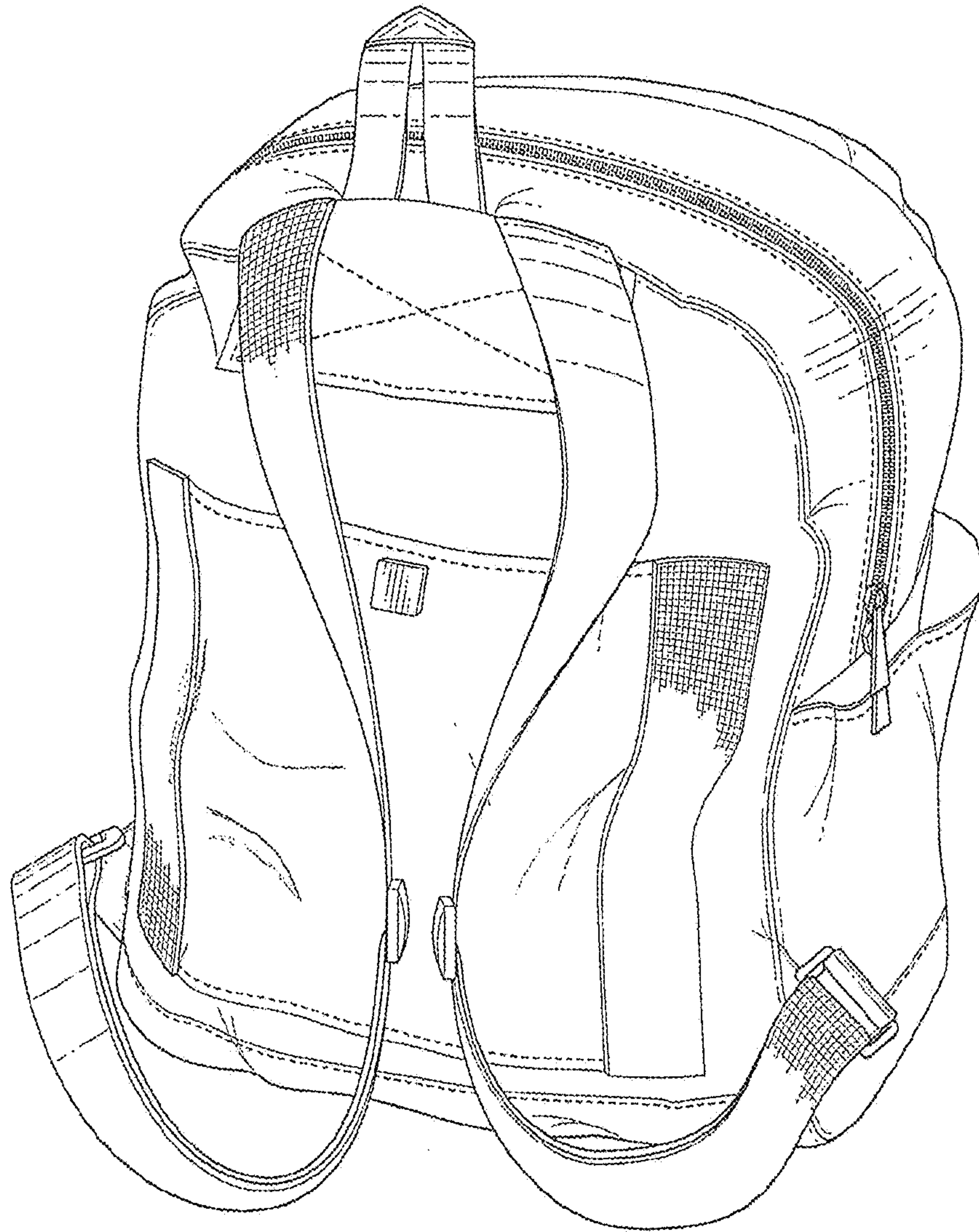

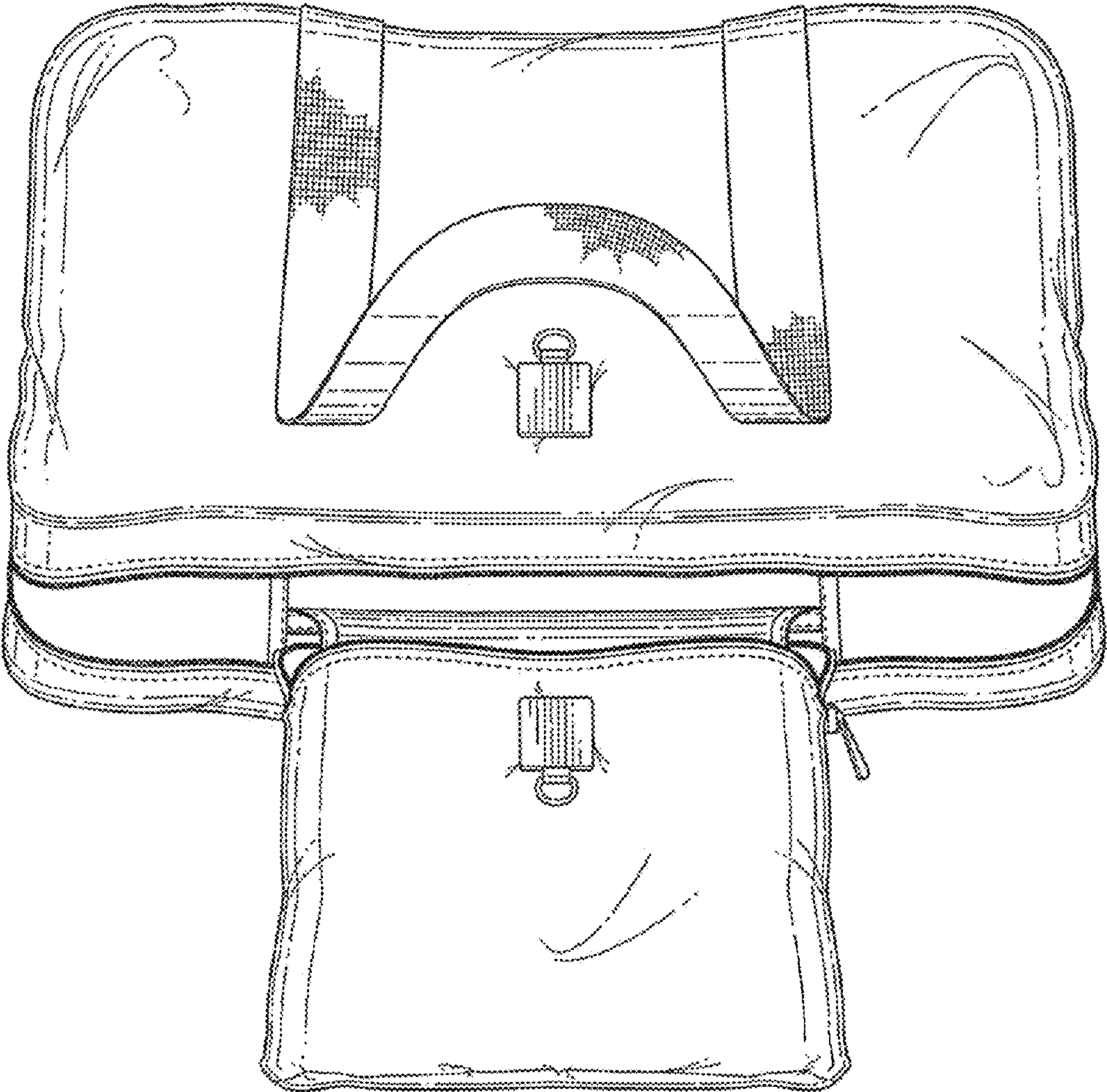
