(57) **CLAIM**

The ornamental design for a handbag, as shown and
described.

DESCRIPTION

FIG. 1 is a front, right perspective view of the new design.

FIG. 2 is a front view of the new design.

FIG. 3 is a rear view of the new design.

FIG. 4 is a right side view of the new design.

FIG. 5 is a left side view of the new design.

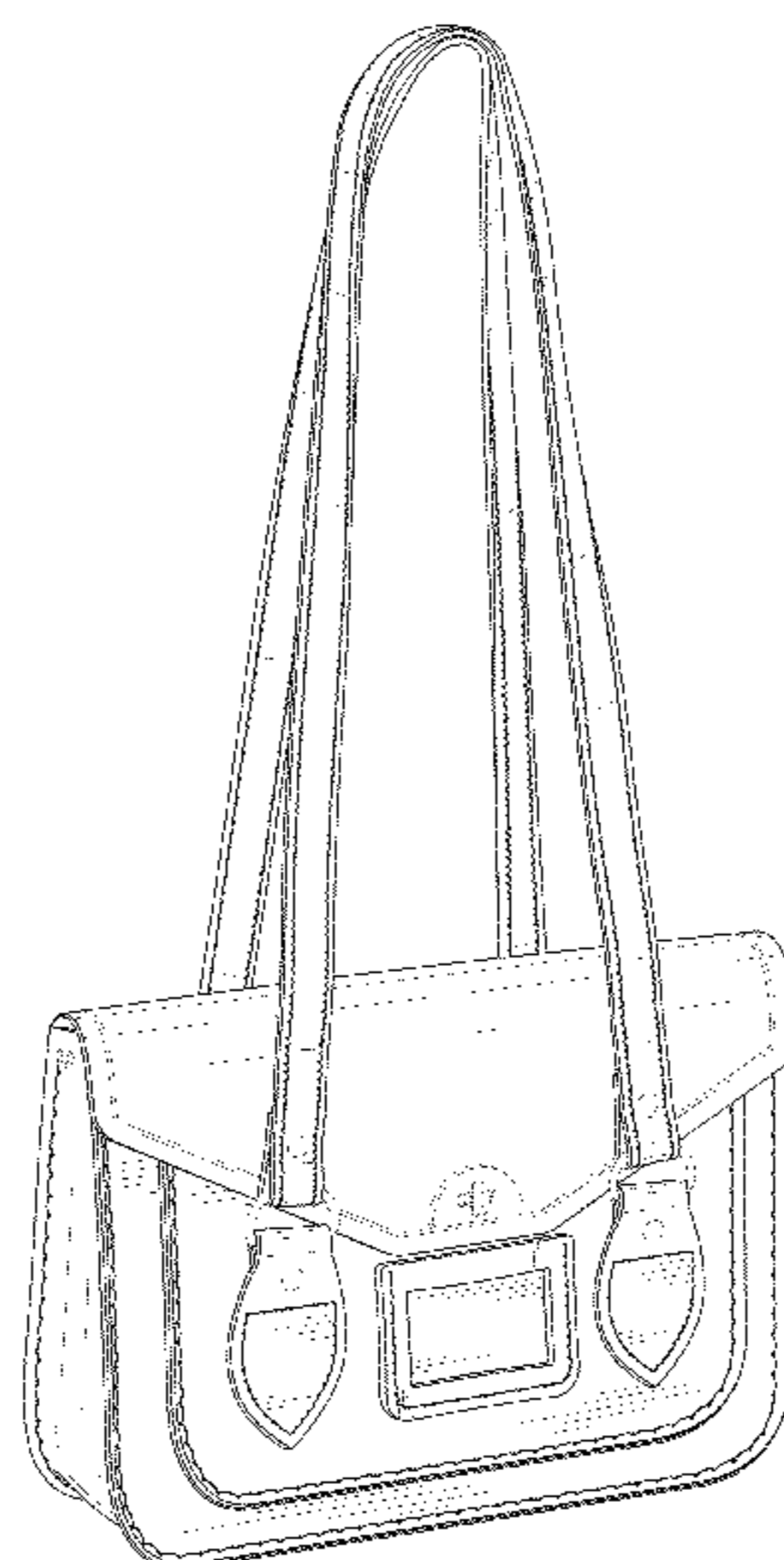
FIG. 6 is a top view of the new design.

FIG. 7 is a top view of the new design with the shoulder straps
omitted; and,

FIG. 8 is a bottom view of the new design.

The broken lines shown in the drawings illustrate portions of
the handbag—namely, a brand name and logo, a clasp, shoul-
der strap attachment rings, and rivets—that form no part of
the claimed design. The shading lines shown in the drawings
represent the approximate three-dimensional contour of the
design and do not indicate surface decoration. In FIG. 7, the
shoulder straps are omitted to show the top of the body of the
handbag.

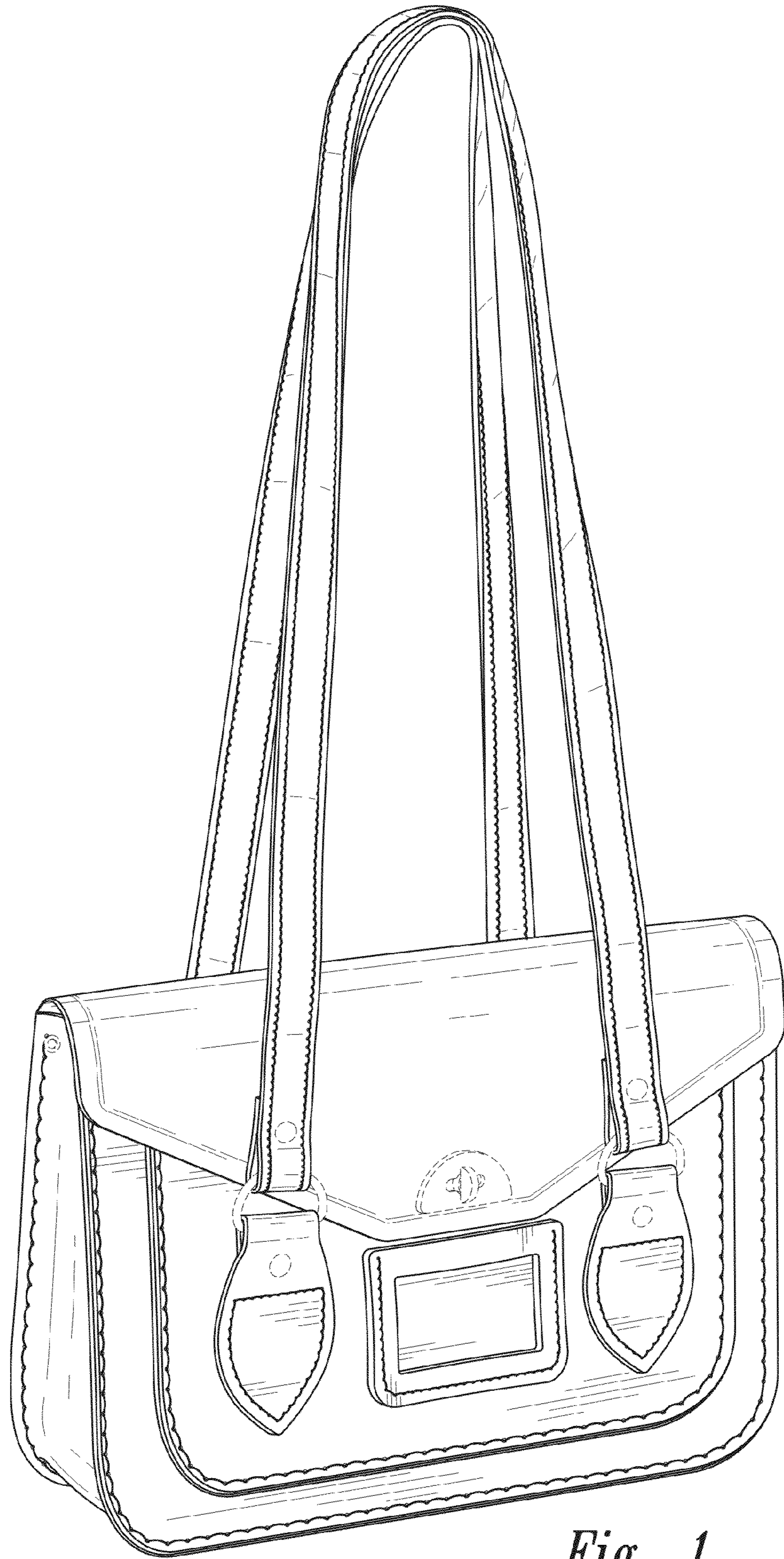

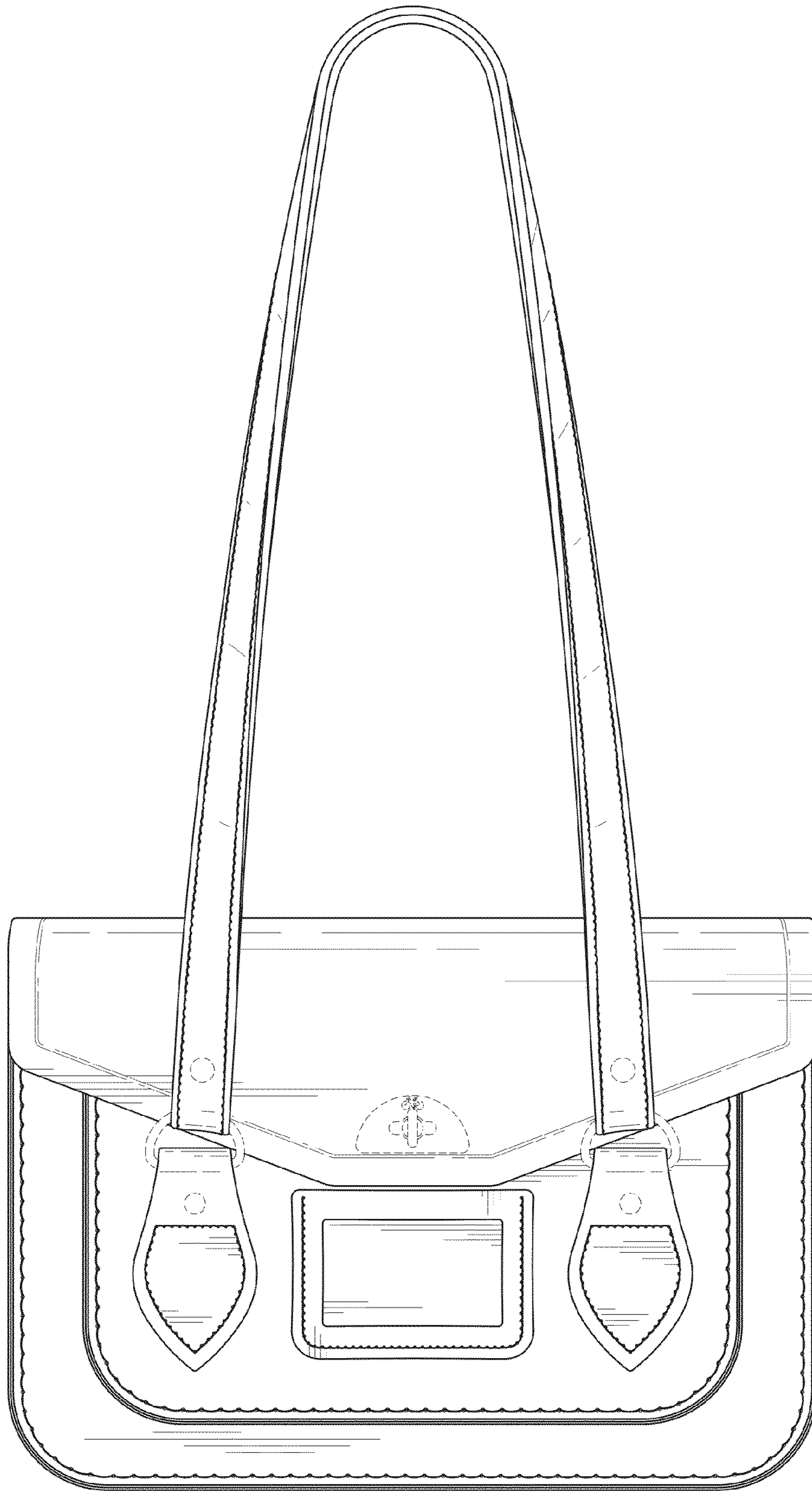

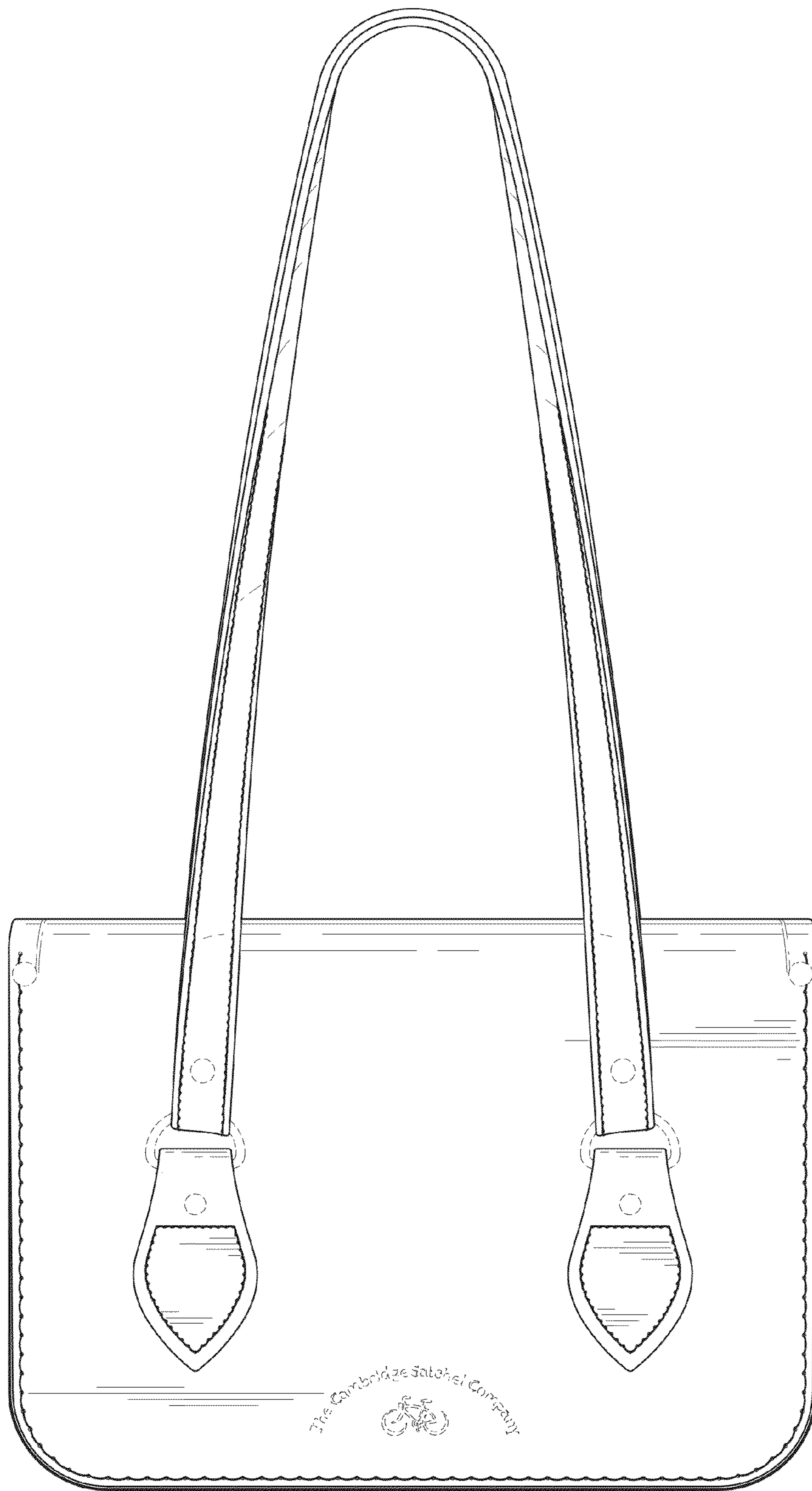

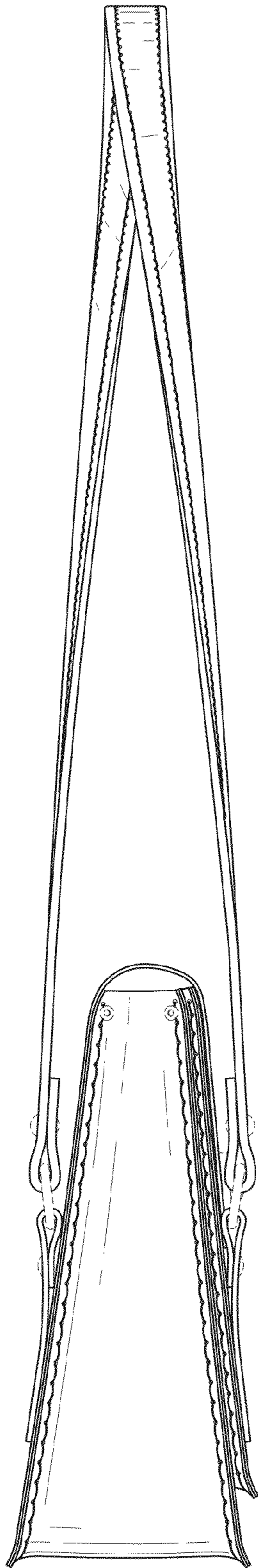

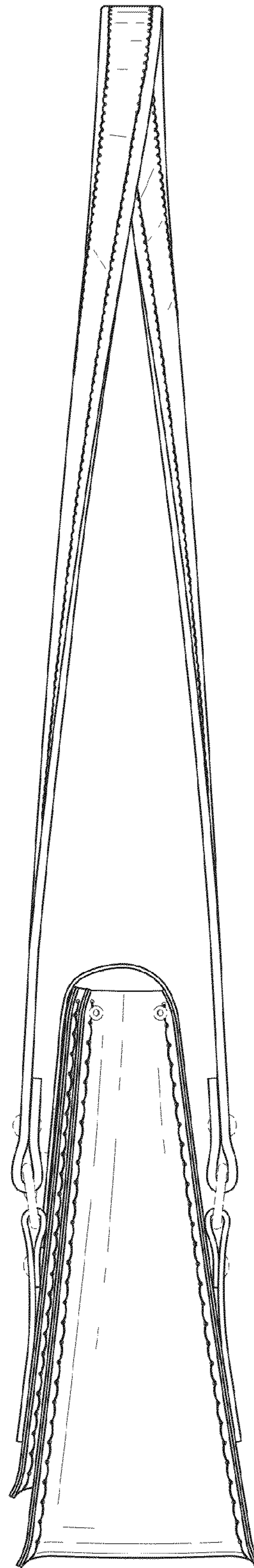

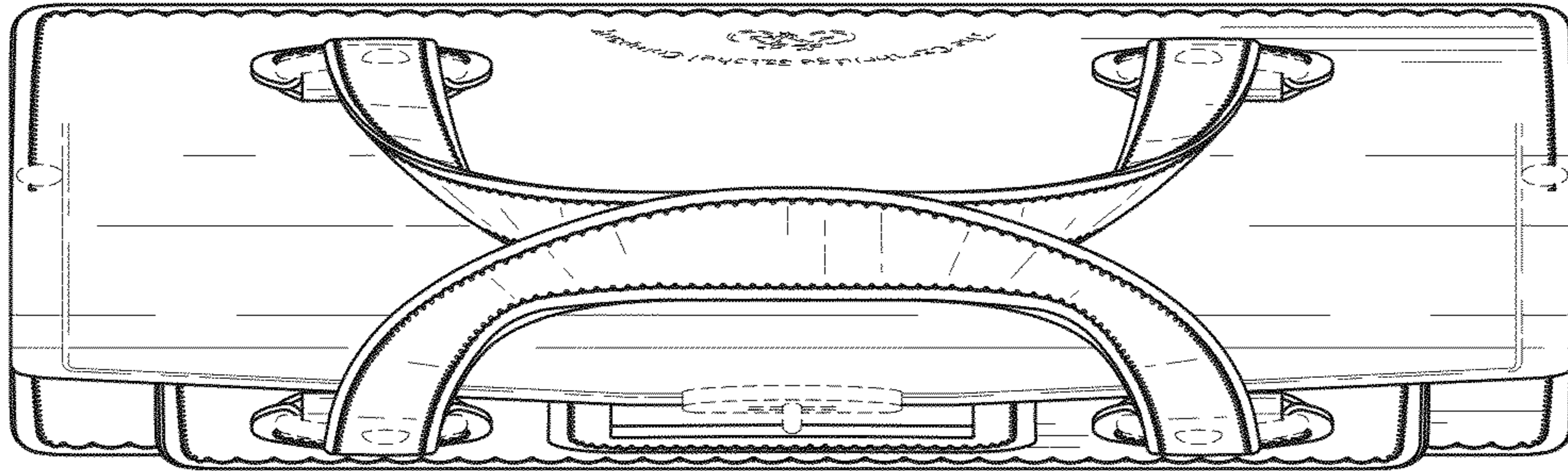

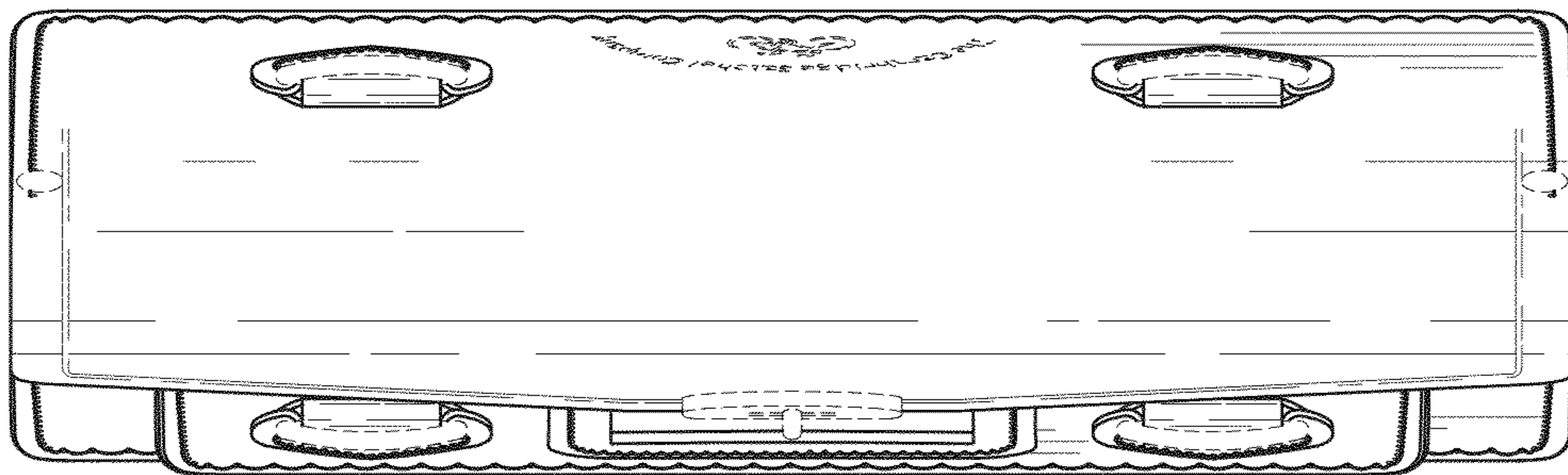

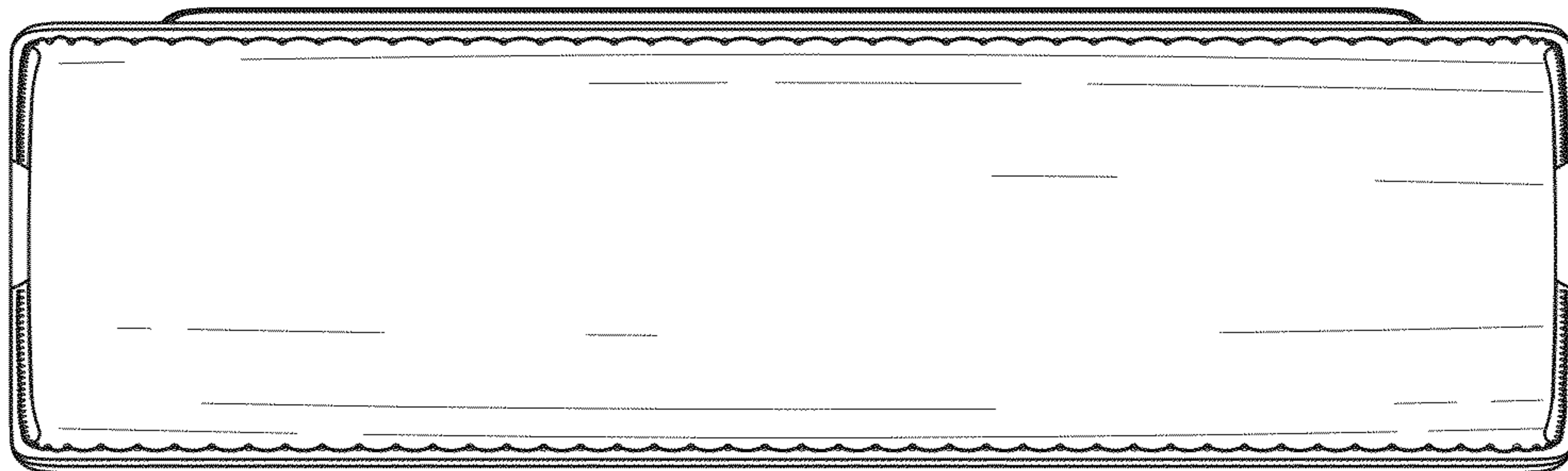
