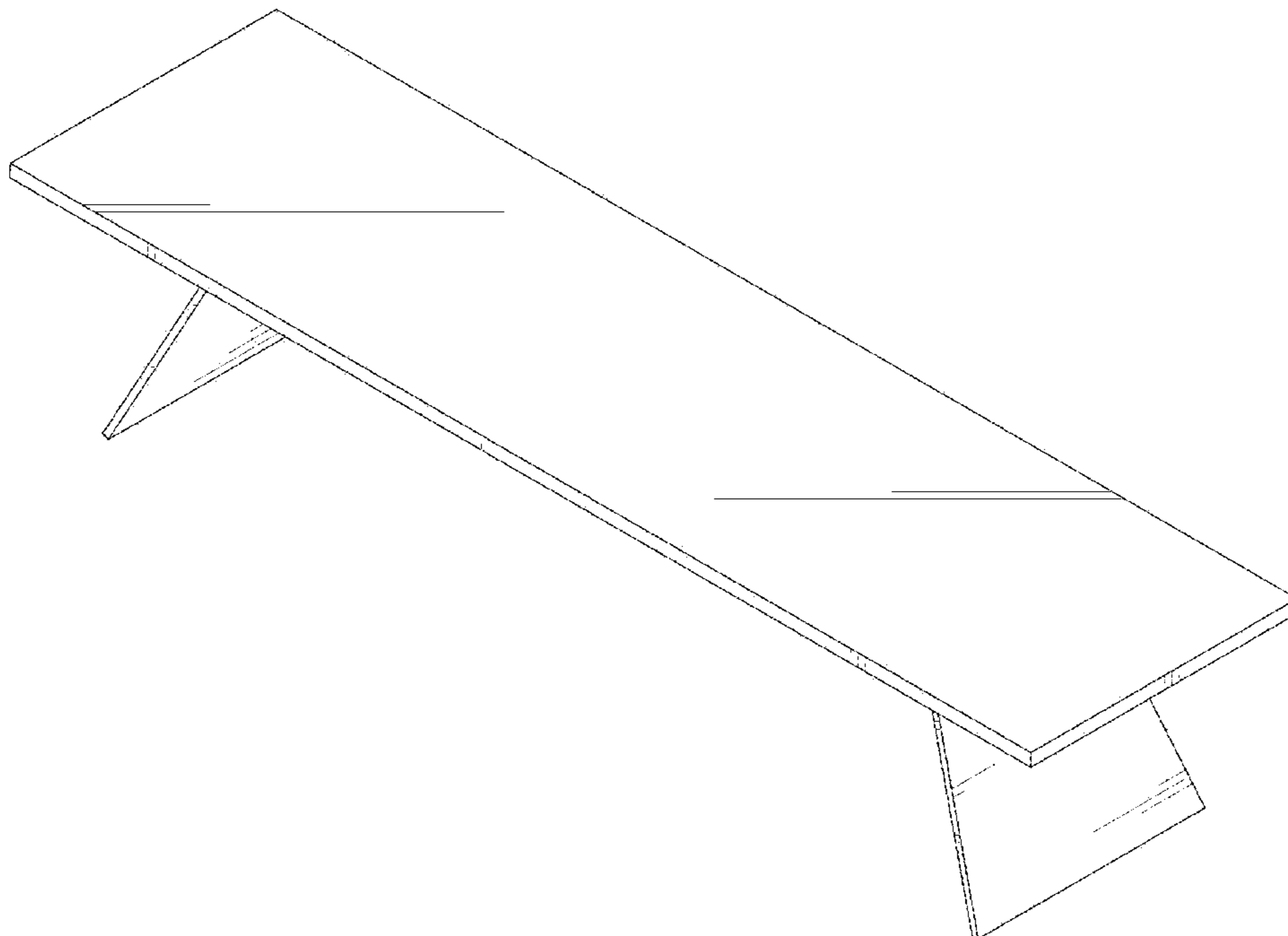

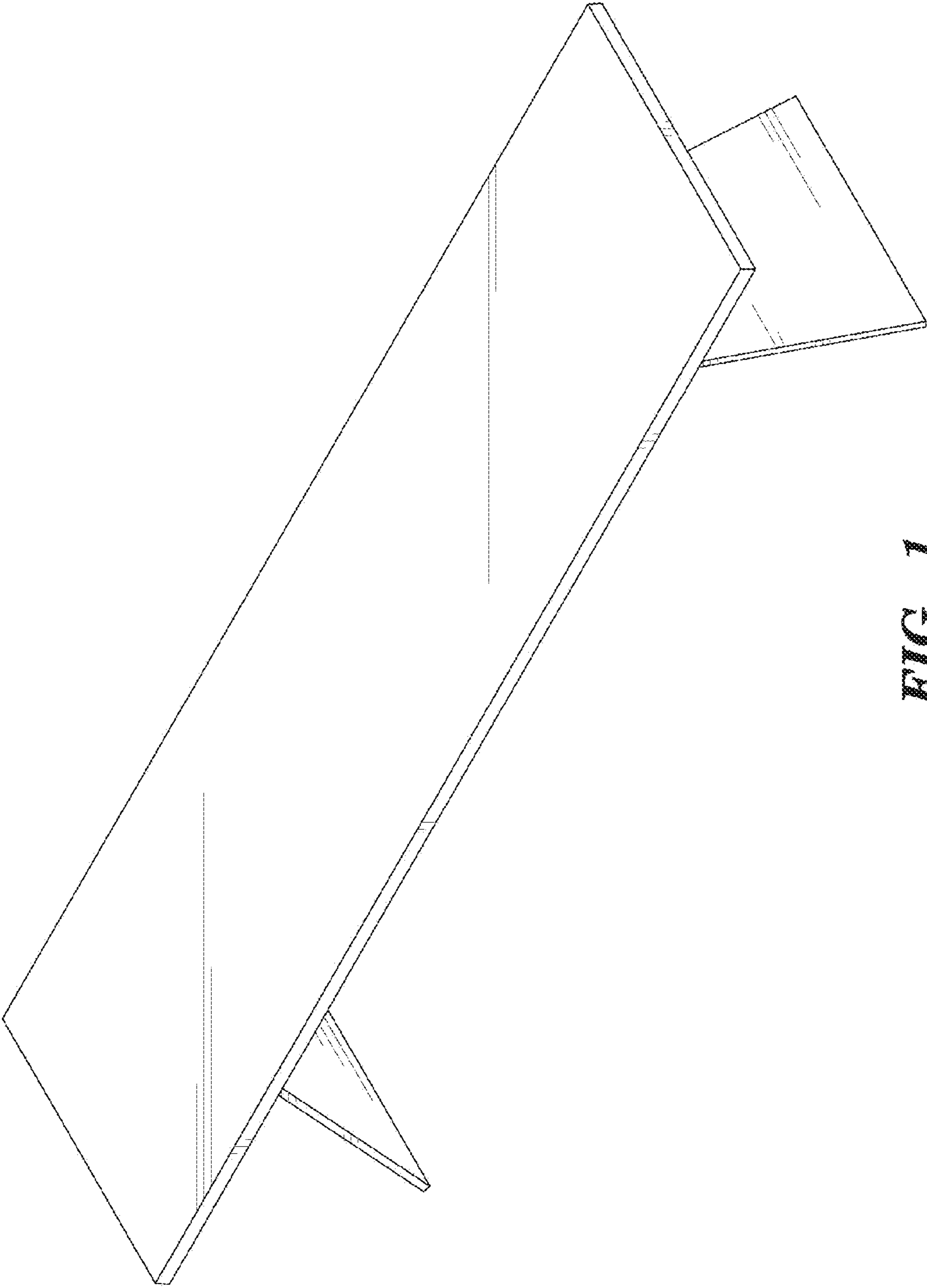
The ornamental design for a bench, as shown and described.

**DESCRIPTION**

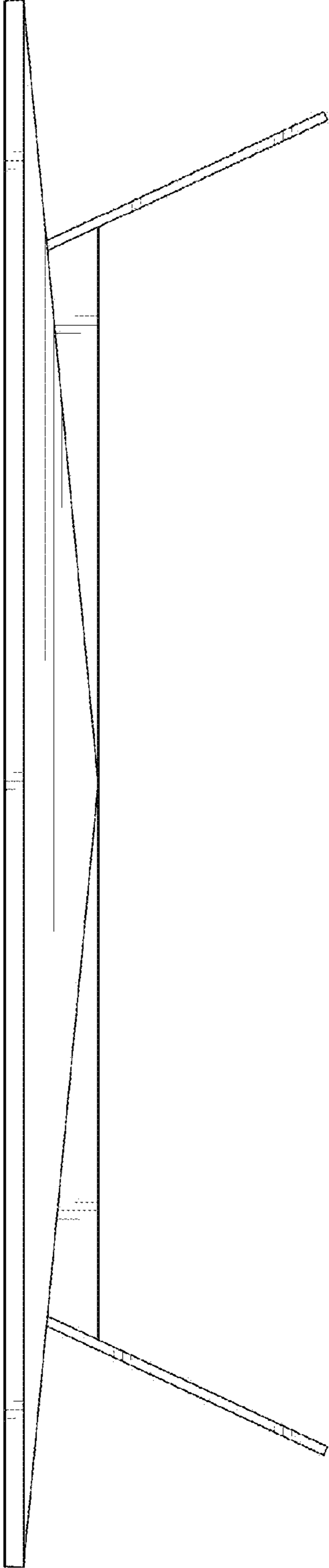
FIG. 1 is a front perspective view of the bench of the present invention;

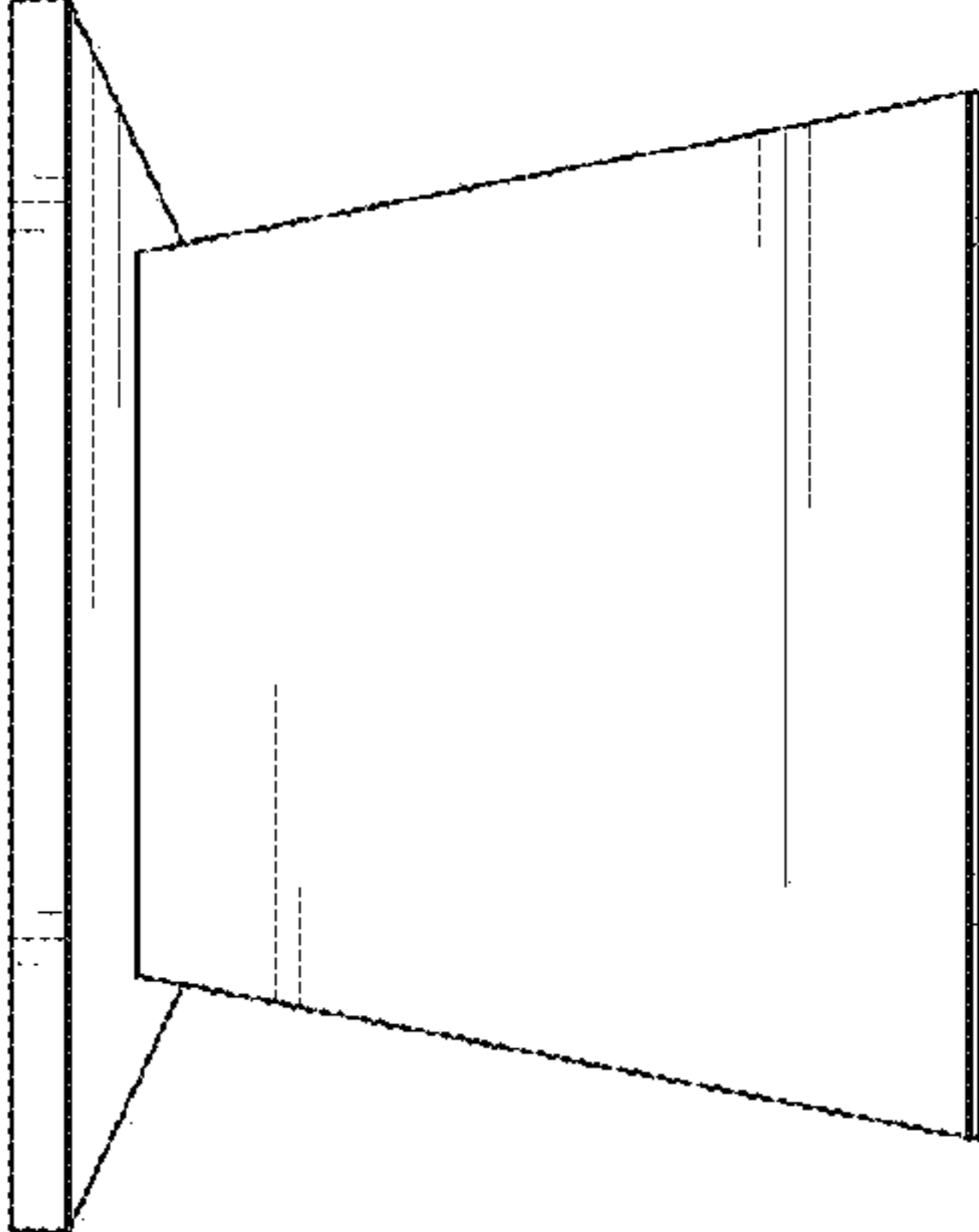




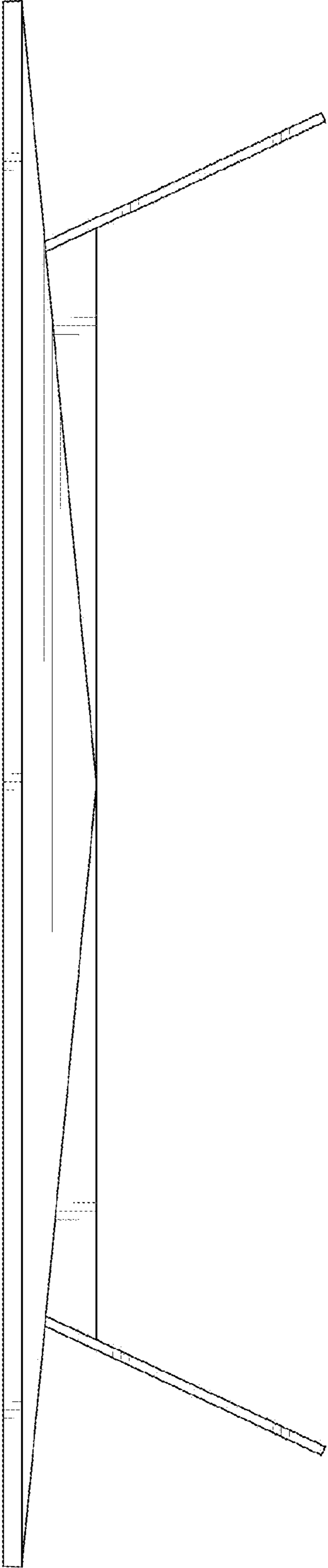

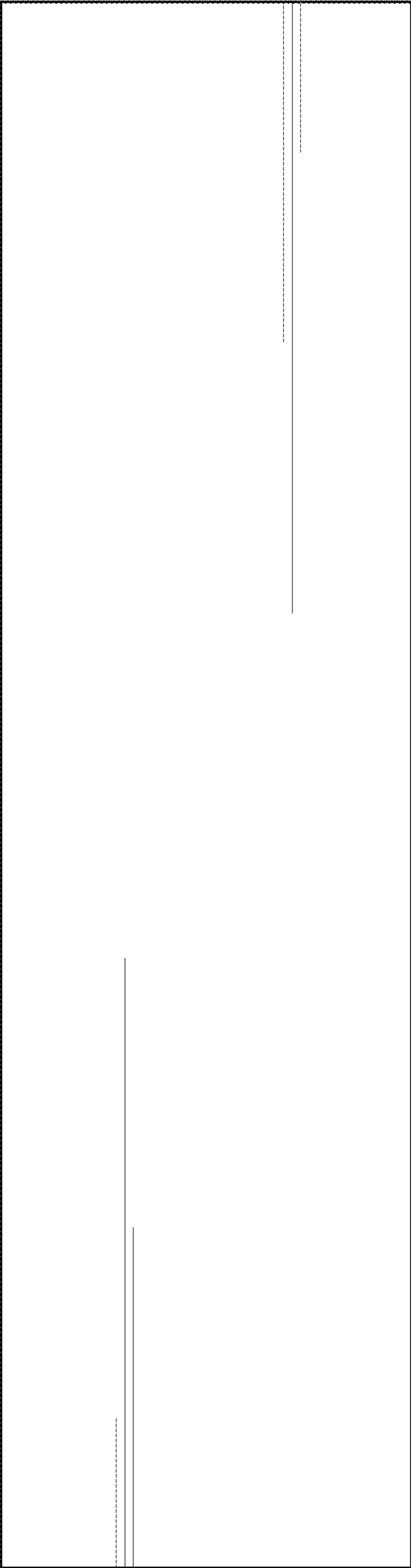
