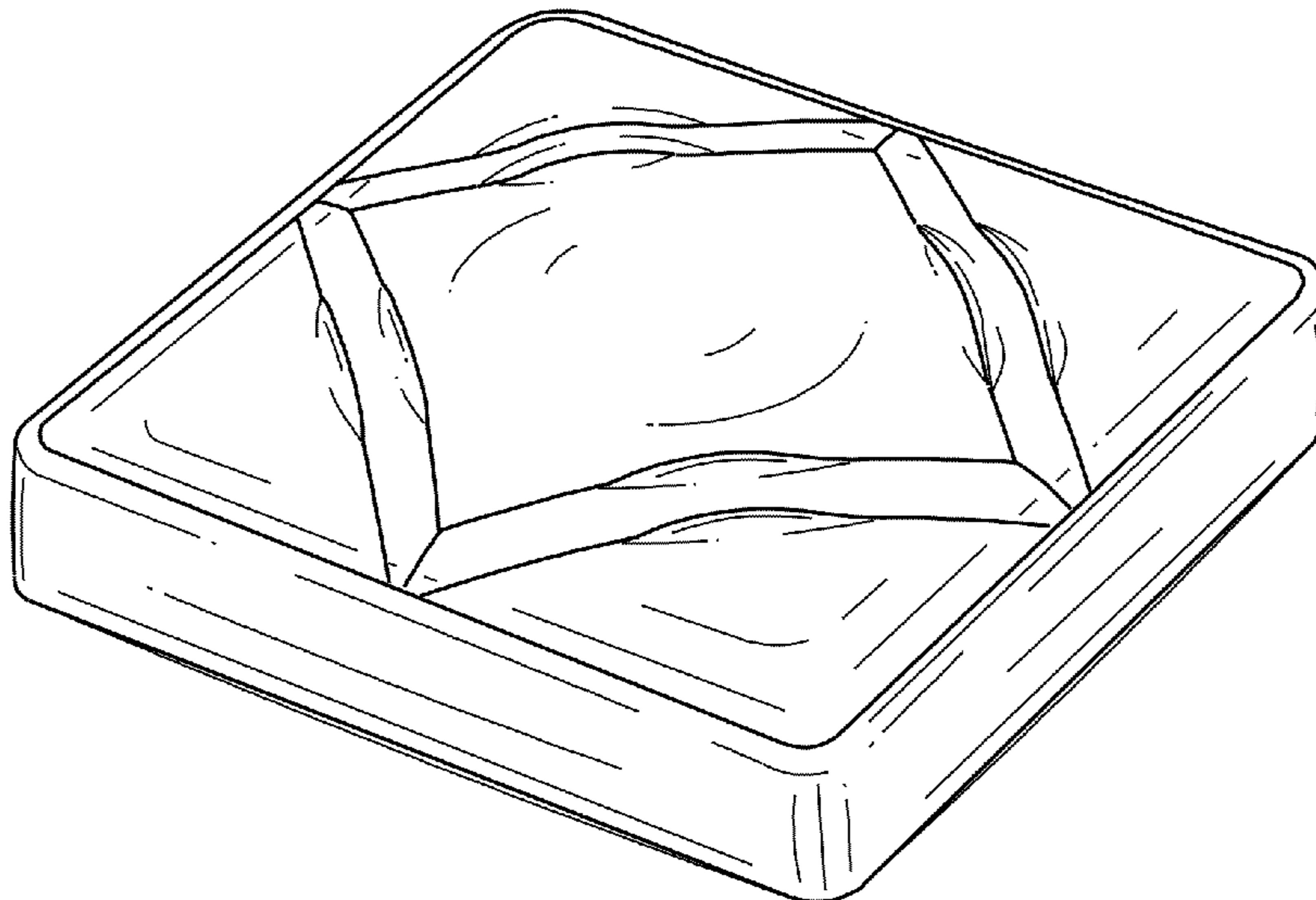
(57) **CLAIM**

The ornamental design for a tablet support pillow, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a tablet support pillow incorporating my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevation view thereof, wherein the back, right and left side elevation views are identical thereto; and,
FIG. 4 is a bottom plan view thereof.

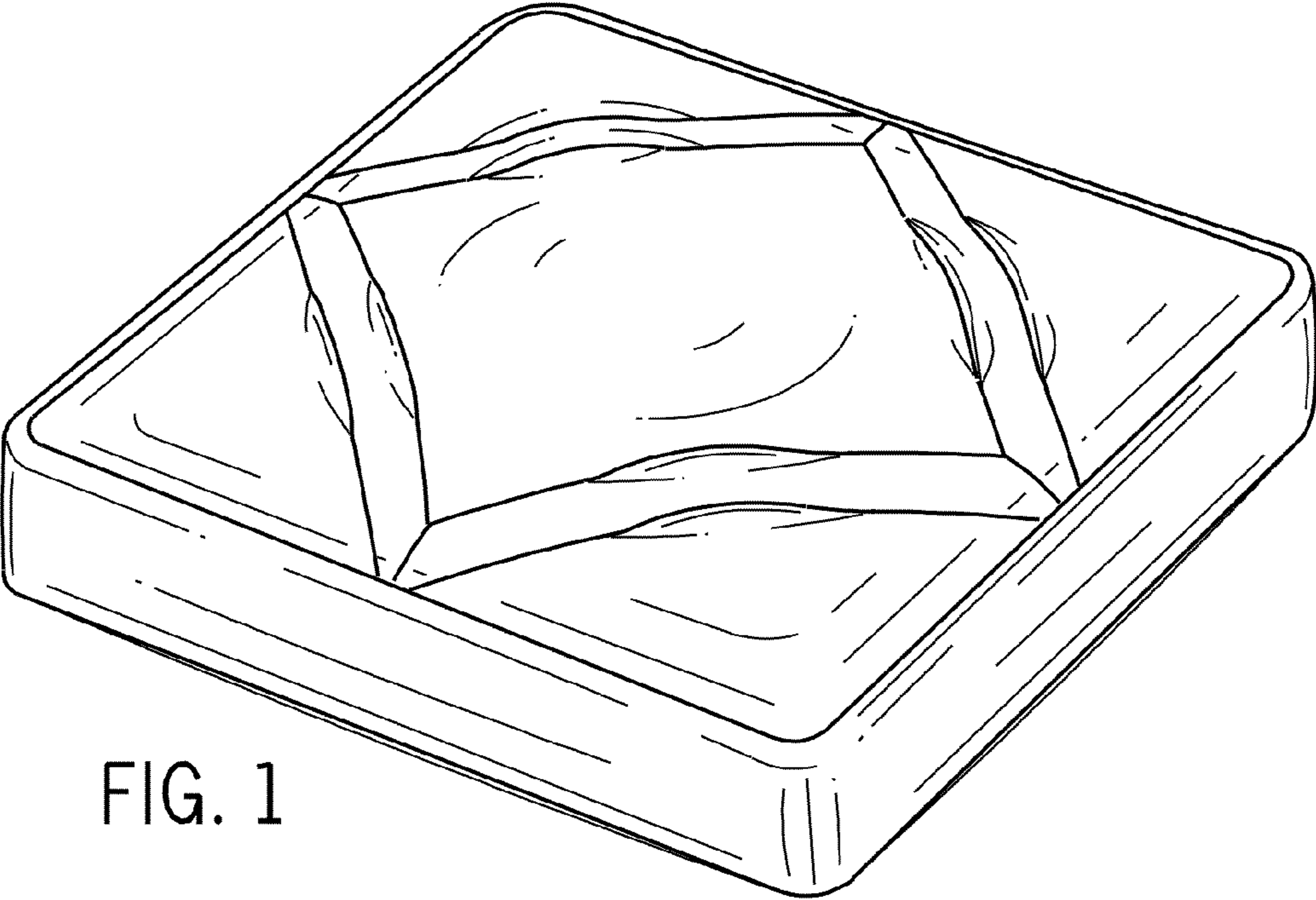

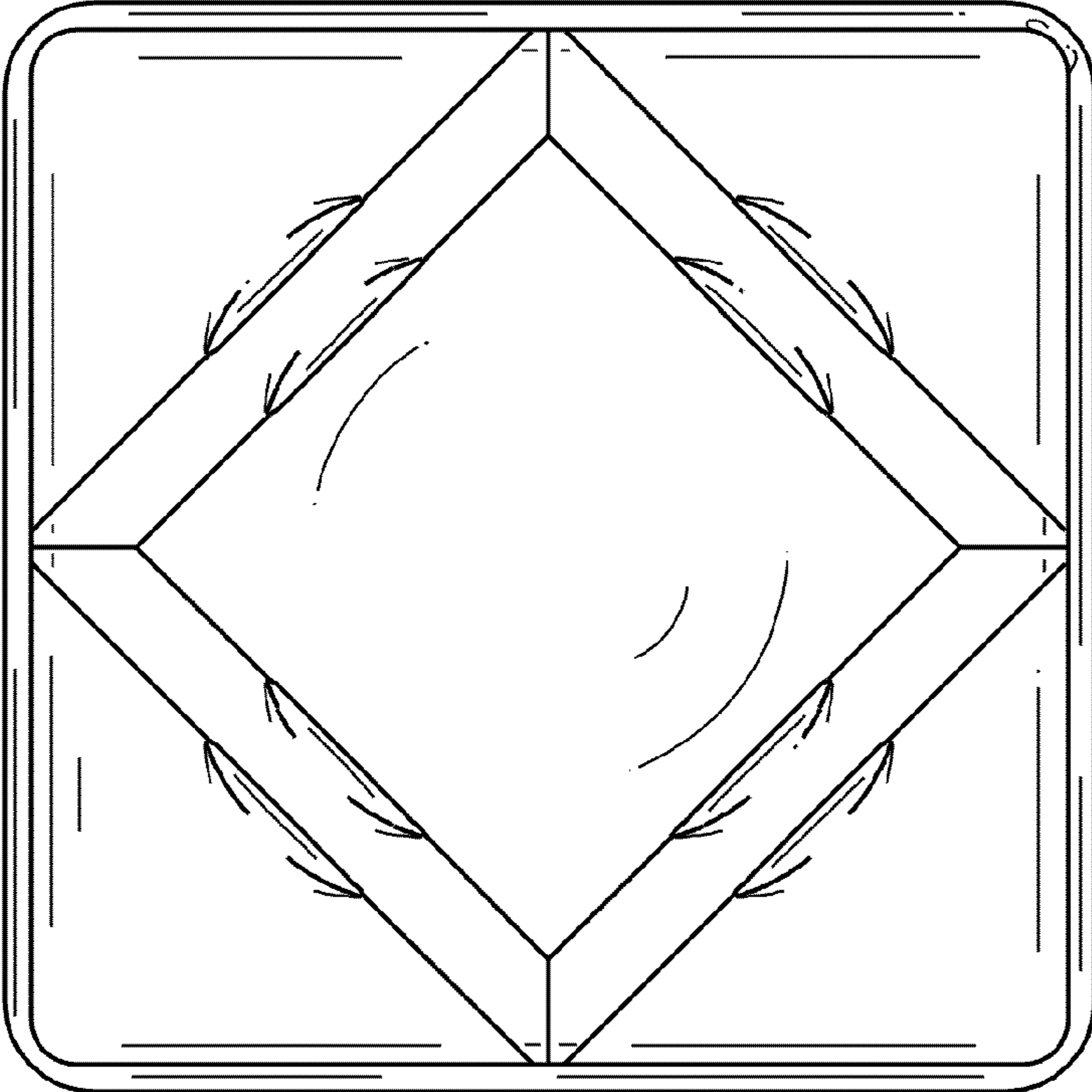

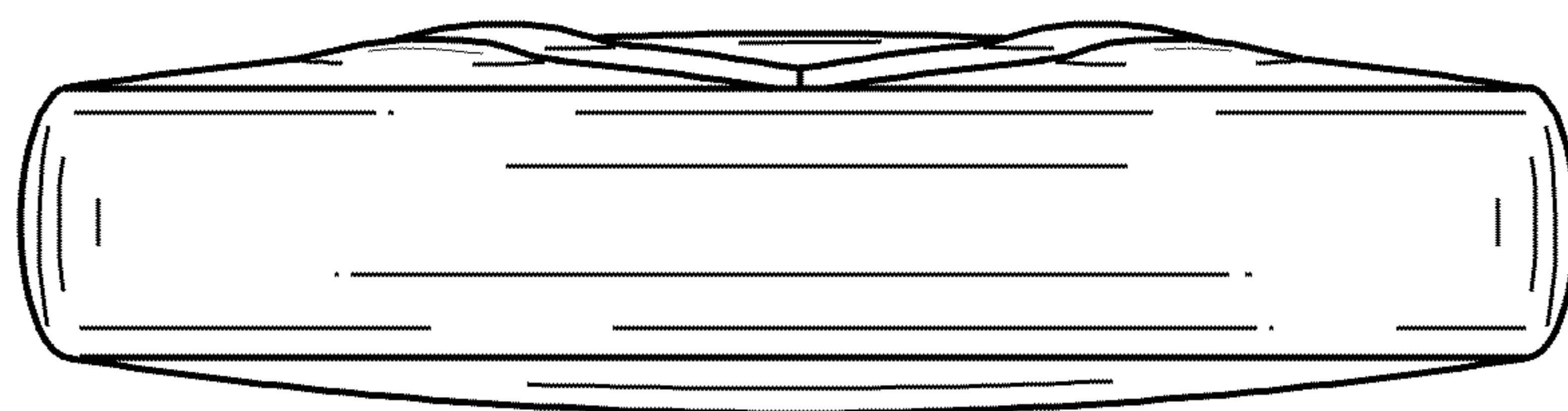

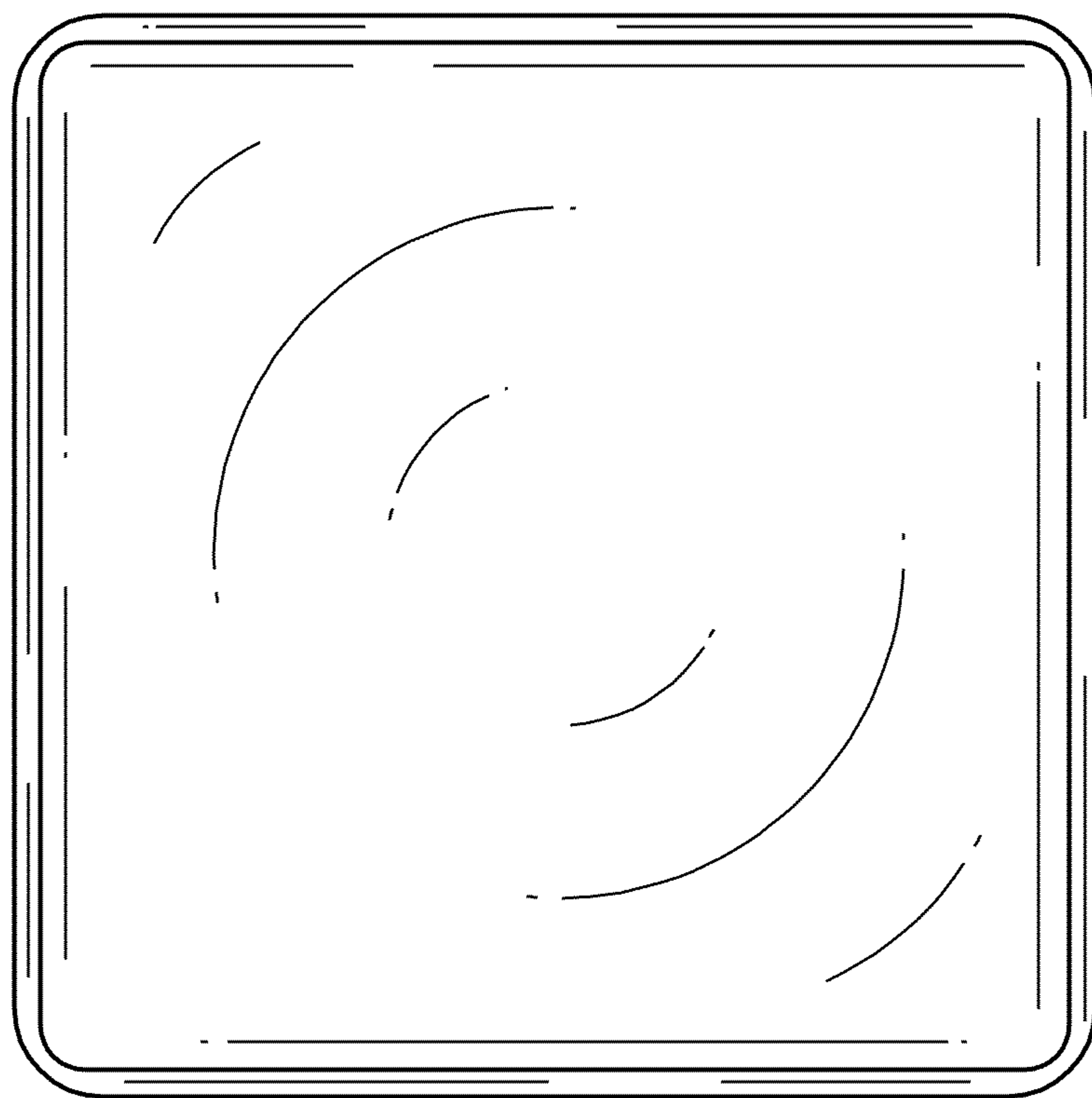
