**DESCRIPTION**

FIG. 3 is a another side elevation of the pillow of FIG. 1, which is the opposite side of that shown in FIG. 2;

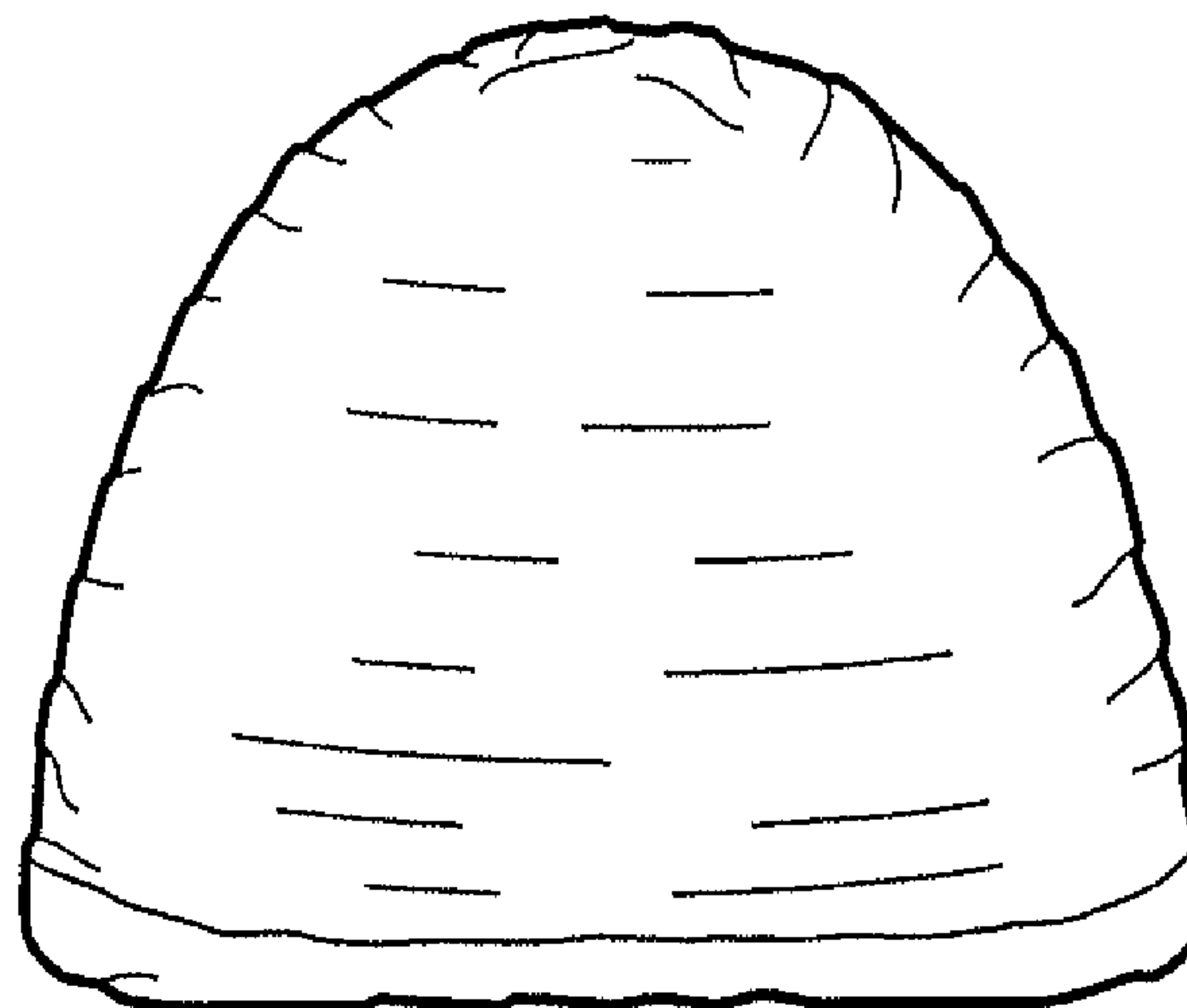
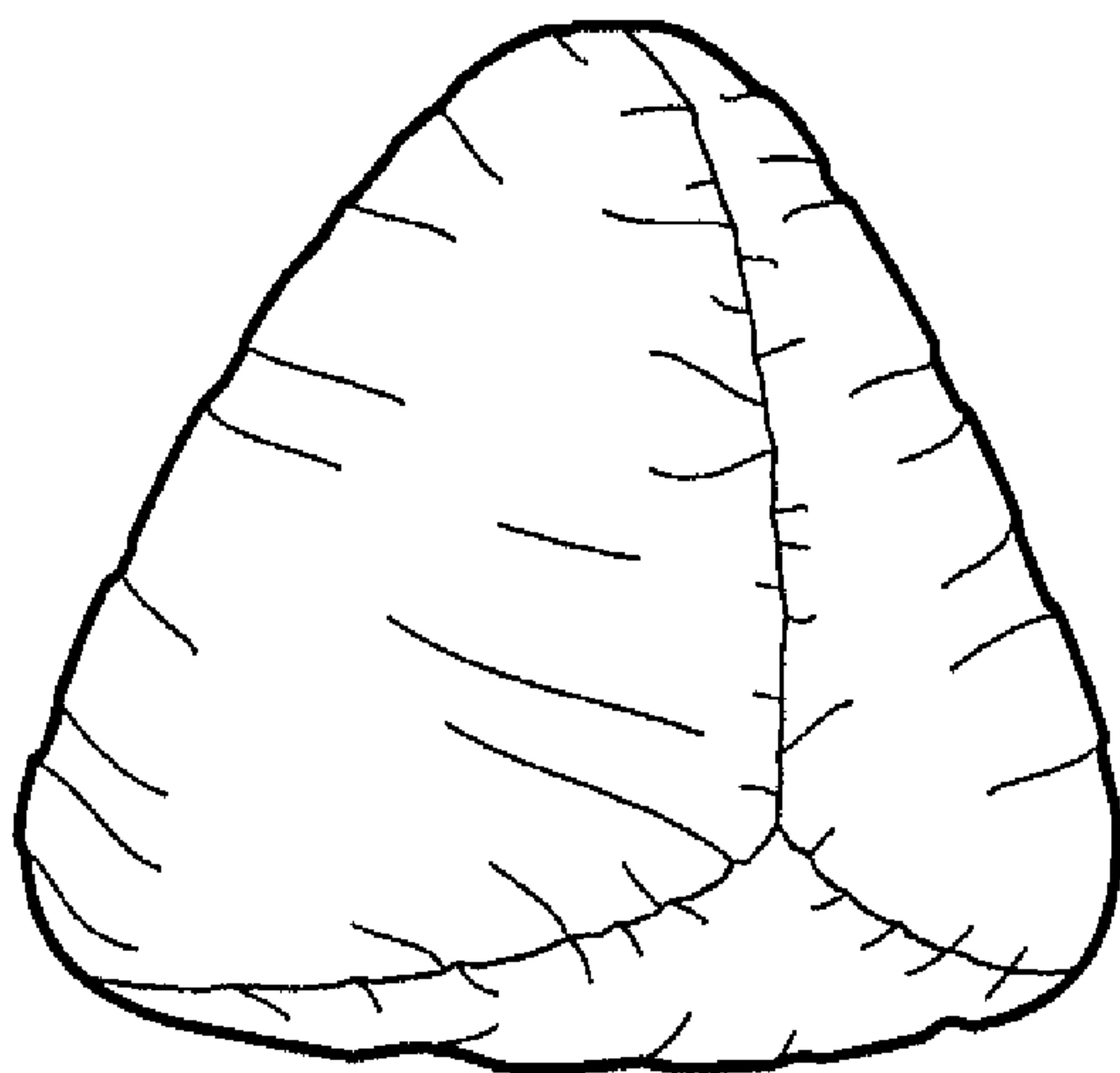
FIG. 4 is front elevation of the pillow of FIG. 1;

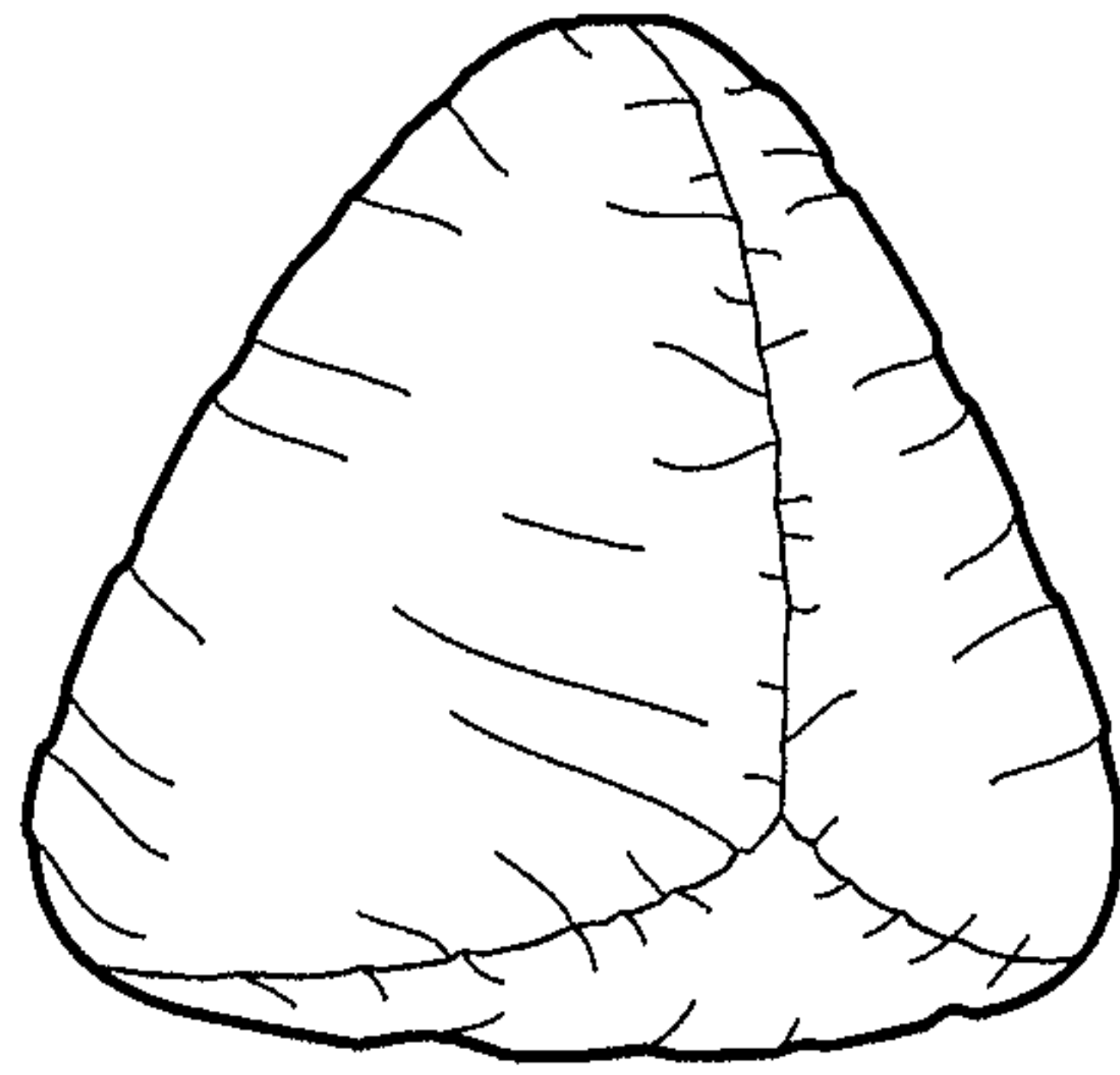

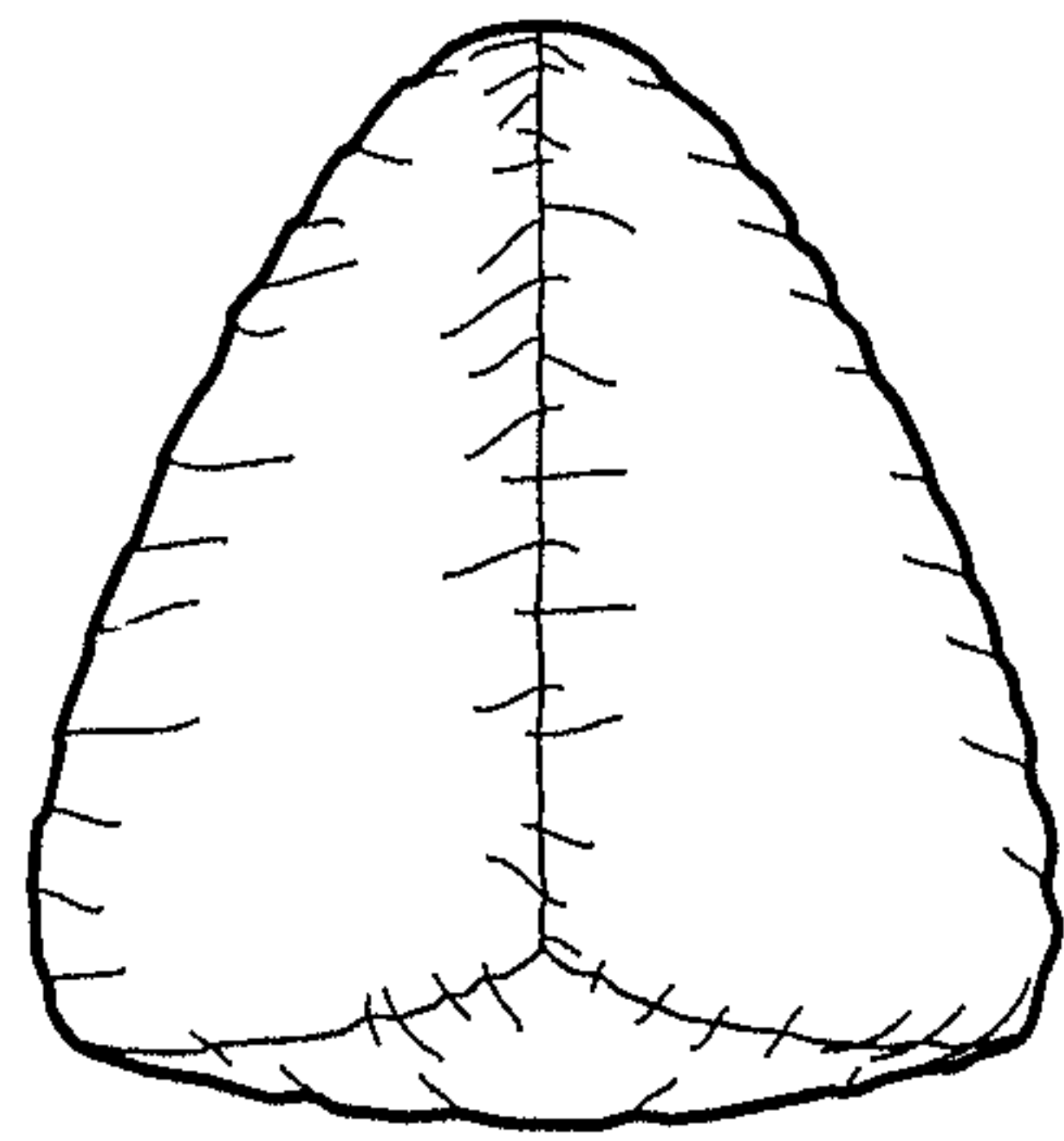

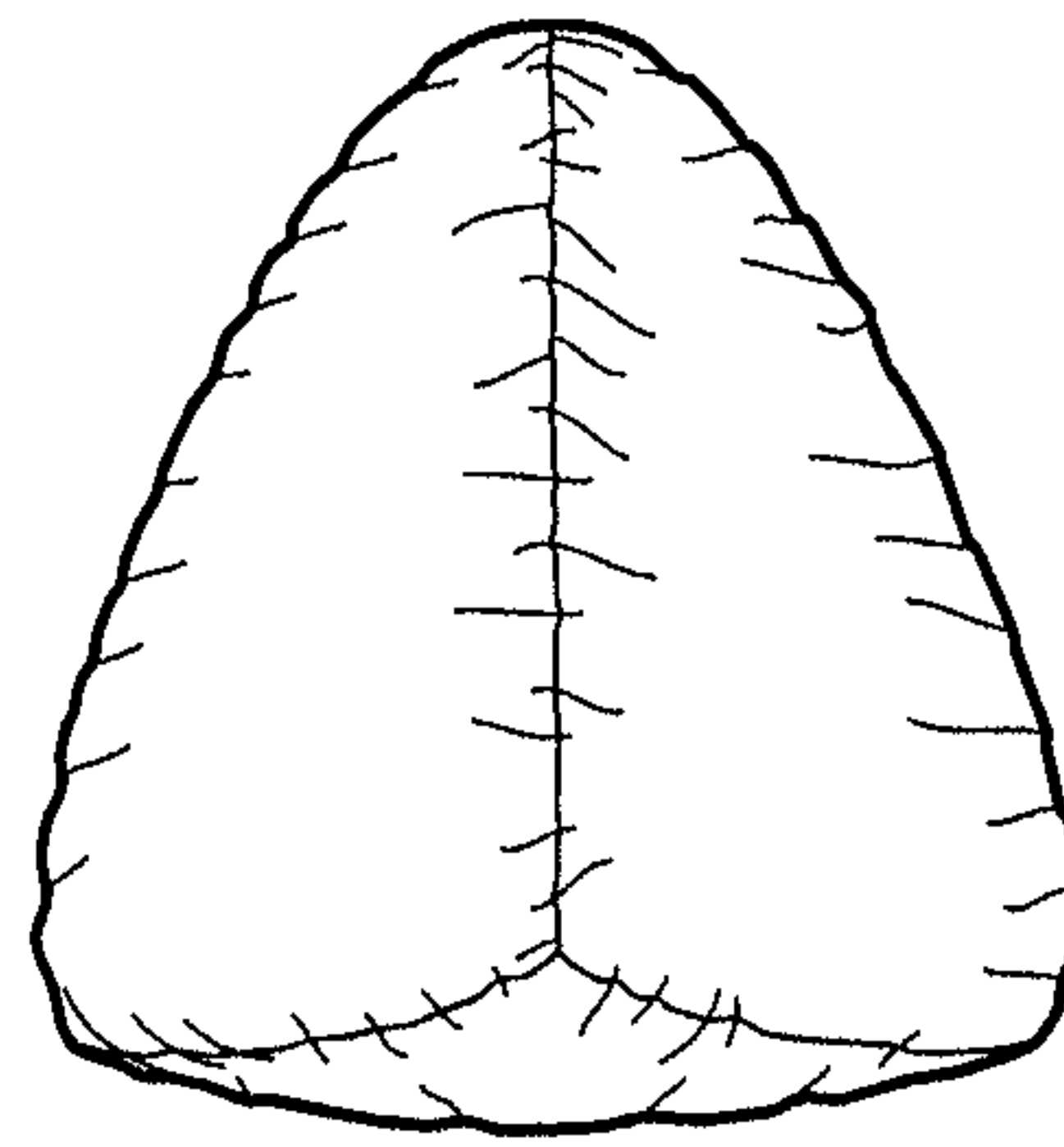

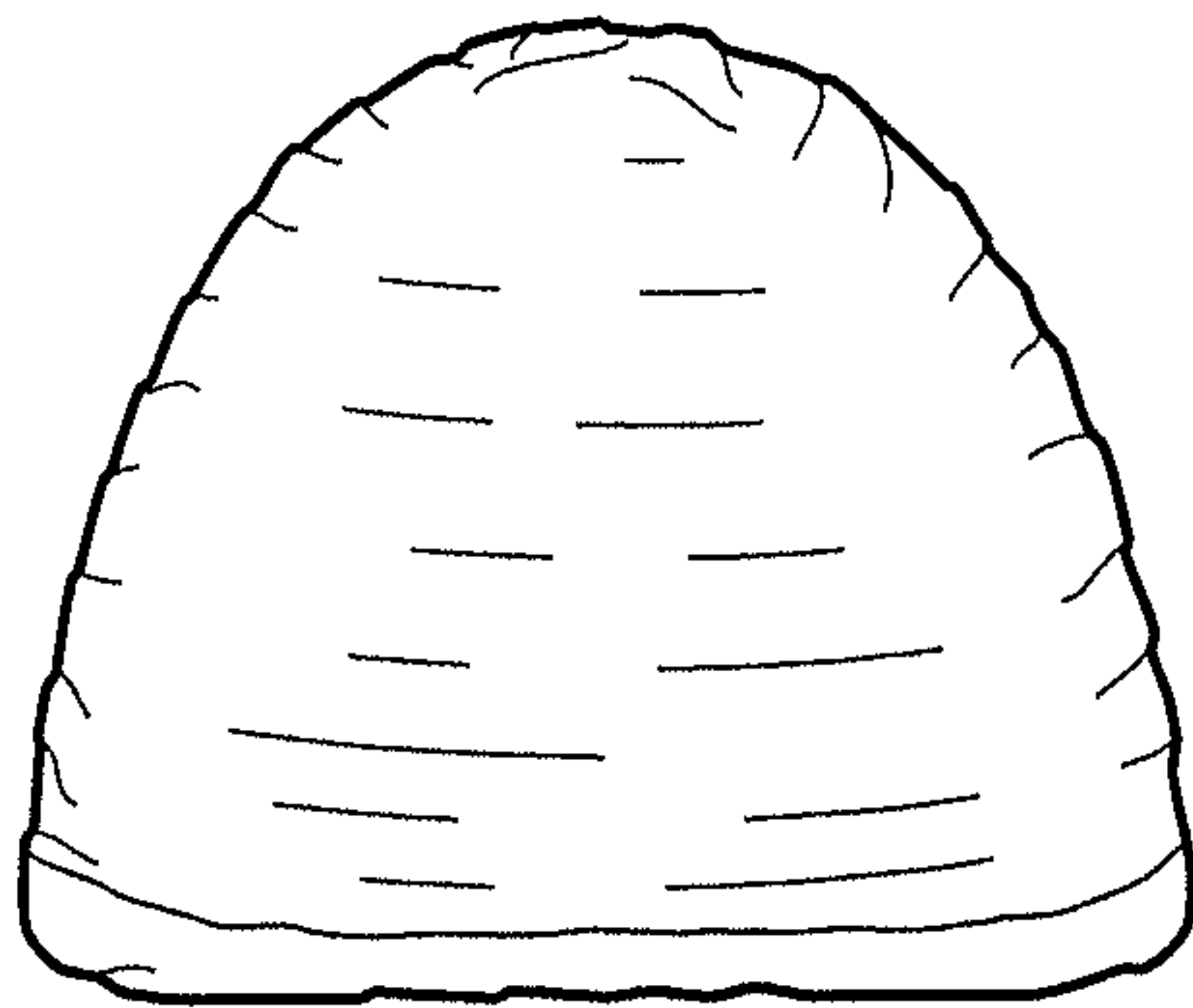

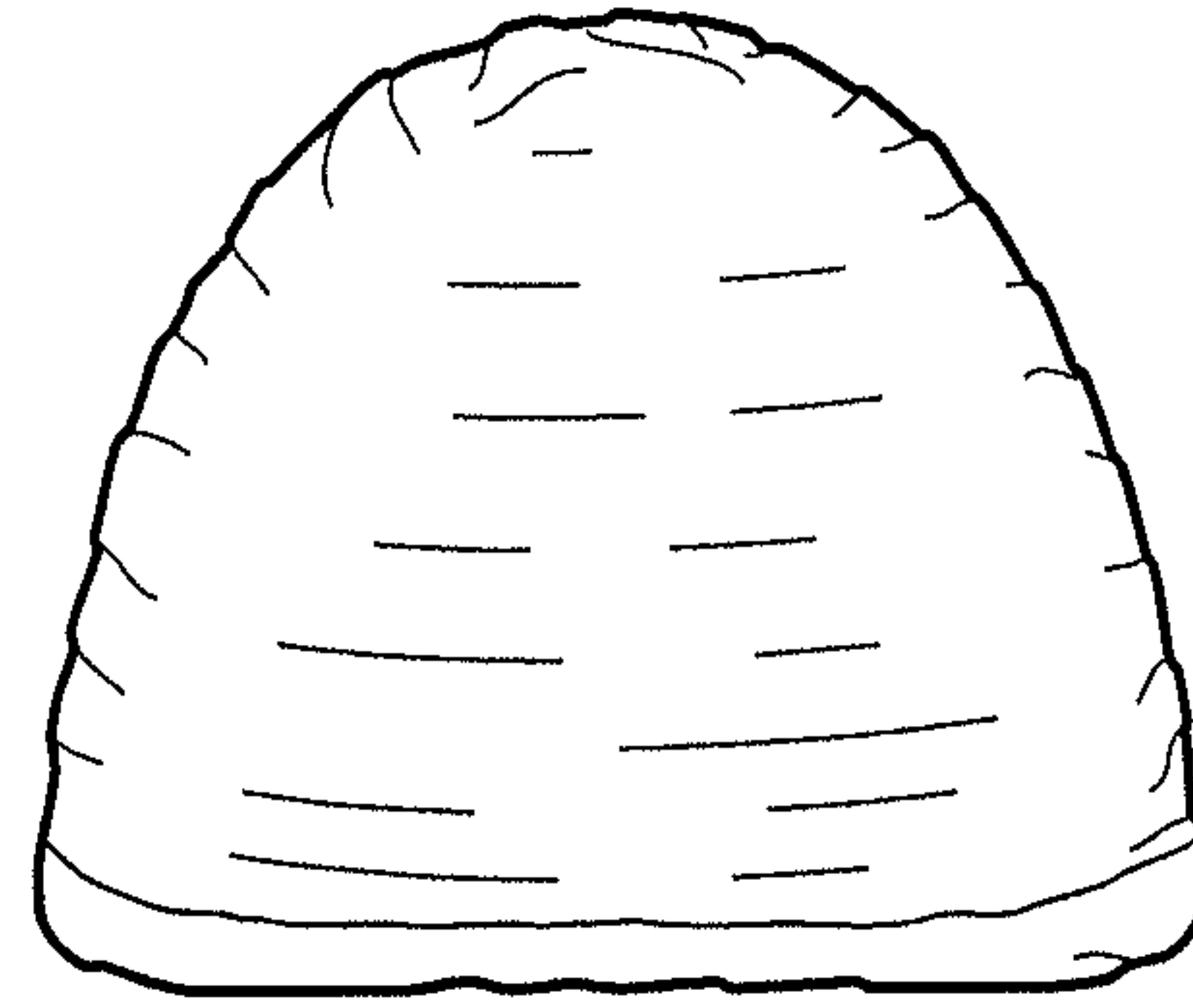

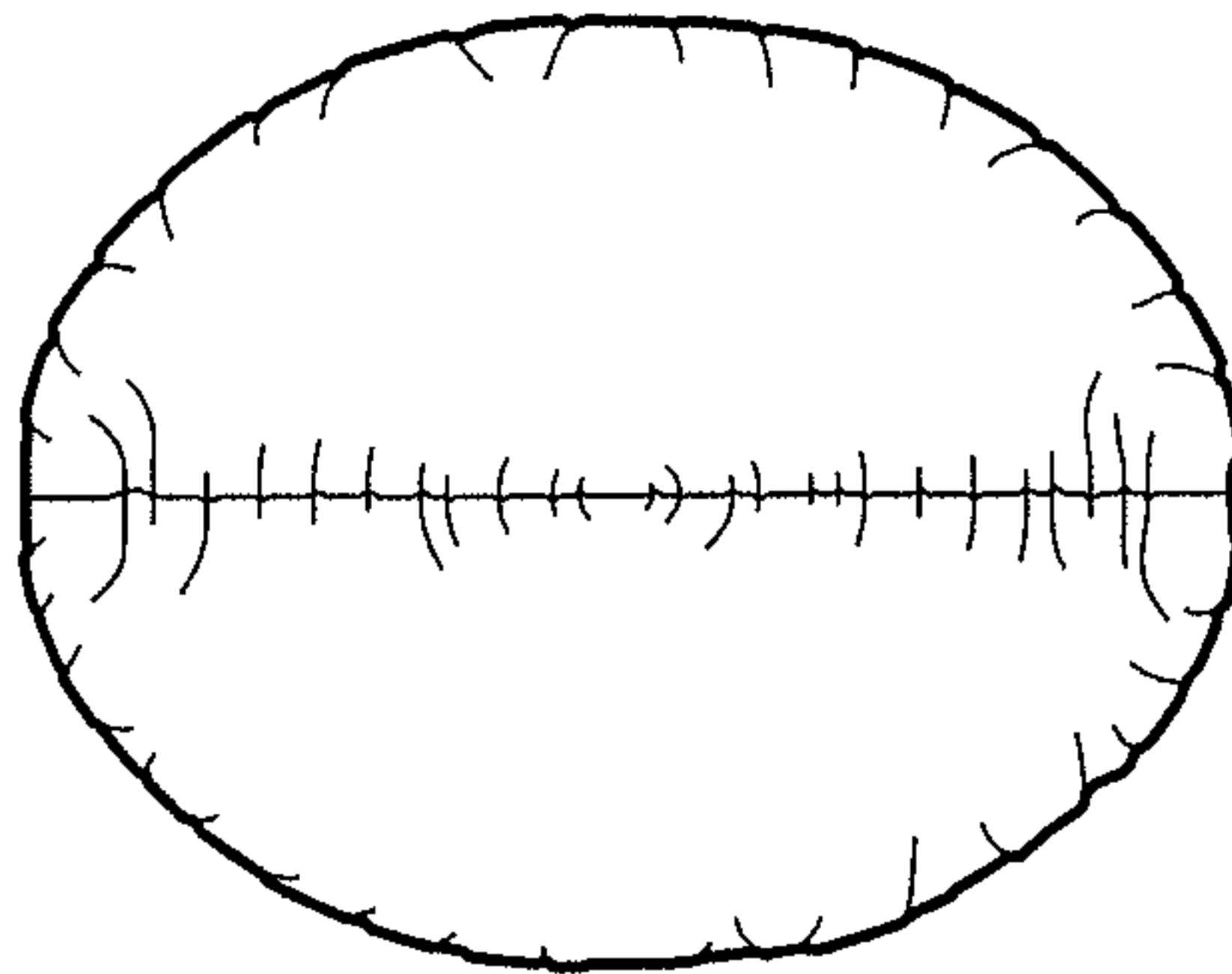

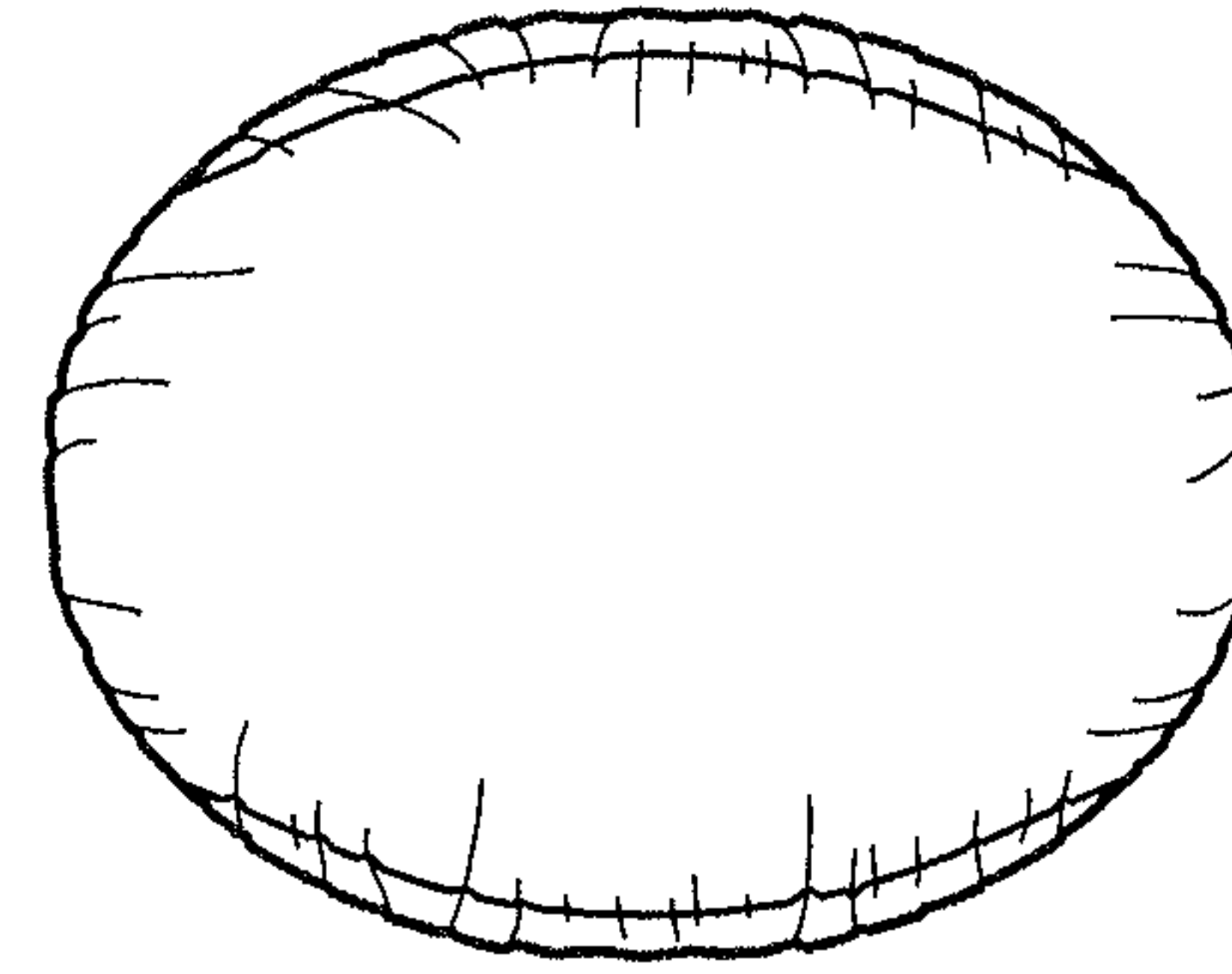
