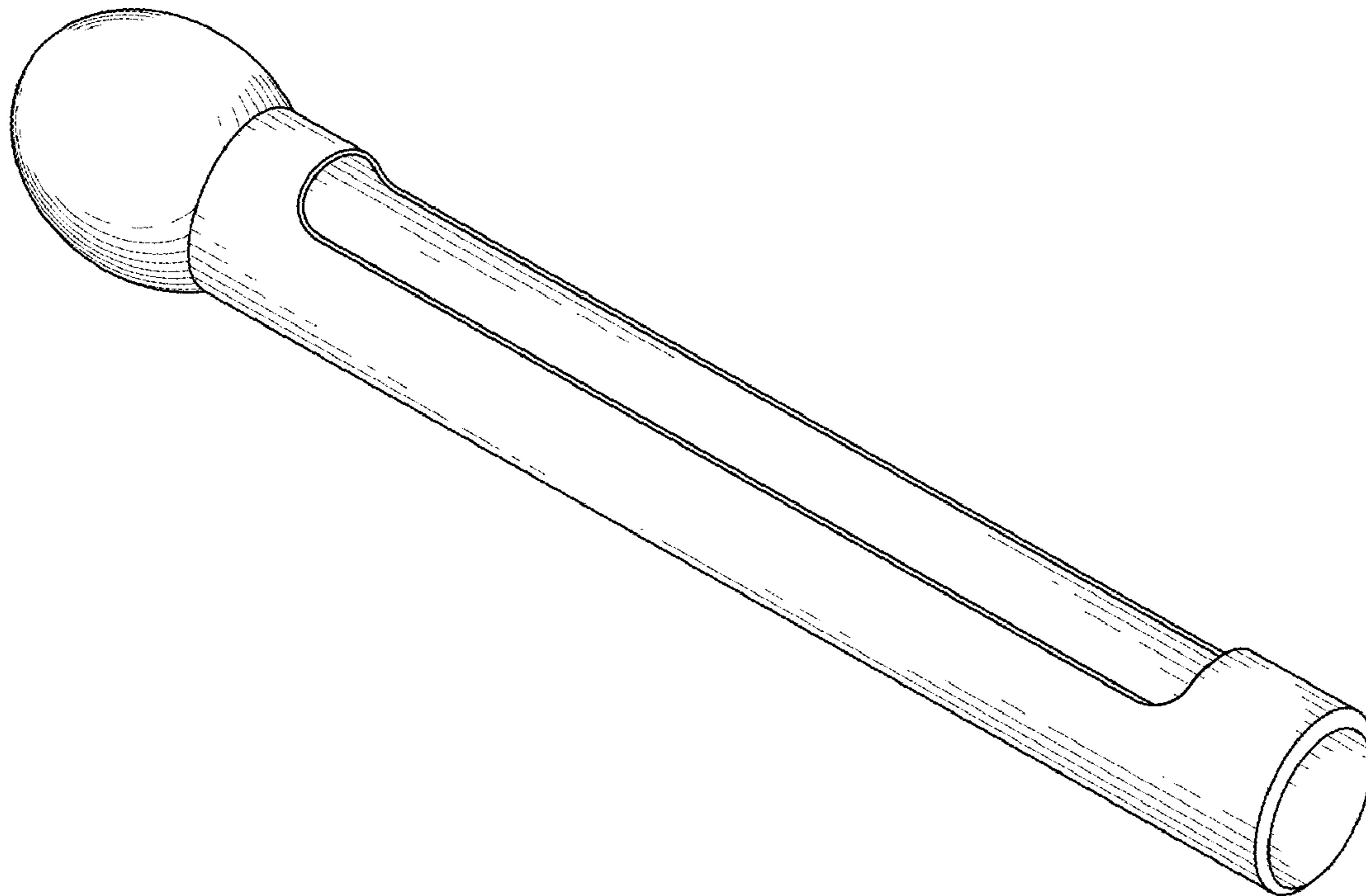

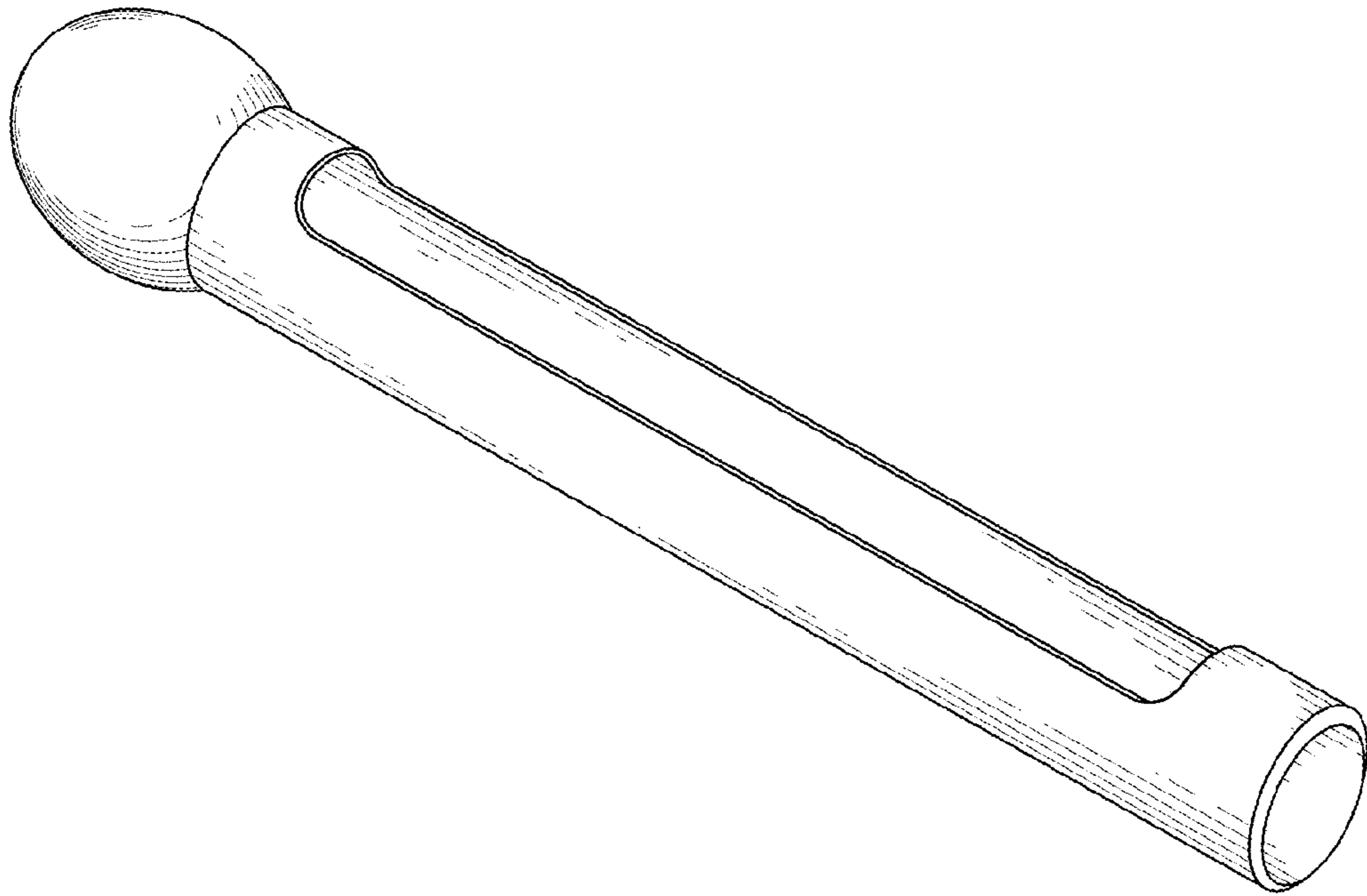
The ornamental design for a coring tool, as shown and described.

**DESCRIPTION**

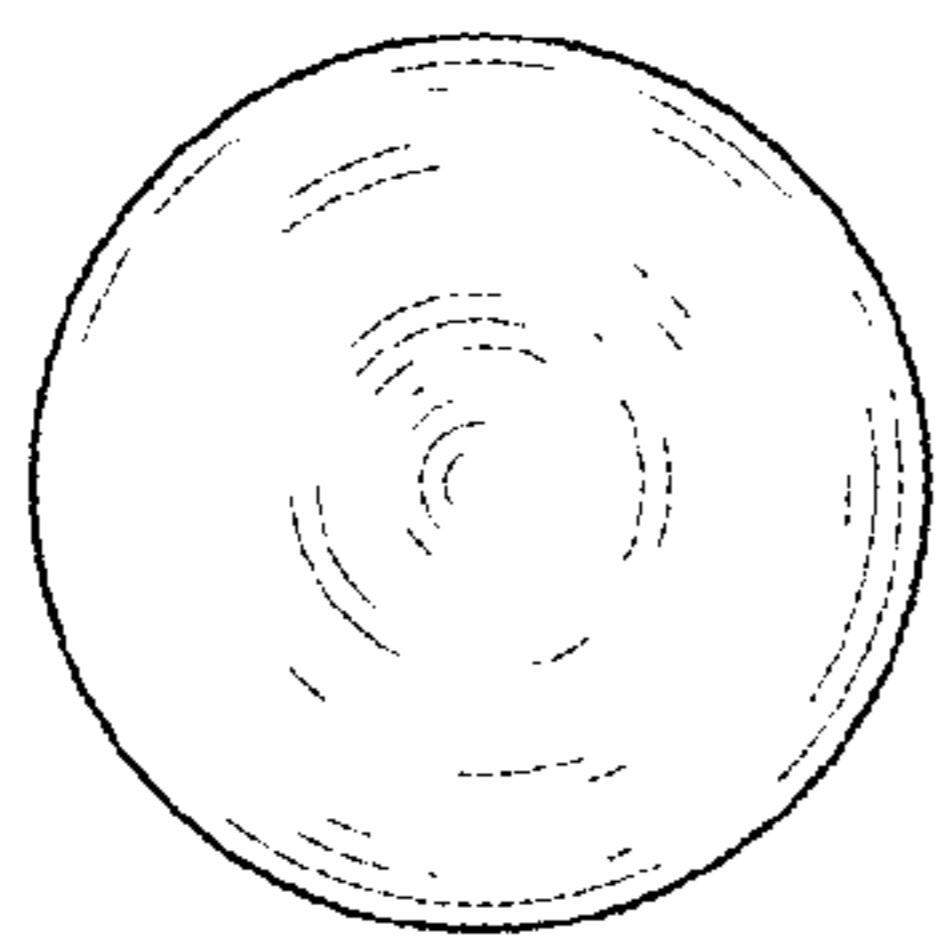
FIG. 1 is a front perspective view of a coring tool showing the new design;

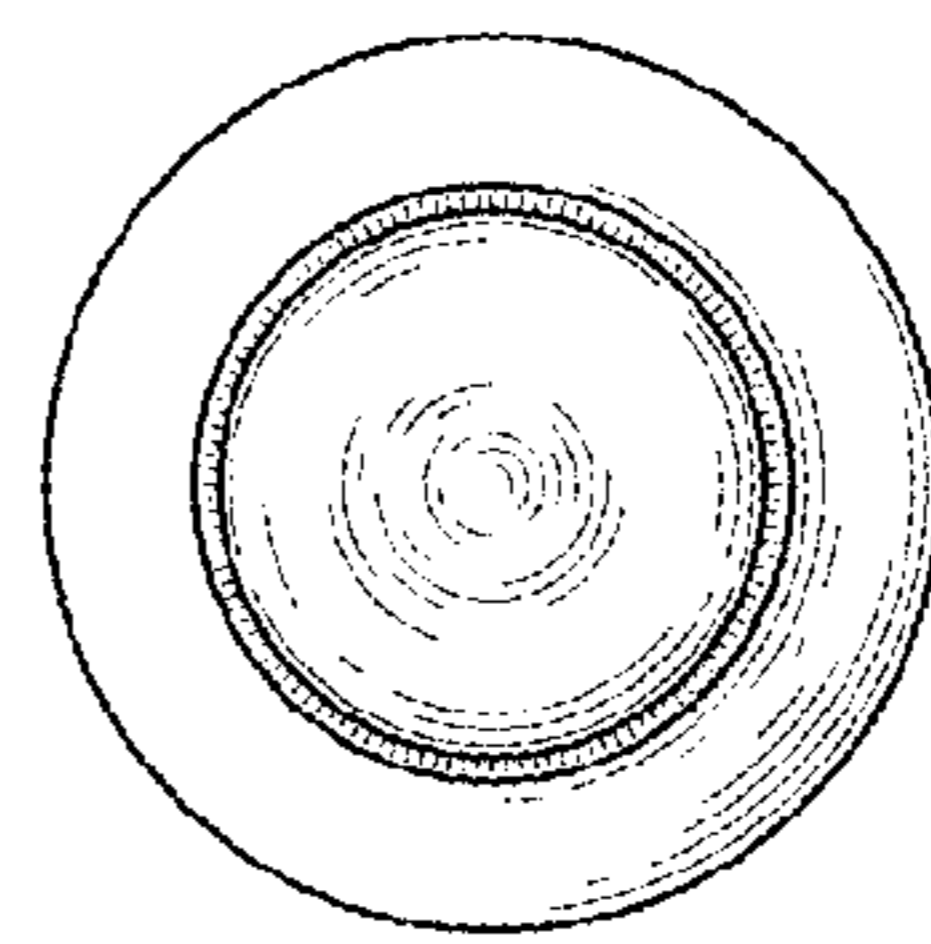




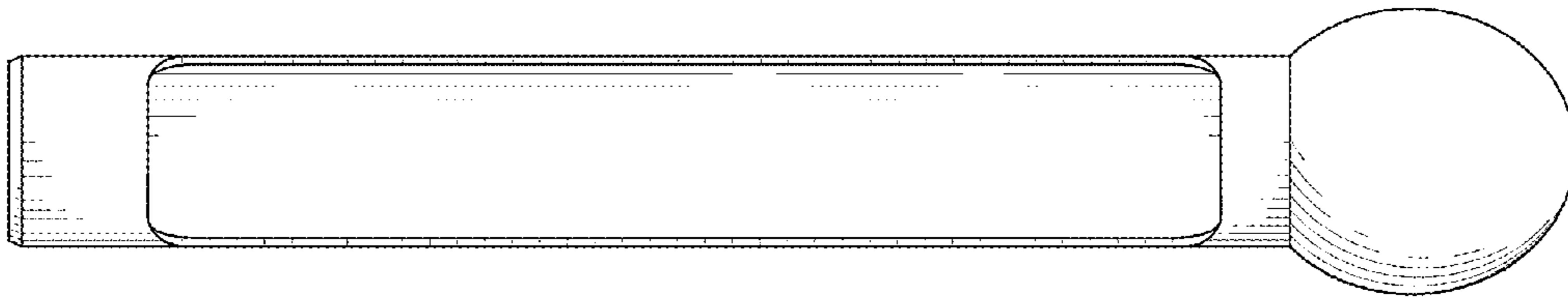

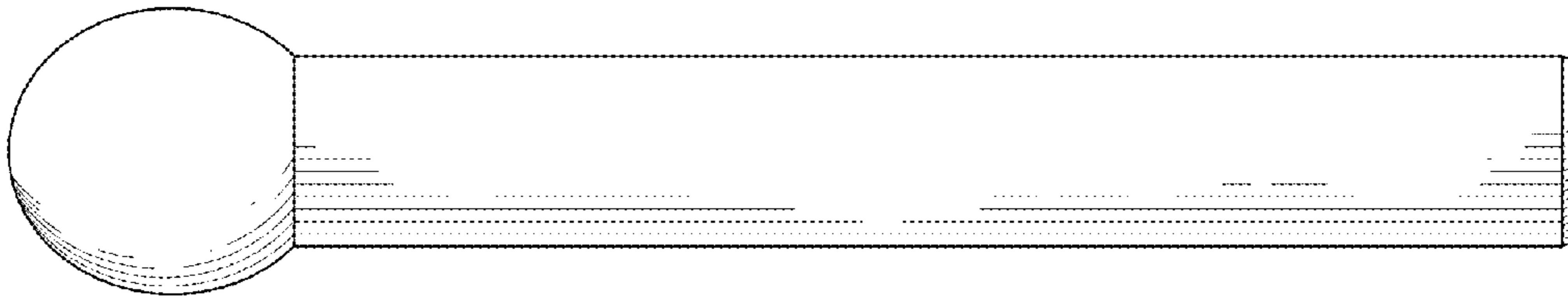

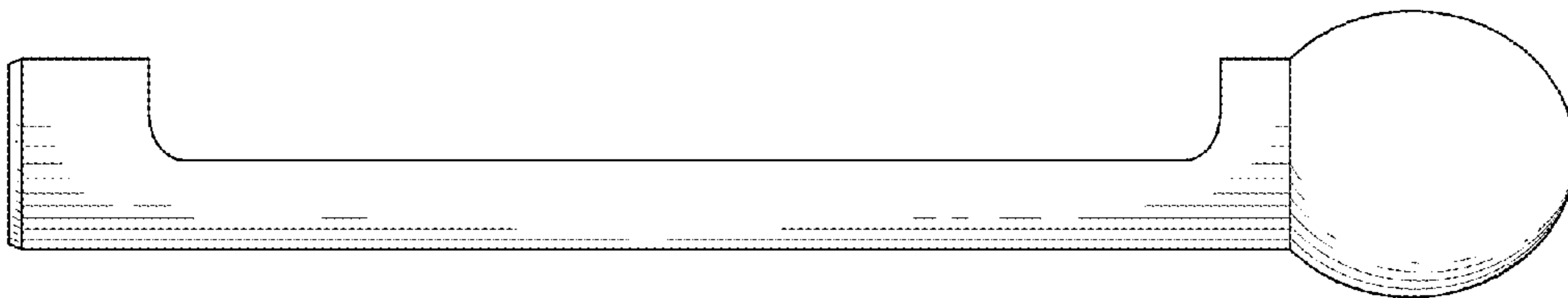

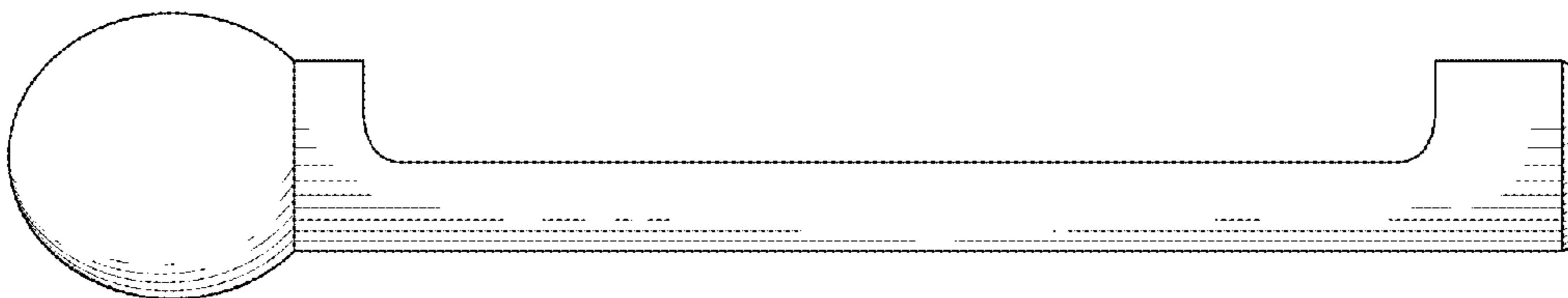
