(57) **CLAIM**

The ornamental design for shock-absorbing gardening tool set, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shock-absorbing gardening tool set of the present invention with a fork head fitted; FIG. 2 is a front perspective view of the shock-absorbing gardening tool set of the present invention with a spade head fitted;

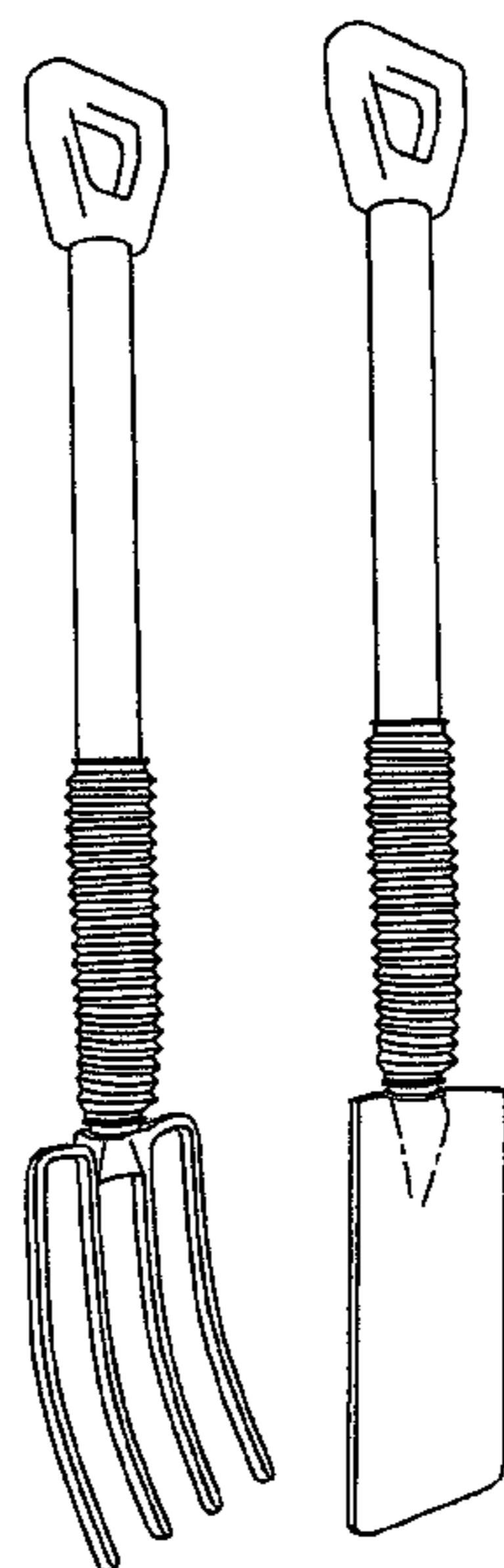
FIG. 3 is a front perspective view of the handle stem portion of the gardening tool set of the present invention, separated from the tool for ease of illustration;

FIG. 4 is a front perspective view of the spade head portion of the gardening tool set of the present invention, separated from the tool for ease of illustration; and,

FIG. 5 is a front perspective view of the fork head portion of the gardening tool set of the present invention, separated from the tool for ease of illustration.

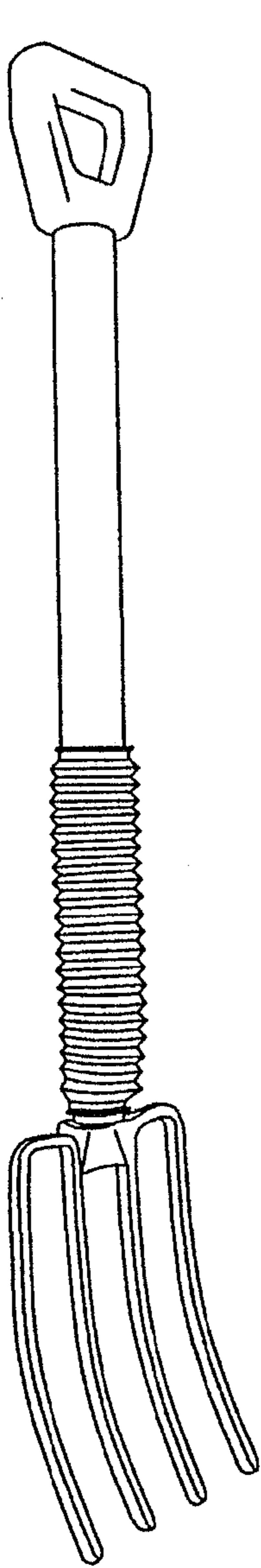

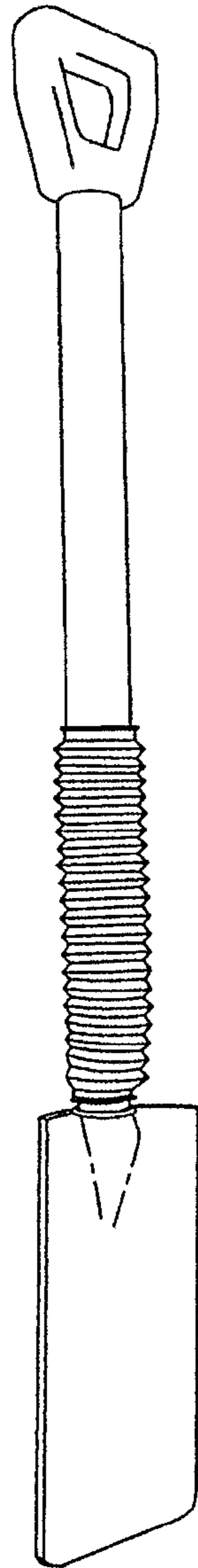

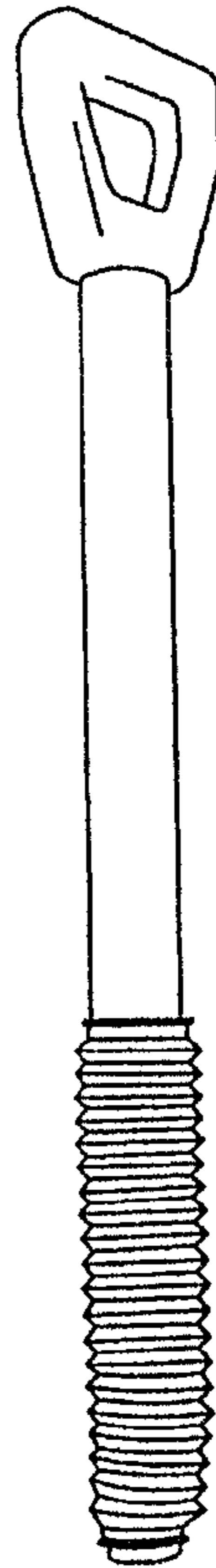

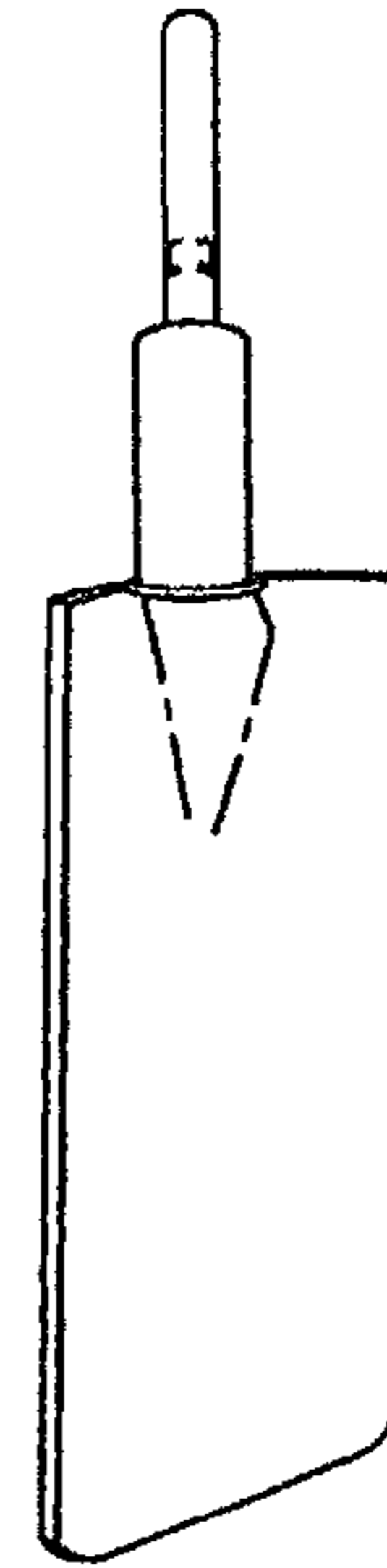

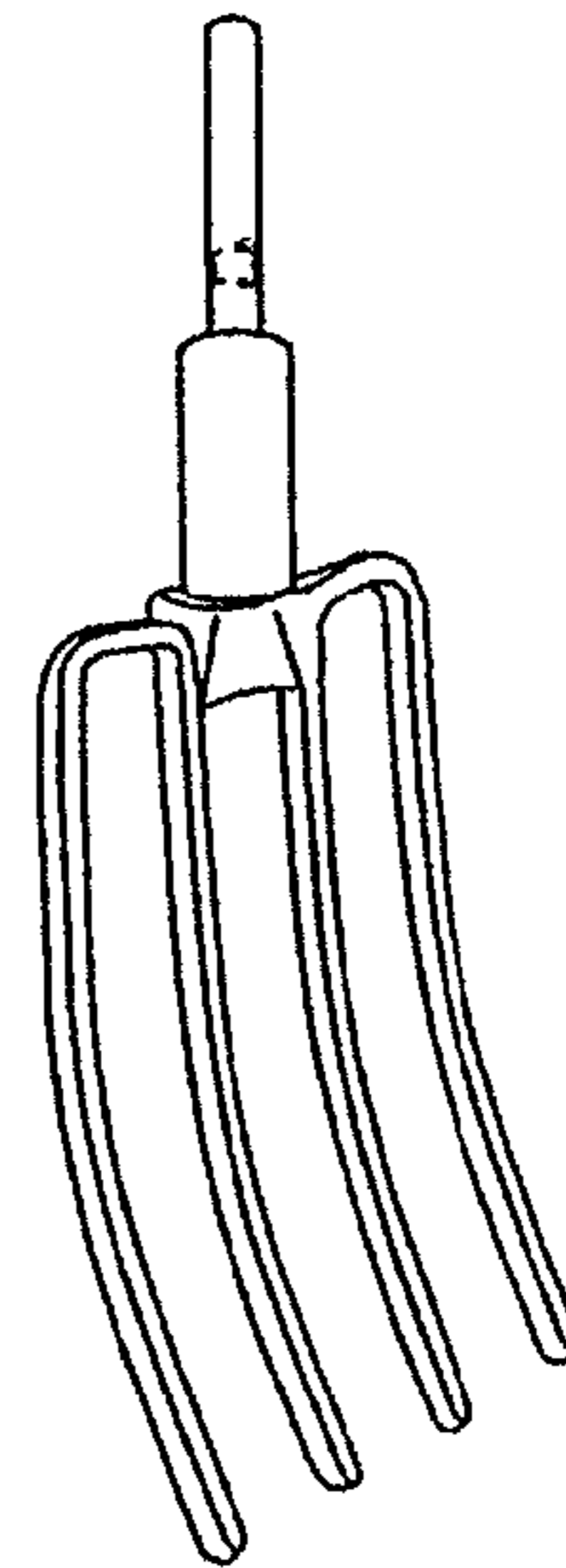
