The ornamental design for a driving head assembly for a pneumatic ratchet wrench, as shown and described.

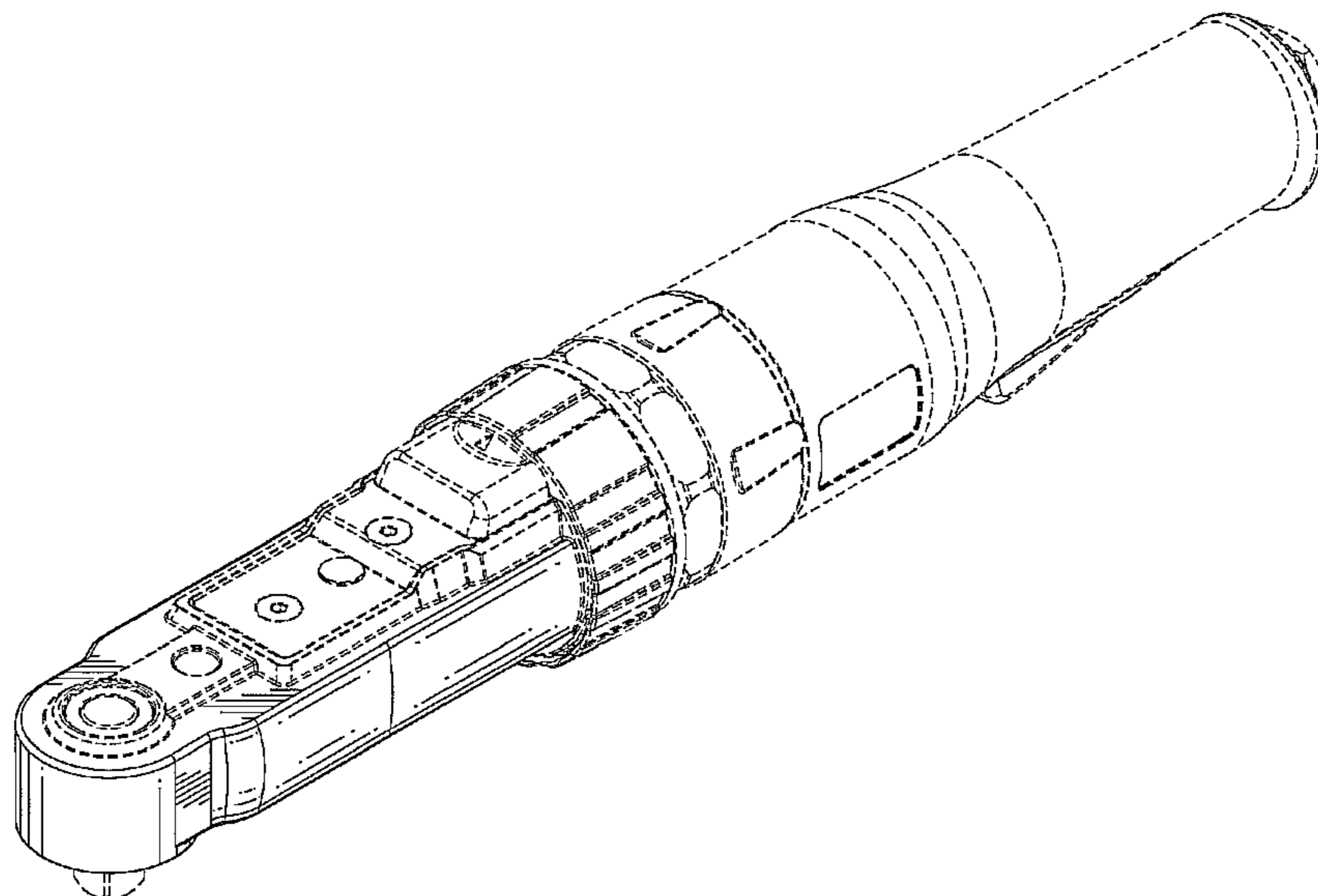
DESCRIPTION

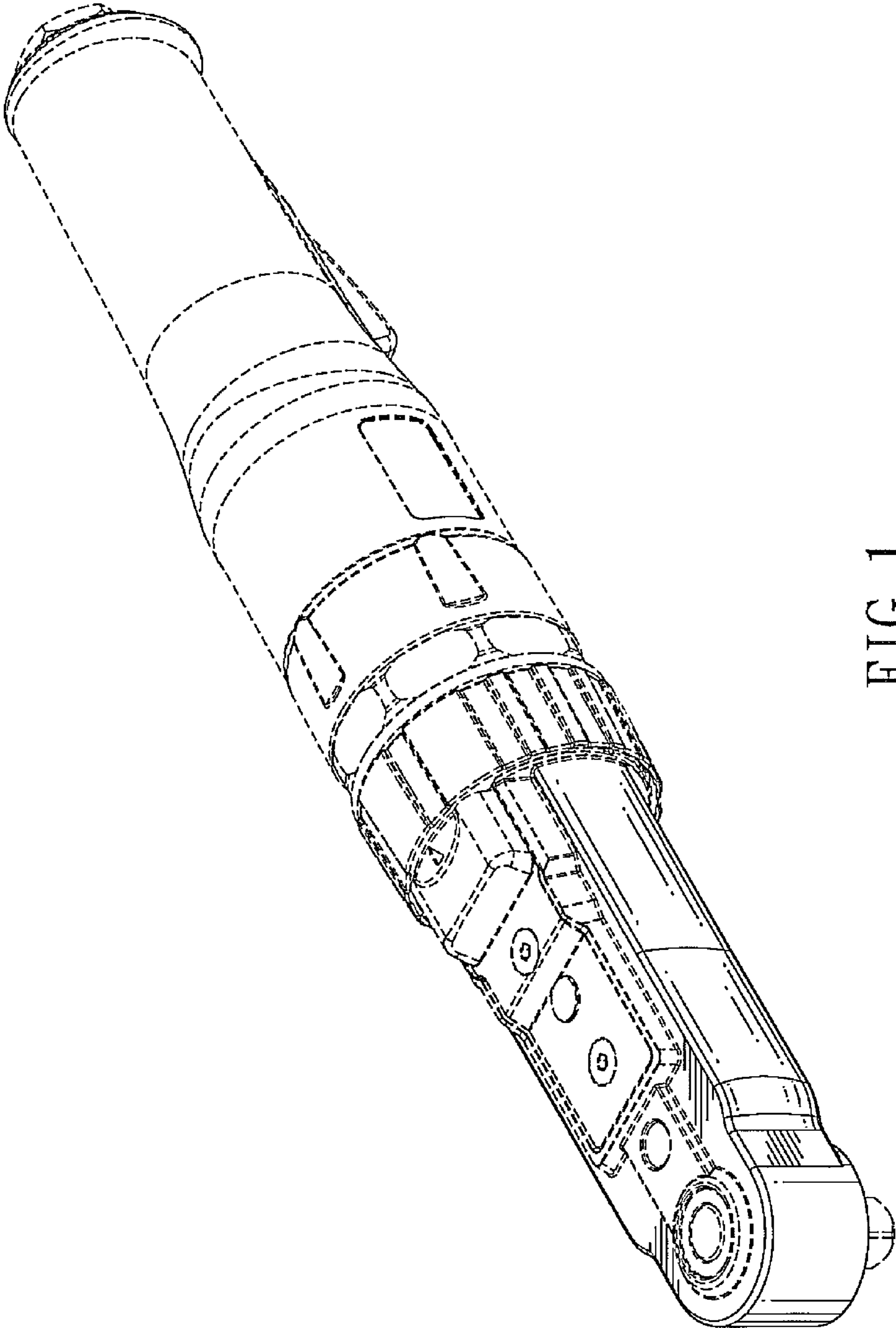

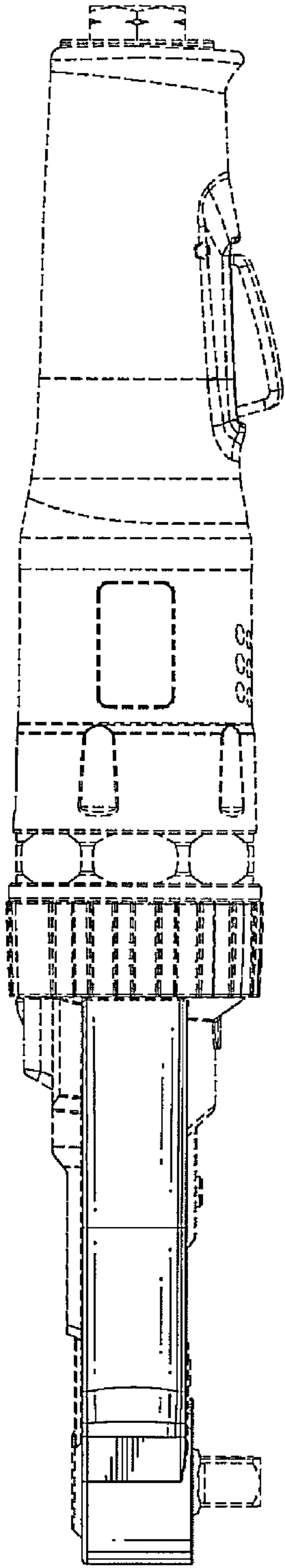

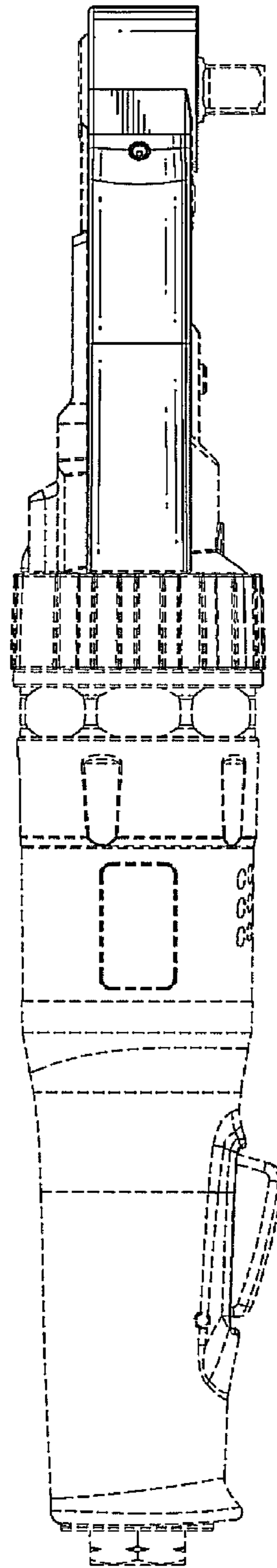

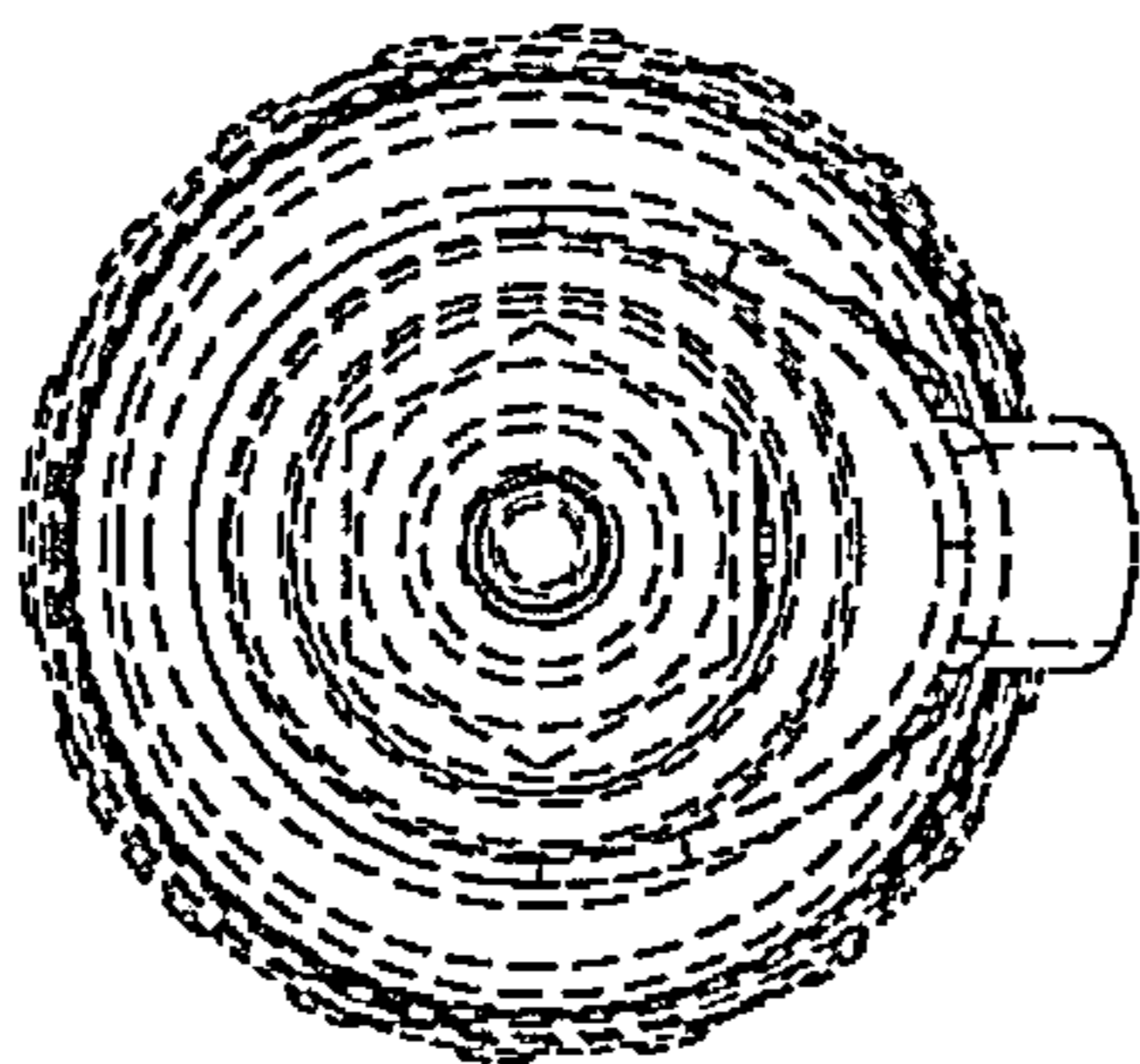

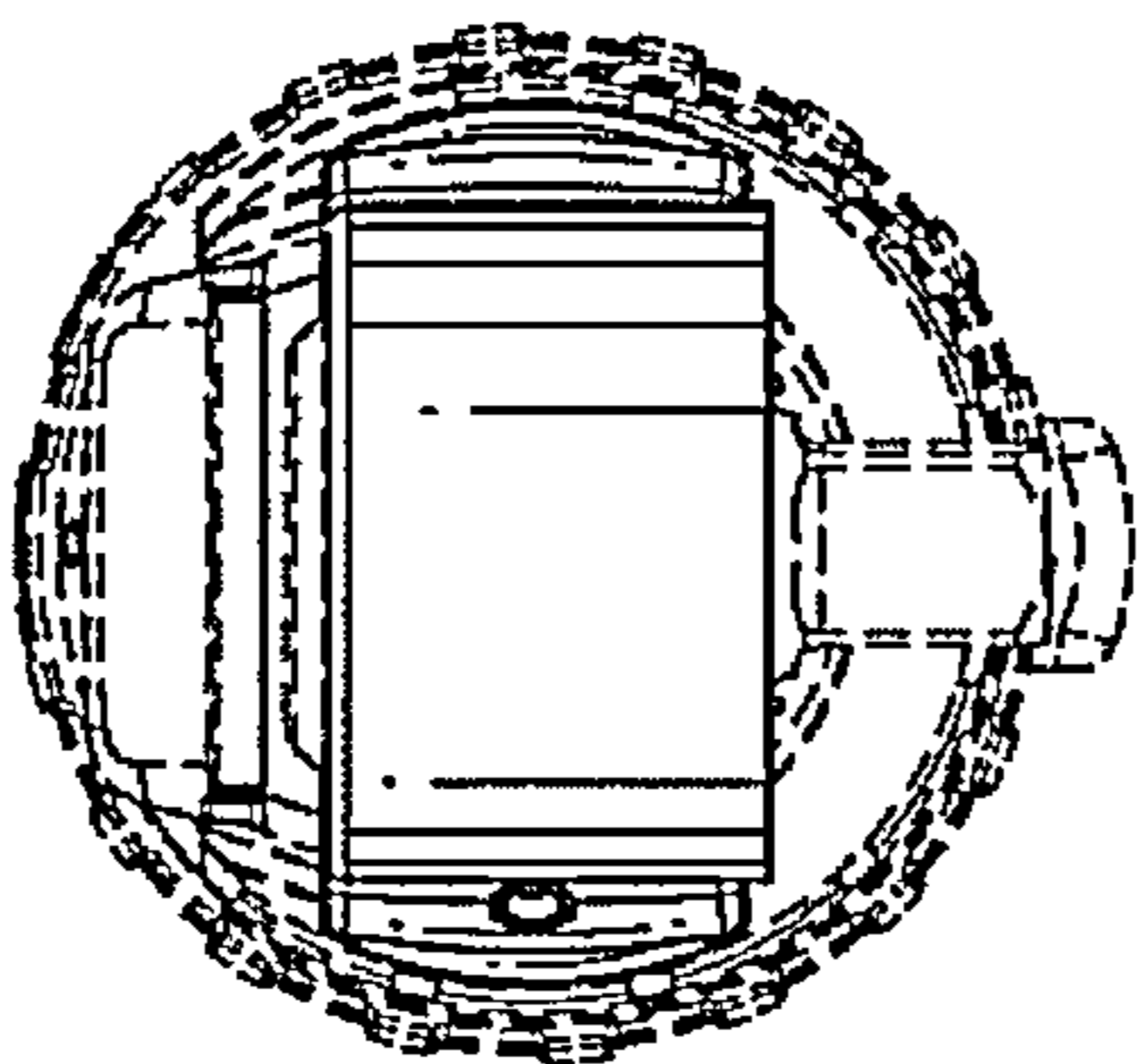

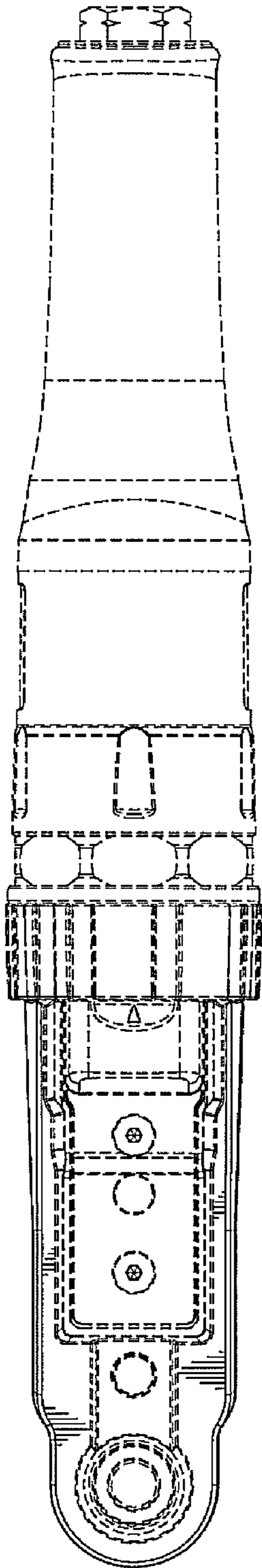

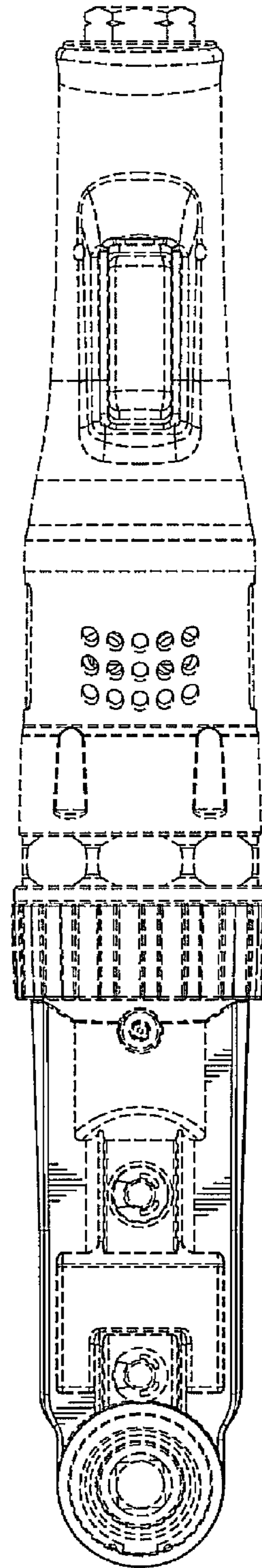
