(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a bottle according to our new design, with the rear view being identical (with the exception of the phantom-line threaded portion on the neck);

FIG. 2 is a left side view thereof, with the right side view thereof being identical (with the exception of the phantom-line threaded portion on the neck); and,

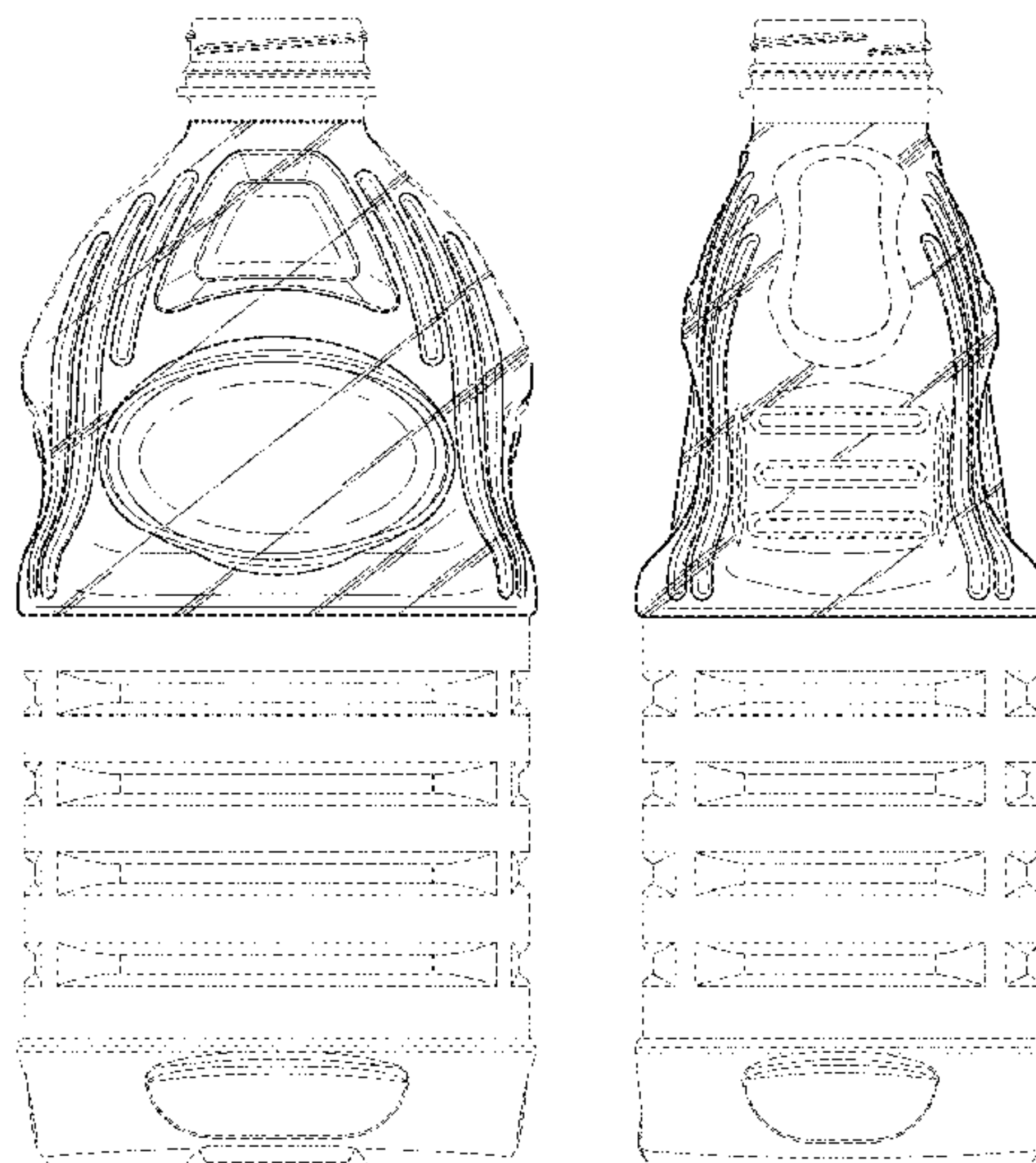
FIG. 3 is a top view thereof.

Where included, dotted lines indicate the border between claimed and unclaimed subject matter and form no part of the claimed design.

The bottle is shown as transparent, but details that would be seen though each bottle are not shown for purposes of clarity.

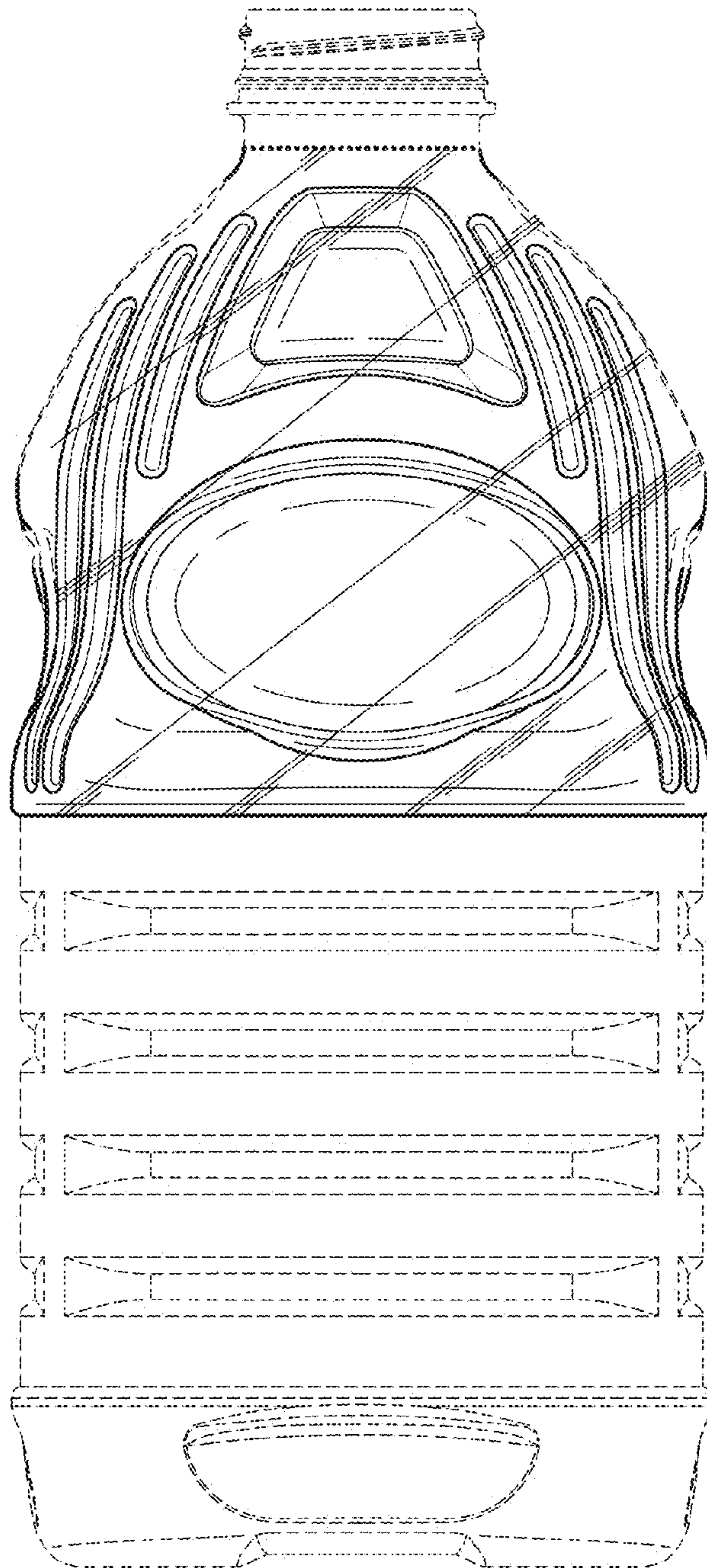

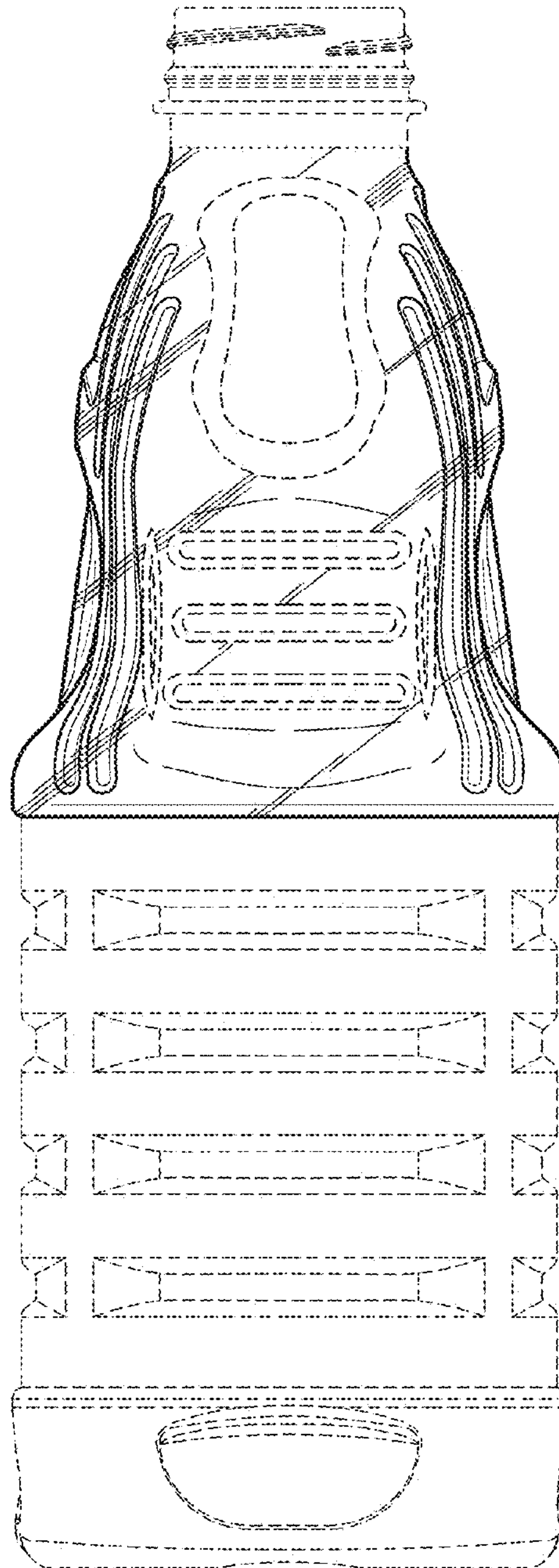

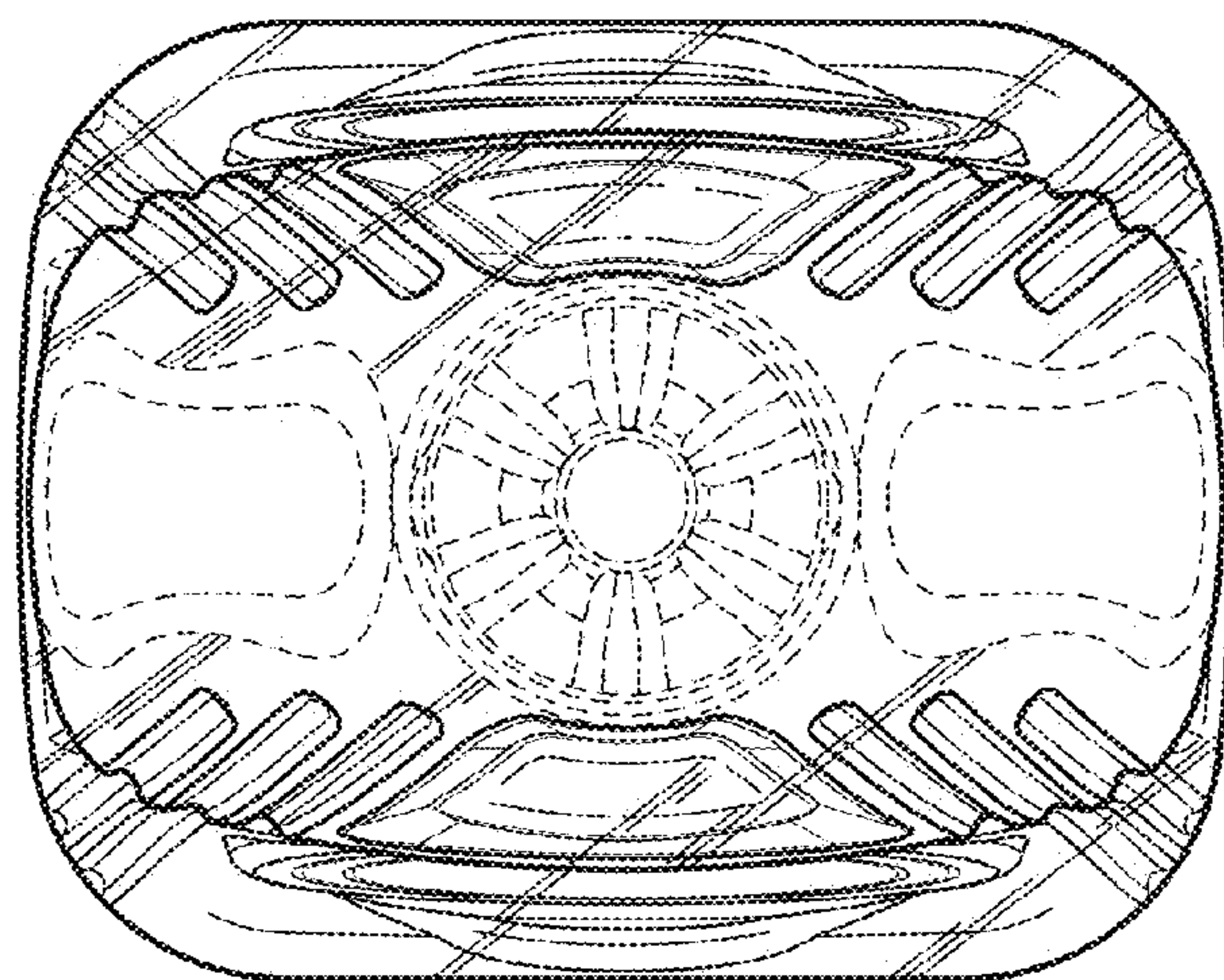
