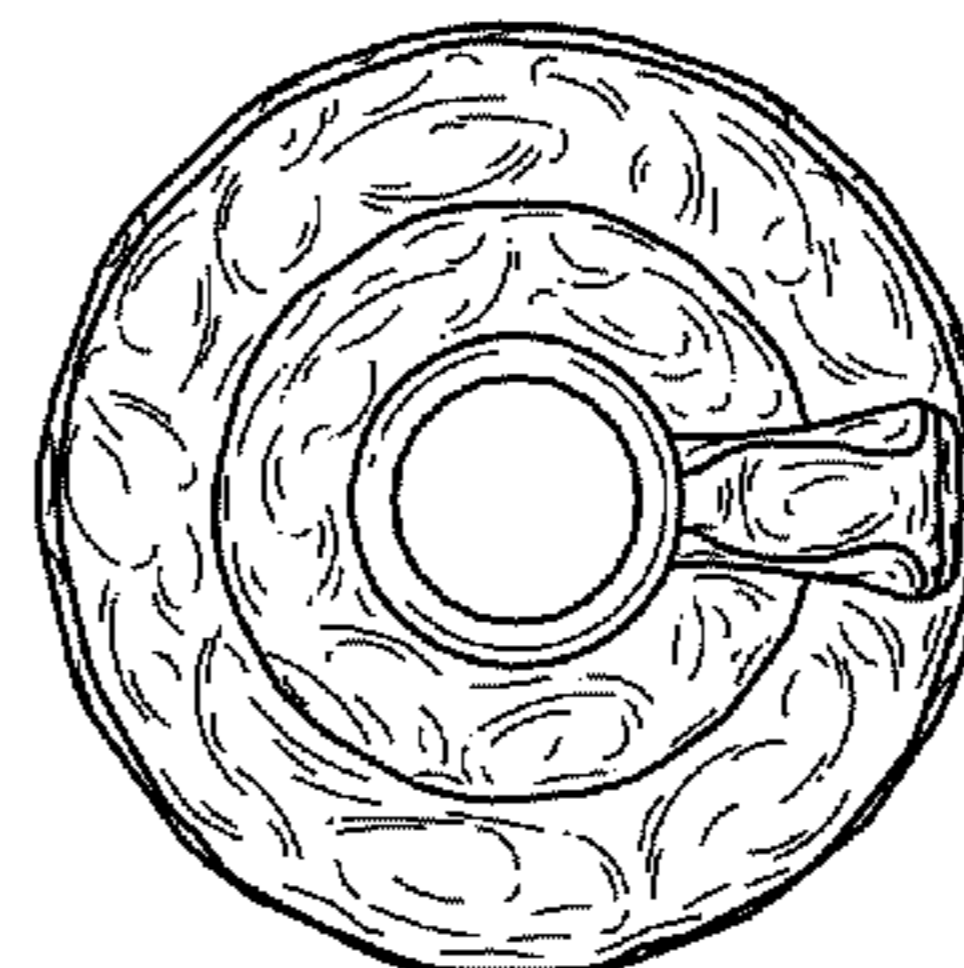
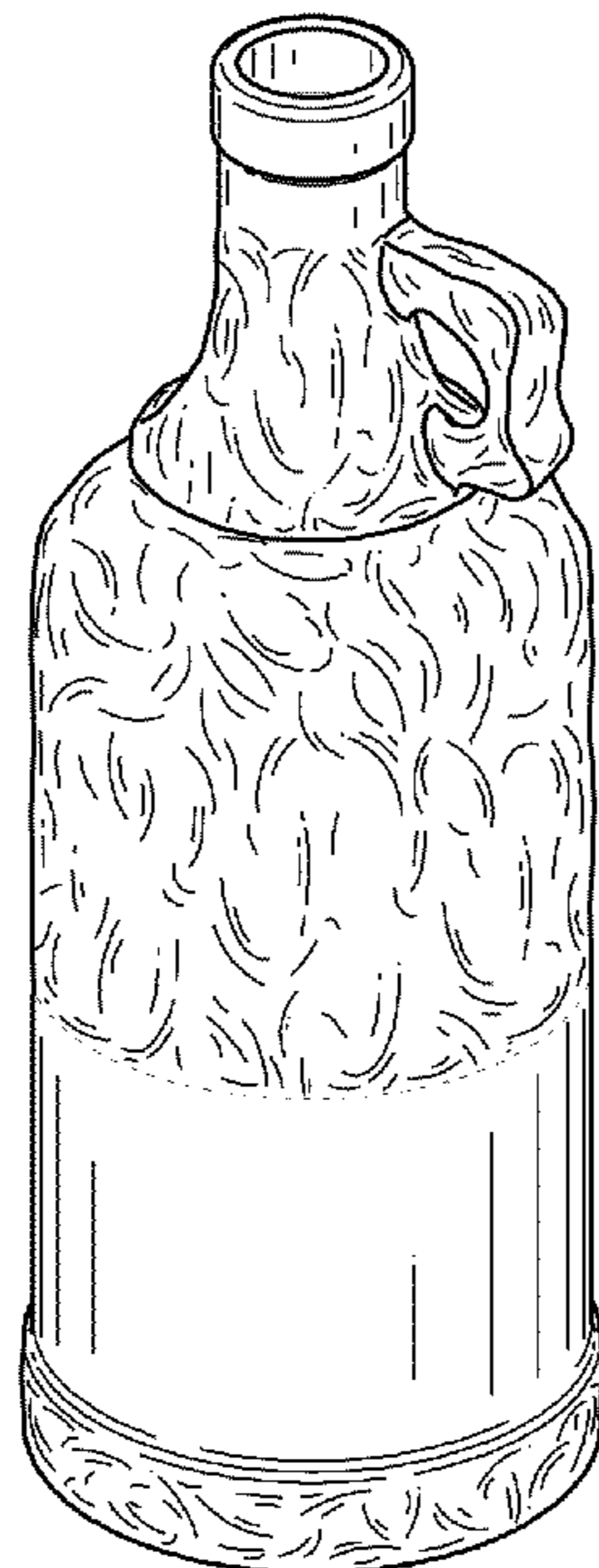
(57) **CLAIM**

I claim the ornamental design for a bottle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right isometric view of a bottle.  
FIG. 2 is a front elevation view of the bottle of FIG. 1, the back elevation view being a mirror image thereof.  
FIG. 3 is a right side elevation view of the bottle of FIG. 1.  
FIG. 4 is a left side elevation view of the bottle of FIG. 1.  
FIG. 5 is a top plan view of the bottle of FIG. 1; and,  
FIG. 6 is a bottom plan view of the bottle of FIG. 1.  
The broken lines, which define the bounds of the claimed design, form no part of the claimed design.

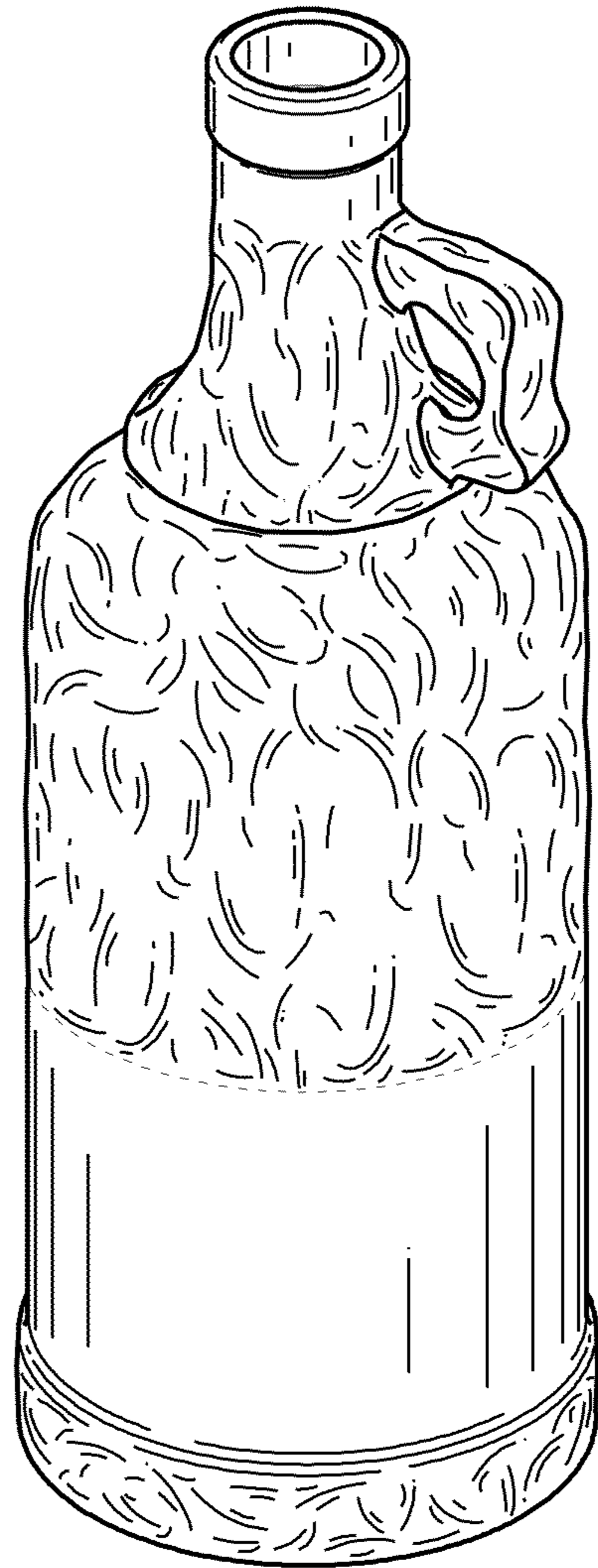

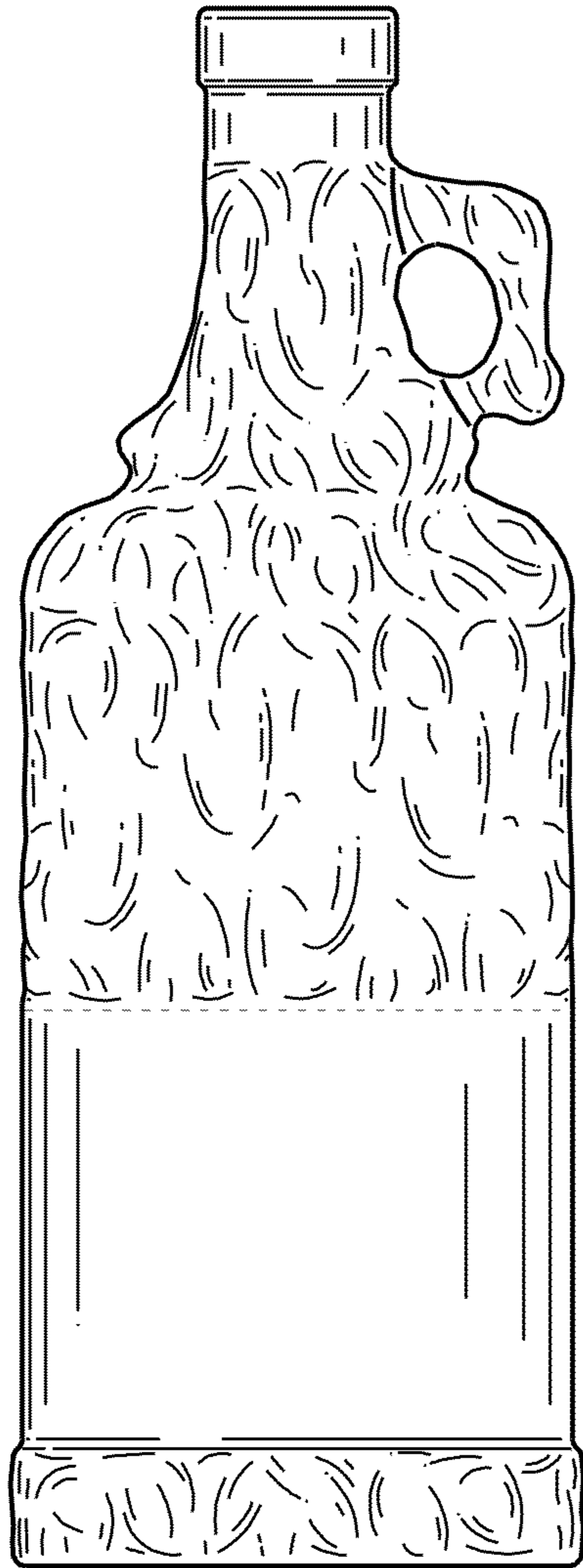

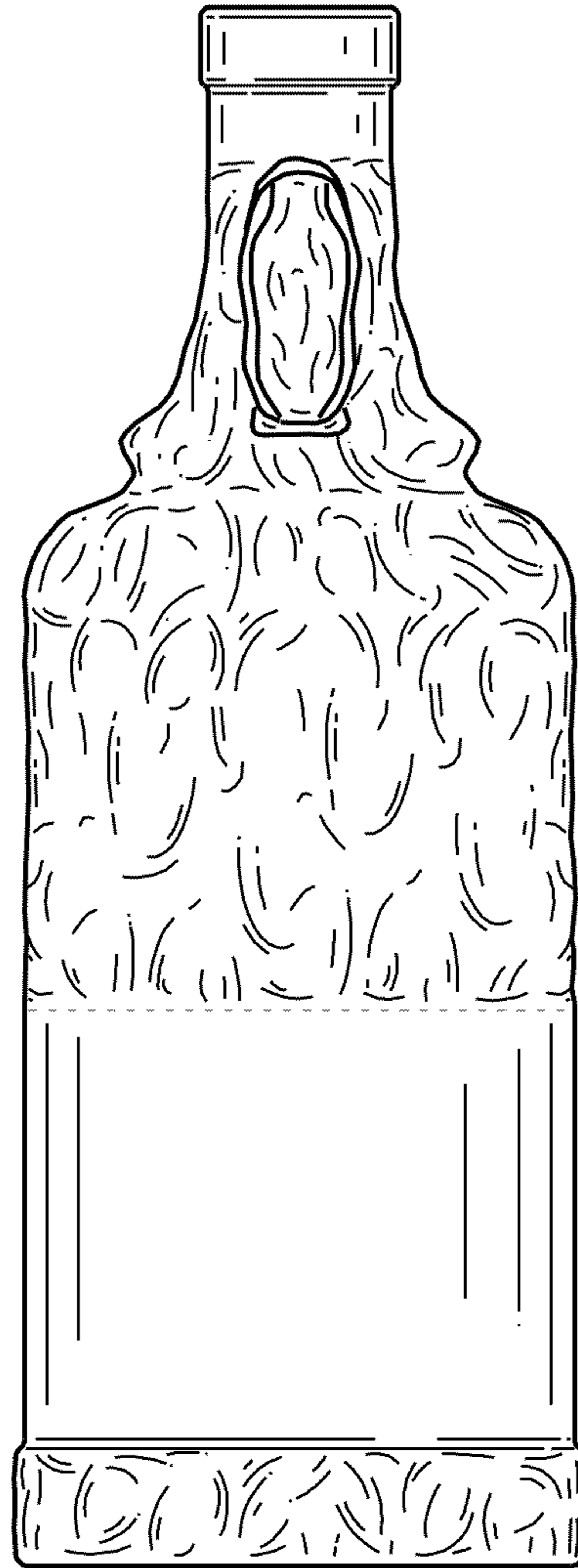

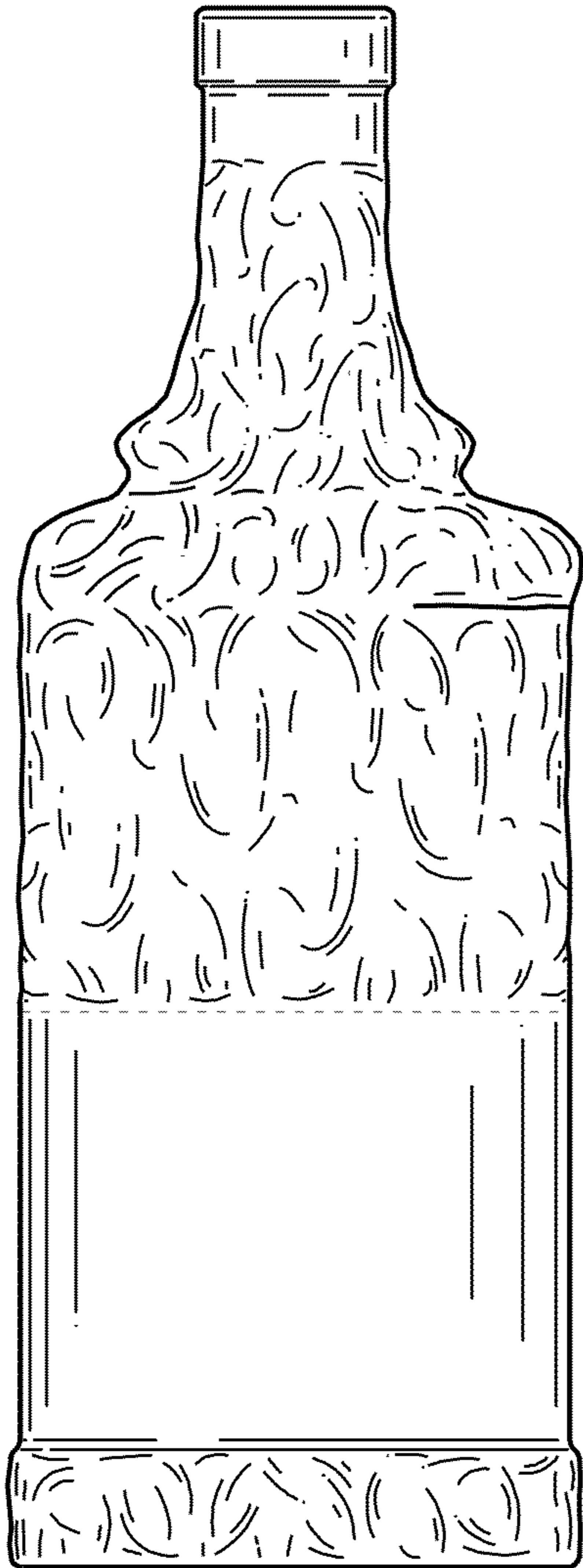

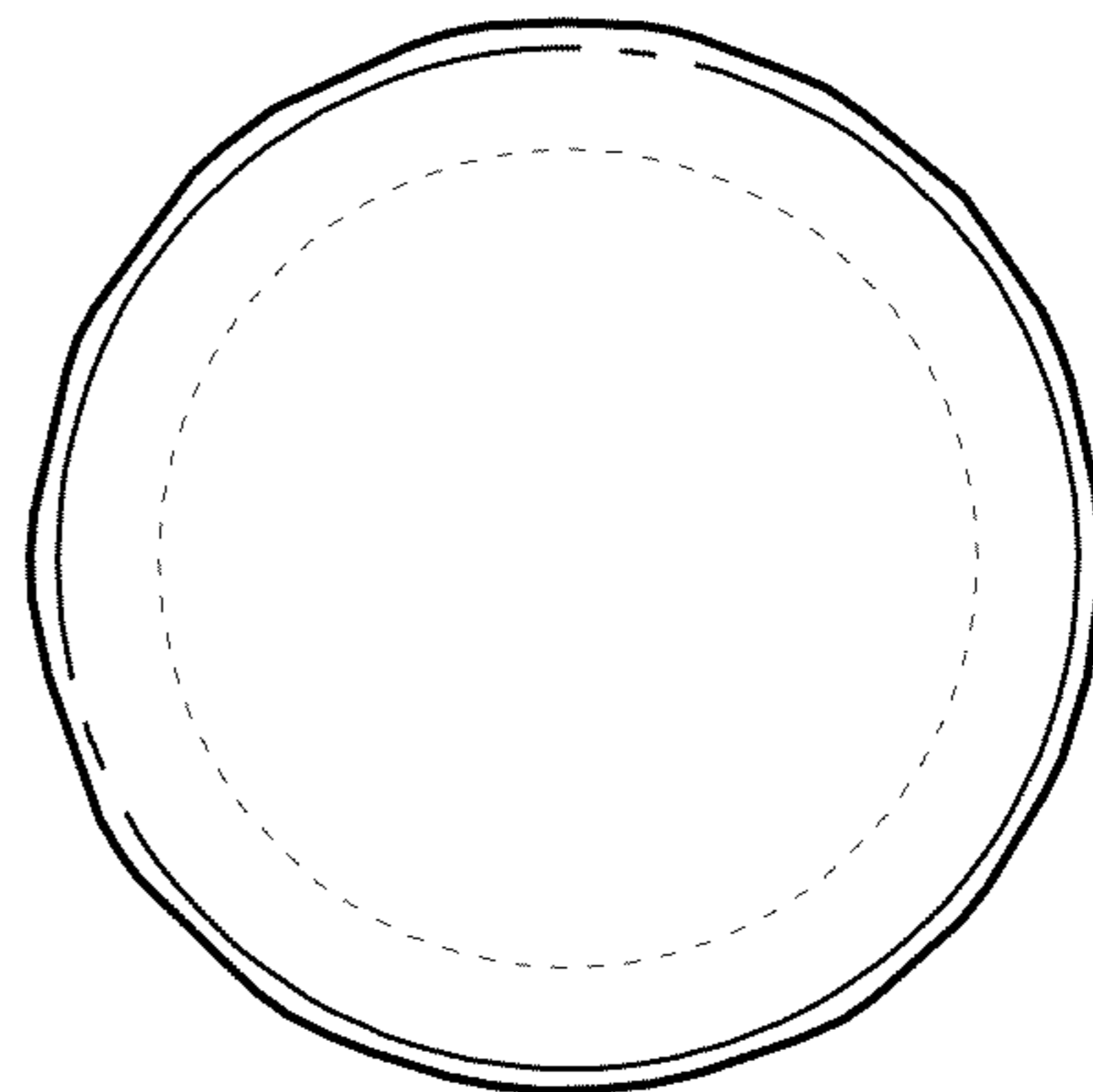

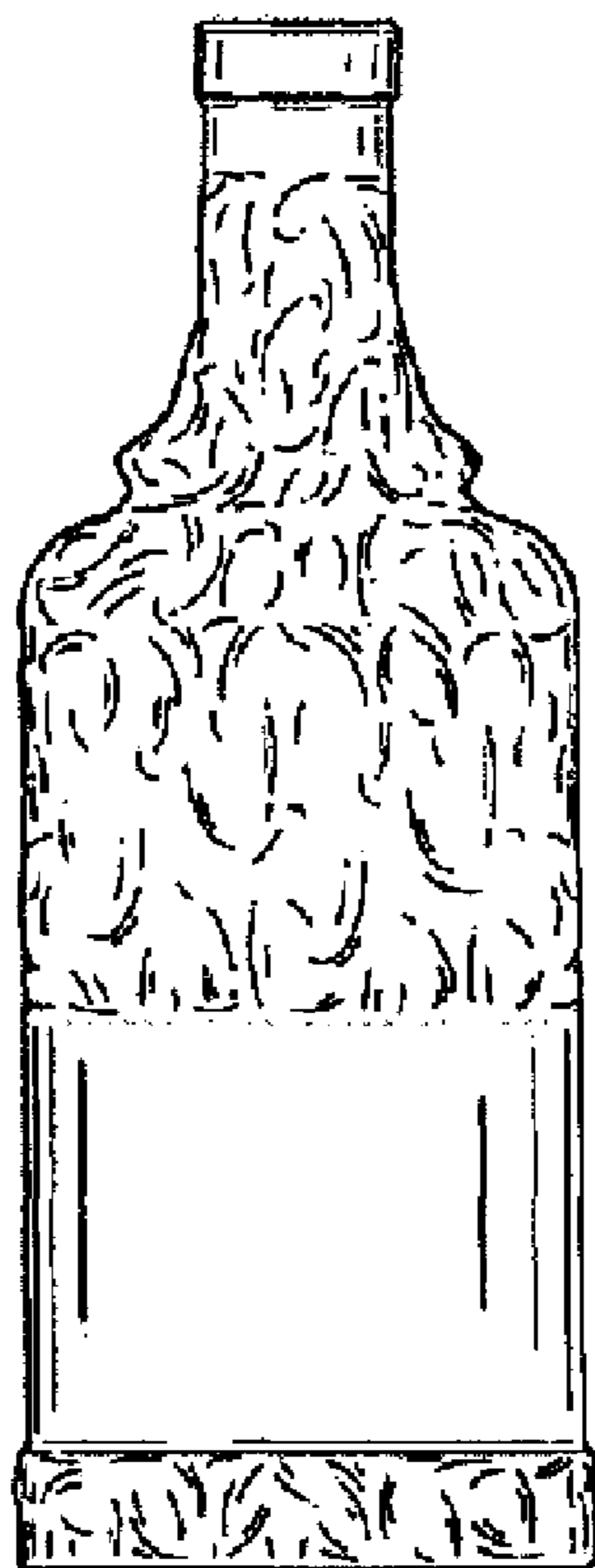
