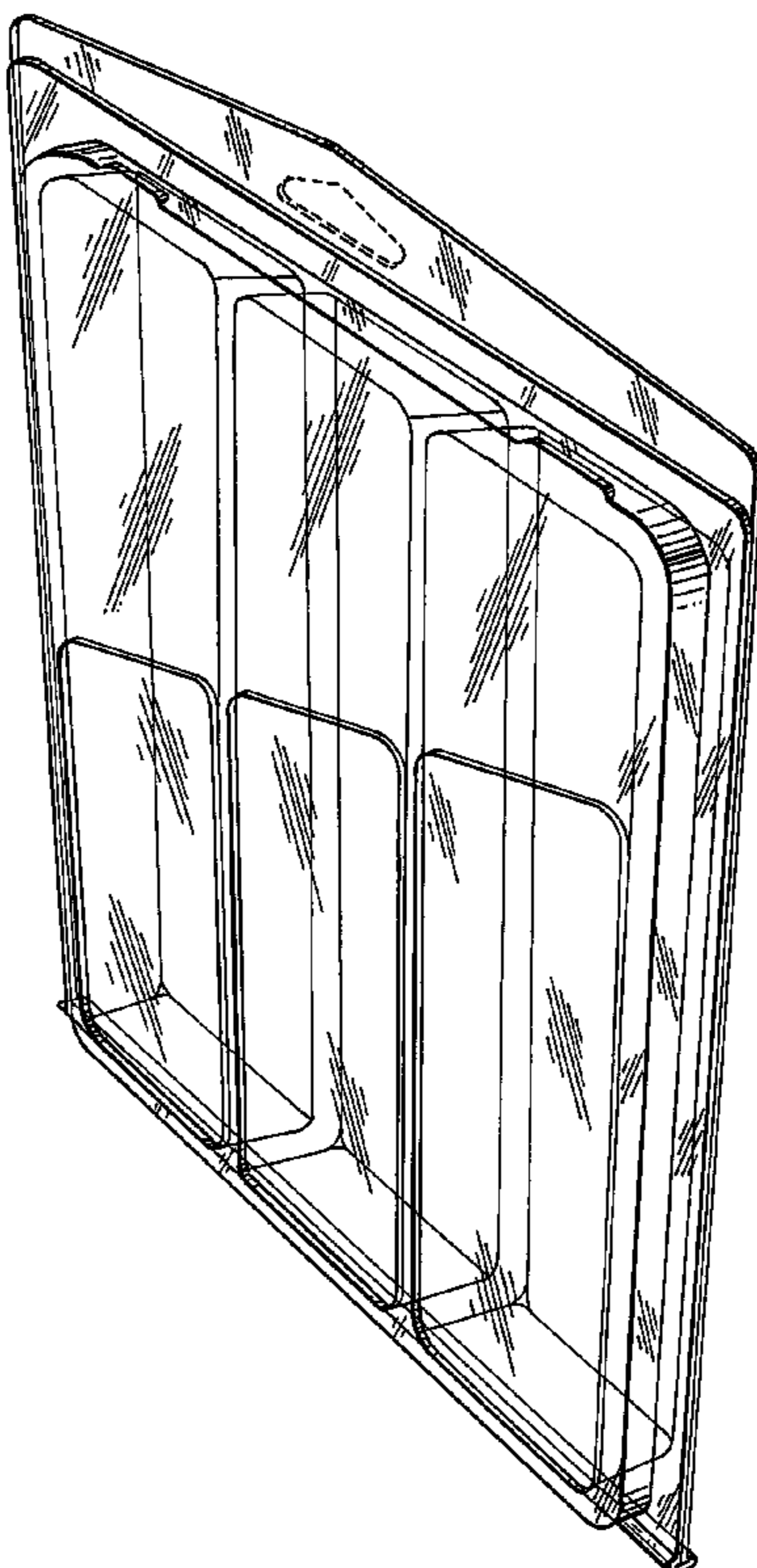
(57) **CLAIM**

The ornamental design for a three compartment package, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom, right side perspective view of the three compartment package in an open position;  
FIG. 2 is a front view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is left side view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a rear view thereof; and,

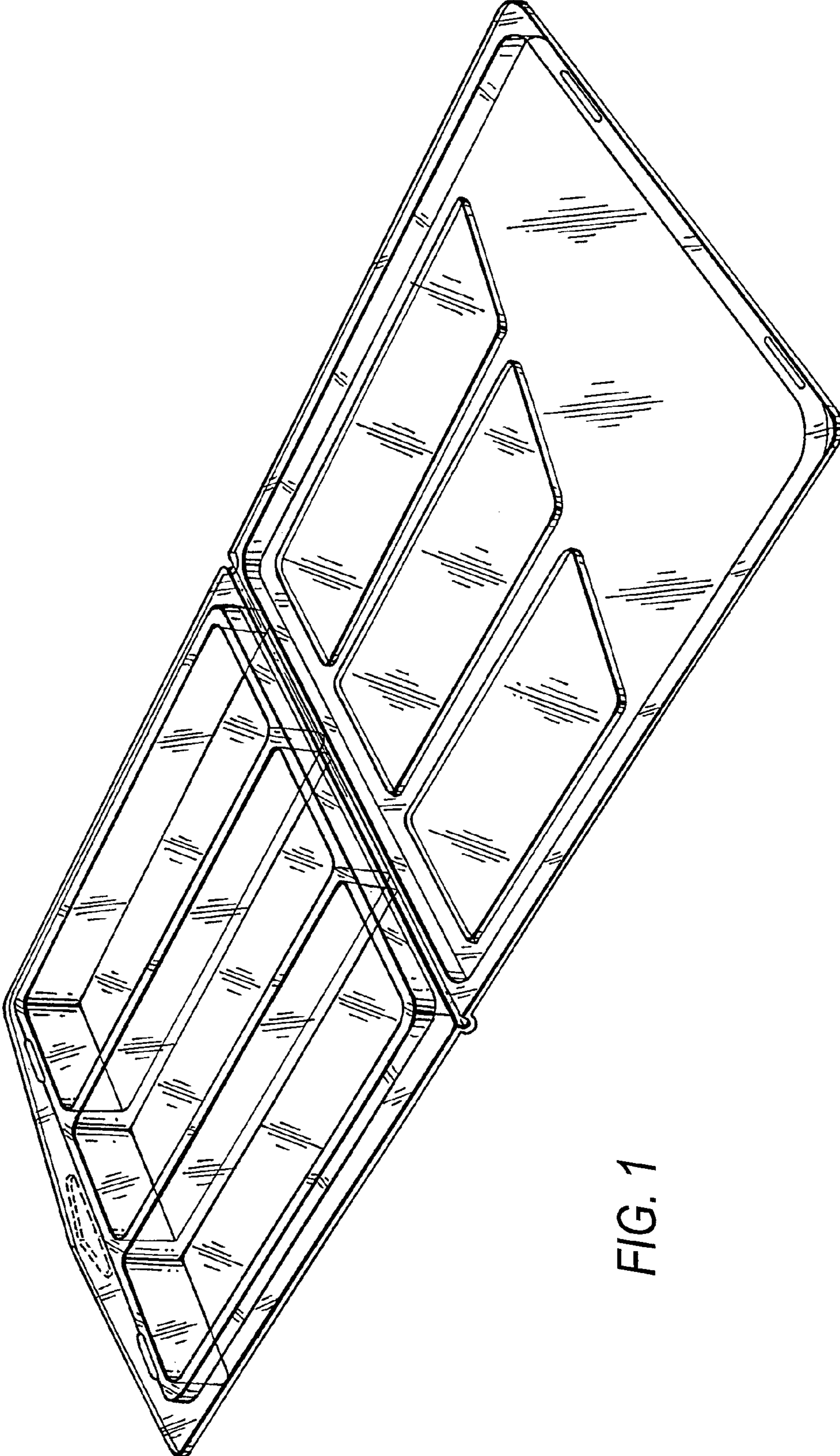

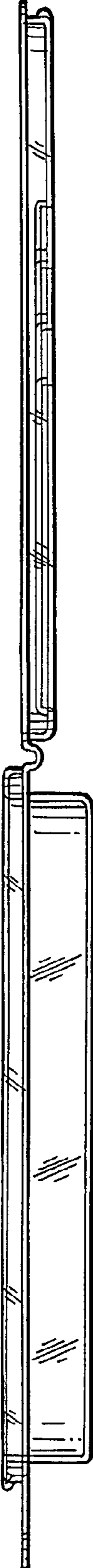
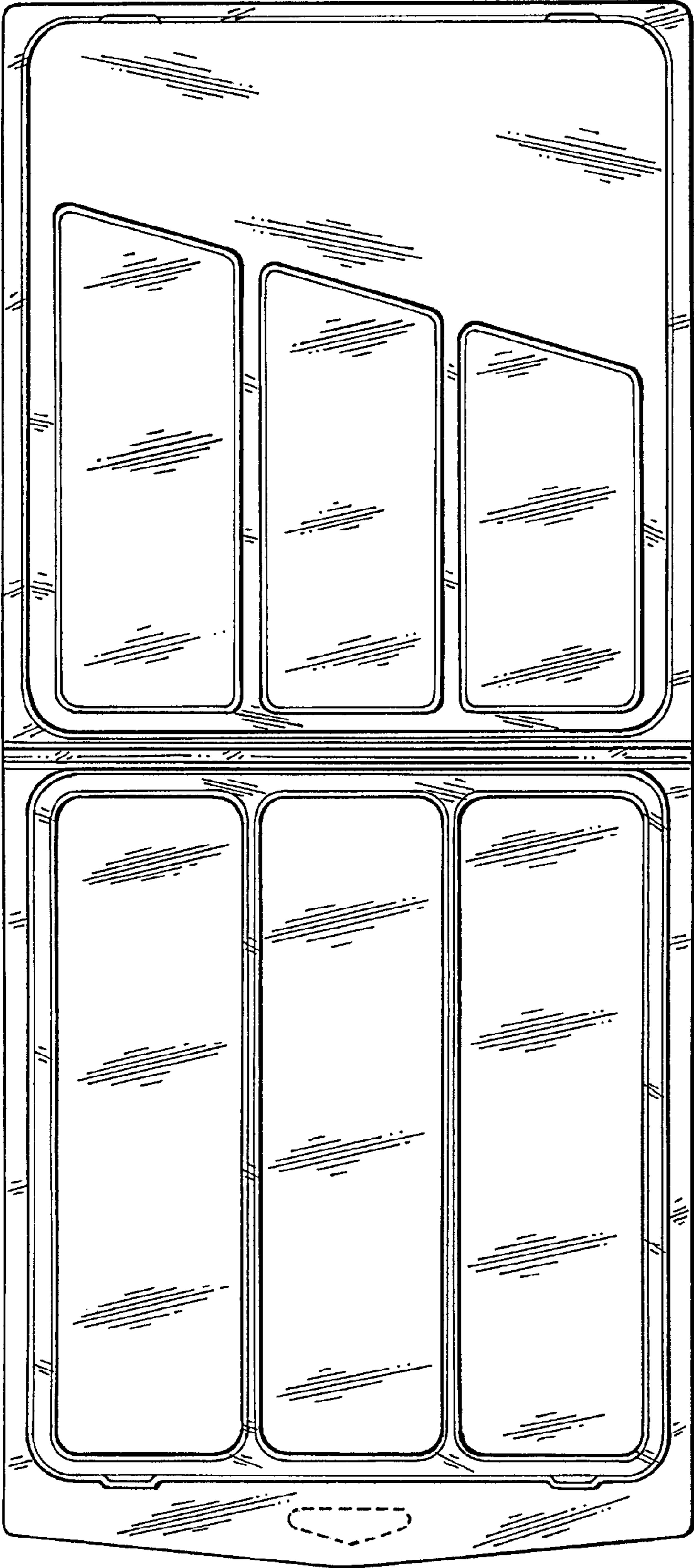

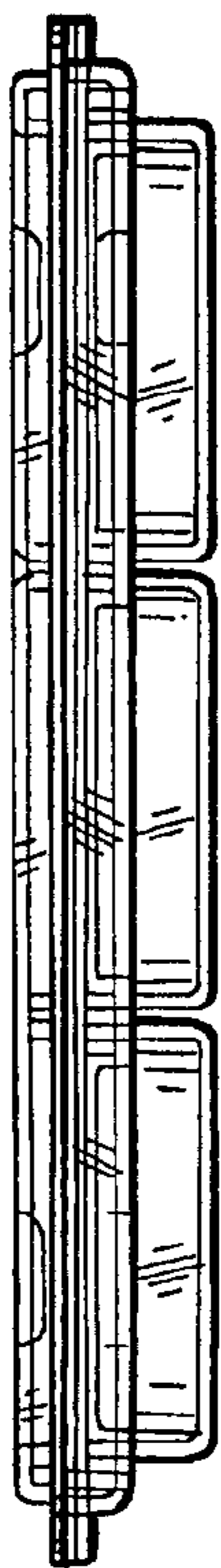

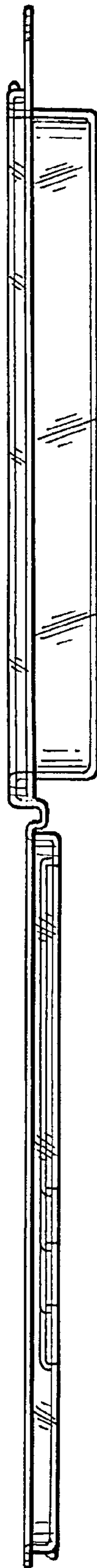

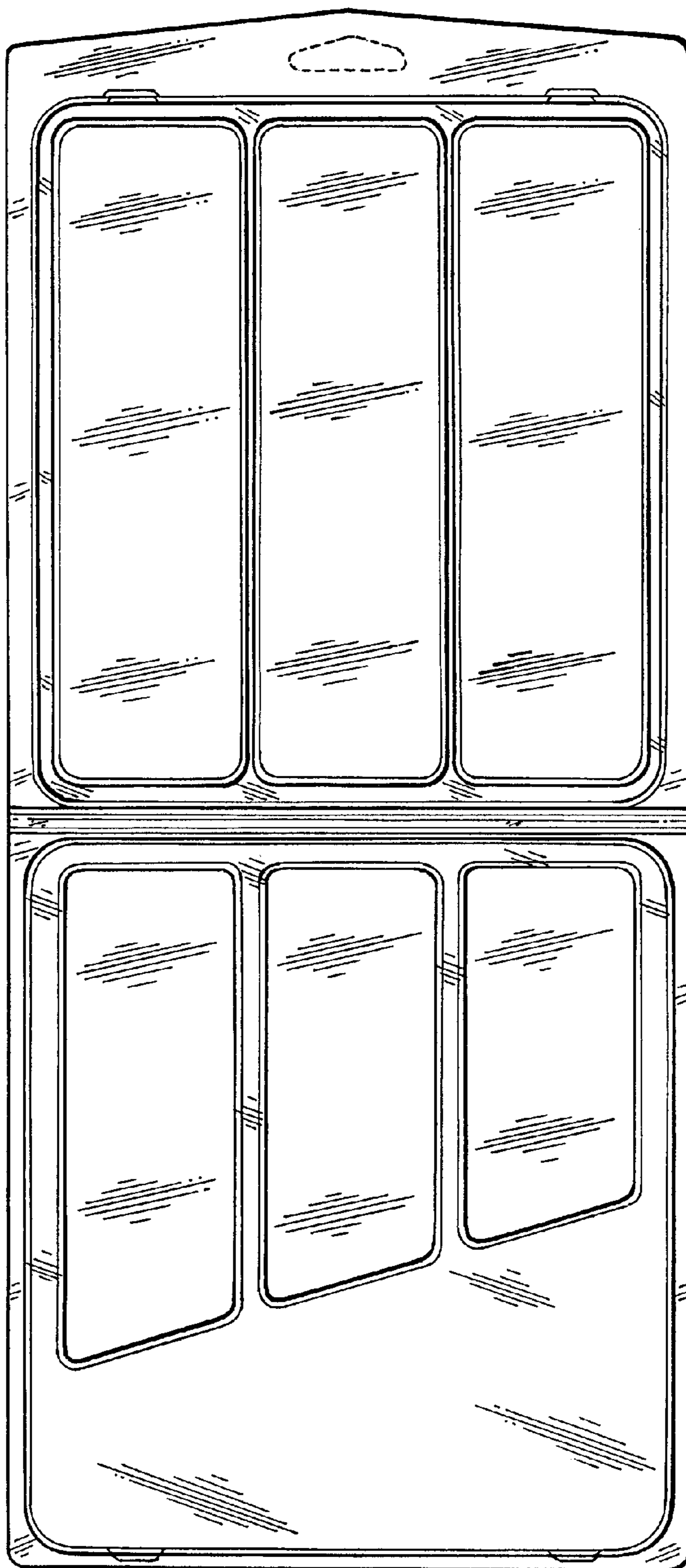
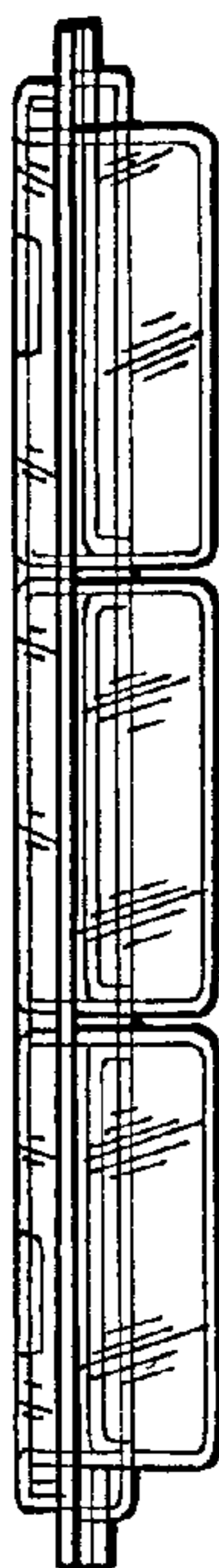

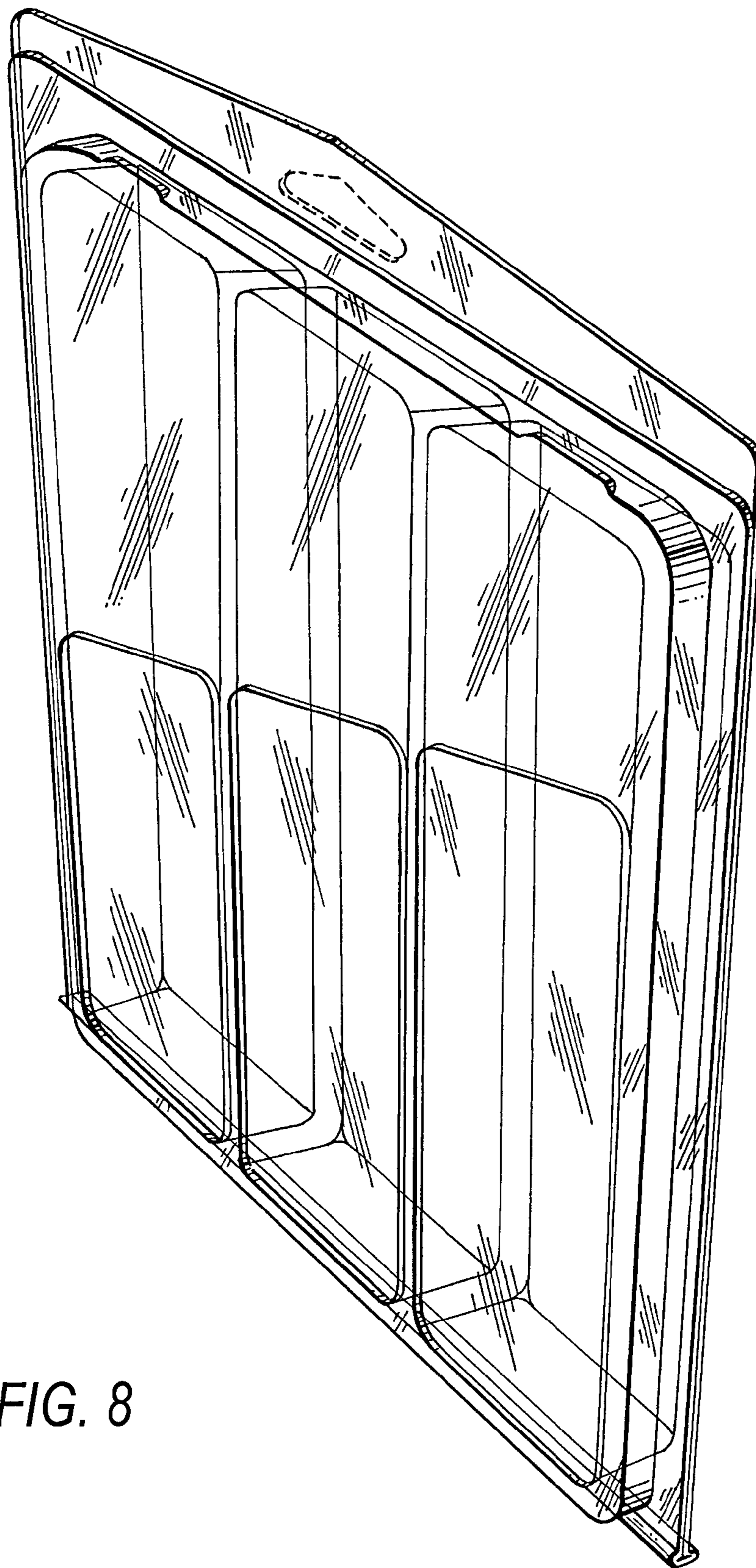
